FIG. 4 is a back perspective view thereof;

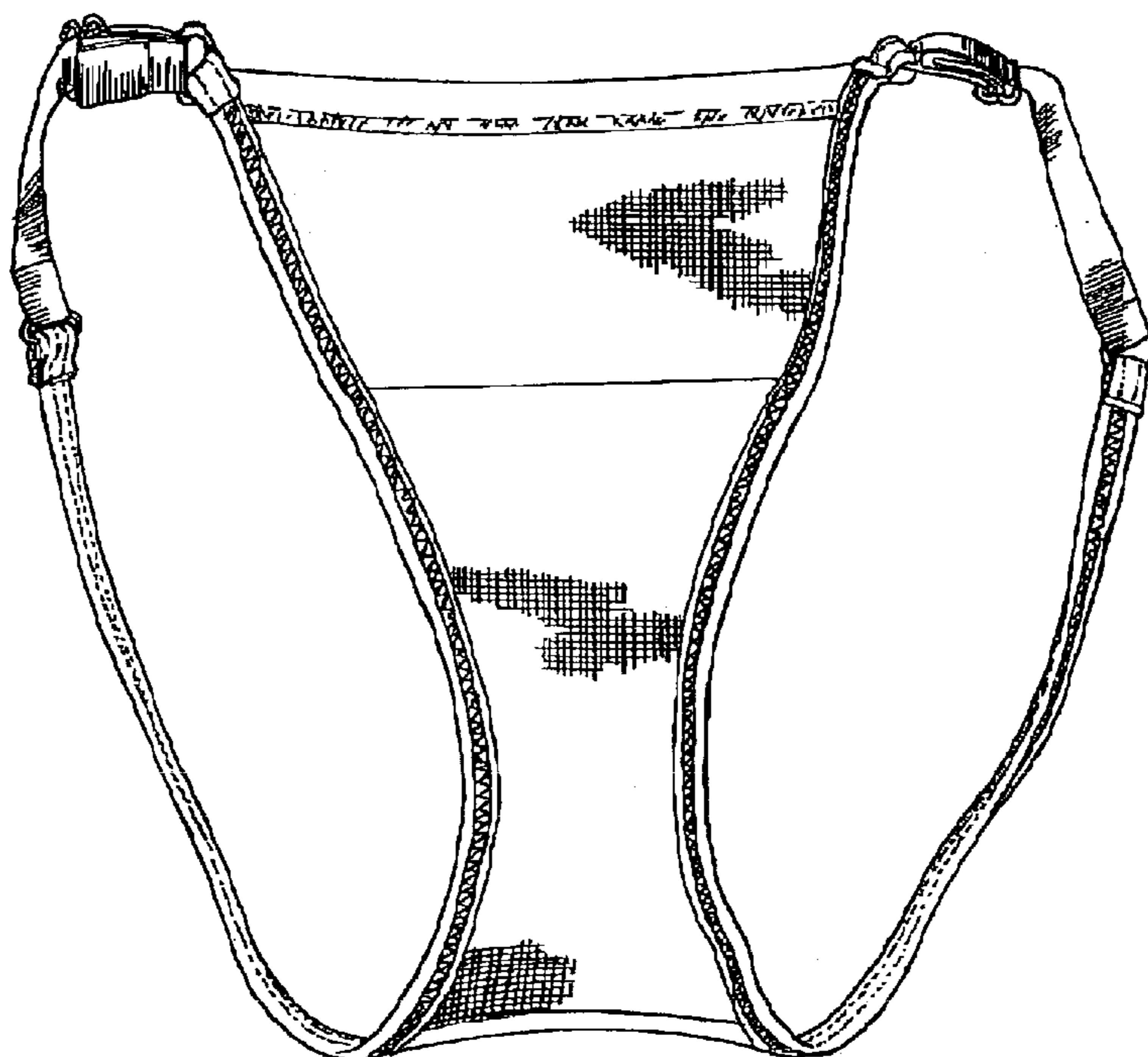
FIG. 5 is a side perspective view of the adjustable strap thereof;

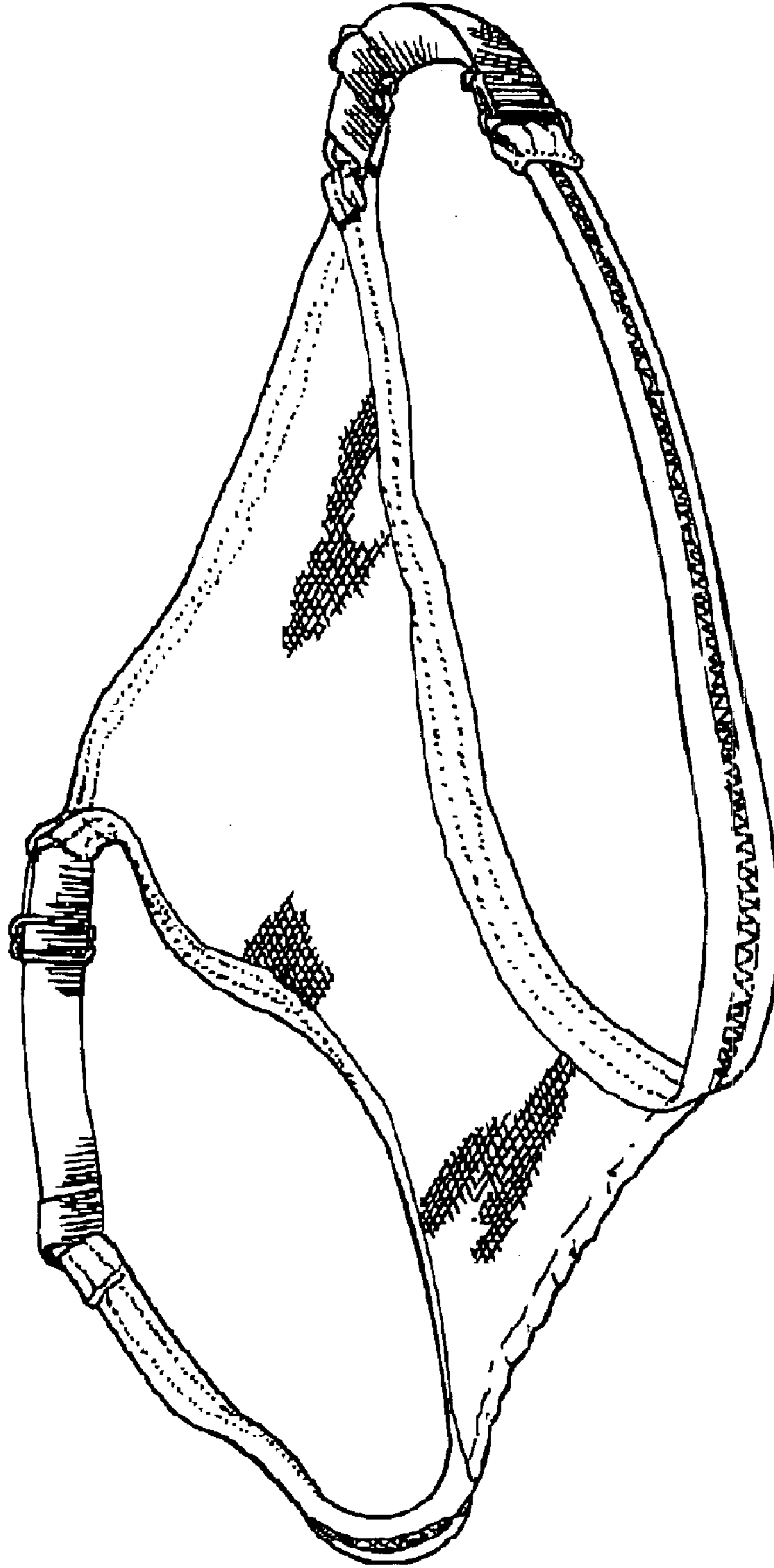

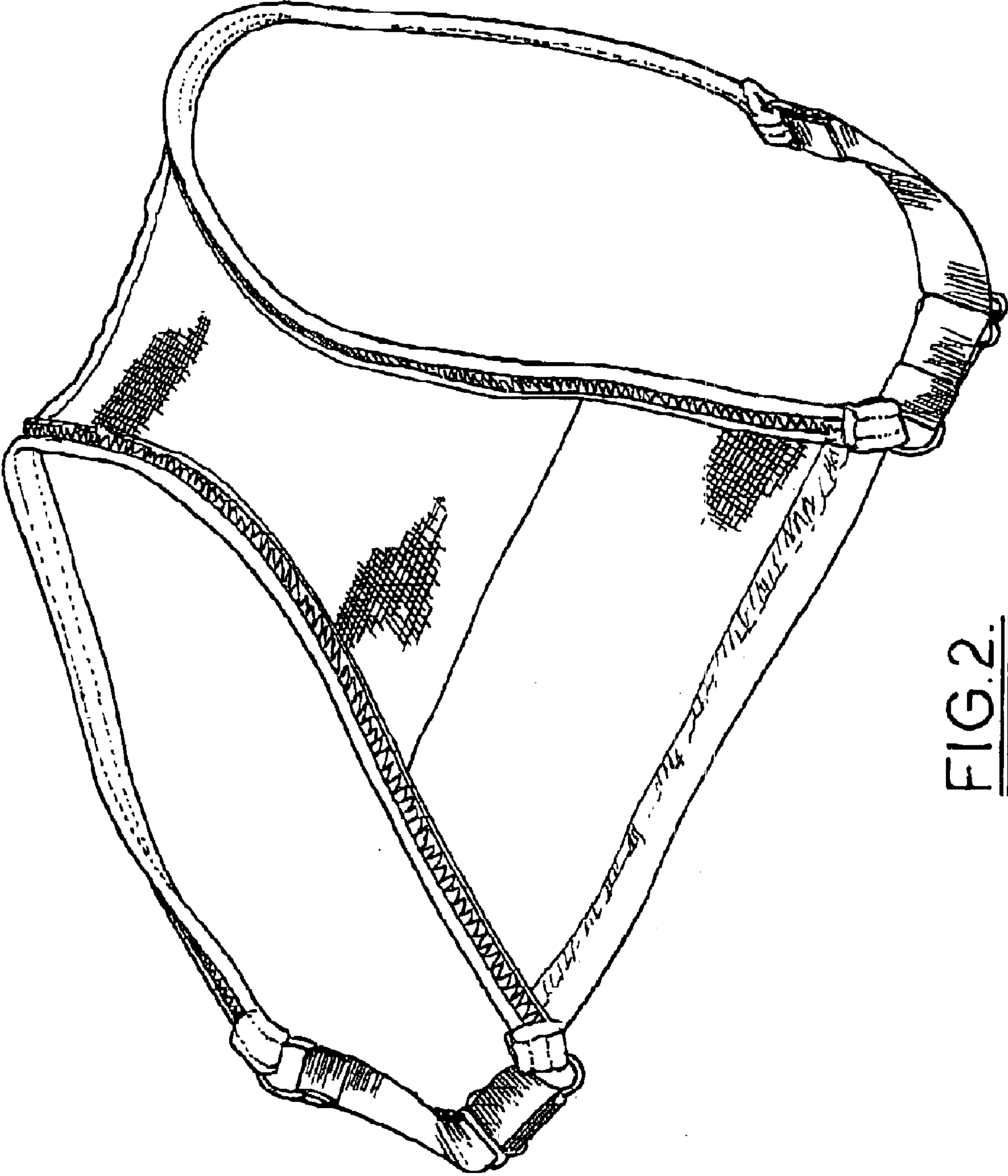

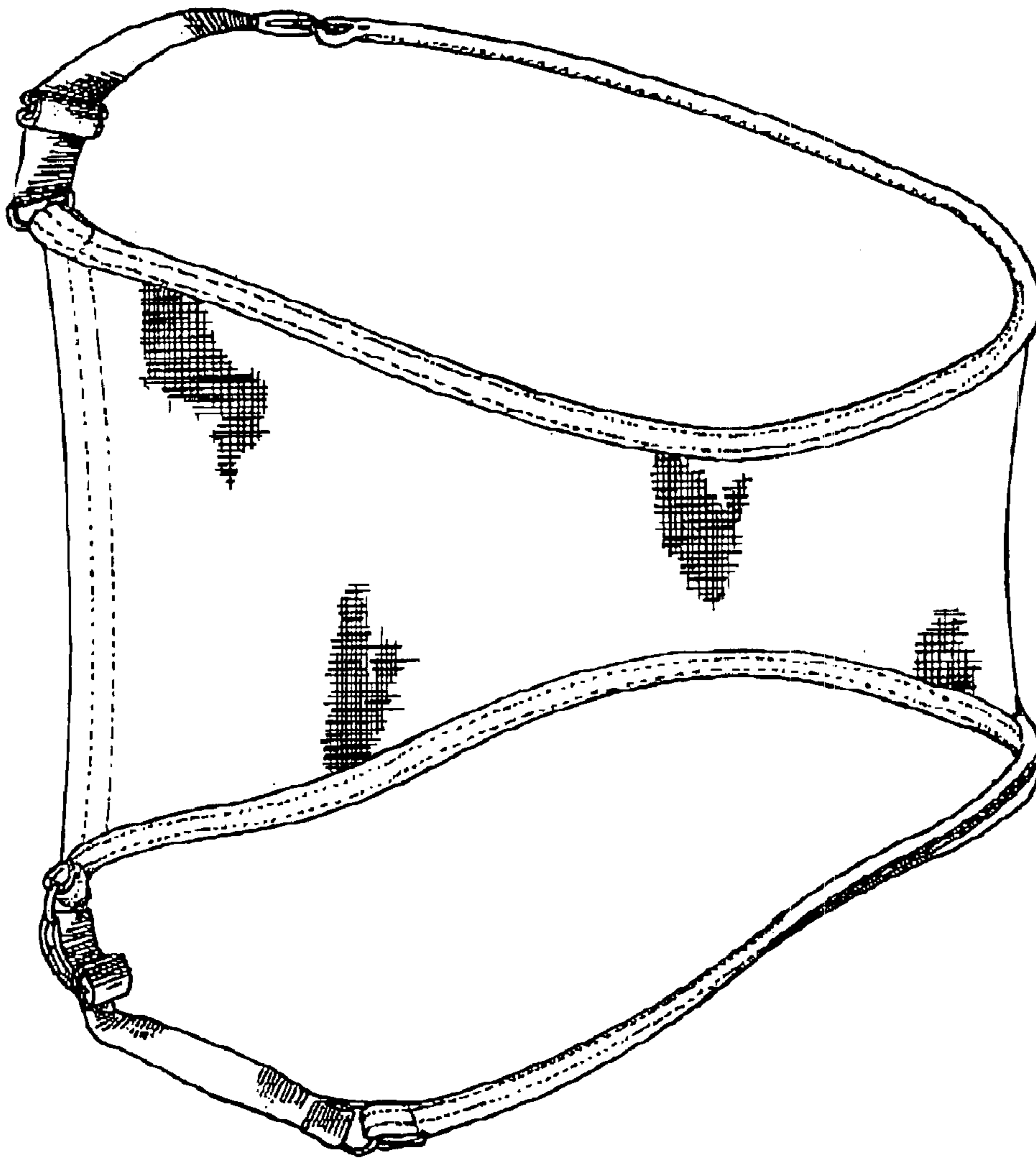

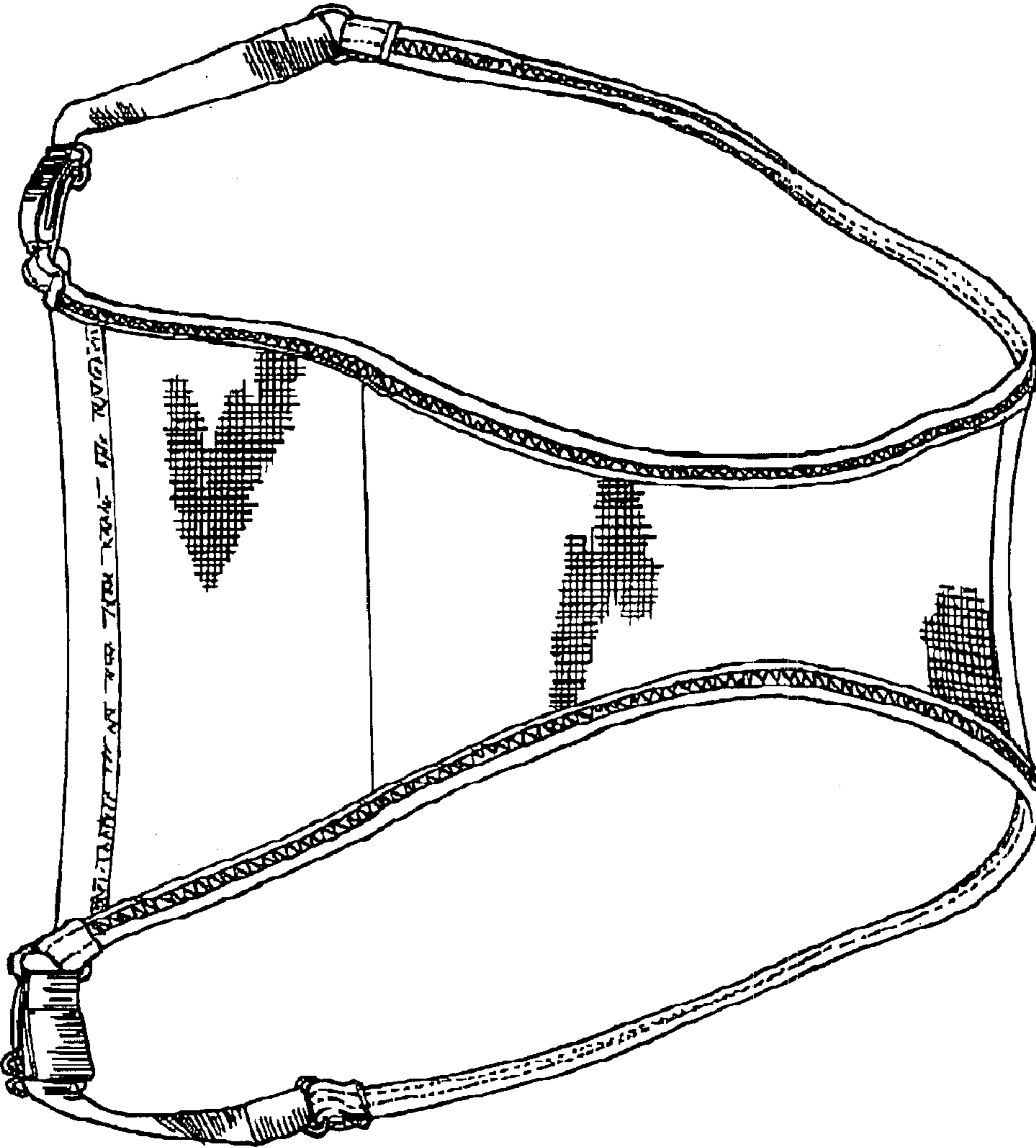
