FIG. 5 is a left side view of a messenger bag showing my new design.

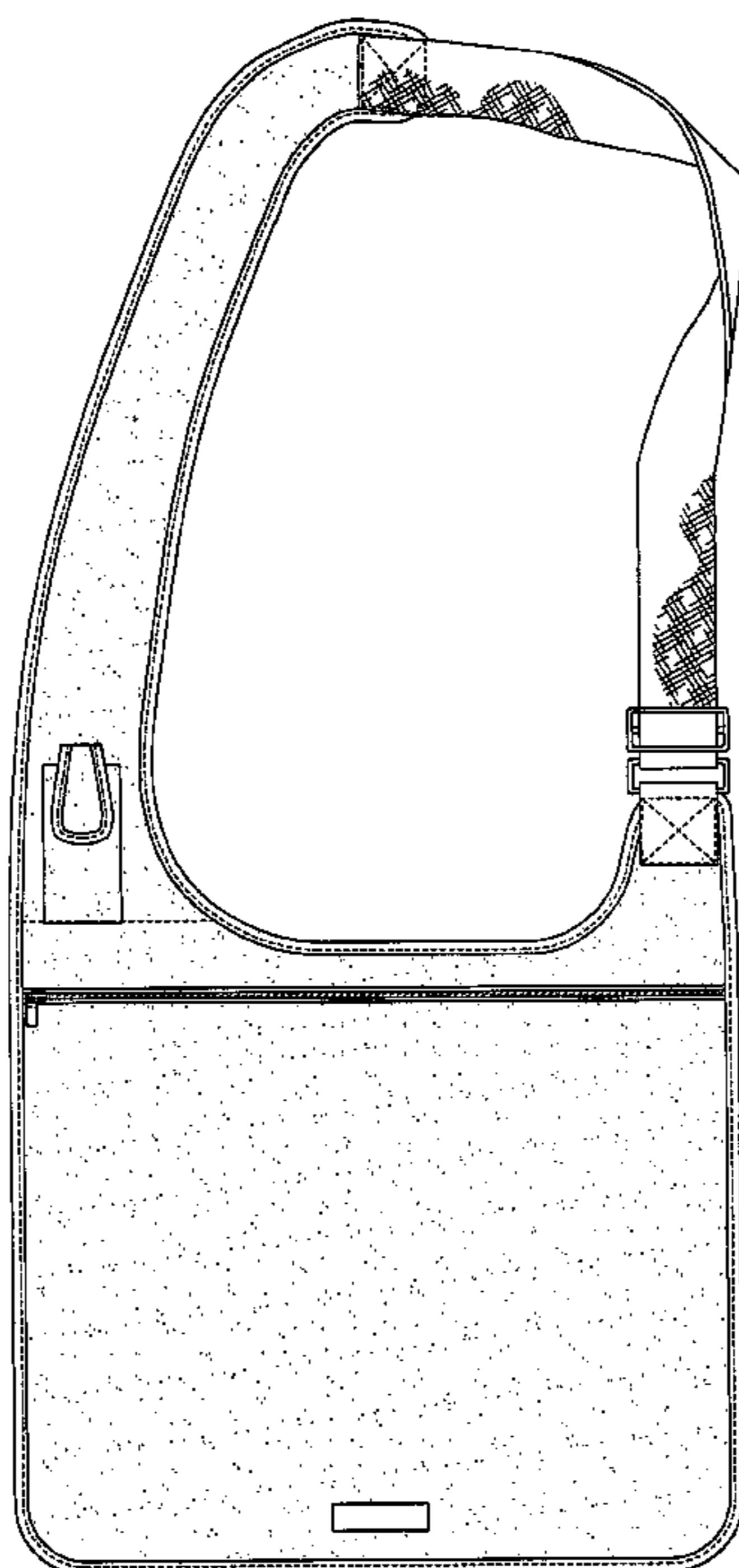
FIG. 6 is a right side view of a messenger bag showing my new design.

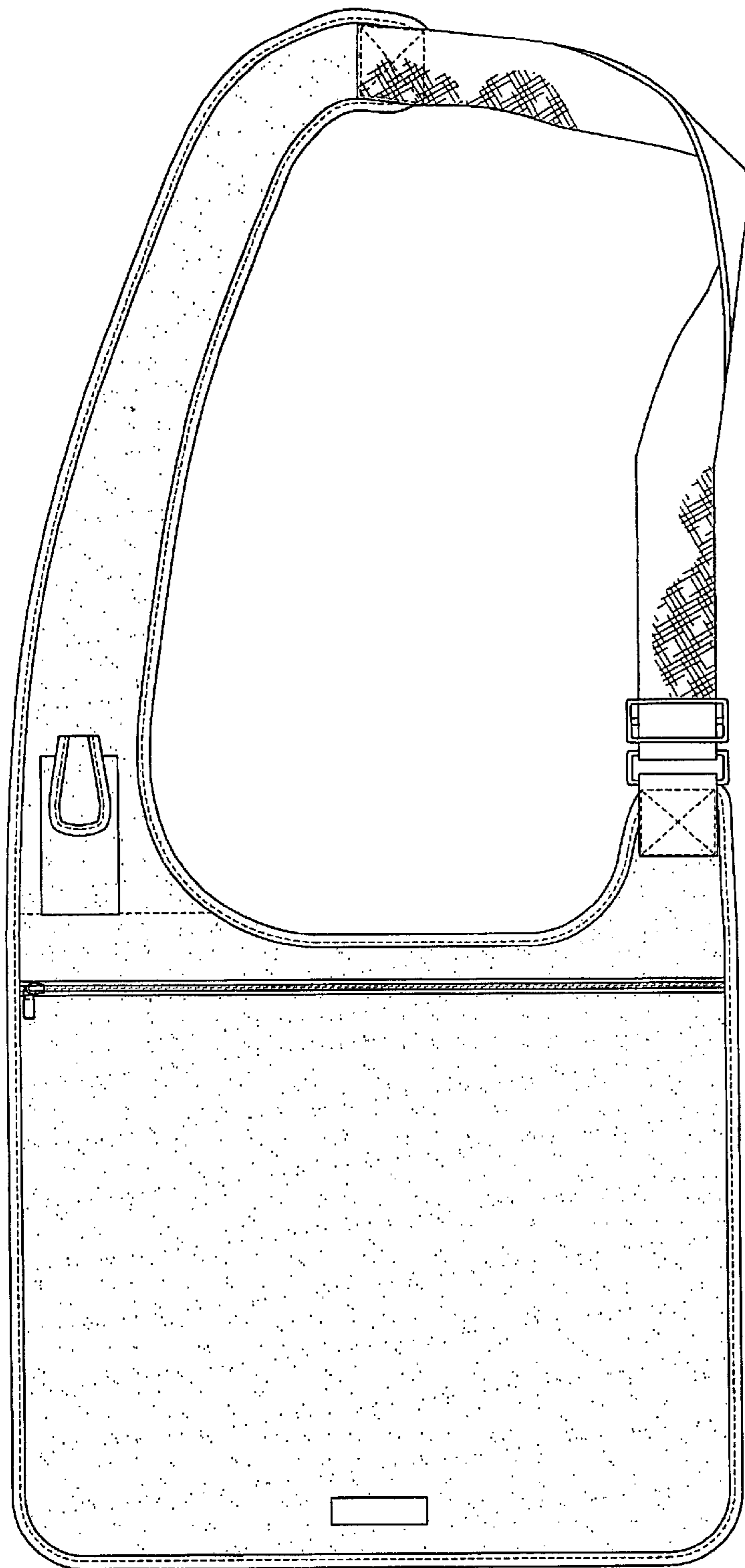

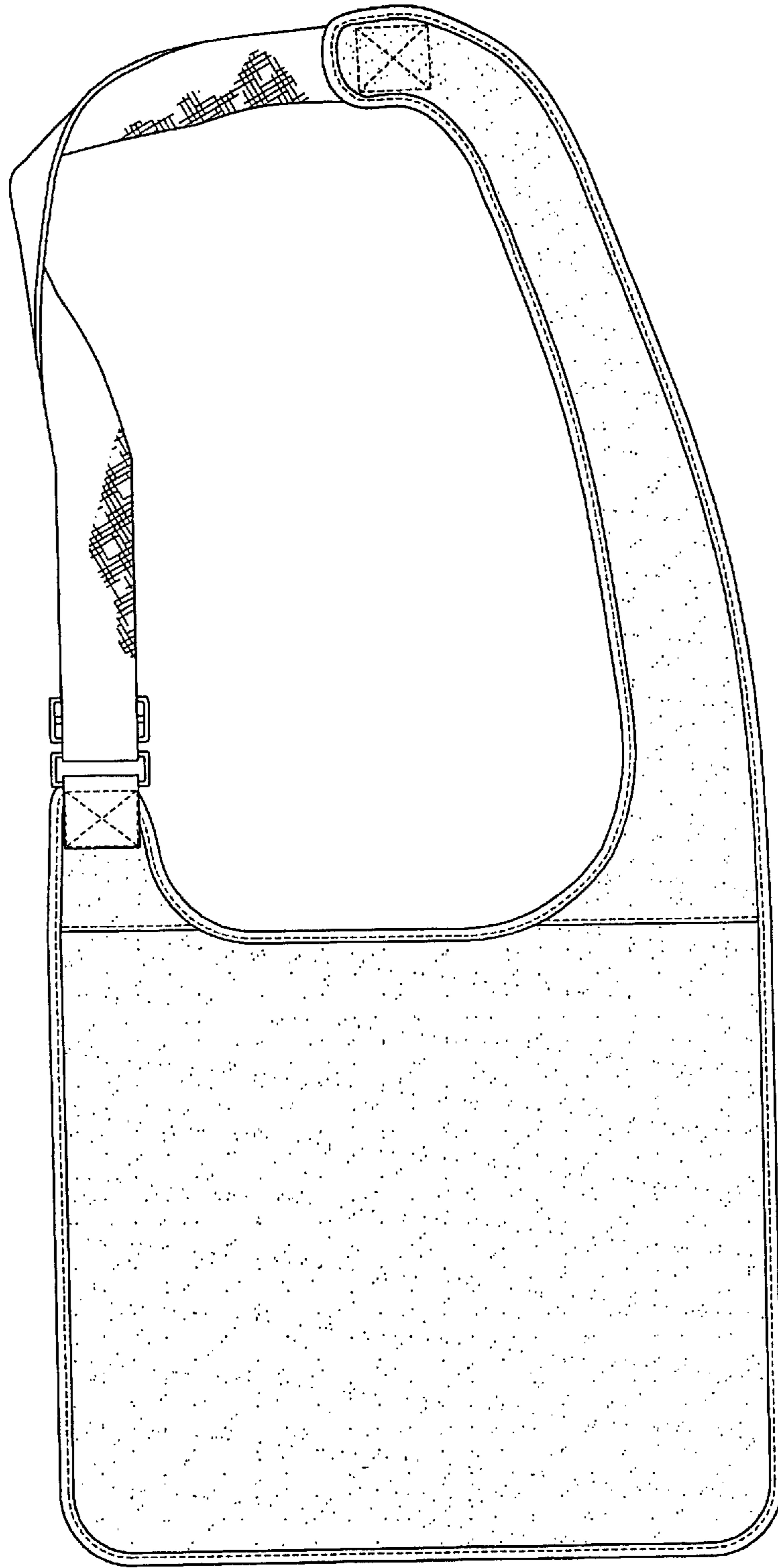

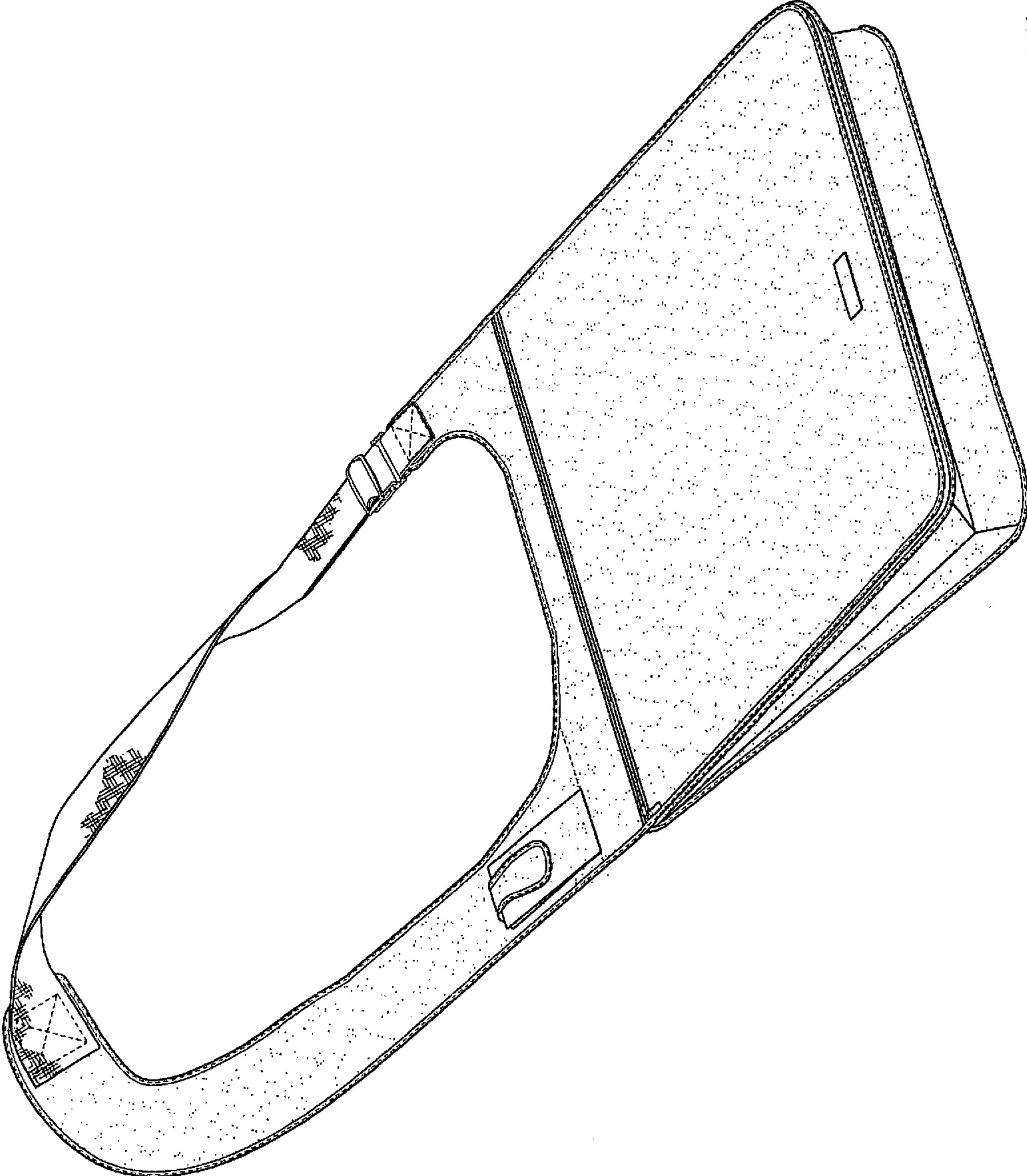

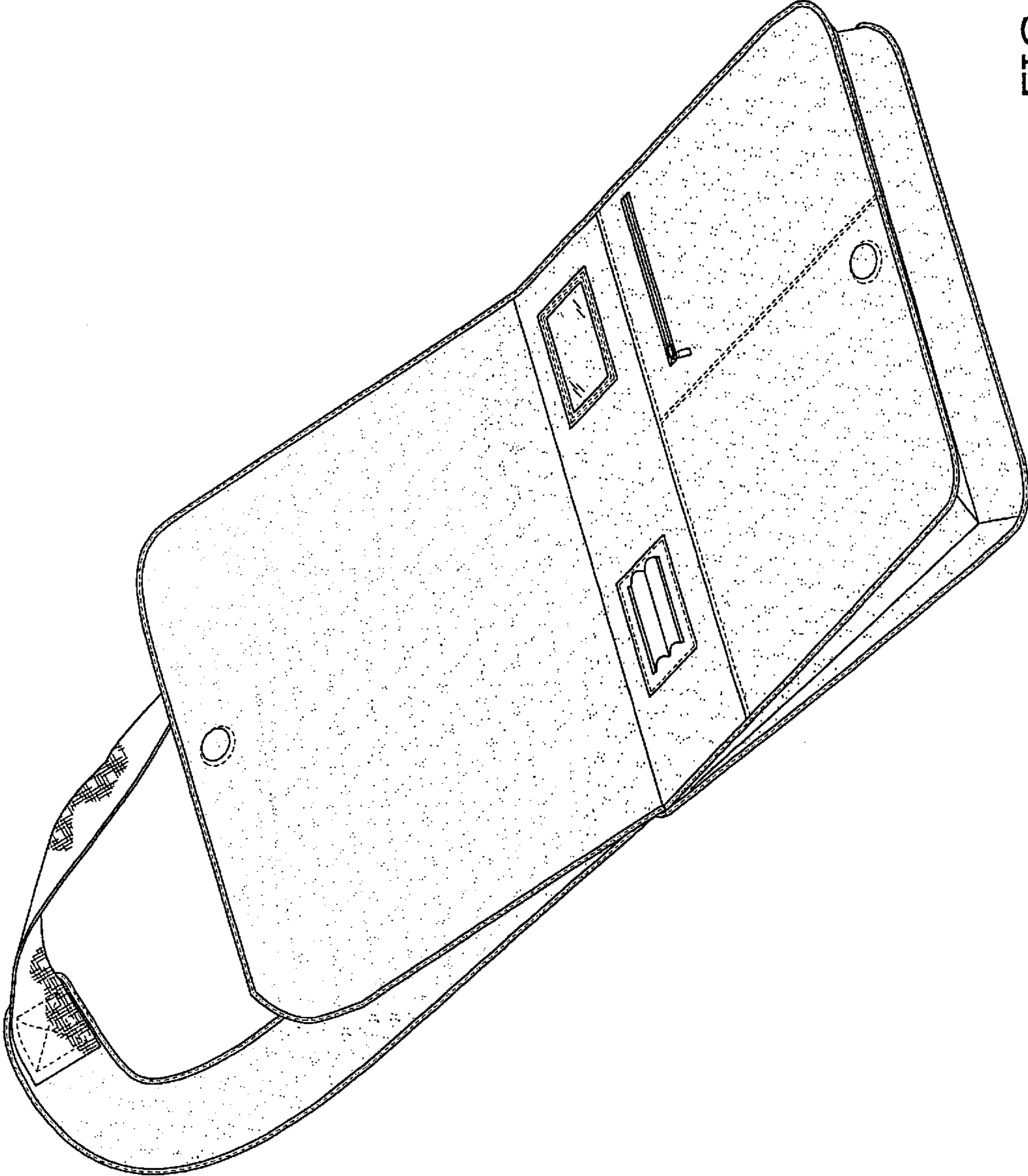

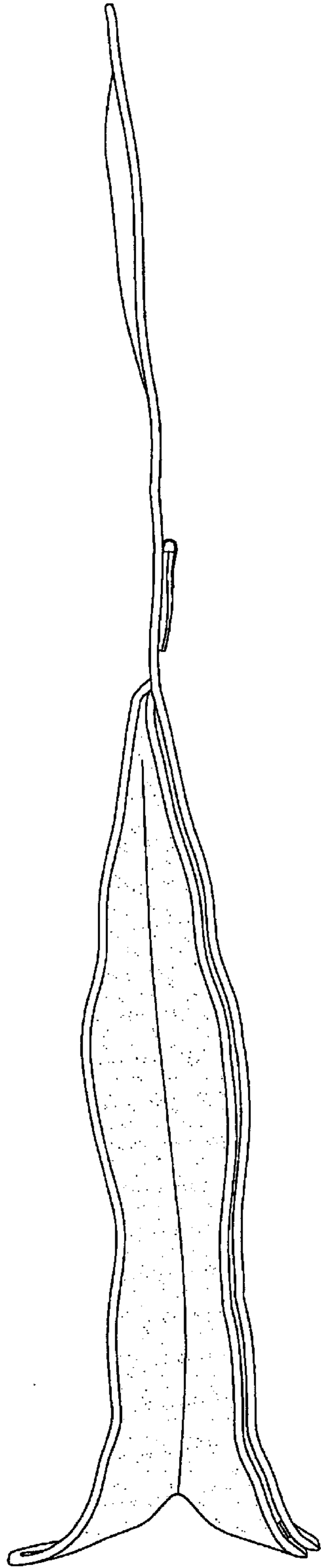

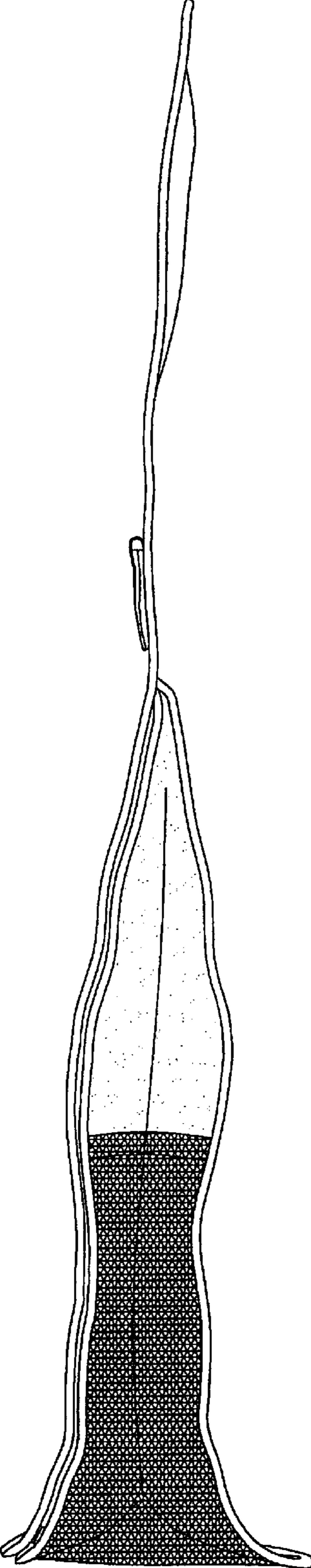

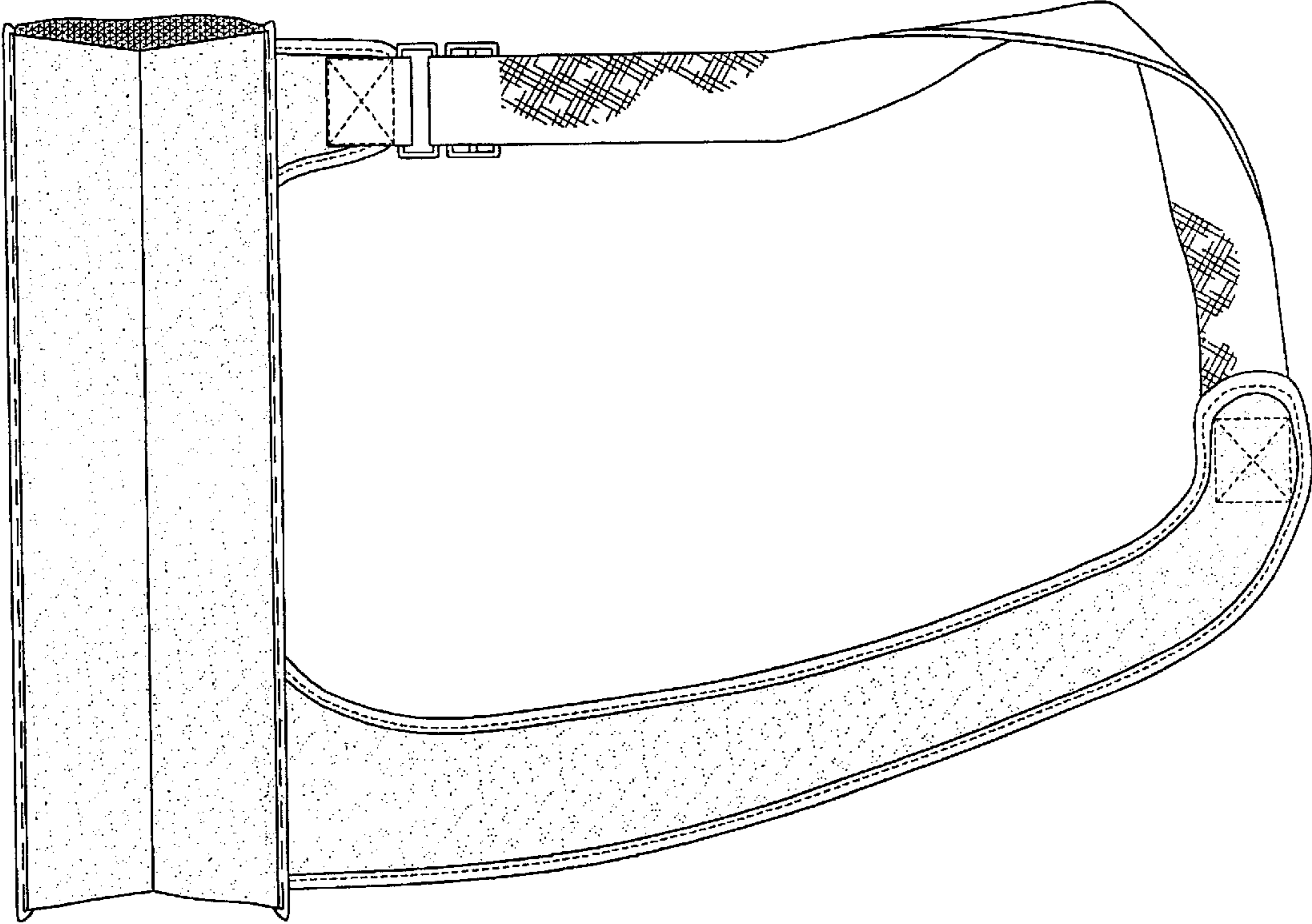

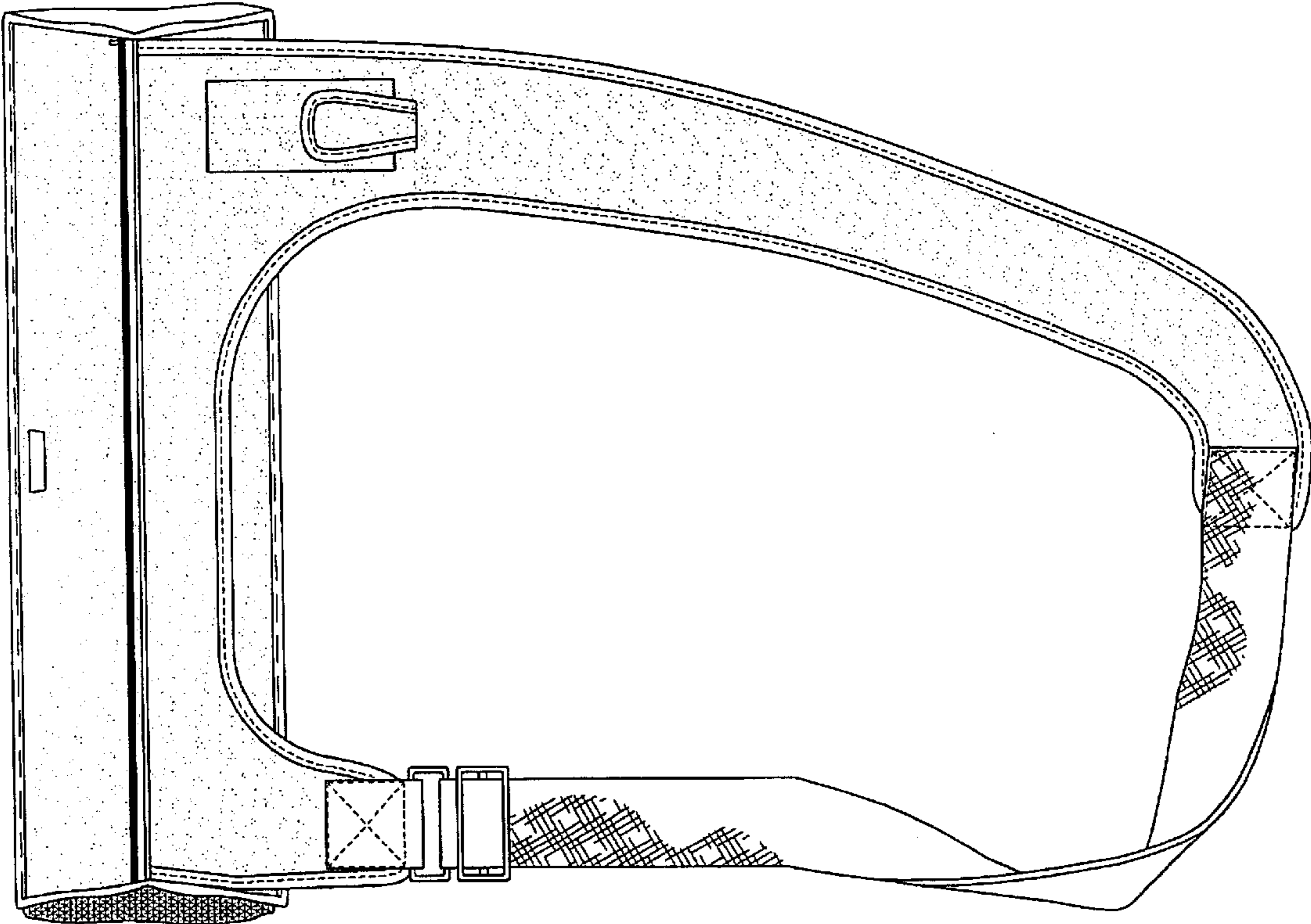
