**DESCRIPTION**

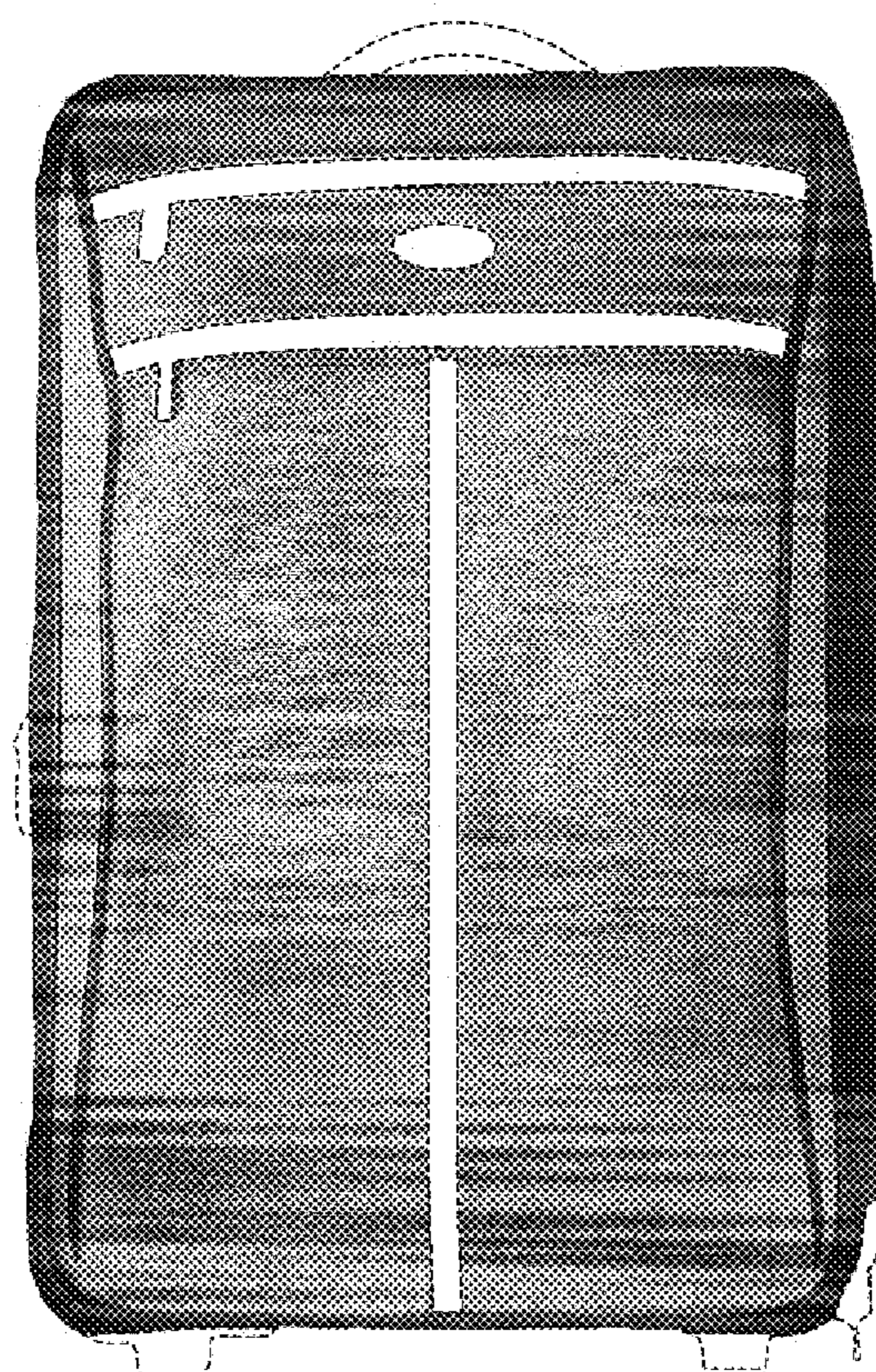
FIG. 1 provides a front elevational view of the piece of baggage.

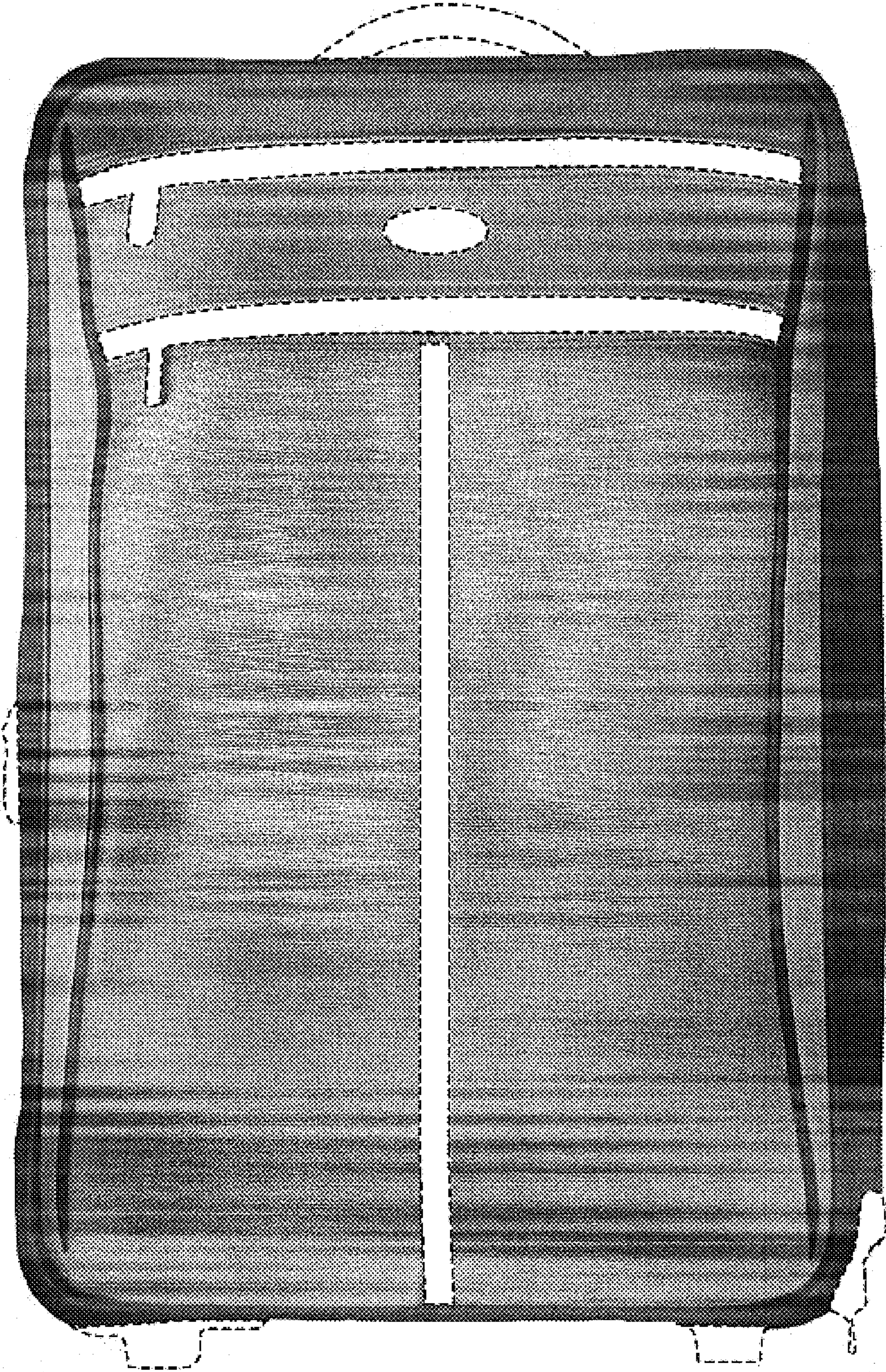

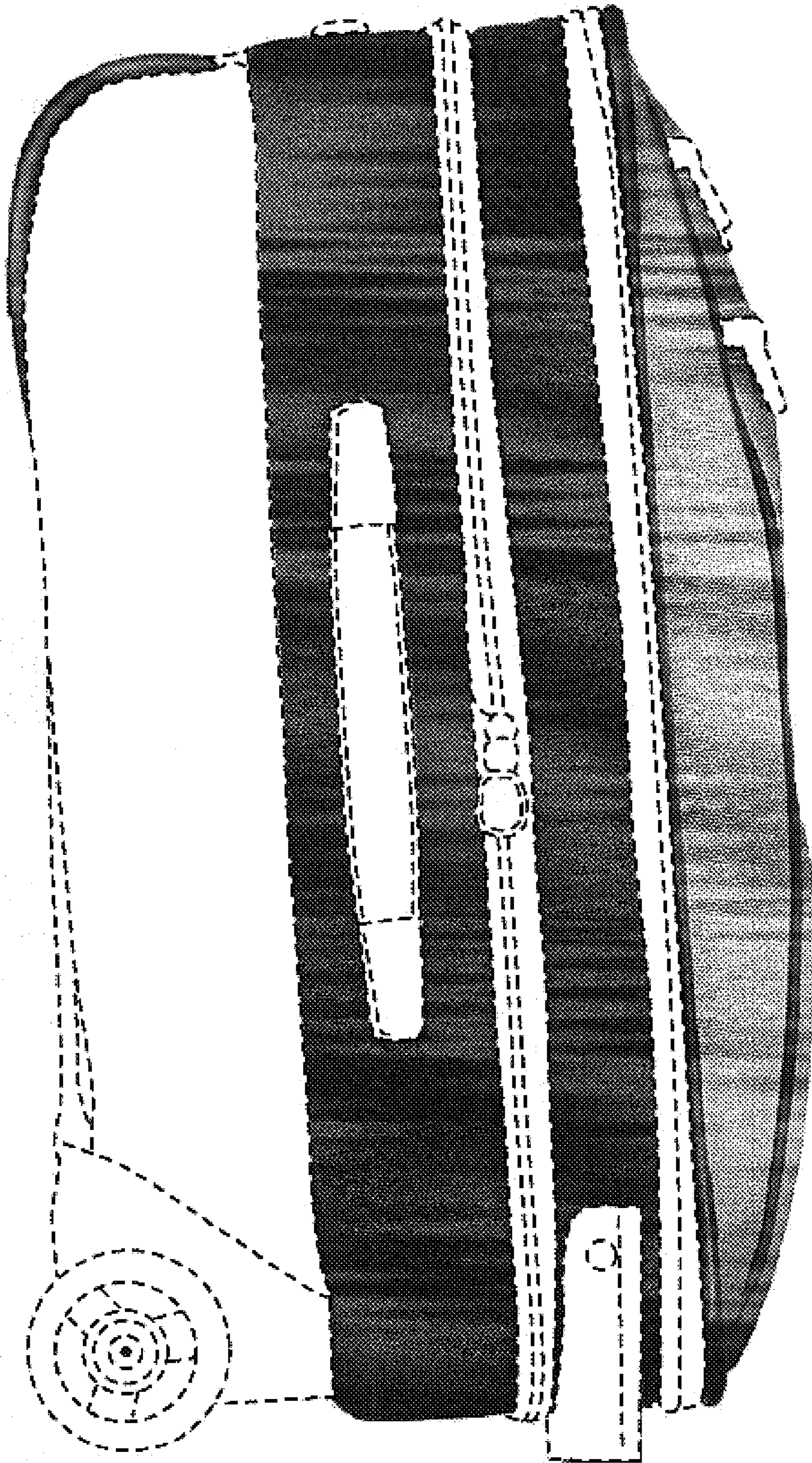

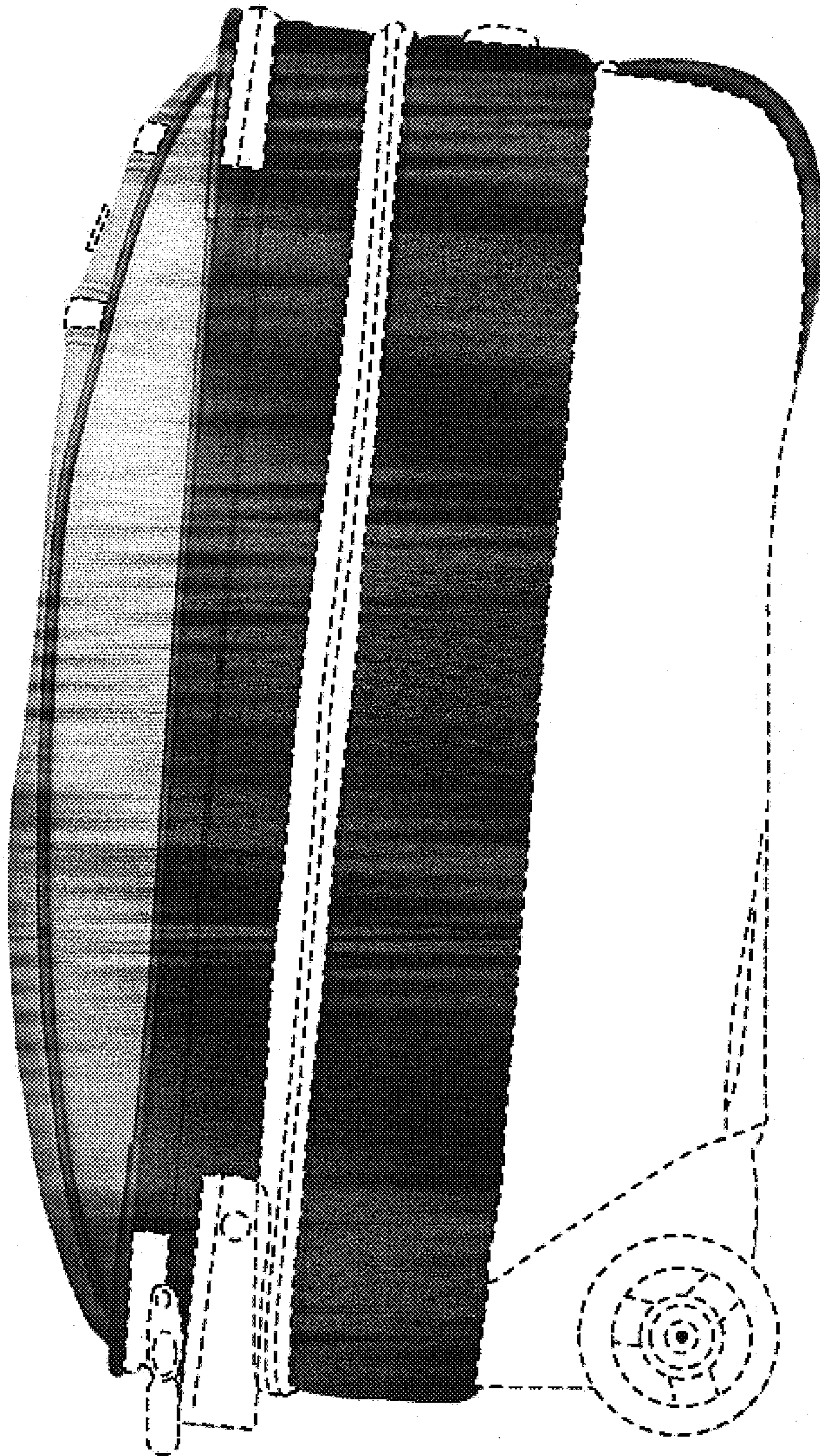

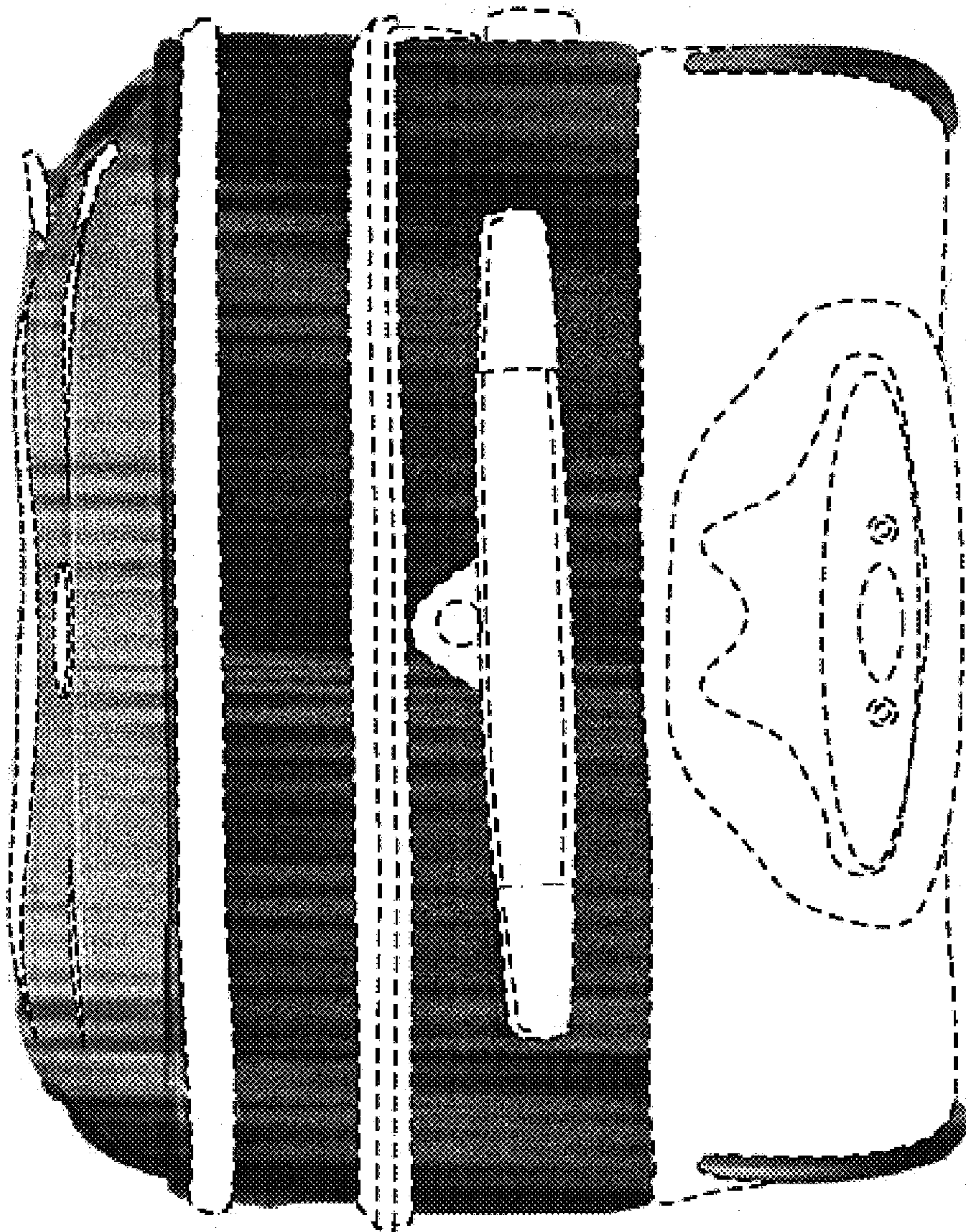

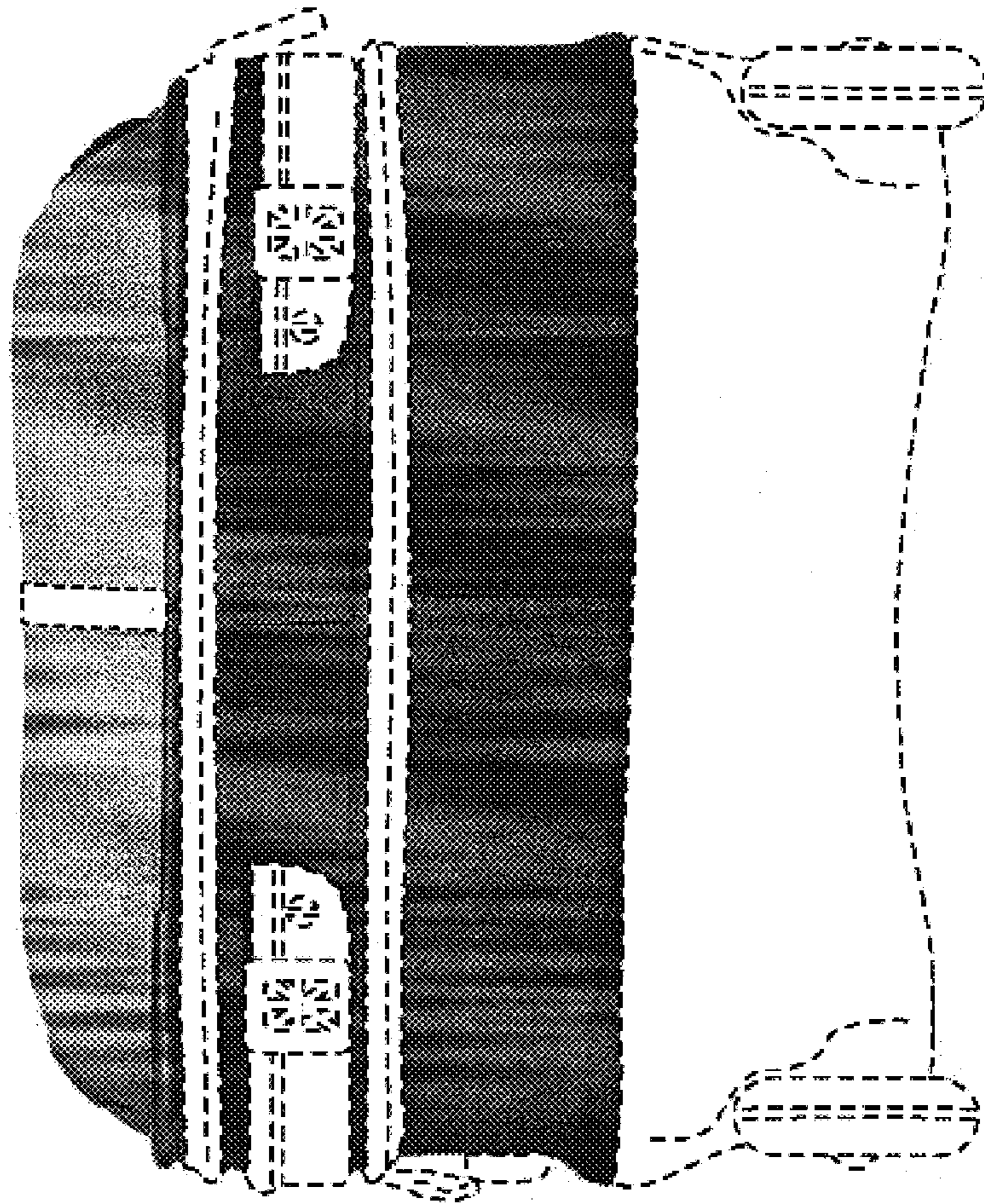
