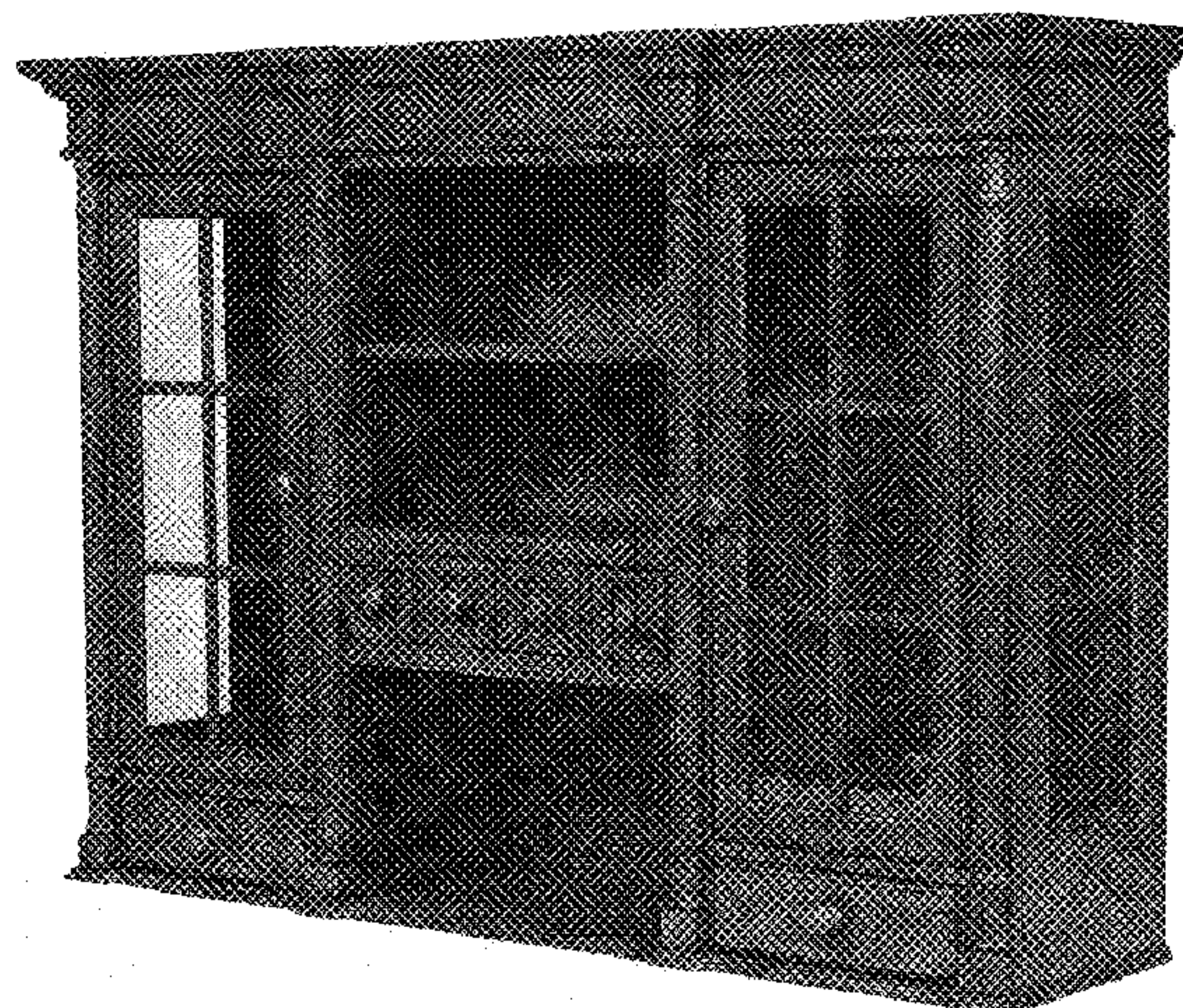
(57) **CLAIM**

The design for a china deck cabinet, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a china deck cabinet showing our new design, the reflection off the glass thereof not being a part of the design;  
FIG. 2 is a front perspective view thereof; and,  
FIG. 3 is a right side elevational view thereof, the reflection off the glass and thereof not being a part of the design, the left side being a mirror image of the right side.  
The surfaces or portions of the article not shown in the Figures or described in the specification form no part of the claimed design.

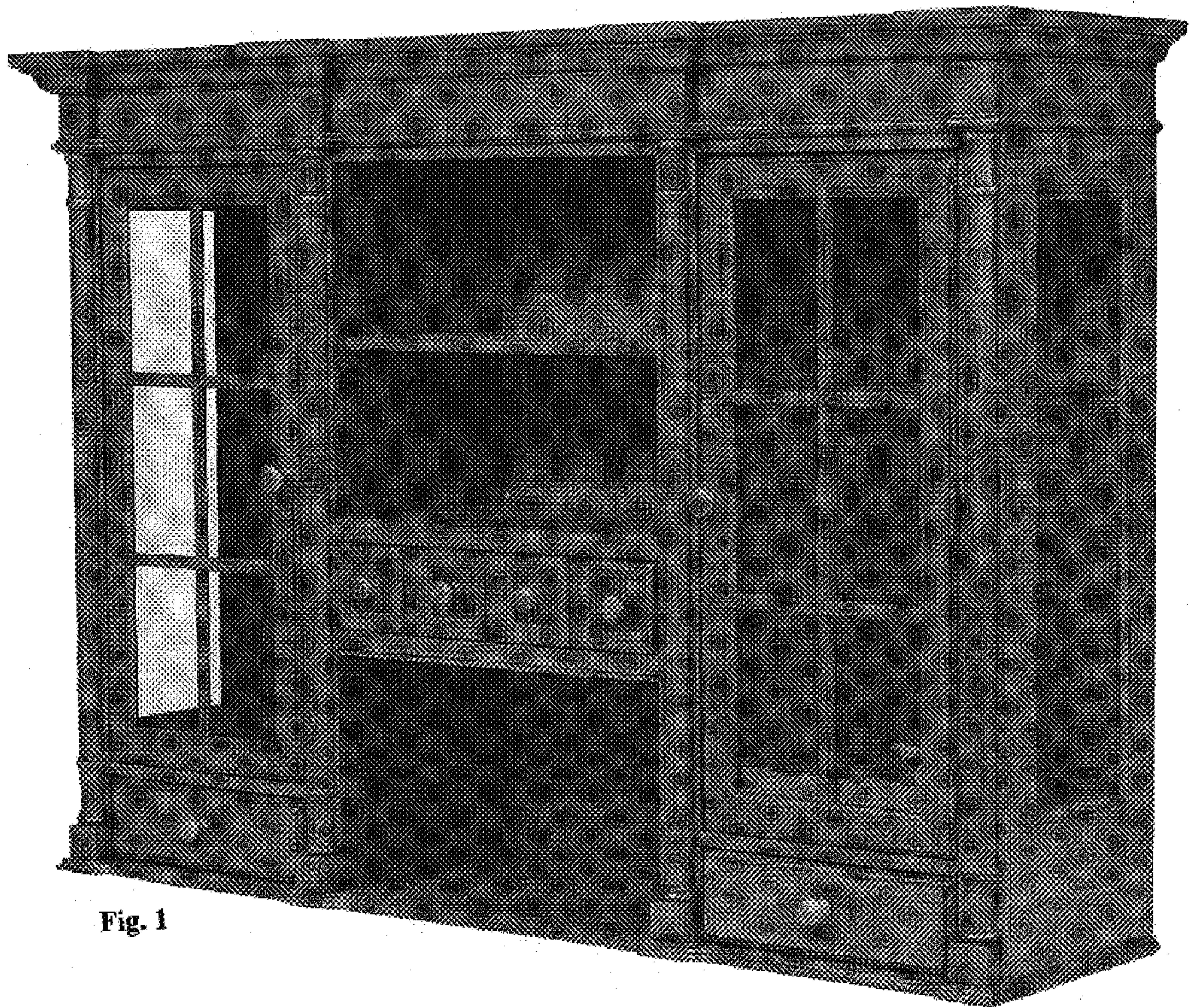

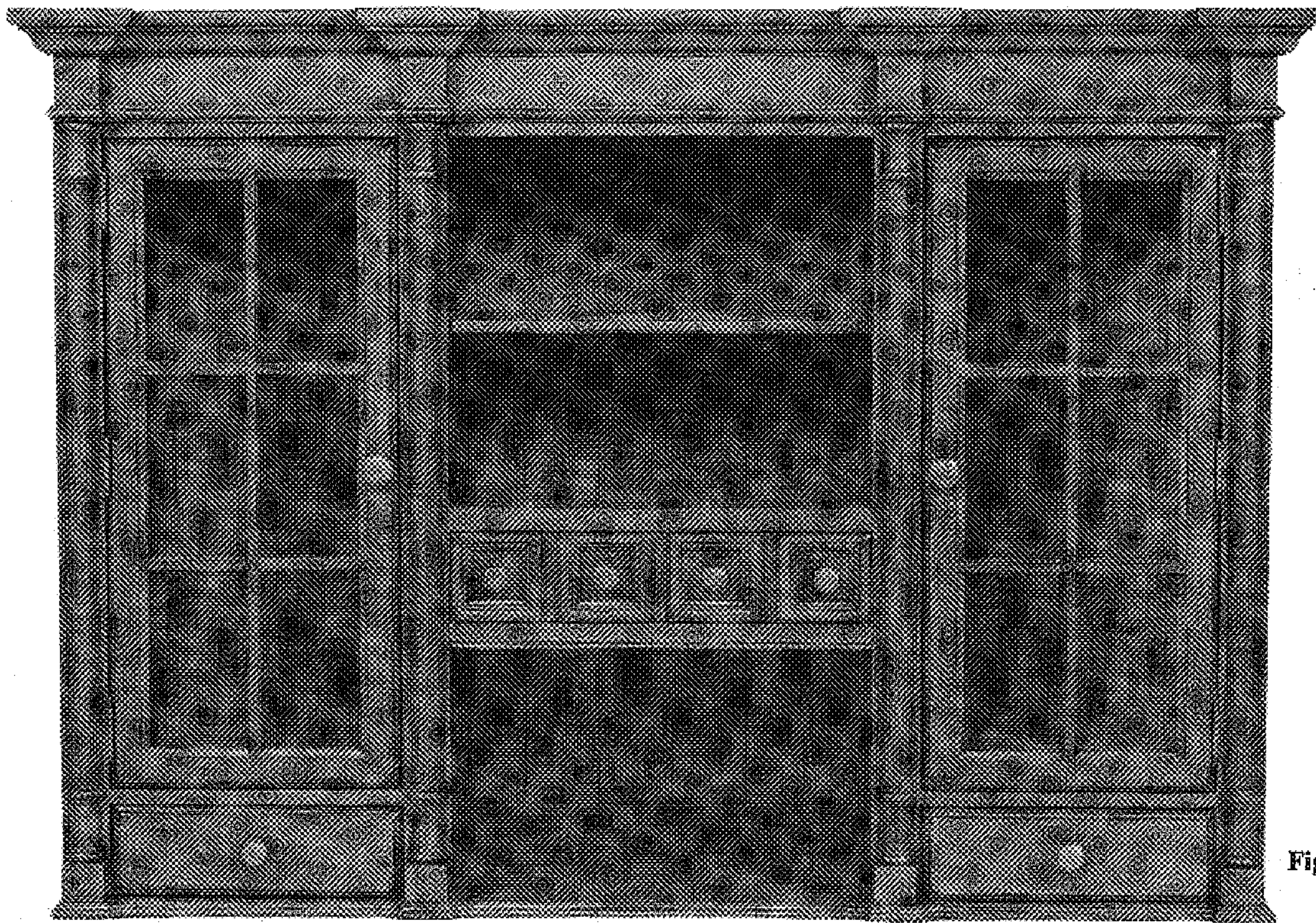

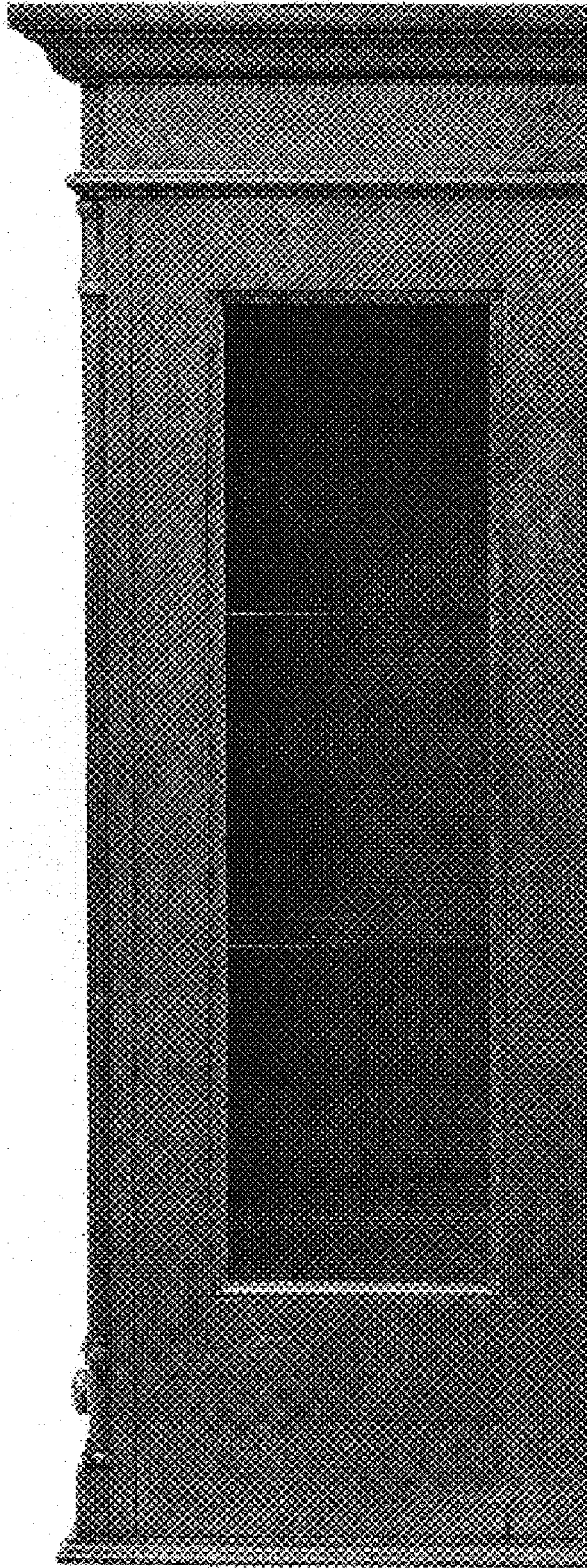
