**DESCRIPTION**

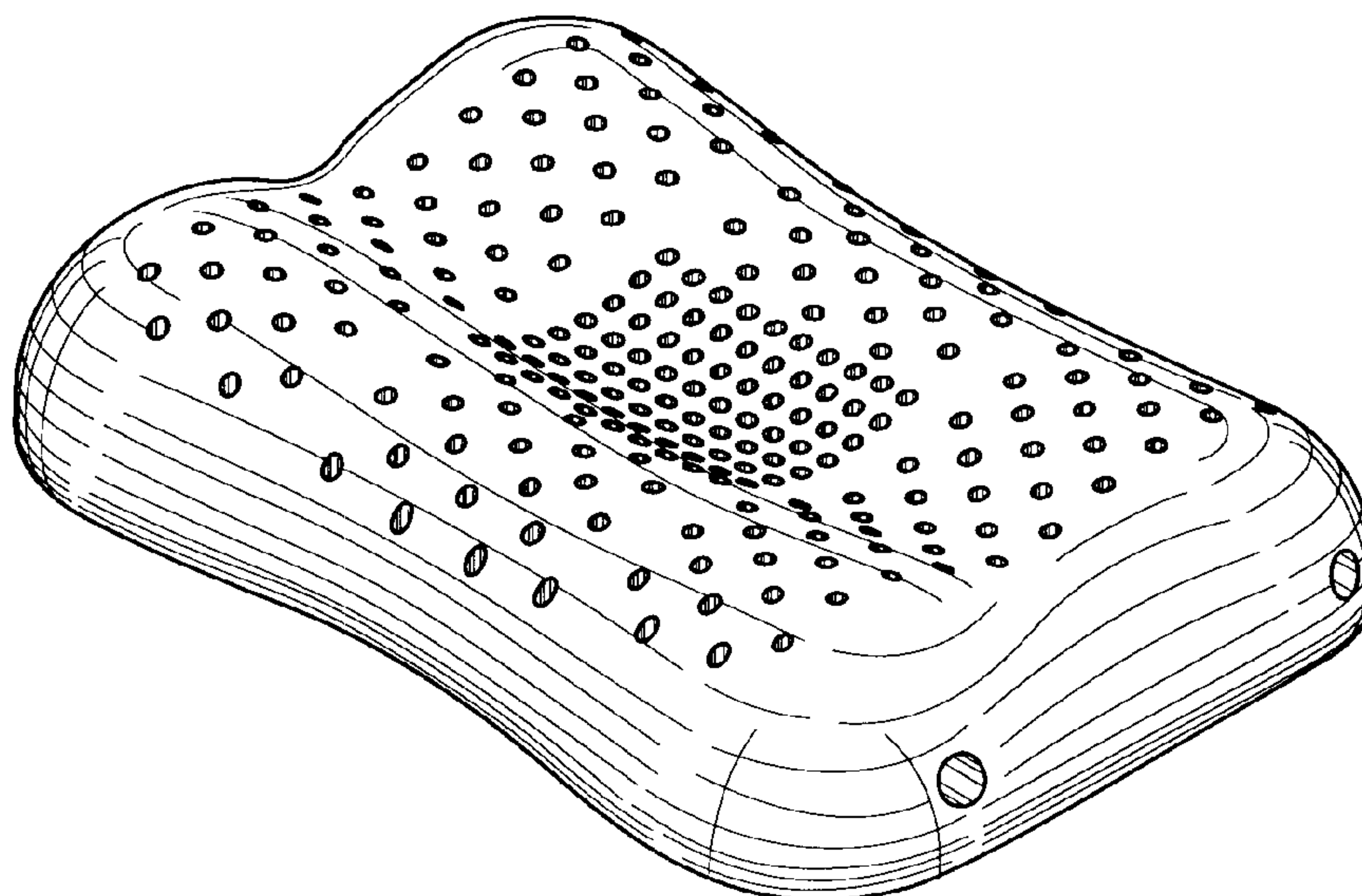

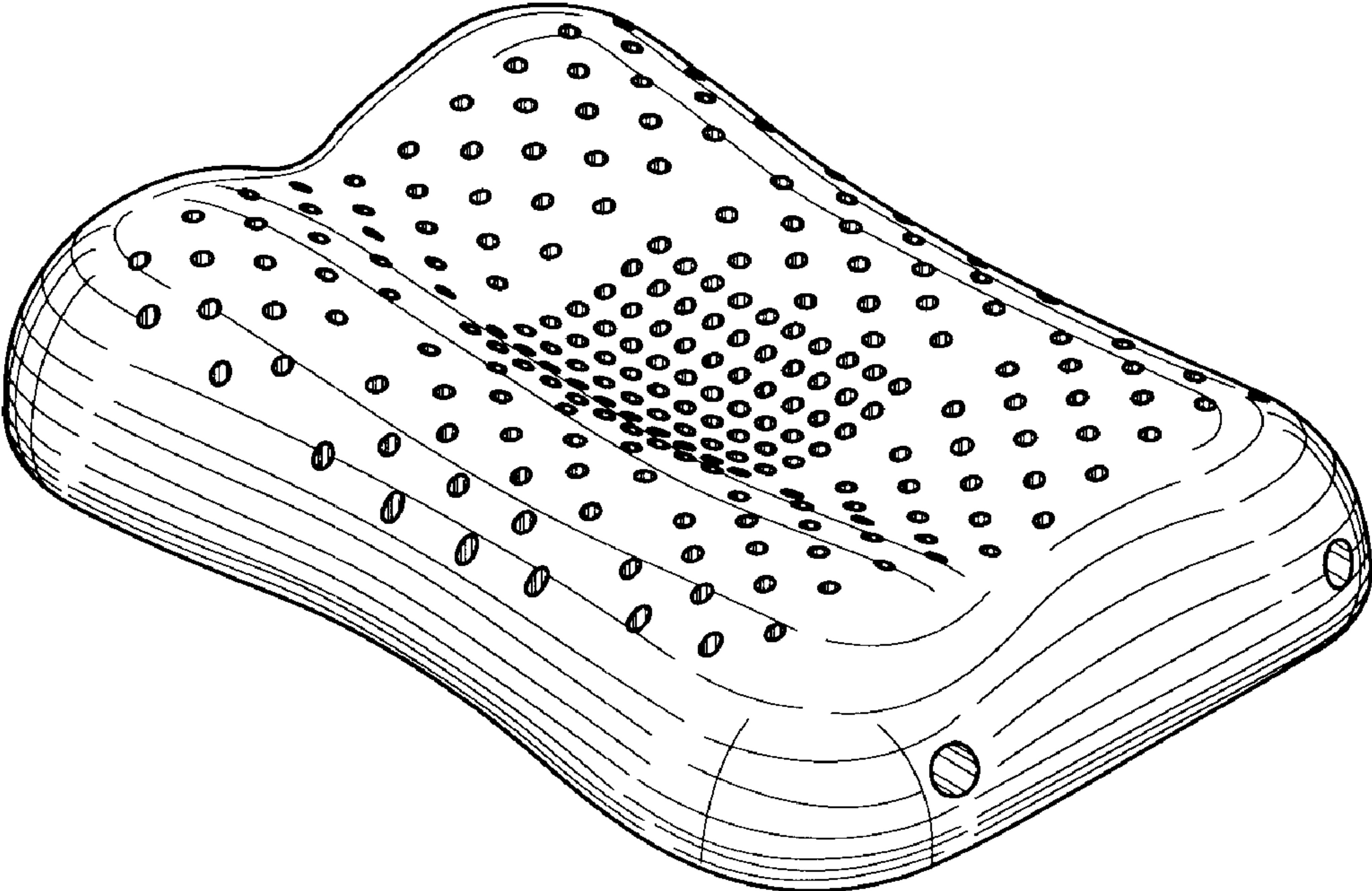

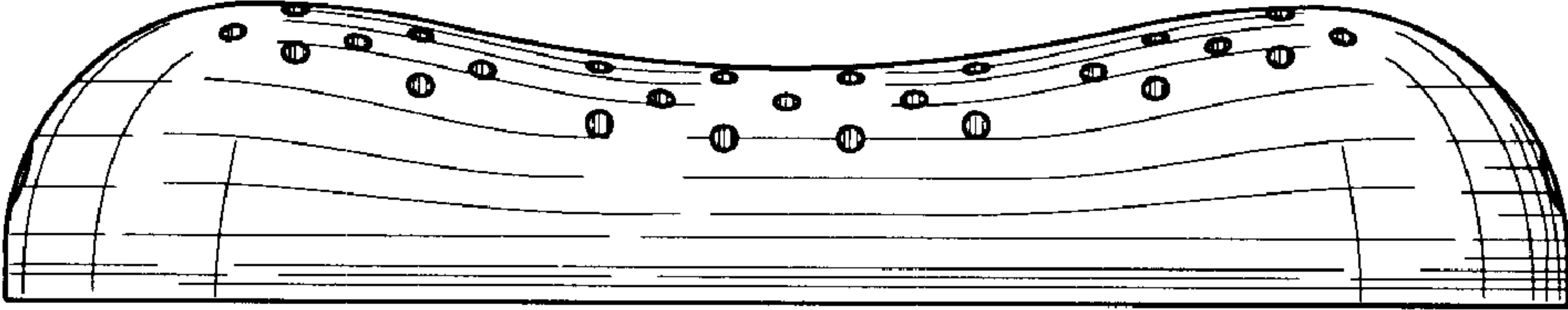

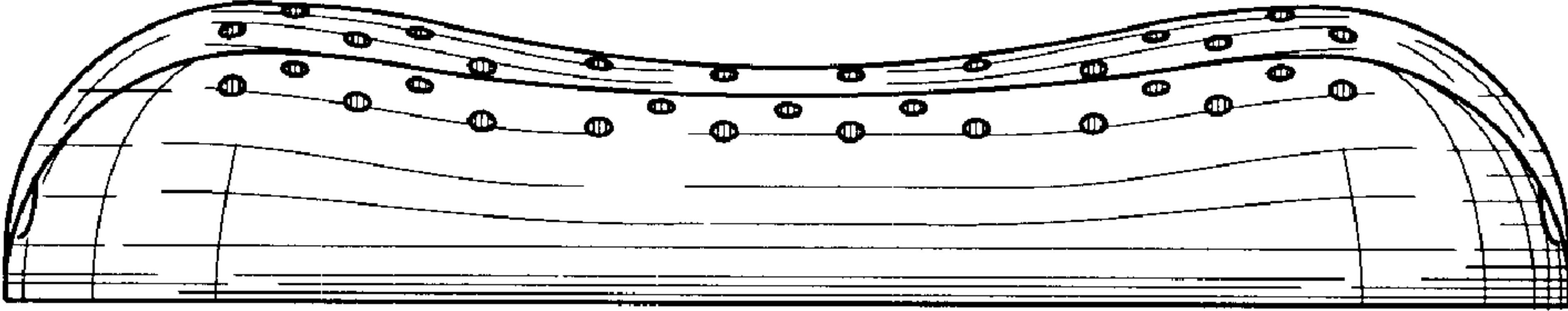

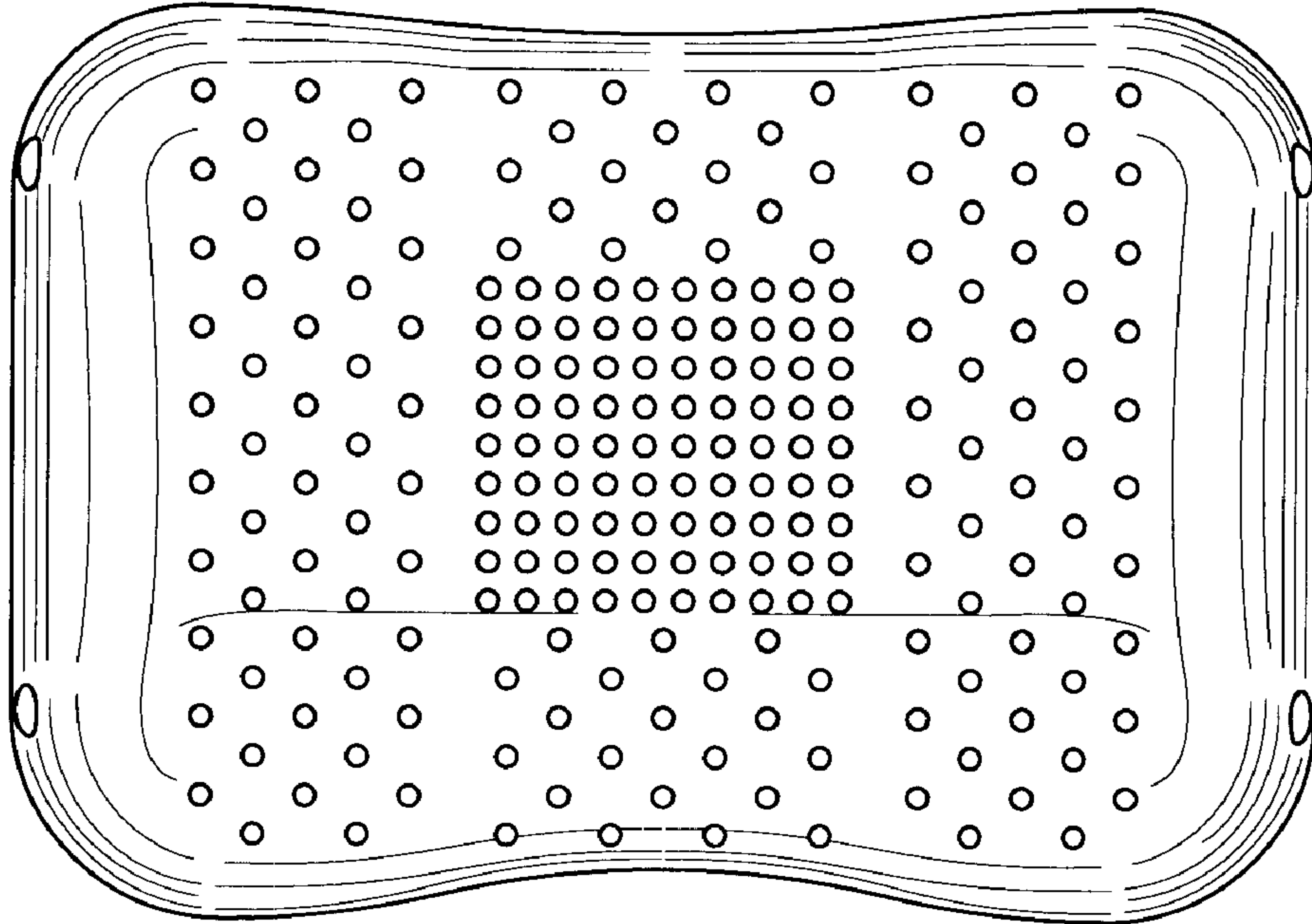

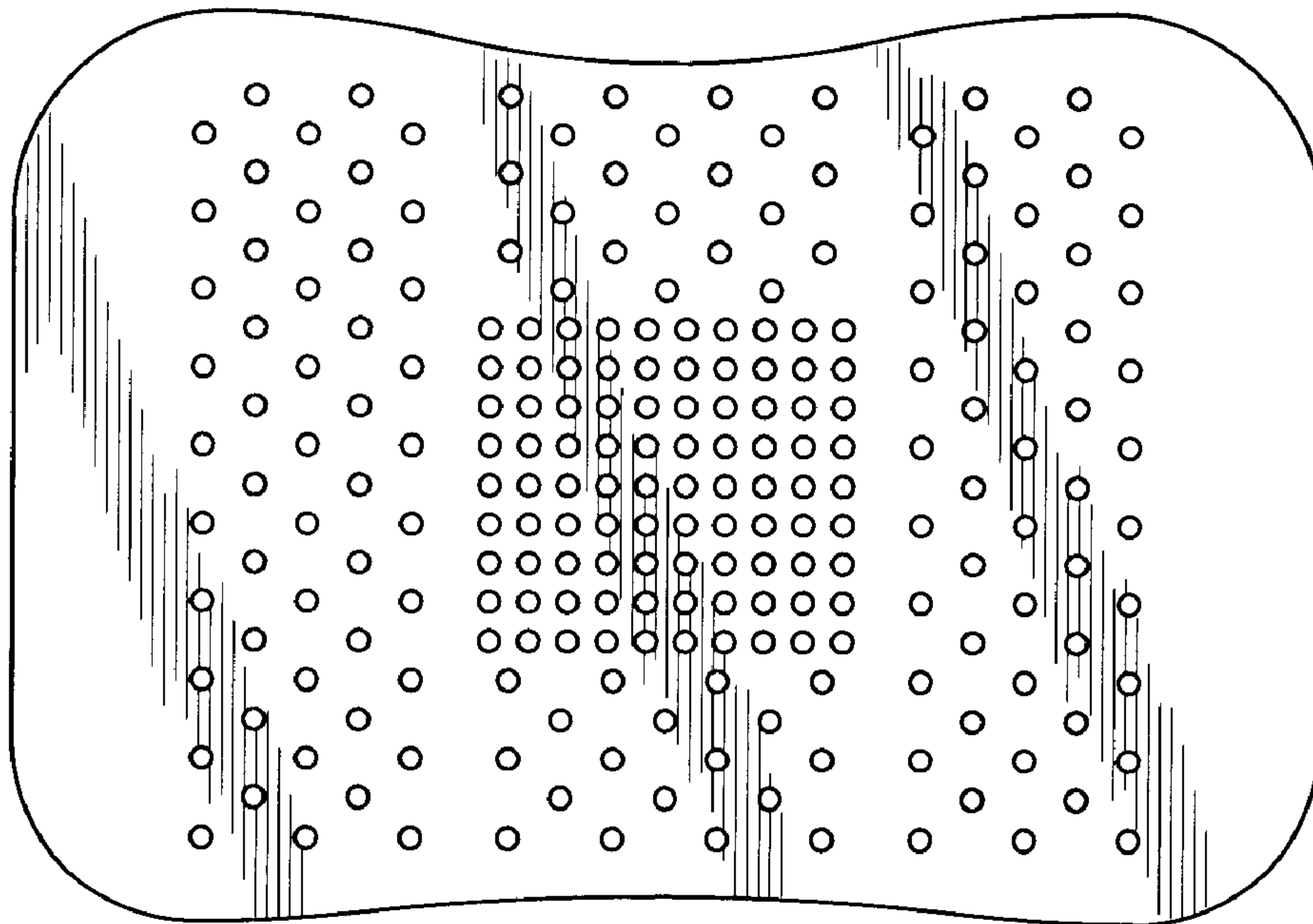

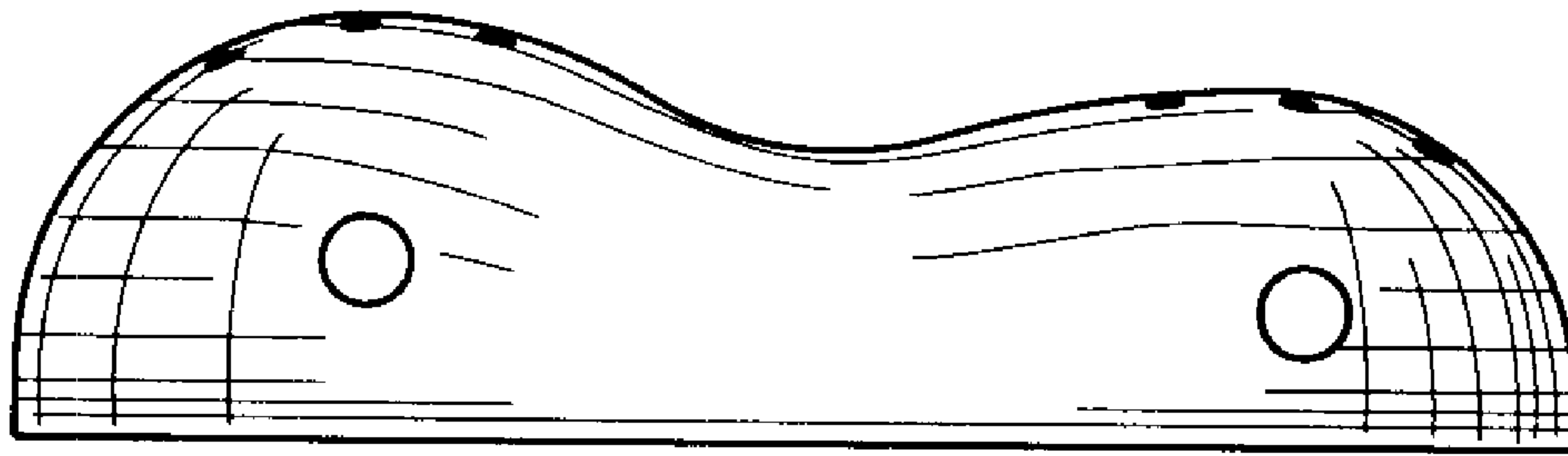
