DESCRIPTION

FIG. 1 is a perspective view of a handle of the new design; FIG. 2 is a side view of the handle of FIG. 1; FIG. 3 is a back view of the handle of FIG. 1; FIG. 4 is a top view of the handle of FIG. 1; FIG. 5 is a side view of the handle of FIG. 1; FIG. 6 is a front view of the handle of FIG. 1; and, FIG. 7 is a bottom view of the handle of FIG. 1. The portions of the Figures shown in phantom lines are not part of the claimed design but are for illustration only.

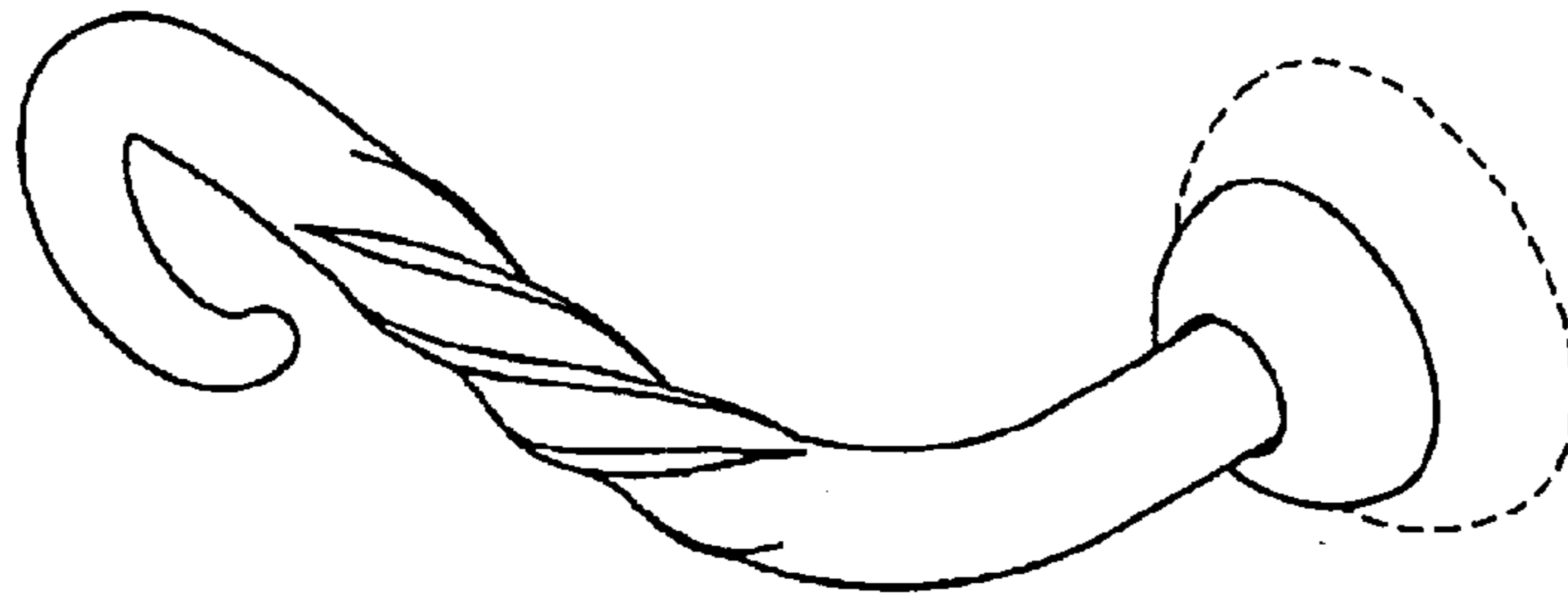

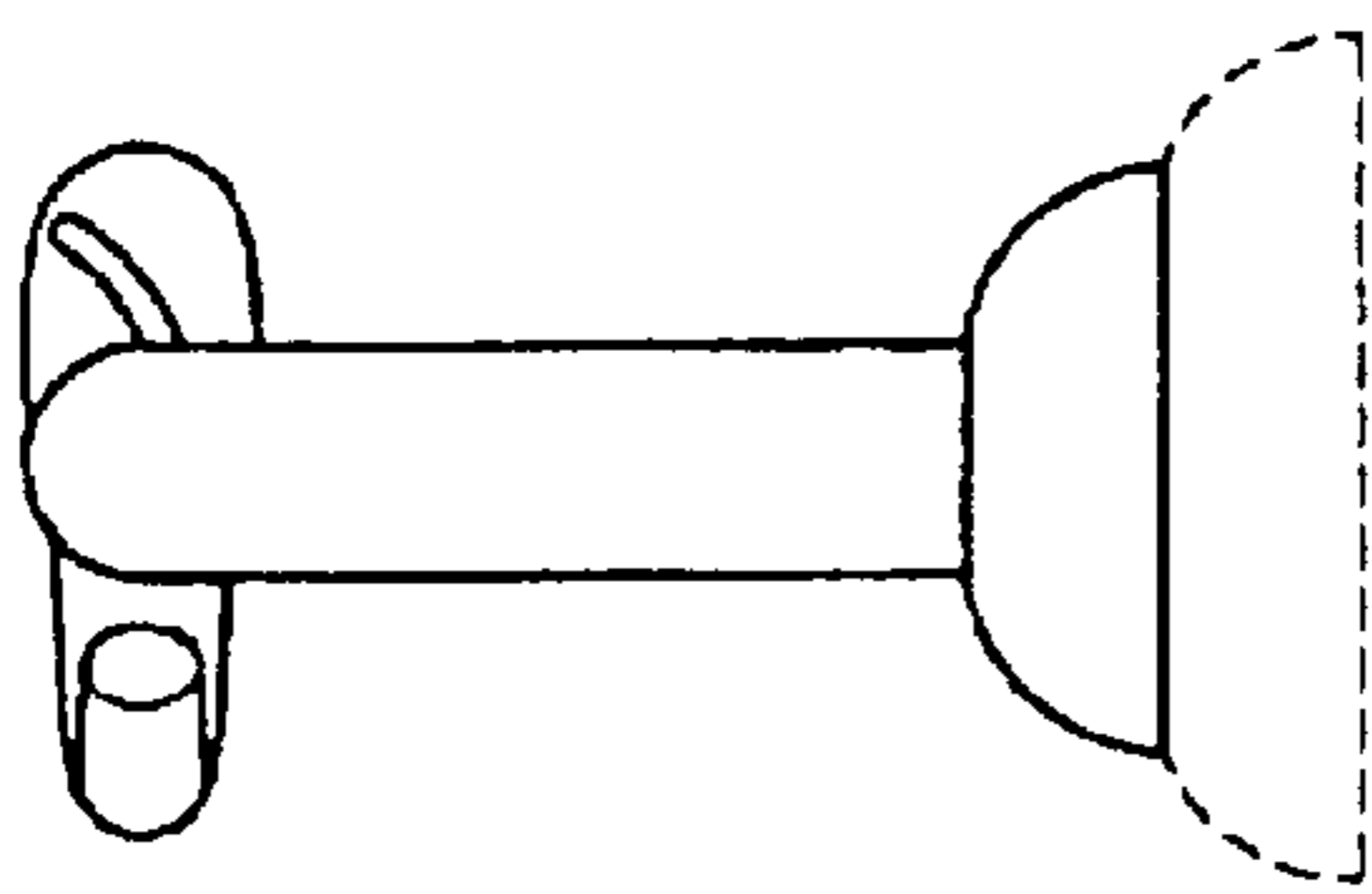

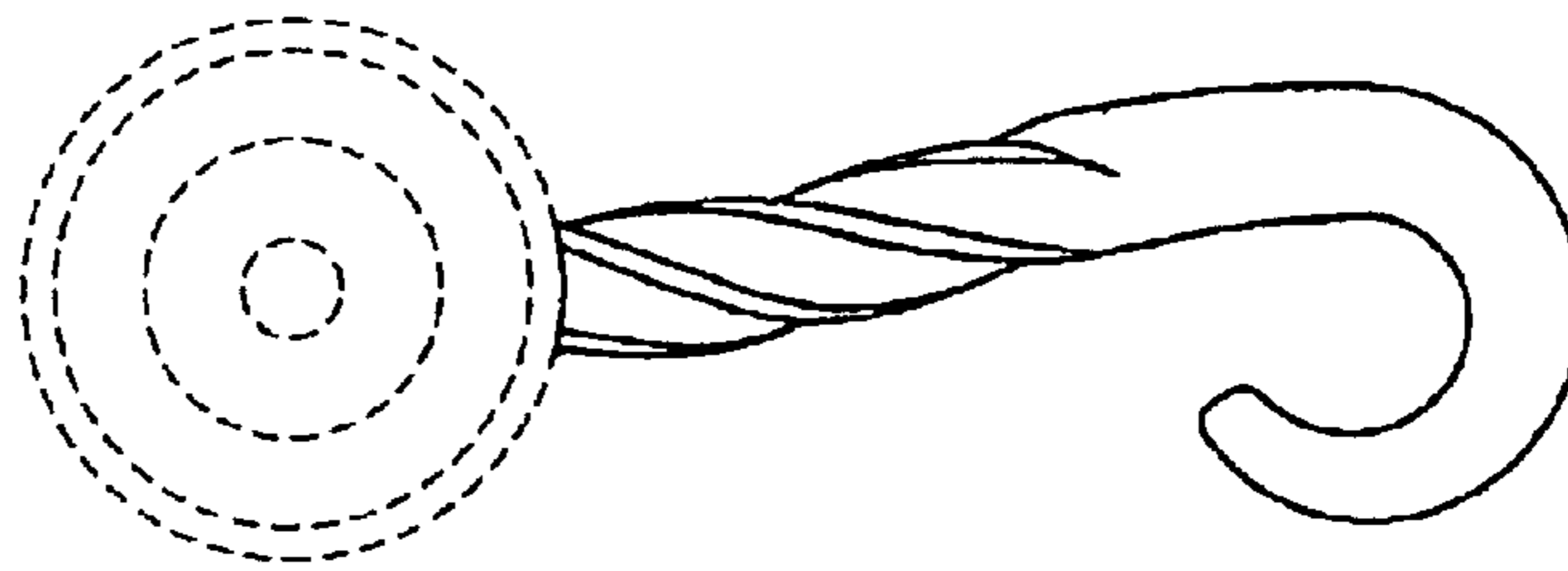

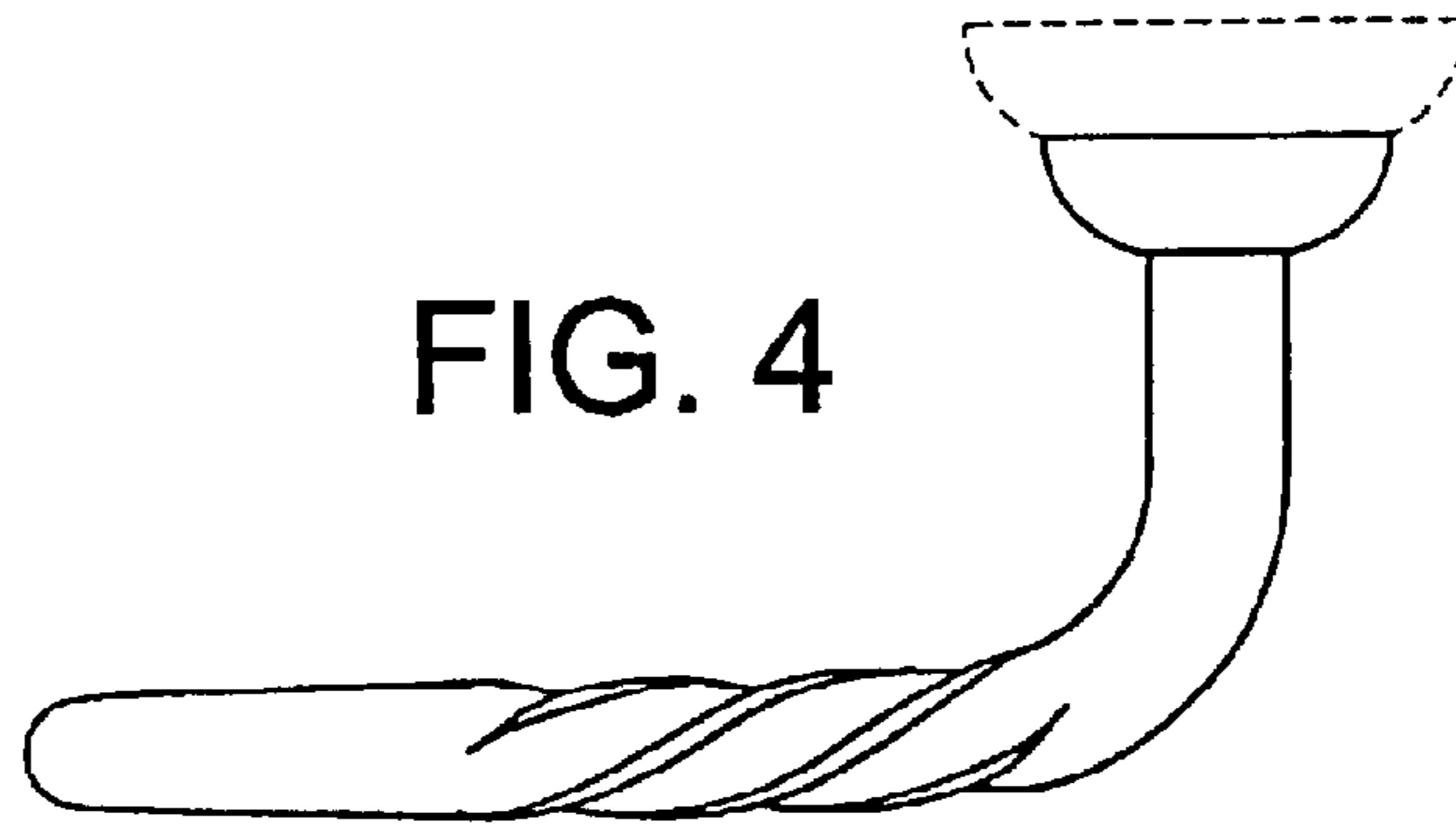

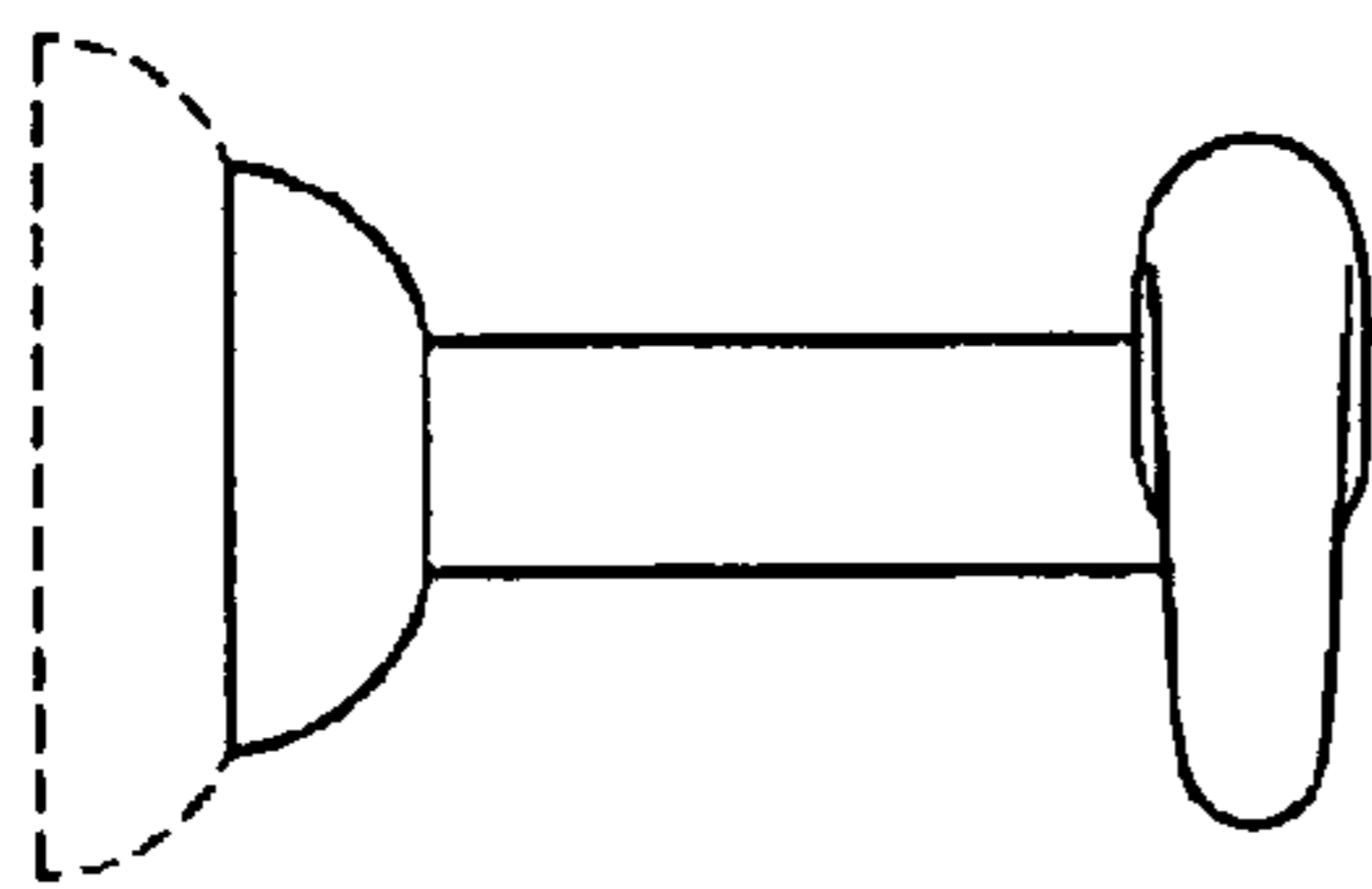

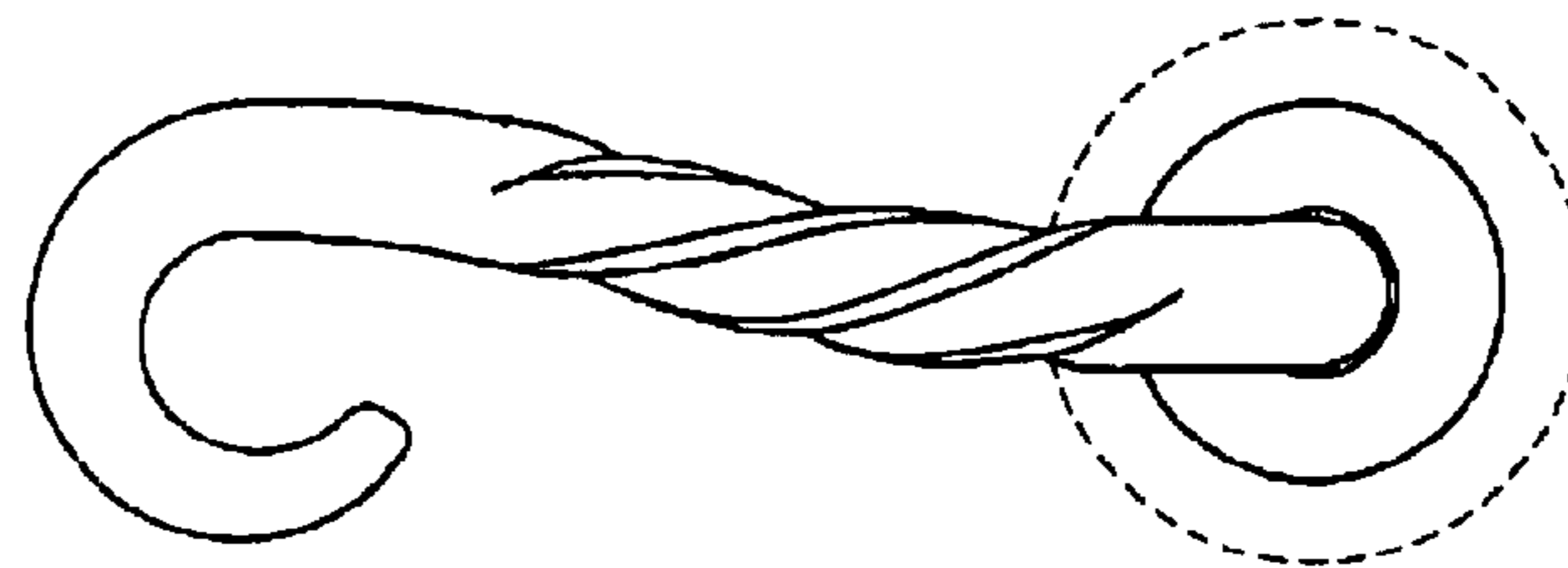

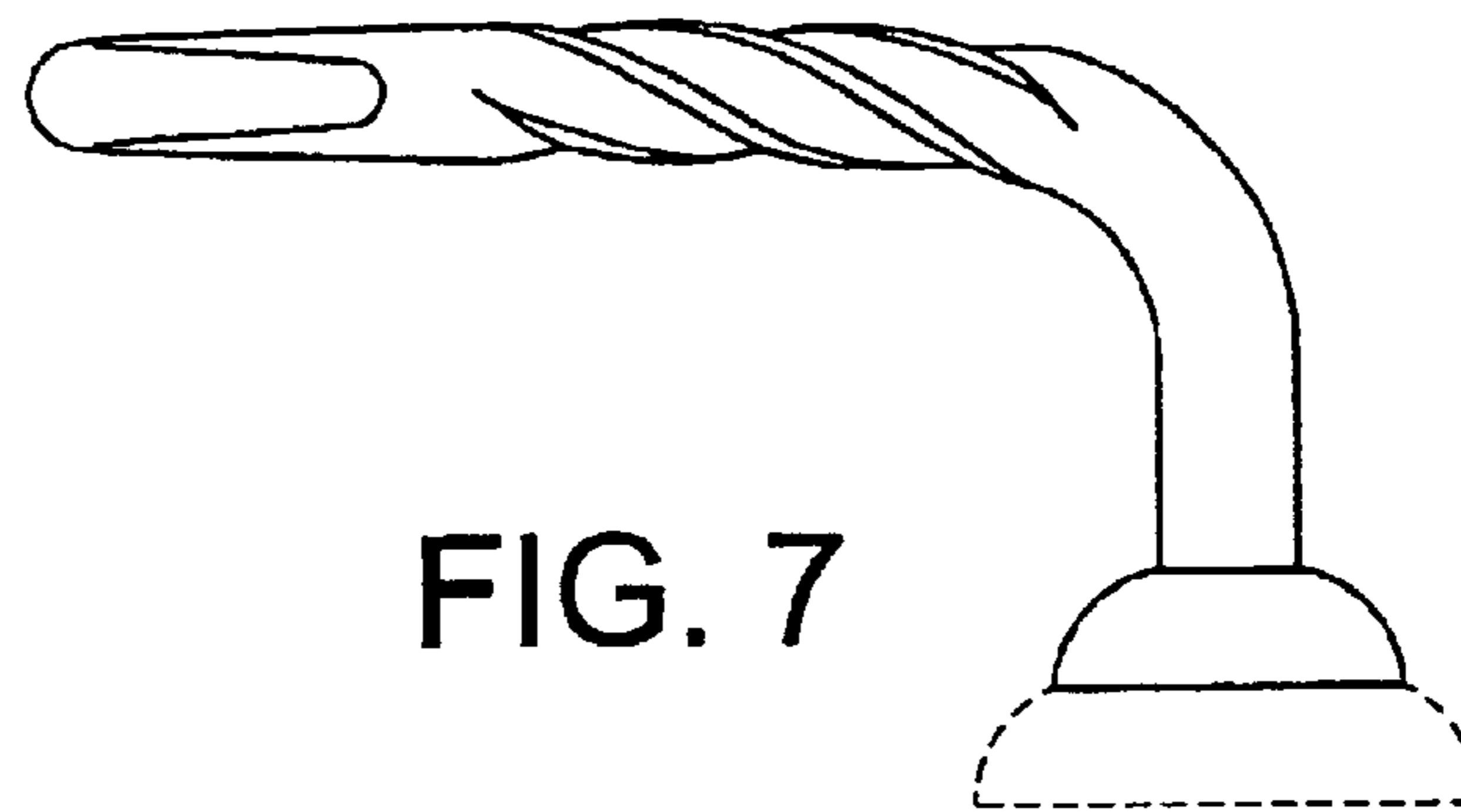
