(57) **CLAIM**

The ornamental design for a motorcycle aerodynamic storage trailer, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper front right perspective view of a first embodiment design of the novel motorcycle aerodynamic storage trailer, and the broken lines are intended to represent a tow hitch, wheel and bumper which are not intended to be part of the invention

FIG. 2 is an upper rear left perspective view of the first embodiment design of FIG. 1.

FIG. 3 is a right side view of the first embodiment design of FIG. 1.

FIG. 4 is a left side view of the first embodiment design of FIG. 1.

FIG. 5 is a rear view of the first embodiment design of FIG. 1.

FIG. 6 is a front view of the first embodiment design of FIG. 1.

FIG. 7 is a top view of the first embodiment design of FIG. 1.

FIG. 12 is a left side view of the second embodiment design of FIG. 9.

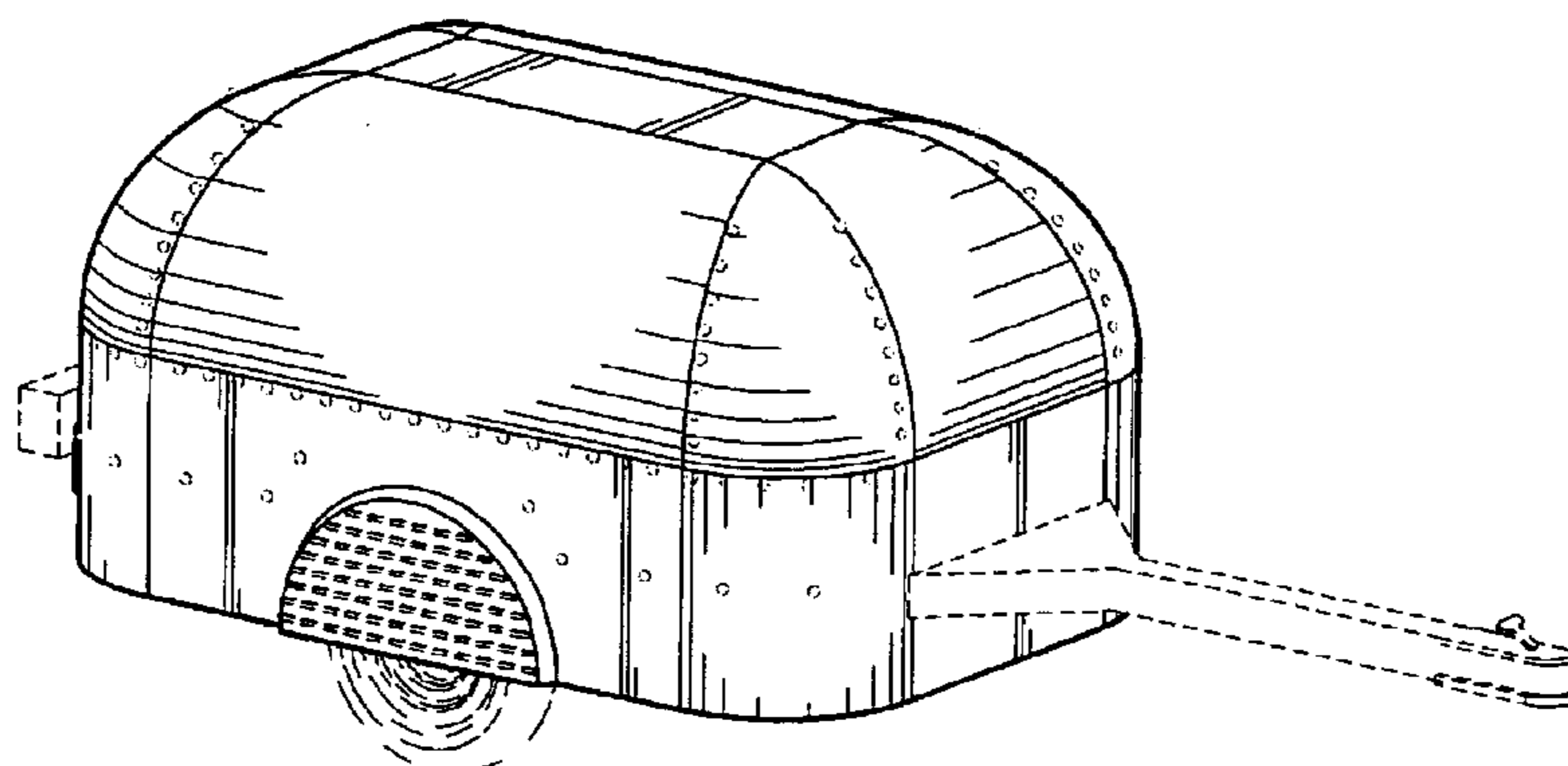
FIG. 13 is a rear view of the second embodiment design of FIG. 9.

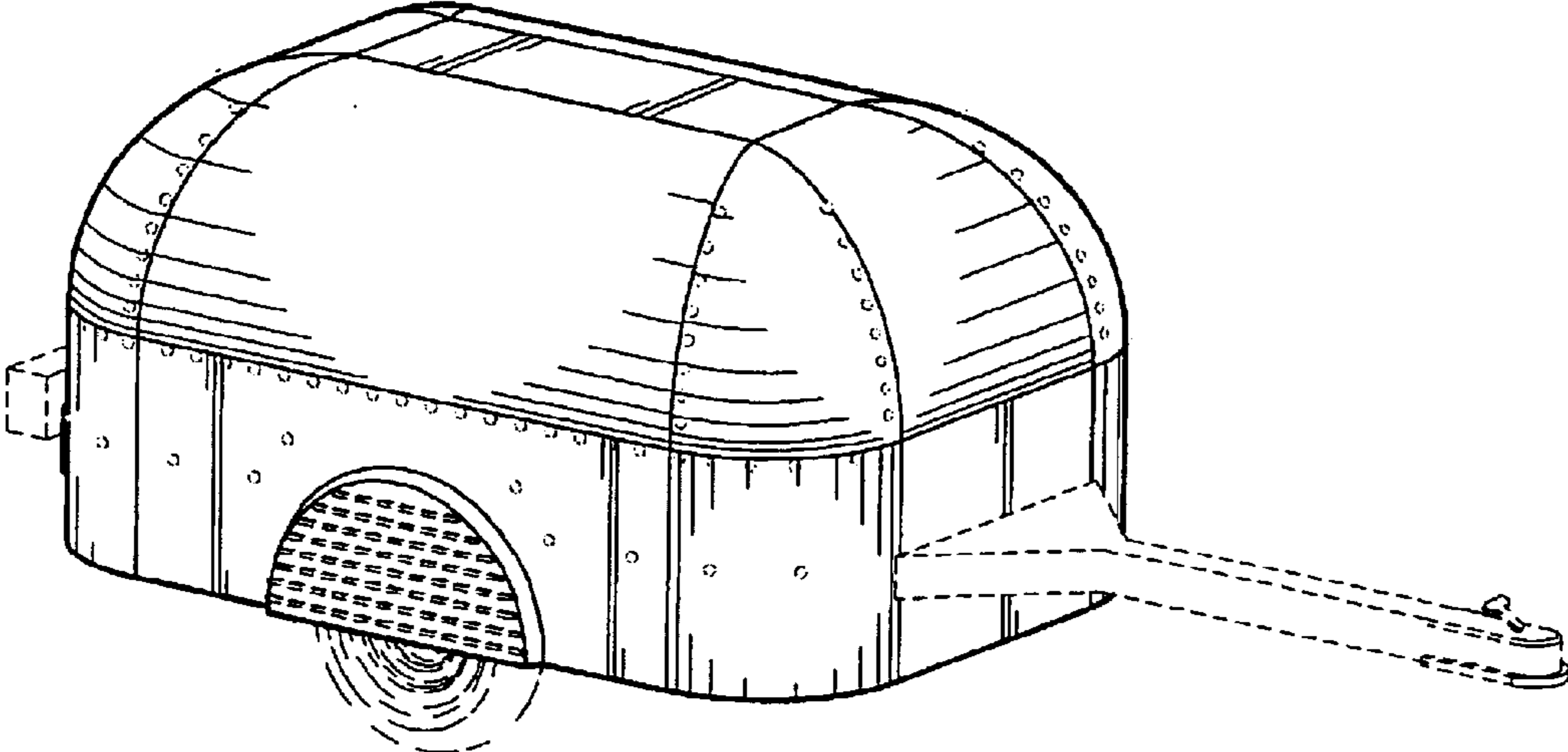
FIG. 14 is a front view of the second embodiment design of FIG. 9.

FIG. 15 is a top view of the second embodiment design of FIG. 9; and,

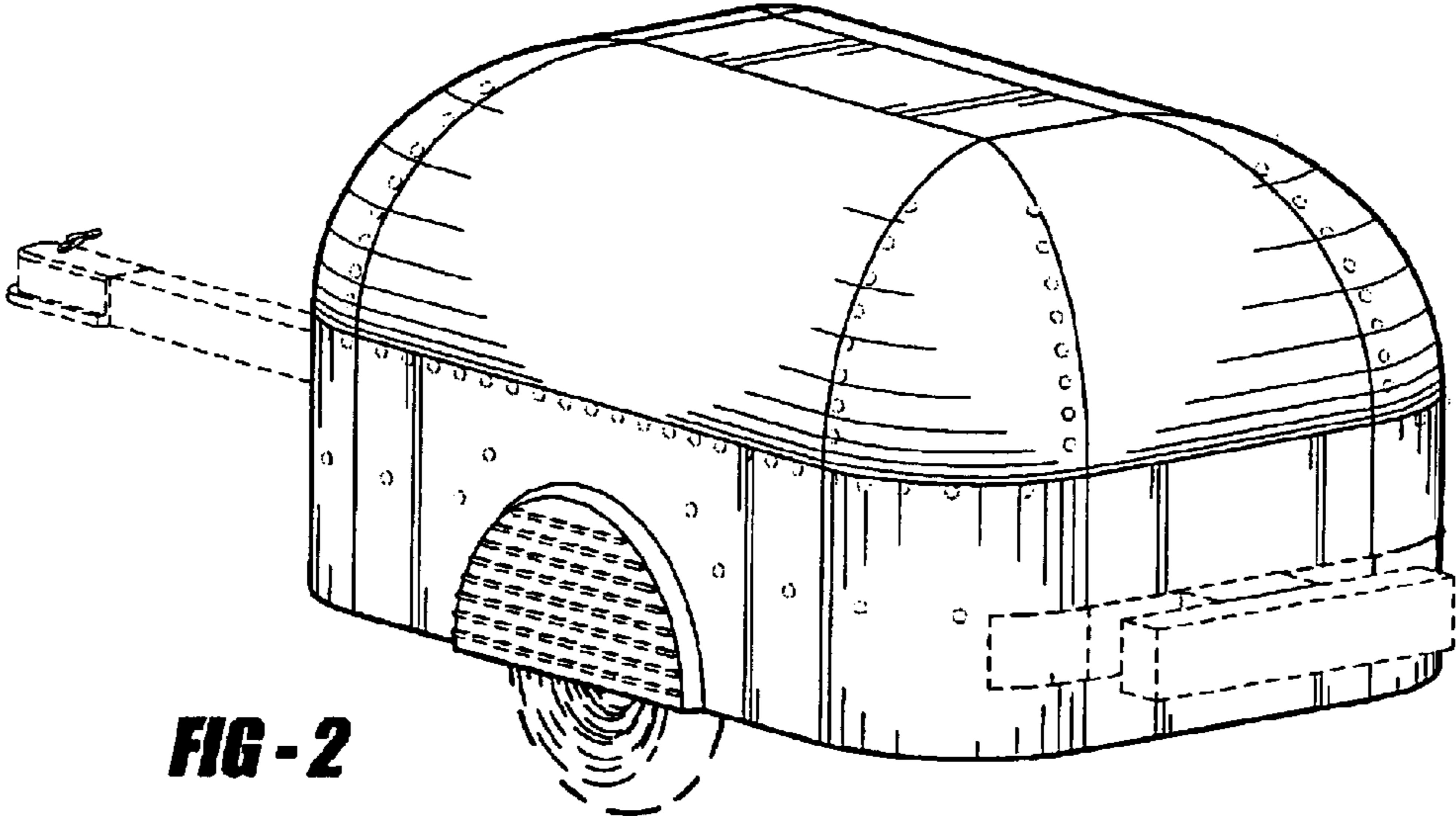
FIG. 16 is a bottom view of the second embodiment design of FIG. 9.

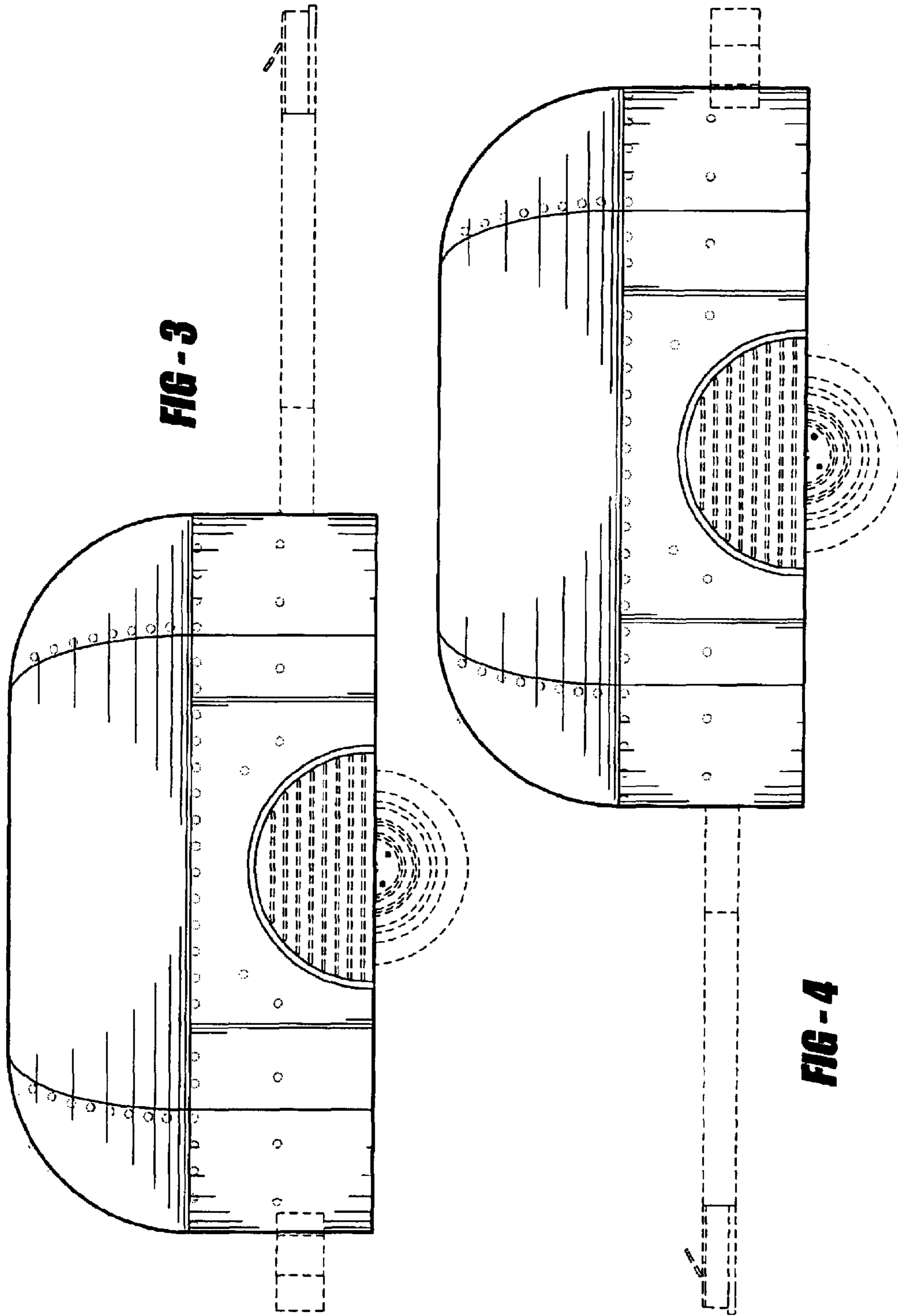


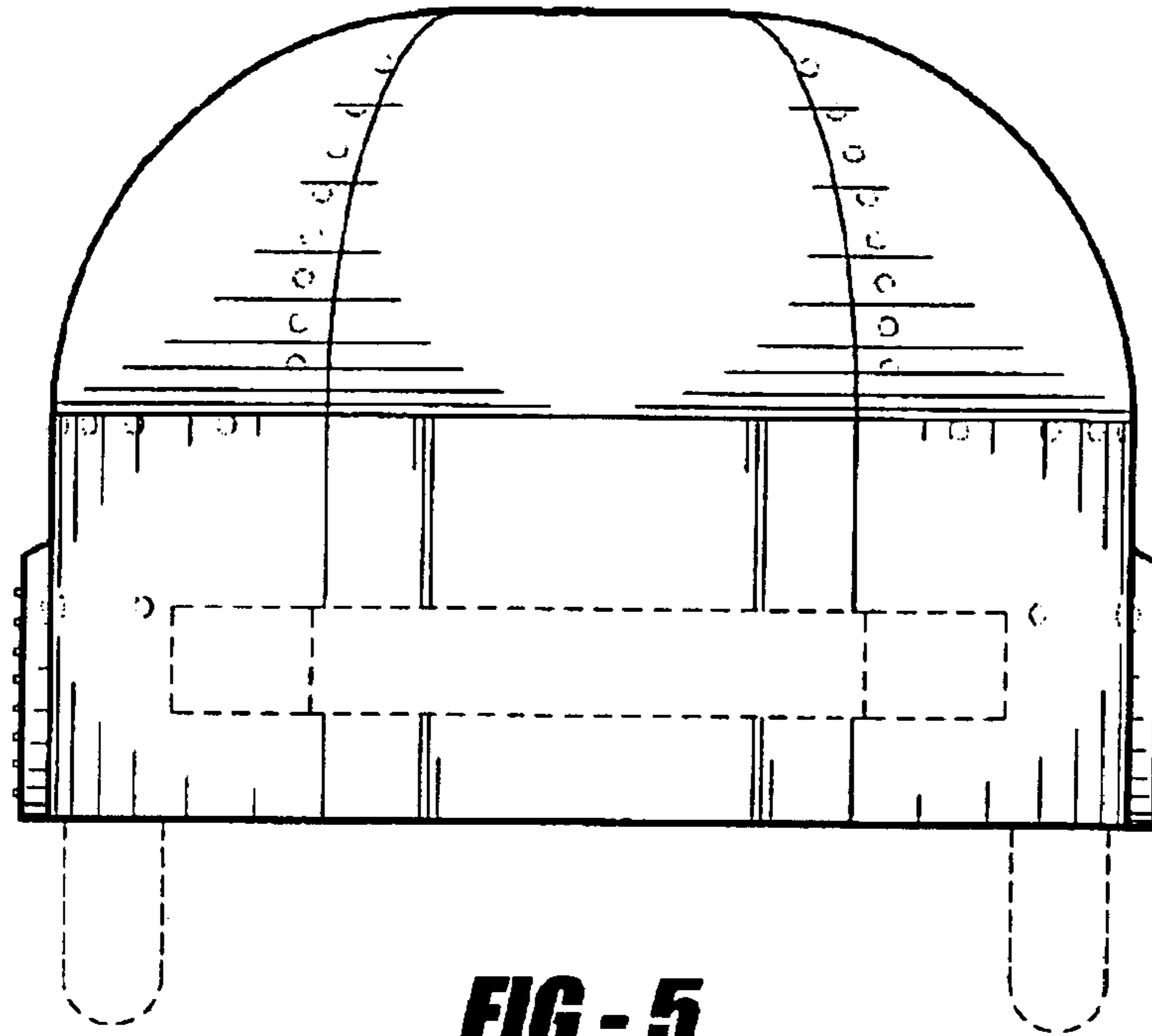

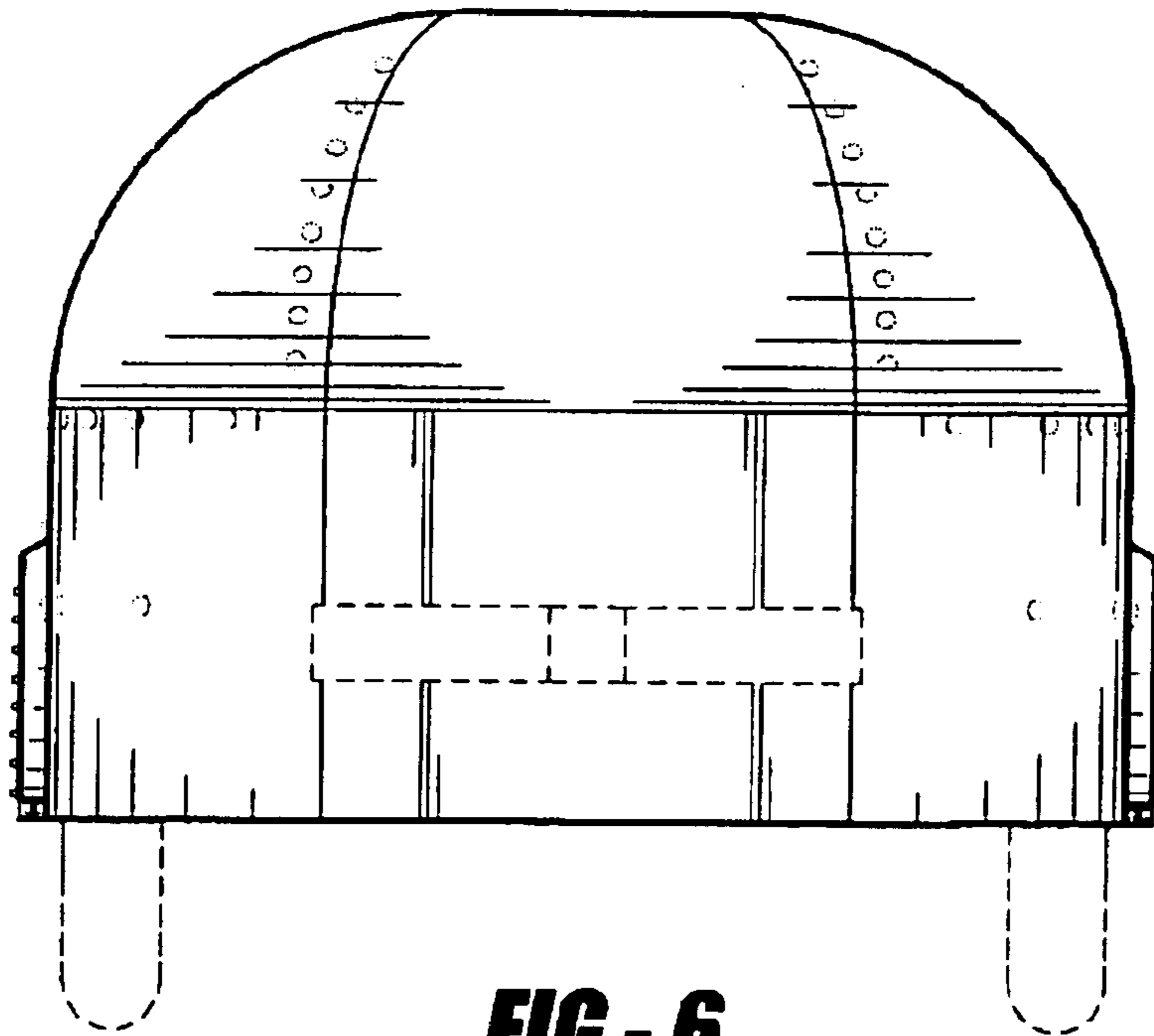

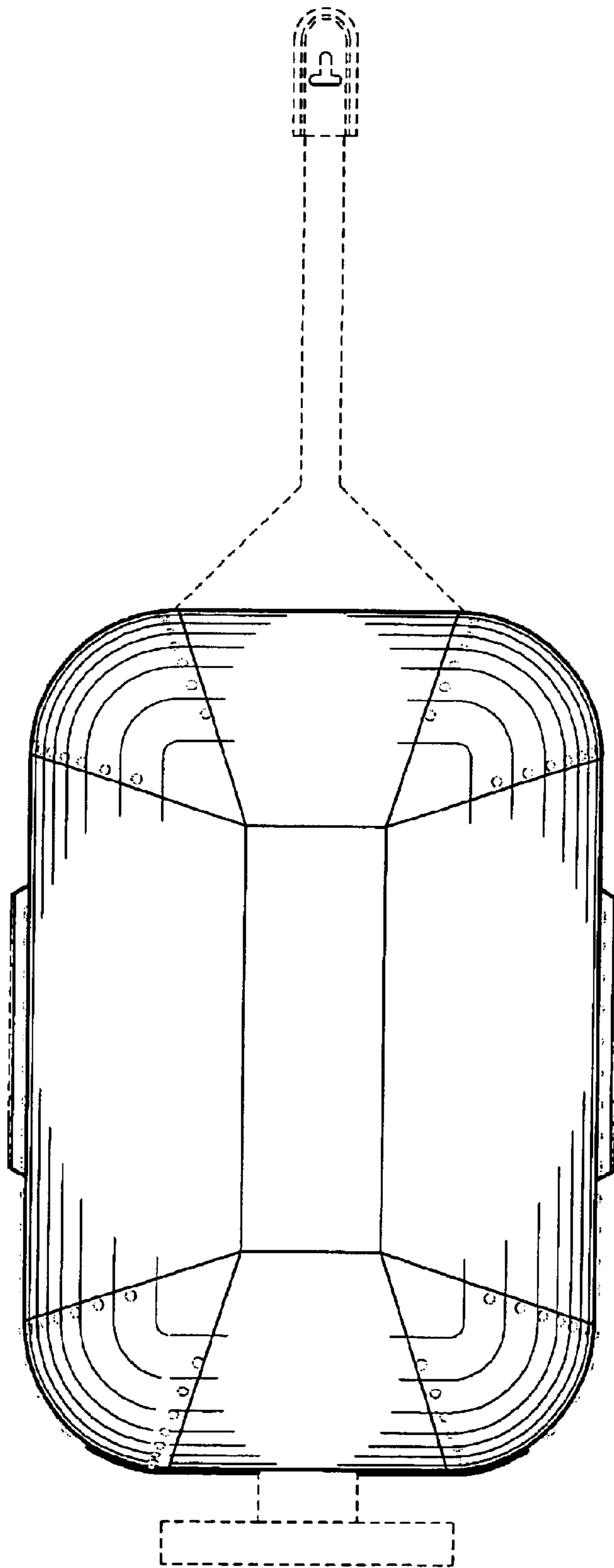




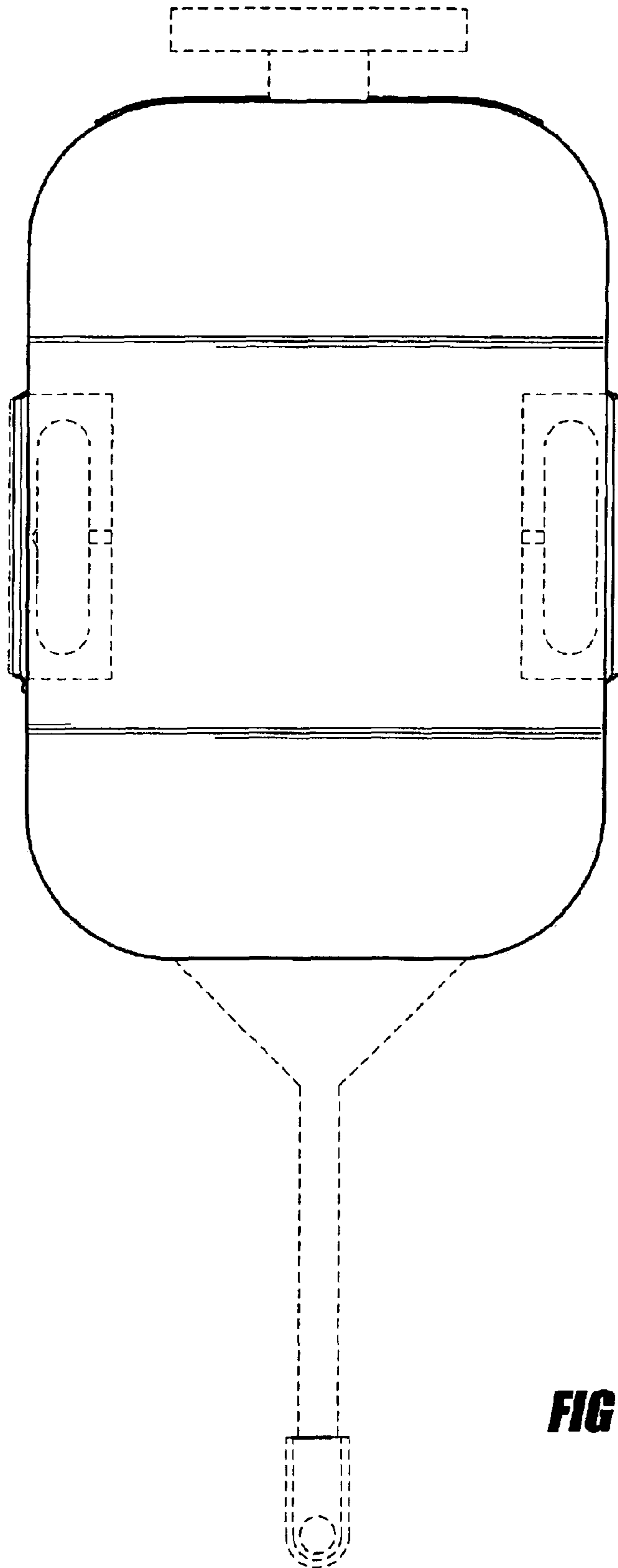

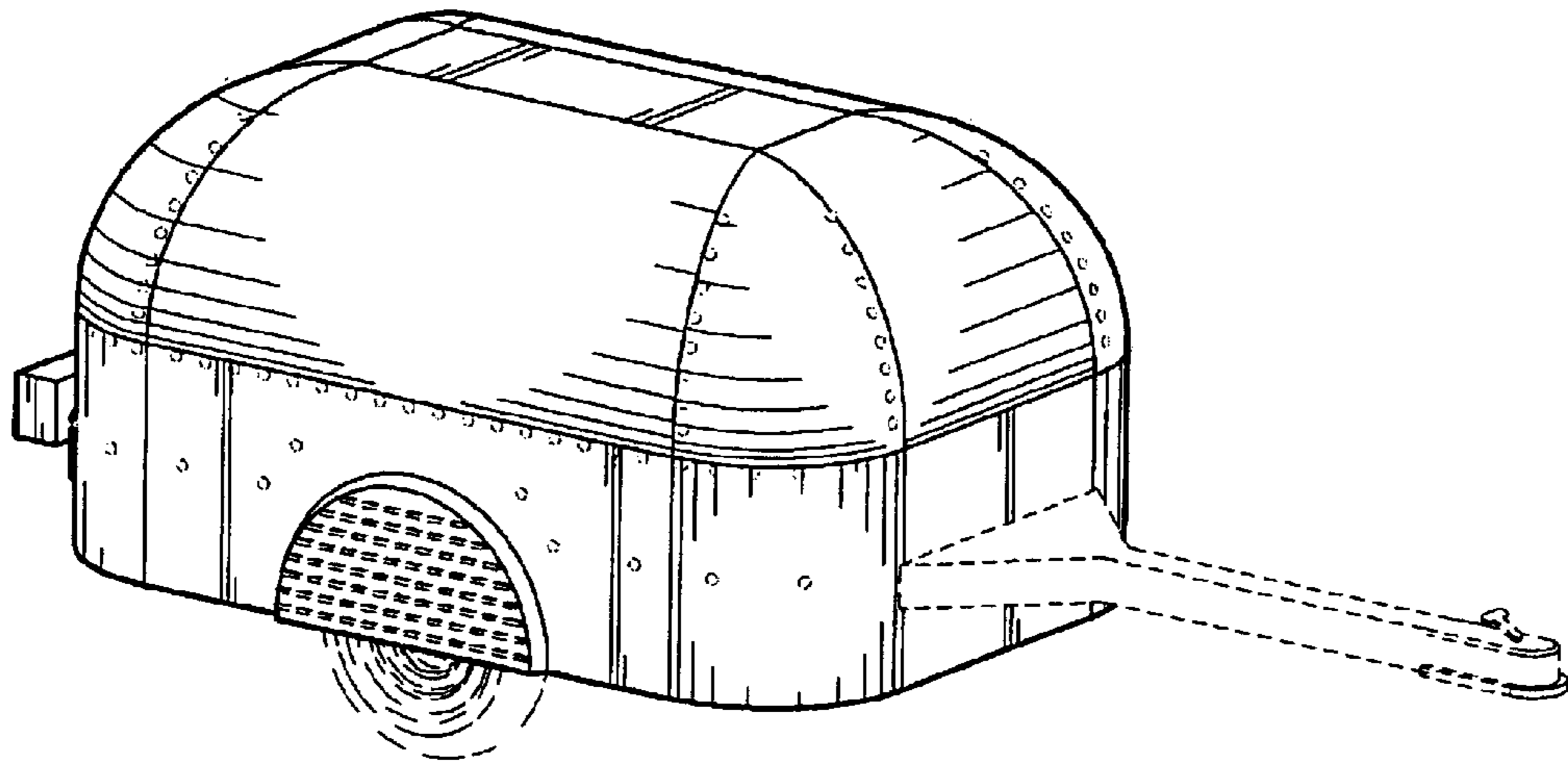

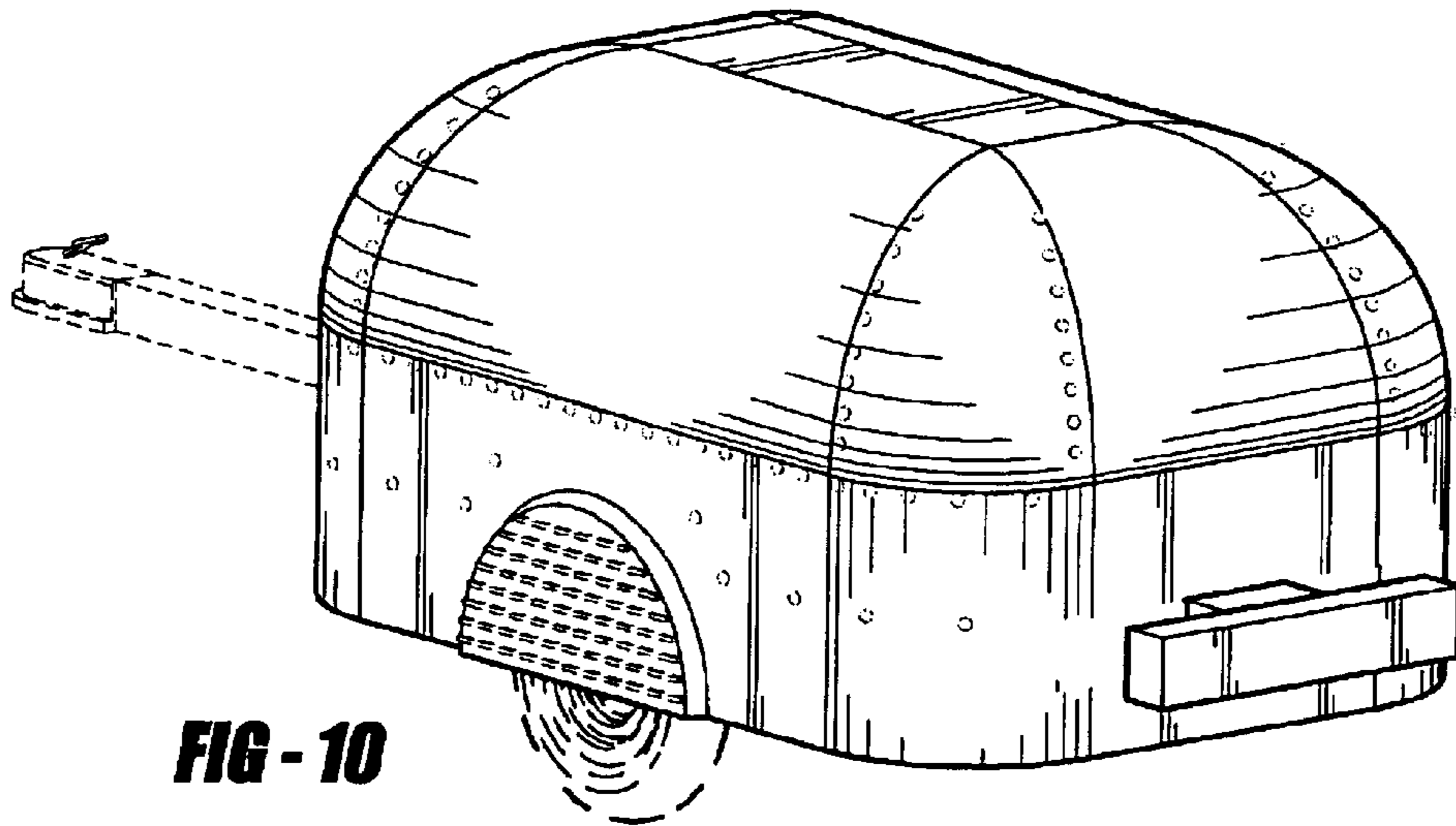

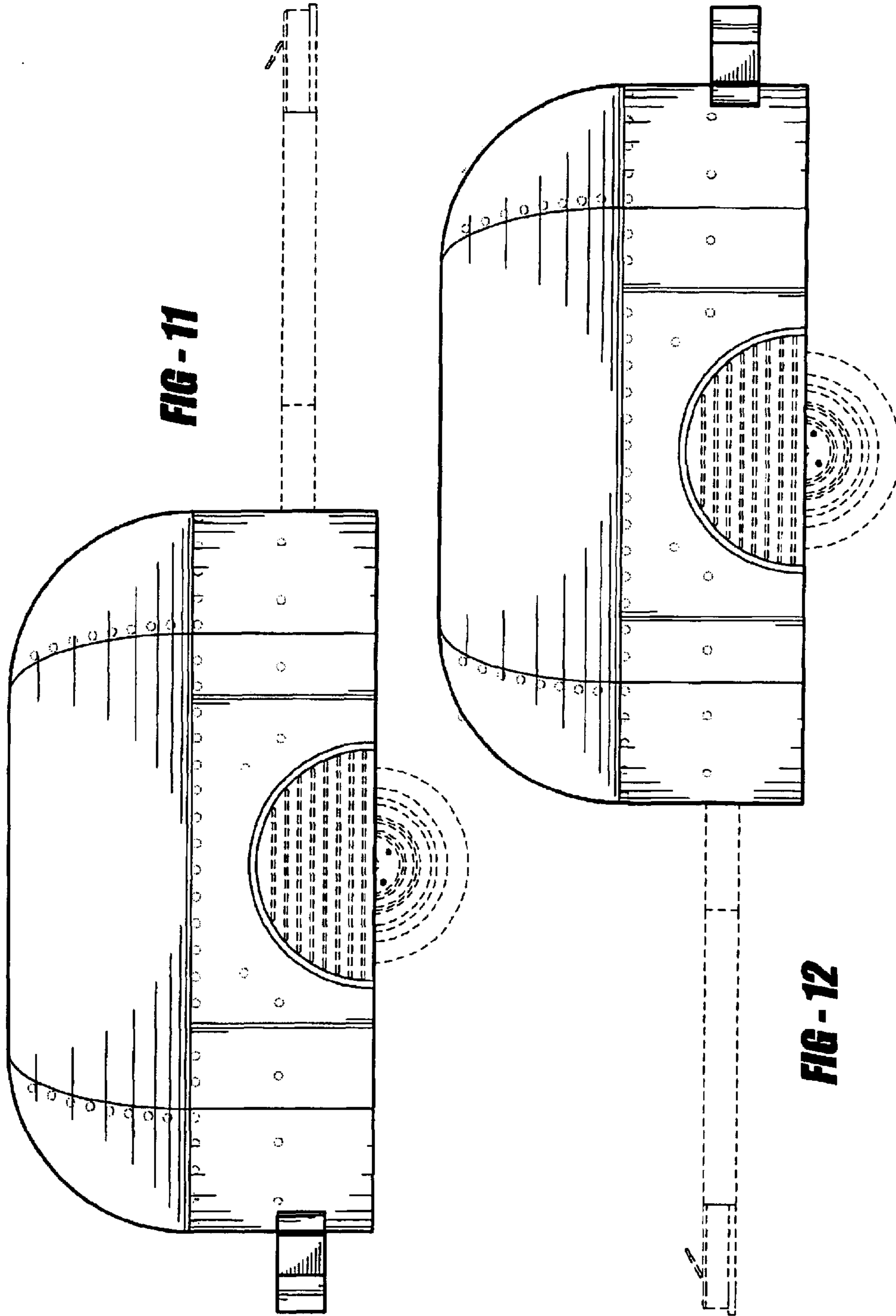

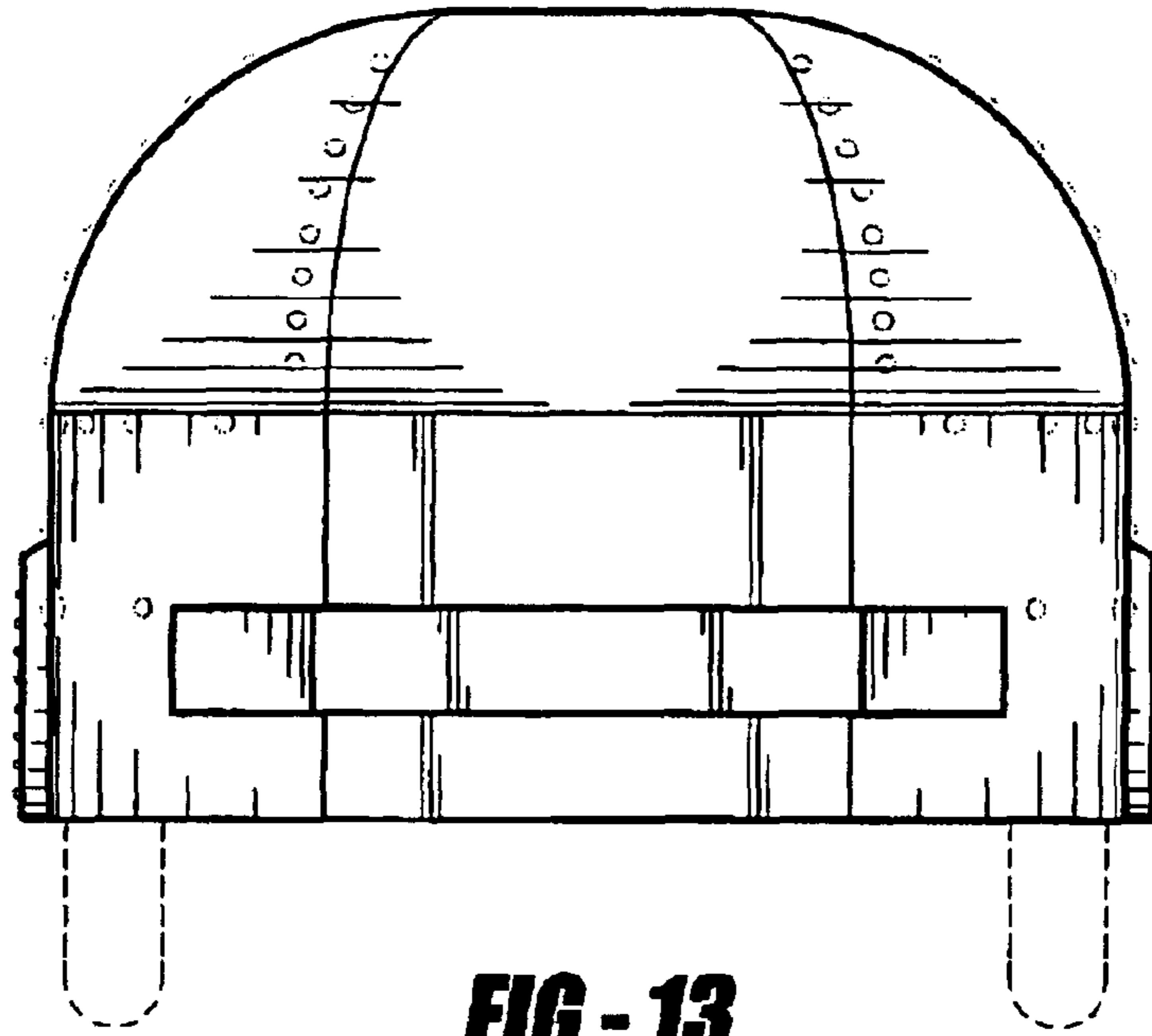

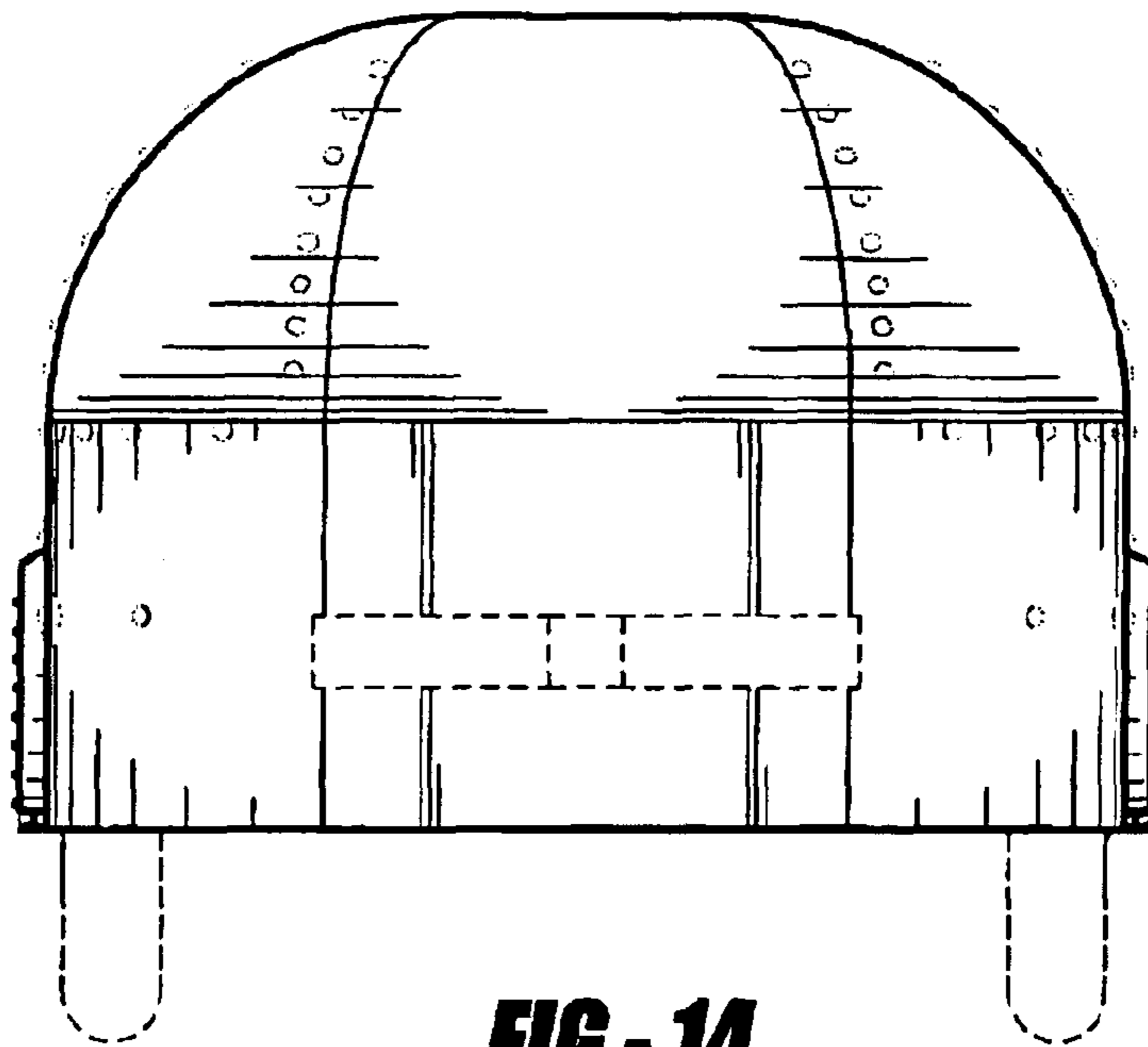

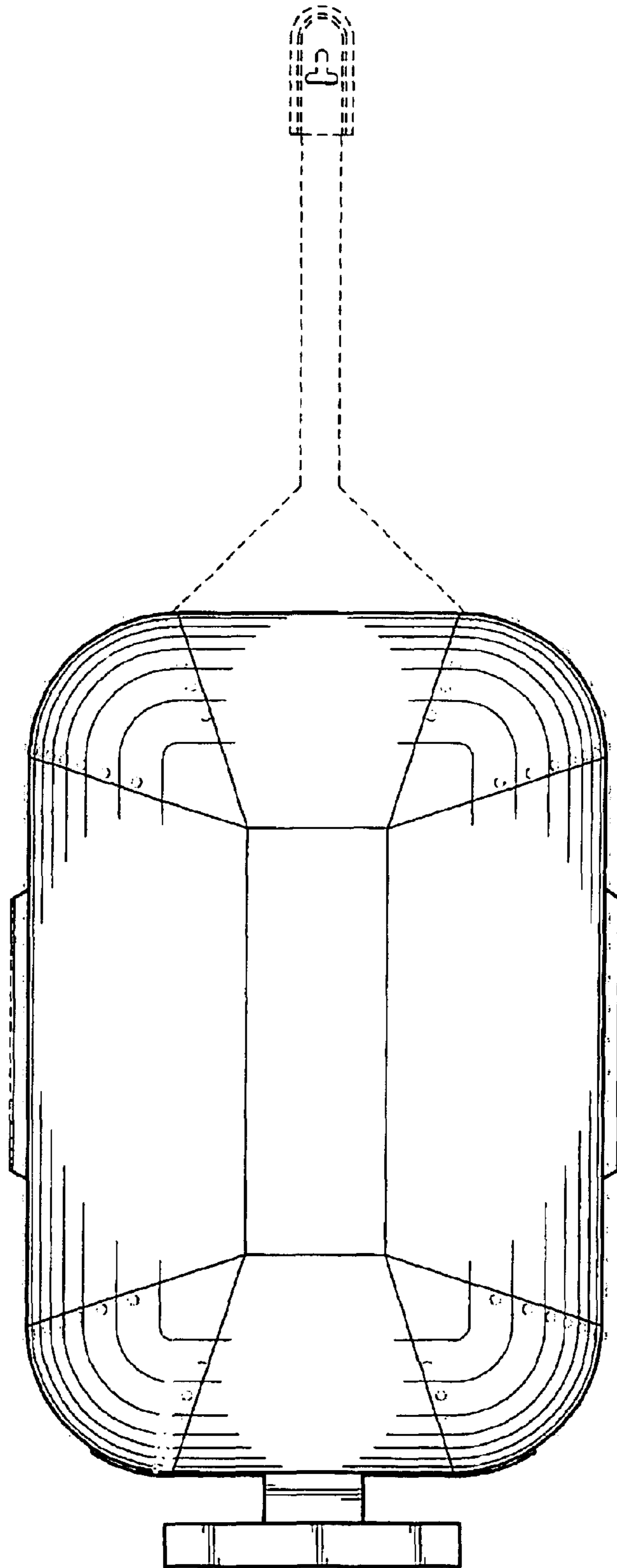




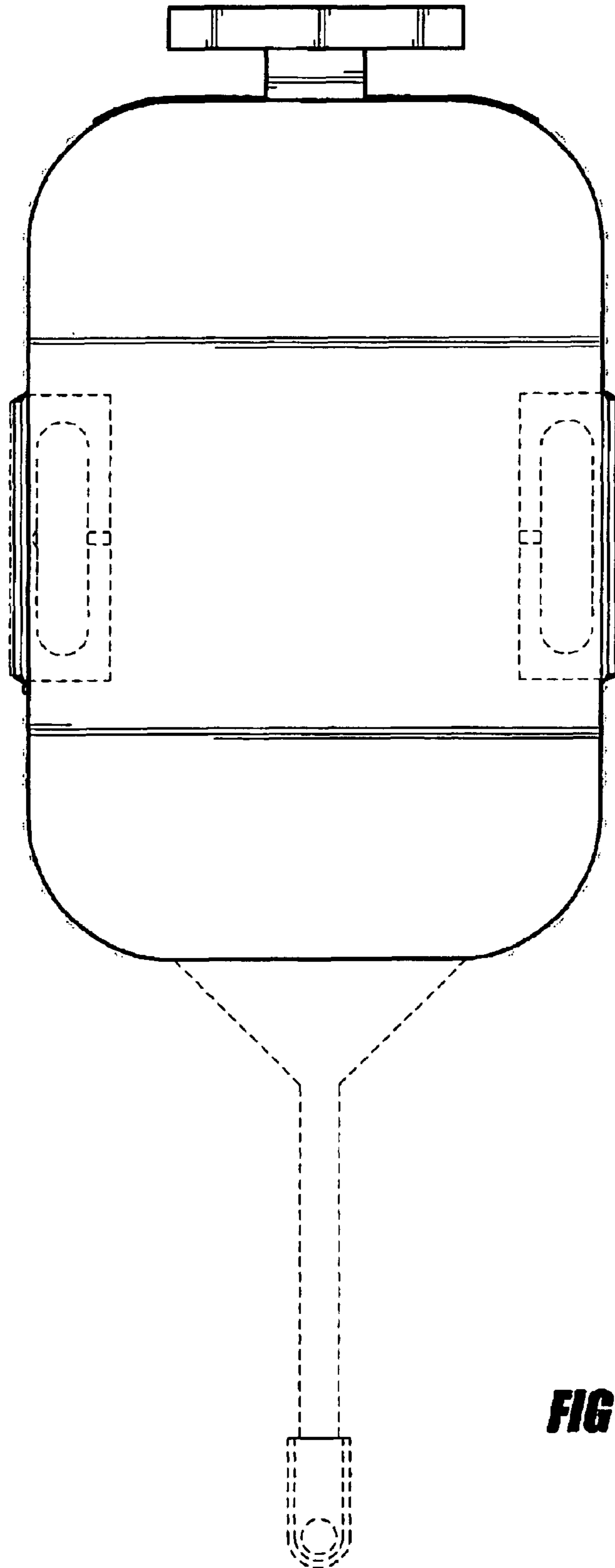
