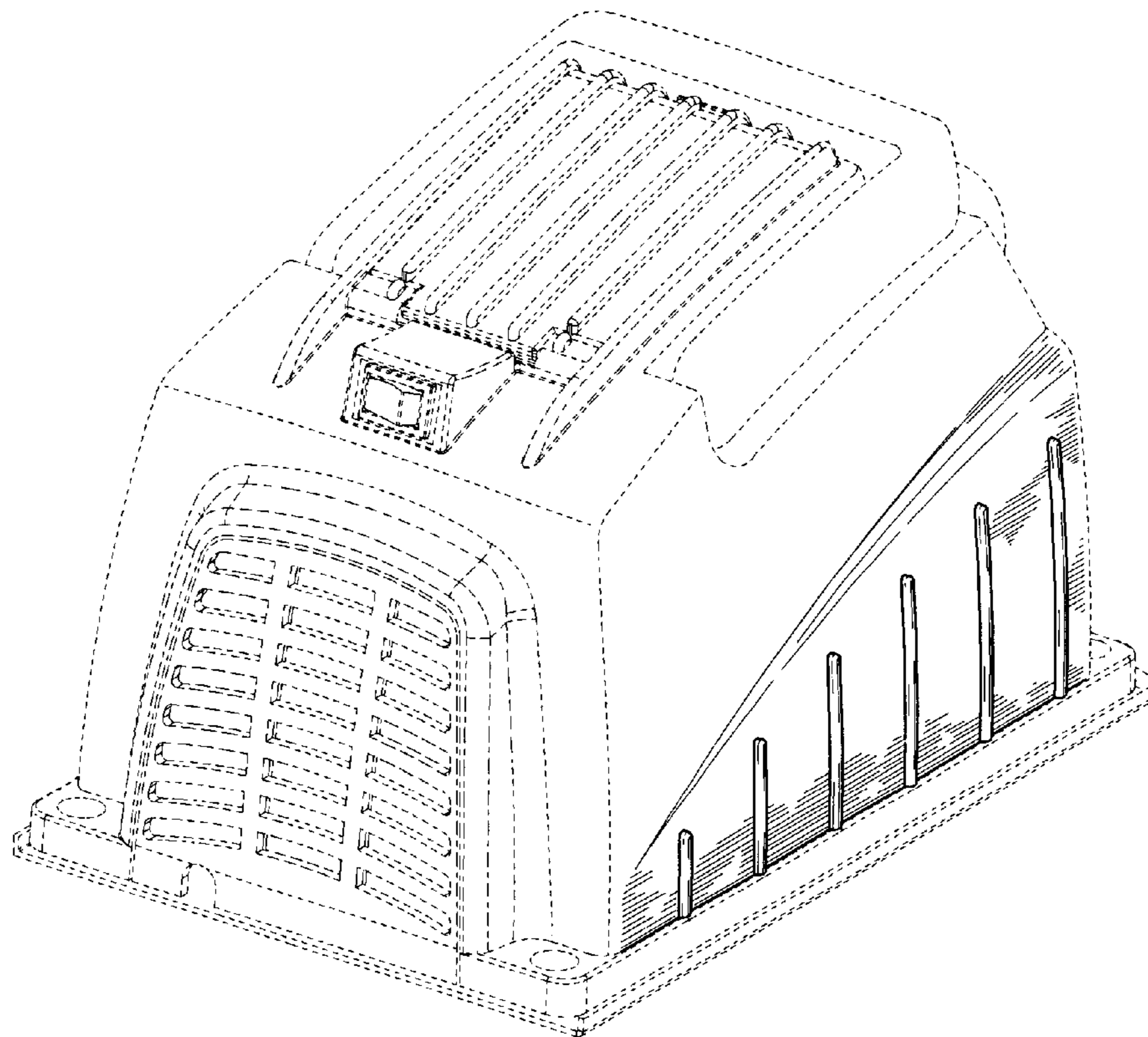
(57) **CLAIM**

We claim the ornamental design for a compressor shroud, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a compressor shroud embodying the ornamental design of the present invention; FIG. 2 is a top view of the compressor shroud; FIG. 3 is a side view of the compressor shroud; FIG. 4 is a front view of the compressor shroud; and, FIG. 5 is a rear view of the compressor shroud. The broken lines in FIGS. 1-5 are for illustrative purposes only and form no part of the claimed design.

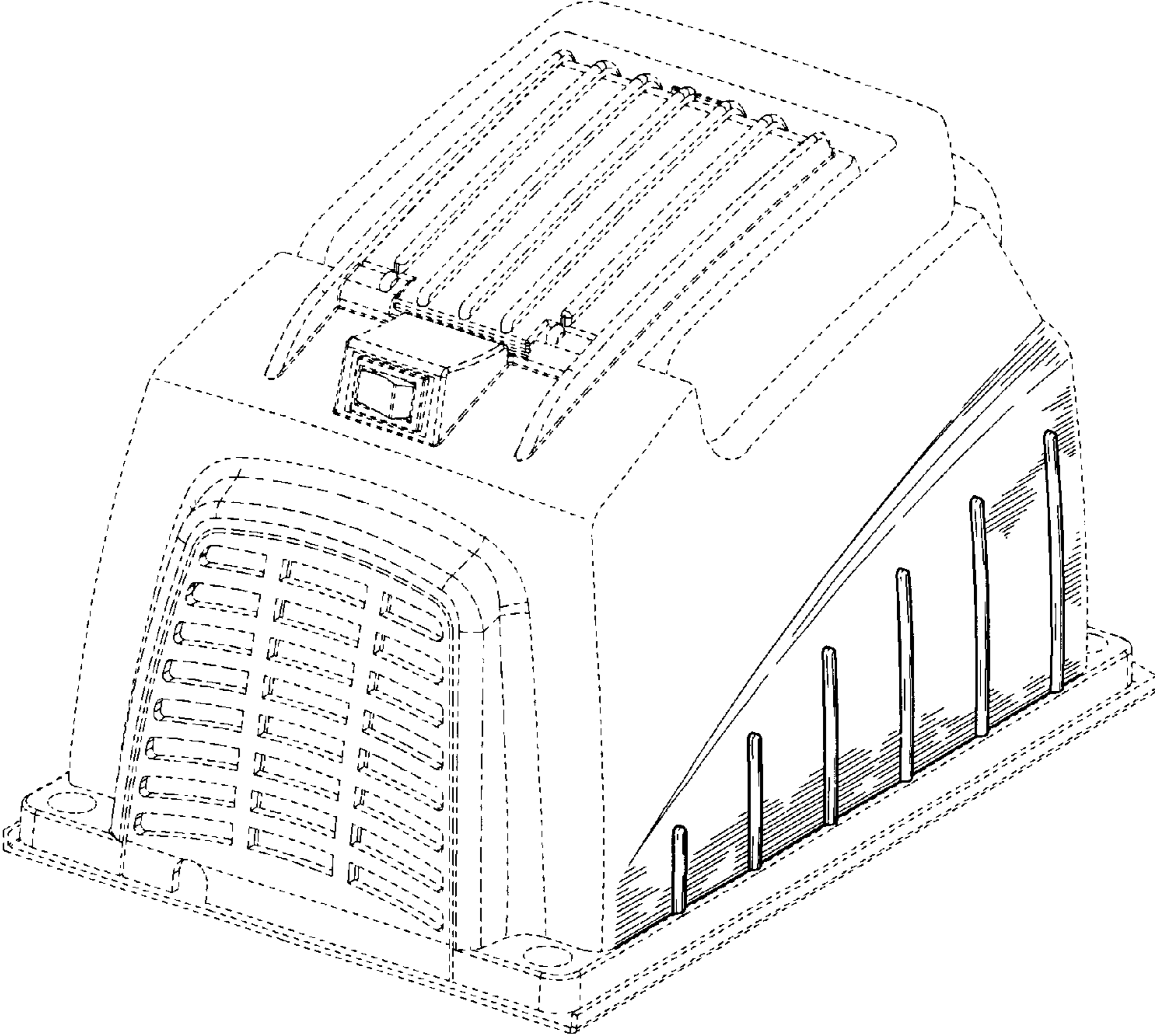

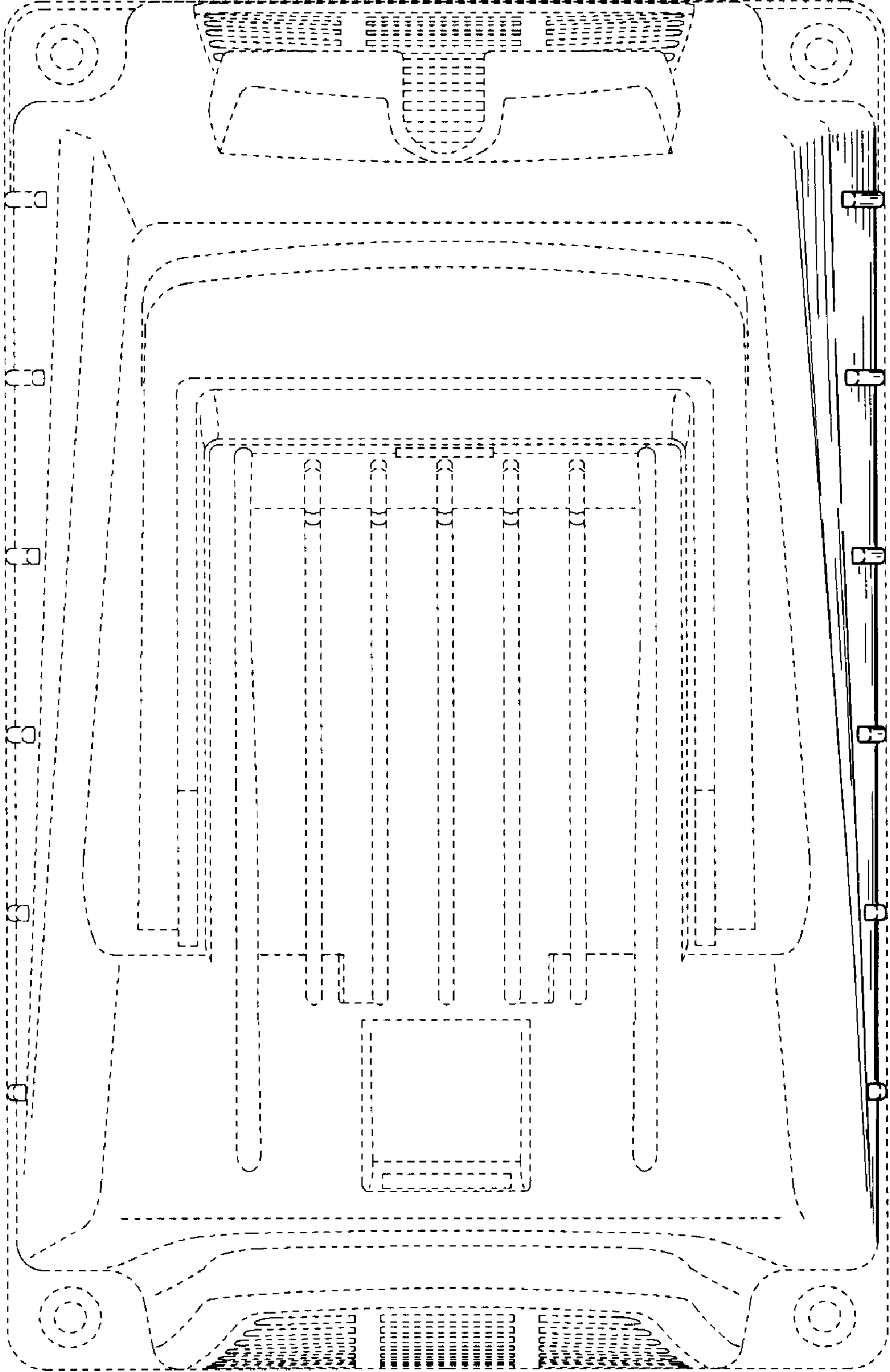

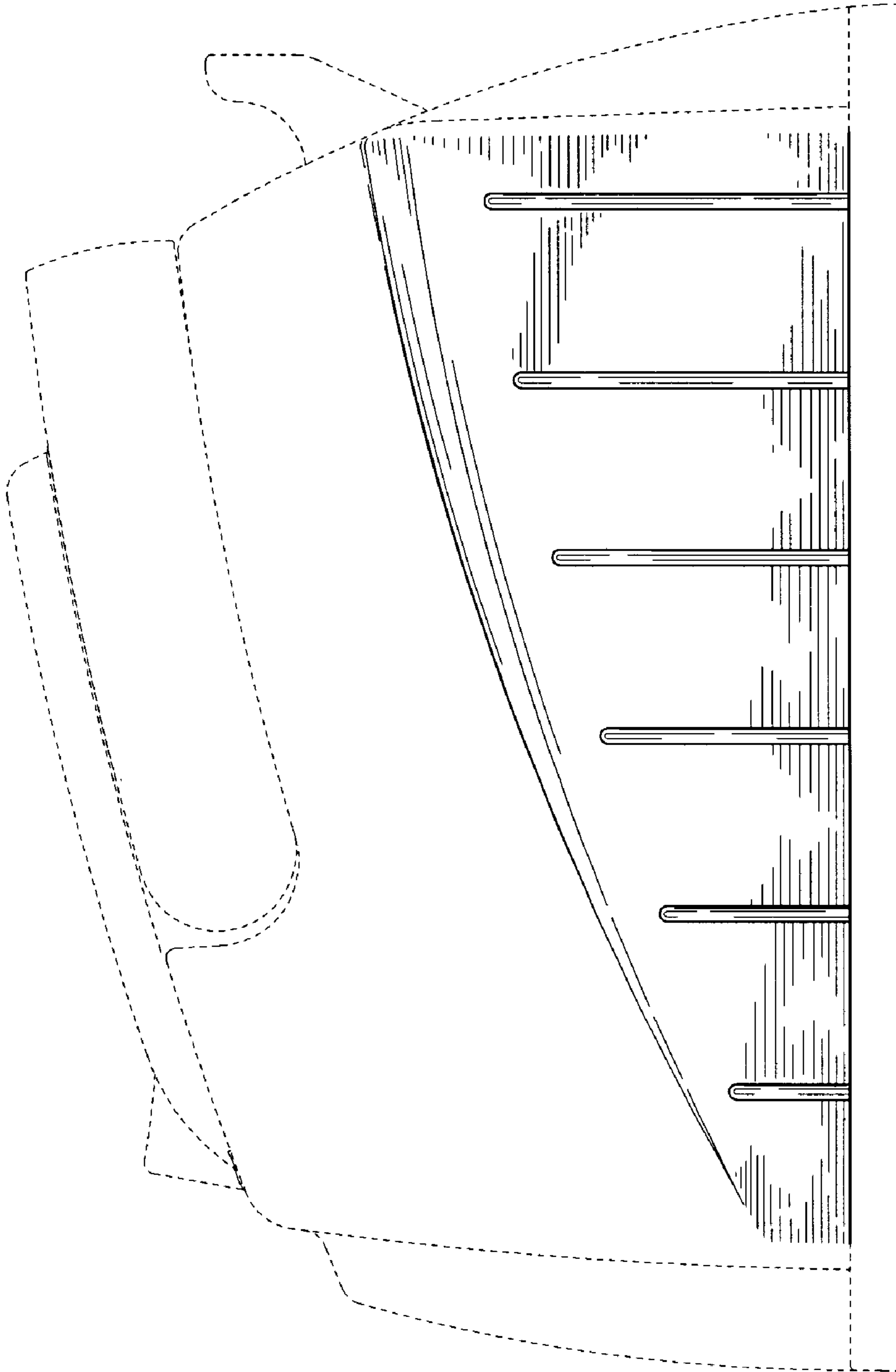

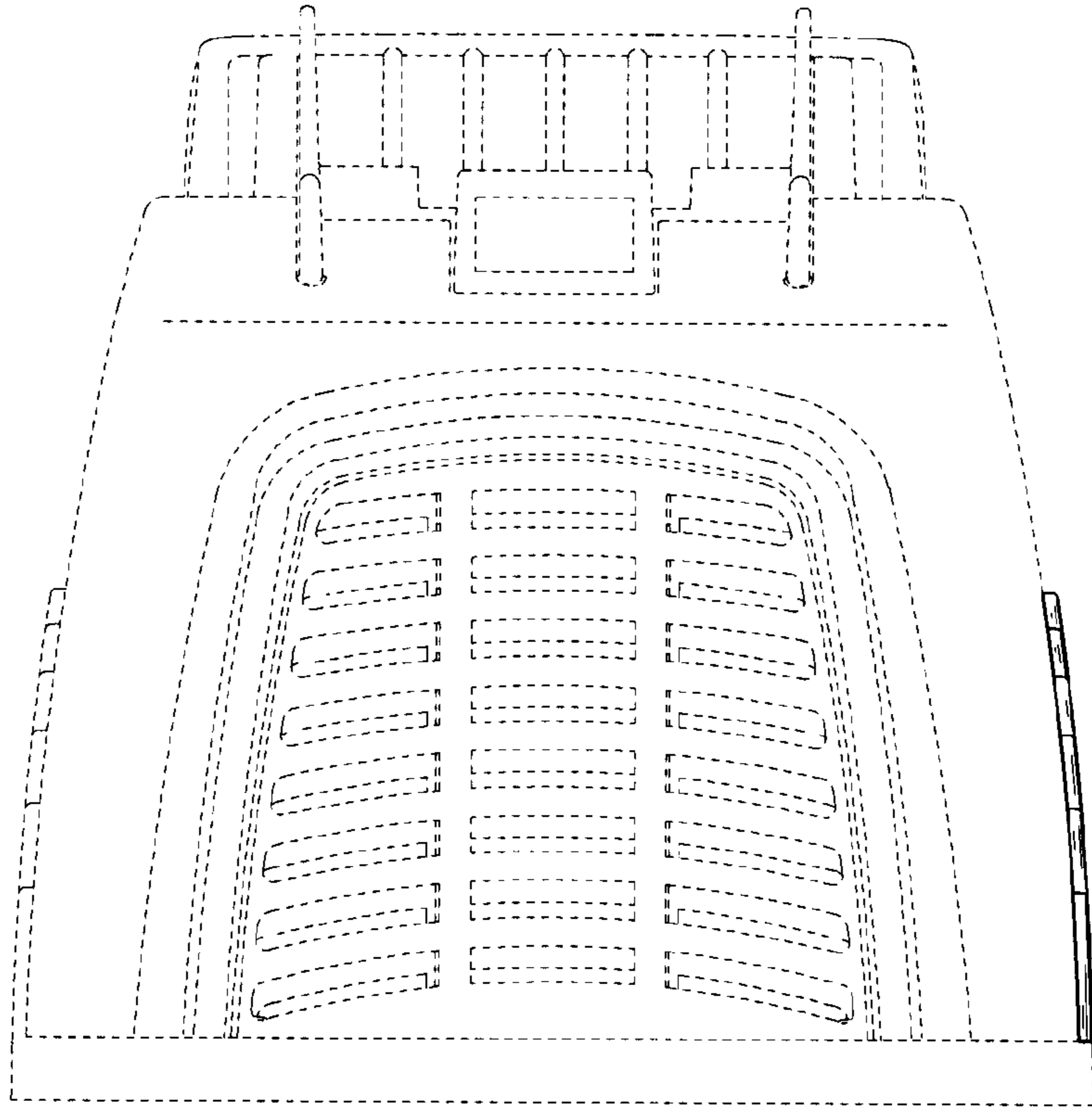

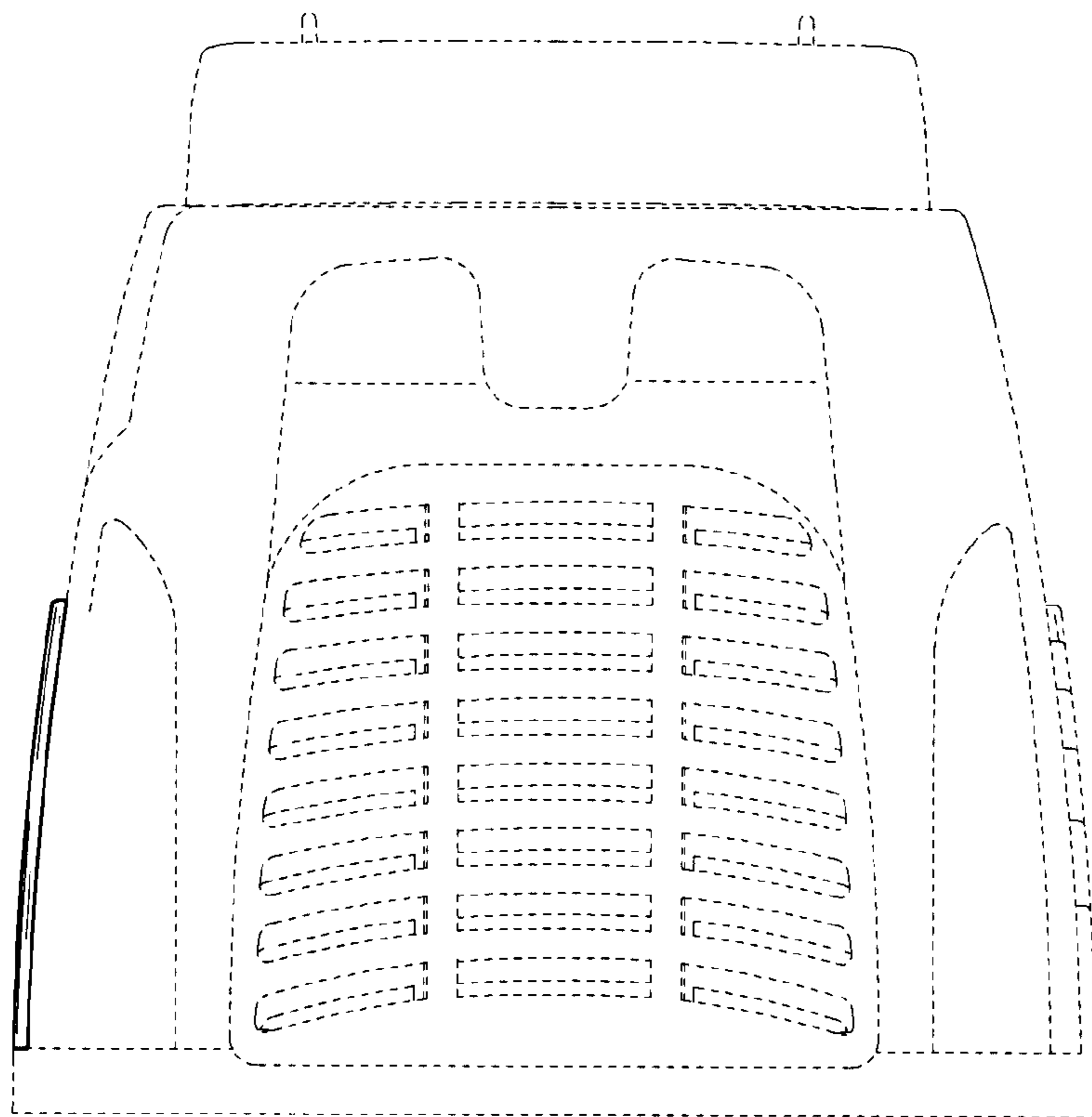
