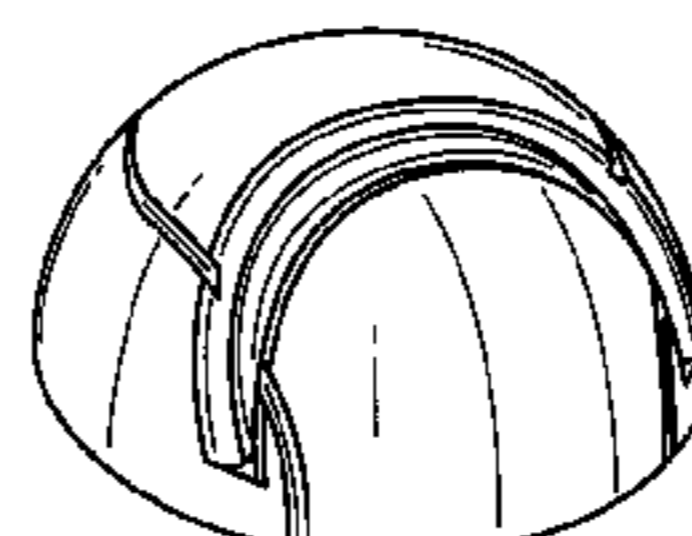
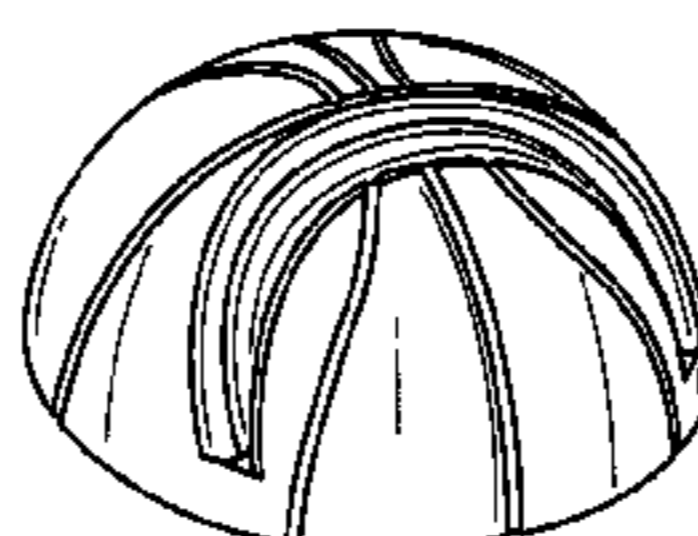
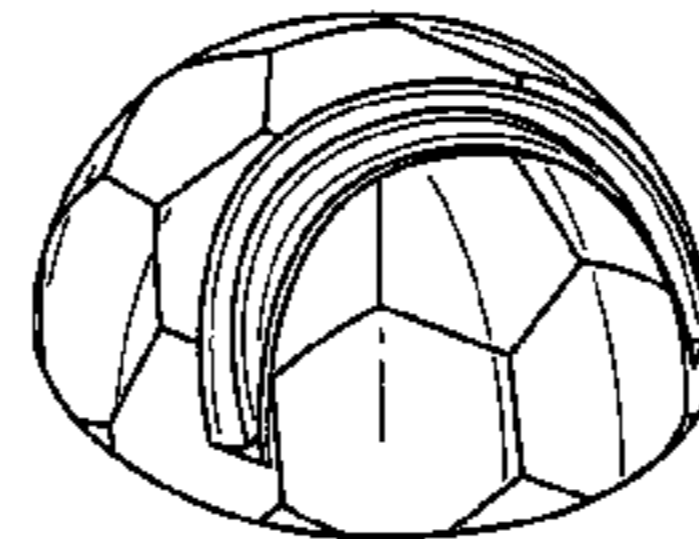
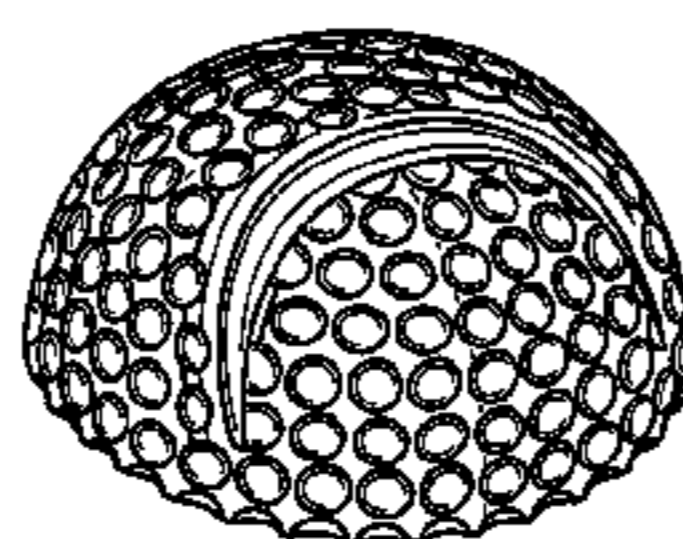
I claim the ornamental design for a paper holder, as shown and described.

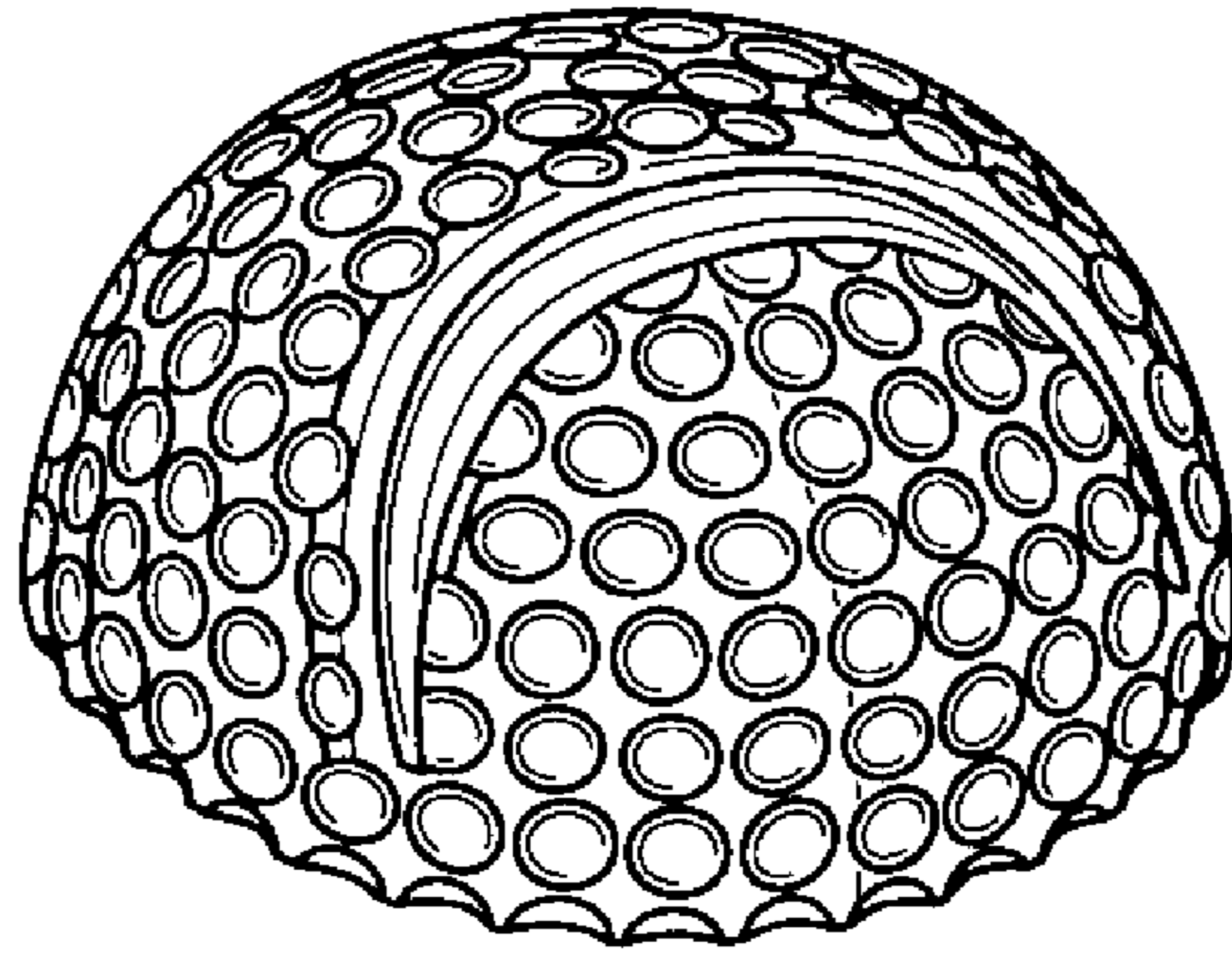

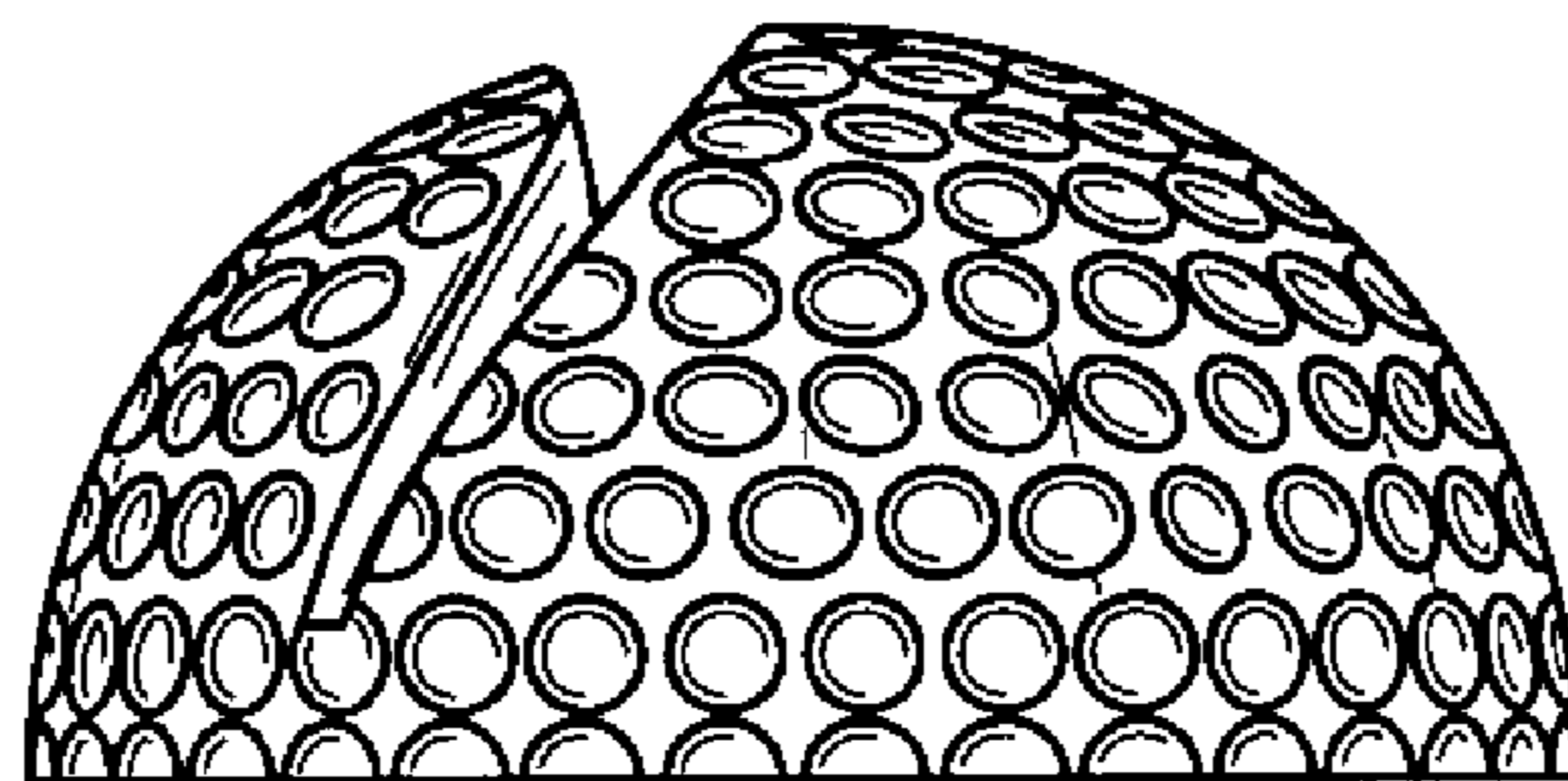

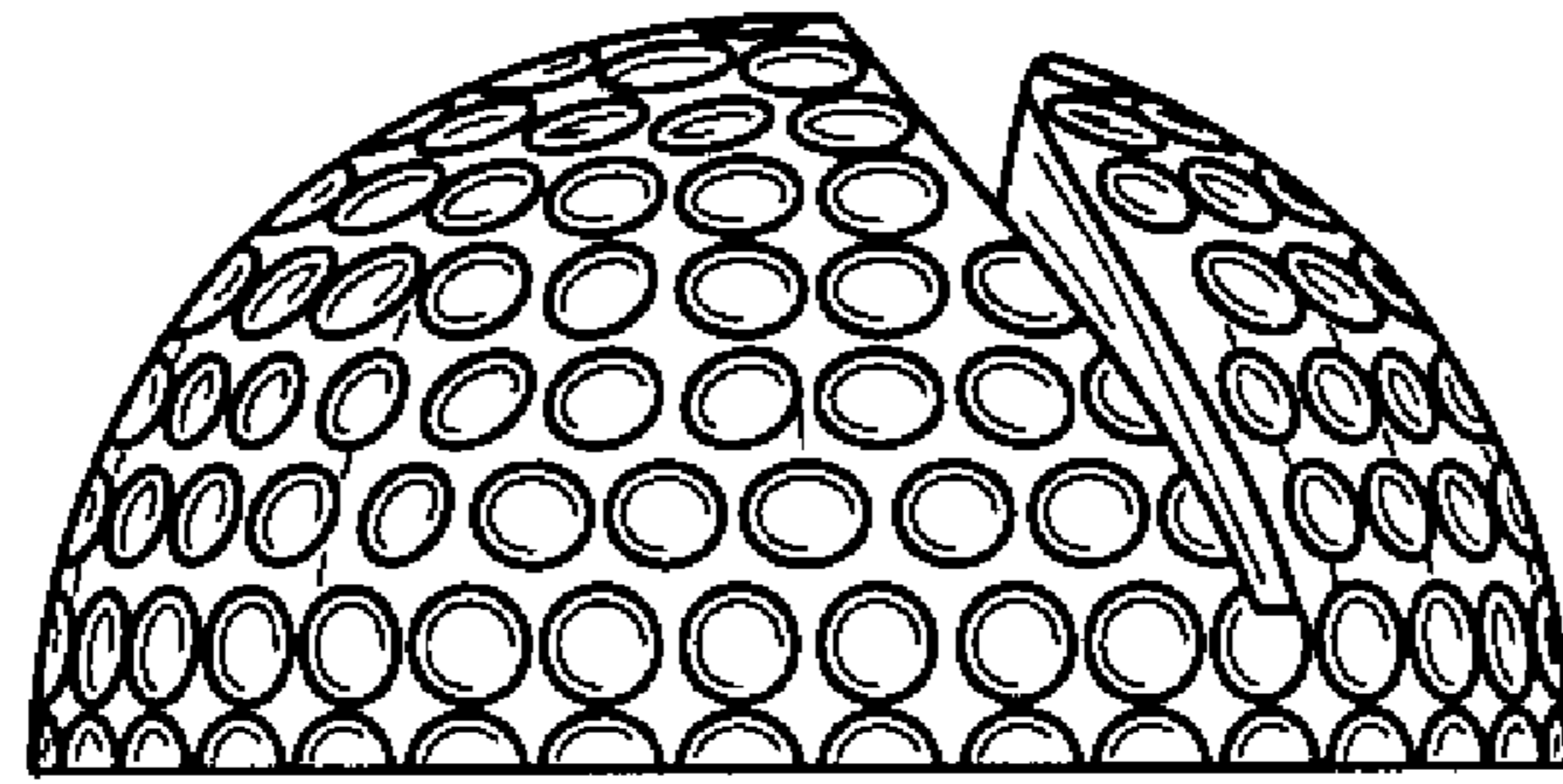

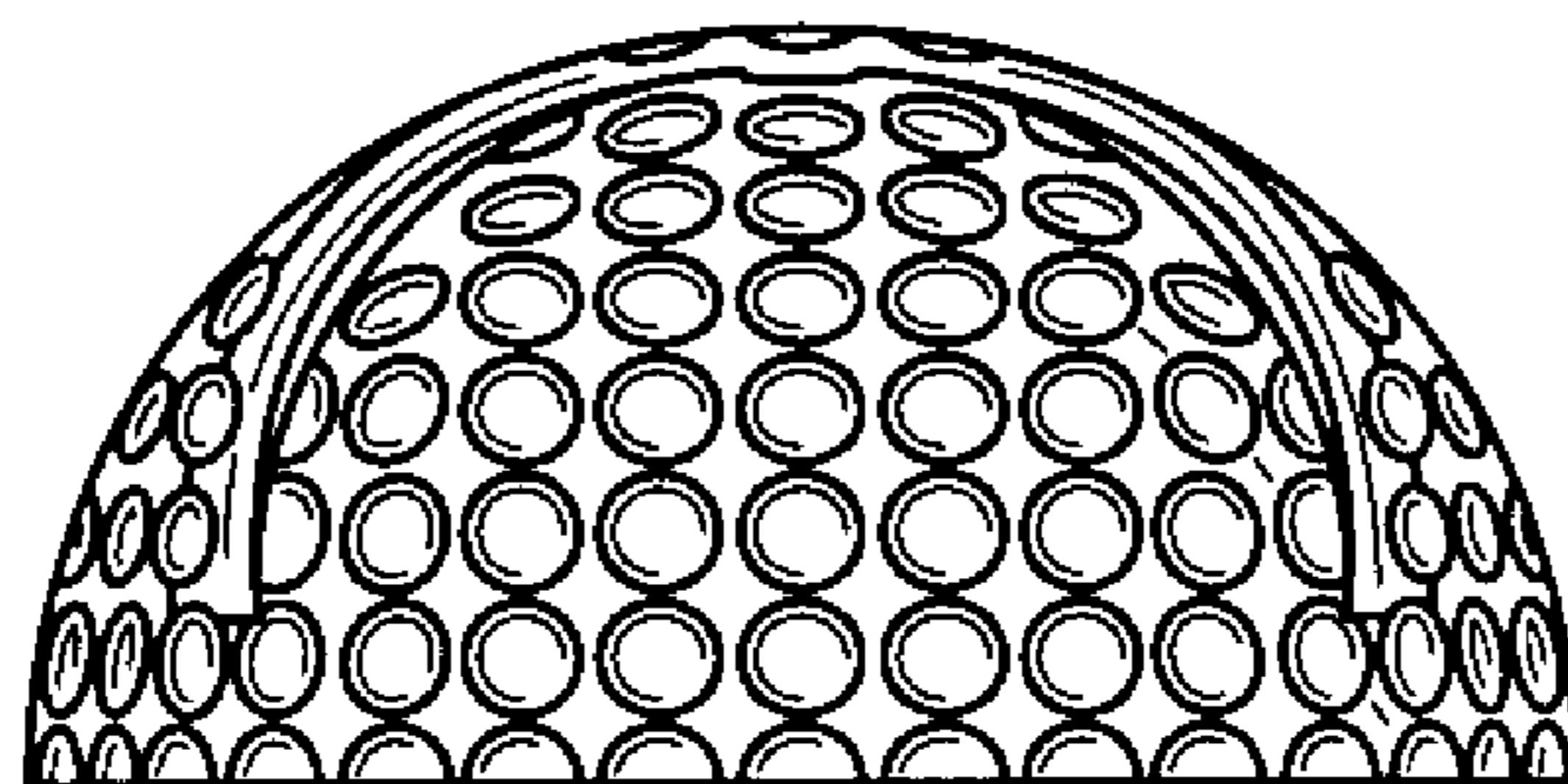

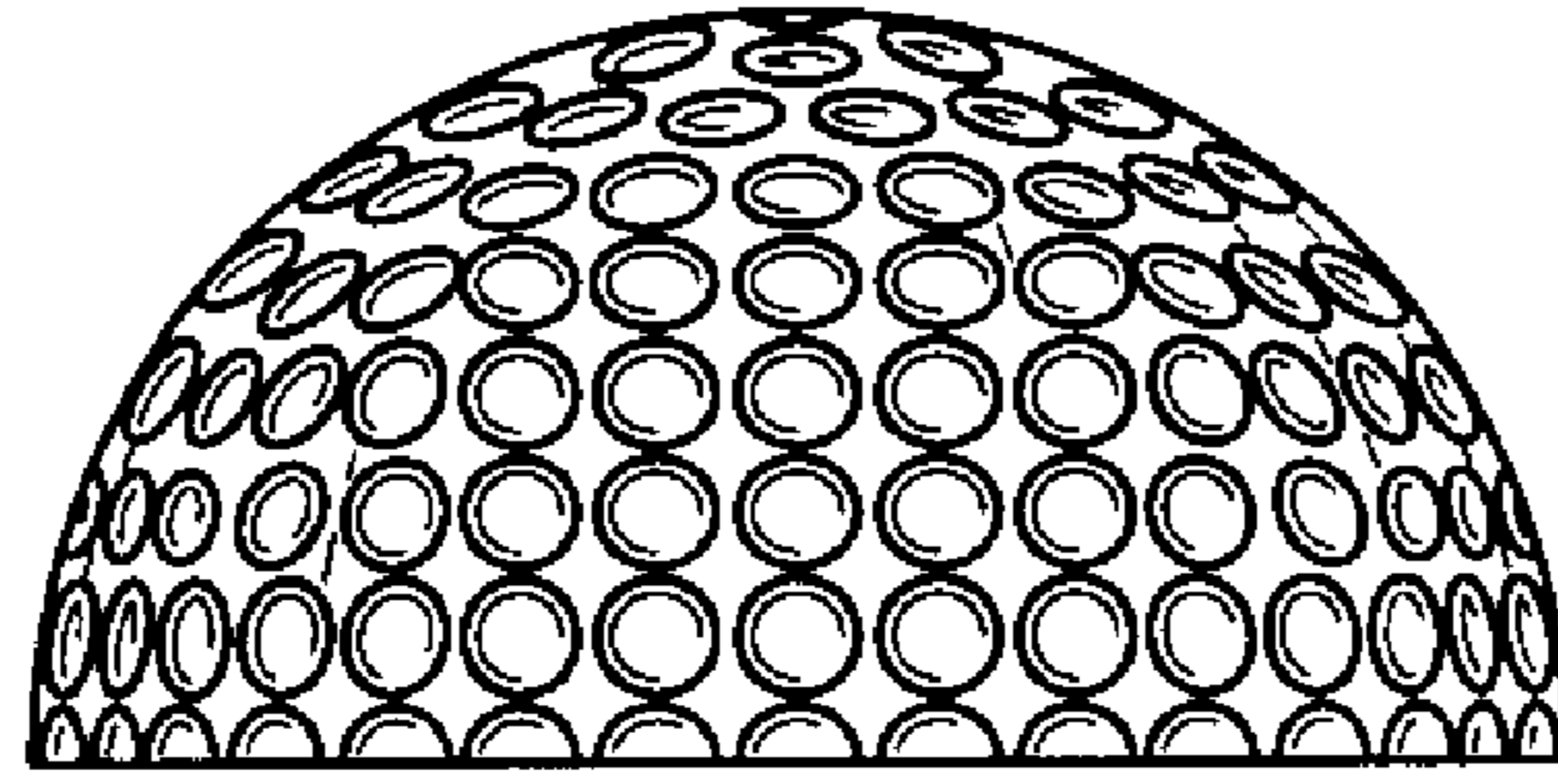

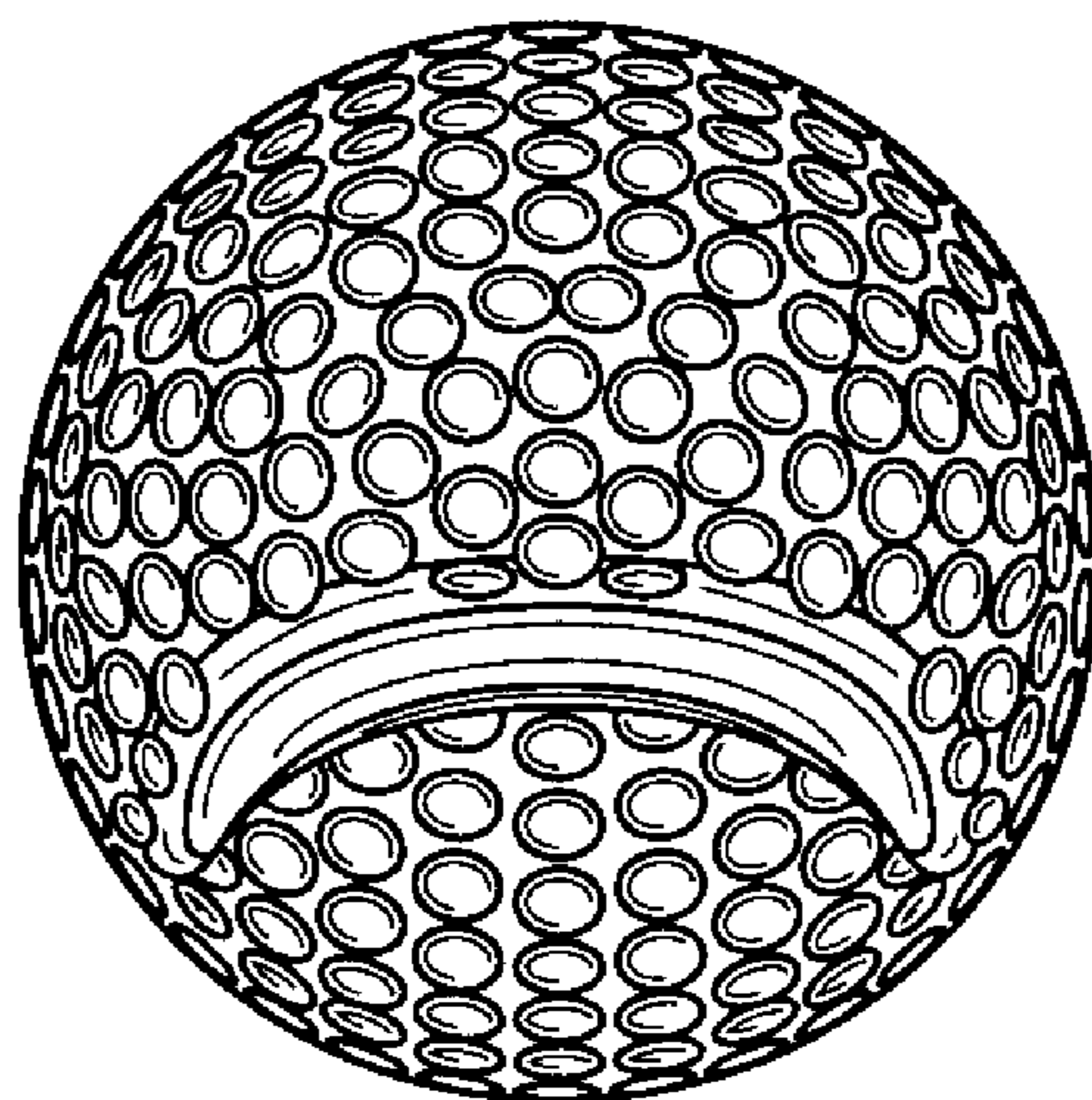

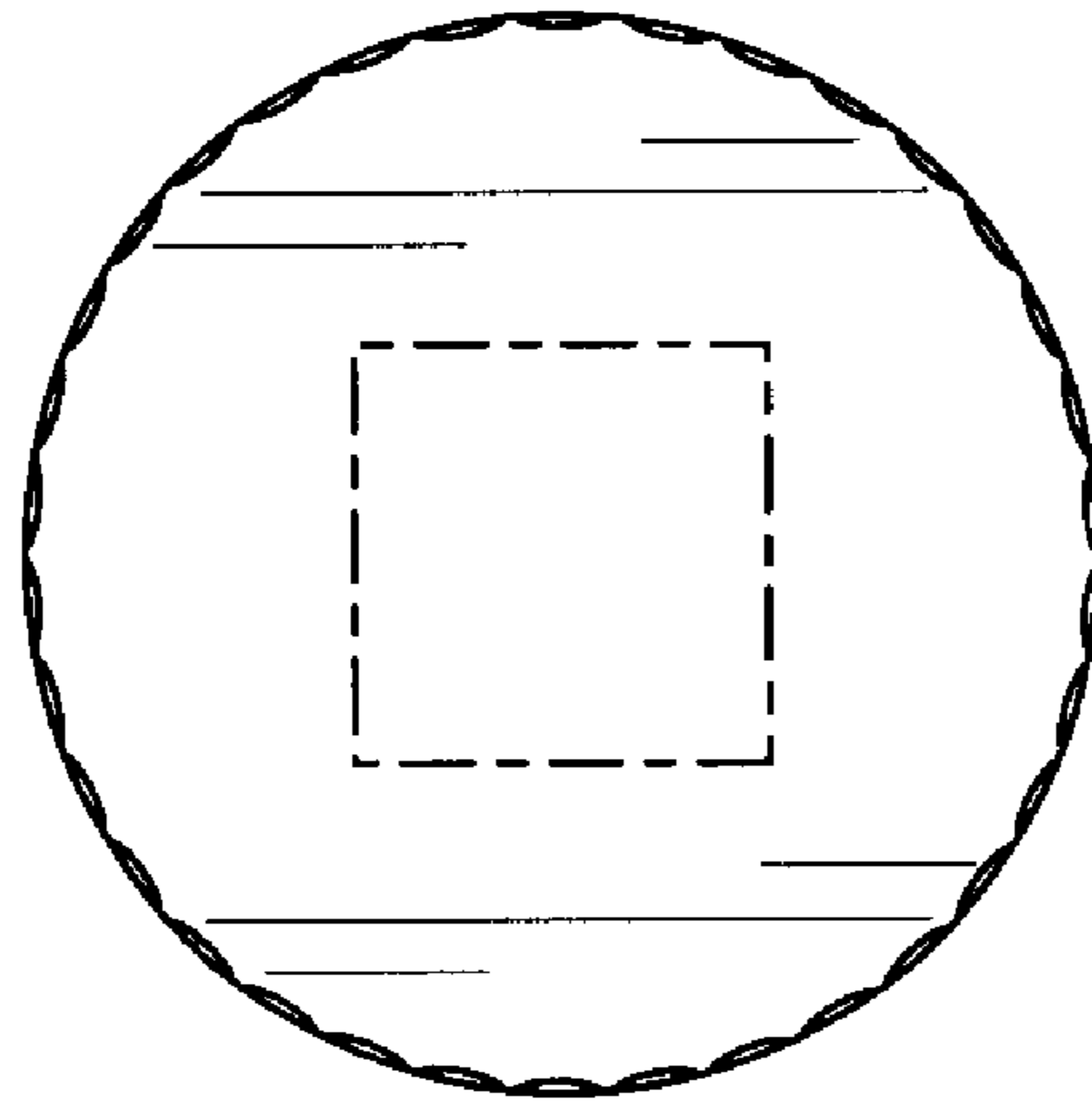

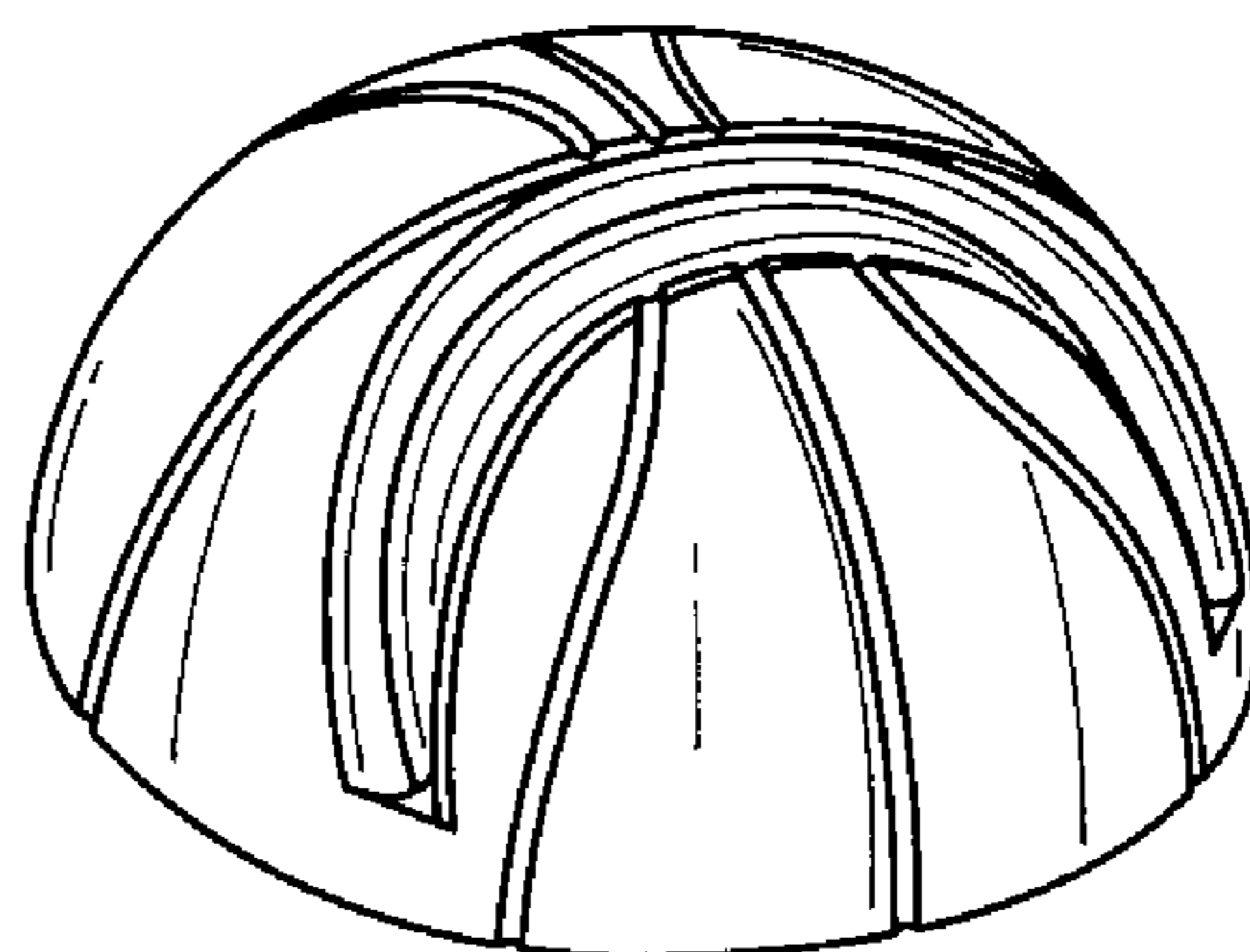

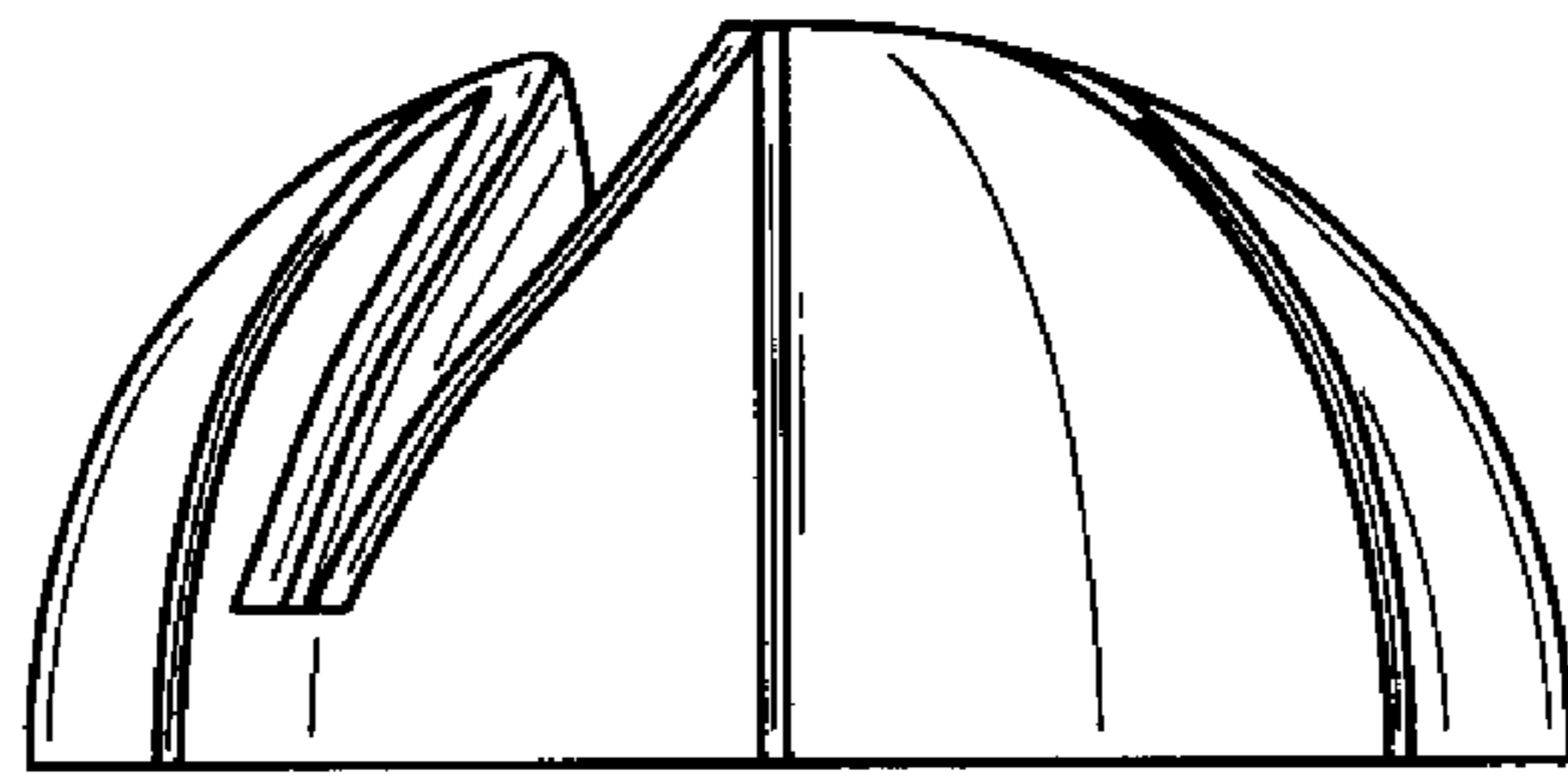

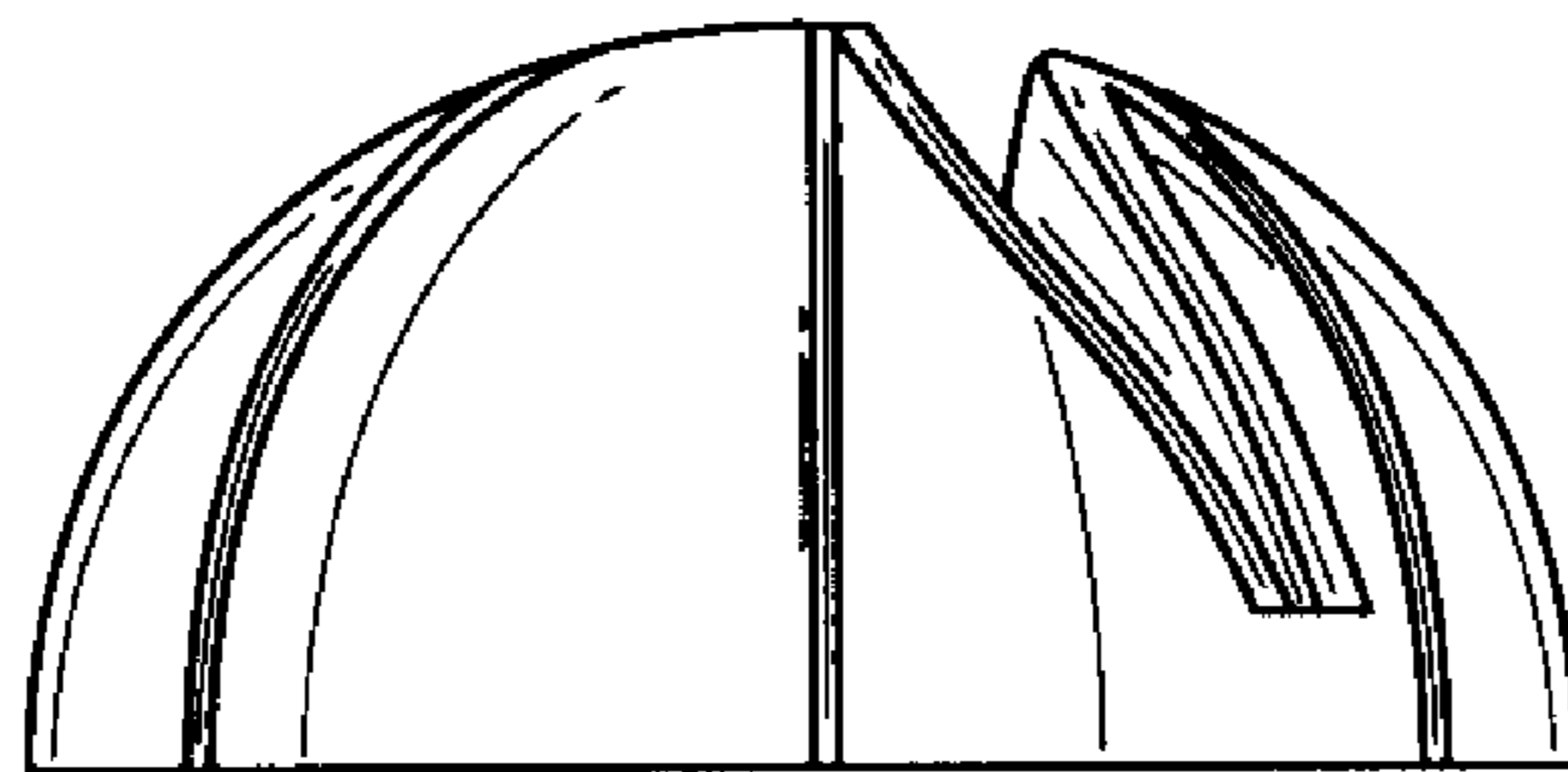

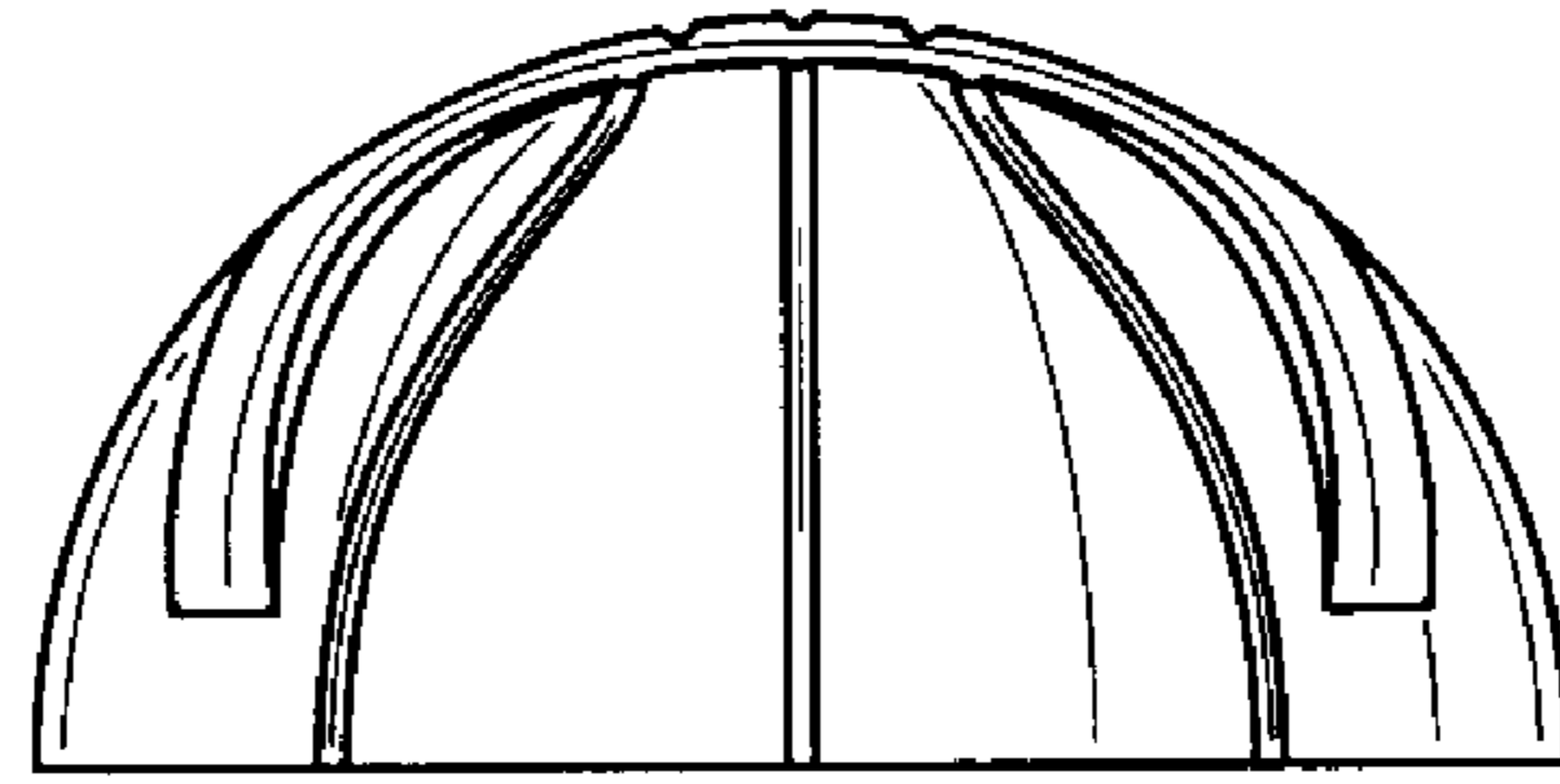

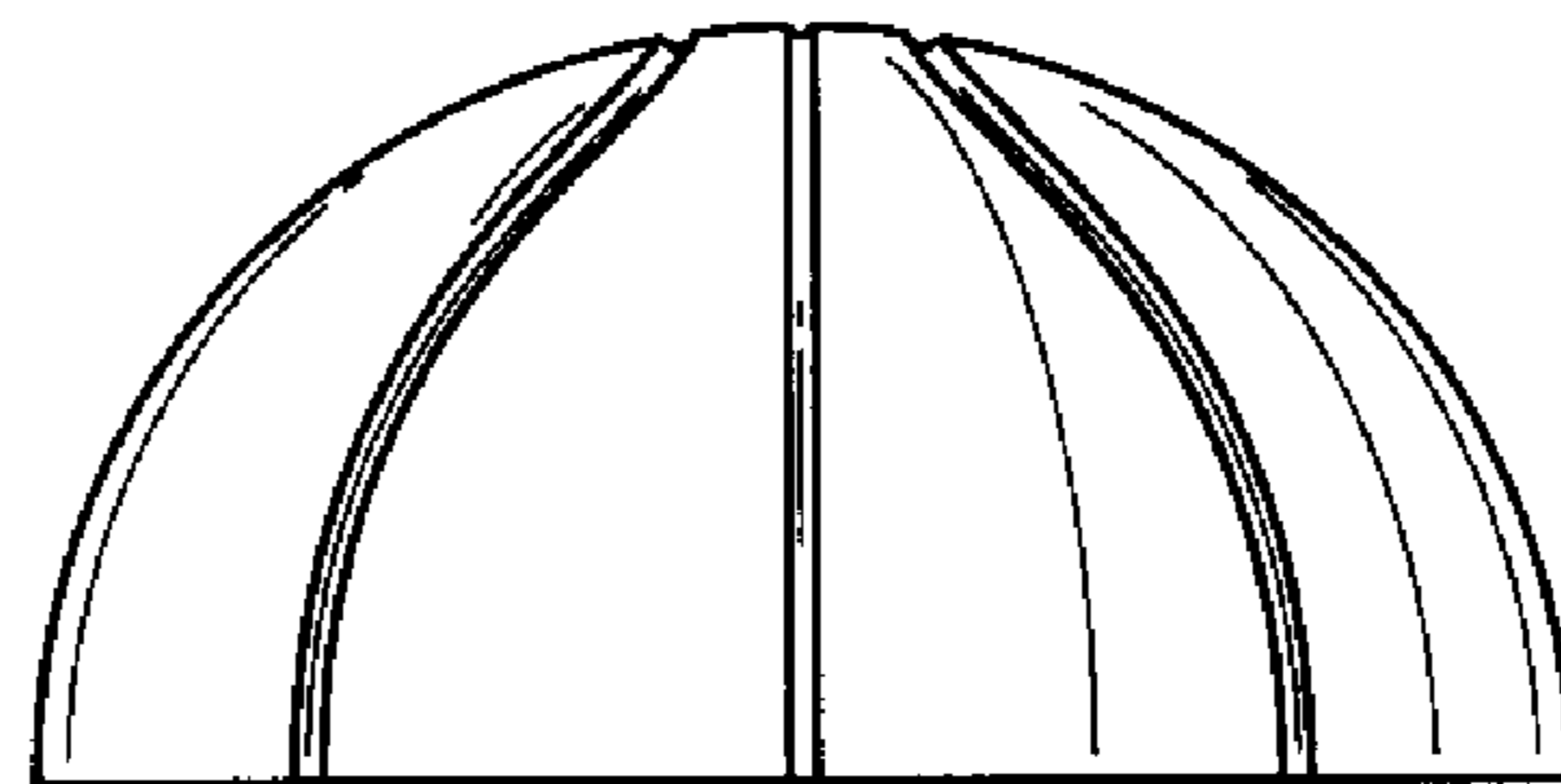

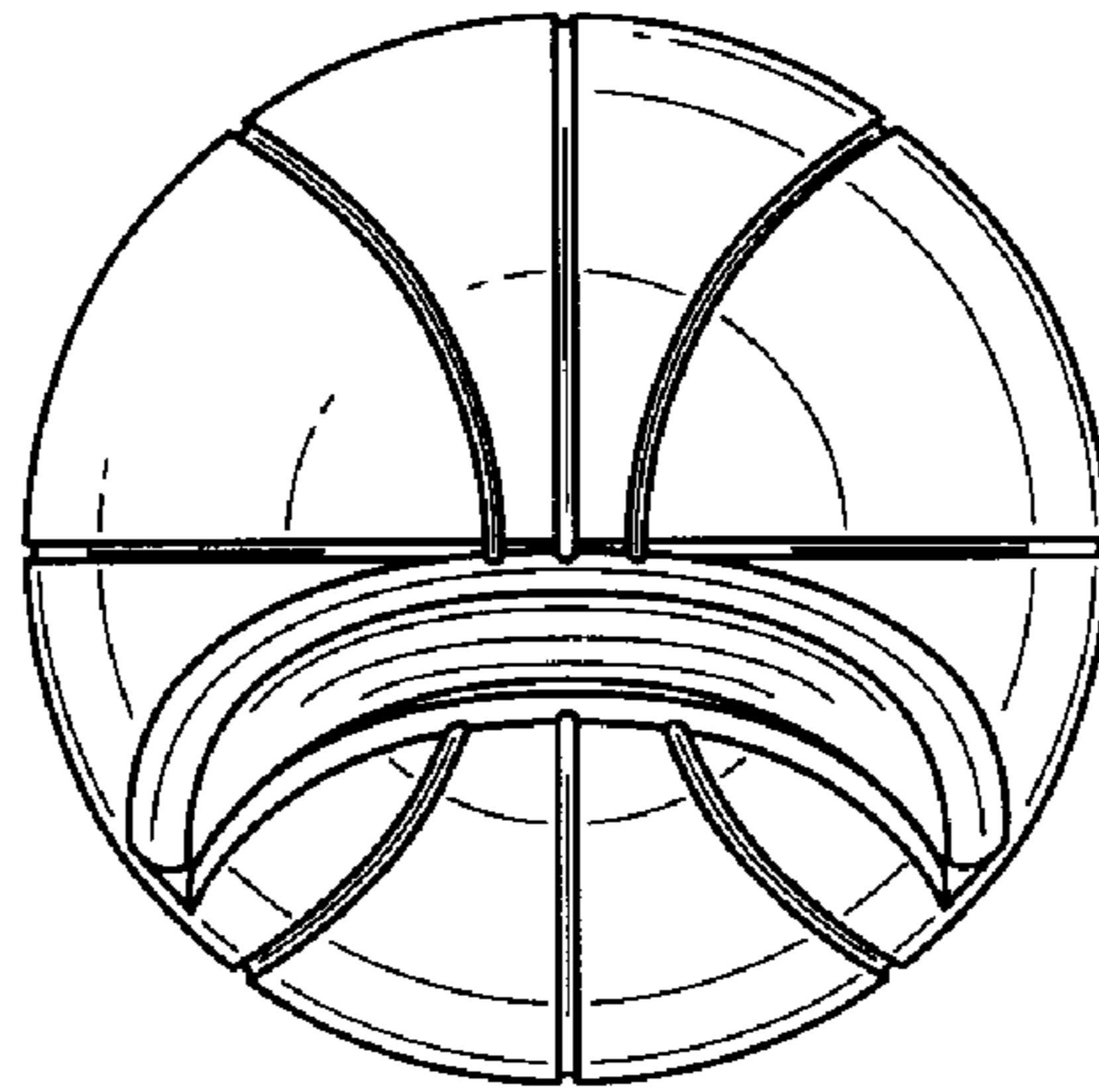

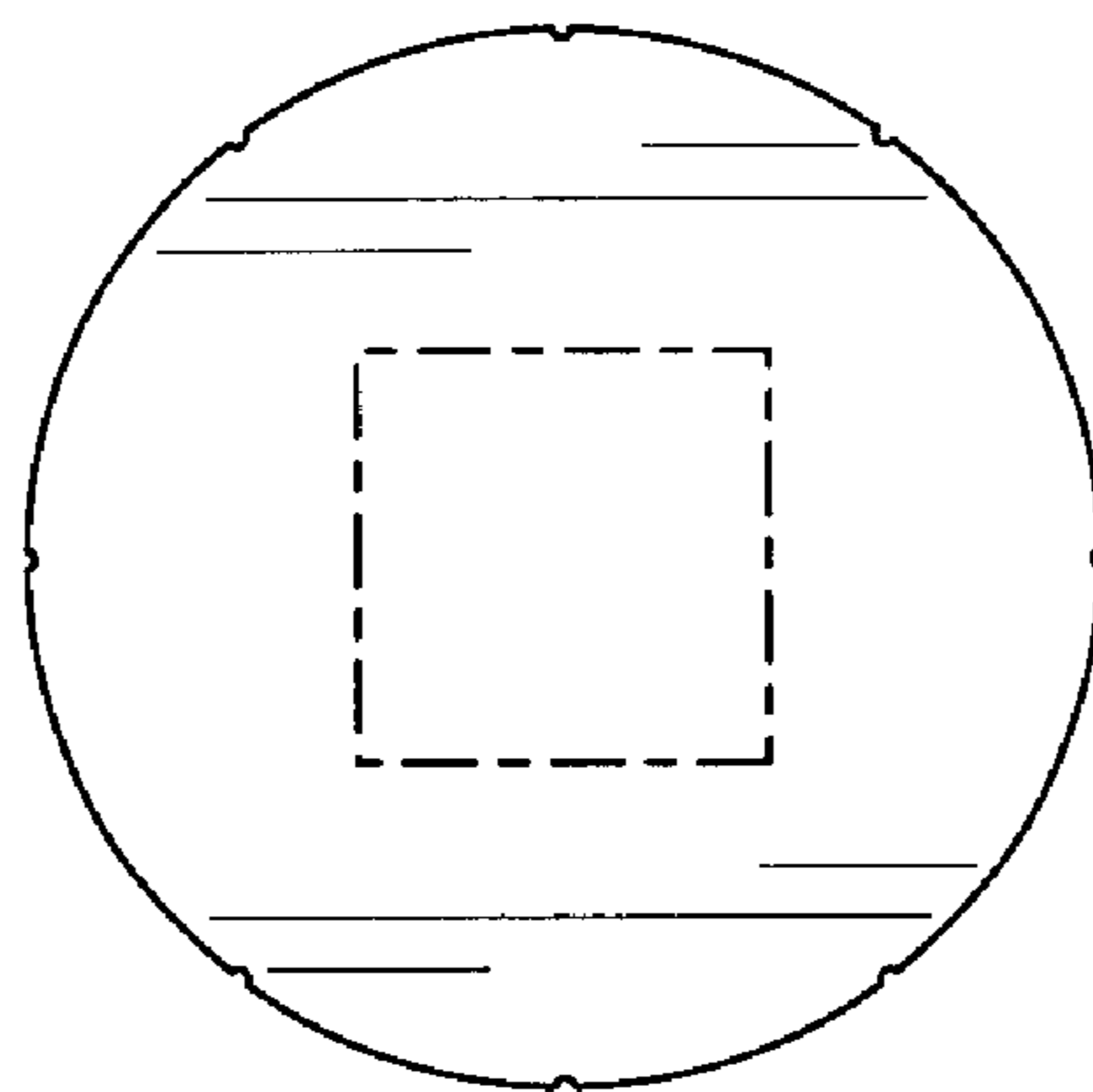

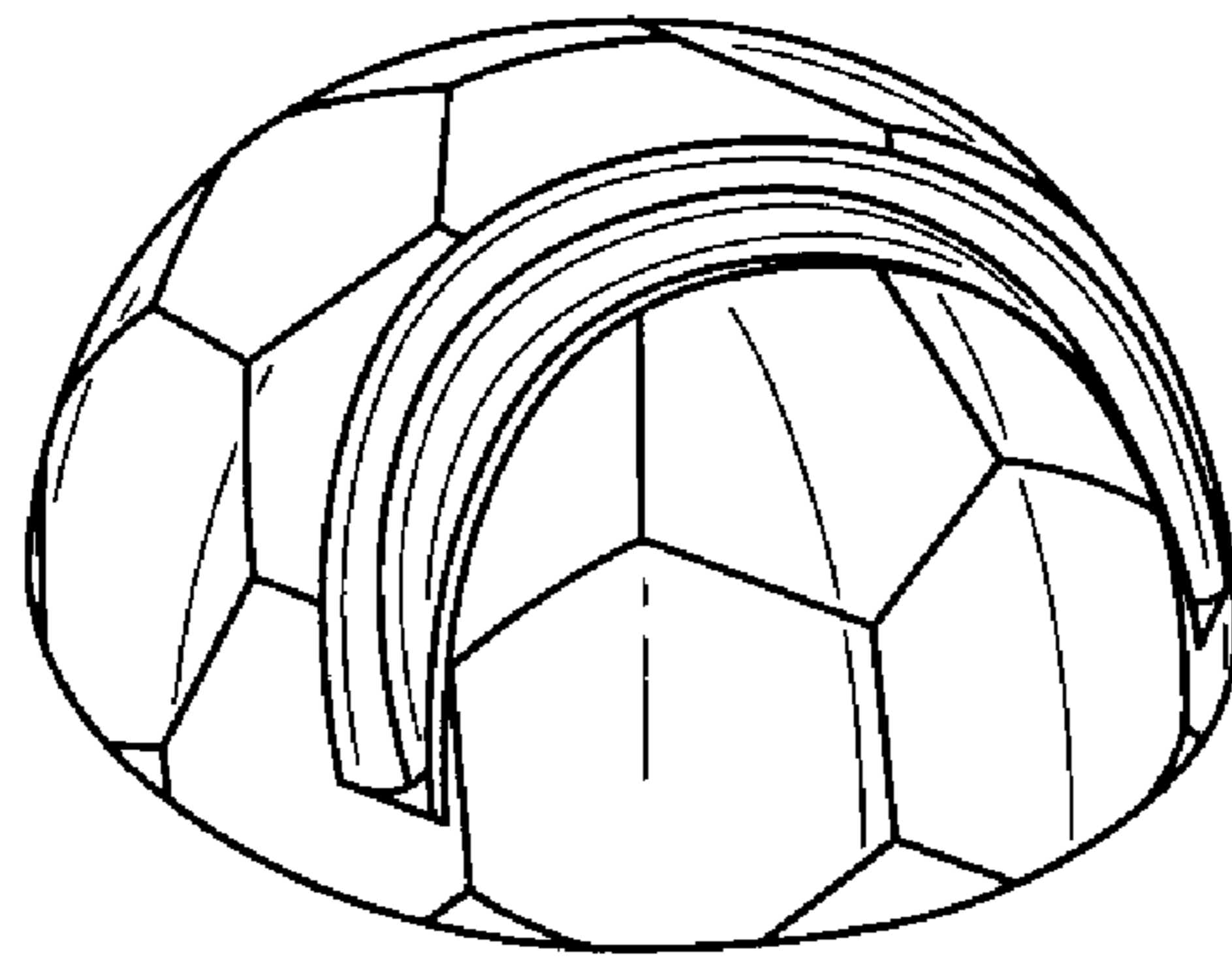

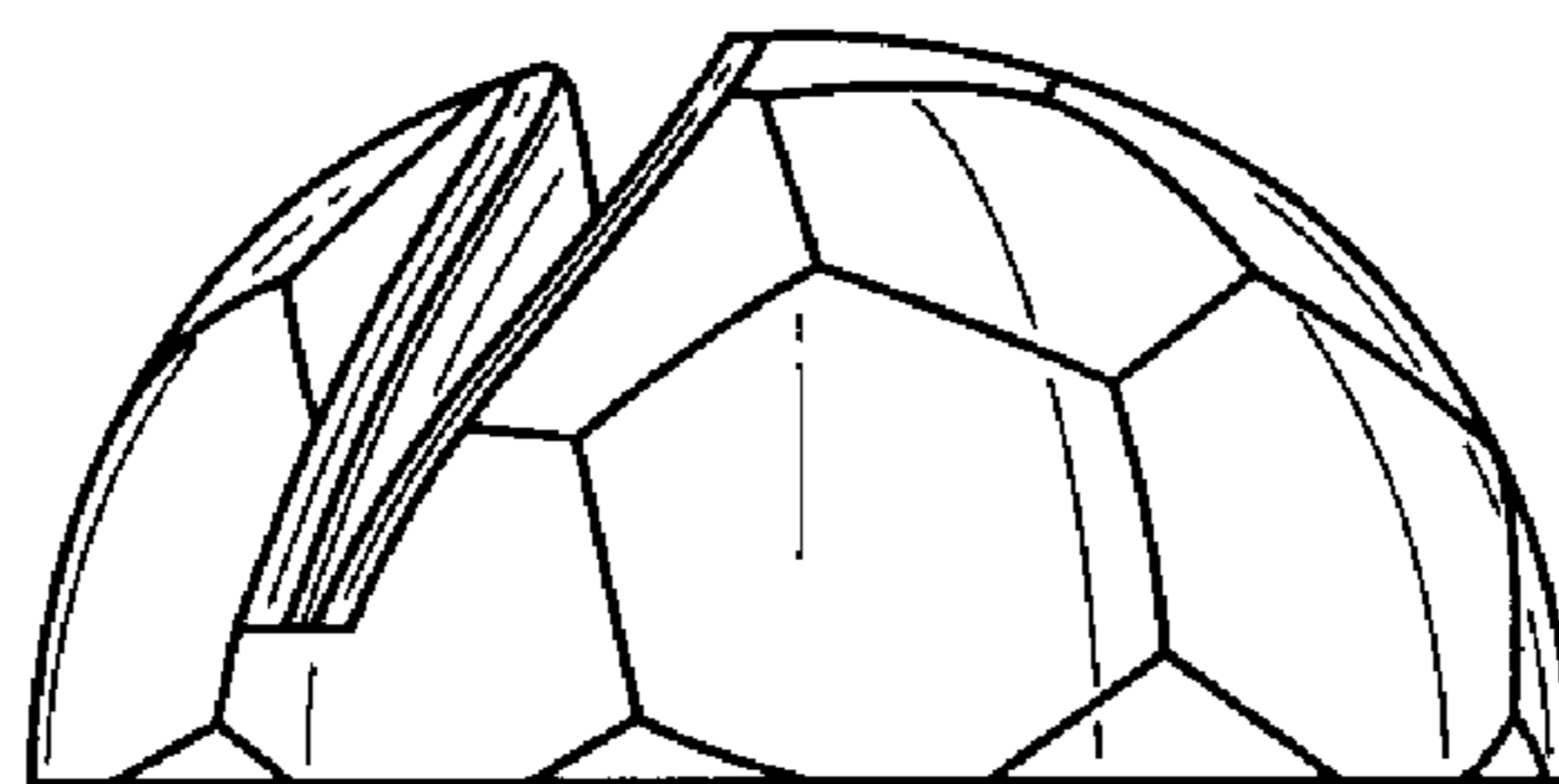

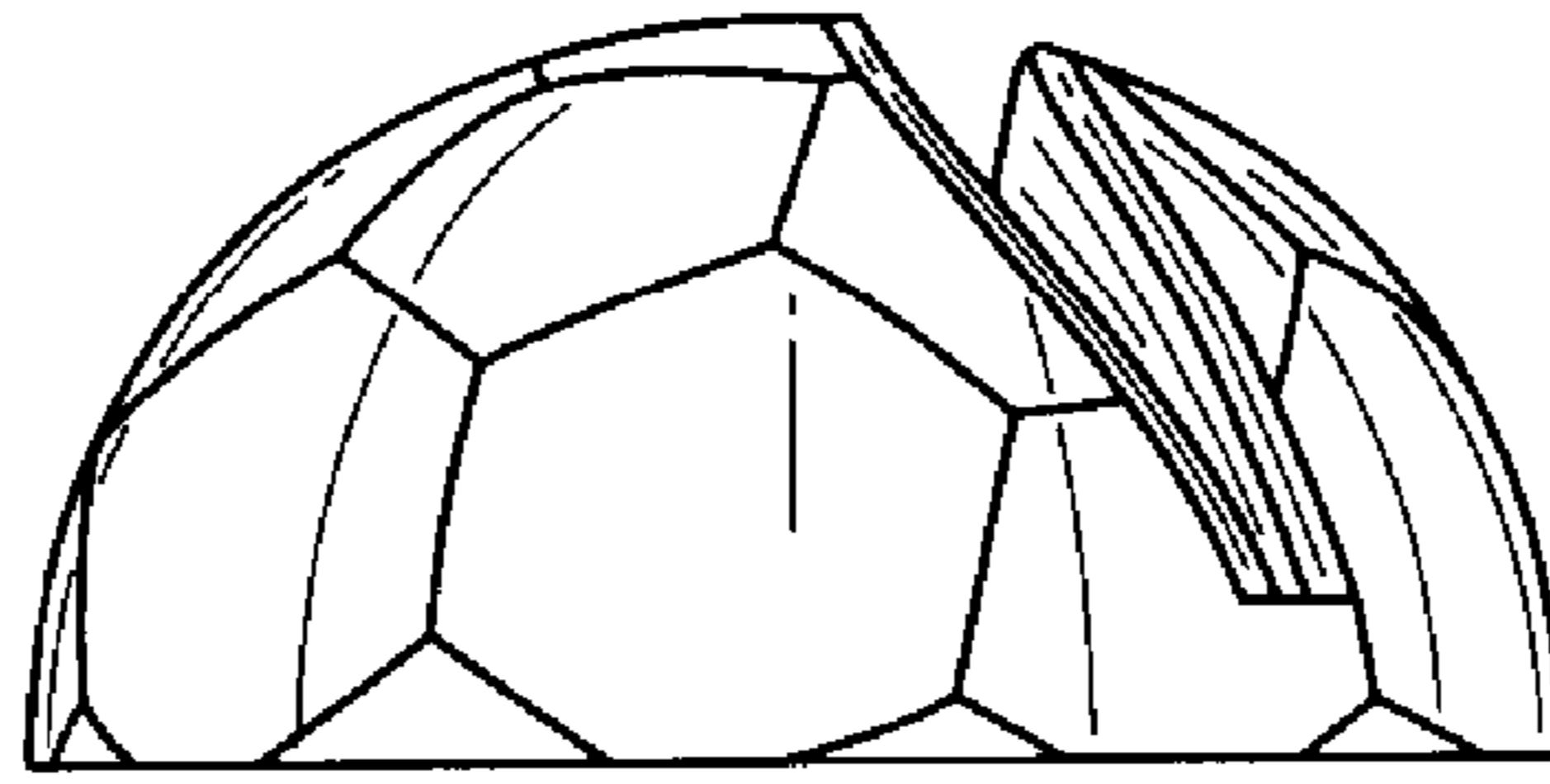

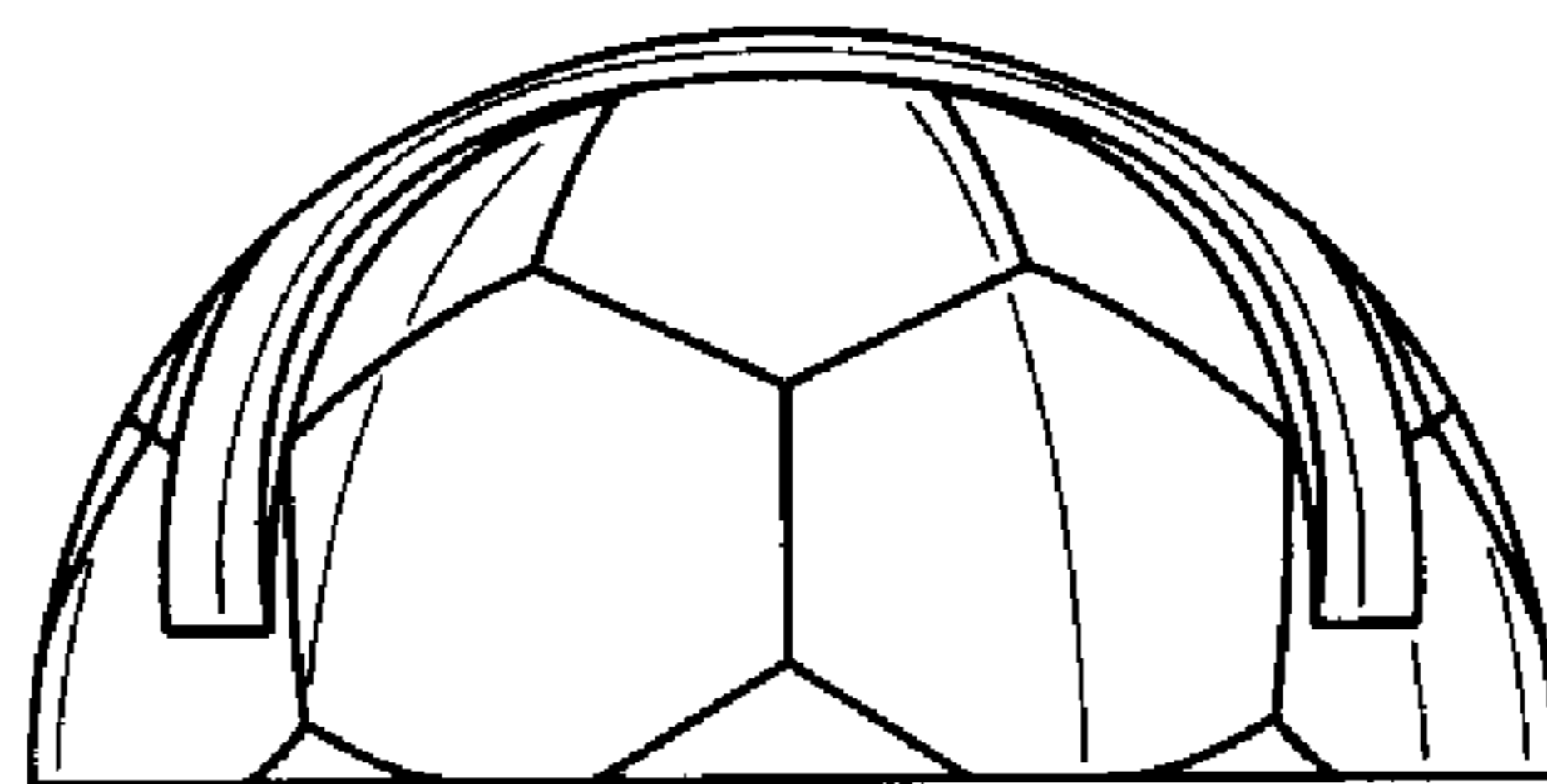

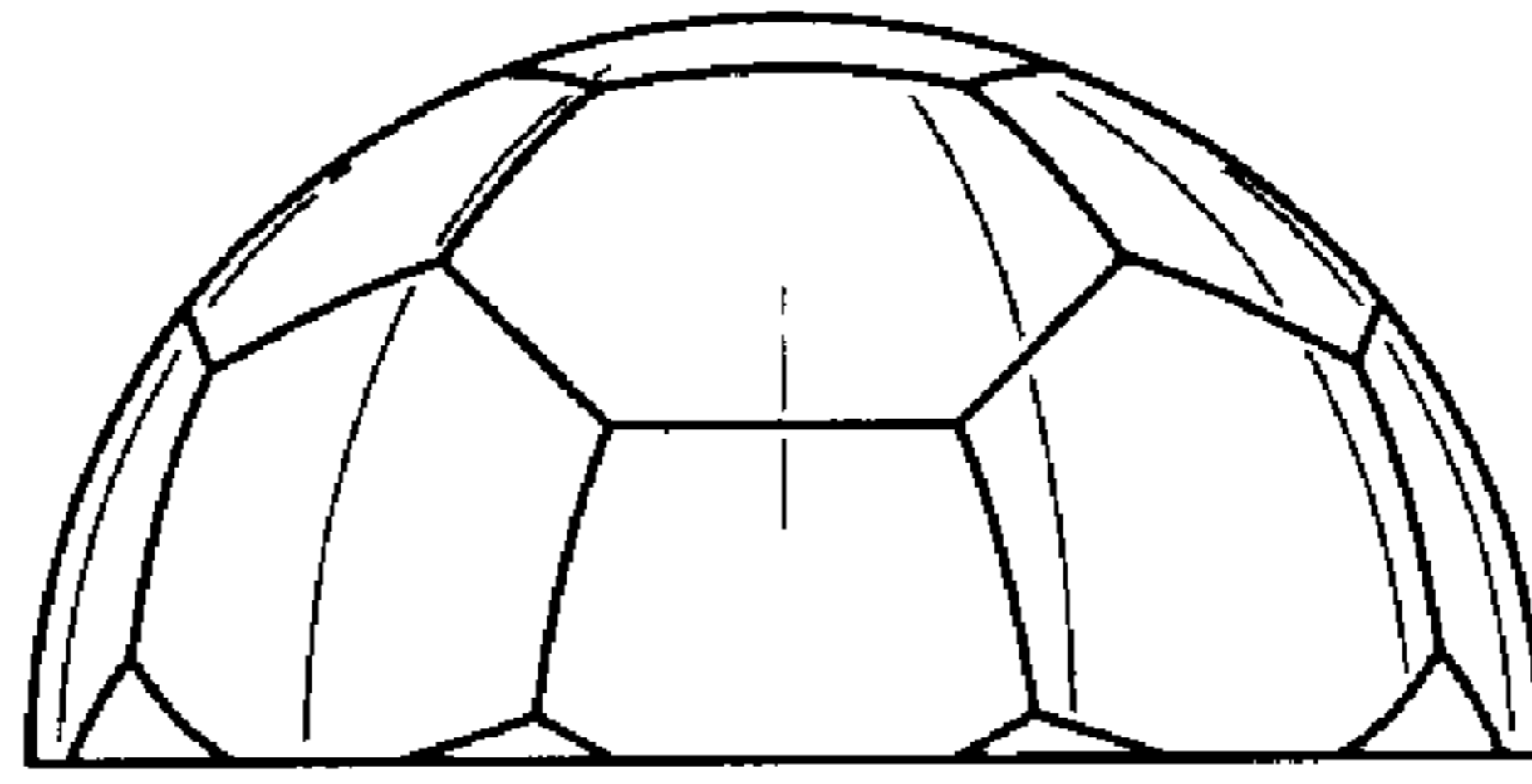

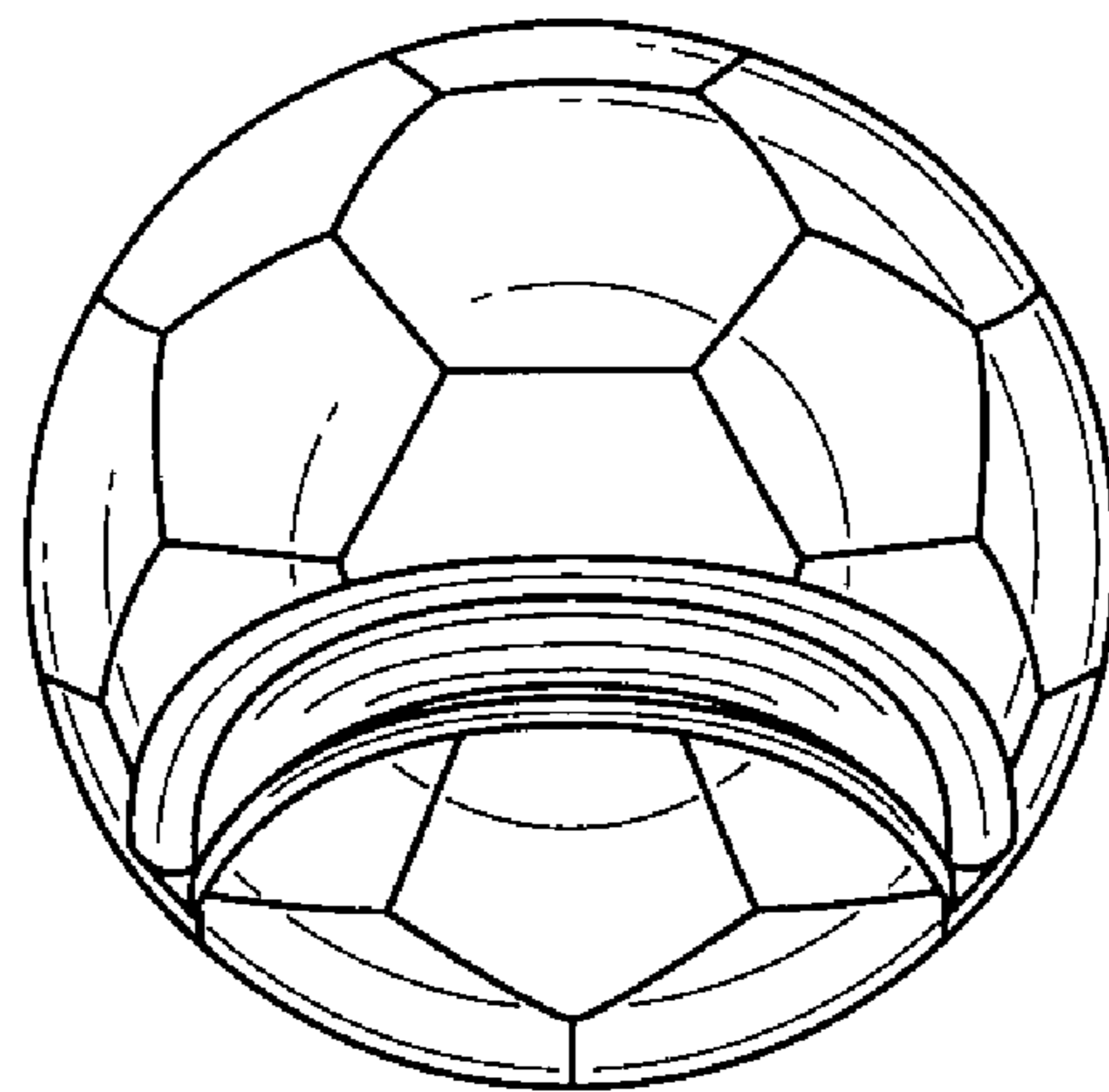

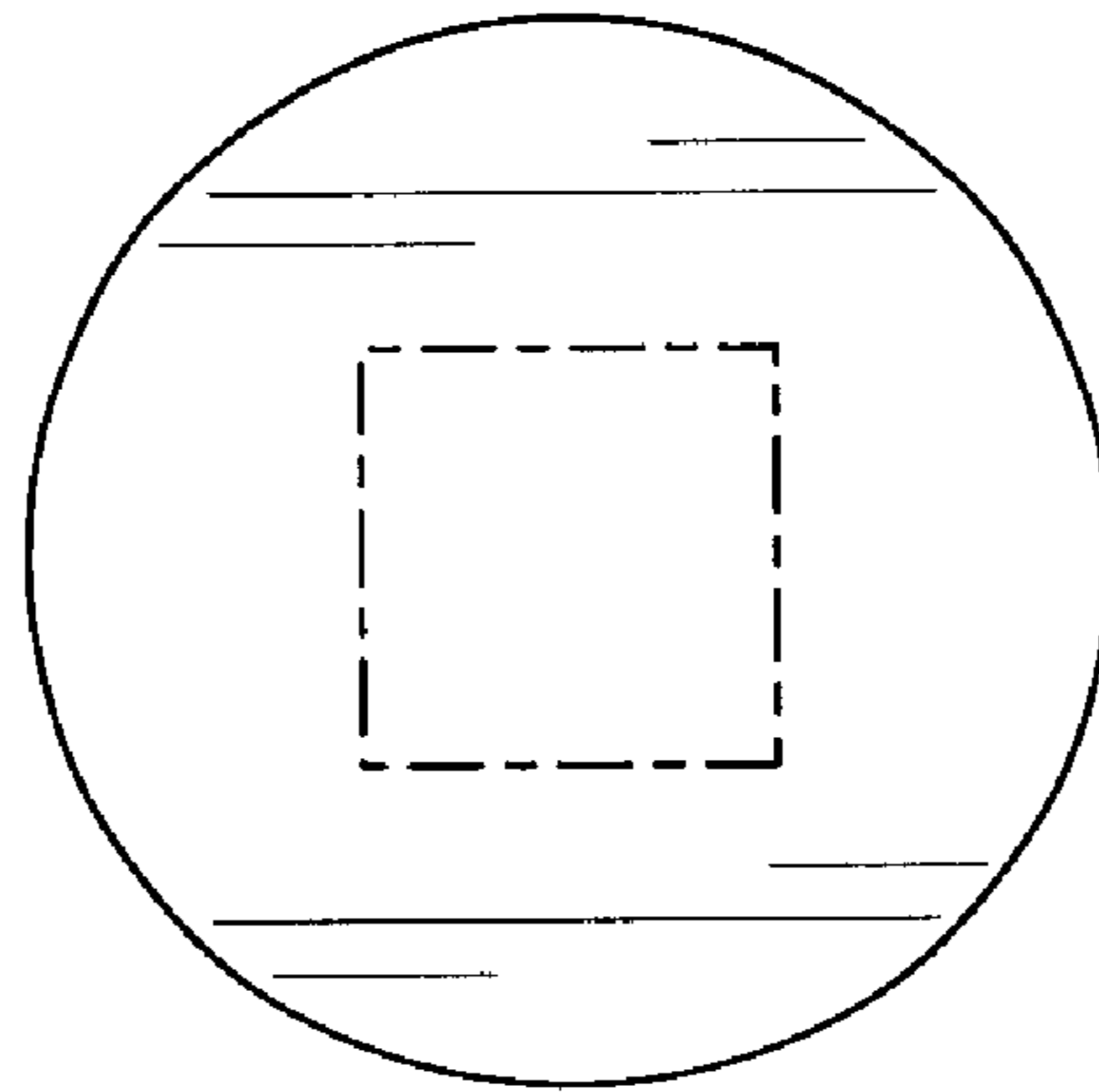

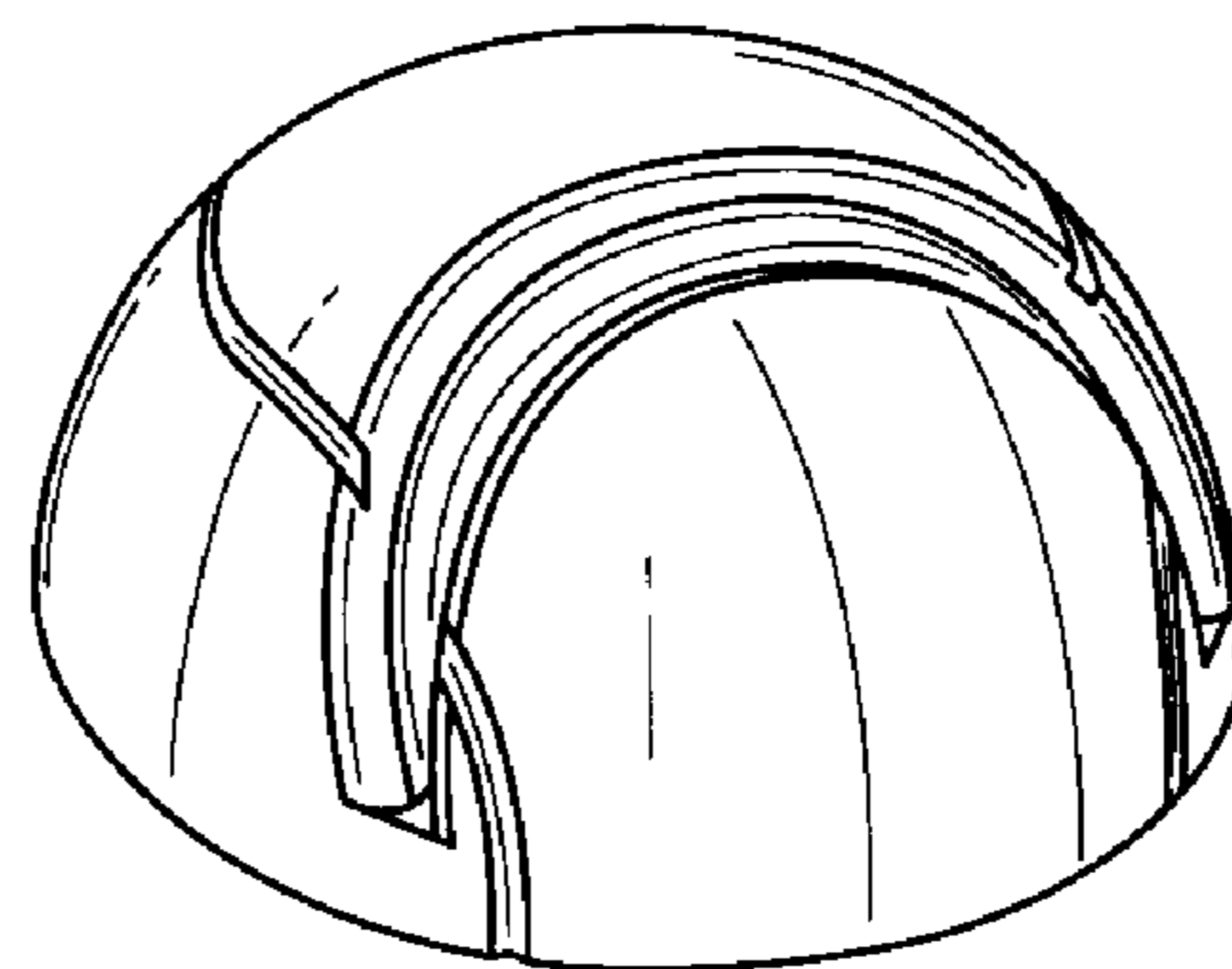

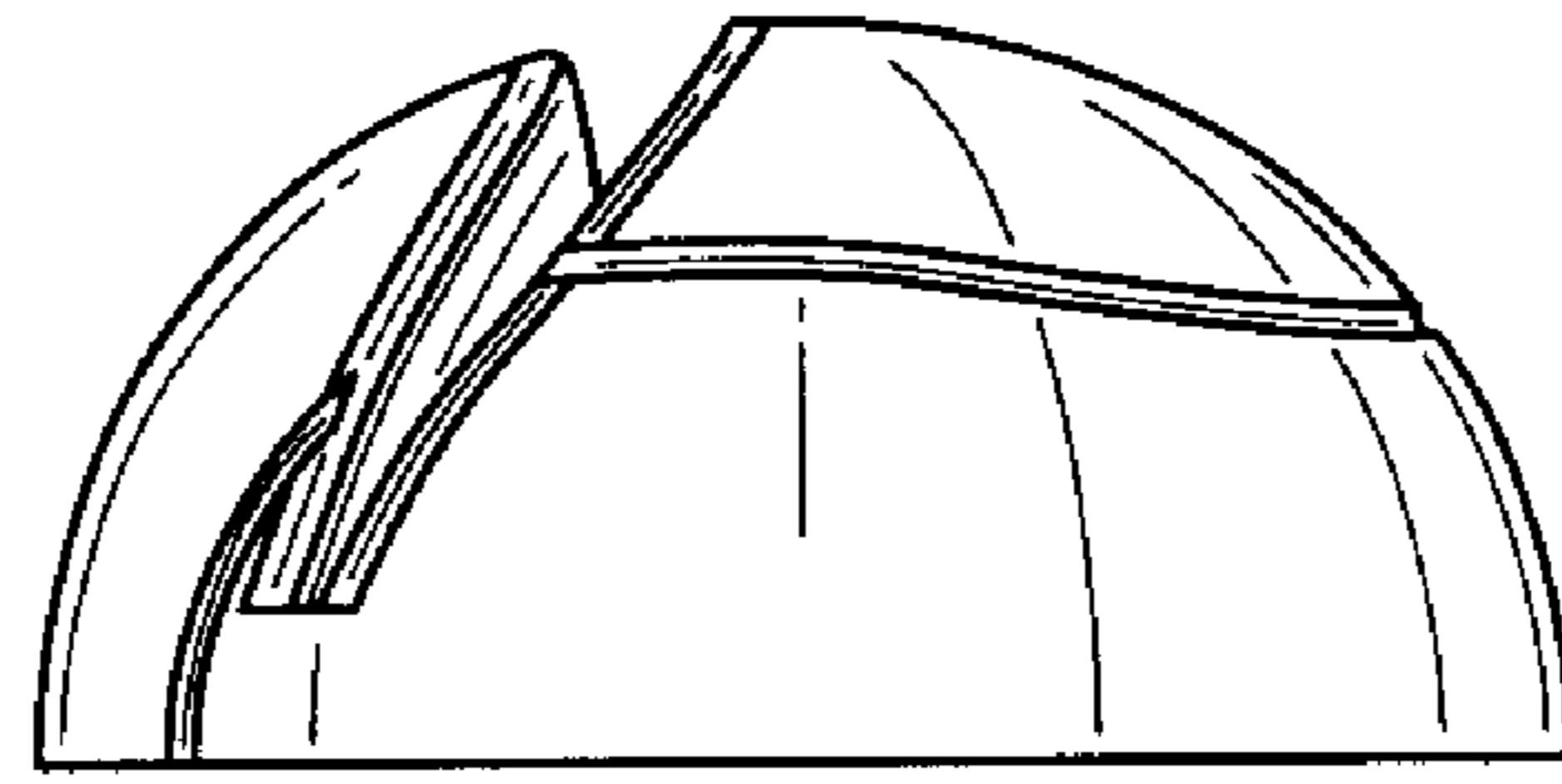

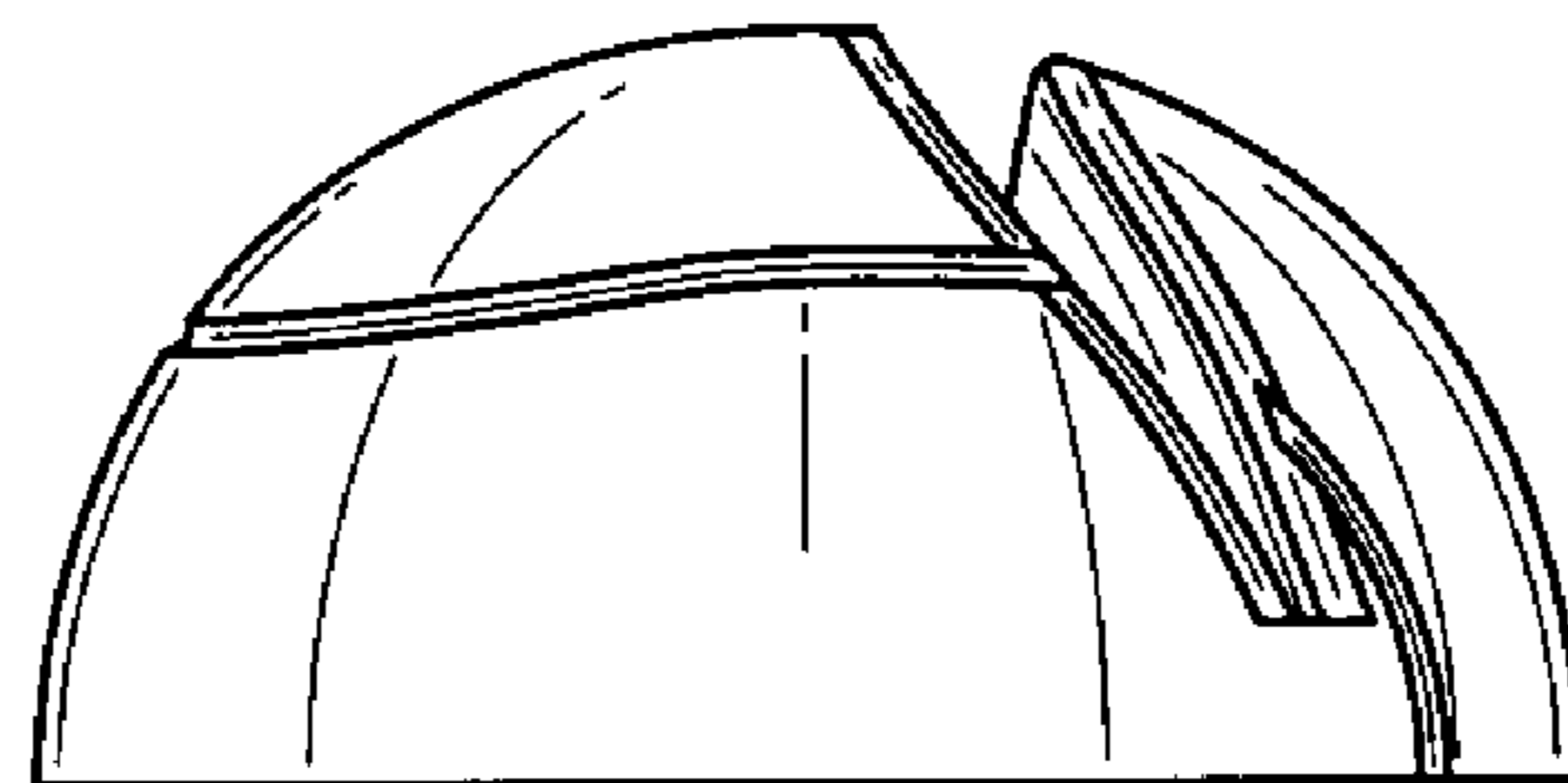

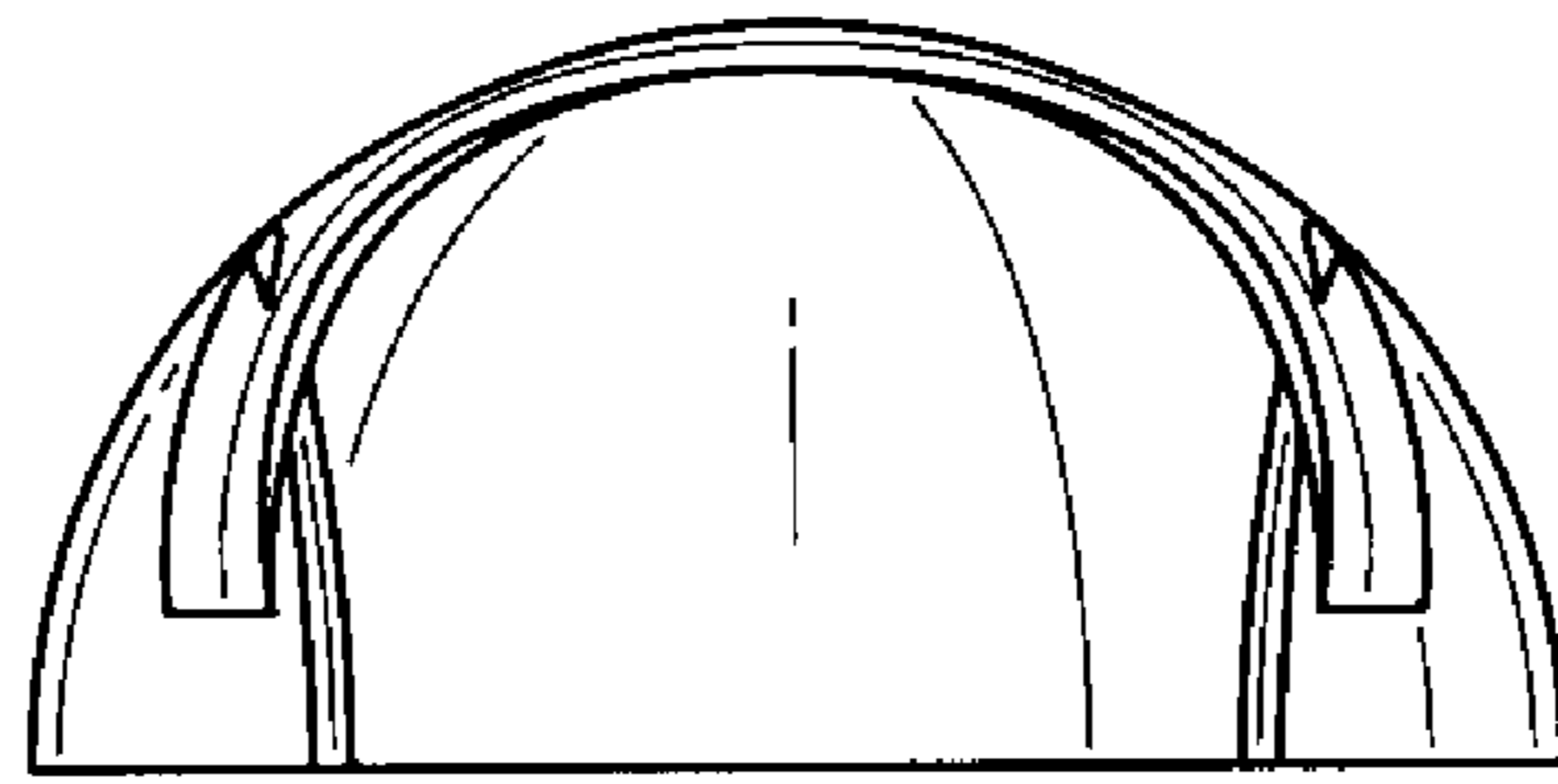

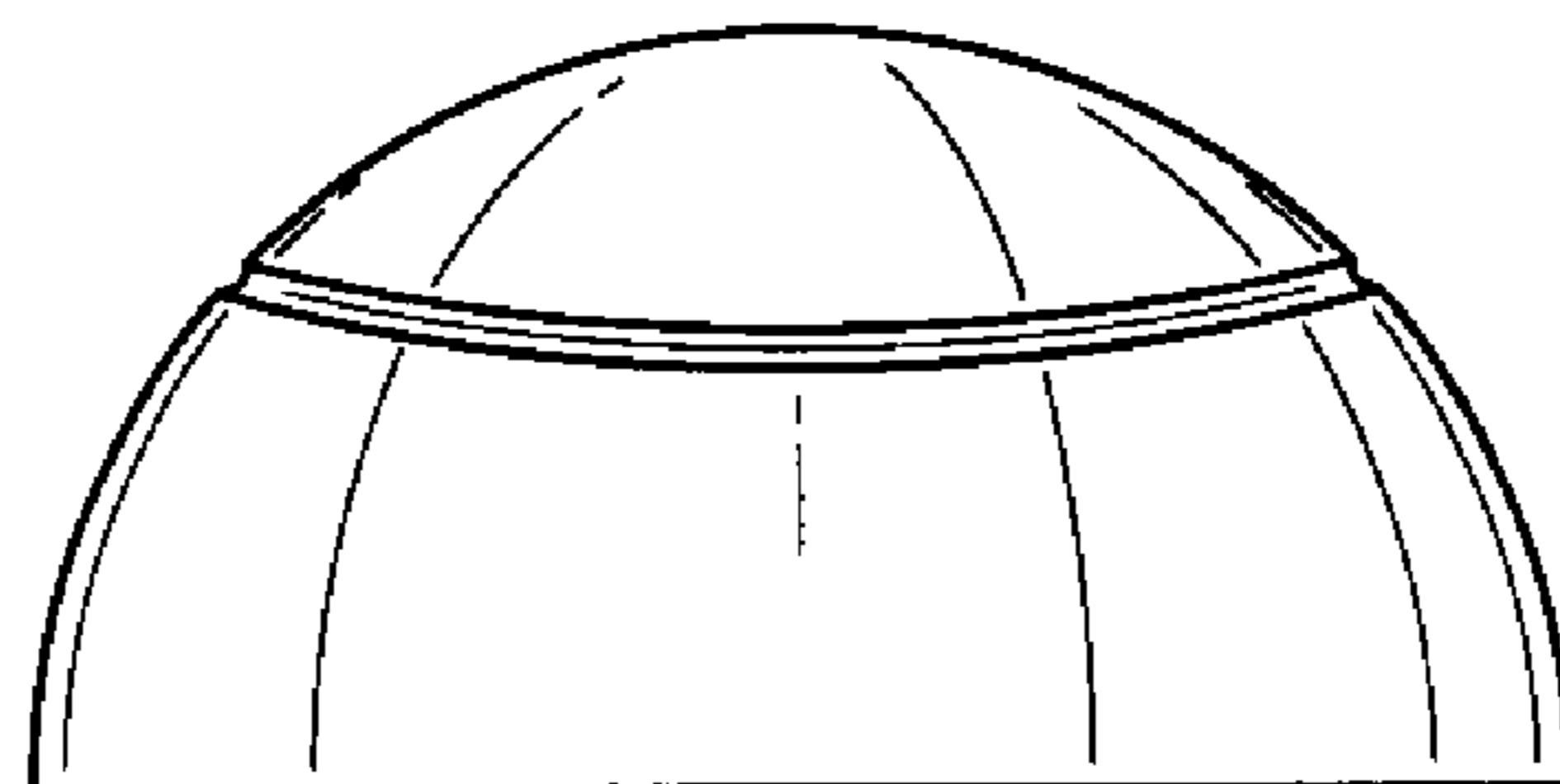

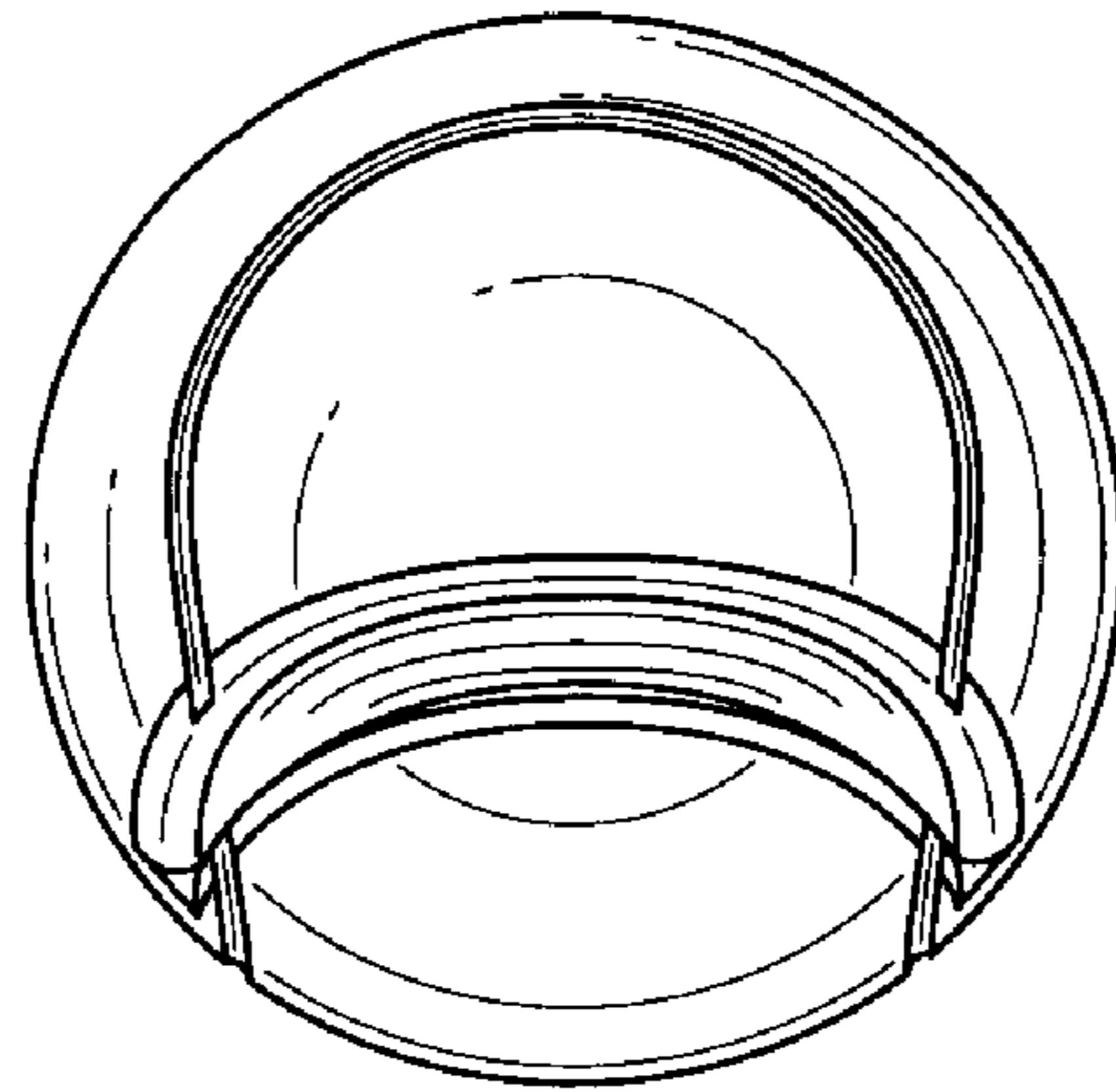

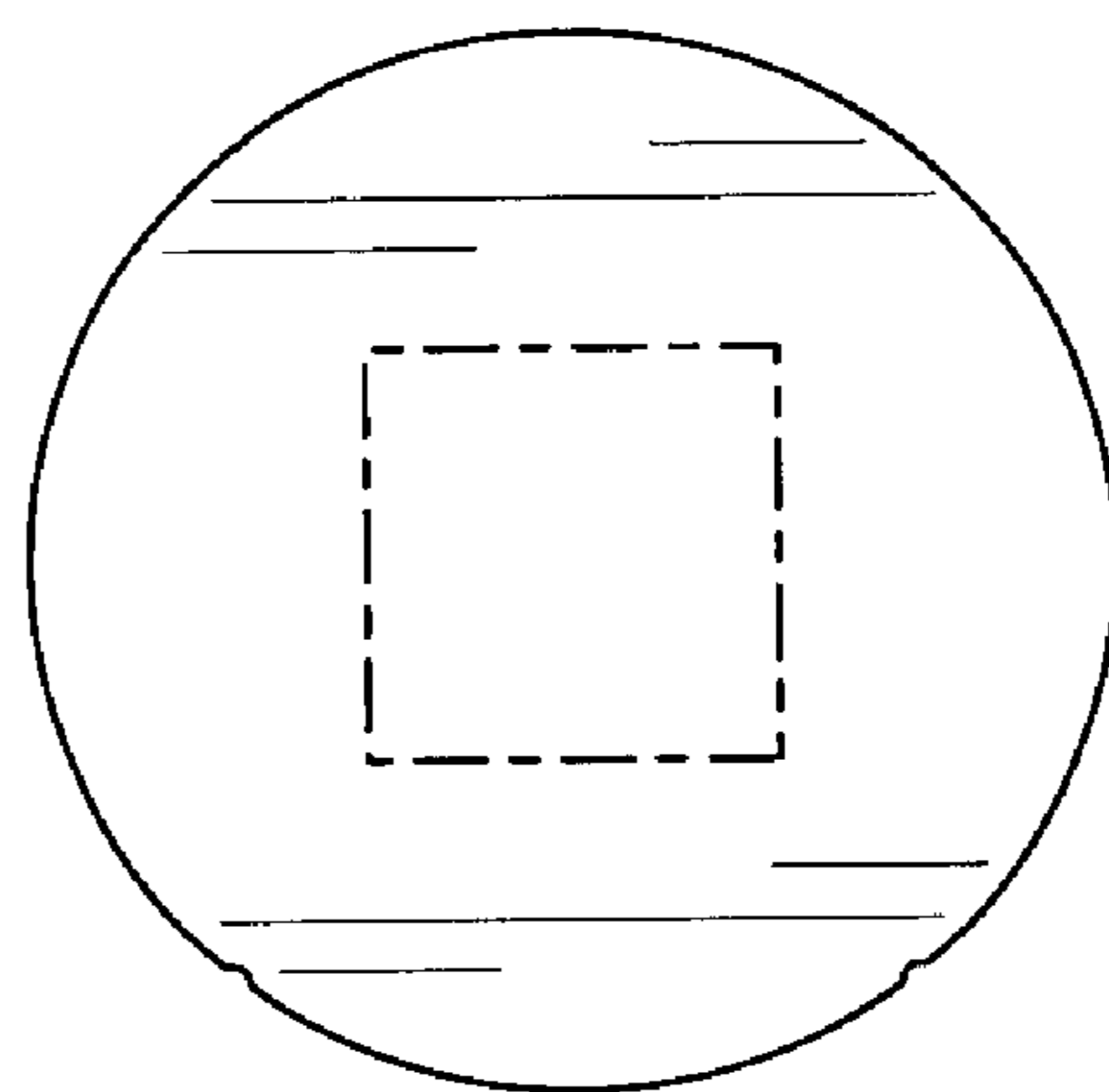

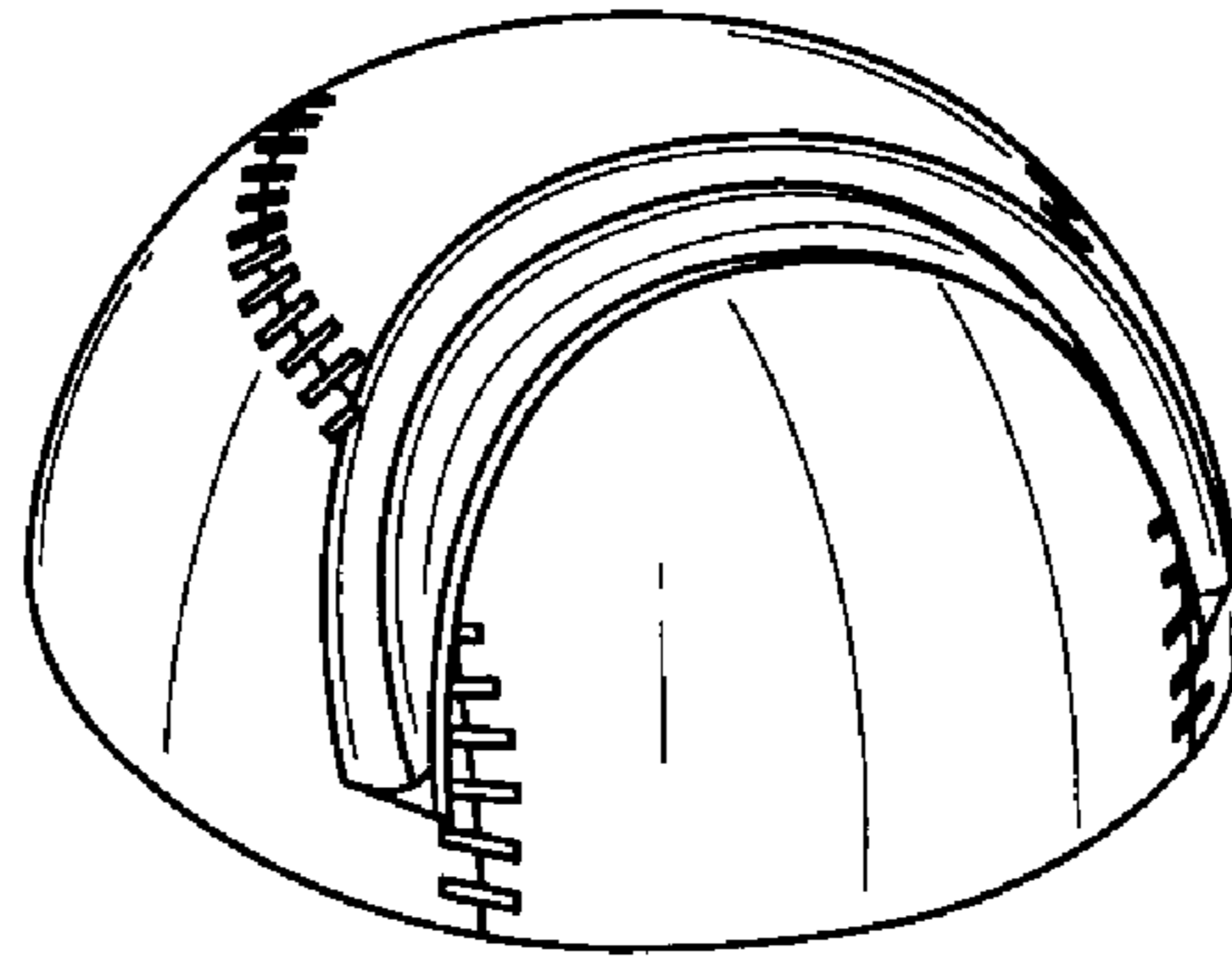

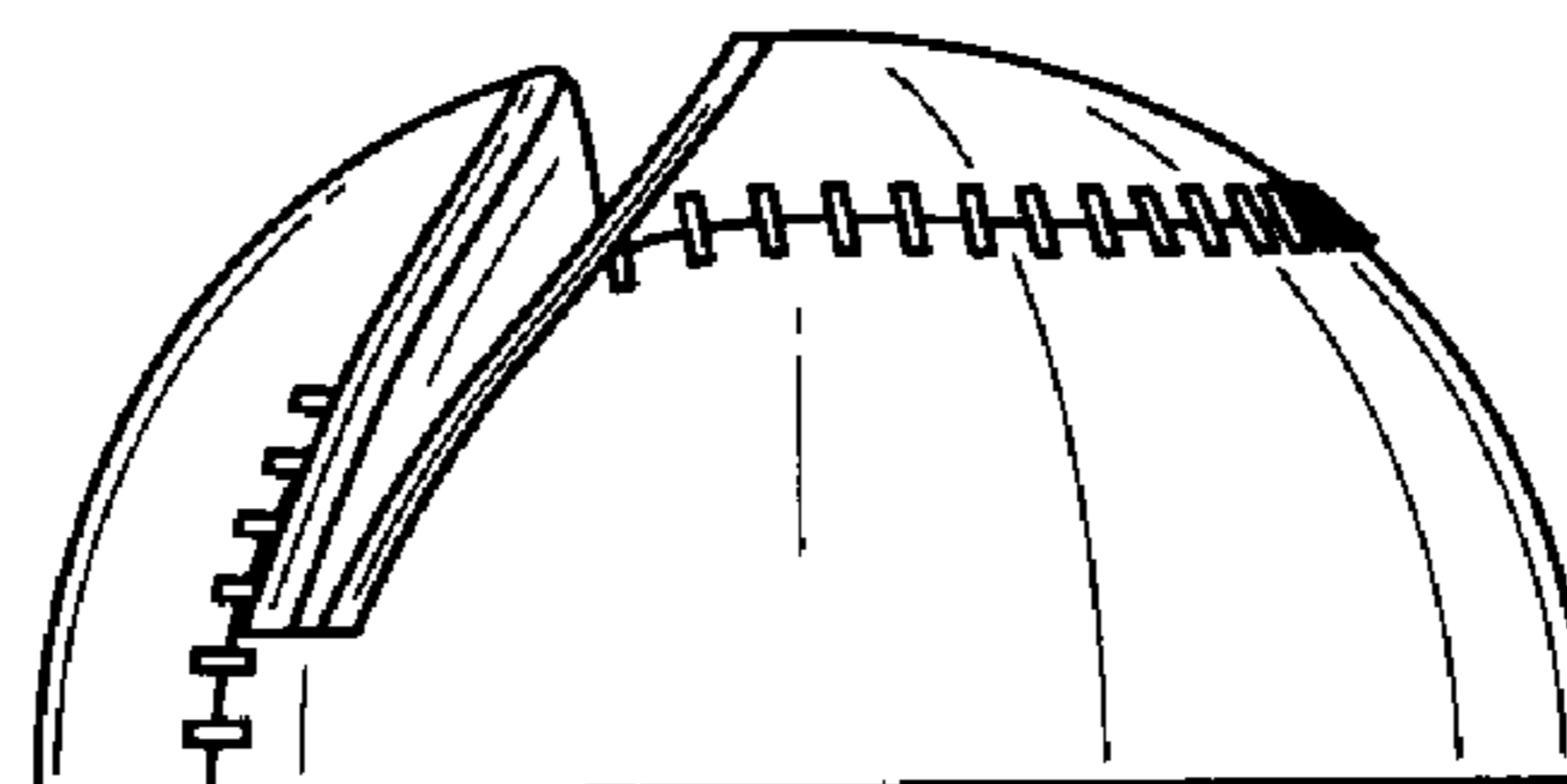

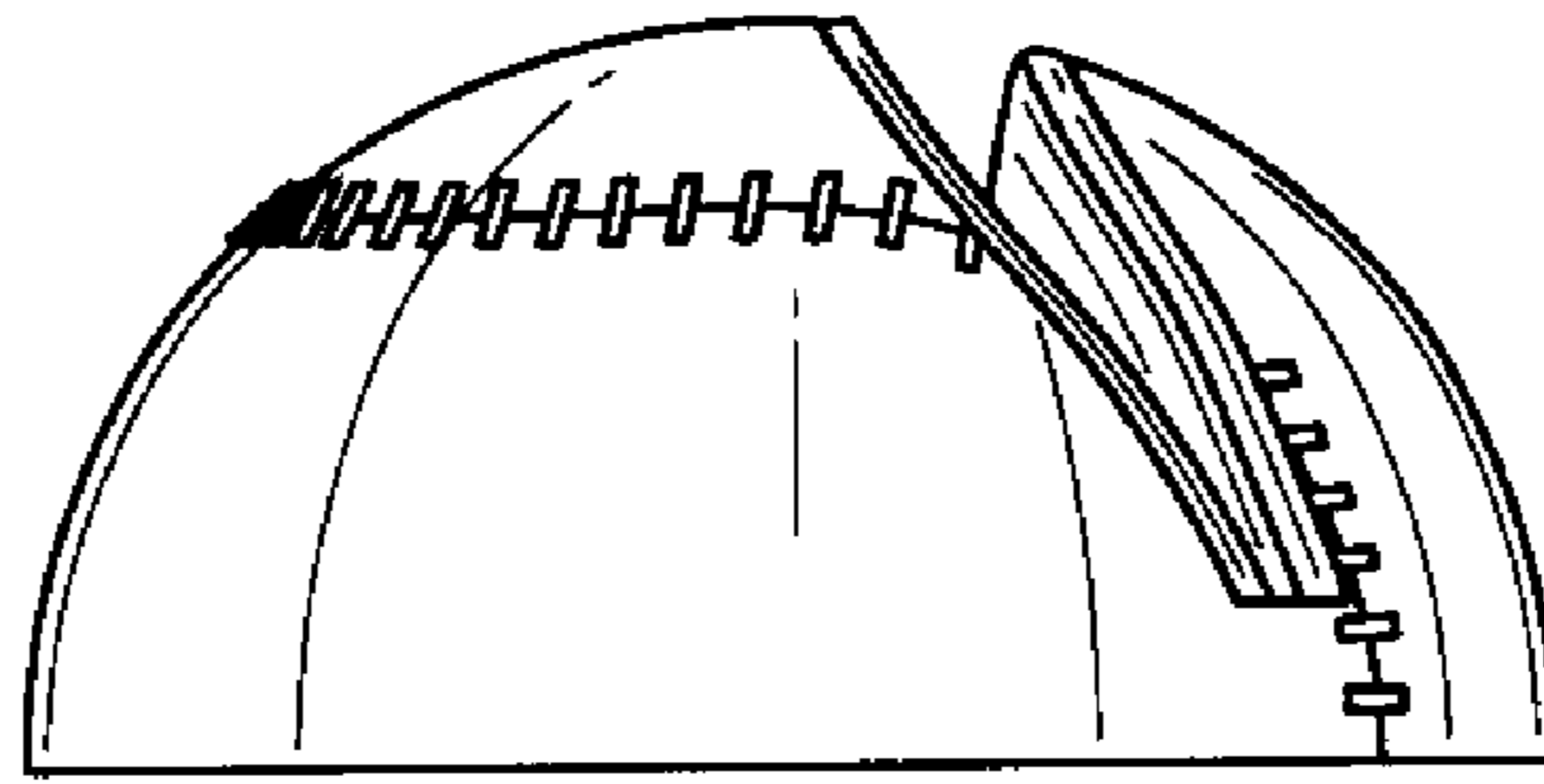

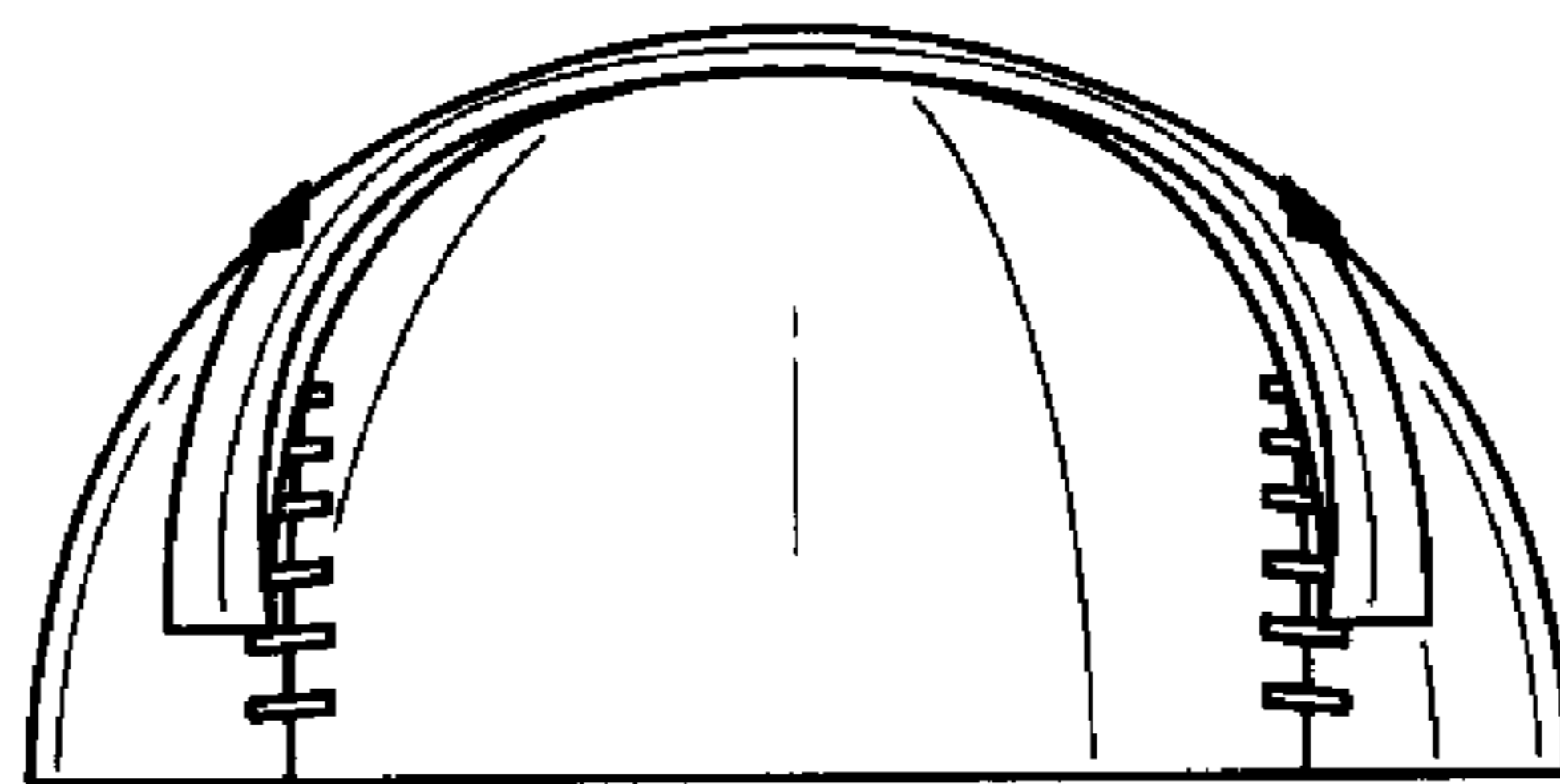

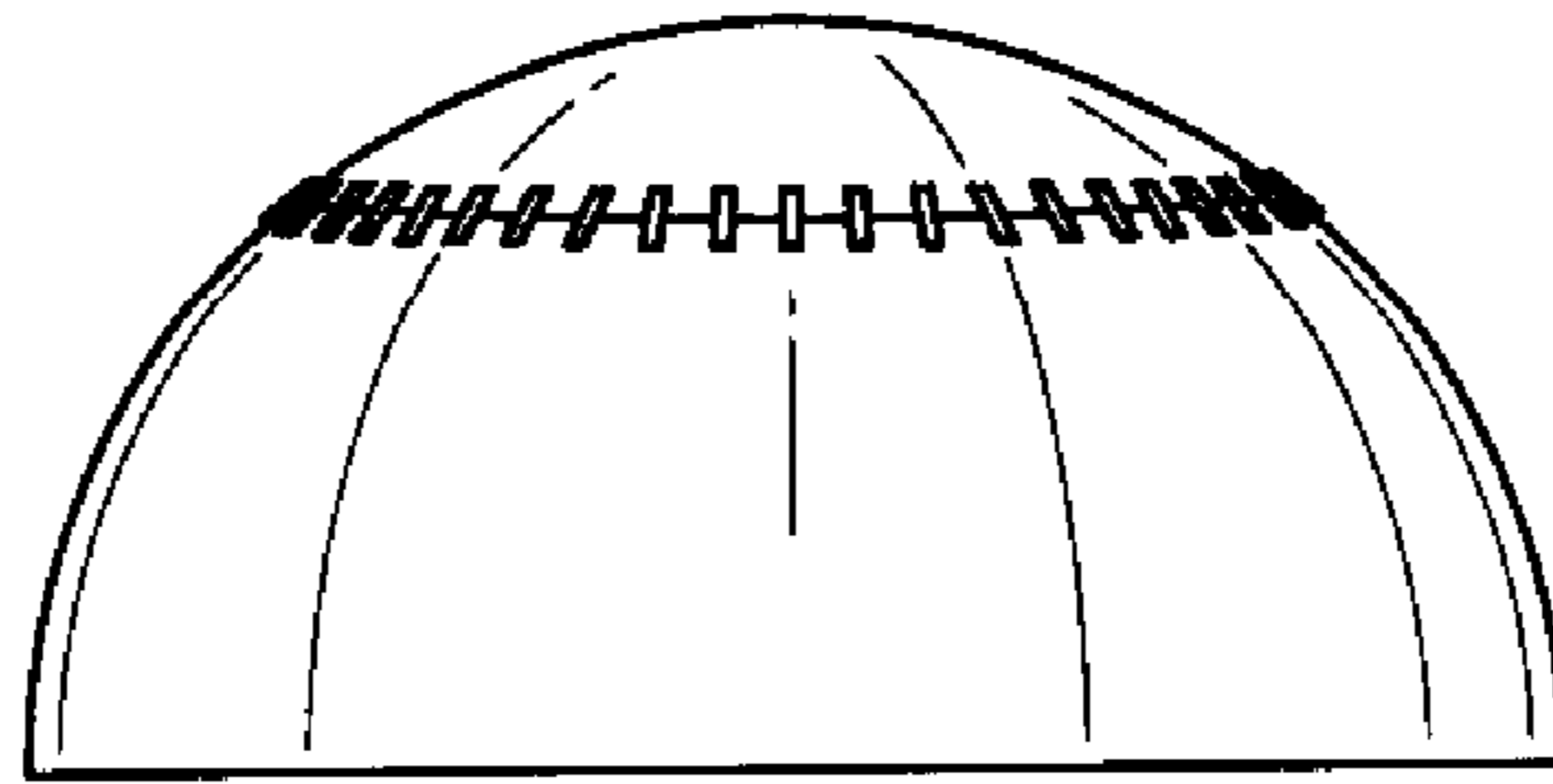

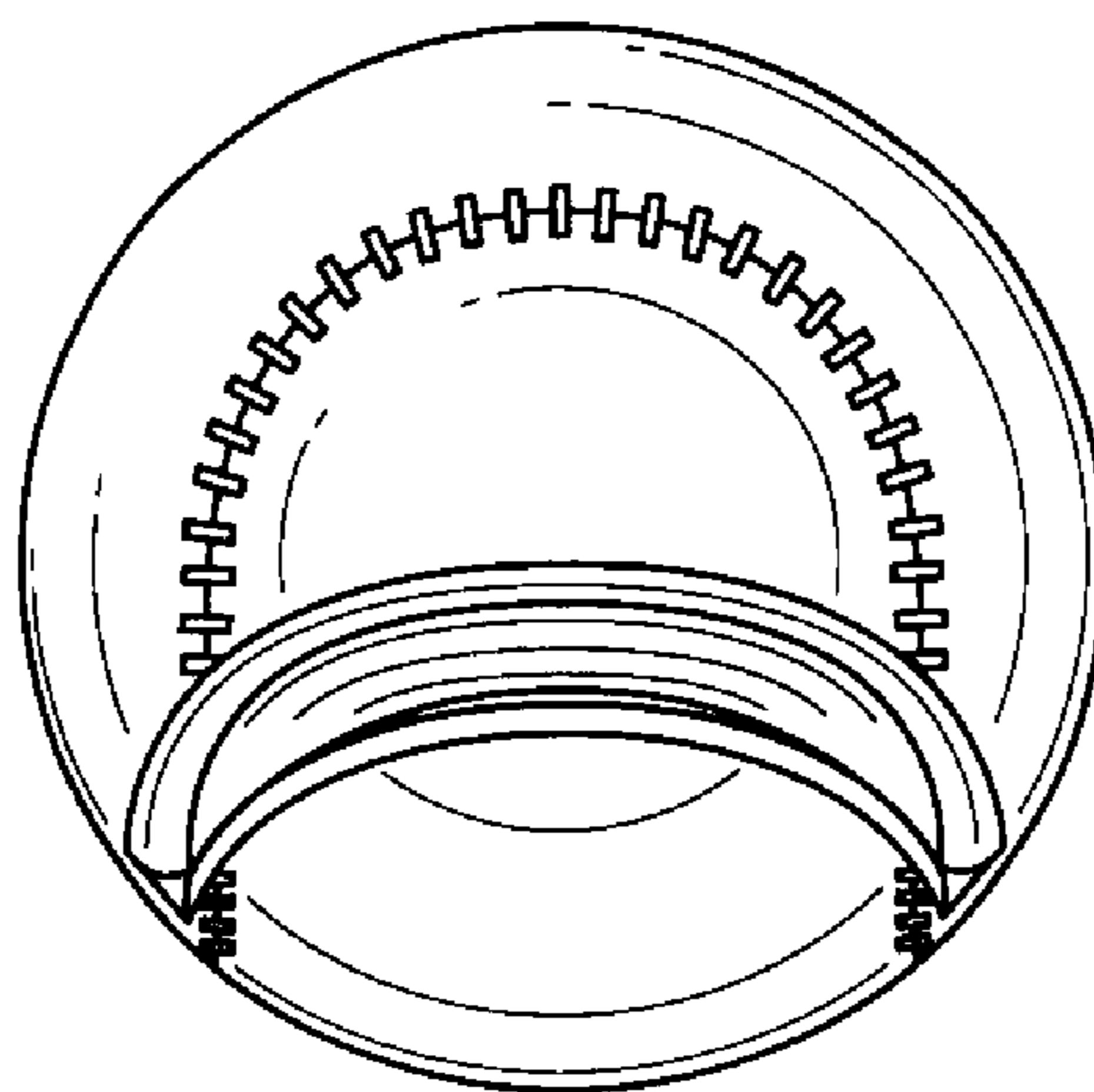

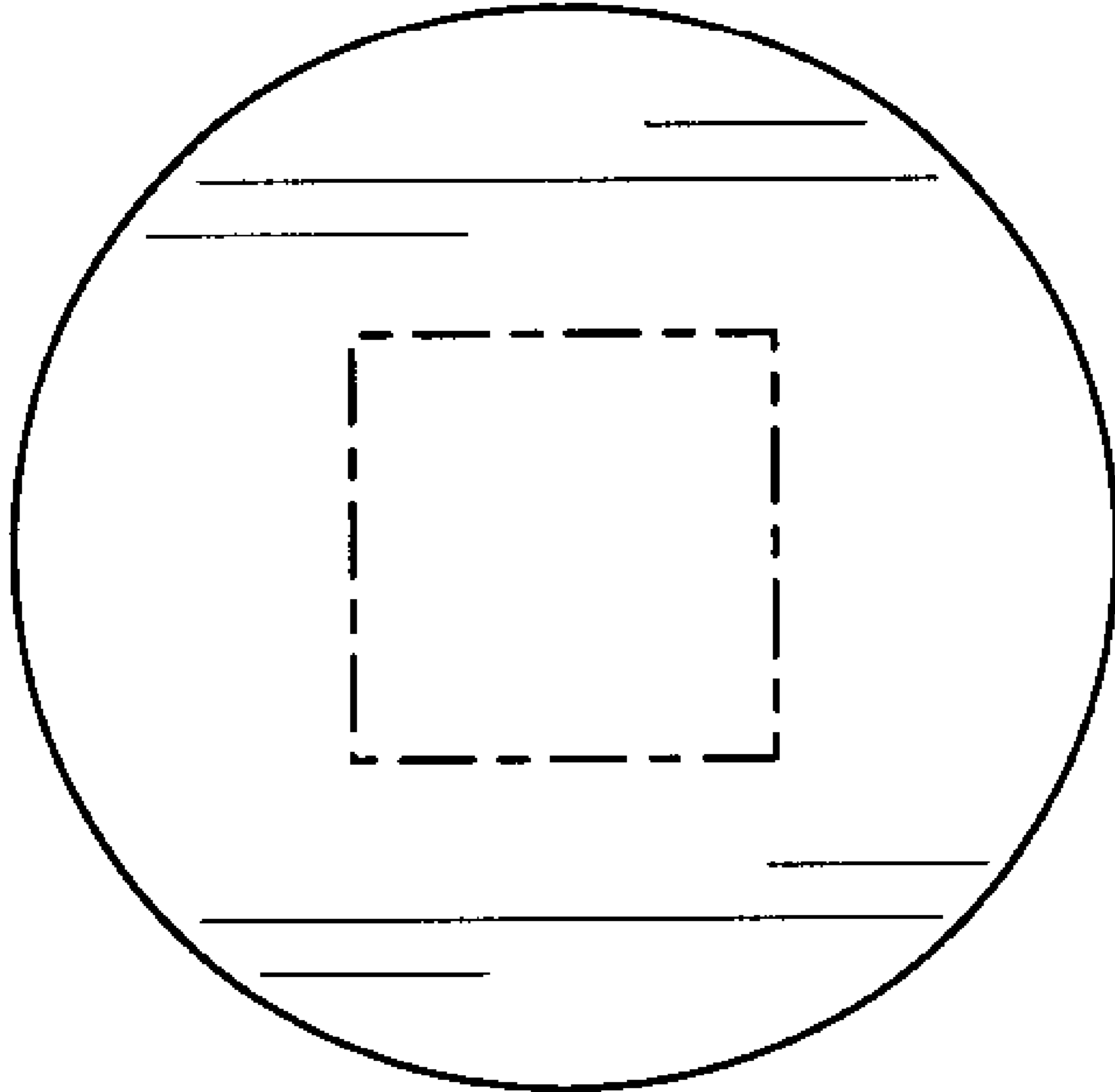
