FIG. 1 is a perspective view of the front of an ergonomic luggage handle of the invention, showing our new design in the context of a piece of luggage with the handle in the down position.

FIG. 2 is a front view of the ergonomic luggage handle of the invention.

FIG. 3 is a side view of the ergonomic luggage handle of the invention.

FIG. 4 is a top view of the ergonomic luggage handle of the invention.

FIG. 5 is a bottom view of the ergonomic luggage handle of the invention.

FIG. 6 is a perspective view of the front of an ergonomic luggage handle of the invention, showing our new design in the context of a piece of luggage with the handle in the up position, parallel to the ground.

FIG. 7 is a perspective view of the front of an ergonomic luggage handle of the invention, showing our new design in the context of a piece of luggage with the handle in the fully up position, perpendicular to the ground; and,

FIG. 8 is a perspective view of the front of an ergonomic luggage handle of the invention, showing our new design in the context of a piece of luggage with the handle in the down position and stored within the luggage.

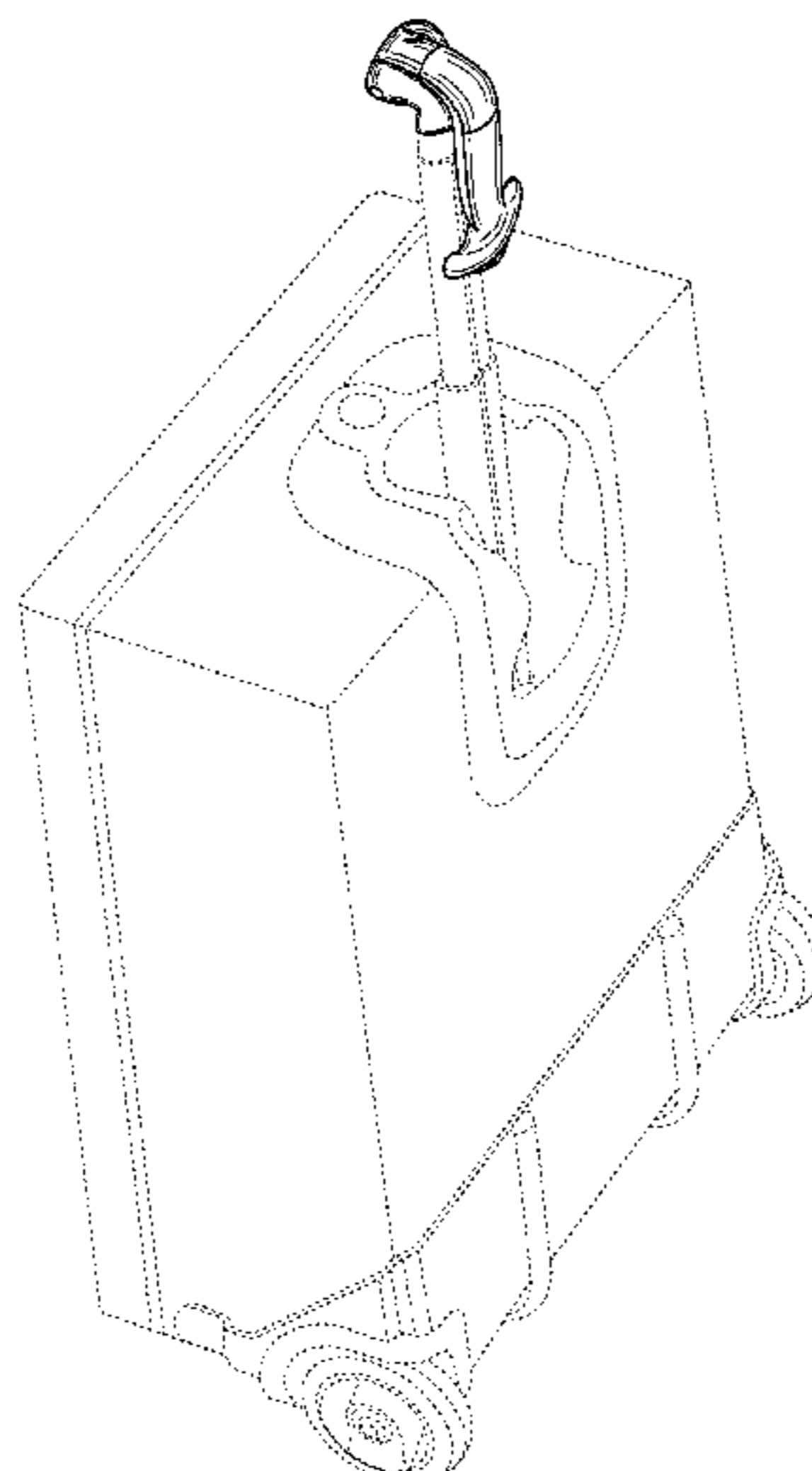
The broken line showing of a suitcase and towing member in FIGS. 1–3, and 6–8, is for illustrative purposes only and forms no part of the claimed design.

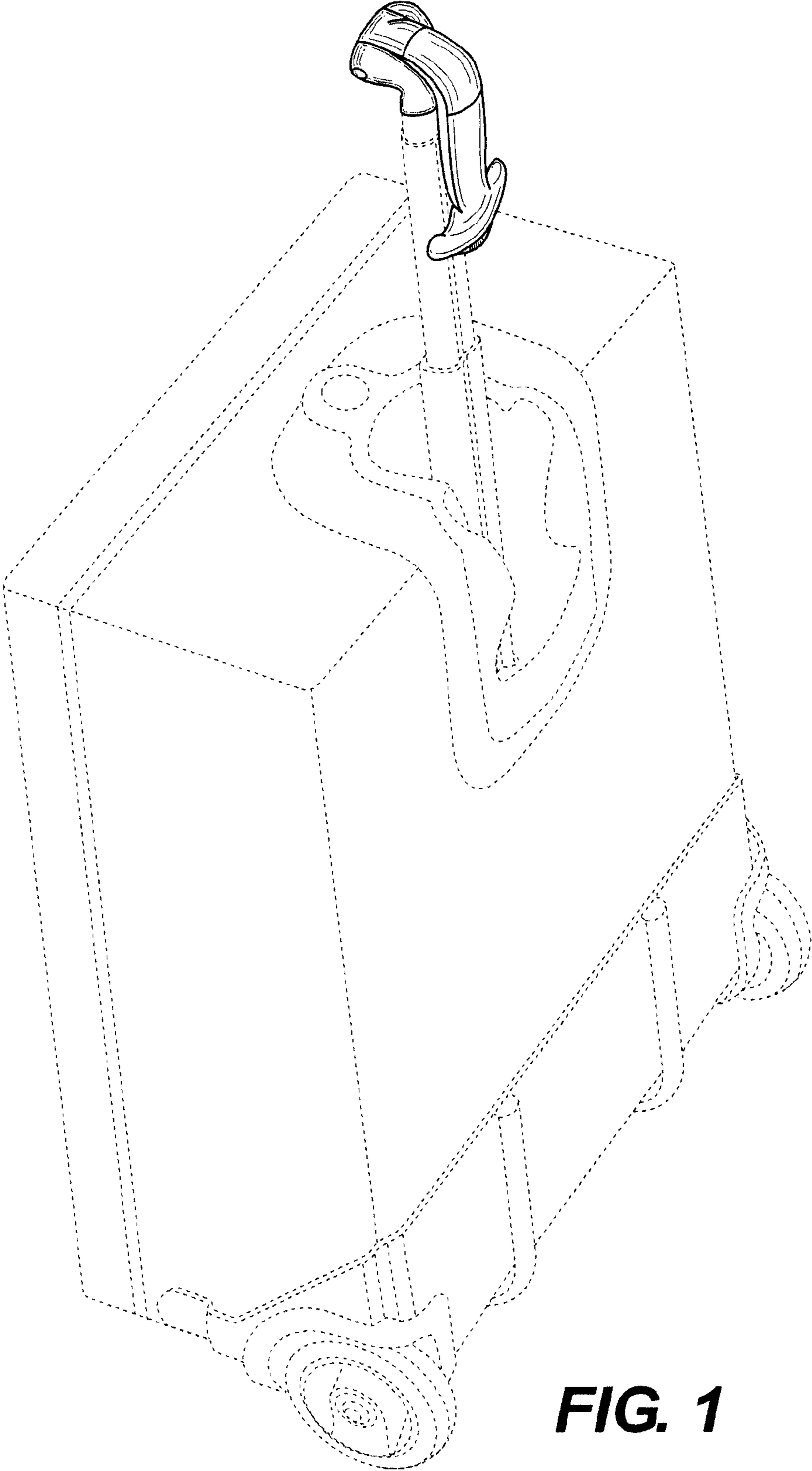

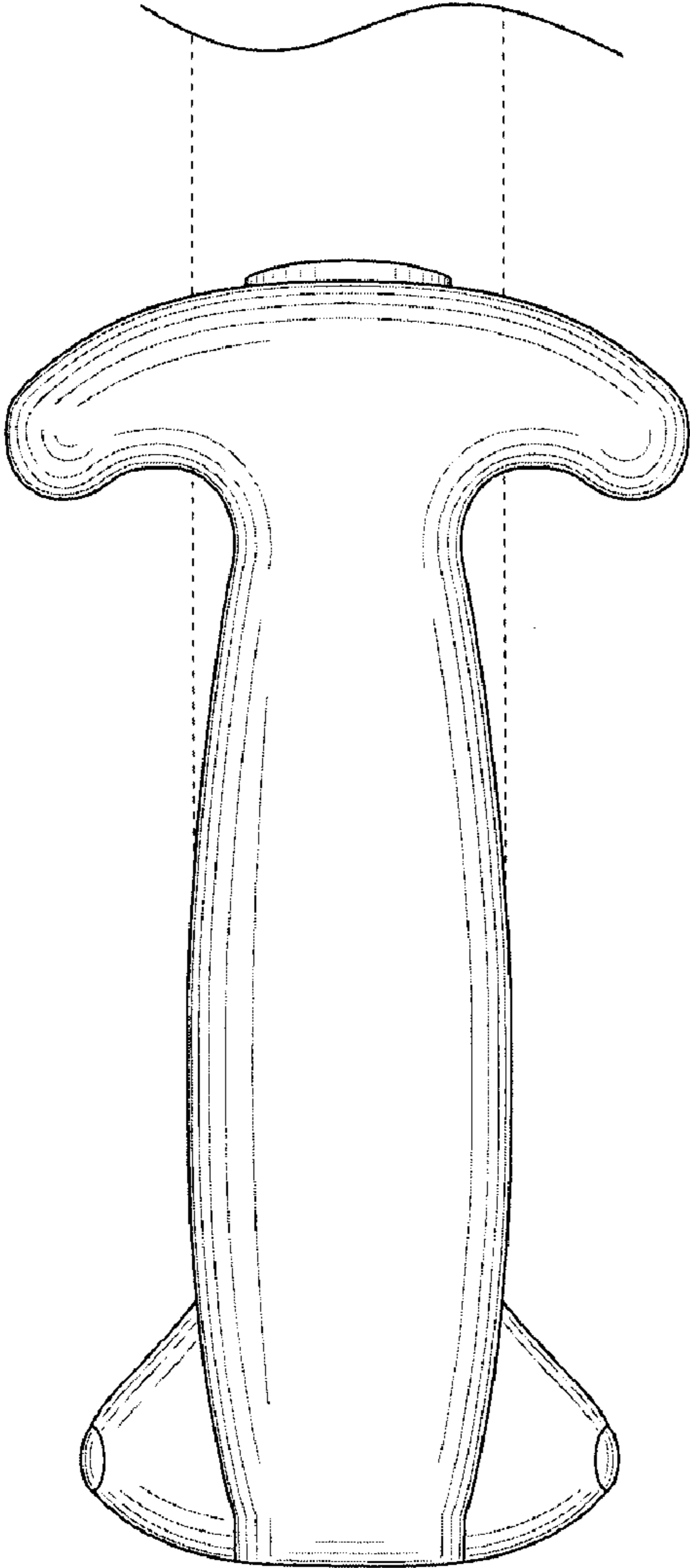

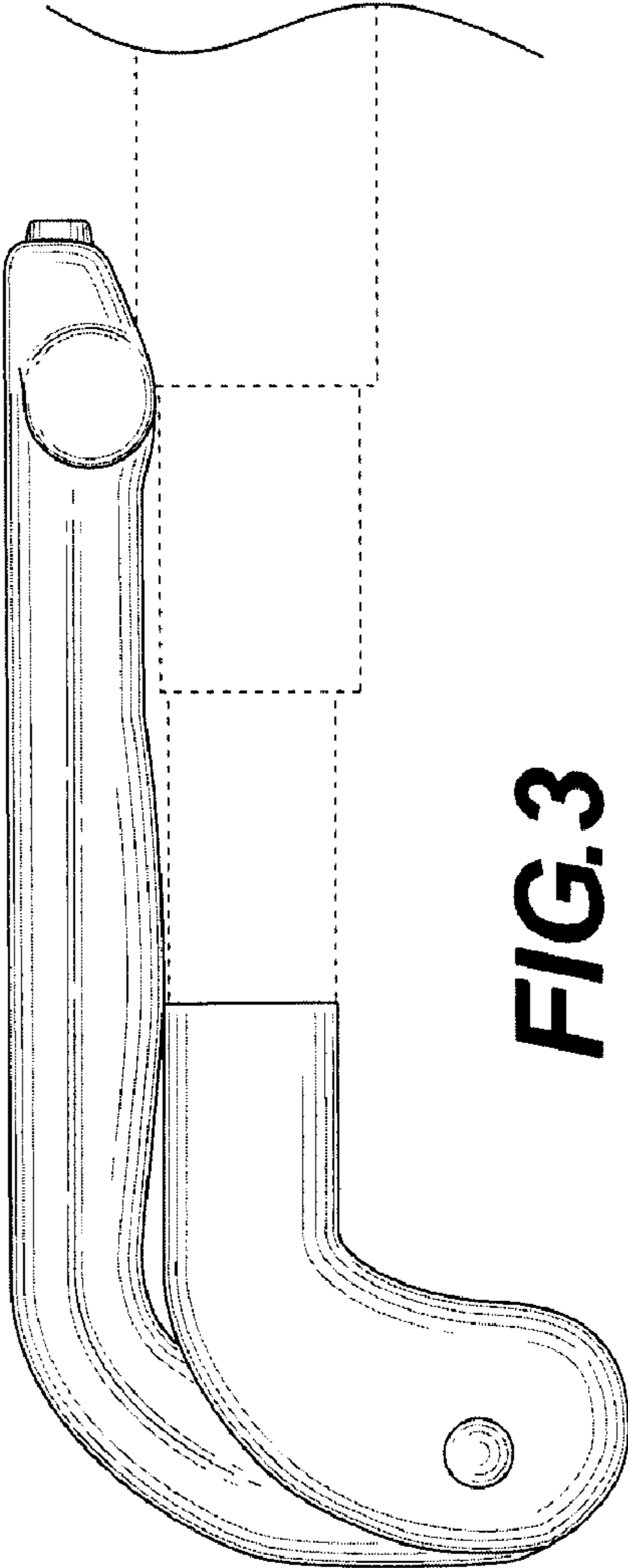

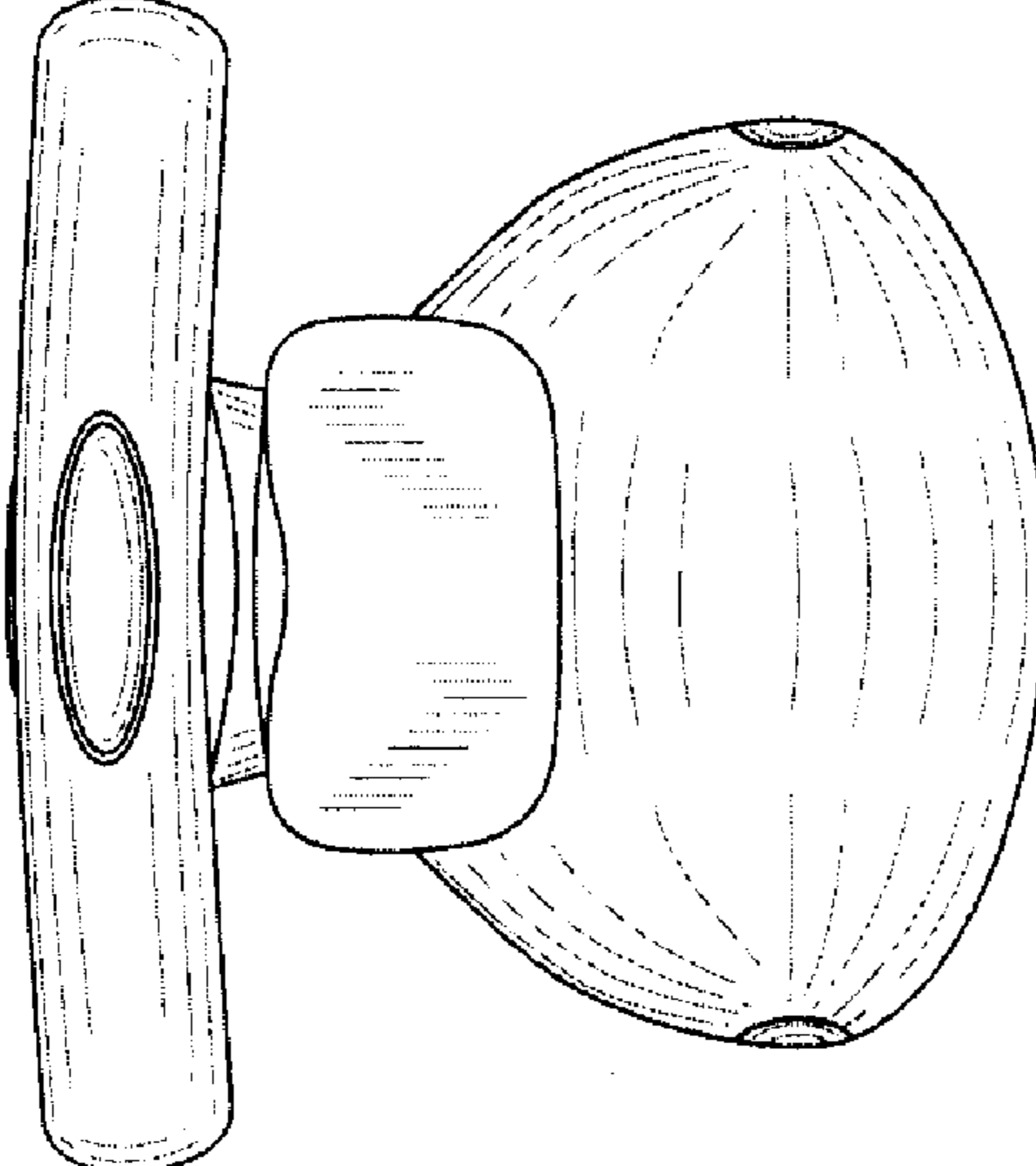

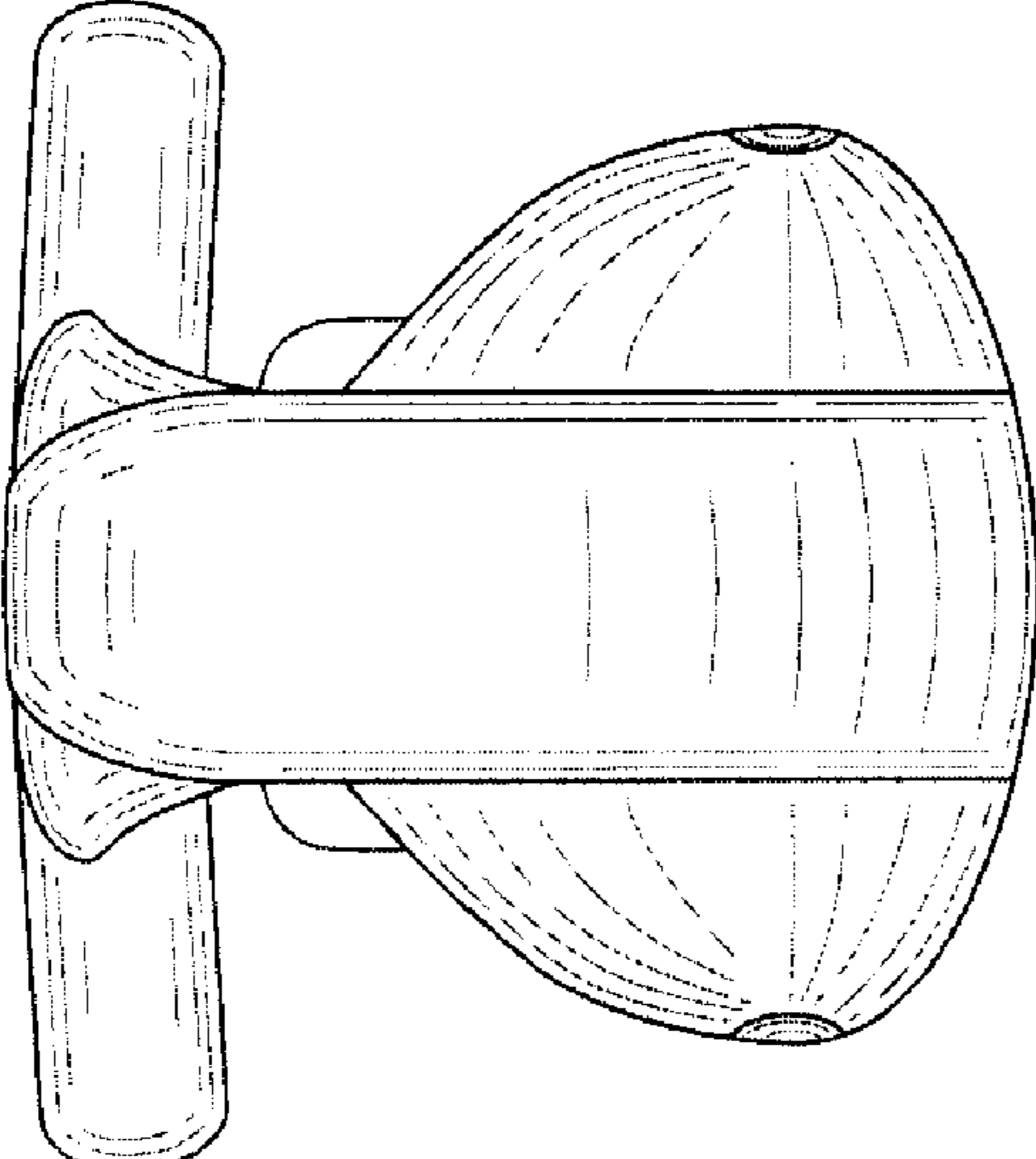

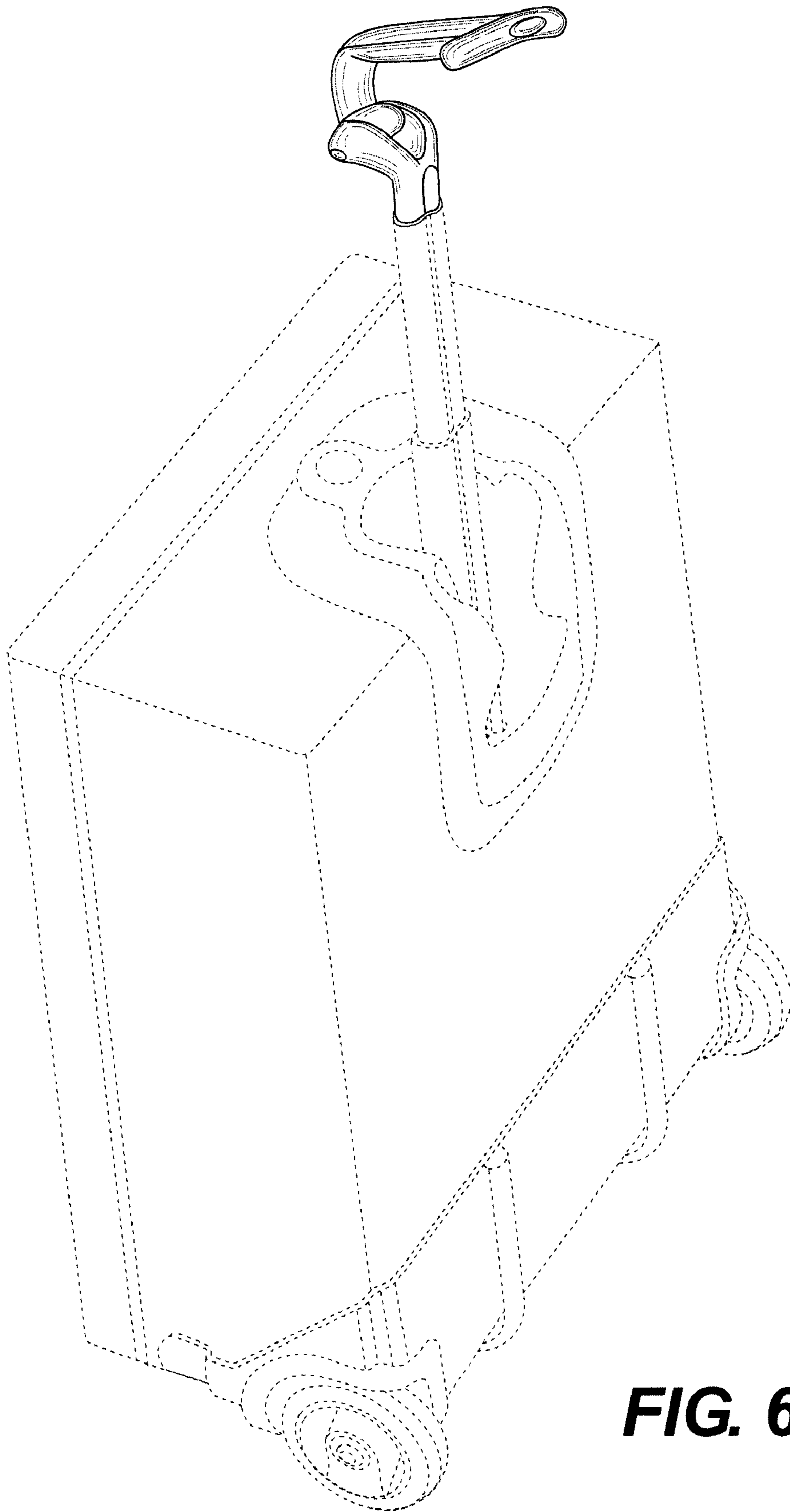

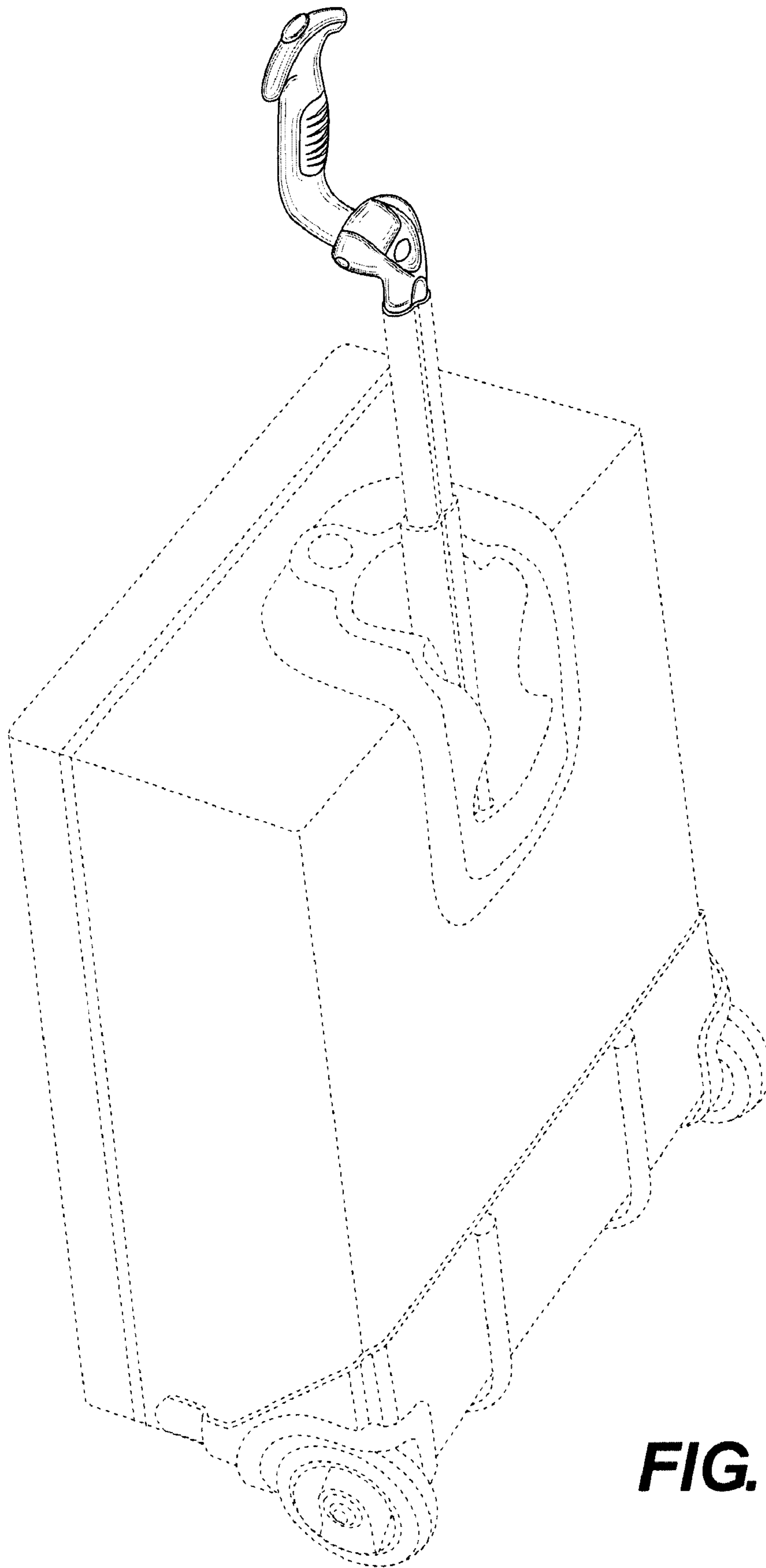

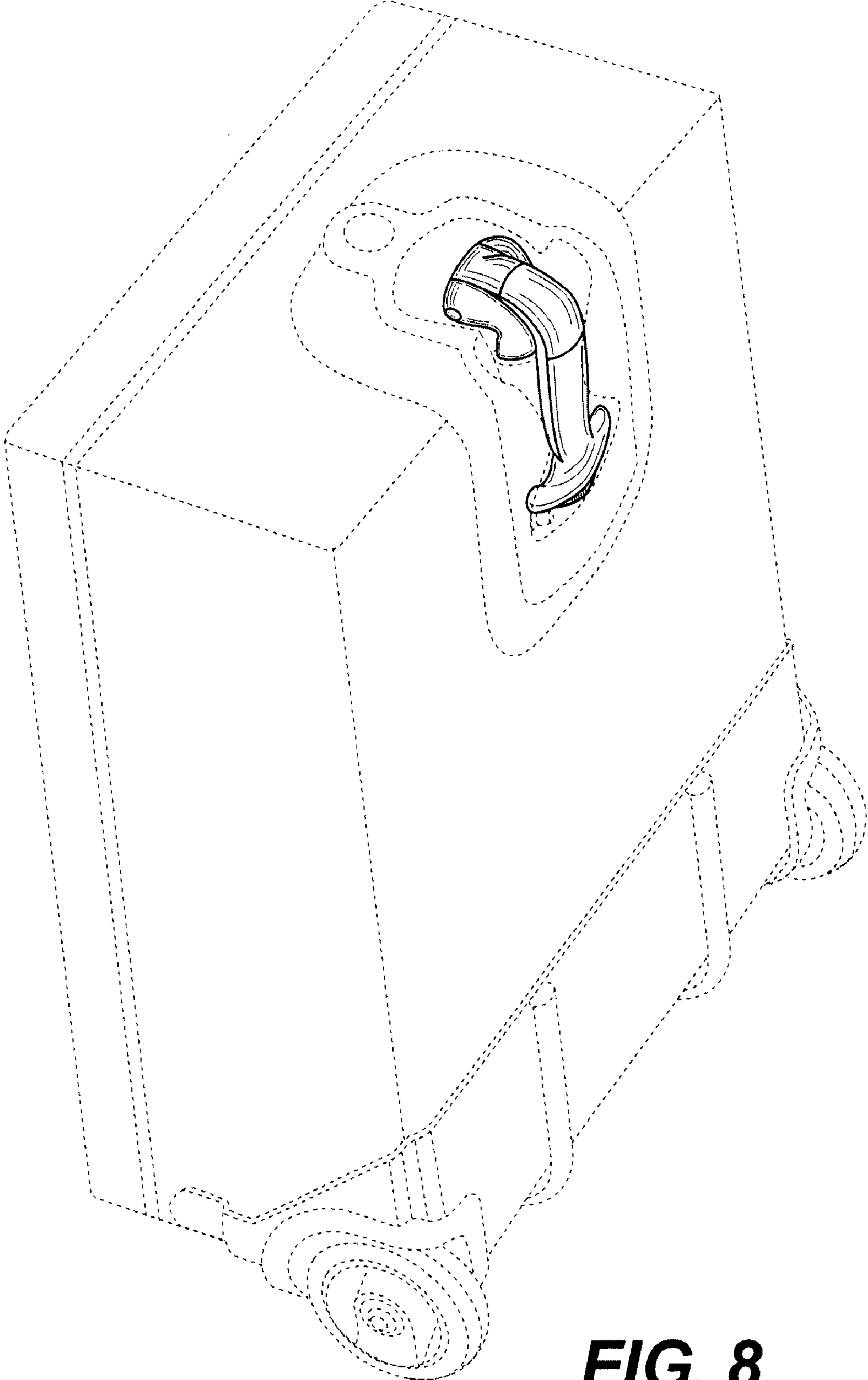
