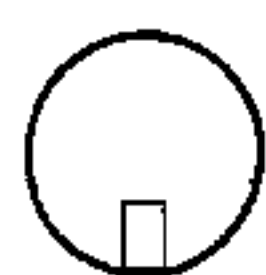
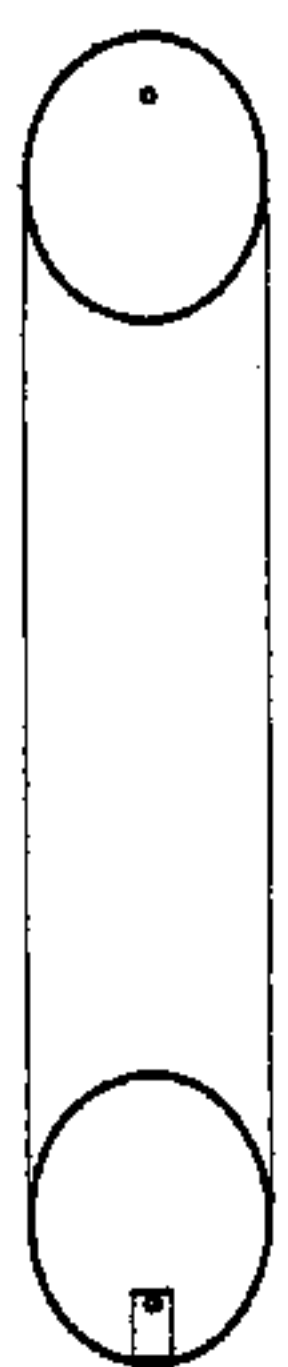
(57) **CLAIM**

The ornamental design for a toilet tissue holder and dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the toilet tissue holder and dispenser embodying my new design showing a tube for disposing toilet paper rolls therein, a bracket at the bottom of the tube, and mounting holes at the top and bottom of the tube; FIG. 2 is a rear view thereof; FIG. 3 is a side view thereof, the other side being a mirror image; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof.

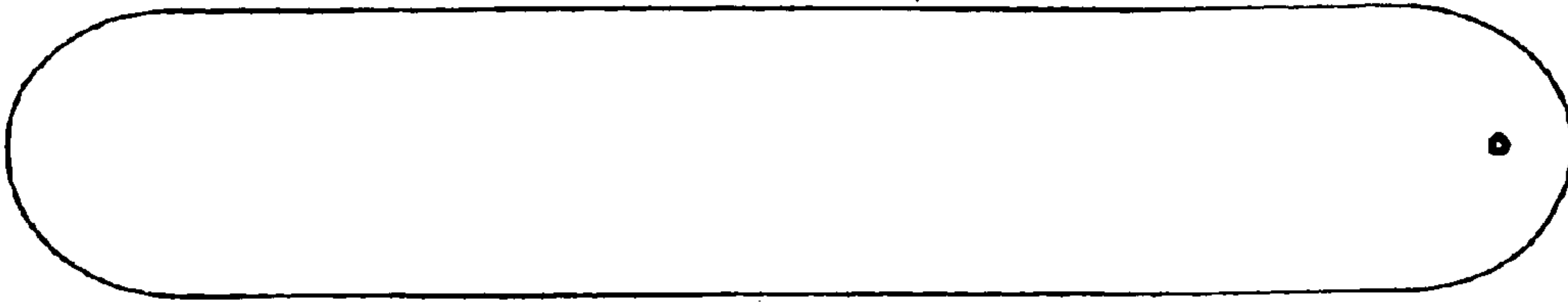

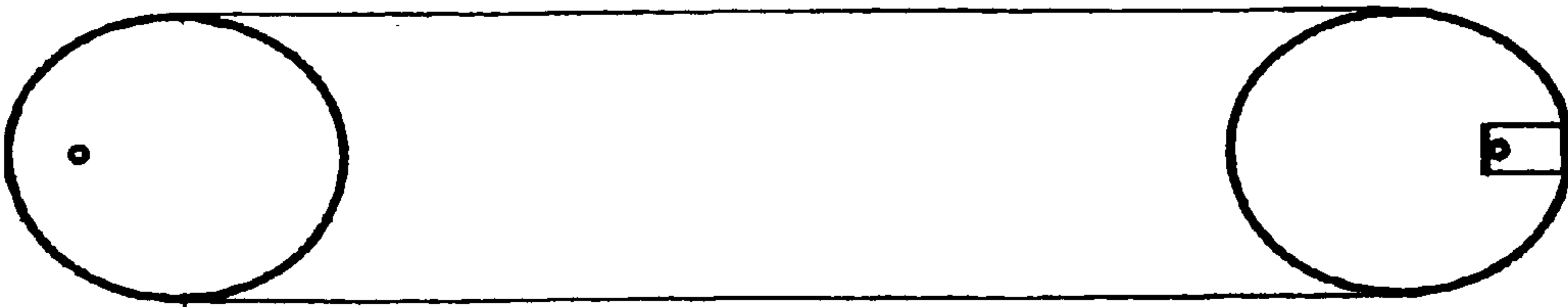

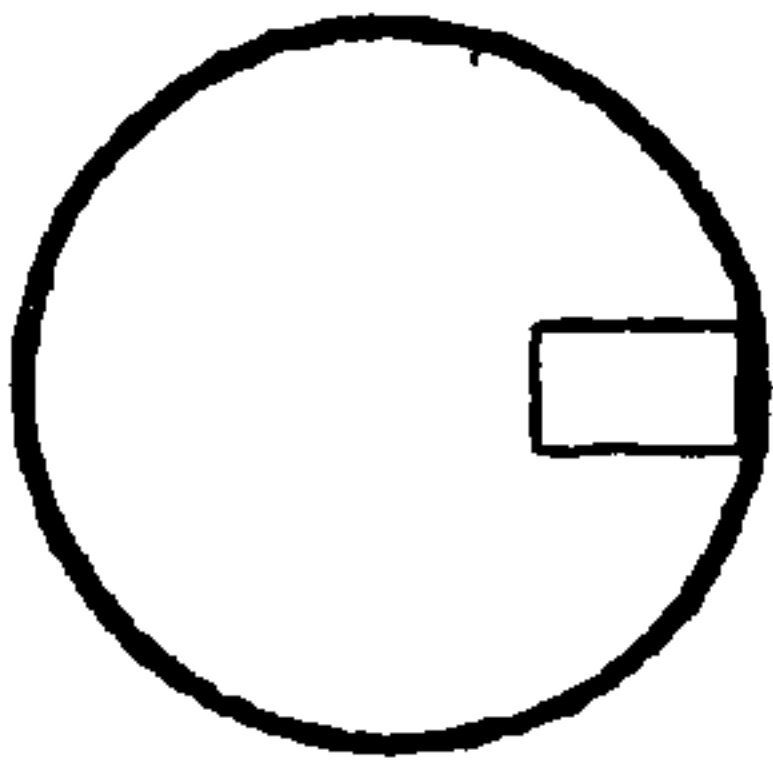

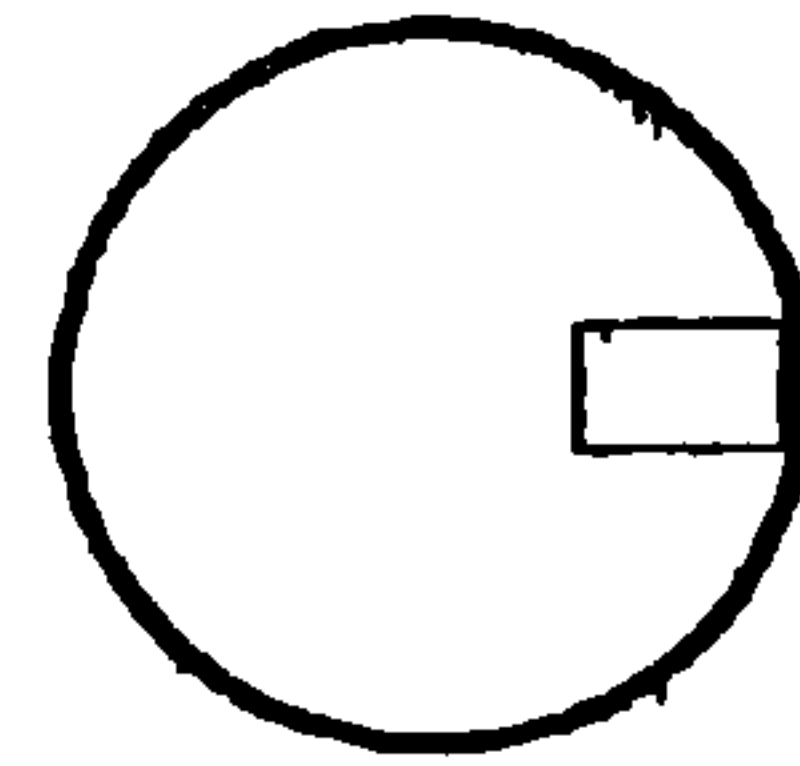

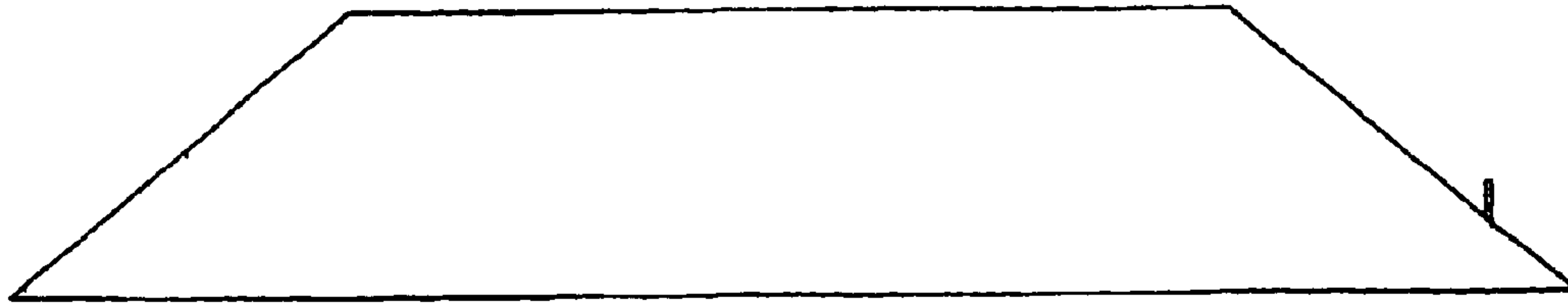
