(57) **CLAIM**

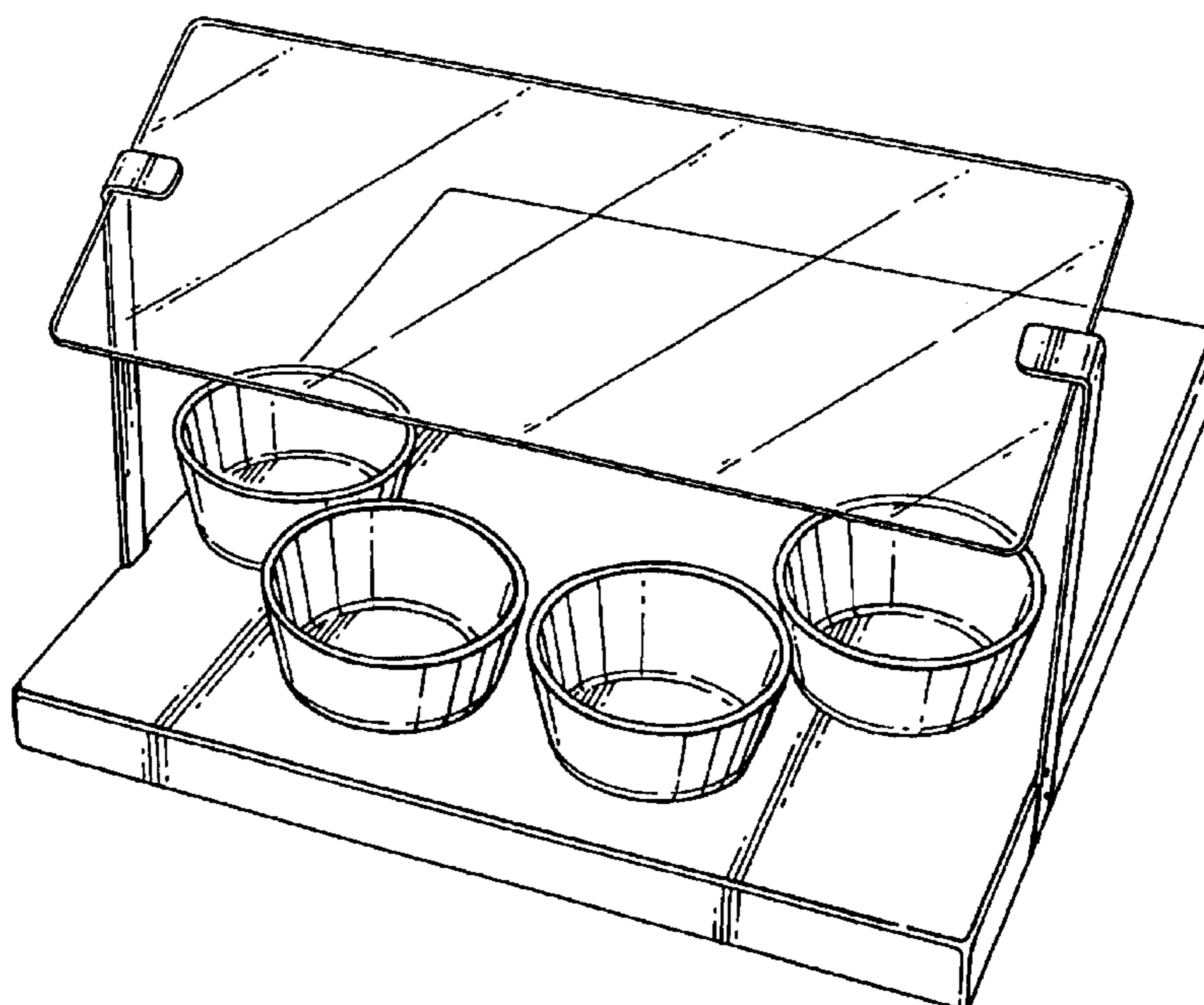
The ornamental design for a soup display assembly, substantially as shown and described.

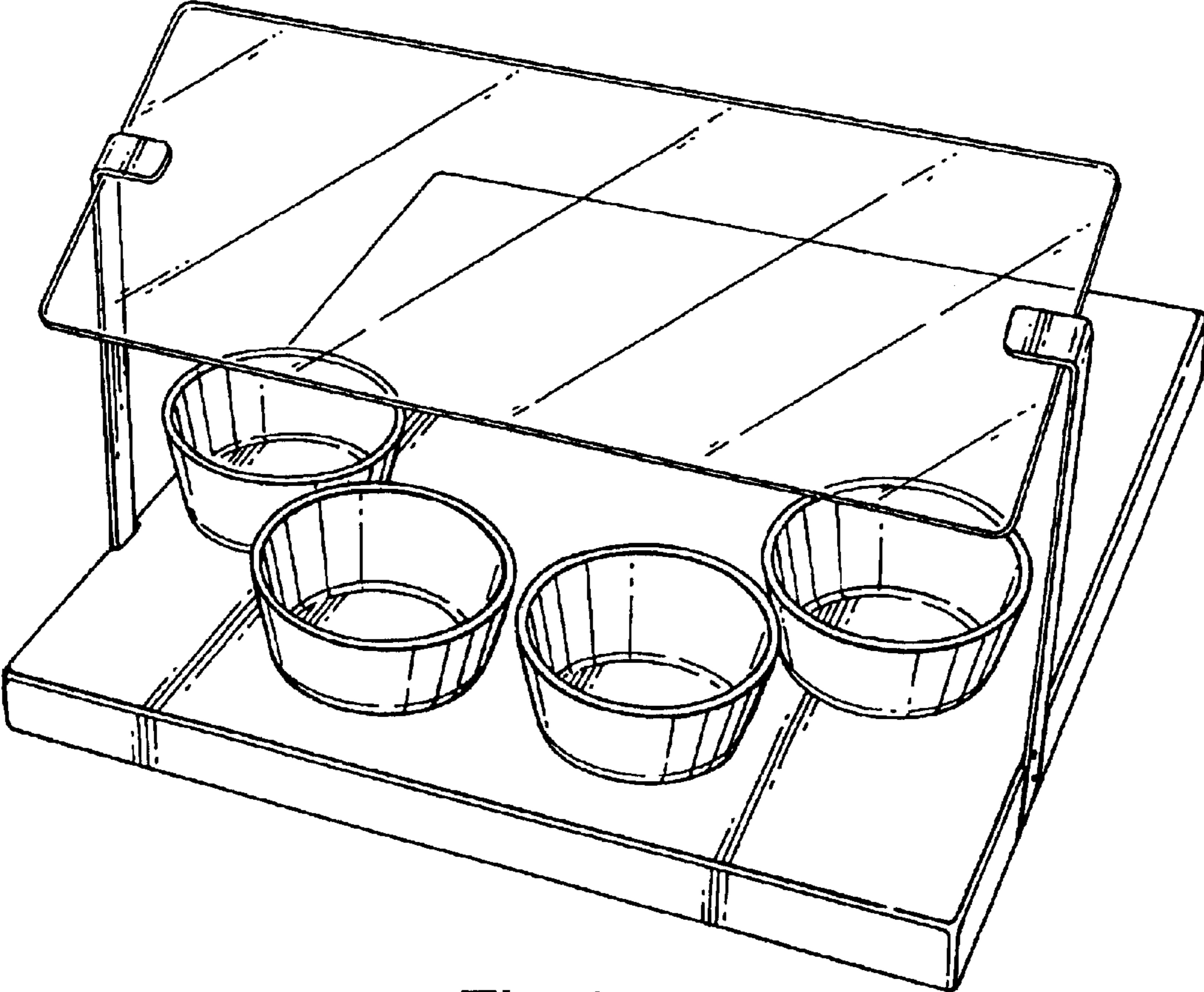

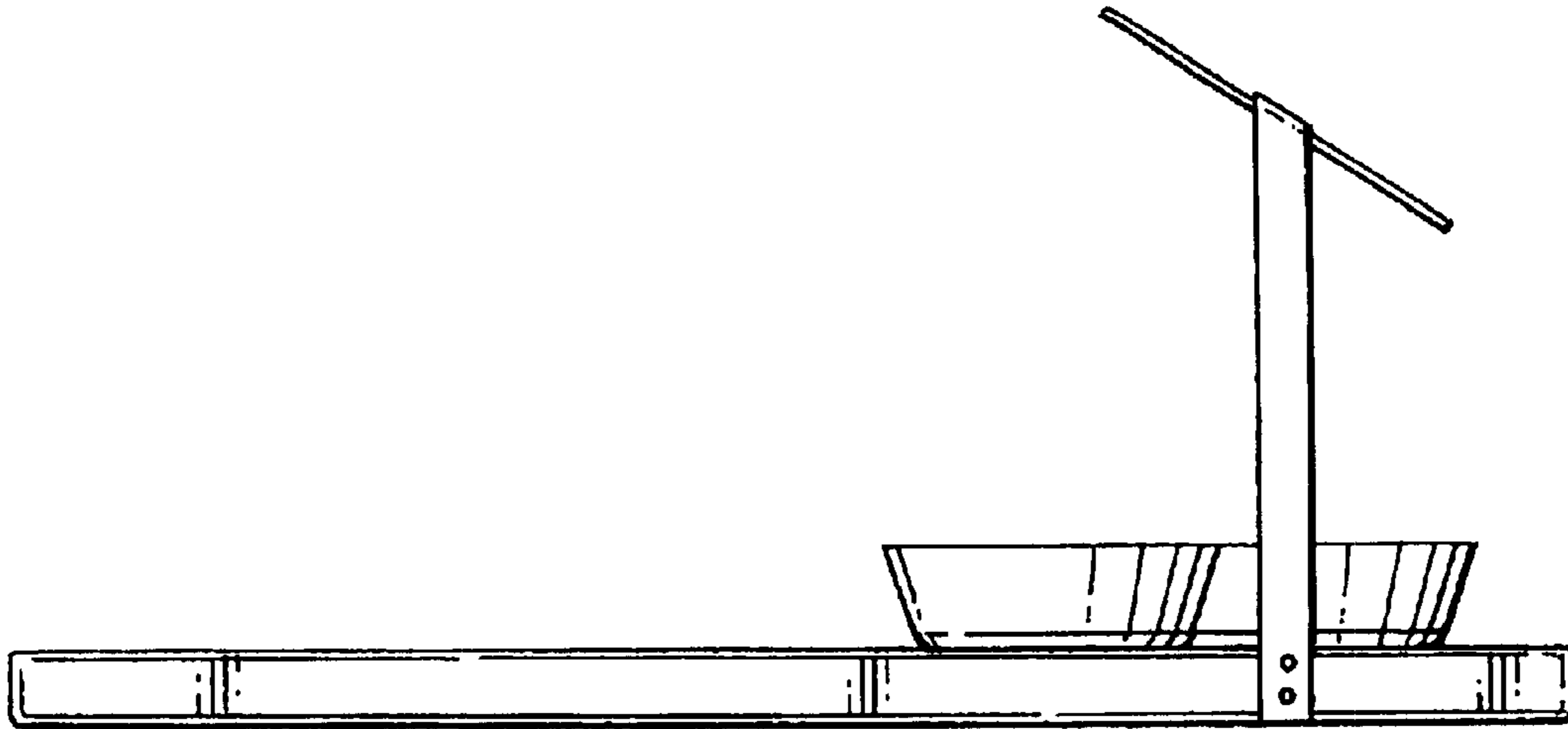

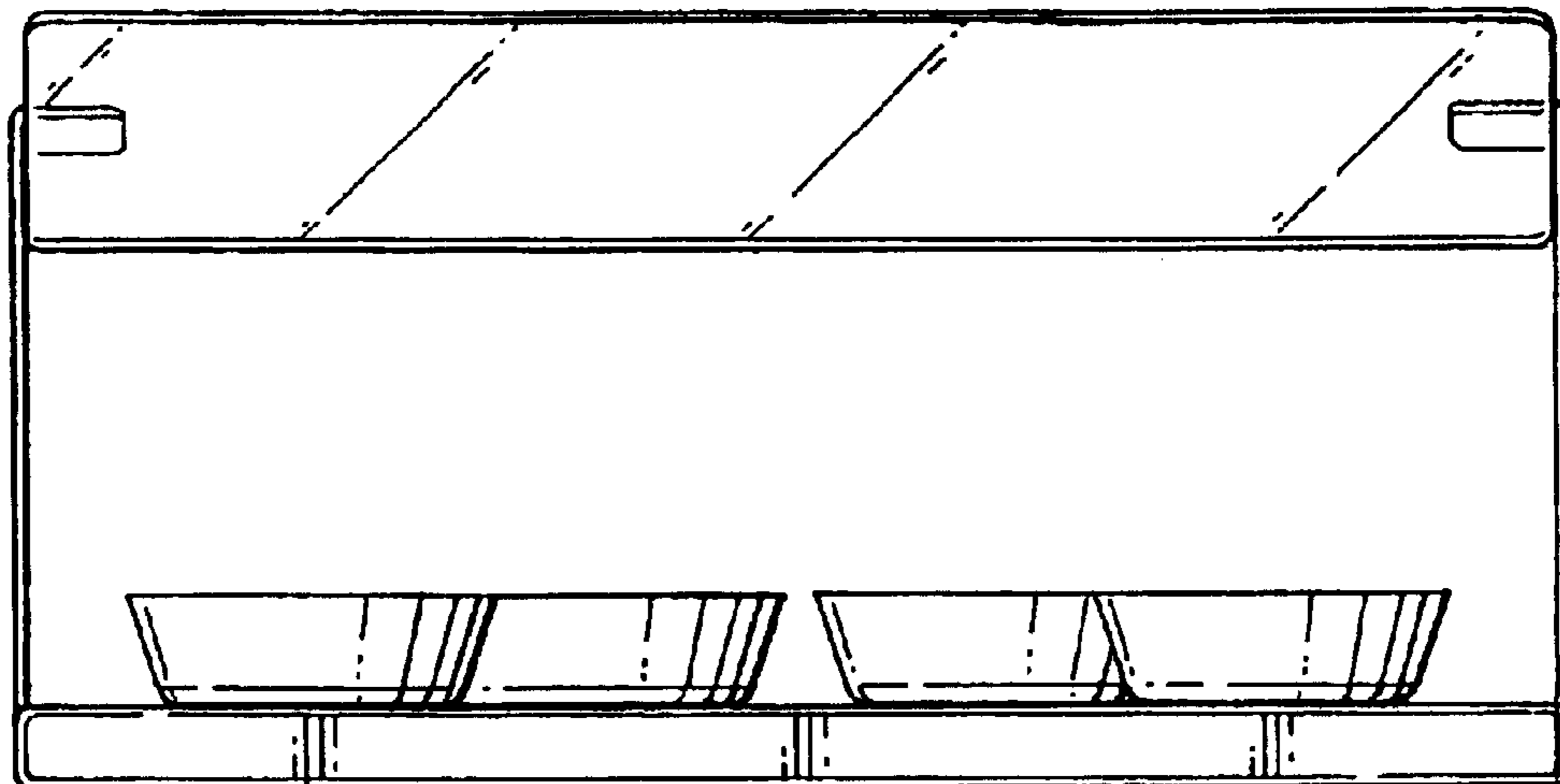

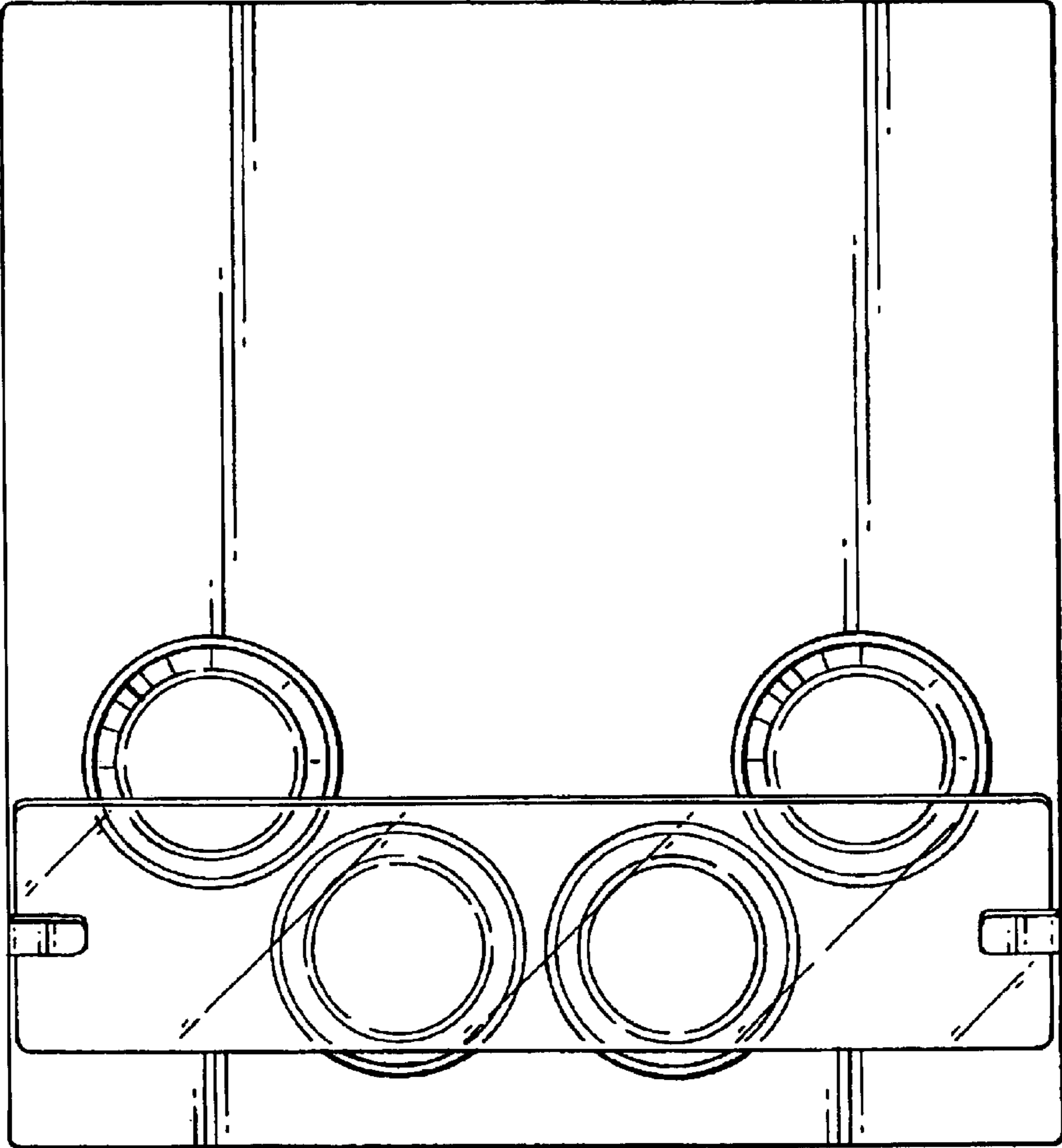
