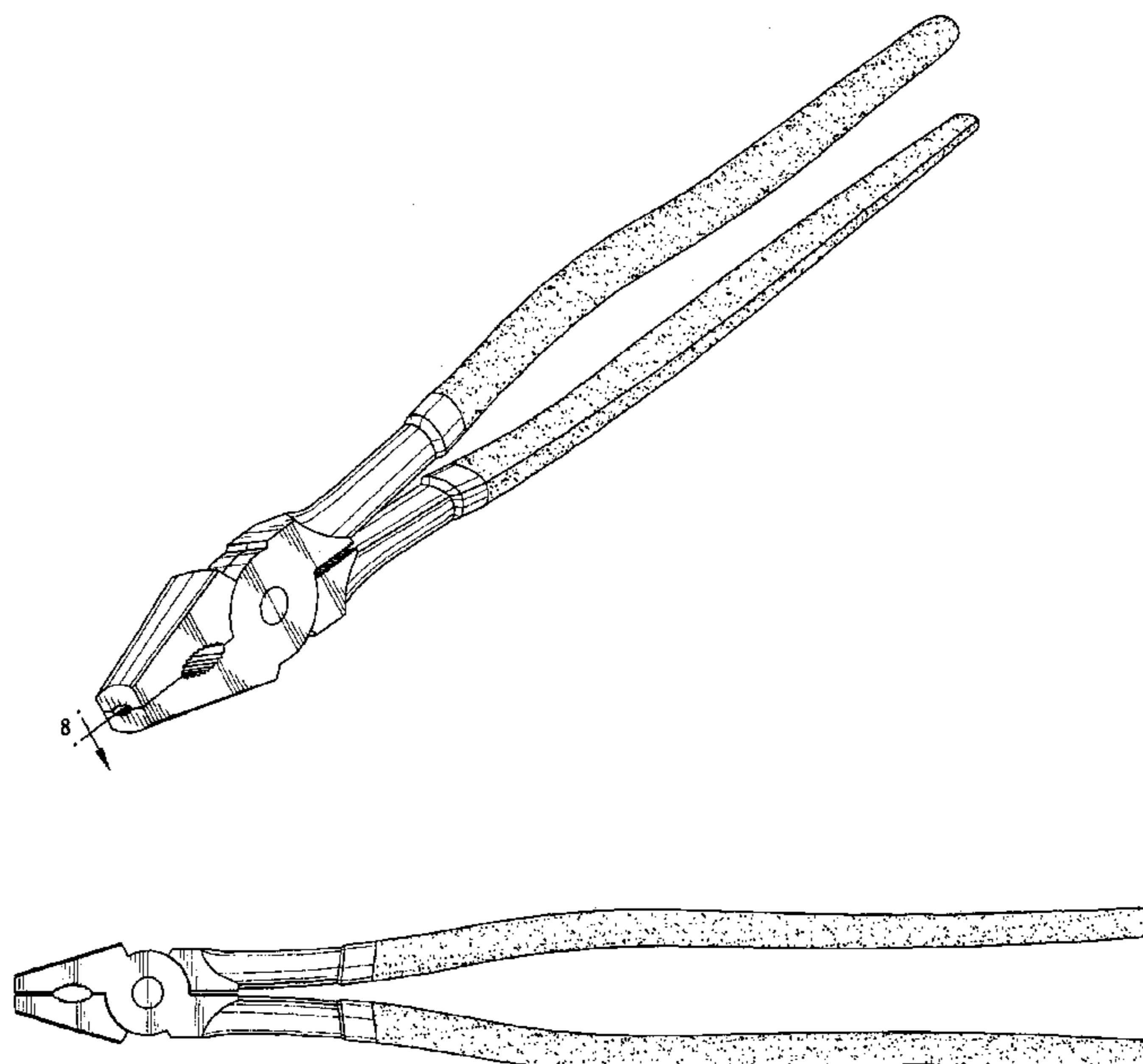
(57) **CLAIM**

The ornamental design for pliers for removing studs from automobile engine blocks and the like, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing my new pliers for removing studs from automobile engine blocks and the like; FIG. 2 is a left side view thereof; FIG. 3 is a top view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a front view thereof; FIG. 7 is a back view thereof; and, FIG. 8 is a cut-away view (as indicated in FIG. 1), showing detail of the grooves of a jaw member of the pliers.

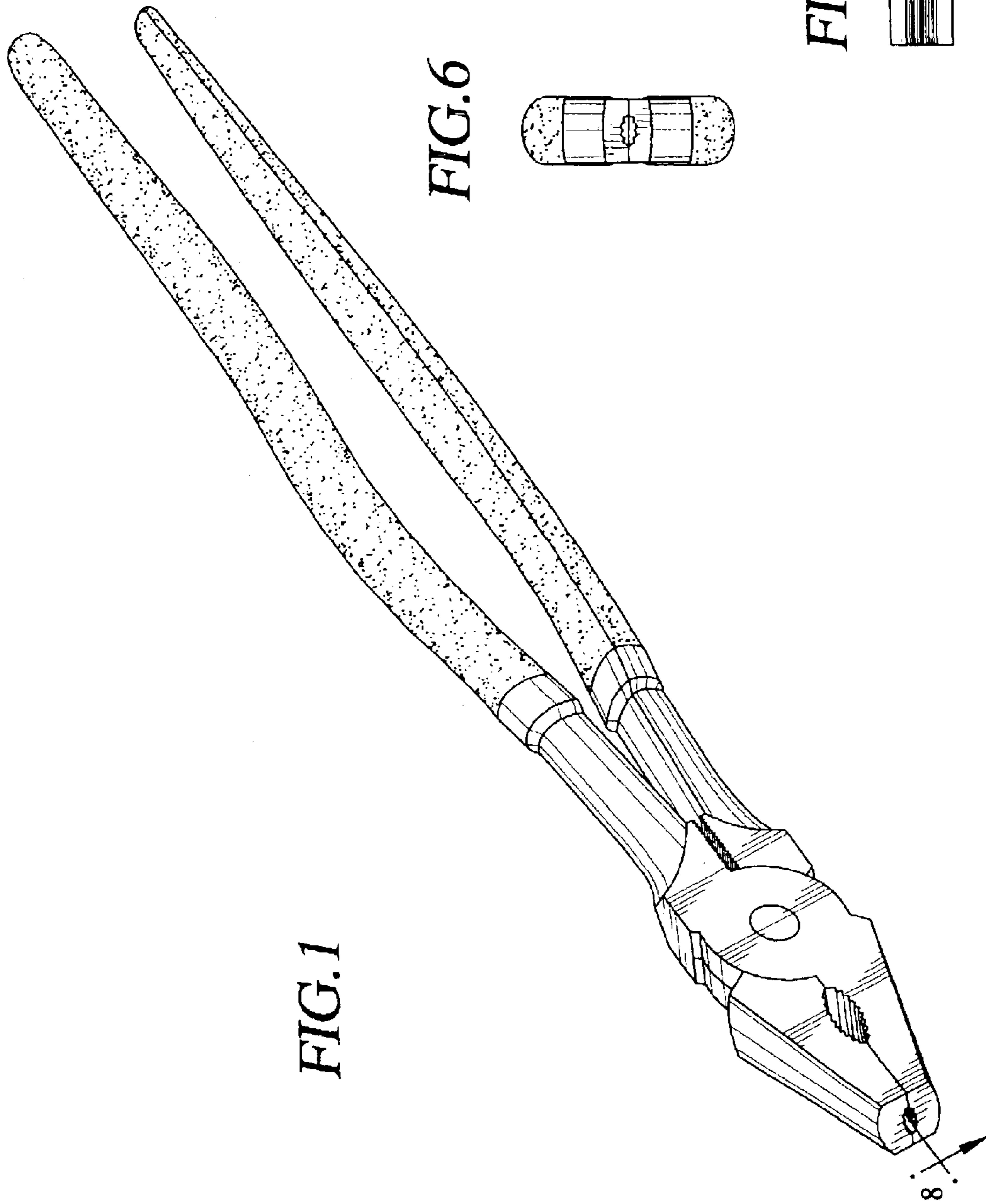

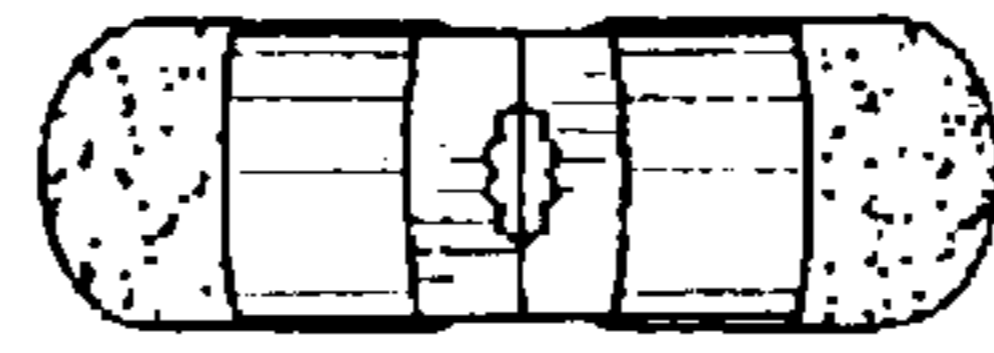
