The ornamental design for a vehicle interior door handle, as shown and described.

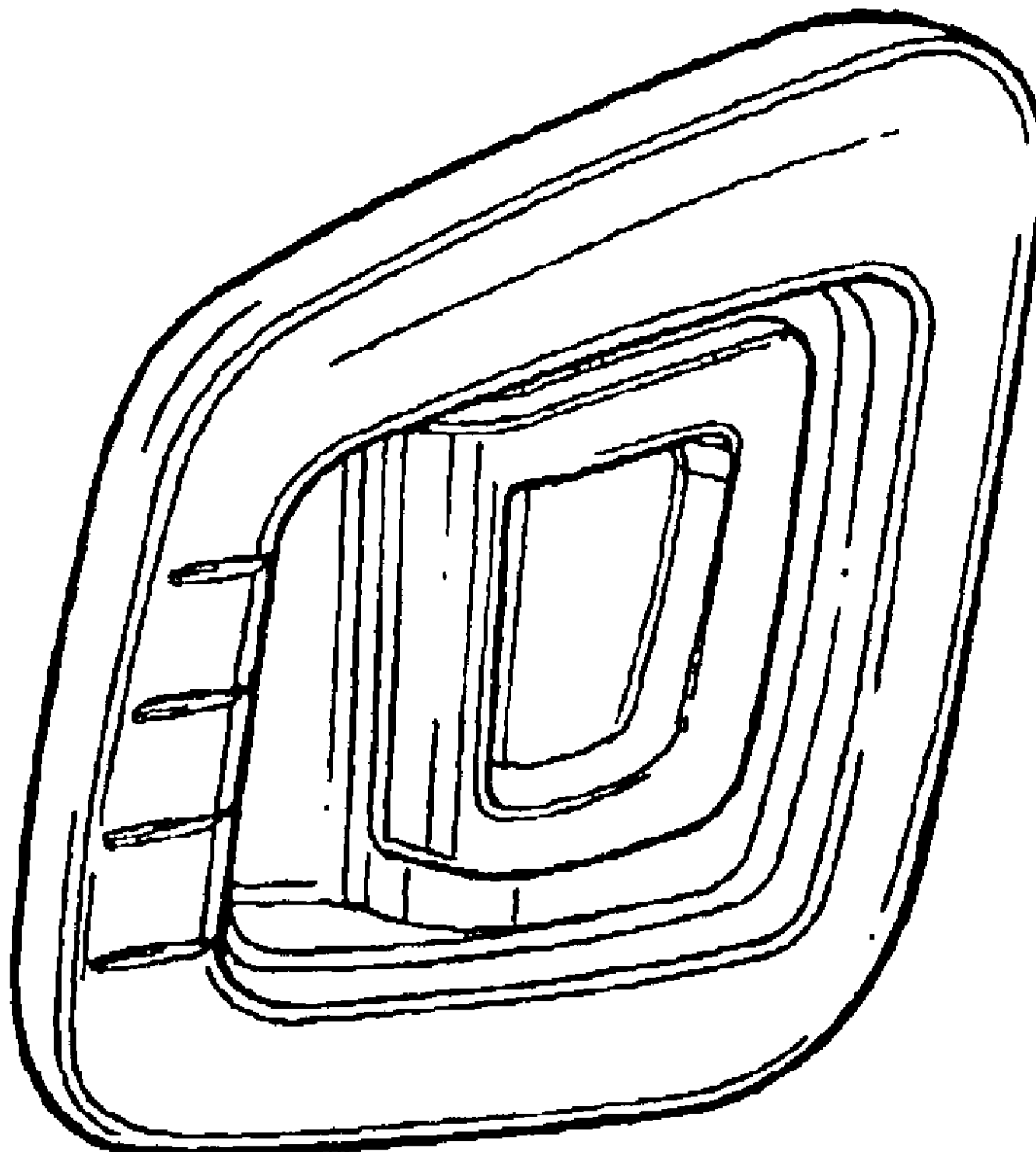
DESCRIPTION

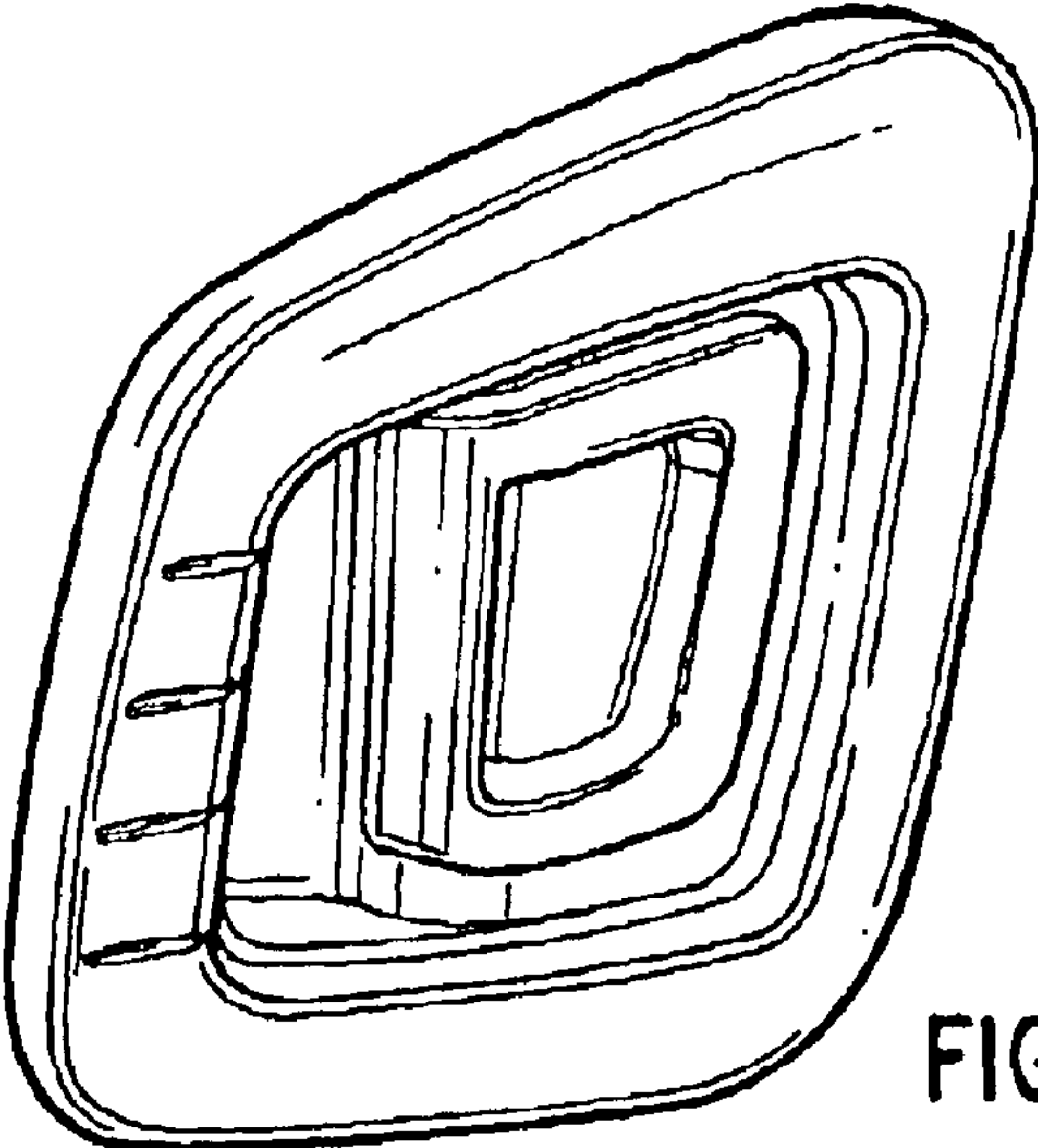

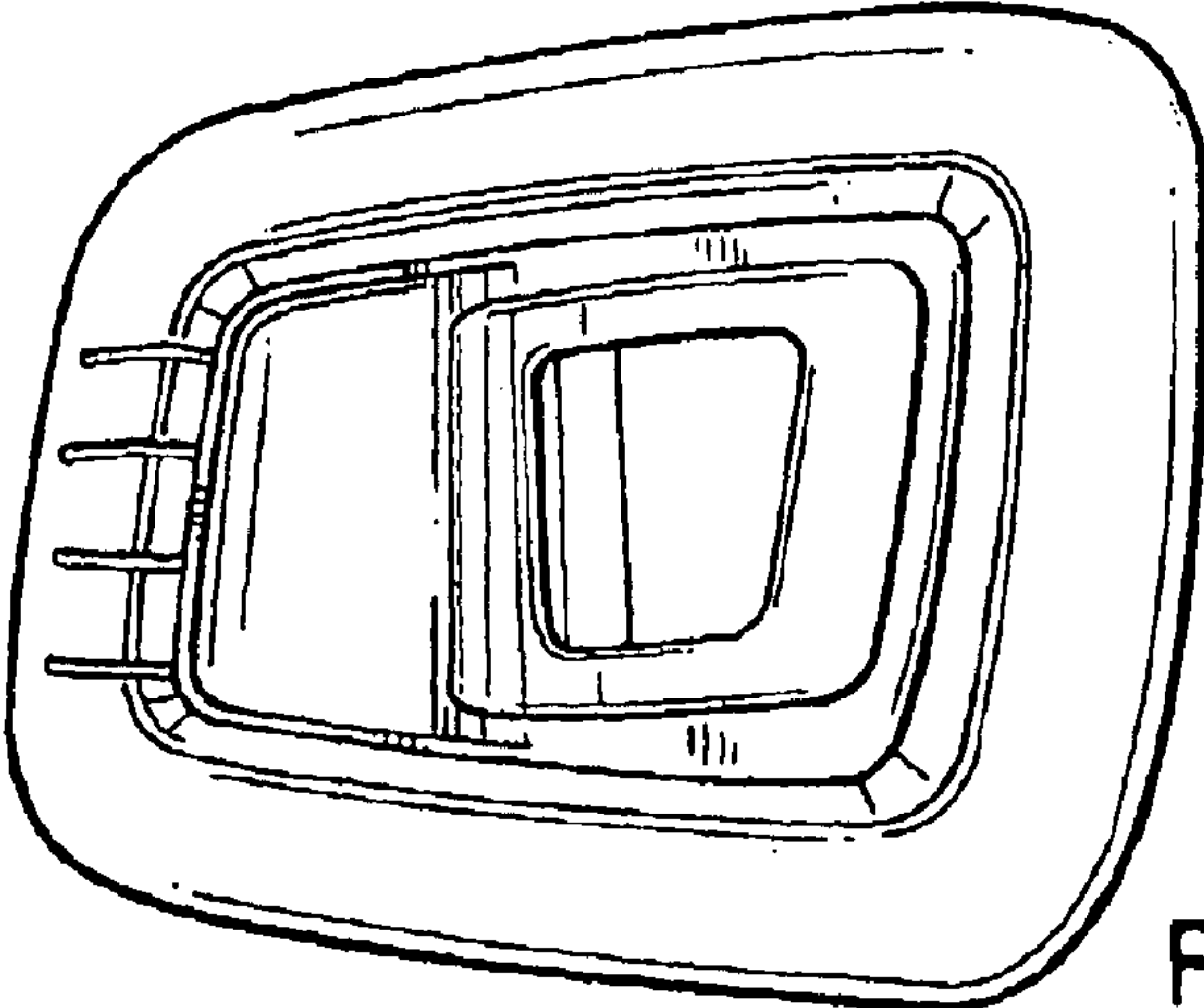

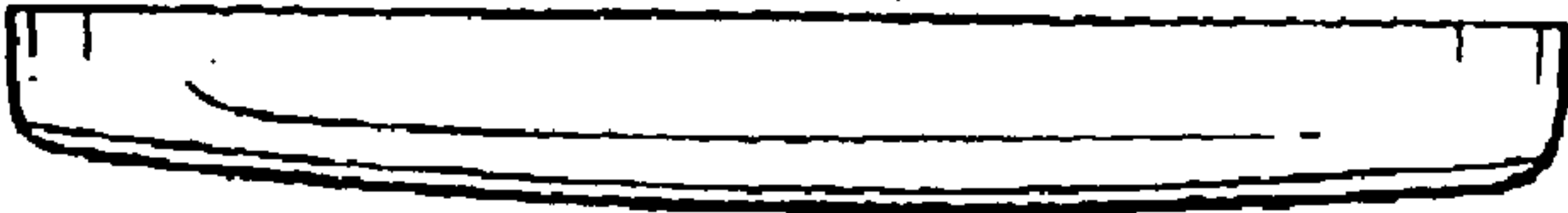
