The ornamental design for a lock, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the design of the present invention;

FIG. 2 is a top view of the lock shown in FIG. 1;

FIG. 3 is a bottom view of the lock shown in FIG. 1;

FIG. 4 is a left side view of the lock shown in FIG. 1;

FIG. 5 is a front view of the lock shown in FIG. 1;

FIG. 6 is a right view of the lock shown in FIG. 1; and,

FIG. 7 is a back view of the lock shown in FIG. 1.

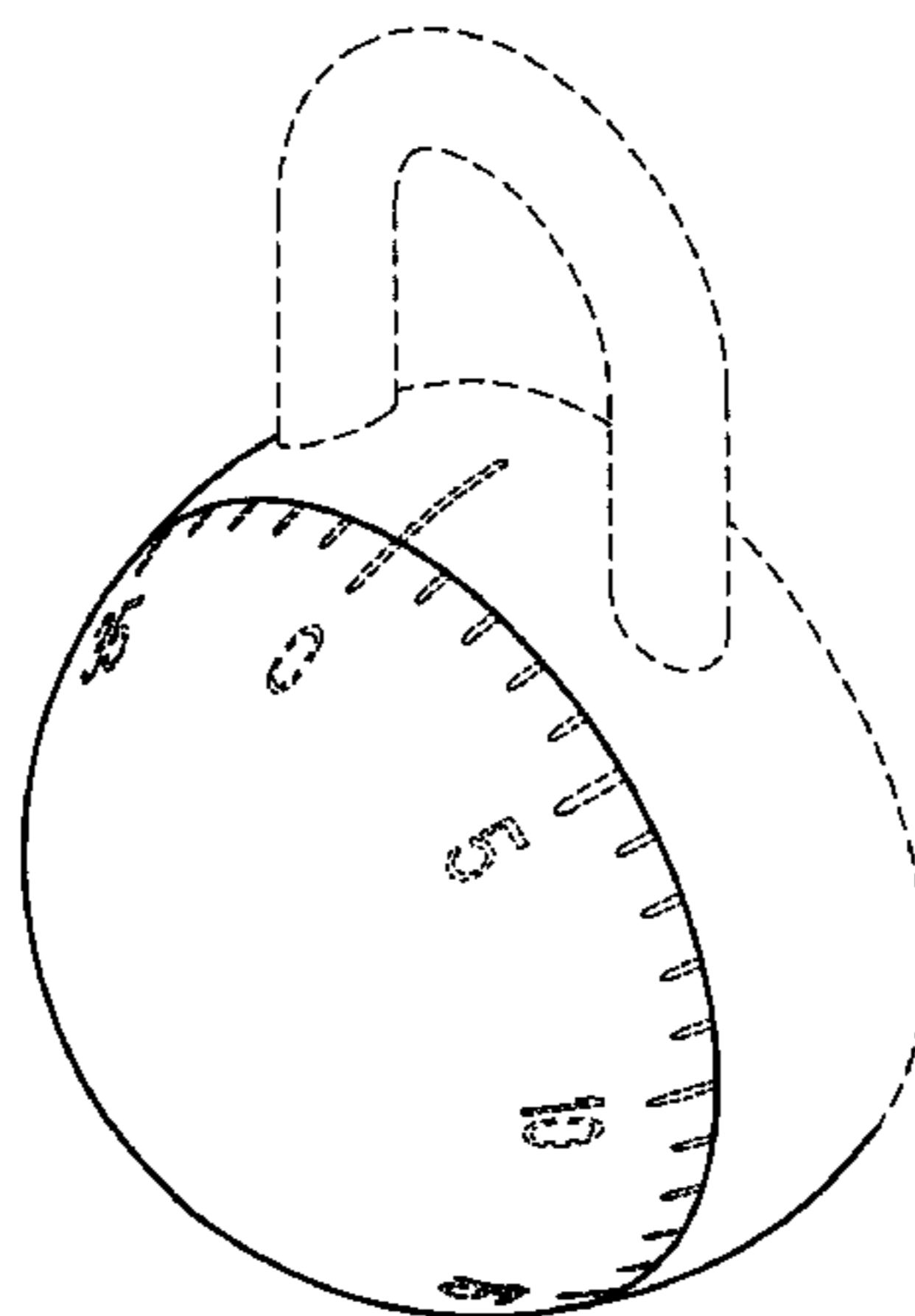

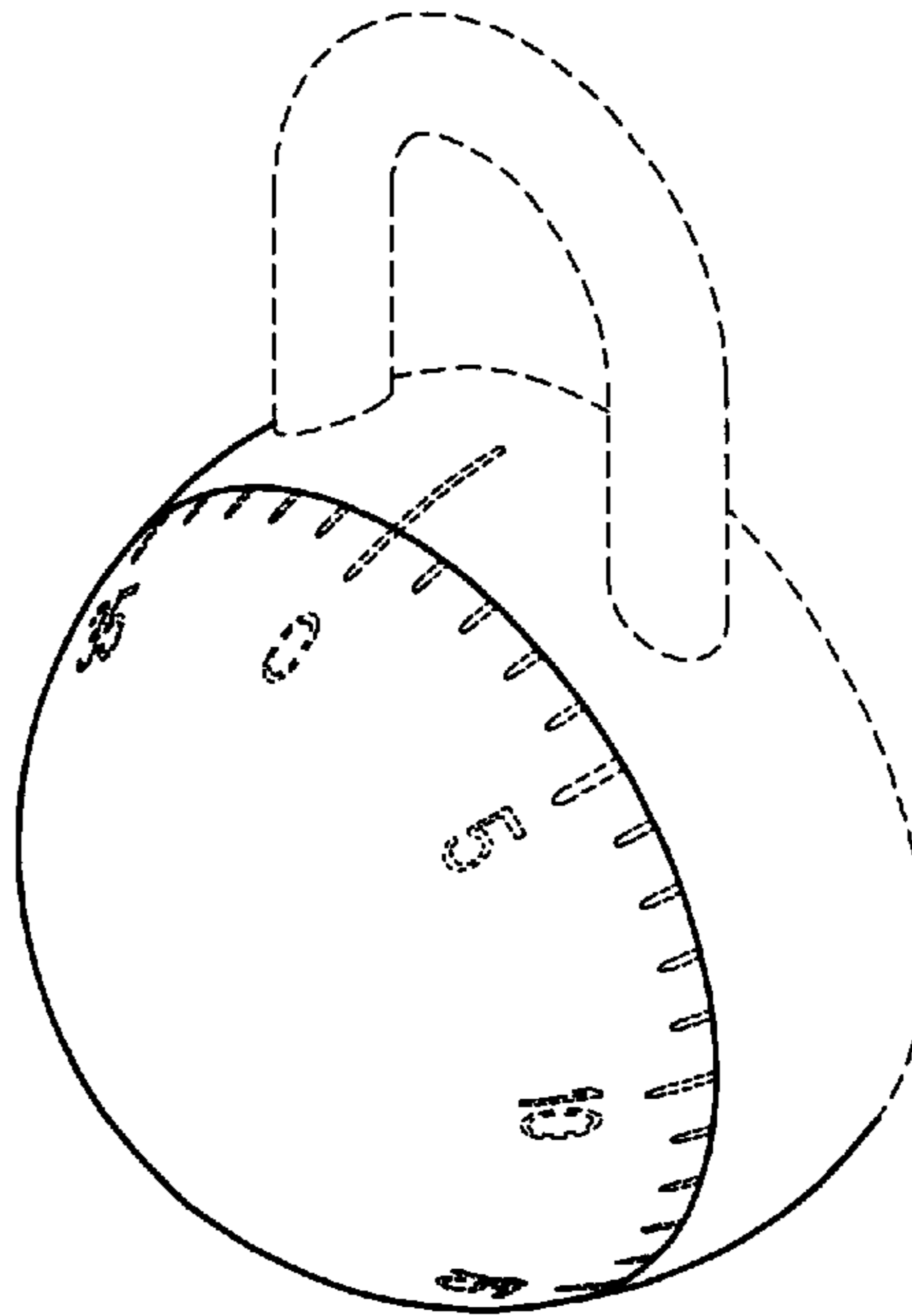

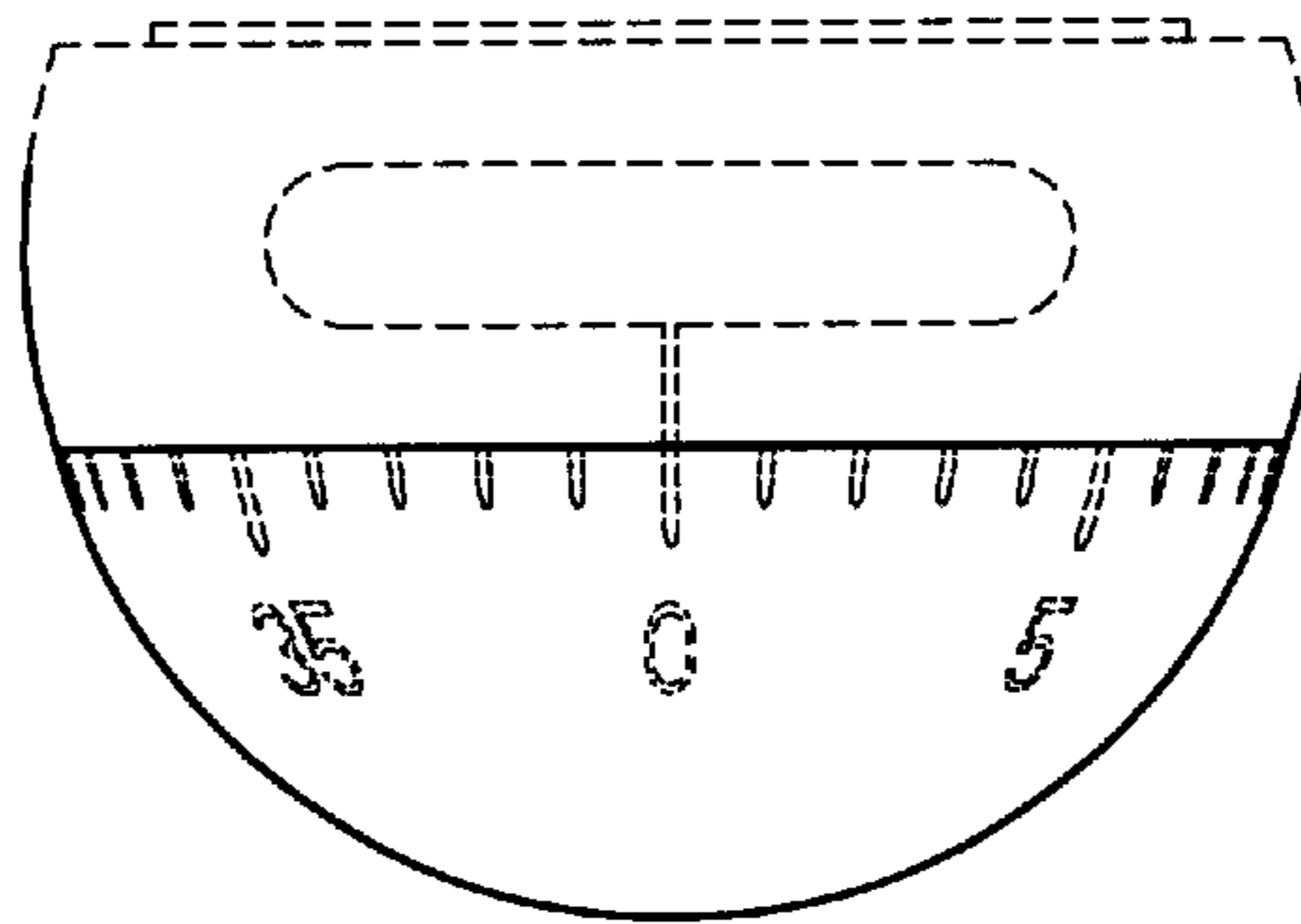
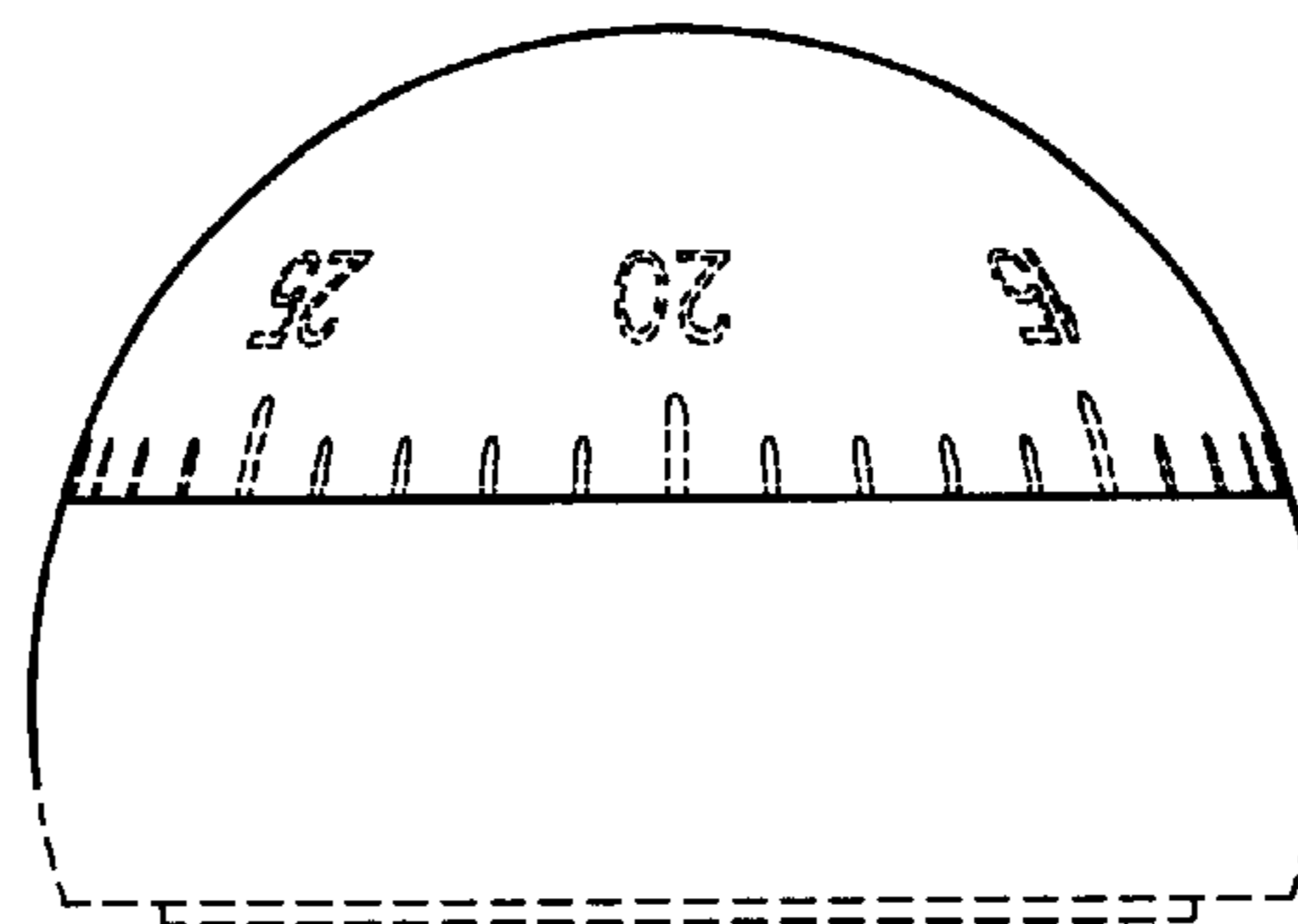

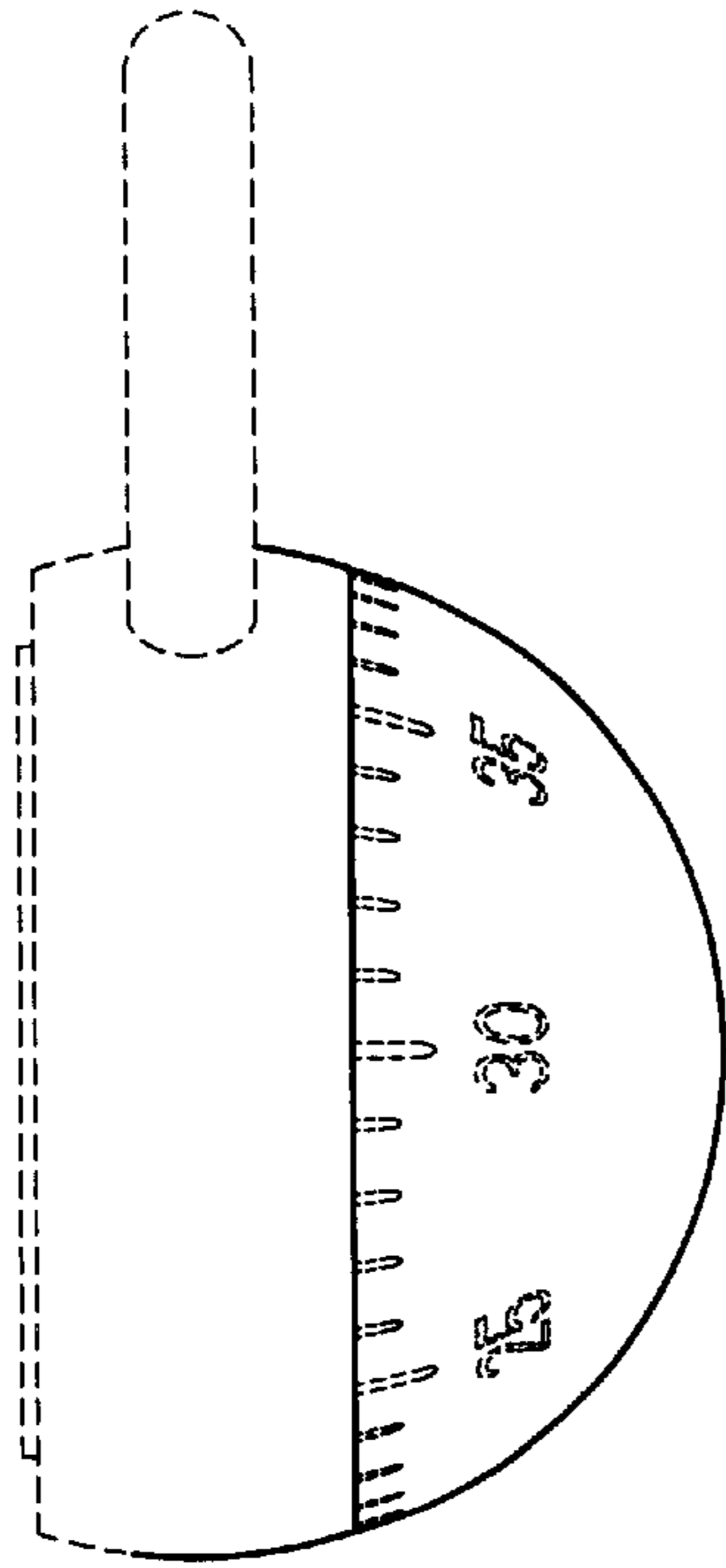

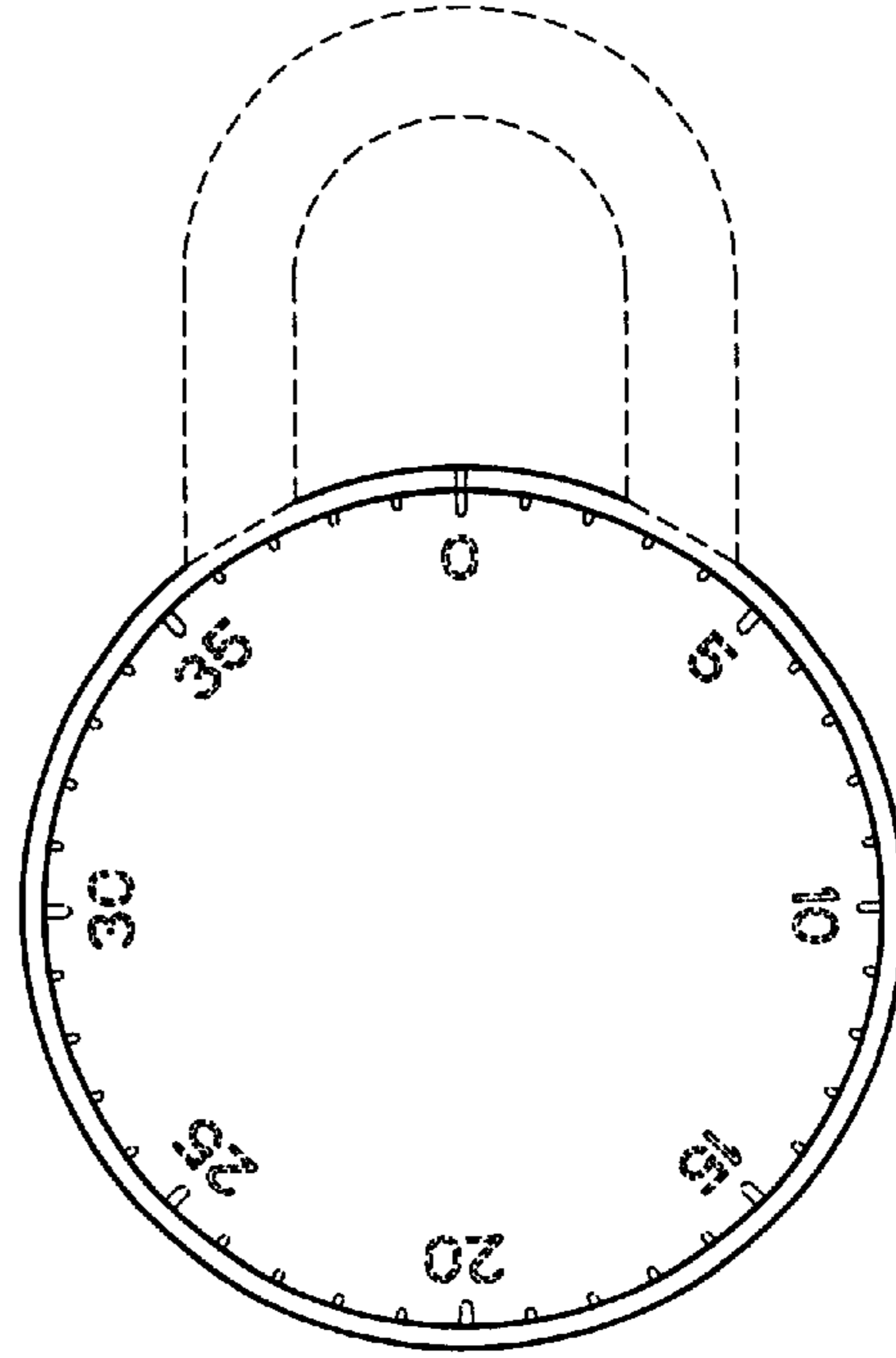

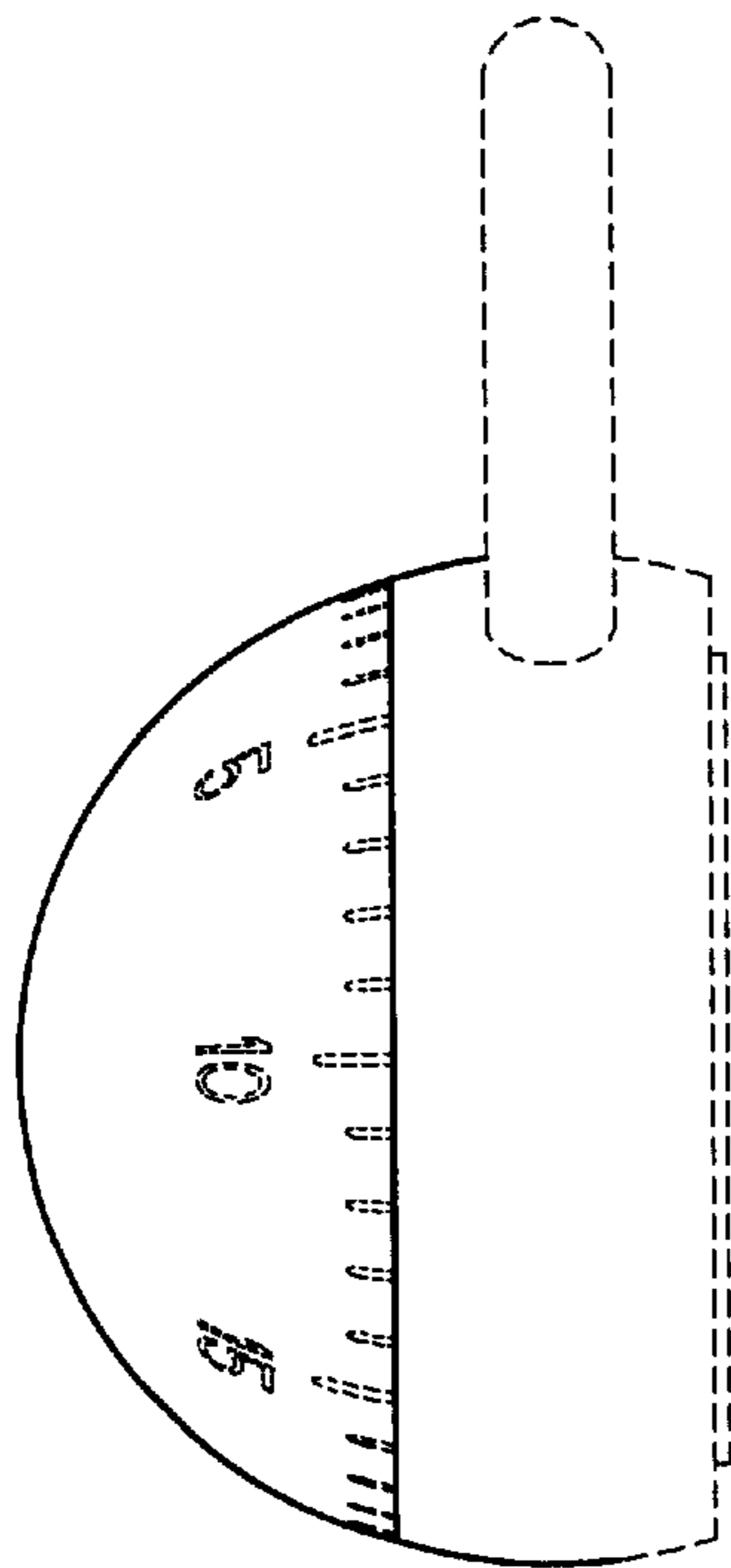

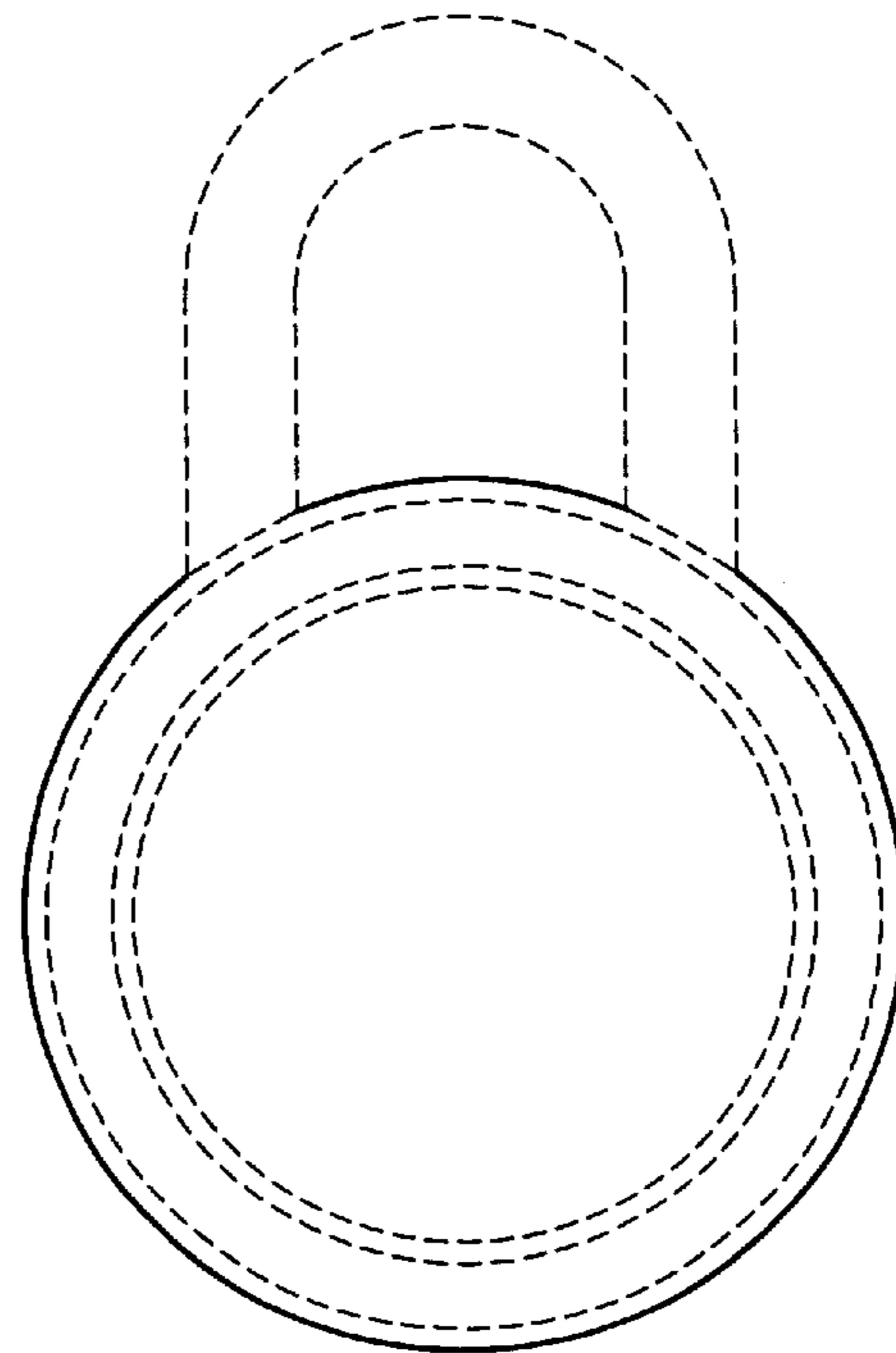
