FIG. 4 is a top plan view thereof;

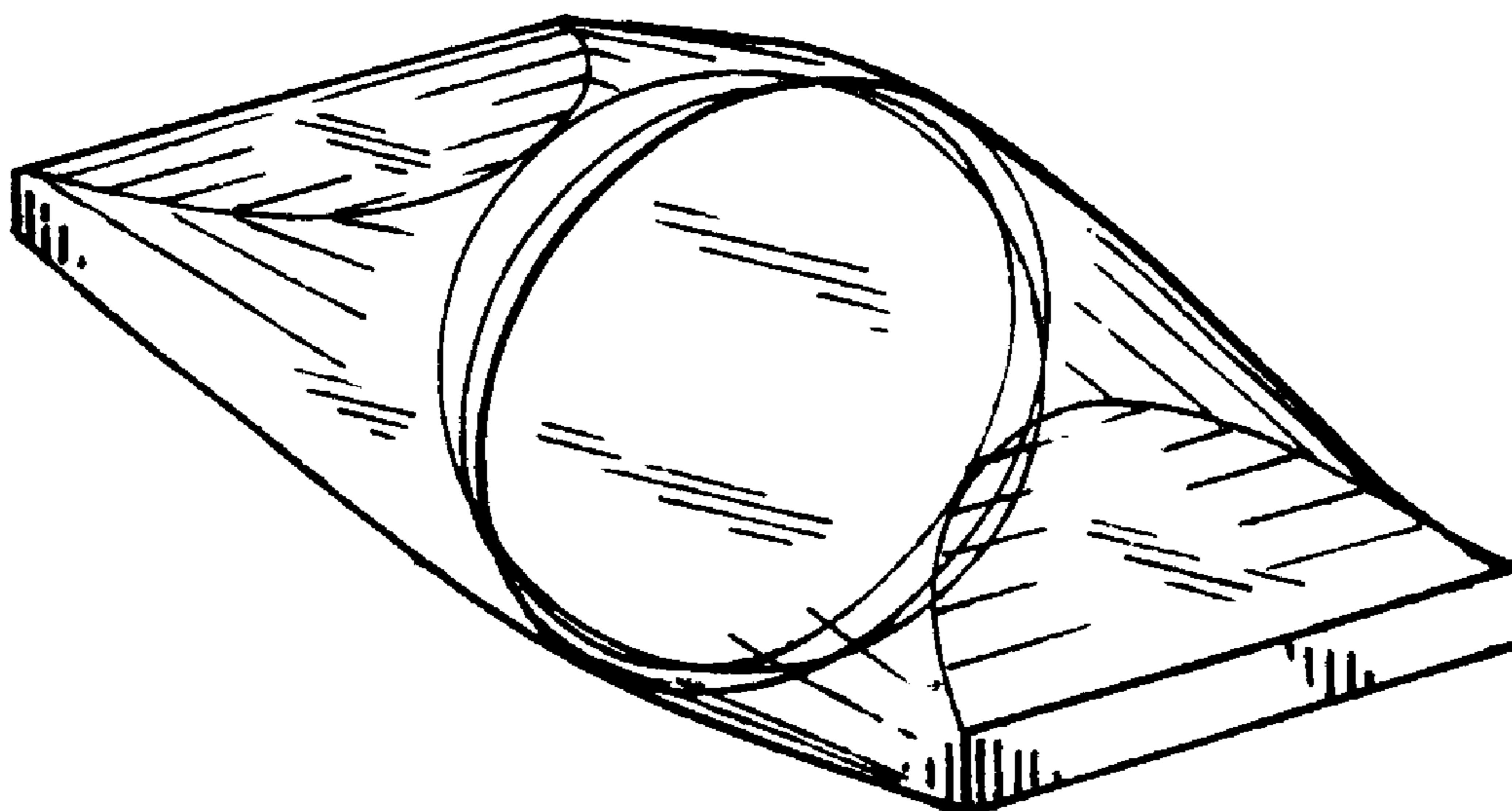
FIG. 5 is a second side elevational view thereof;

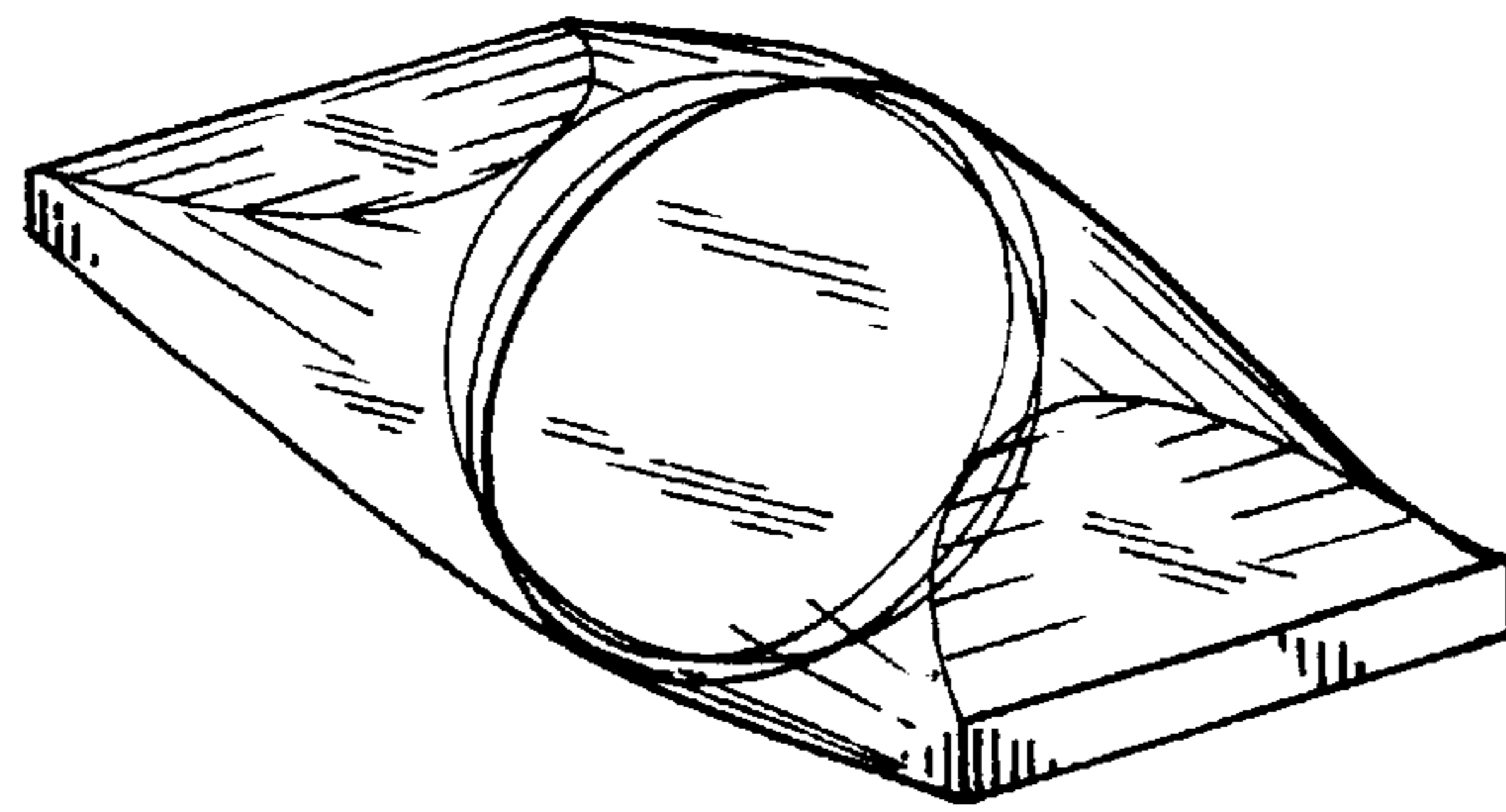
FIG. 6 is a bottom plan view thereof;

FIG. 7 is a rear elevational view thereof; and,

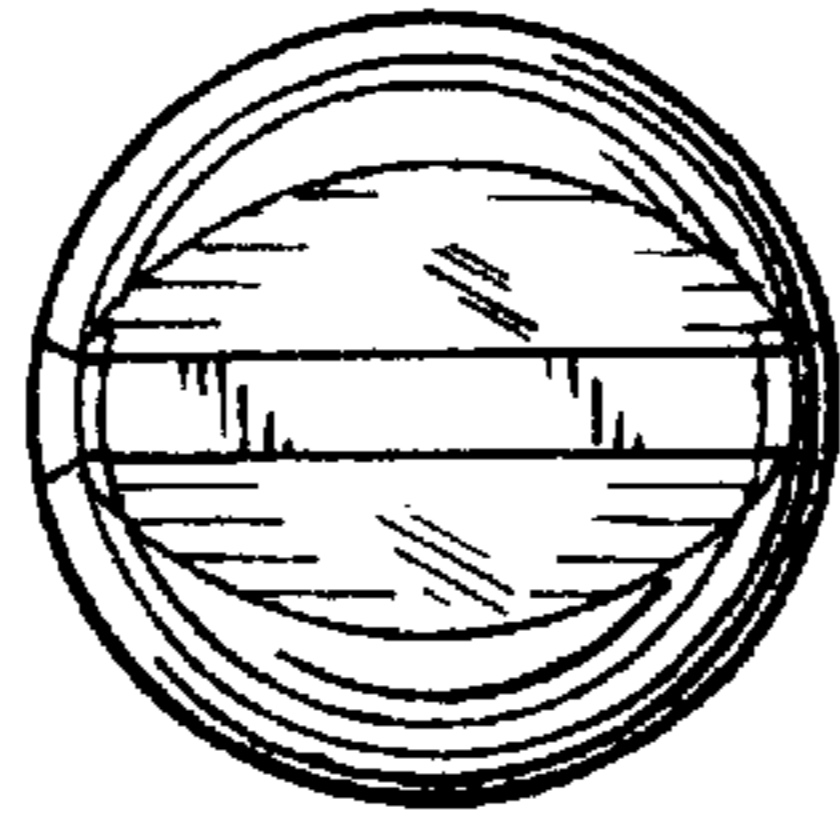
FIG. 8 is an exploded side elevational view thereof.

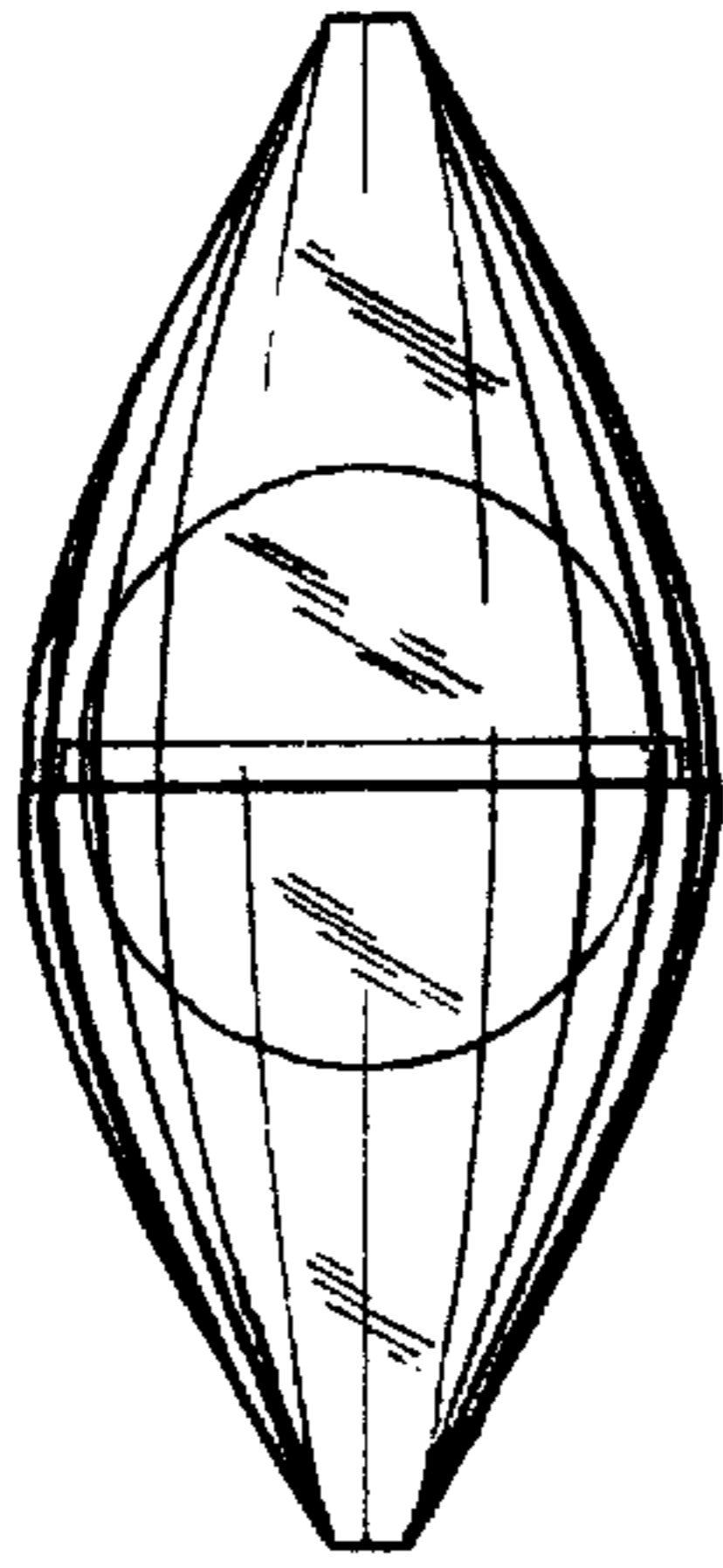




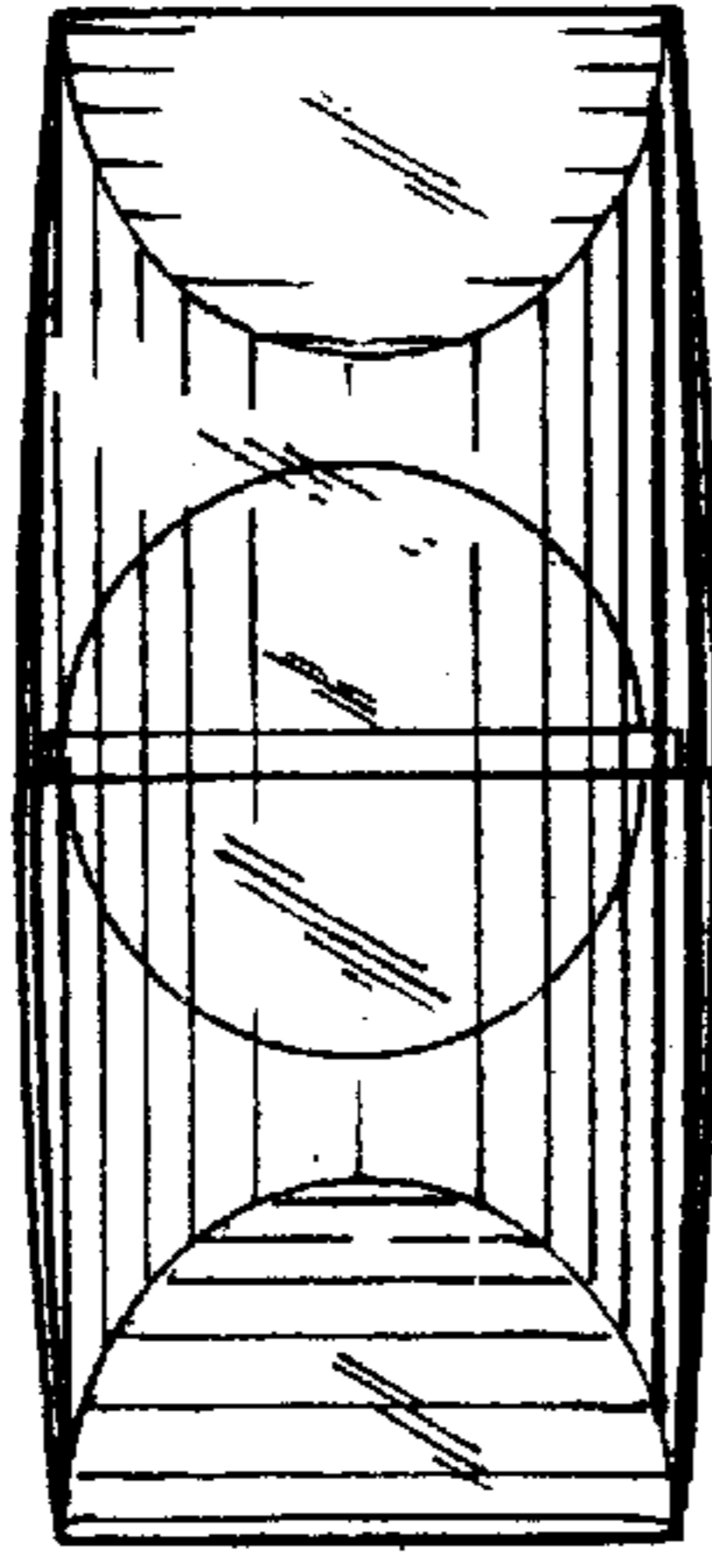

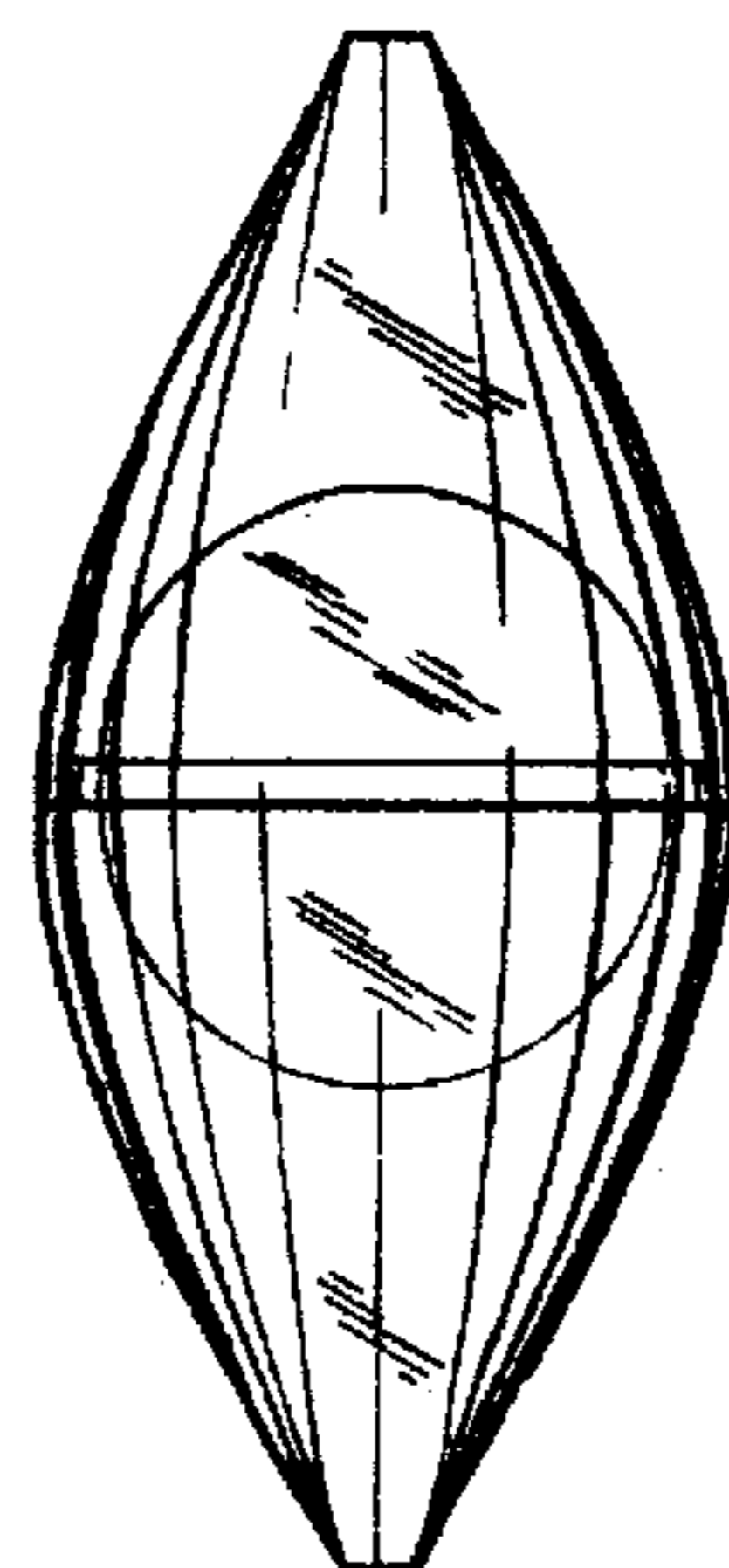

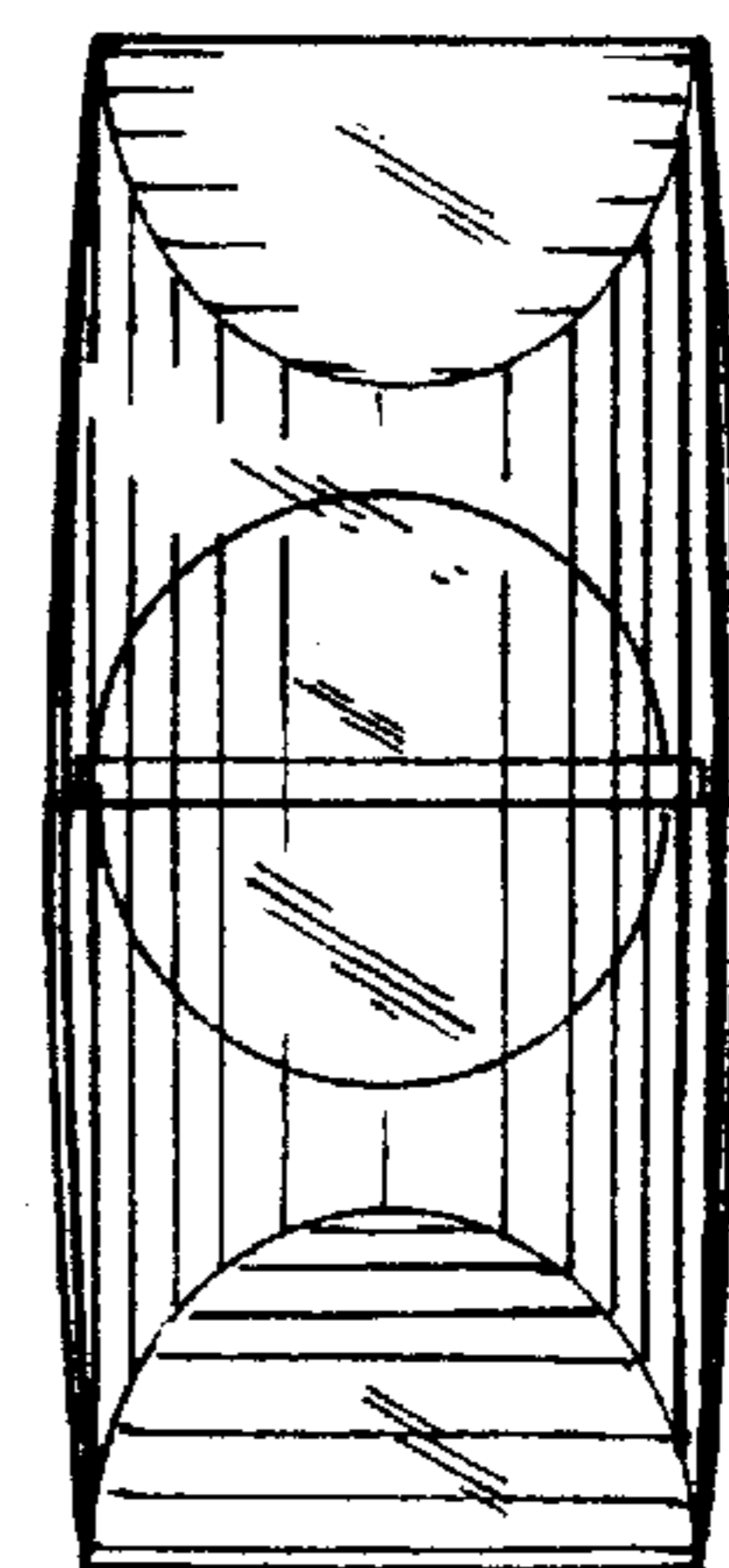

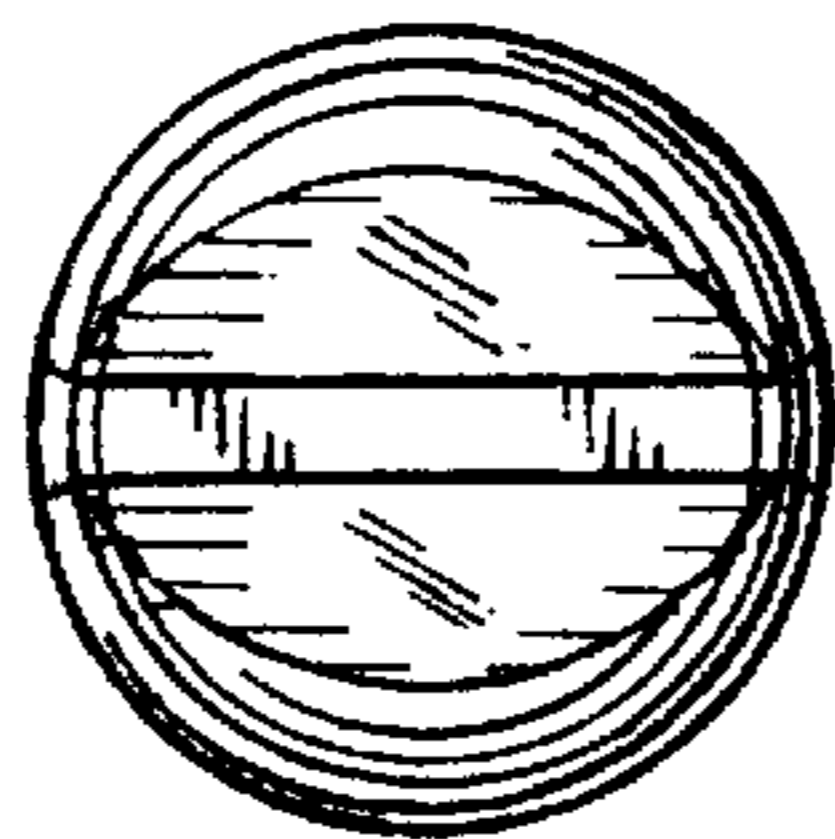

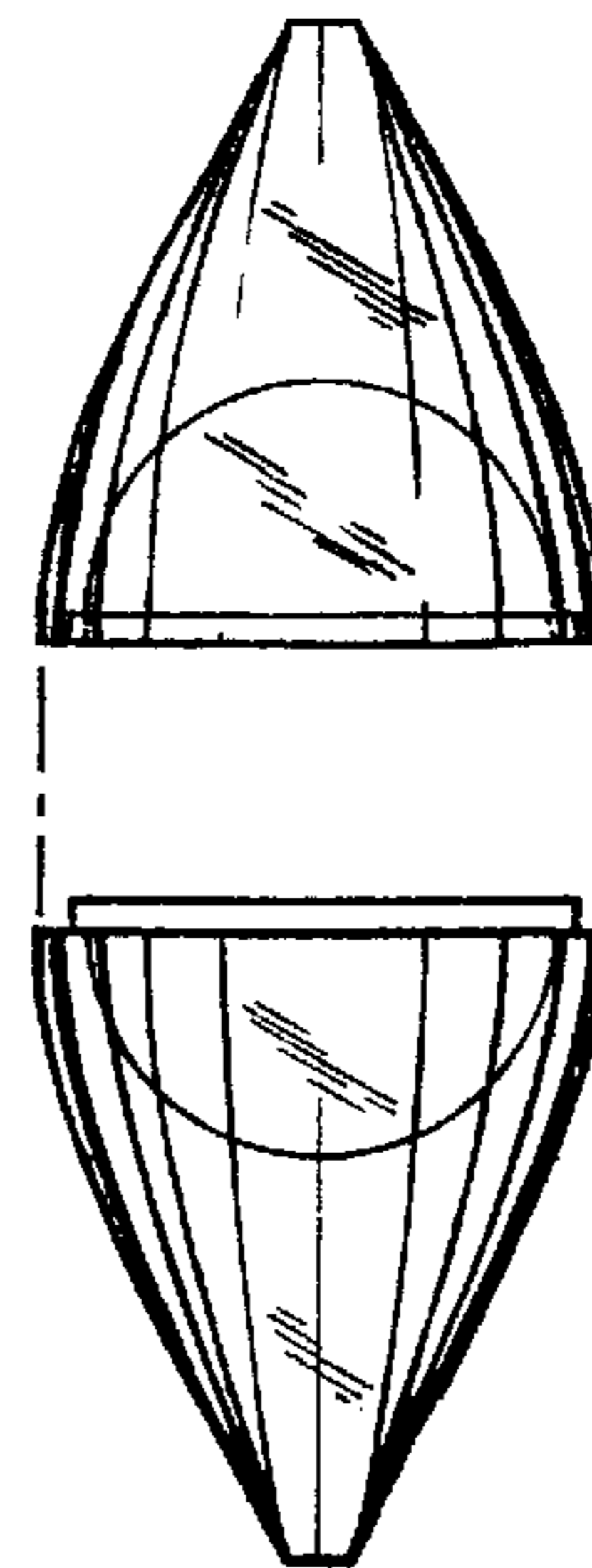
