**DESCRIPTION**

FIG. 11 is a bottom plan view of the solar powered inverter of FIG. 8;

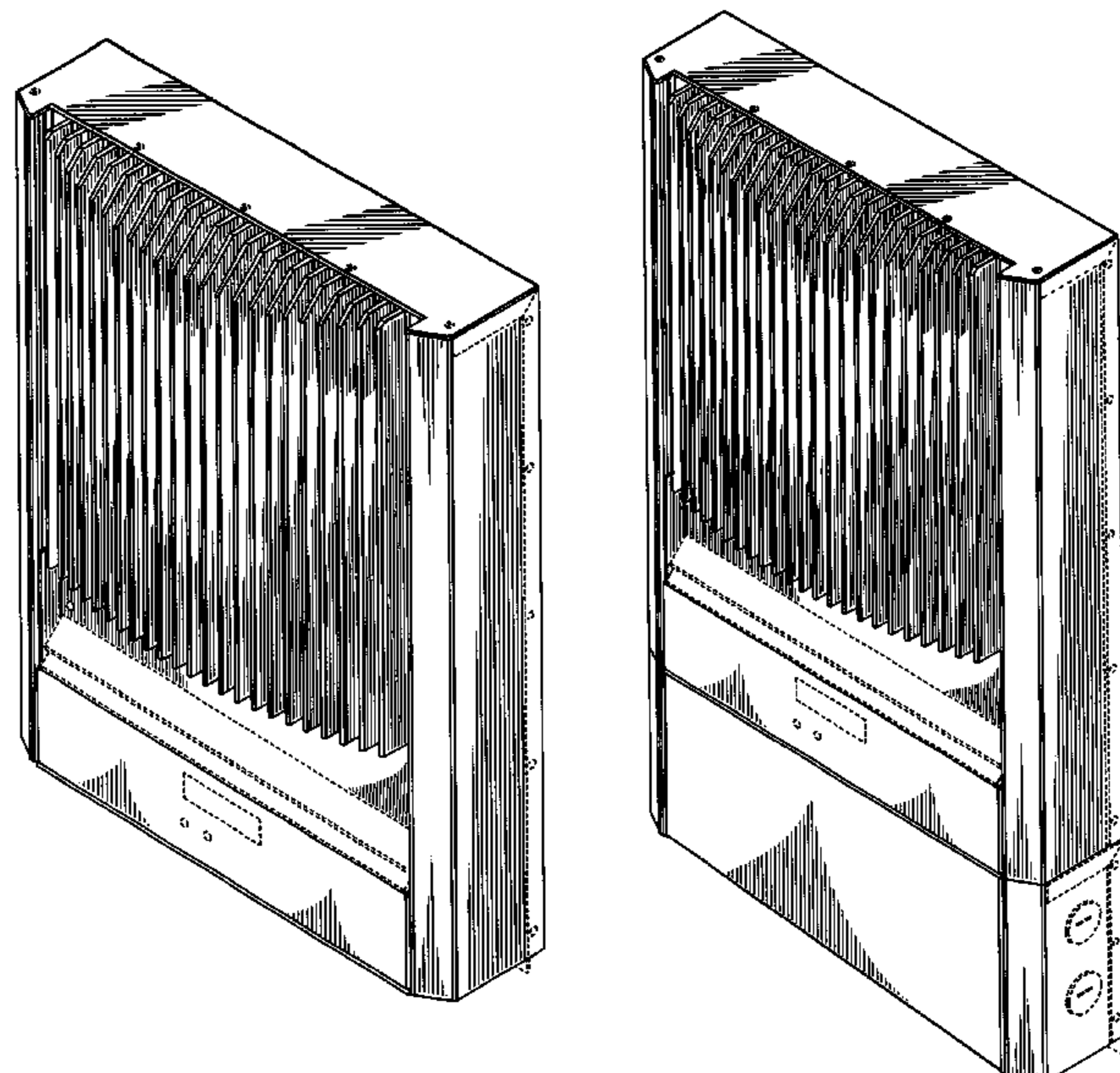
FIG. 12 is a rear elevation view of the solar powered inverter of FIG. 8;

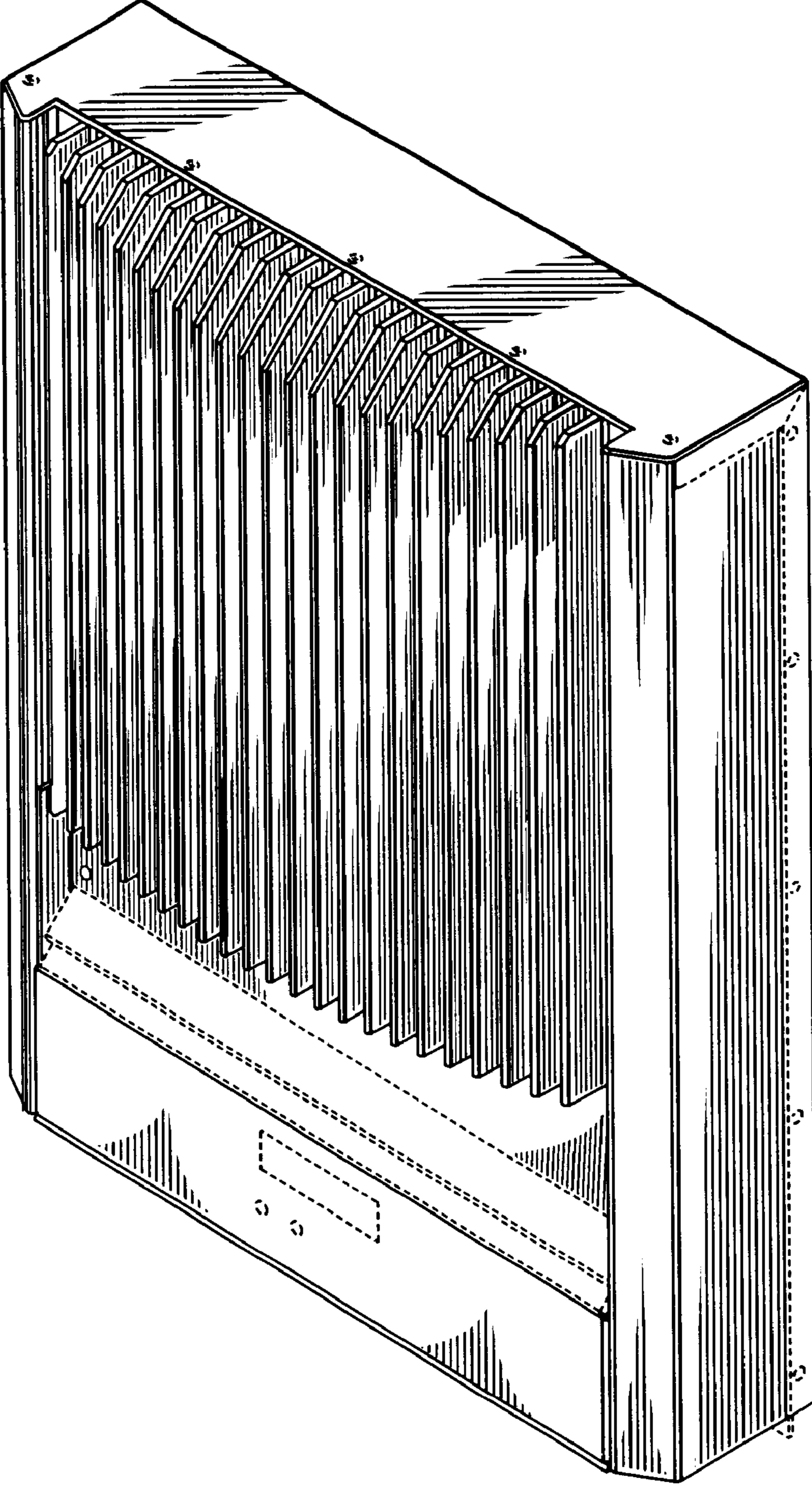
FIG. 13 is a right hand side elevation view of the solar powered inverter of FIG. 8; and,

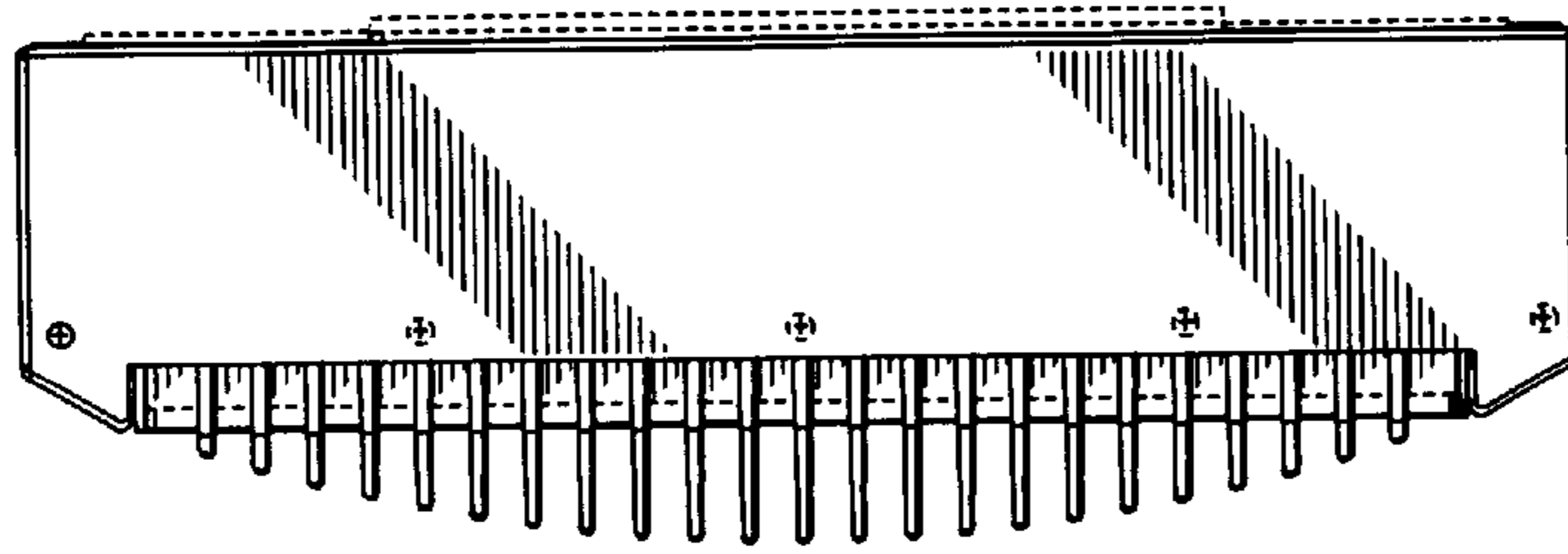

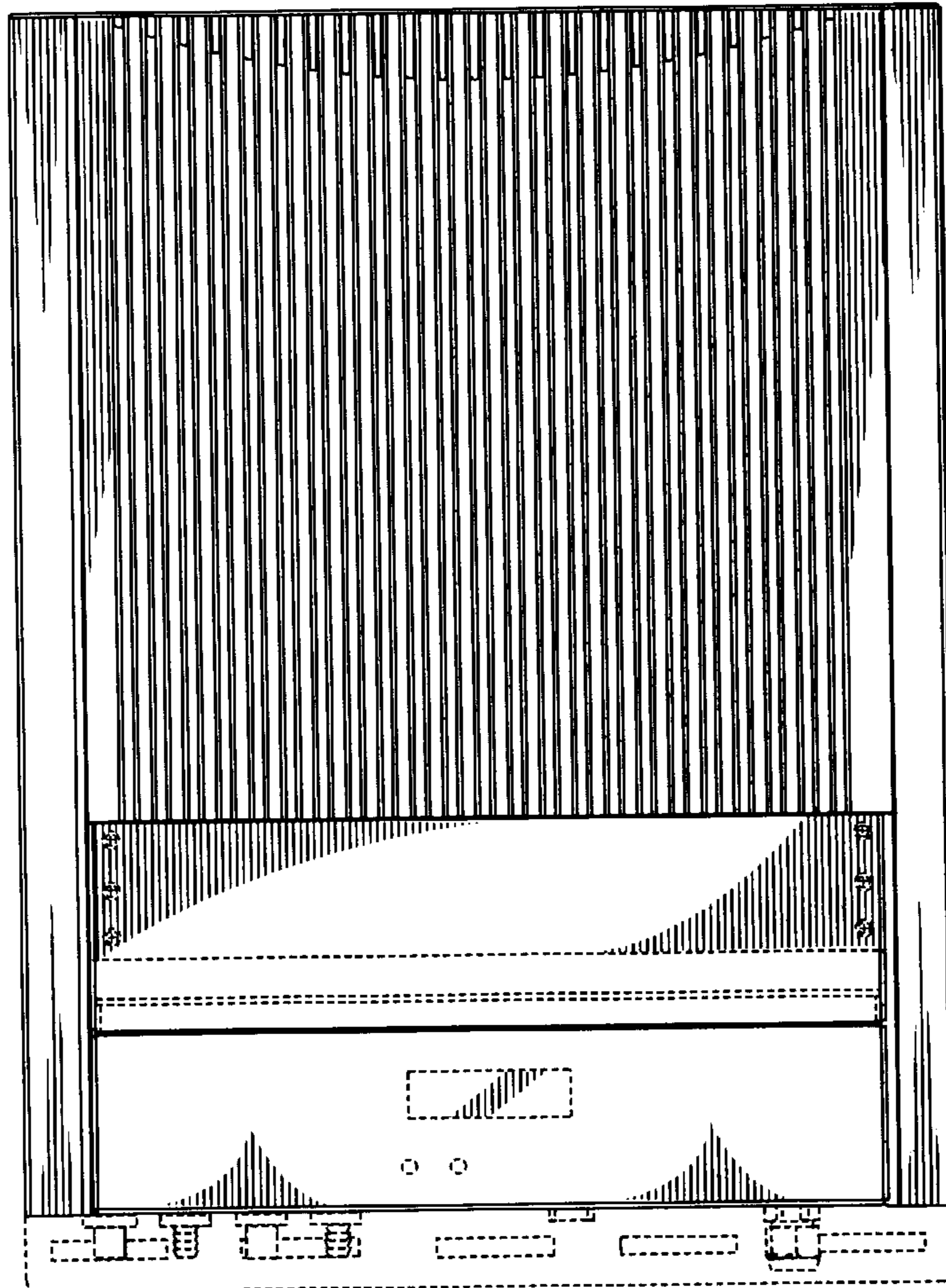

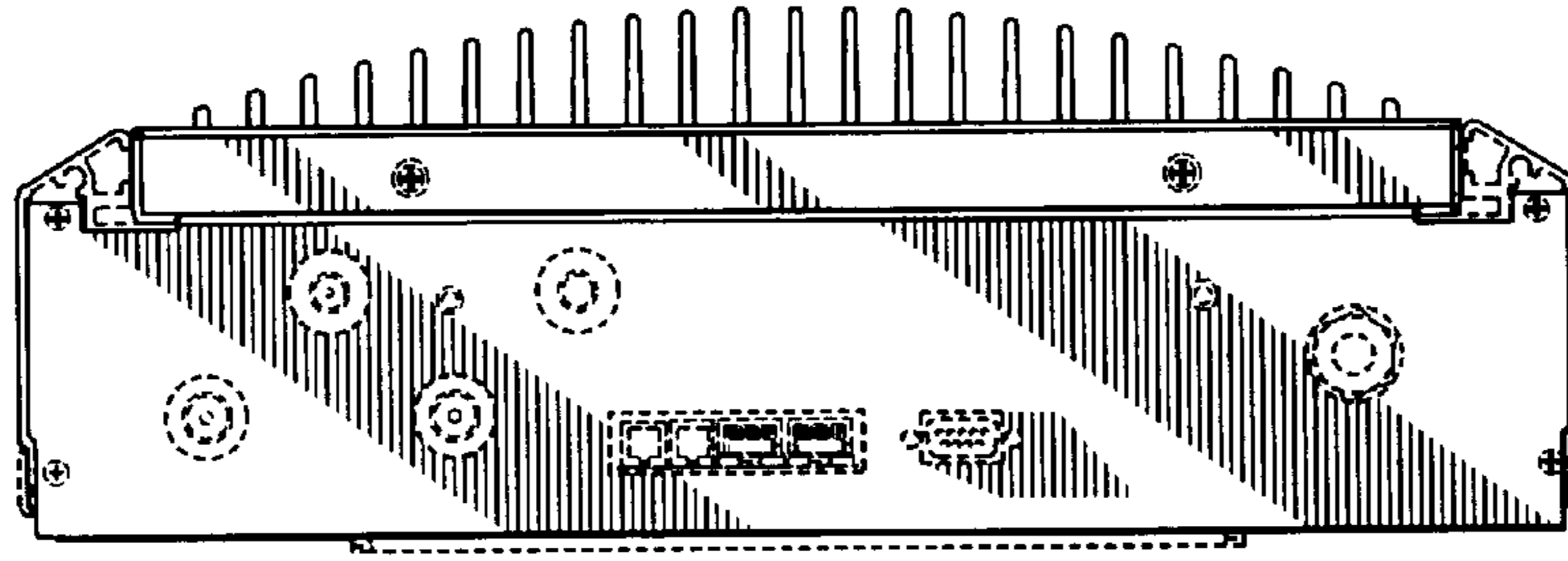

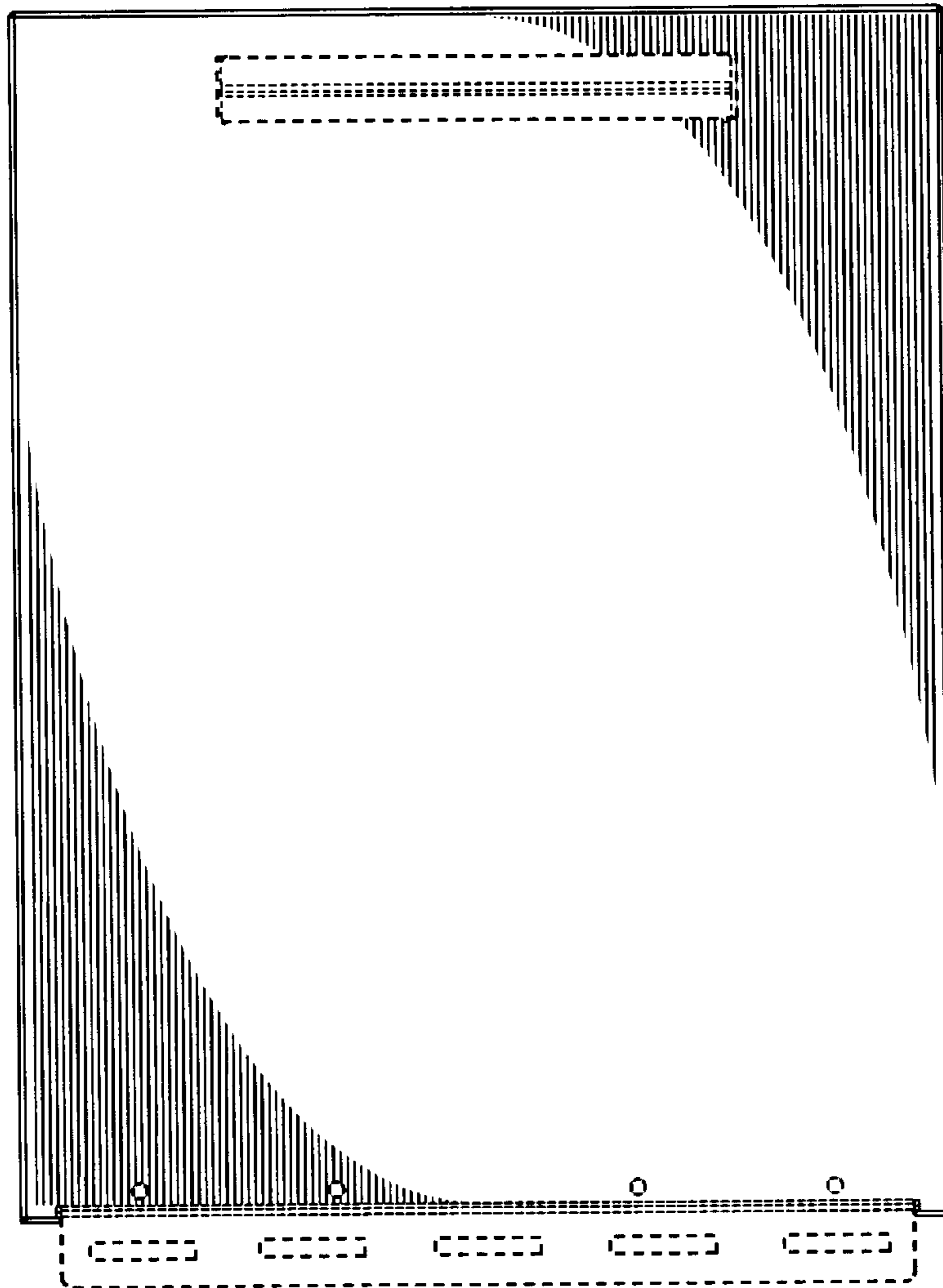
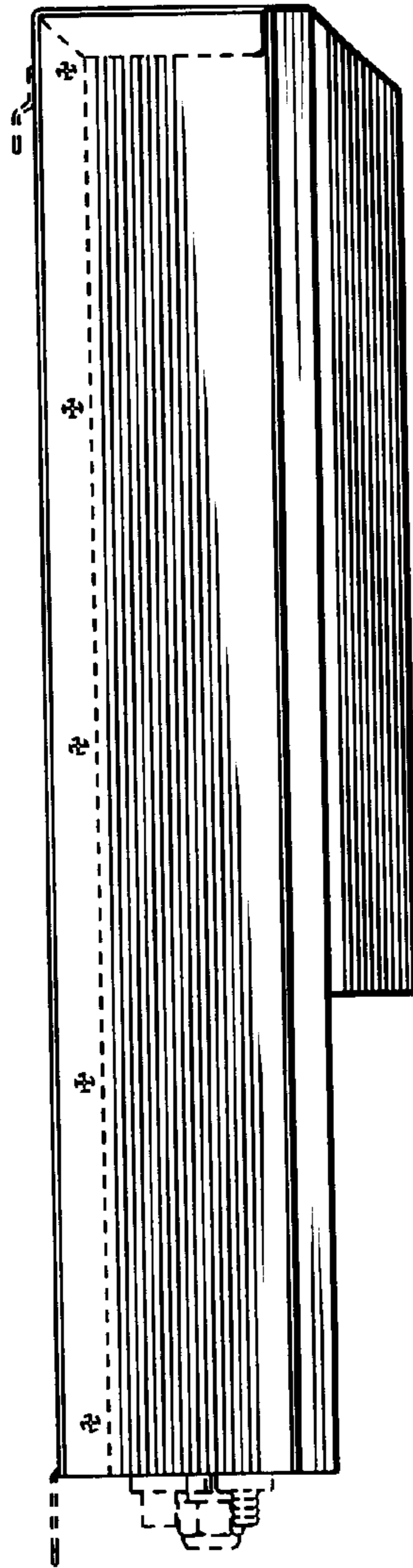
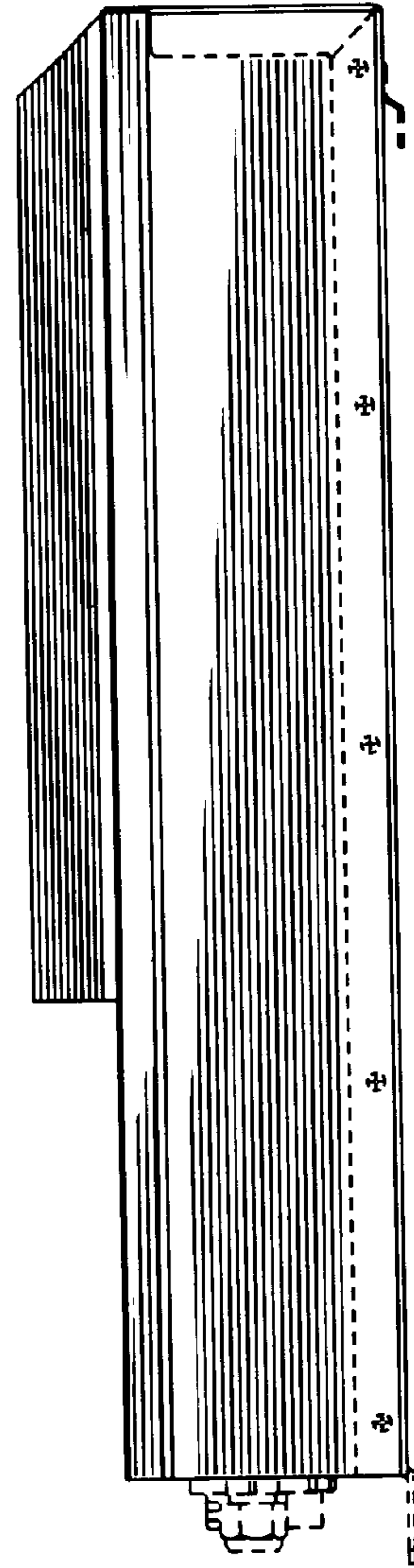

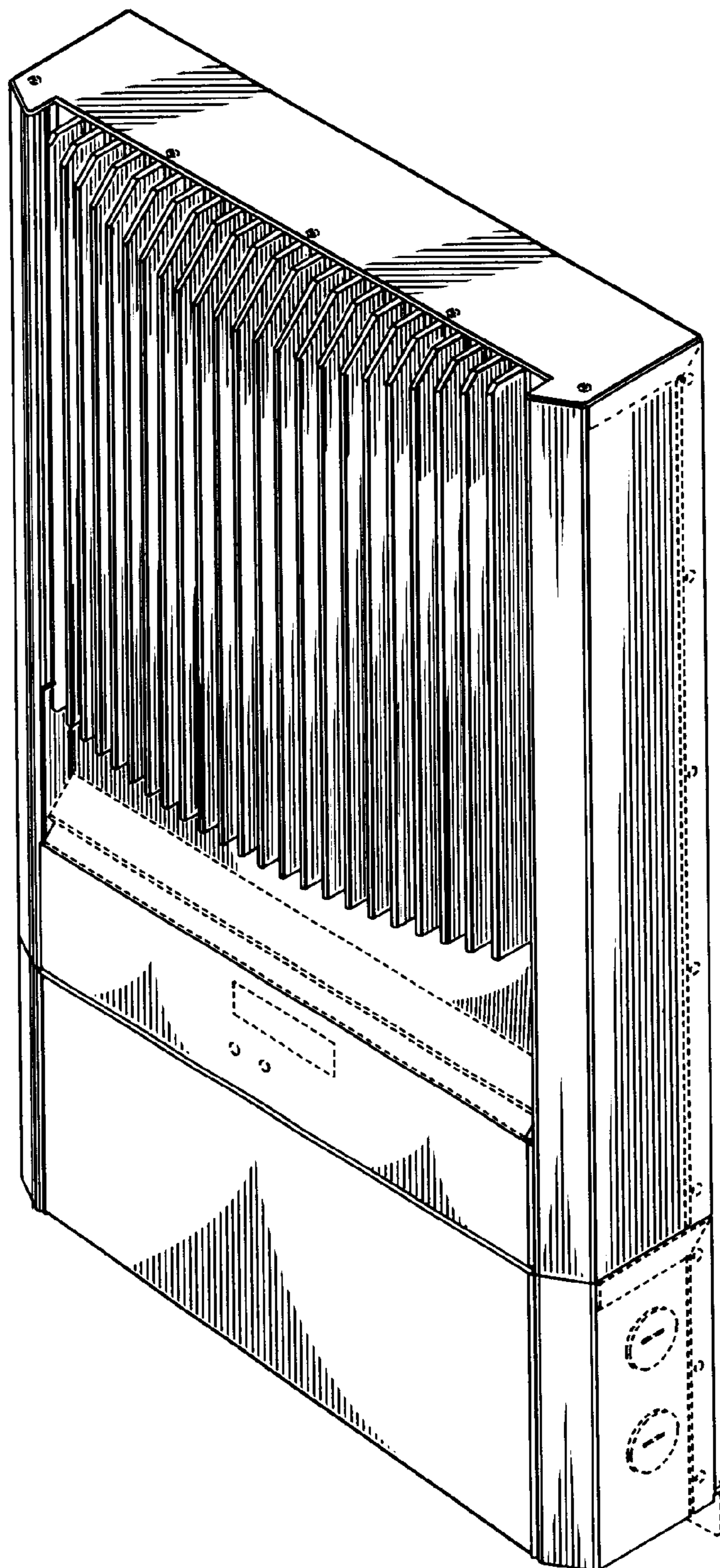

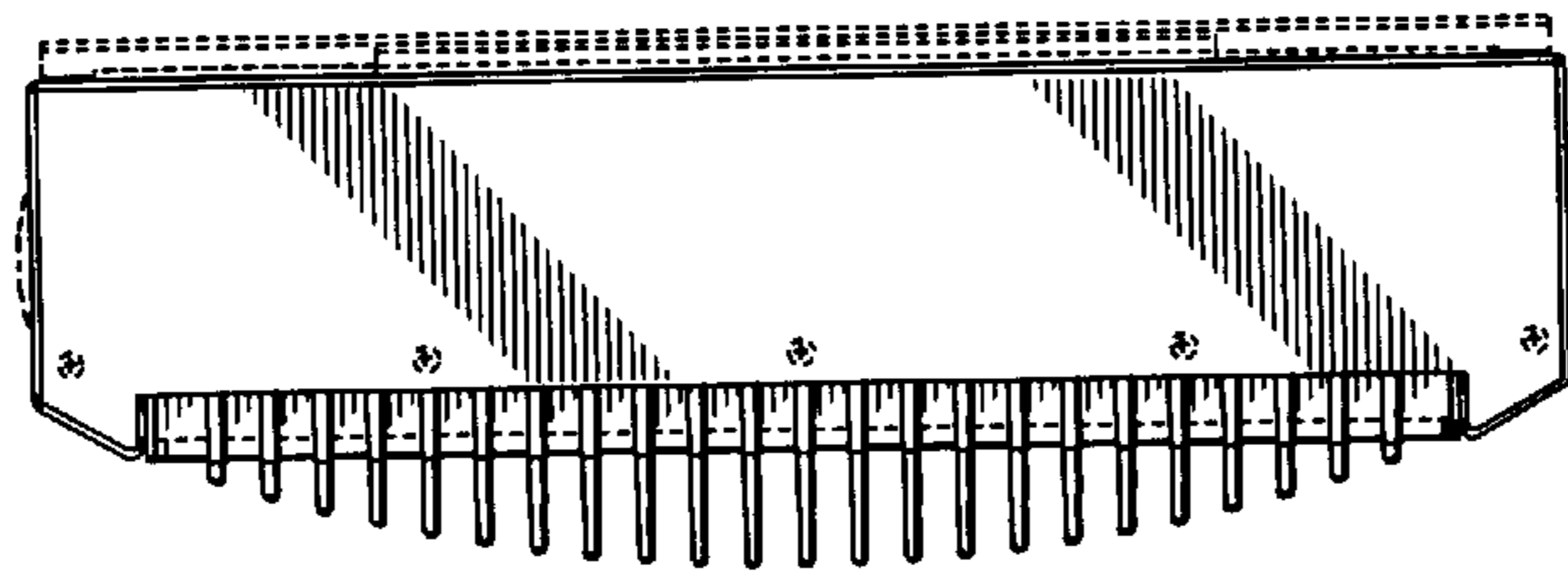

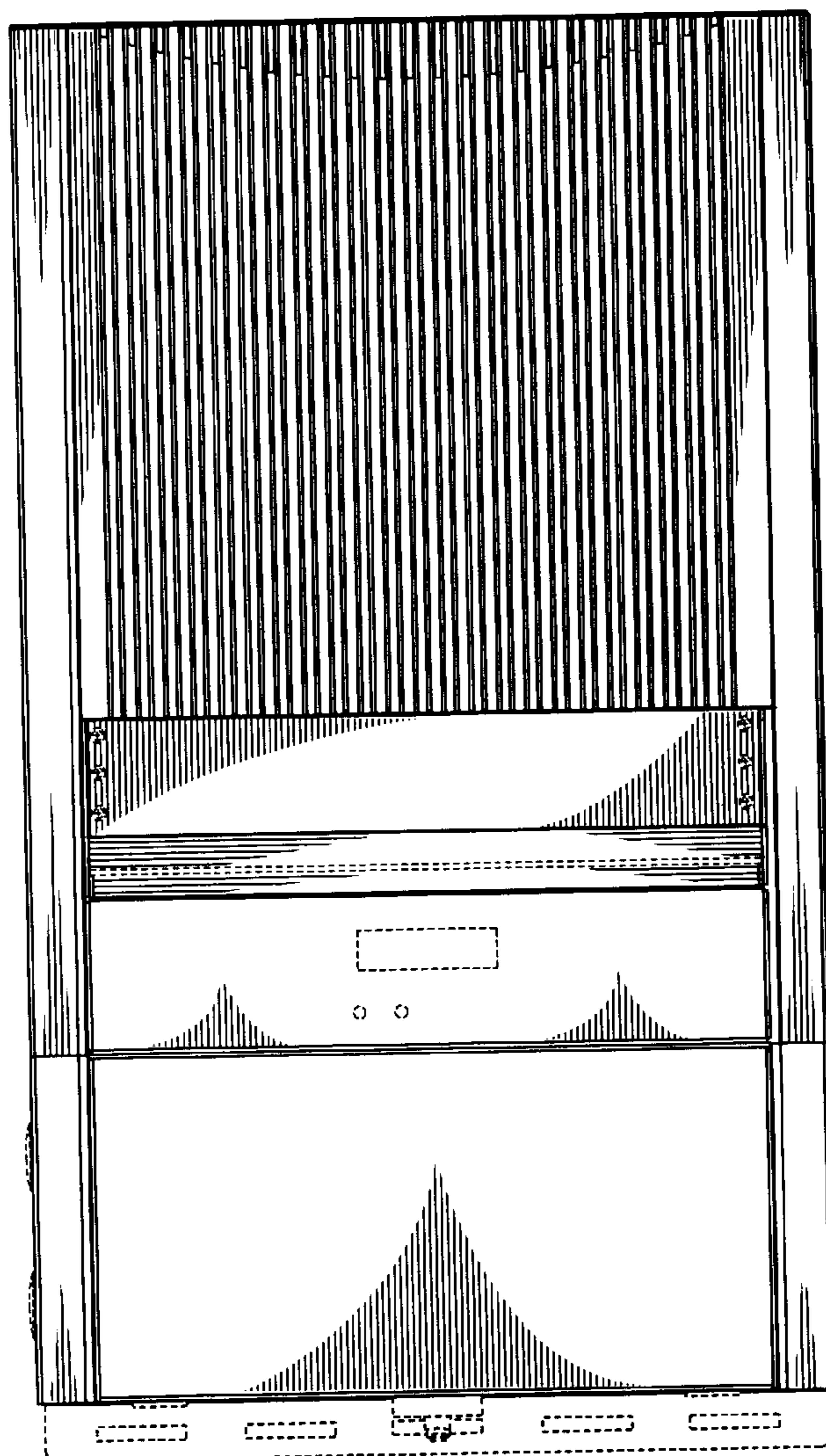

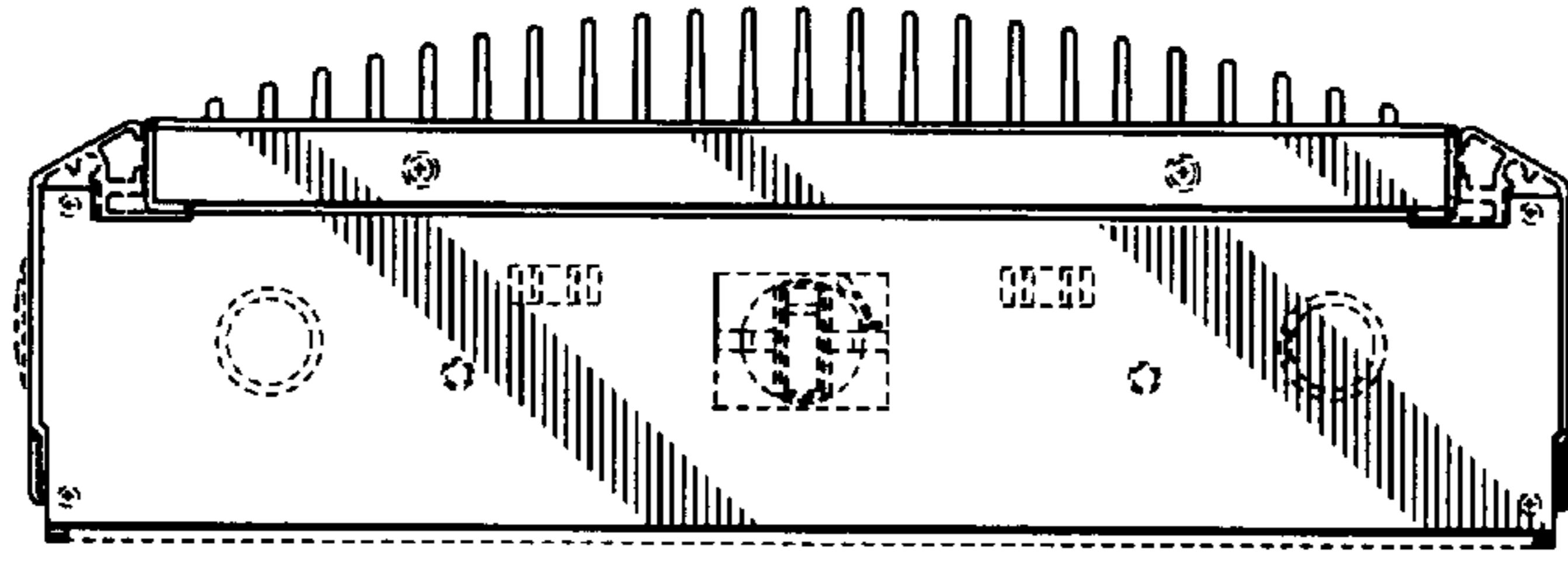

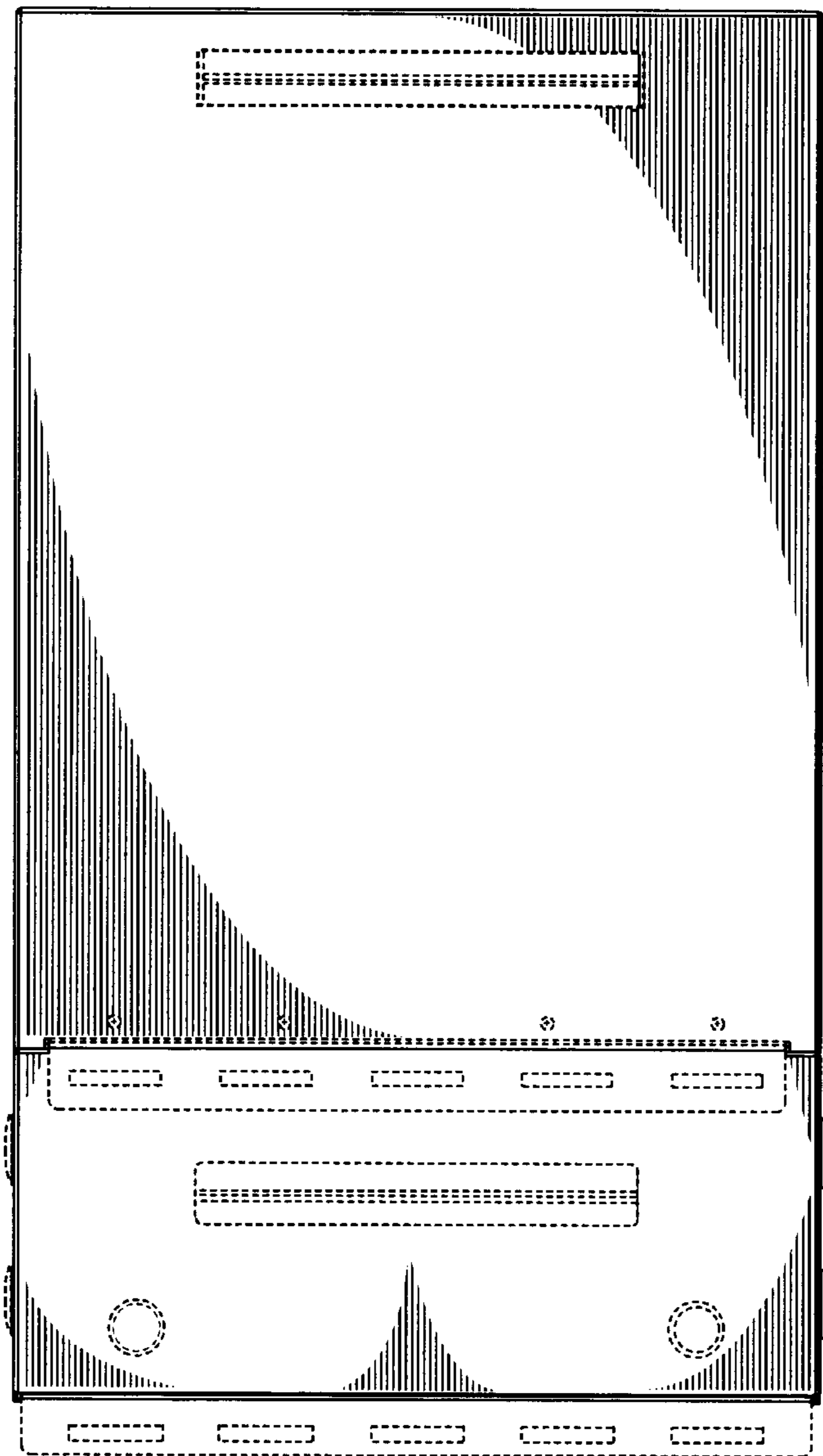
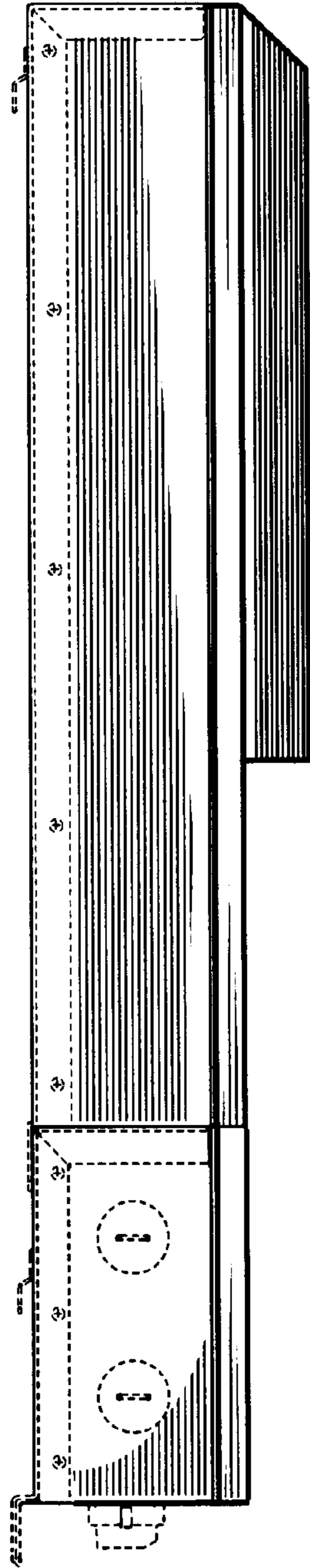
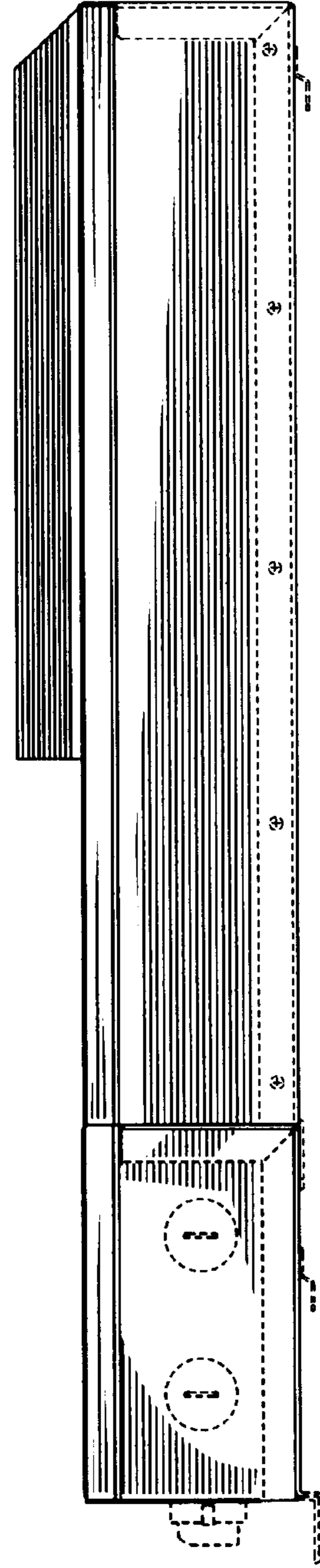
