FIG. 3 is a left plan view of the preferred embodiment of the present invention;

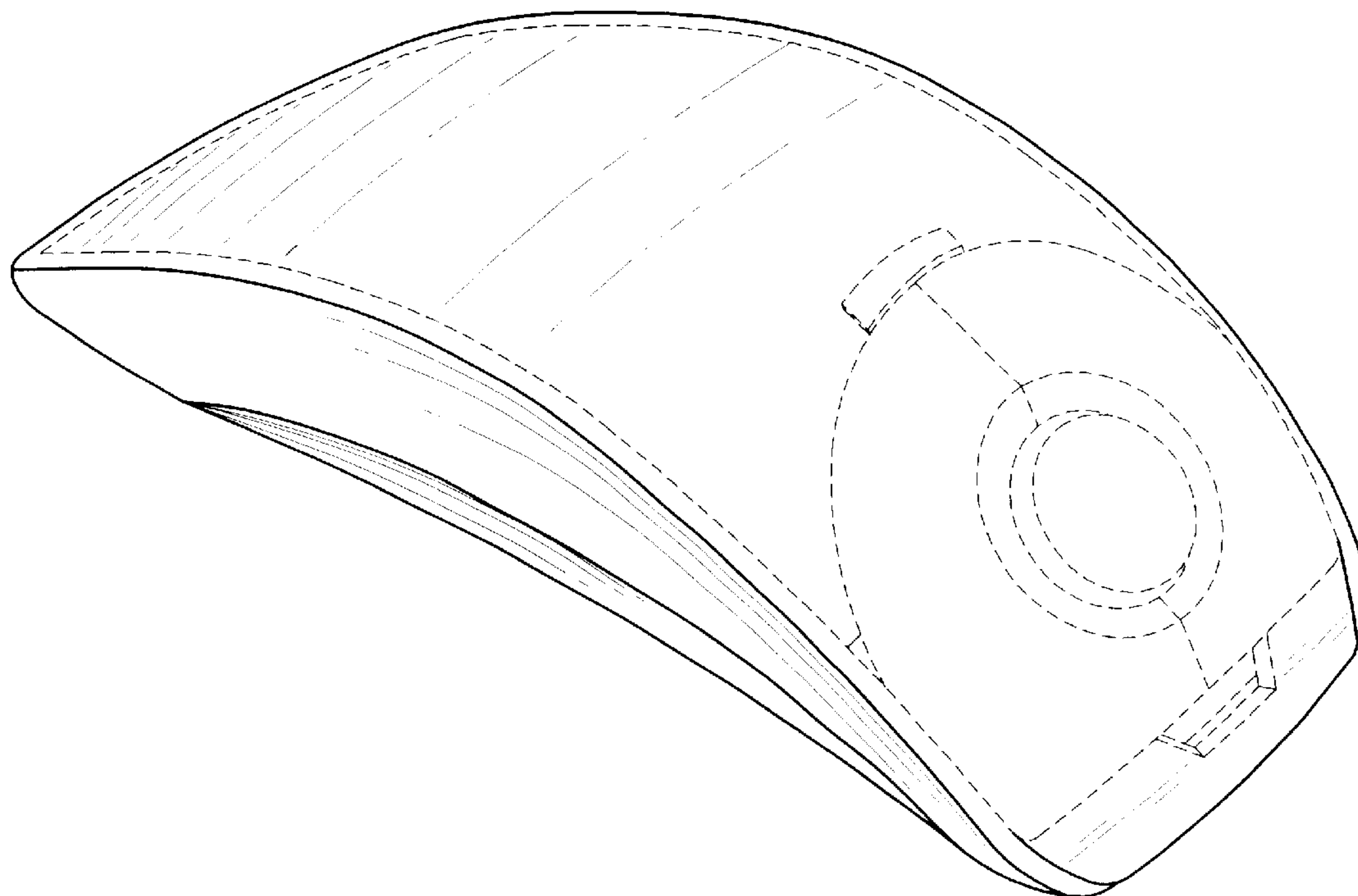
FIG. 4 is a top plan view of the preferred embodiment of the present invention;

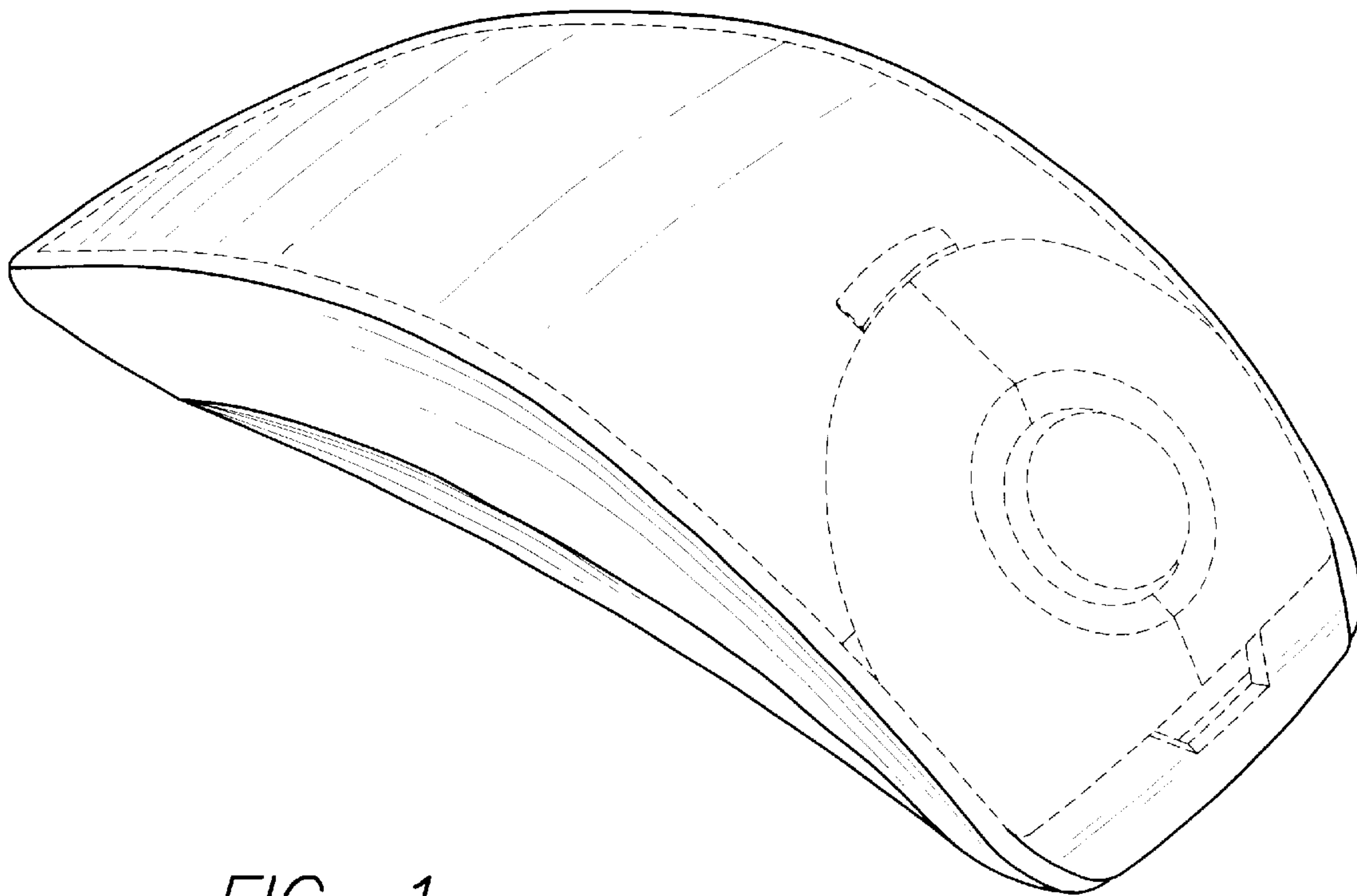

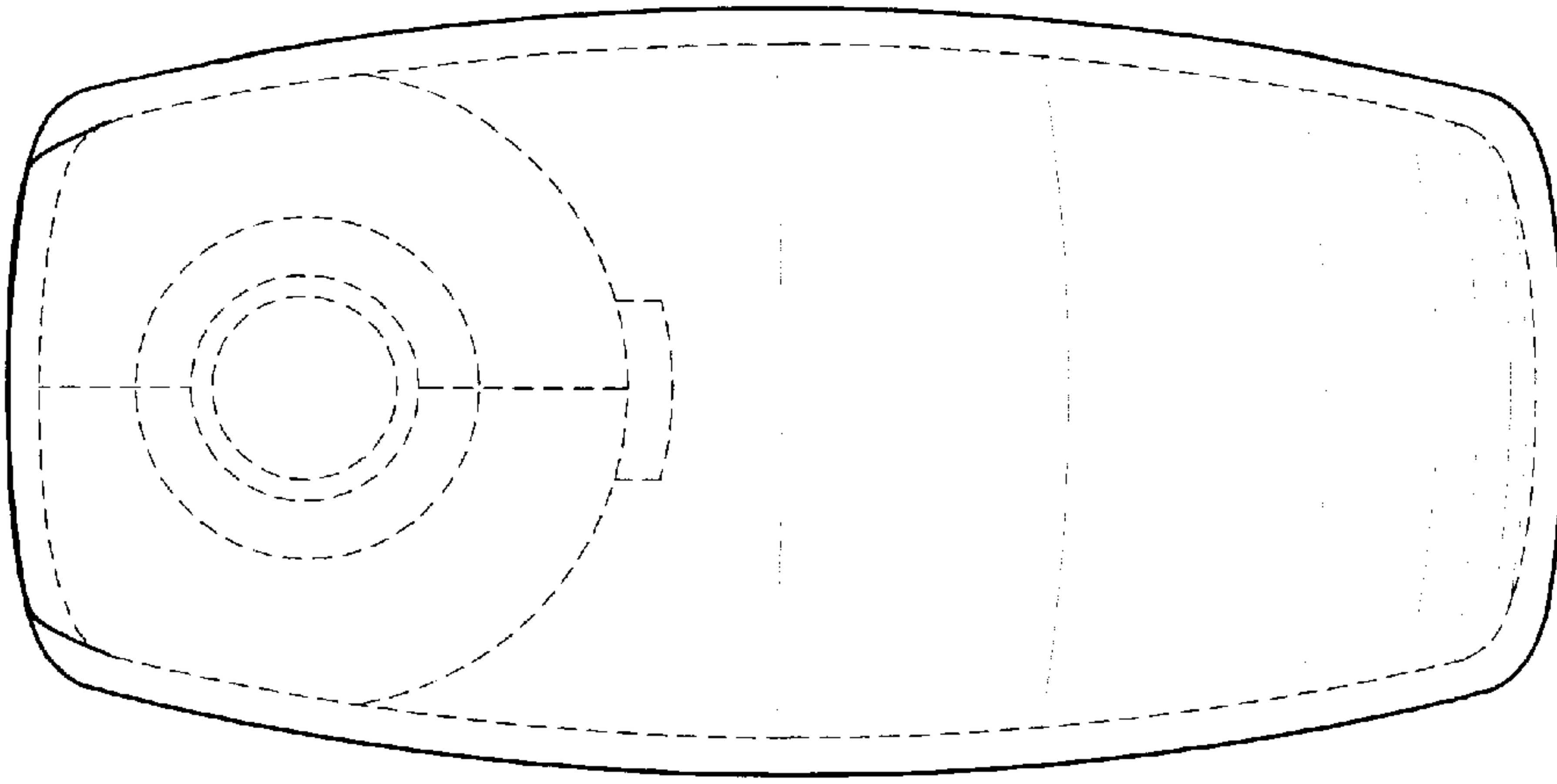

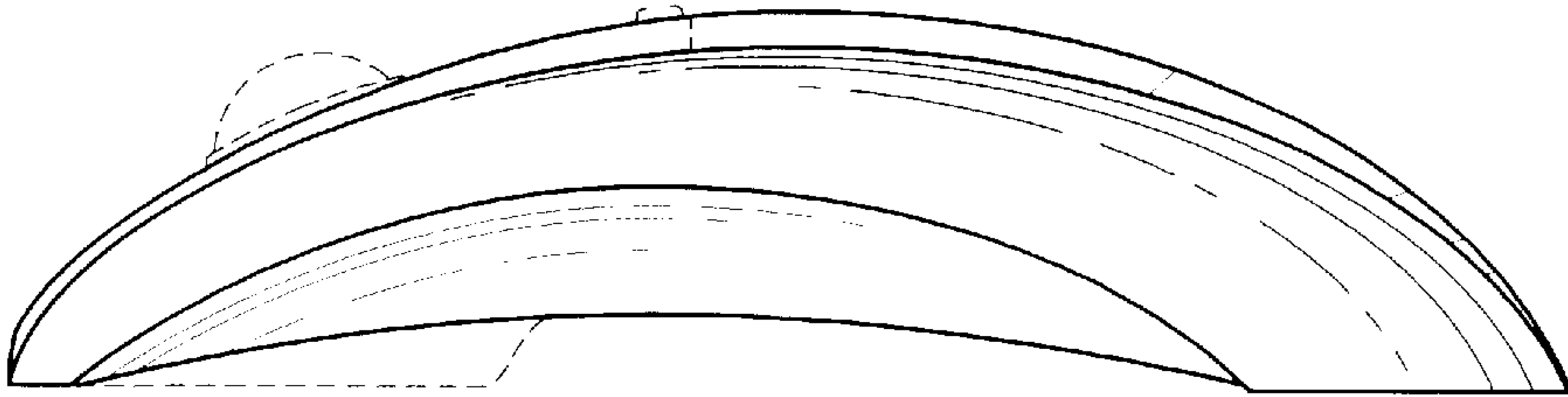

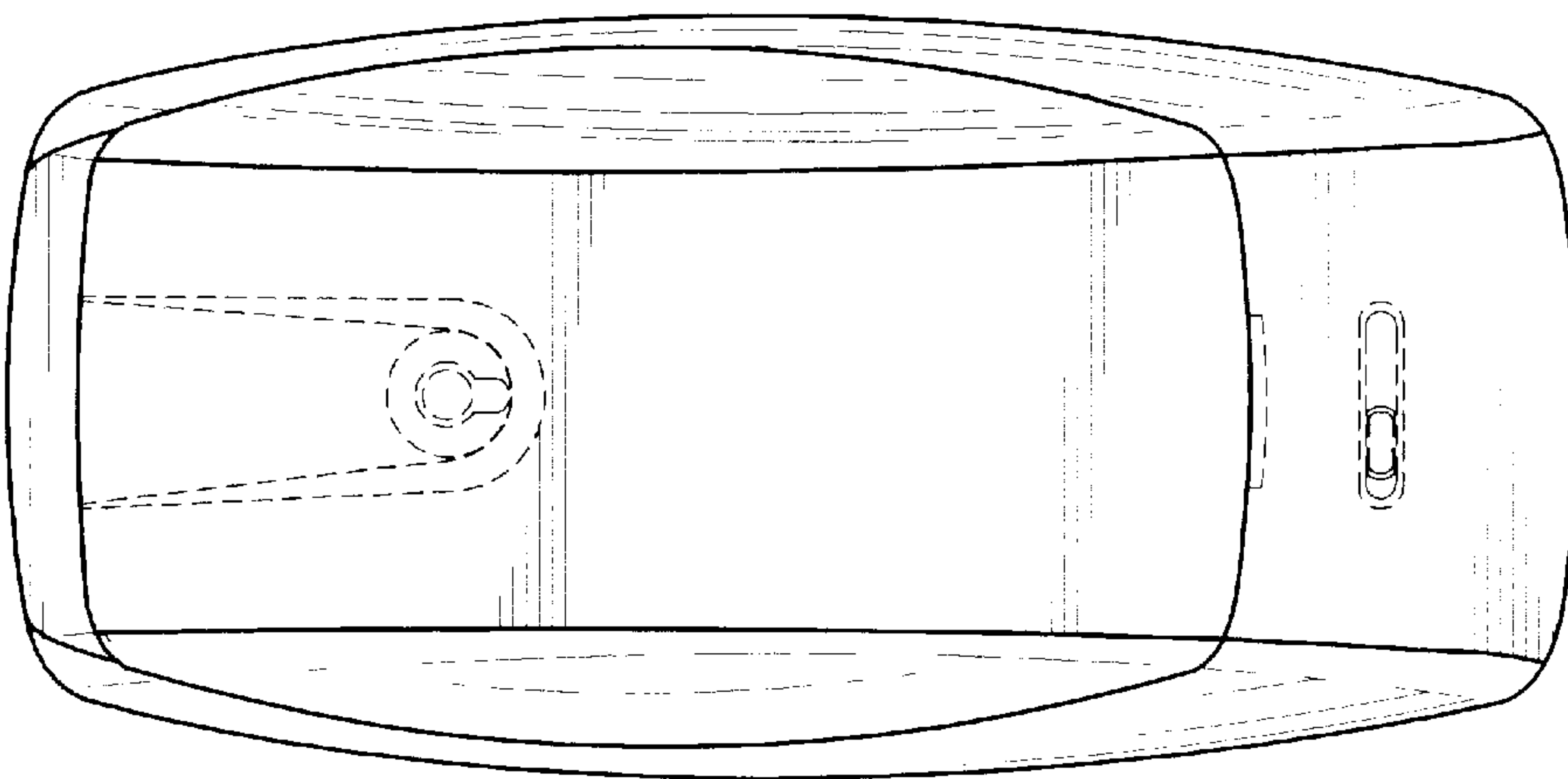
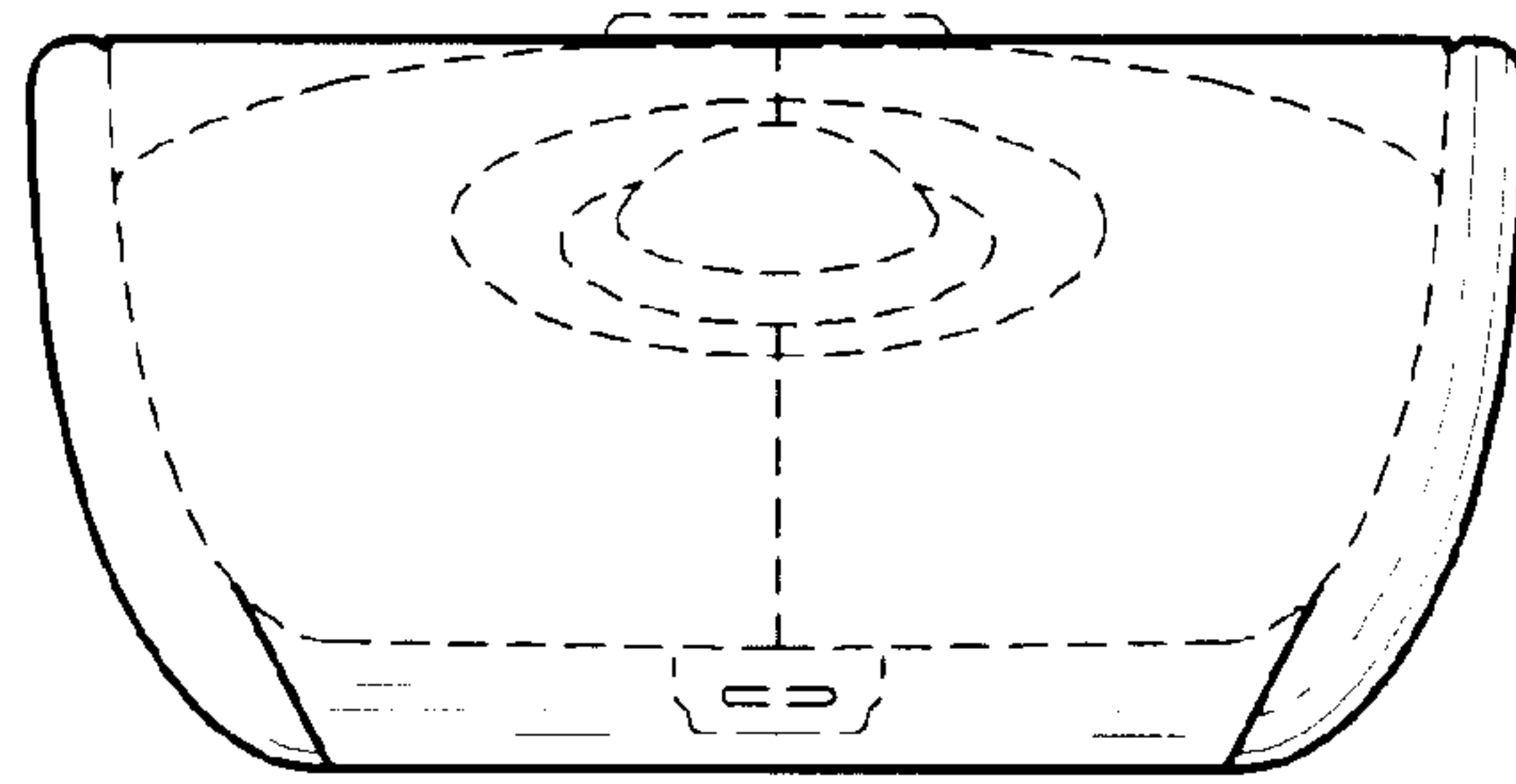
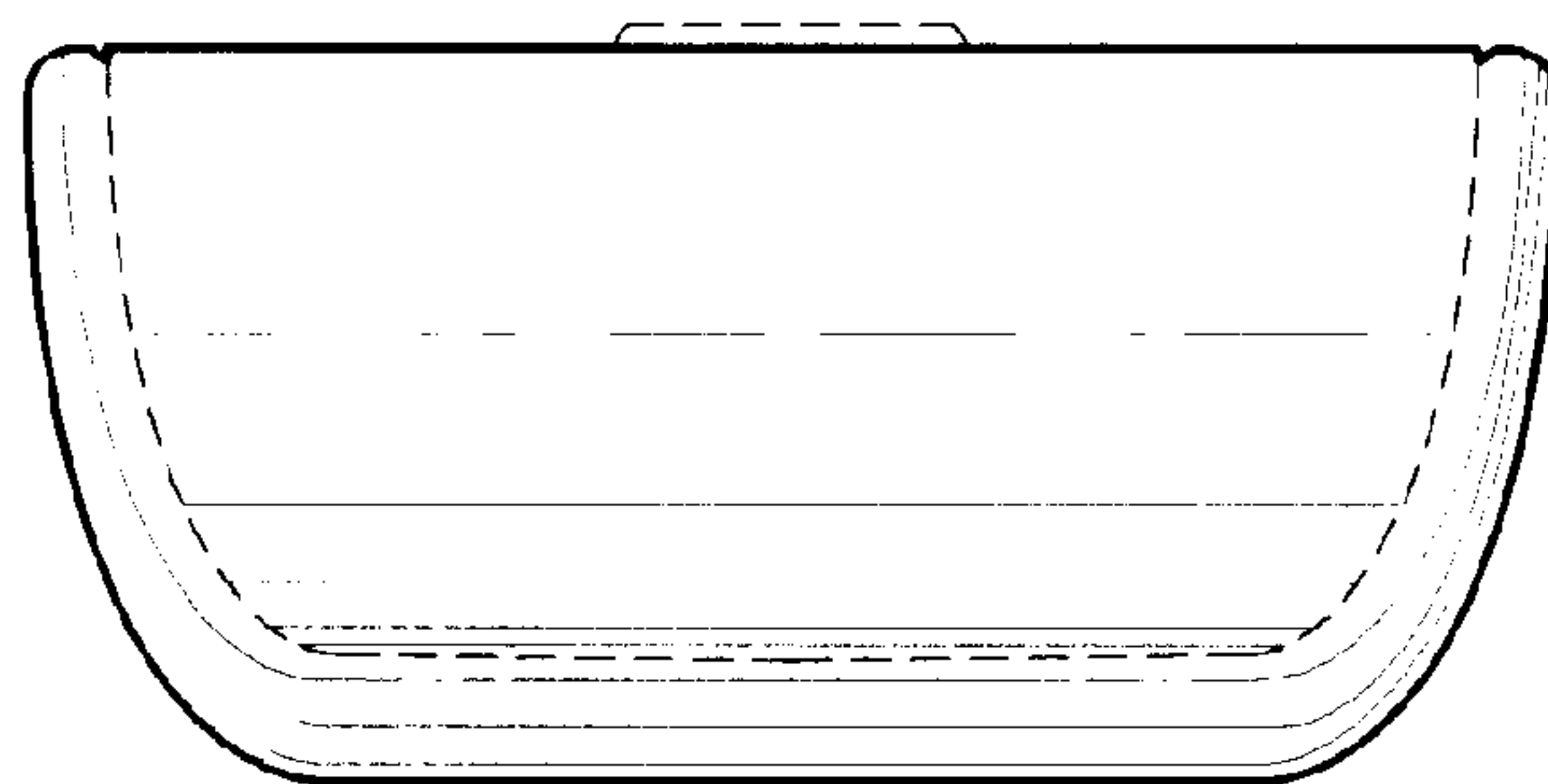
