(57) **CLAIM**

The ornamental design for a wood golf head, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a wood golf club head

showing my new design according to a first embodiment of the invention;

FIG. 2 is a rear elevational view of the wood golf club head of FIG. 1;

FIG. 3 is a right-hand side elevational view of the wood golf club head of FIG. 1;

FIG. 4 is a left-hand side elevational view of the wood golf club head of FIG. 1;

FIG. 5 is a top elevational view of the wood golf club head of FIG. 1;

FIG. 6 is a bottom elevational view of the wood golf club head of FIG. 1;

FIG. 7 is a perspective view from the front, left-hand side of the wood golf club head of FIG. 1;

FIG. 8 is a perspective view from the rear, right-hand side of the wood golf club head of FIG. 1;

FIG. 9 is a front perspective view of the wood golf club head of FIG. 1;

FIG. 10 is a bottom perspective view of the wood golf club head of FIG. 1;

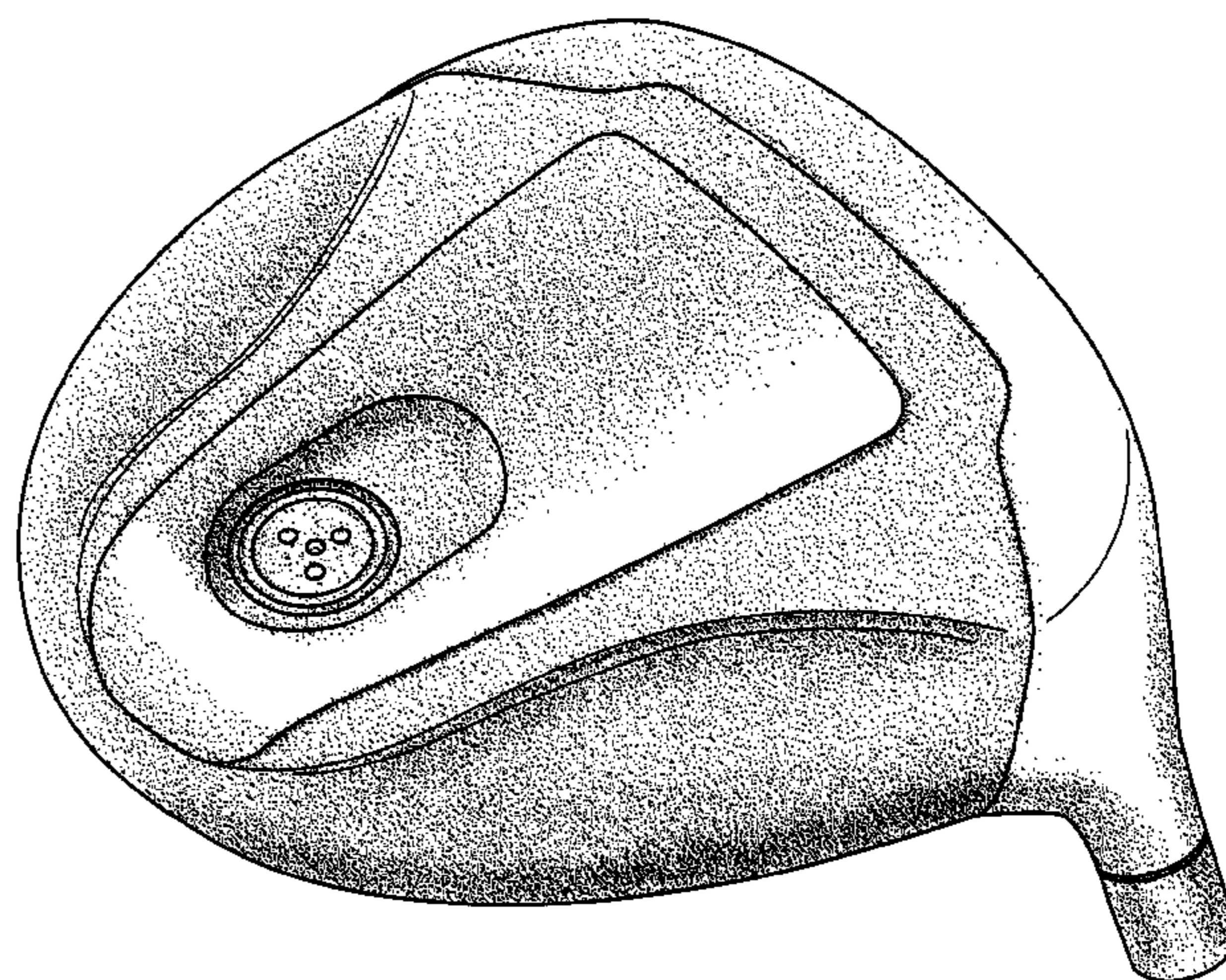
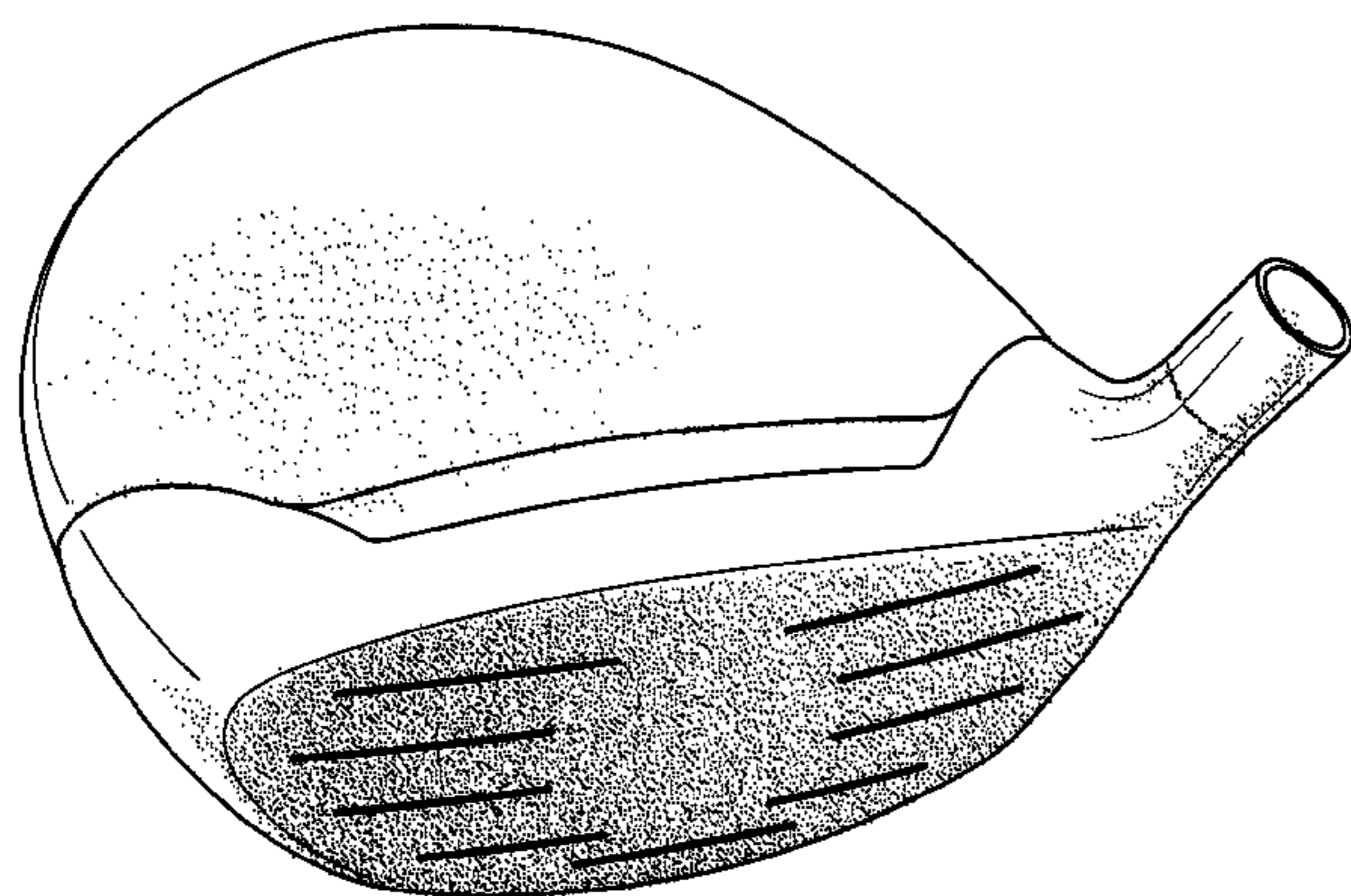
FIG. 11 is a bottom perspective view from the front of the wood golf club head of FIG. 1;

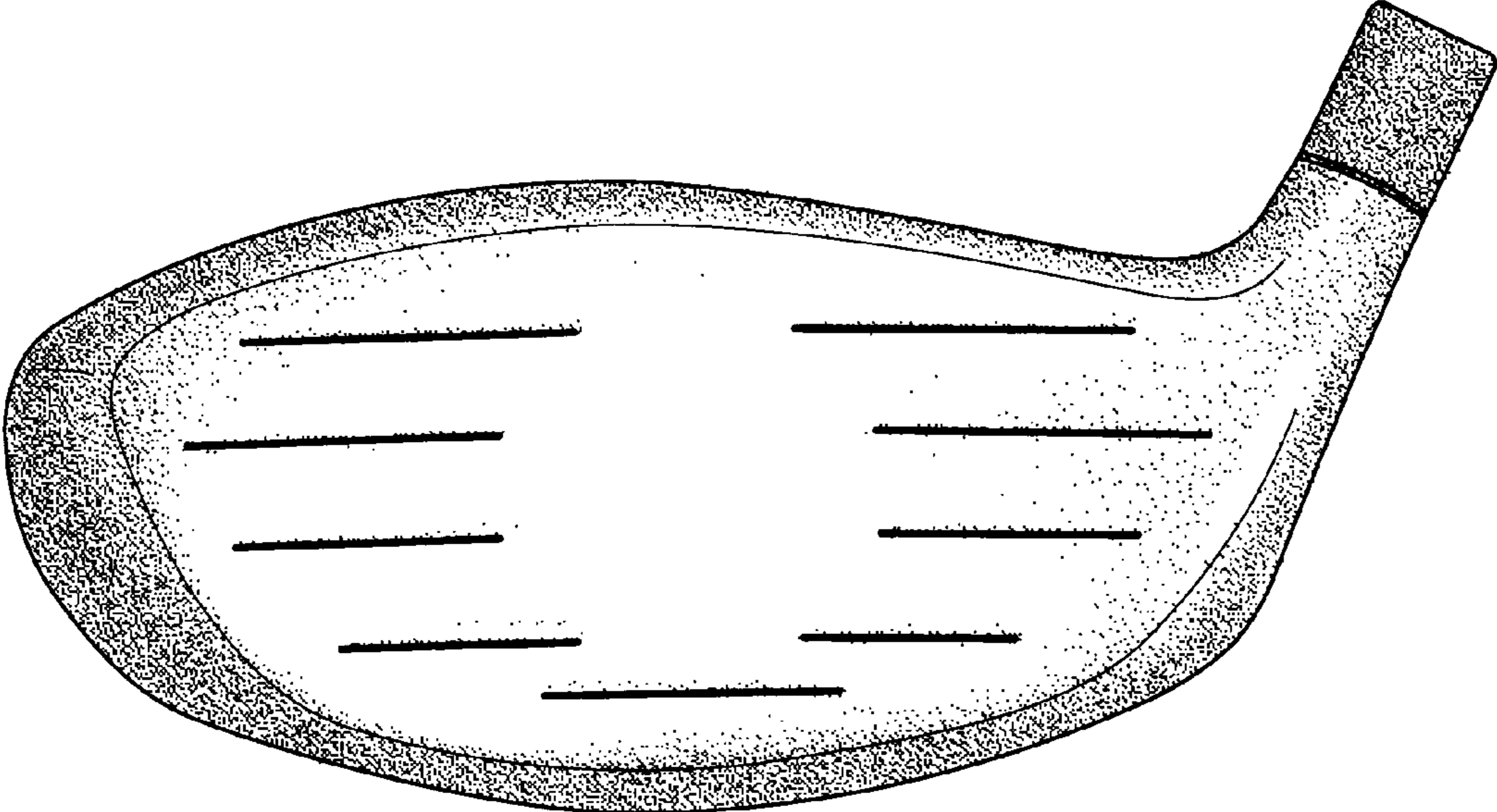

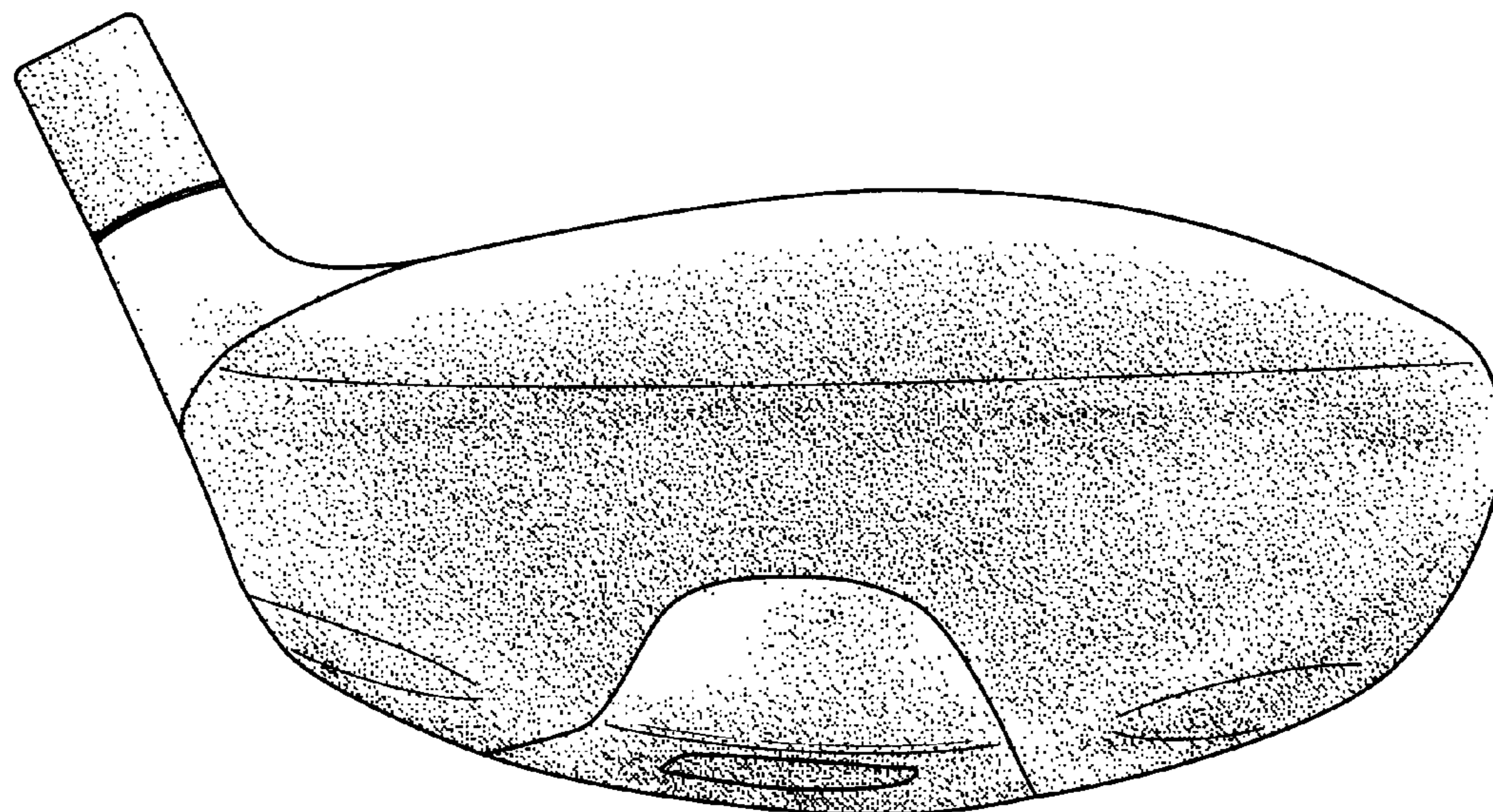

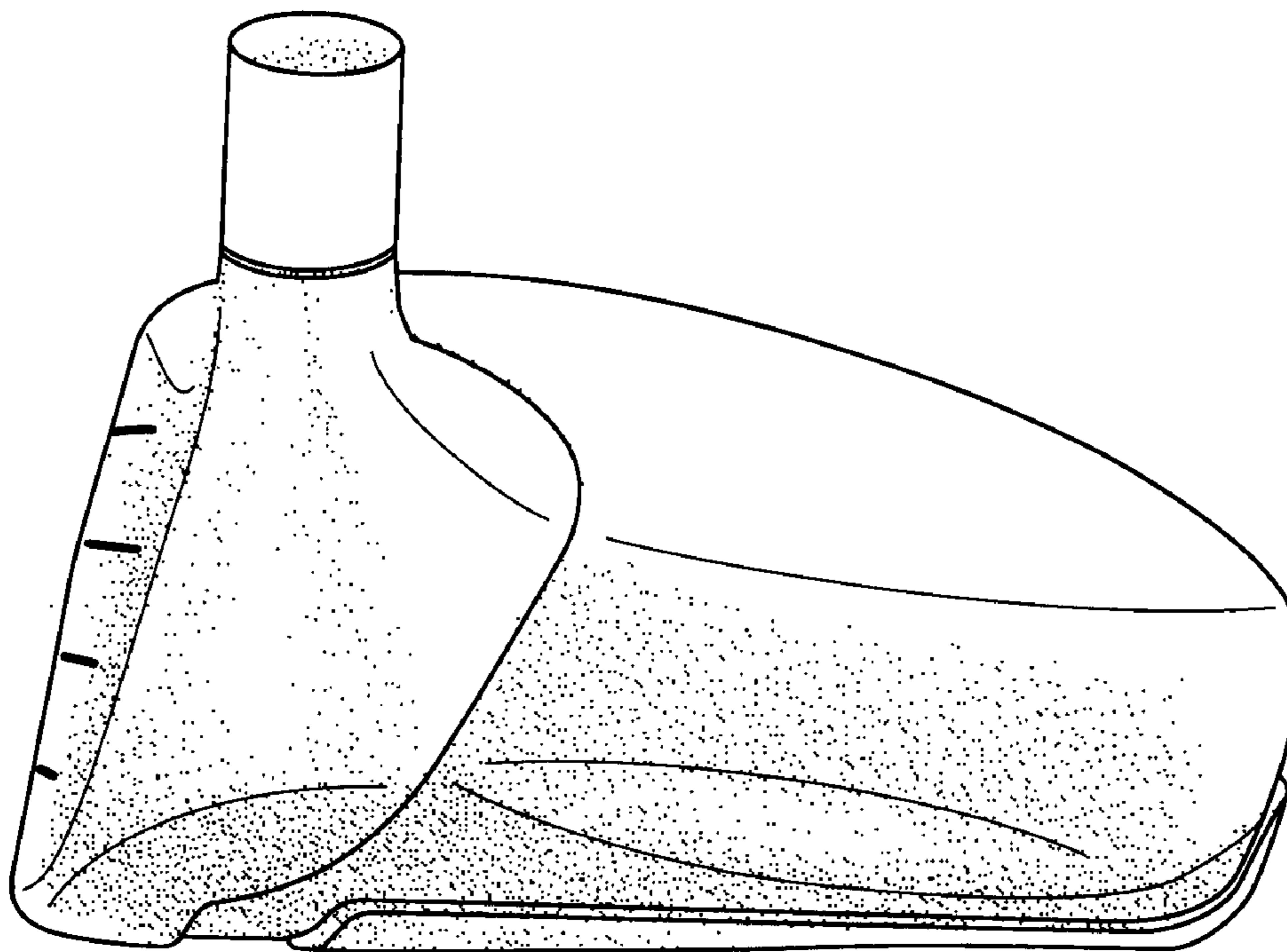

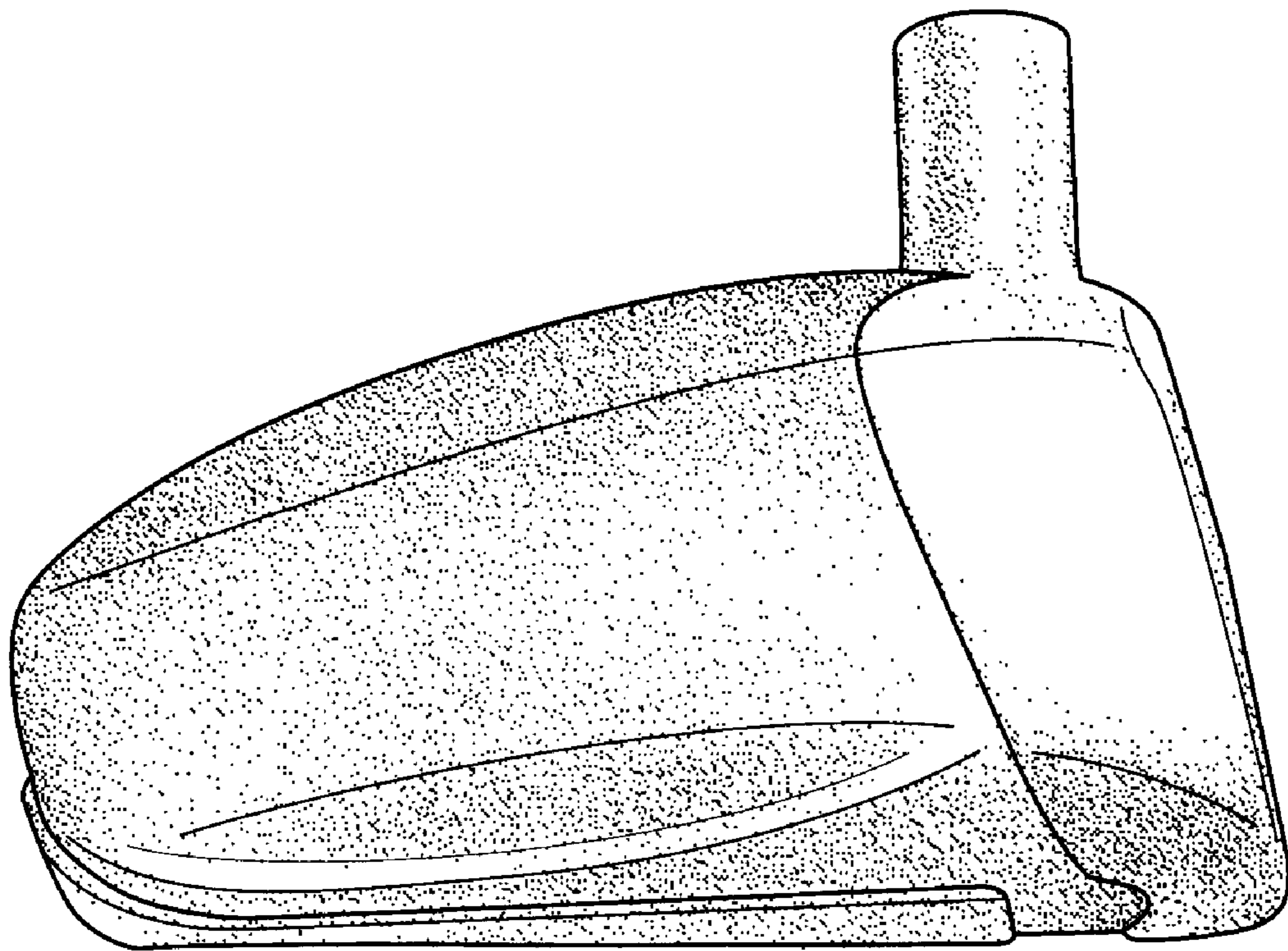

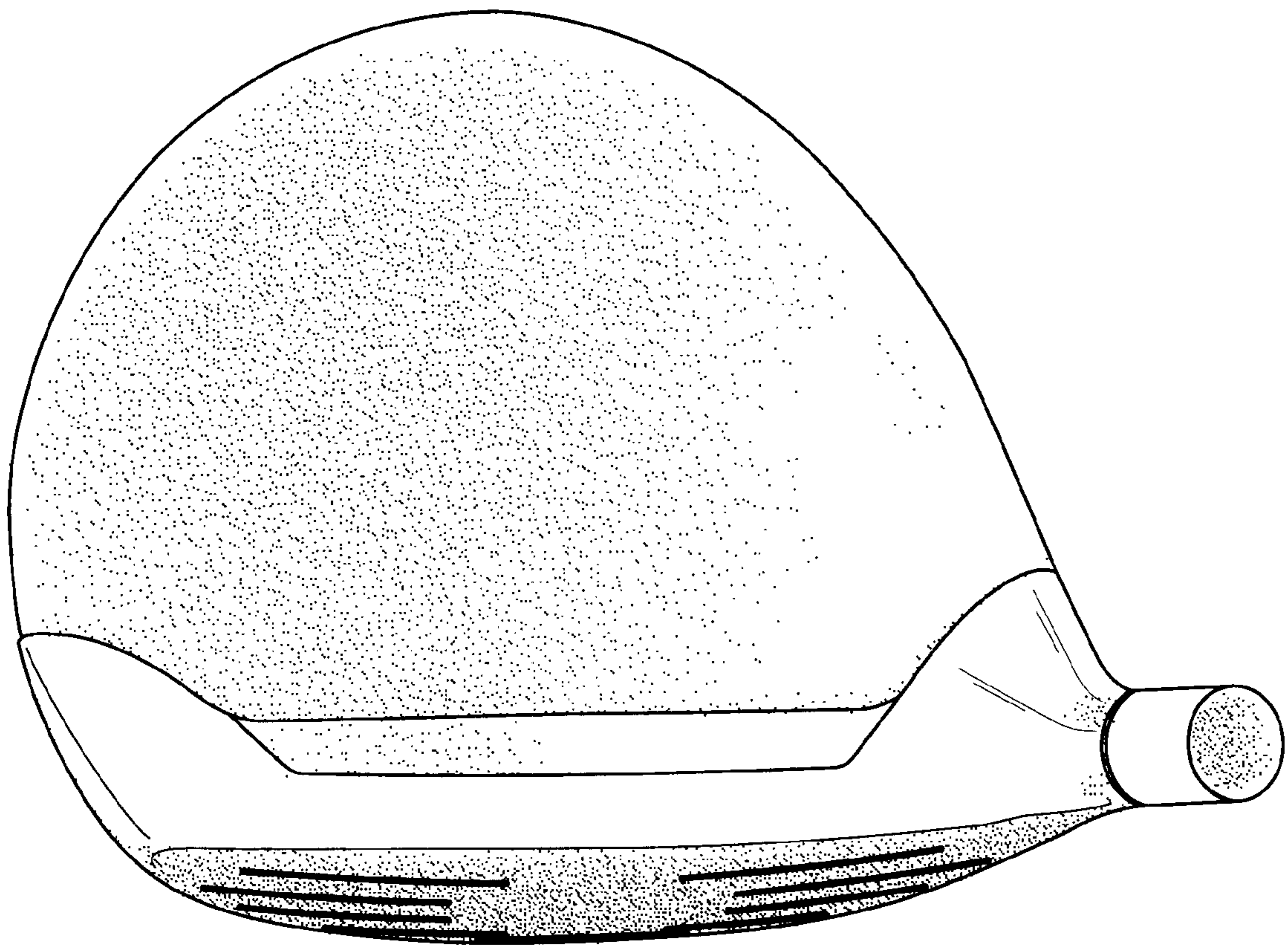

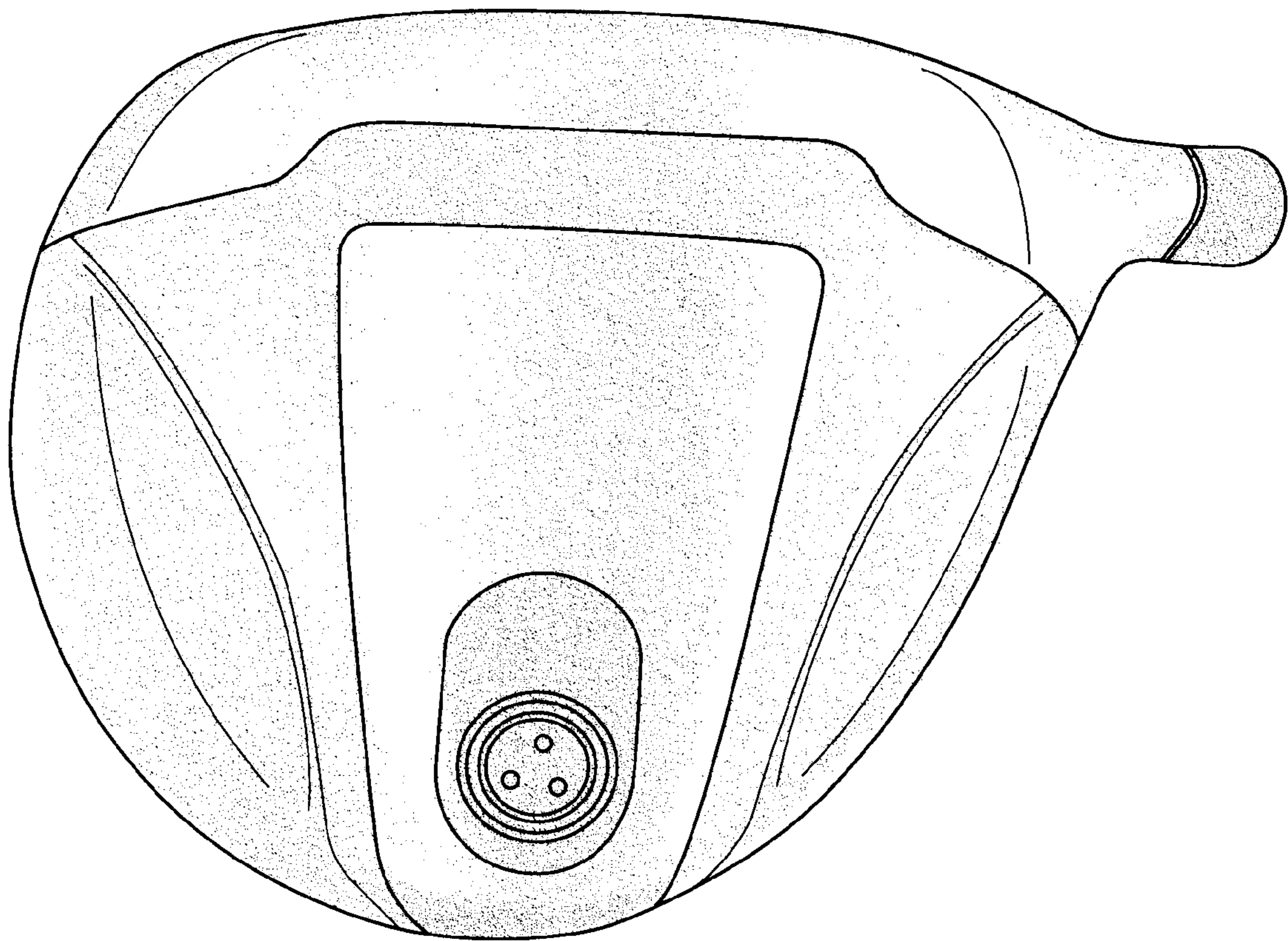

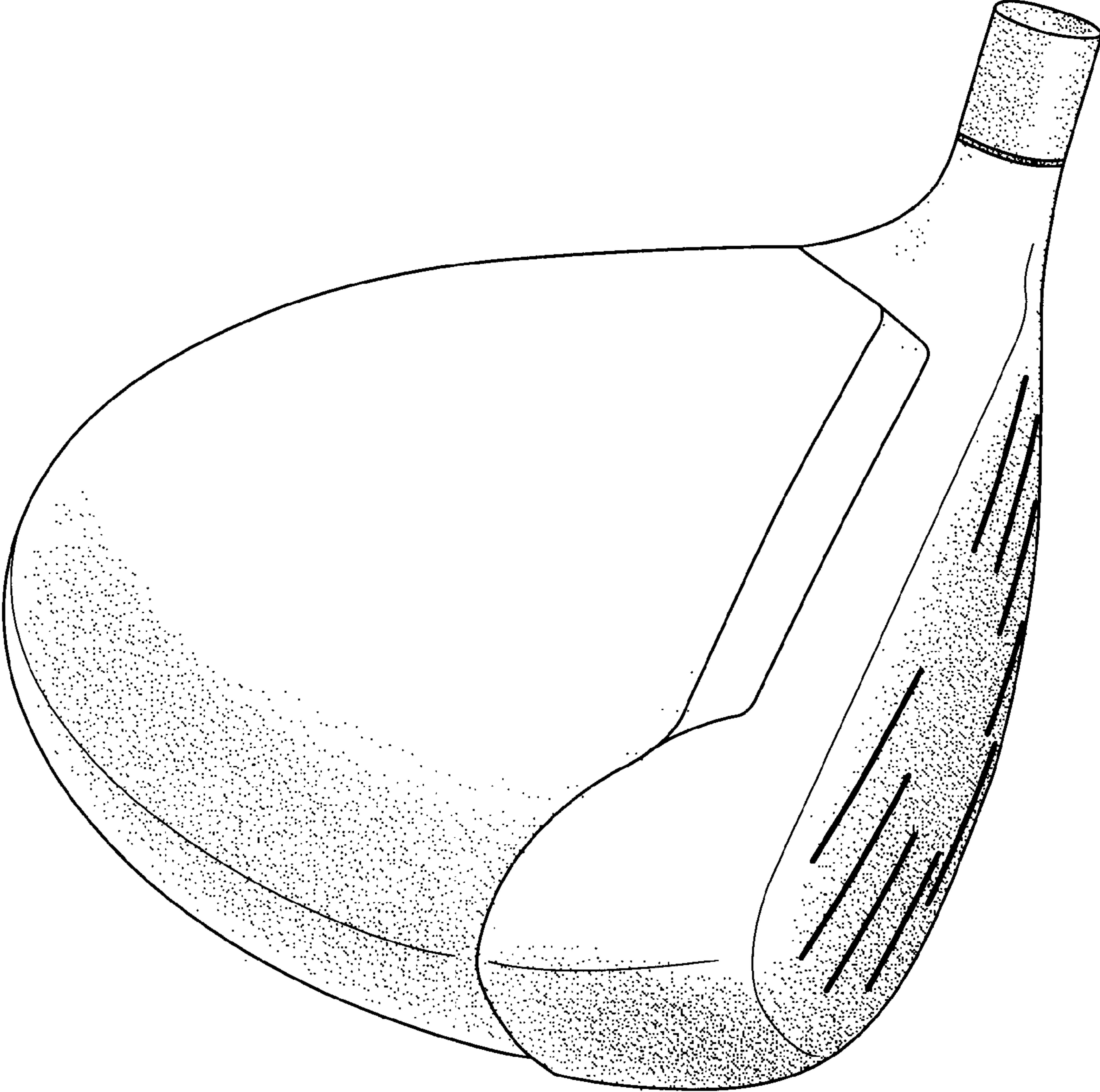

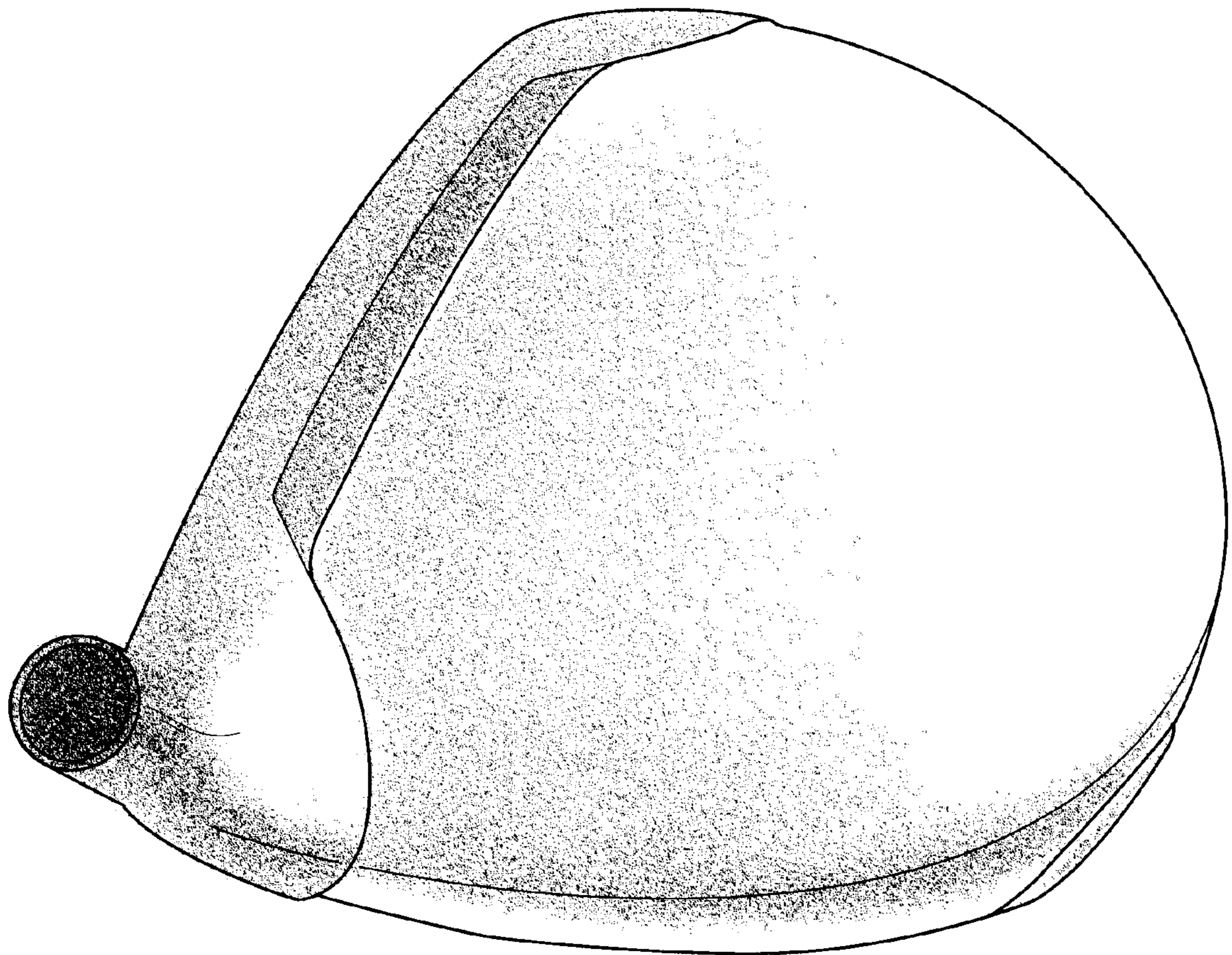

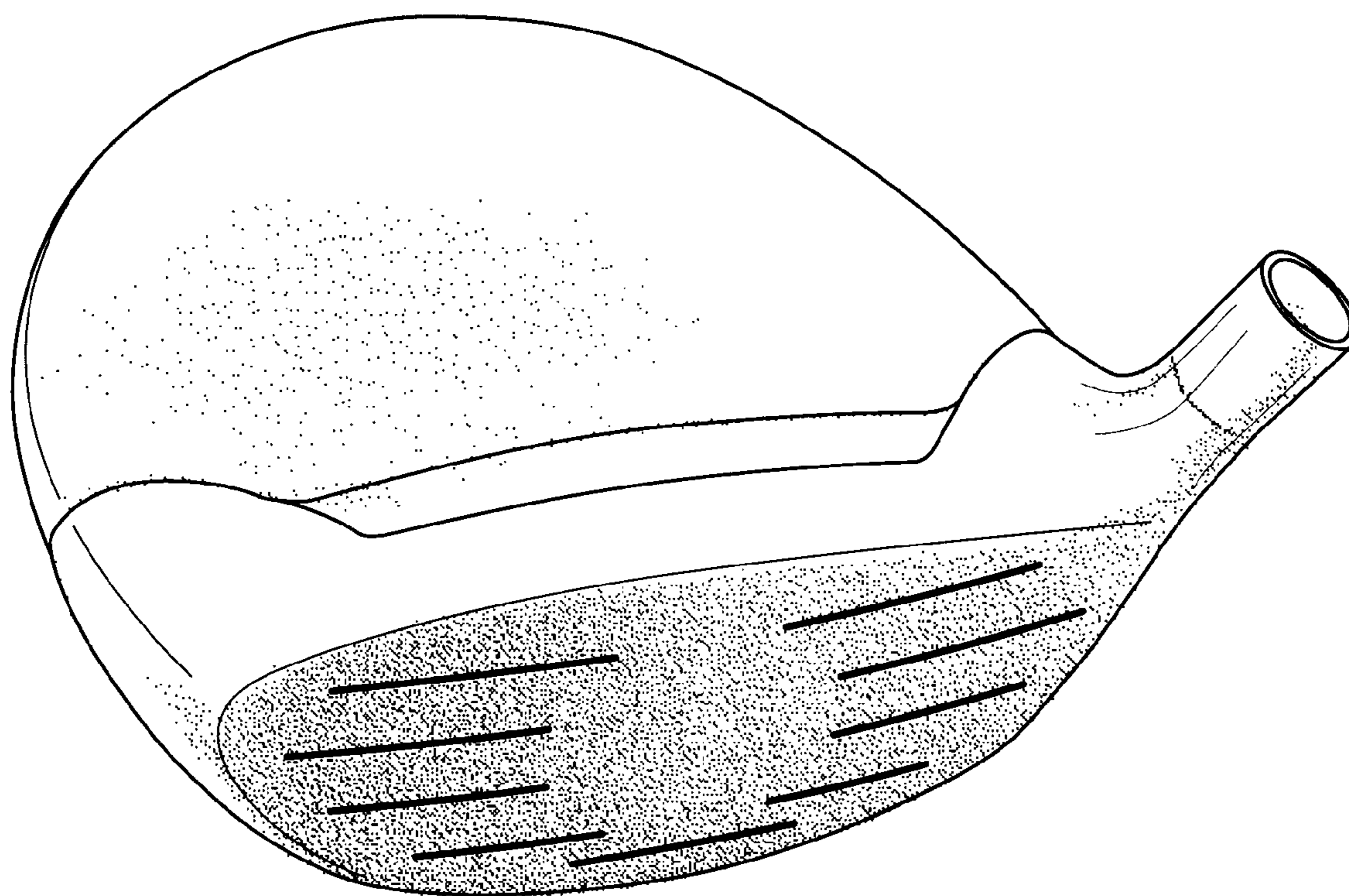

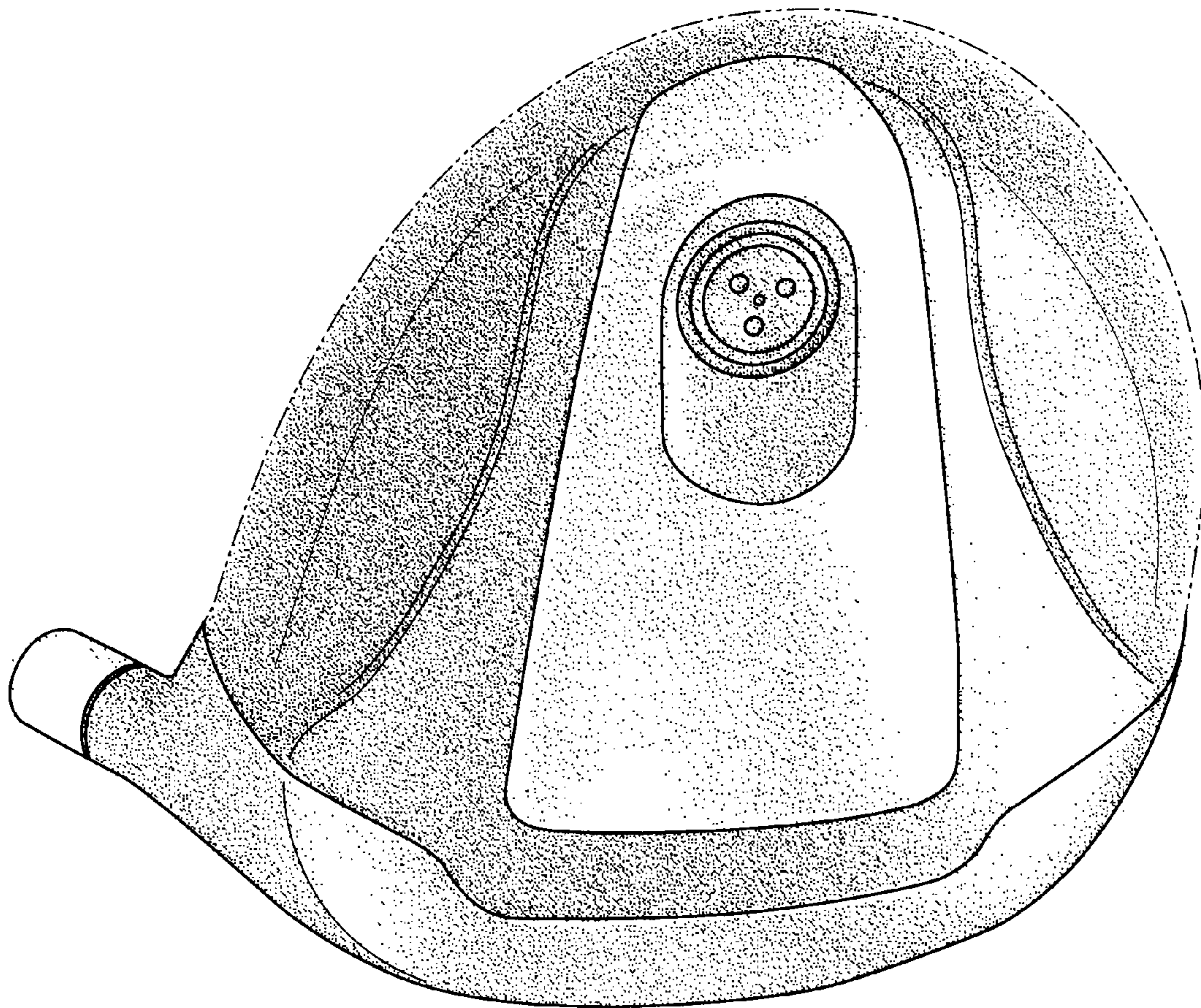

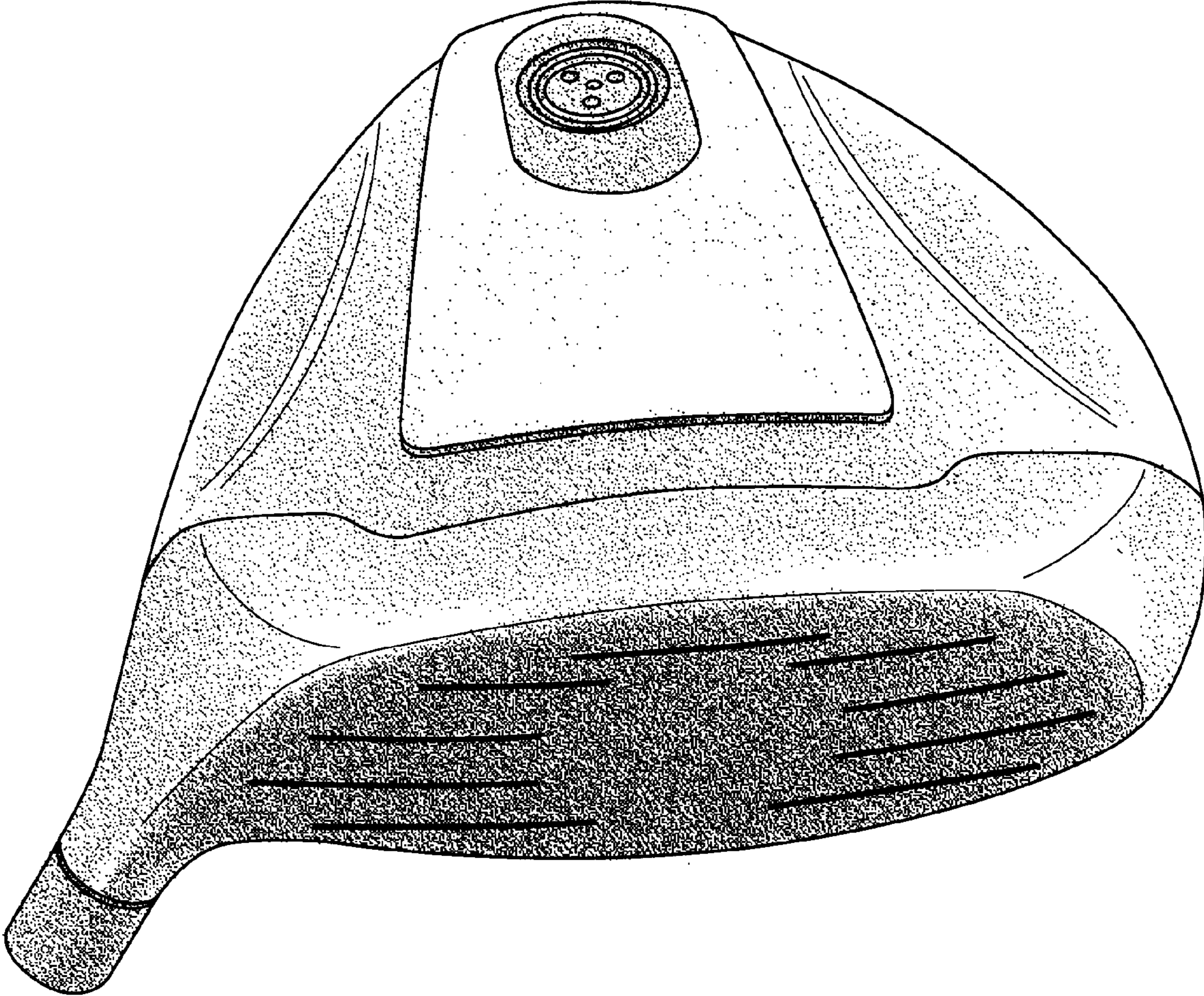

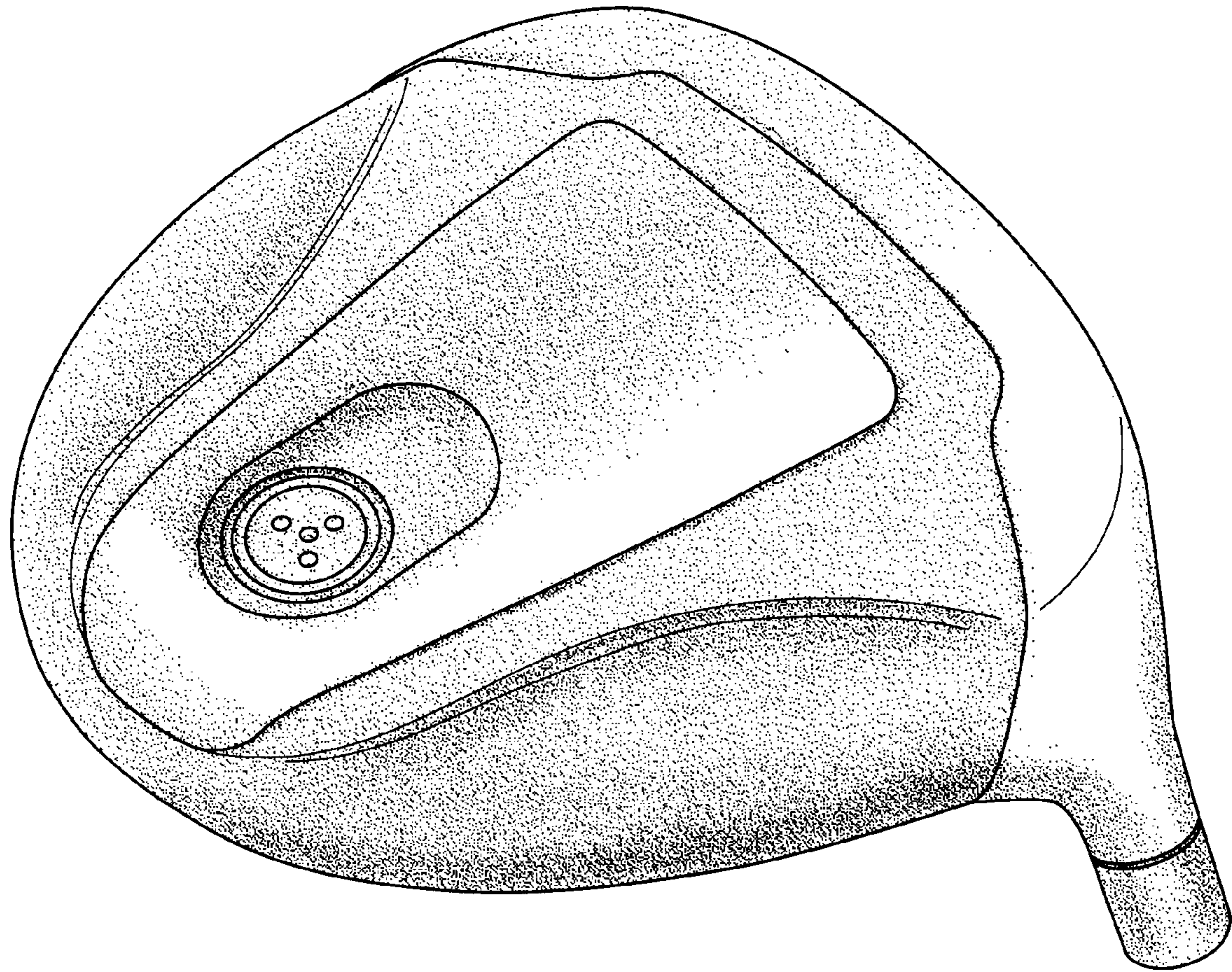

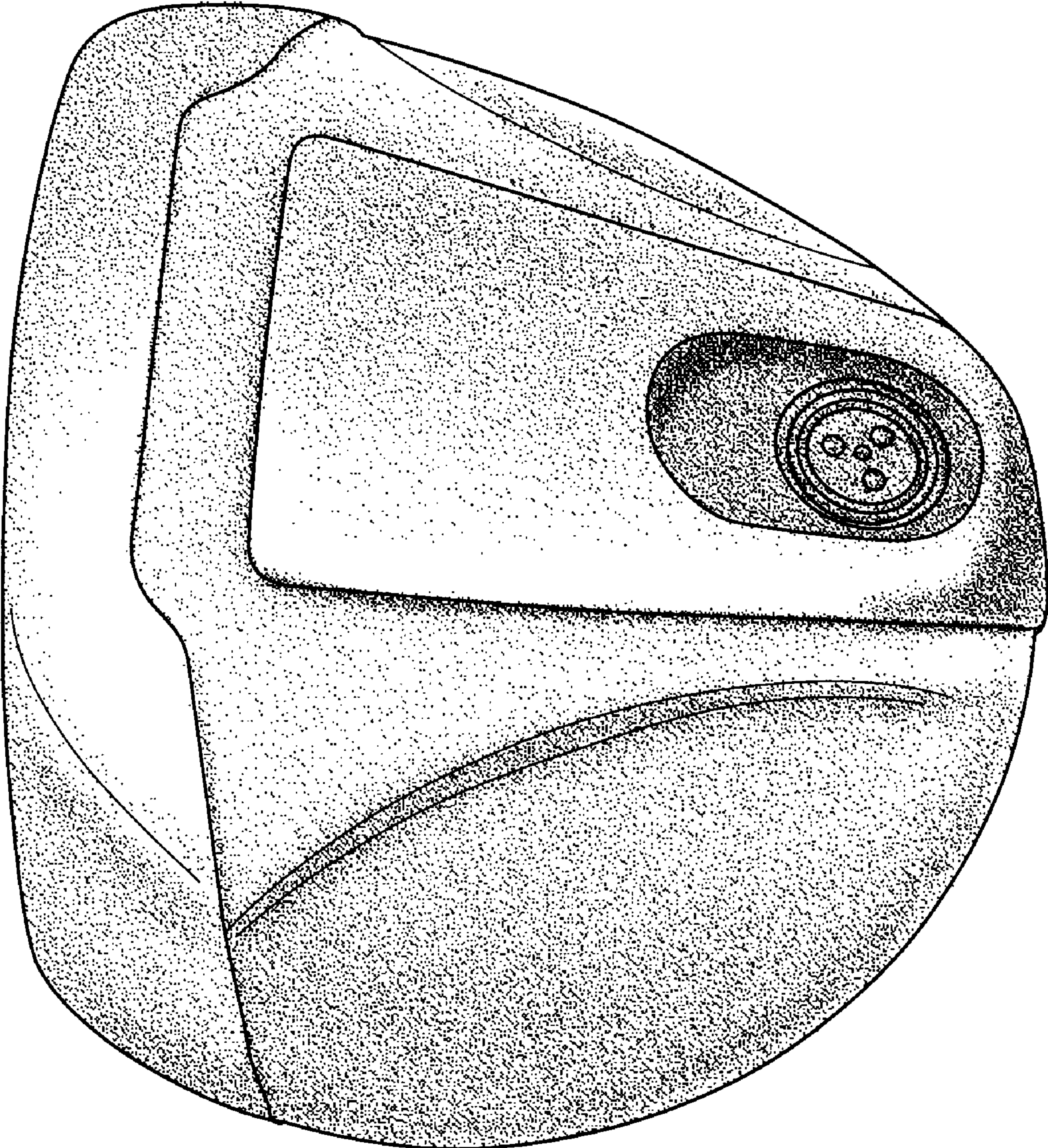
