(57) **CLAIM**

The ornamental design for a fishing reel as shown and described.

**DESCRIPTION**

FIG. 1 is a front side view of a fishing reel in accordance with my new design;

FIG. 2 is a rear side view of the fishing reel in accordance with my new design;

FIG. 3 is a top plan view of the fishing reel in accordance with my new design;

FIG. 4 is a bottom plan view of the fishing reel in accordance with my new design;

FIG. 5 is a left side view of the fishing reel in accordance with my new design;

FIG. 6 is a right side view of the fishing reel in accordance with my new design;

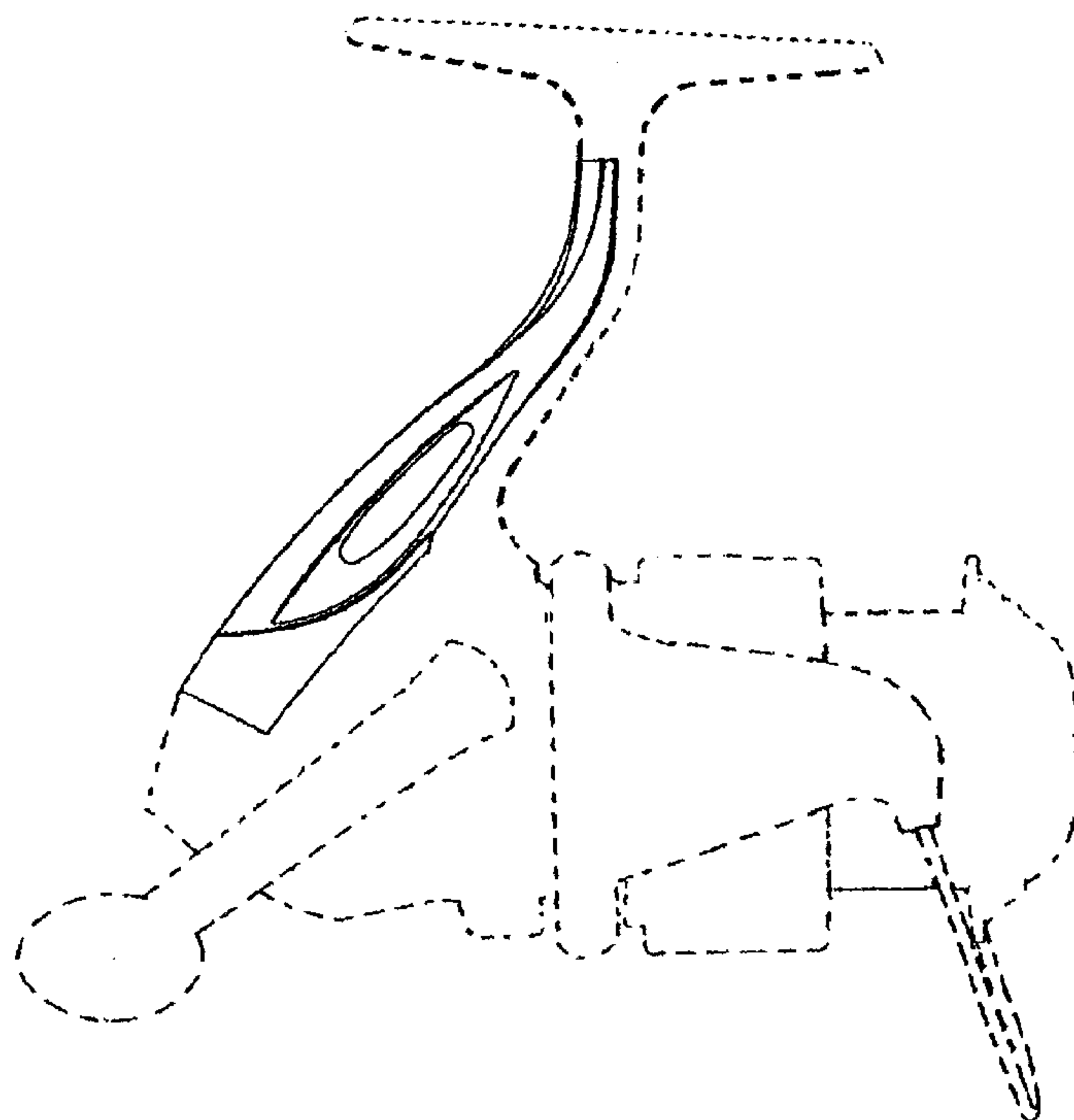
FIG. 7 is a top-front side perspective view of the fishing reel in accordance with my new design;

FIG. 8 is a bottom-rear side perspective view of the fishing reel in accordance with my new design; and,

FIG. 9 is a cross sectional view of the leg portion of the fishing reel in accordance with my new design, as viewed along the line 9—9 in FIG. 6 .

The broken line showing the environment (the remaining structure of the fishing reel) in the Figures is for illustrative purposes only and forms no part of the claimed design. More specifically, parts of the fishing reel other than the leg portion are hereby disclaimed.

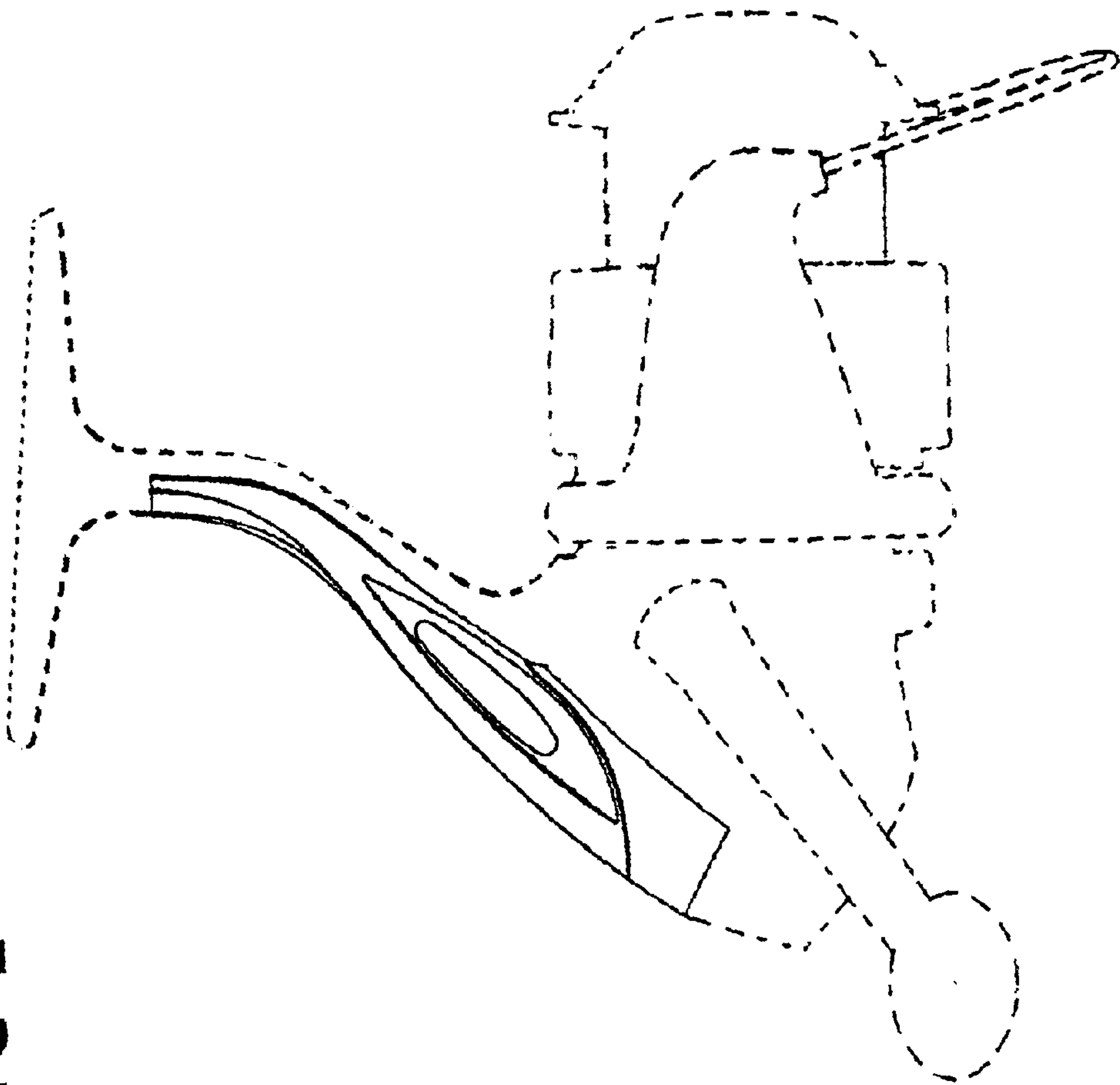

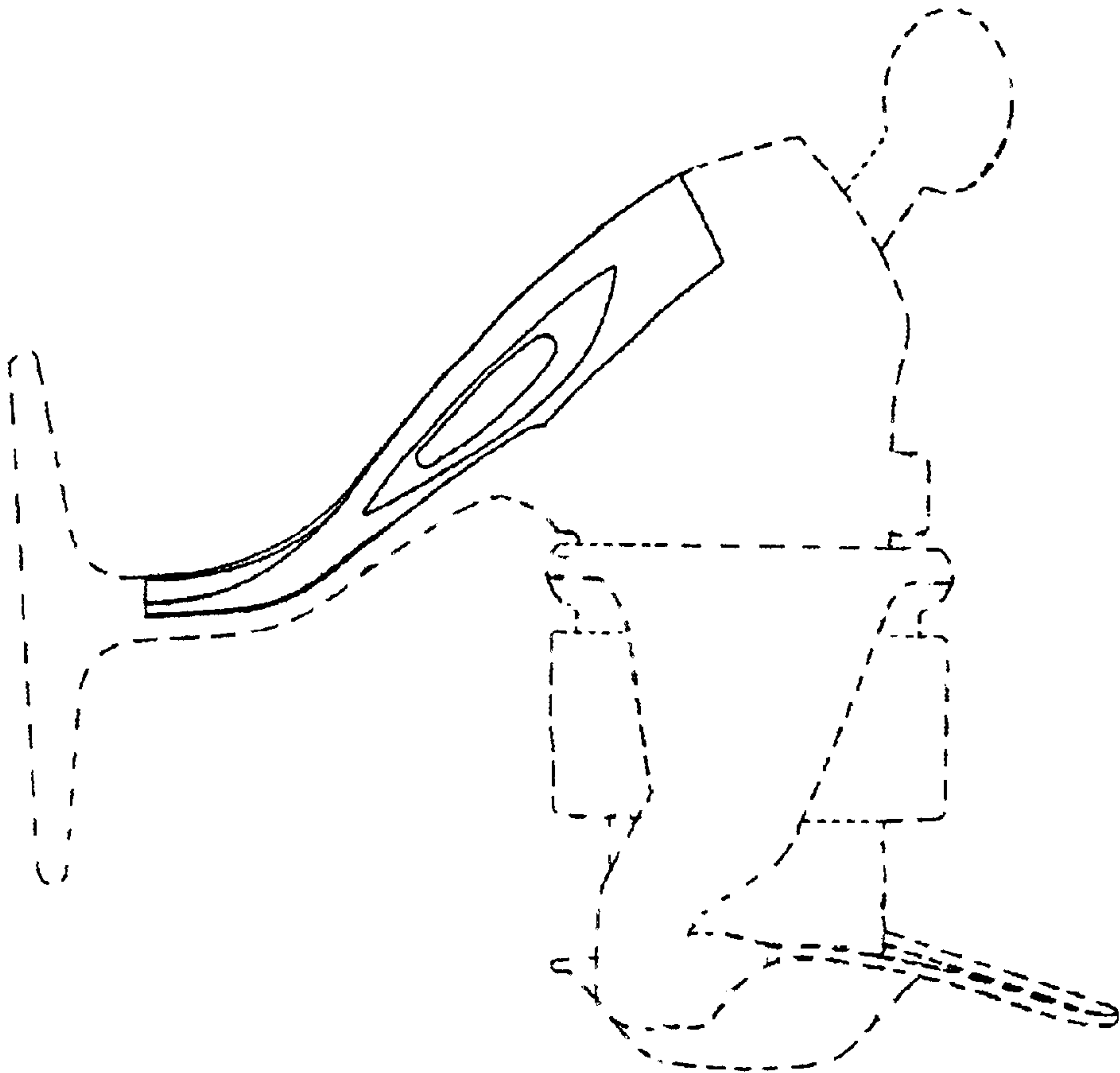
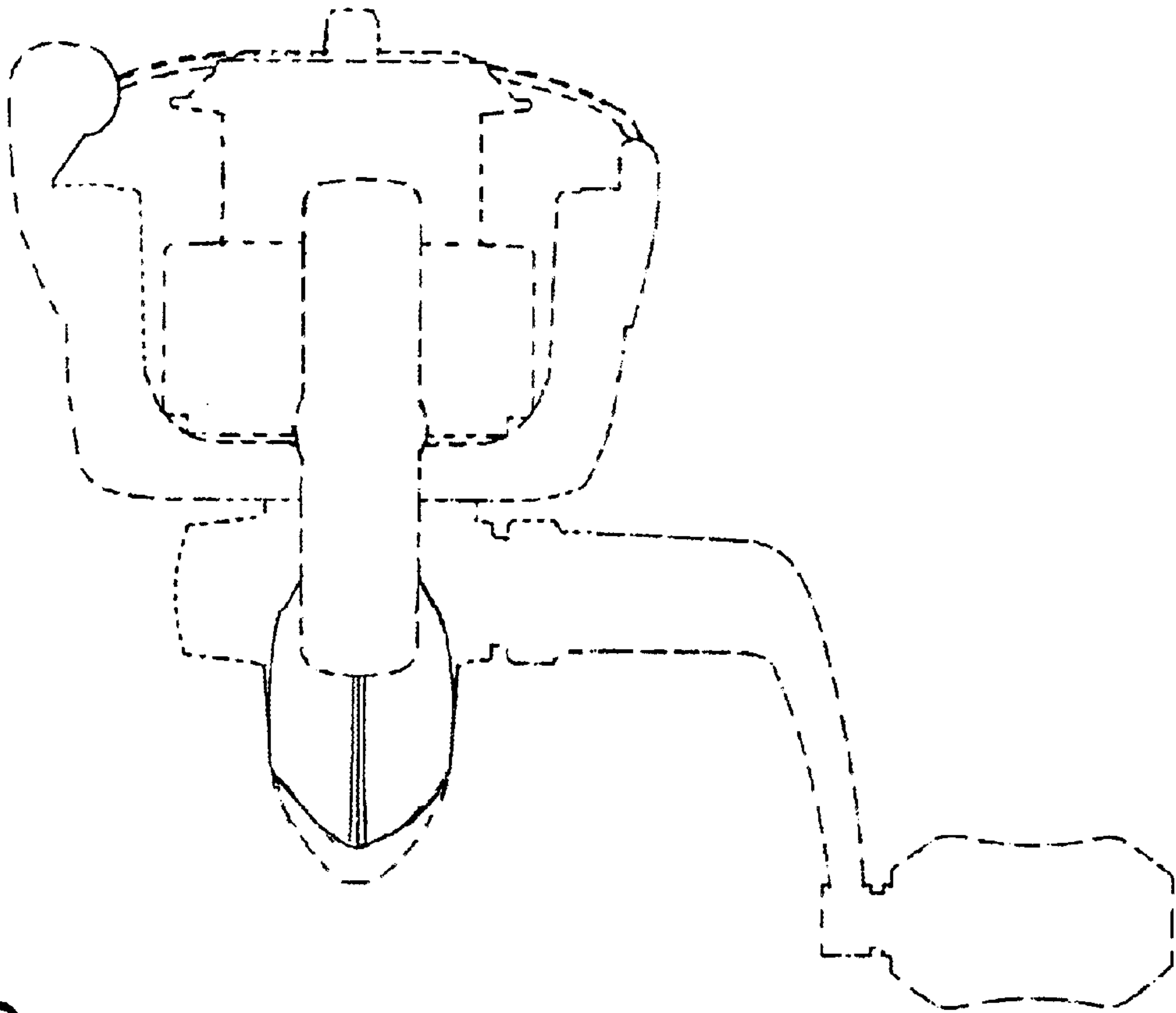

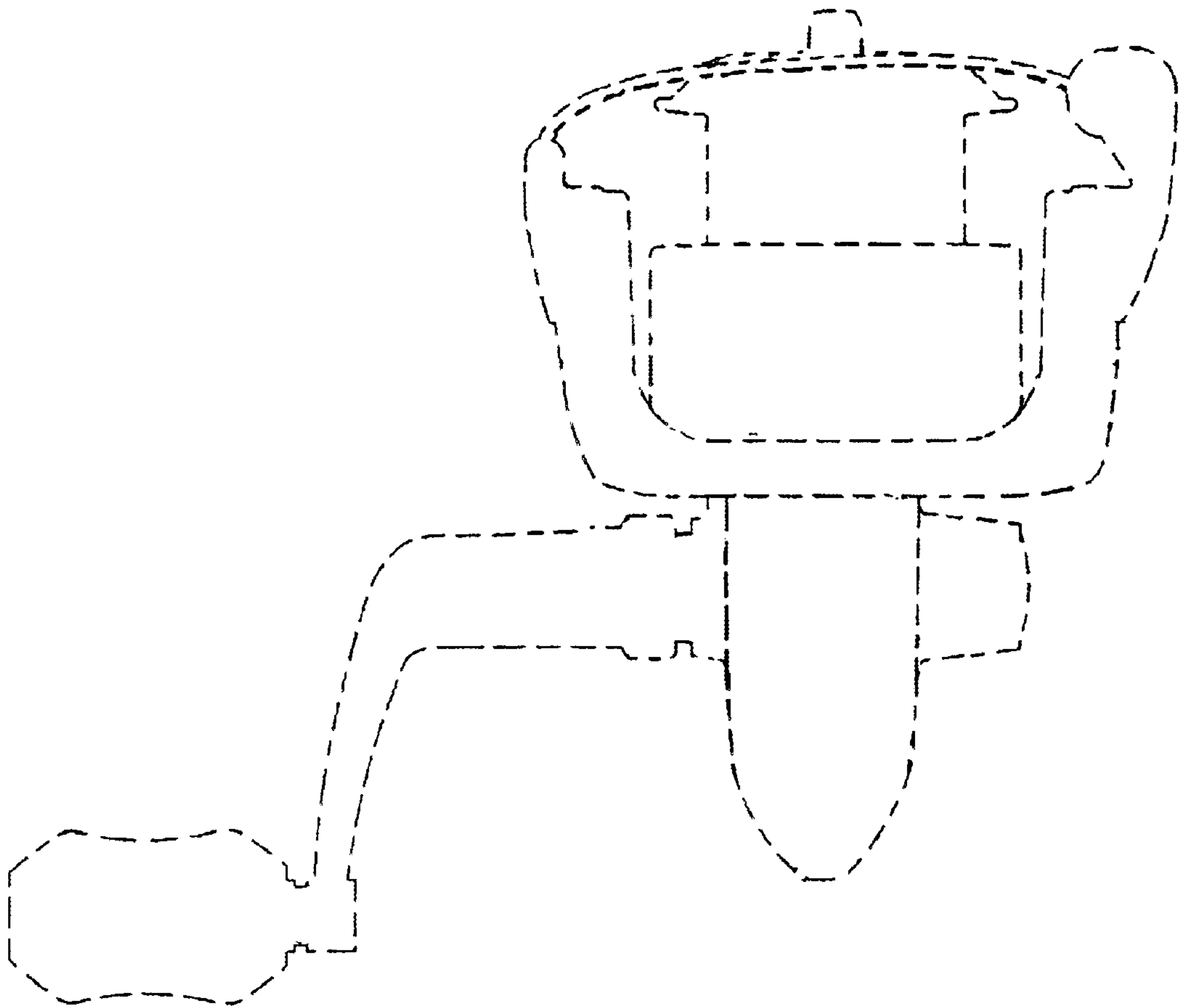

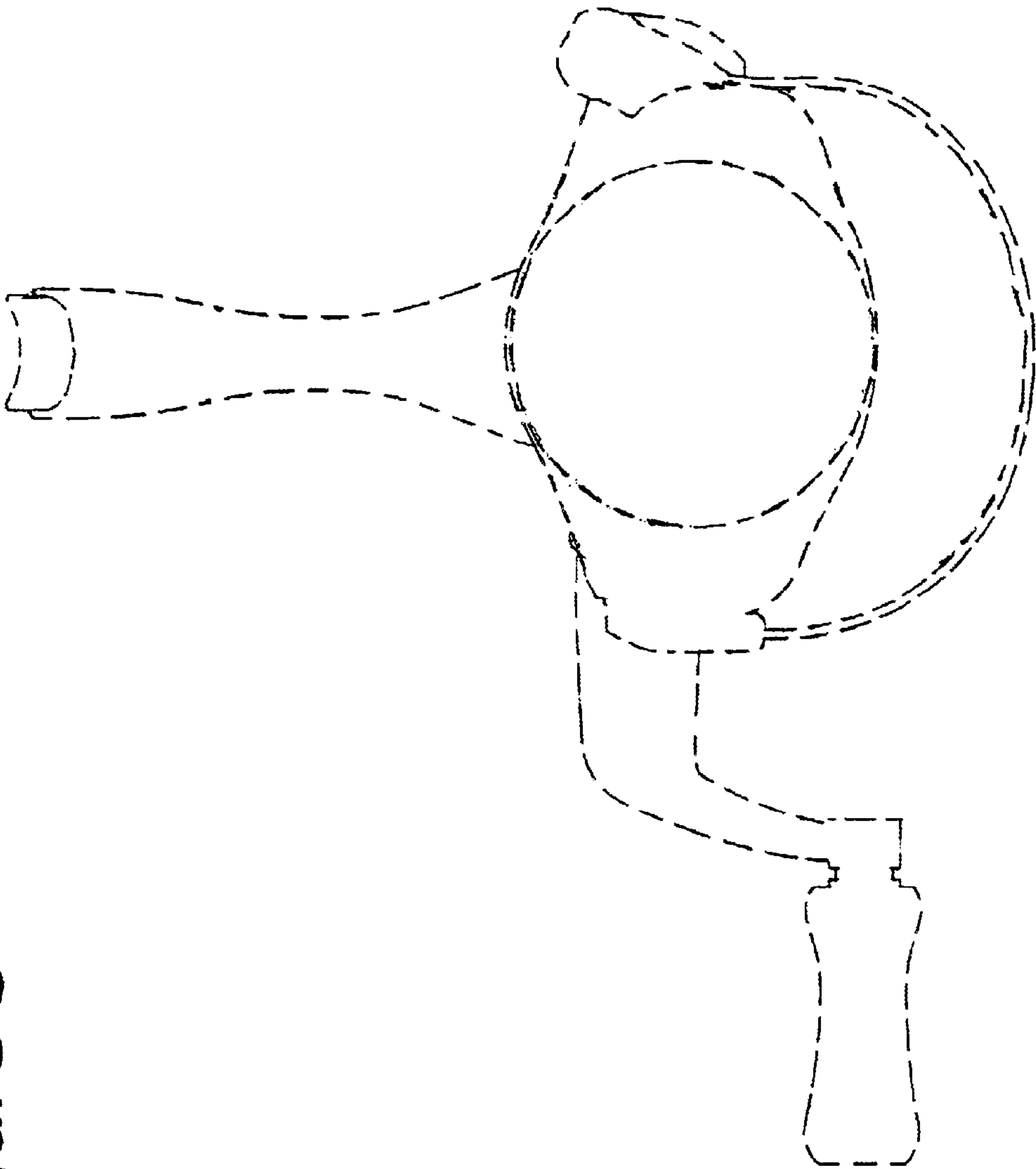

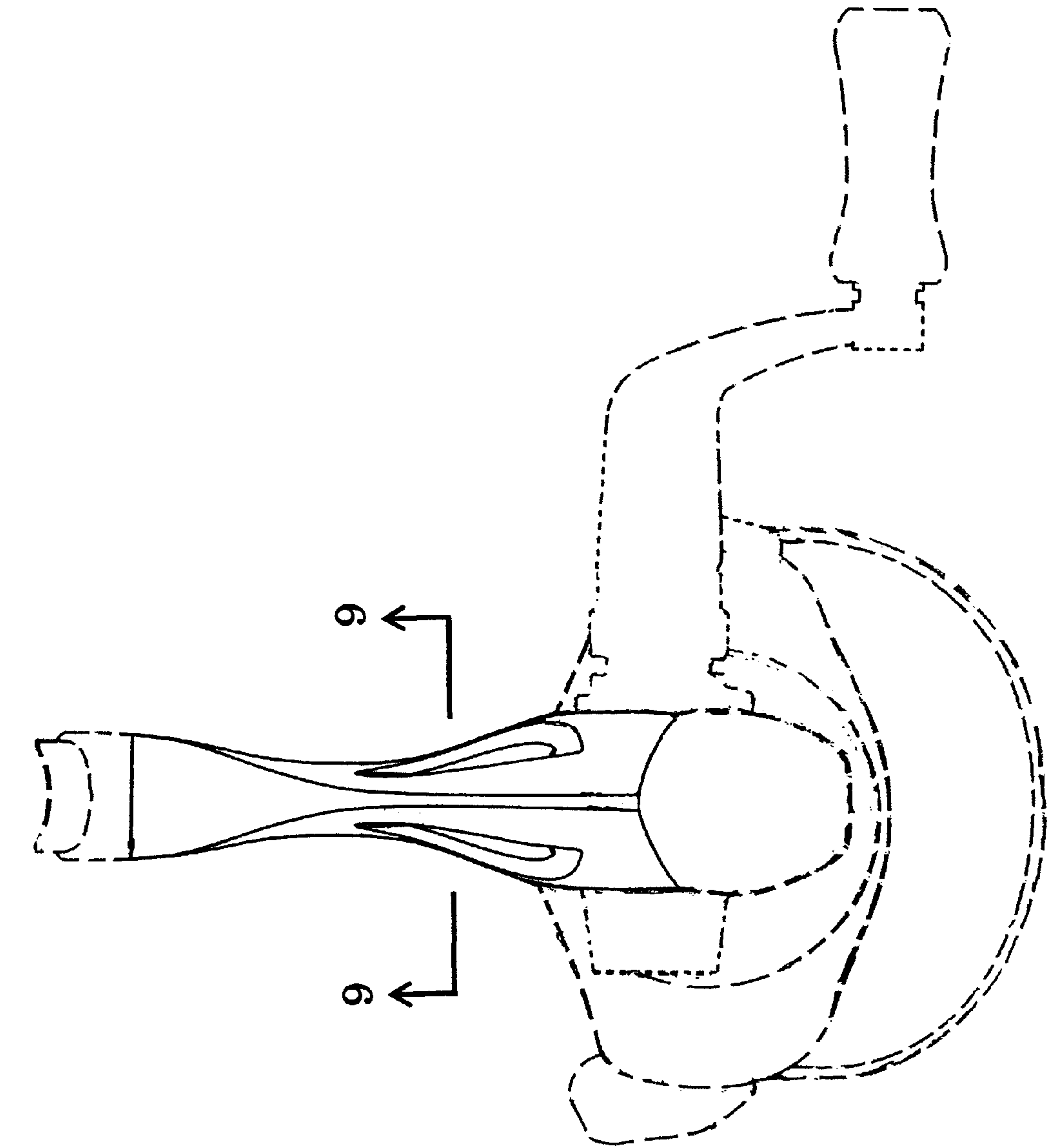
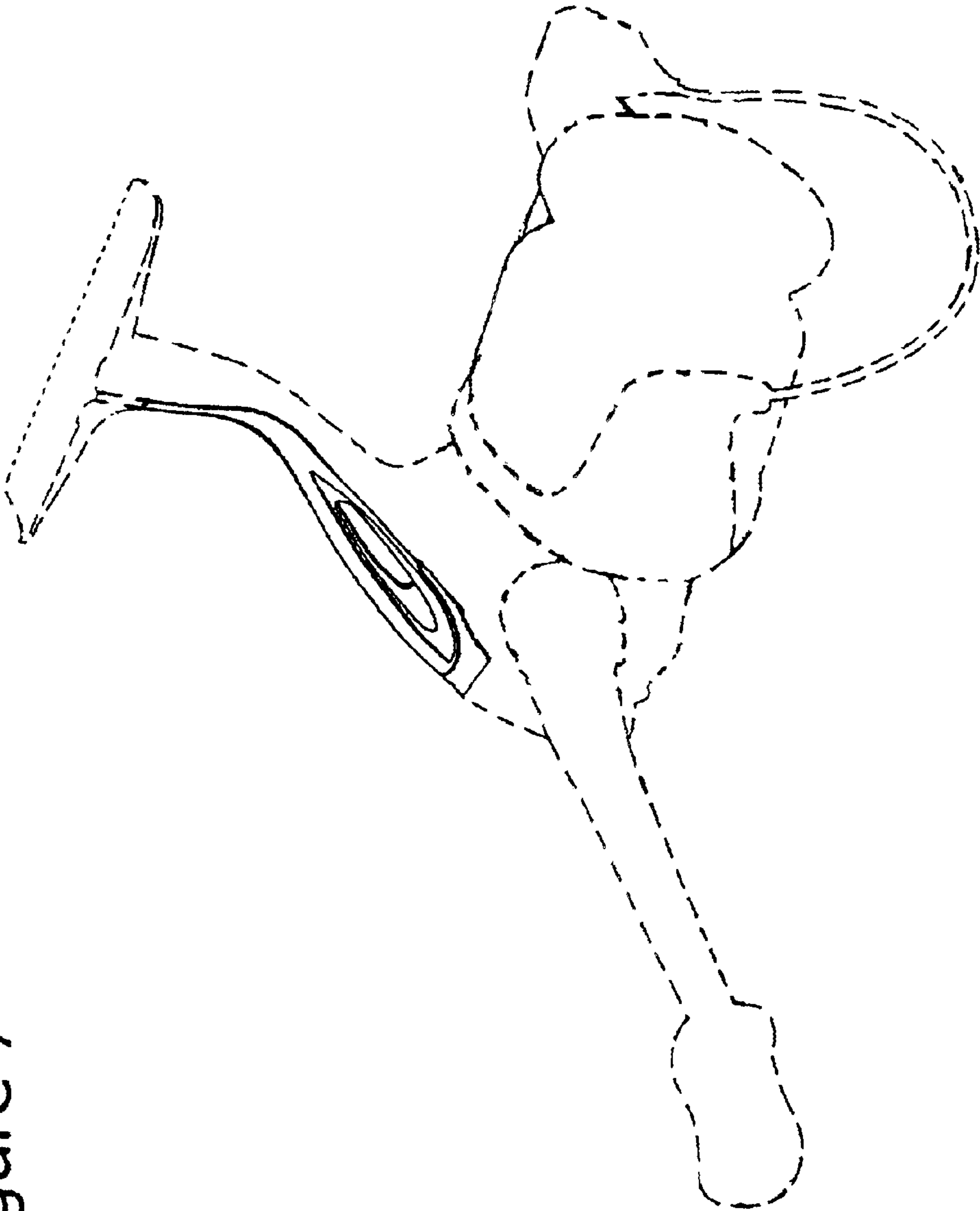

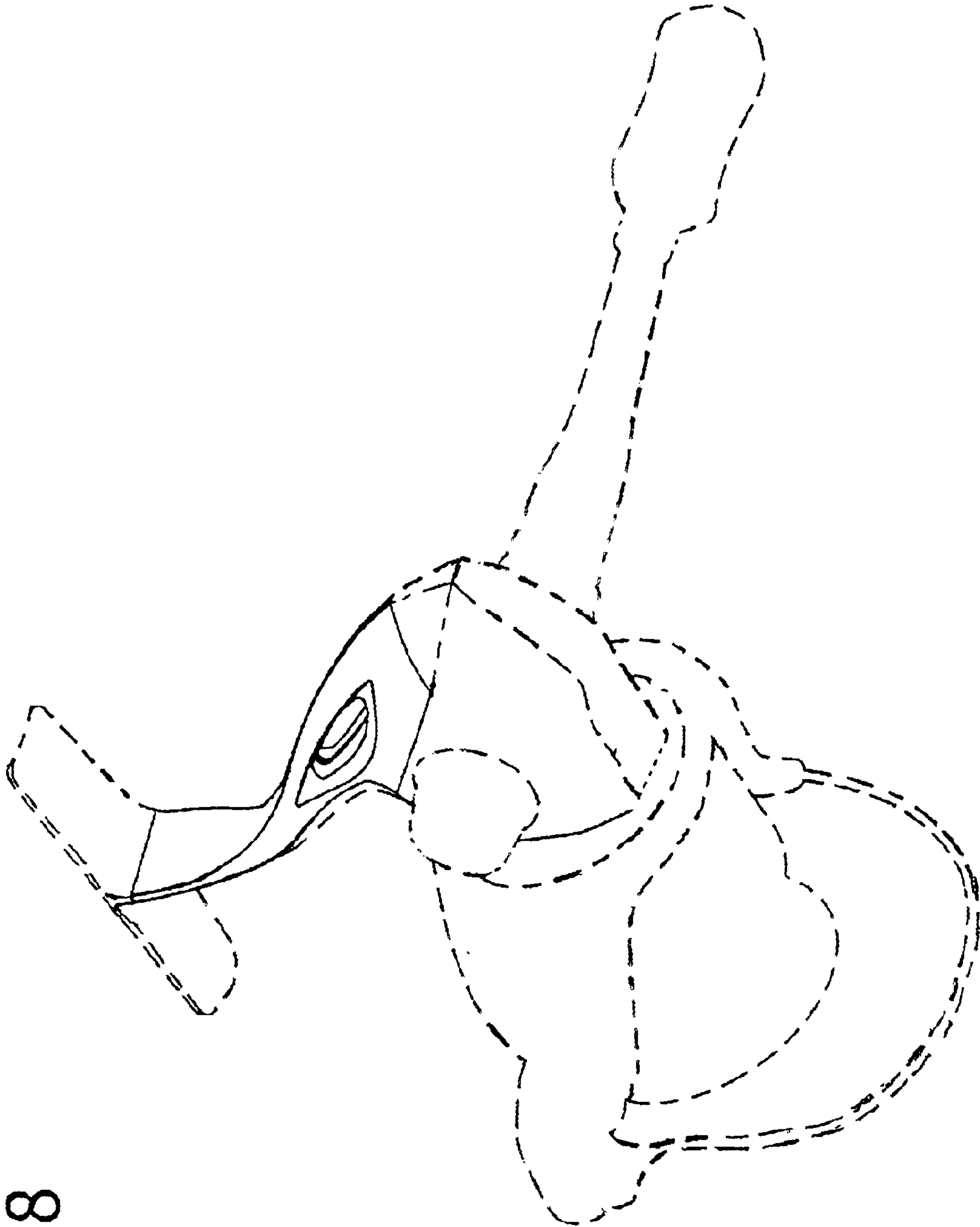
