DESCRIPTION

FIG. 1 is an upper perspective view of capsule in accordance with a first embodiment of my new design;

FIG. 4 is a top plan view thereof with a bottom plan view being identical, except for the color;

FIG. 5 is an upper perspective view of capsule in accordance with a second embodiment of my new design;


FIG. 6 is a front elevational view thereof, with a rear elevational view being identical;
















