**DESCRIPTION**

FIG. 1 is a black and white photograph illustrating a top perspective view of my new design; FIG. 2 is a black and white photograph illustrating a bottom plan view of my new design shown in FIG. 1 the top plan view being a mirror image thereof; FIG. 3 is a black and white photograph illustrating a bottom perspective view of my new design shown in FIG. 1; FIG. 4 is a black and white photograph illustrating a front elevation view of my new design shown in FIG. 1; and, FIG. 5 is a black and white photograph illustrating a rear elevation view of my new design shown in FIG. 1.

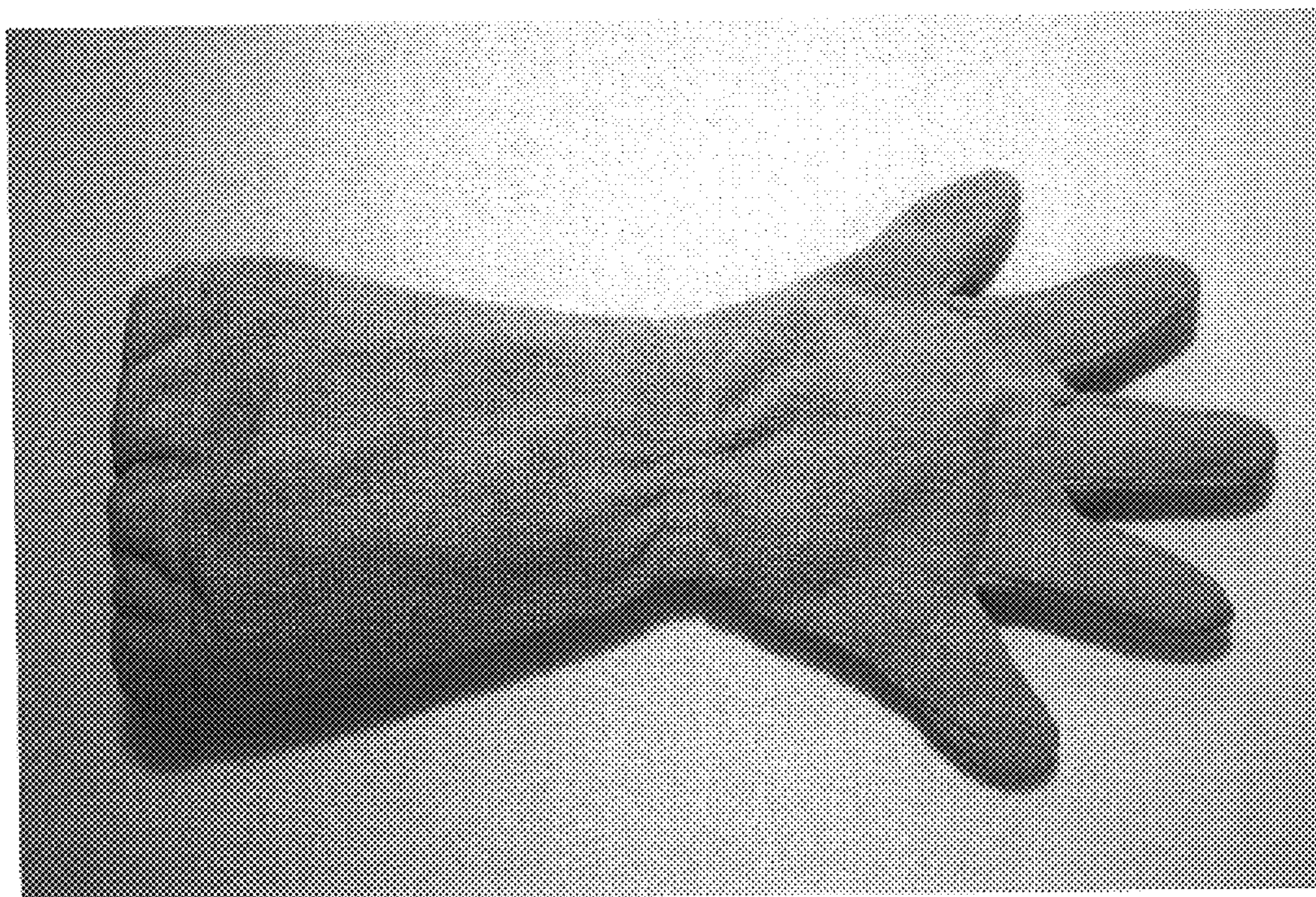

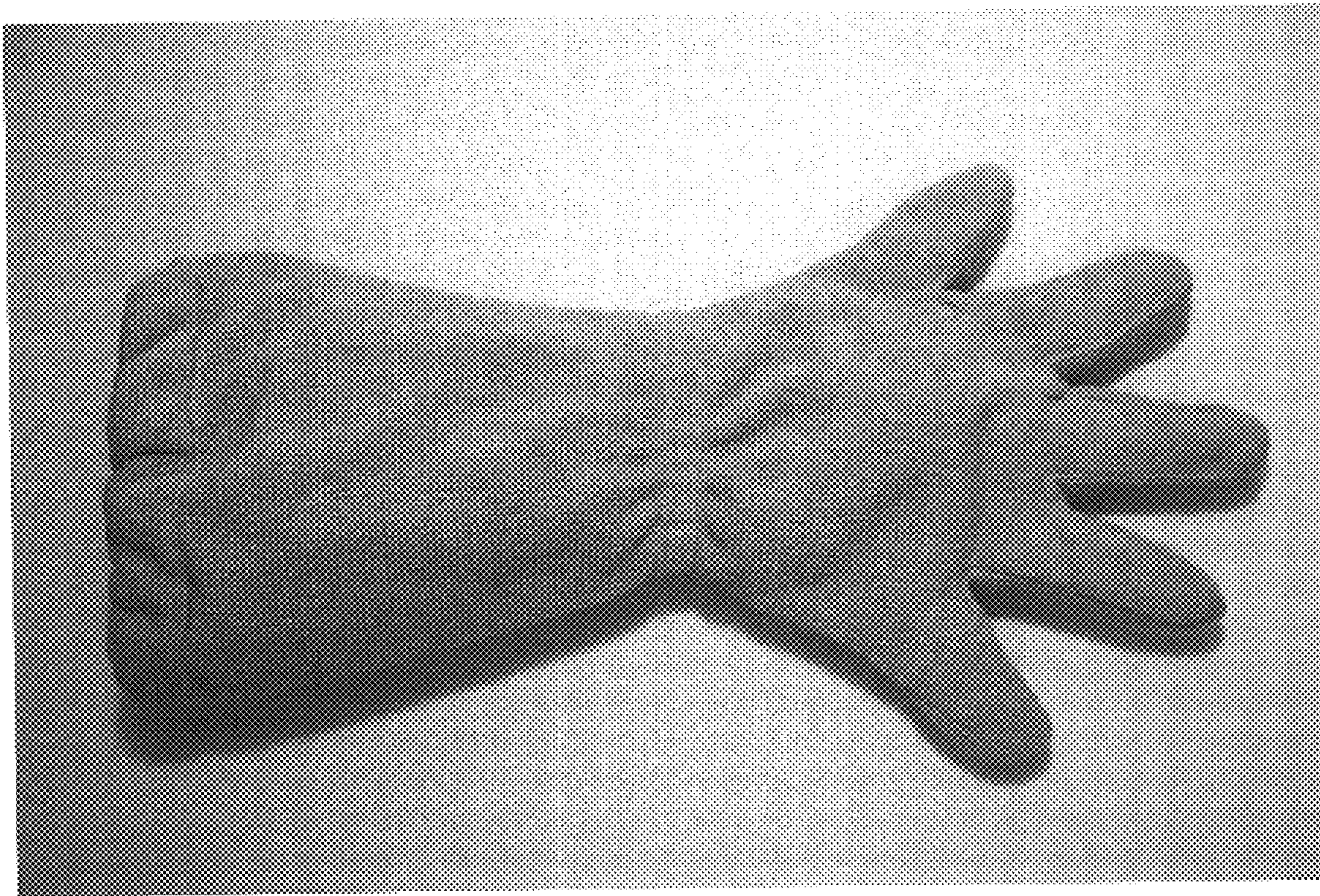

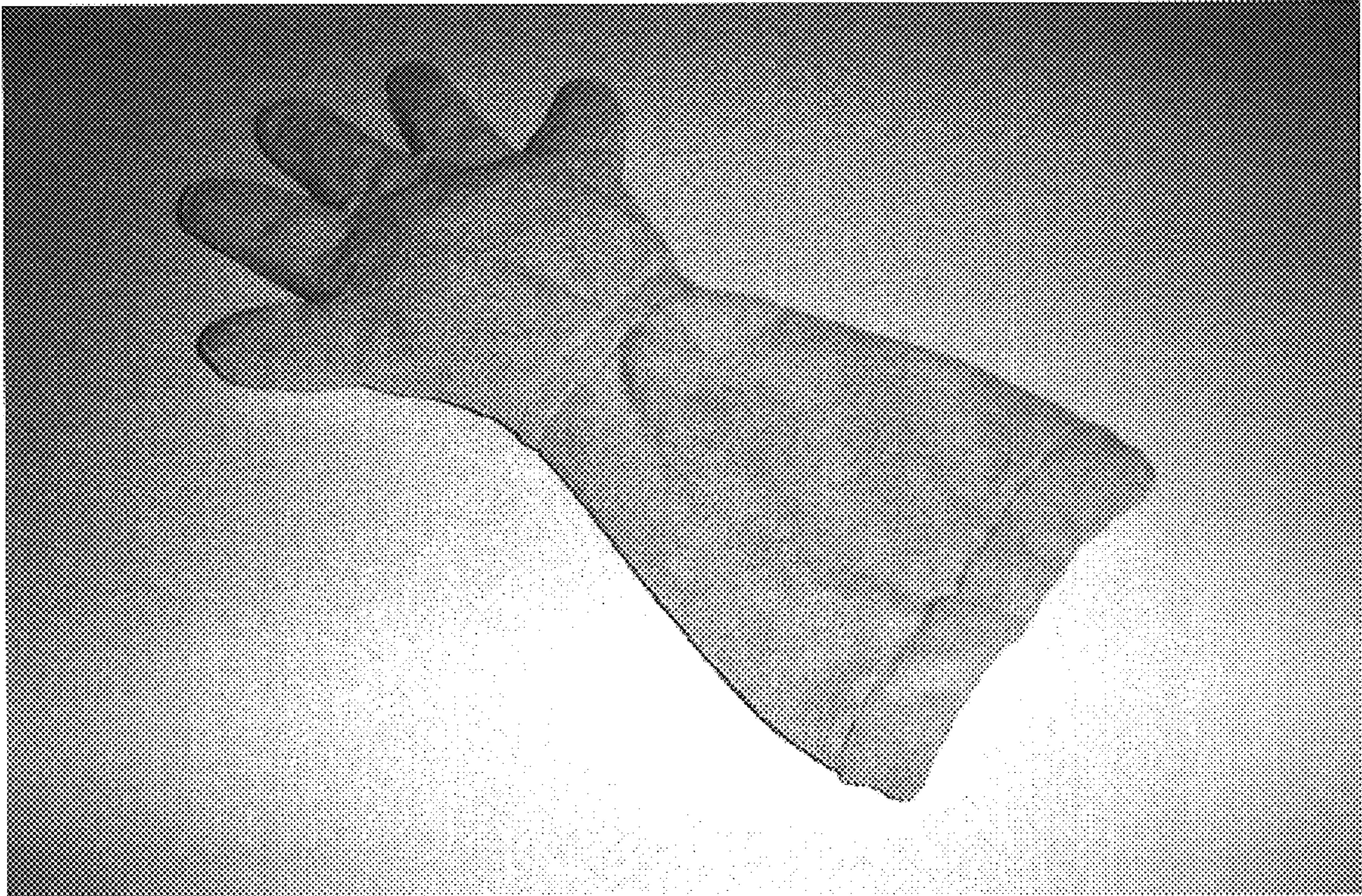

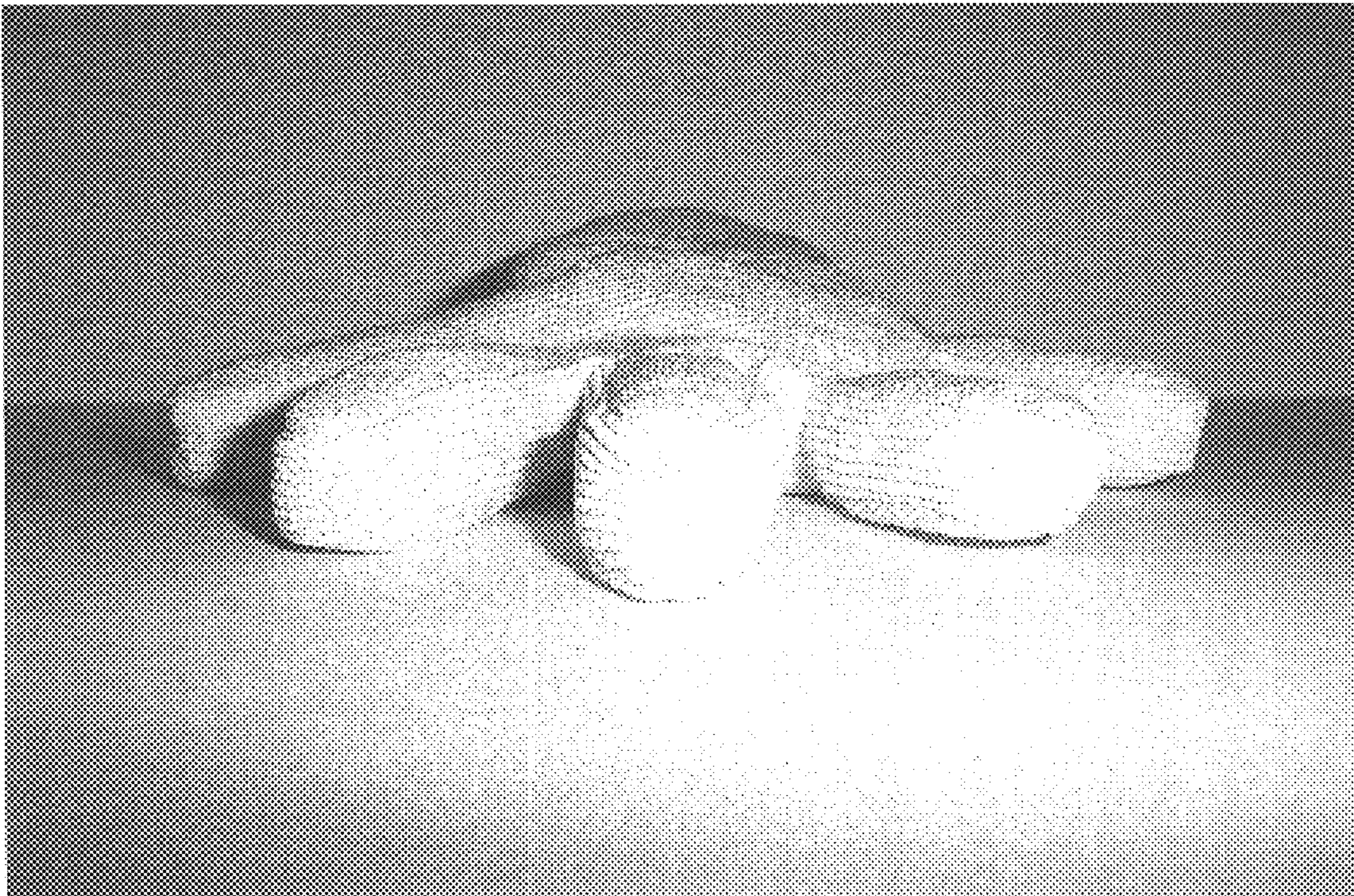

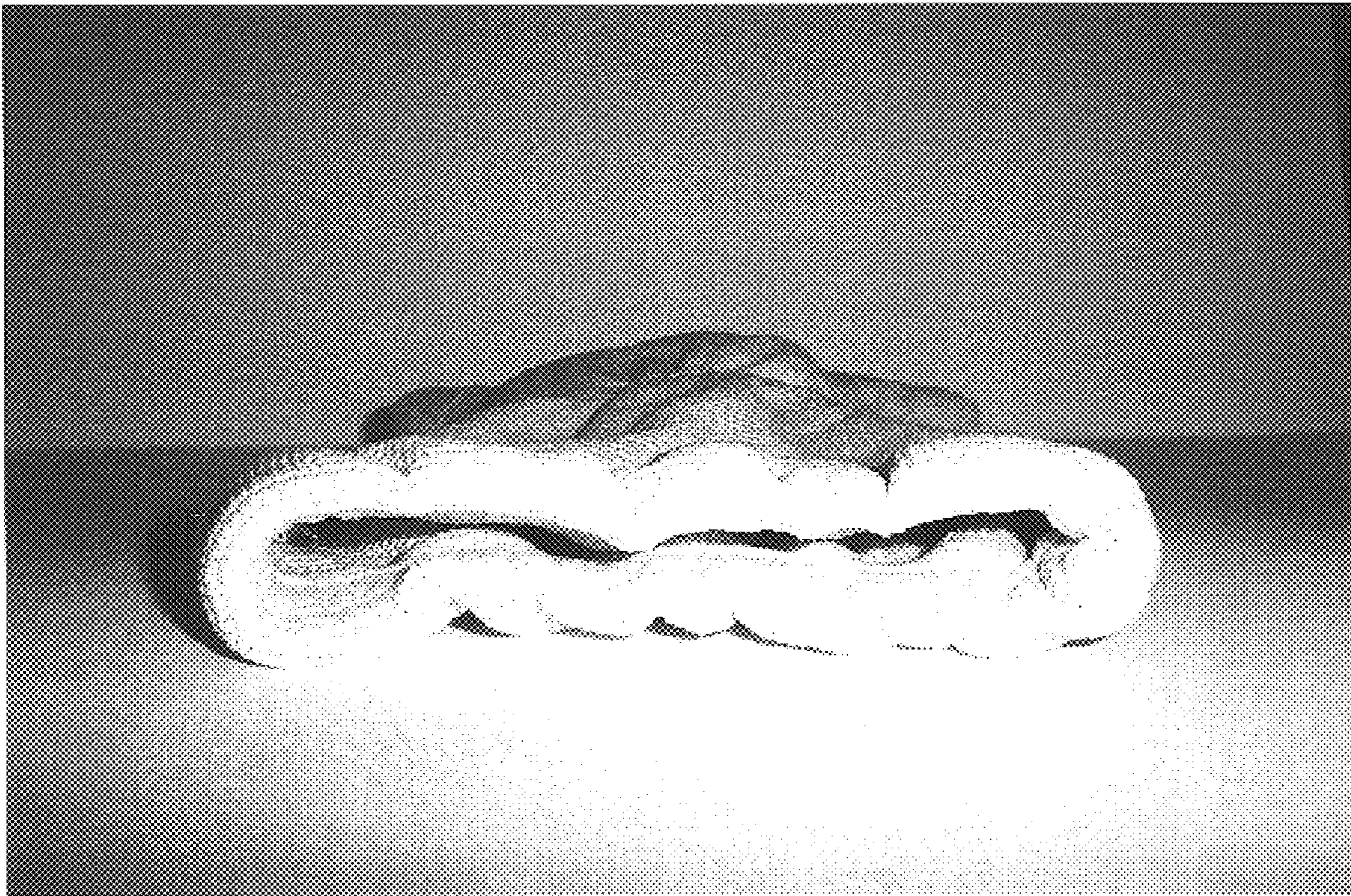
