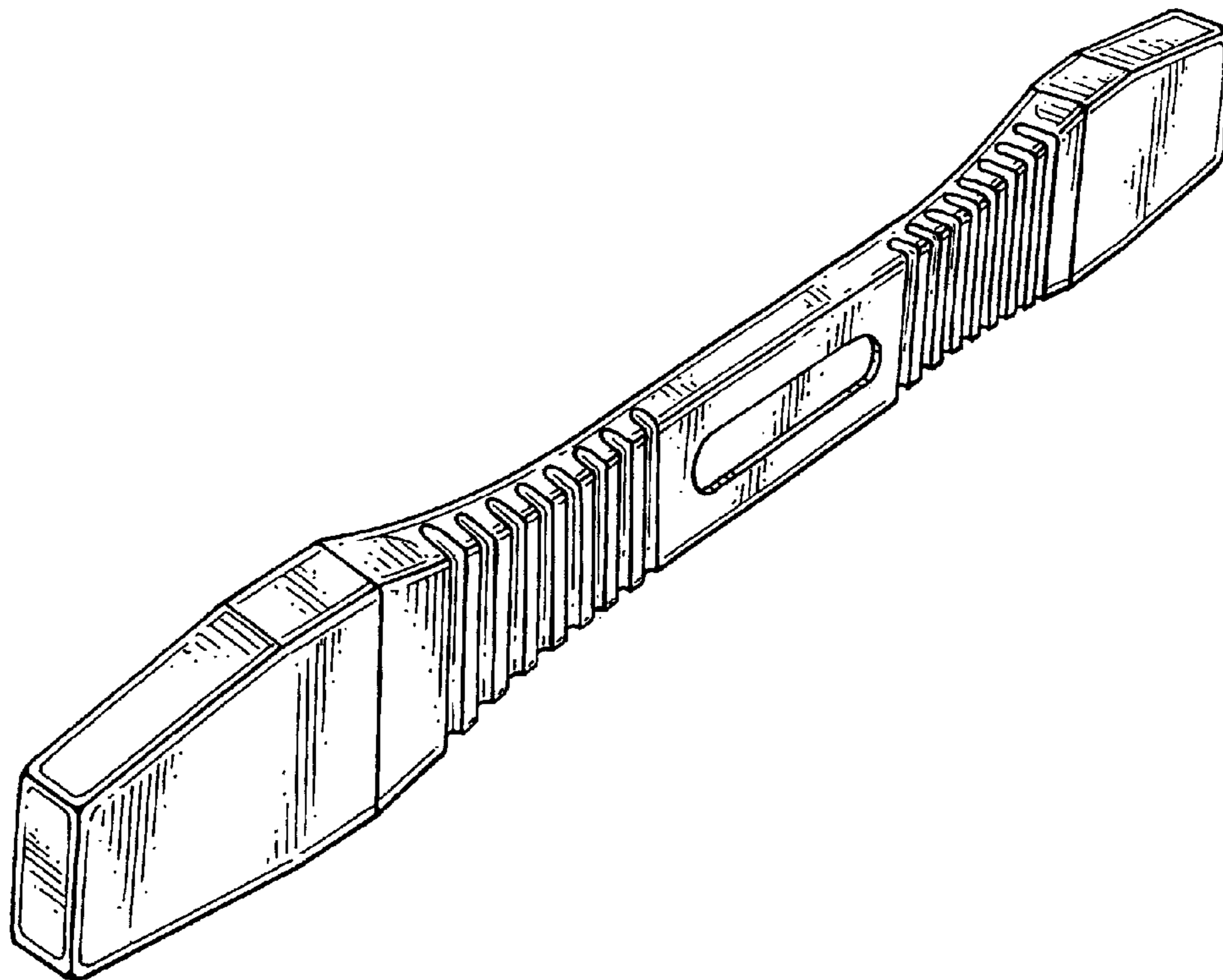
(57) **CLAIM**

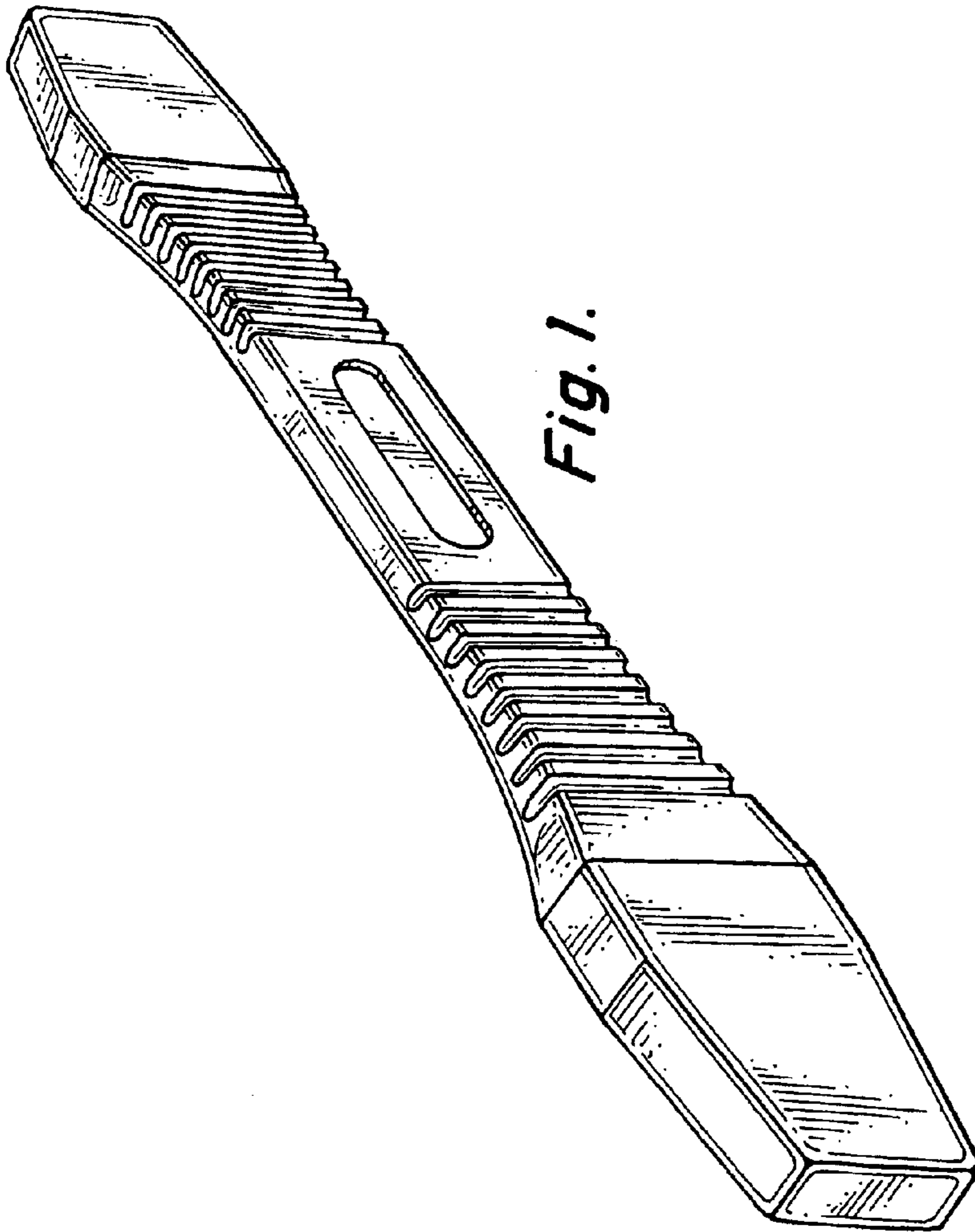
The ornamental design for a strap handle, as shown and described.

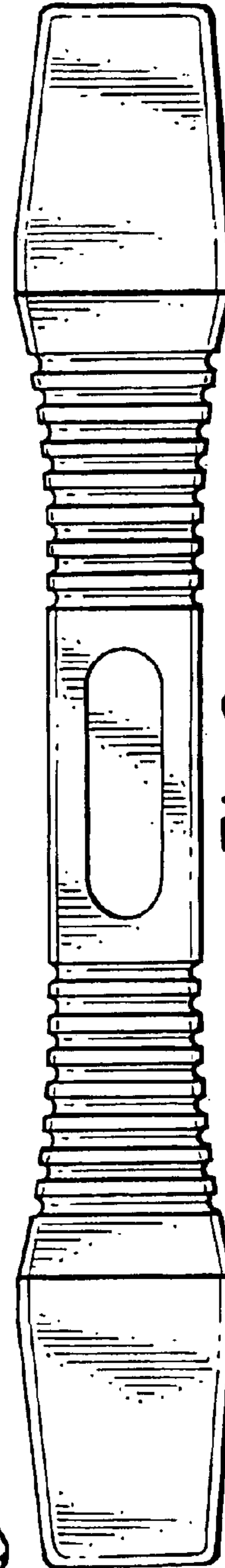




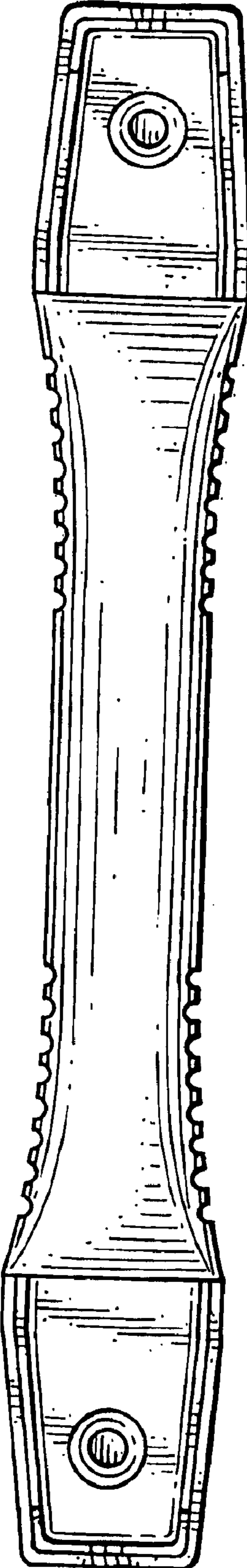

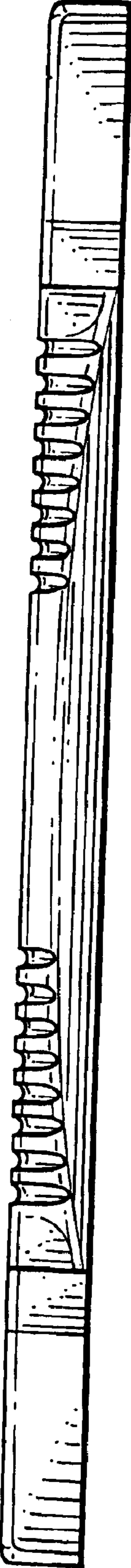
