I claim the ornamental design for a head rest monitor for an automobile, as shown and described.

DESCRIPTION

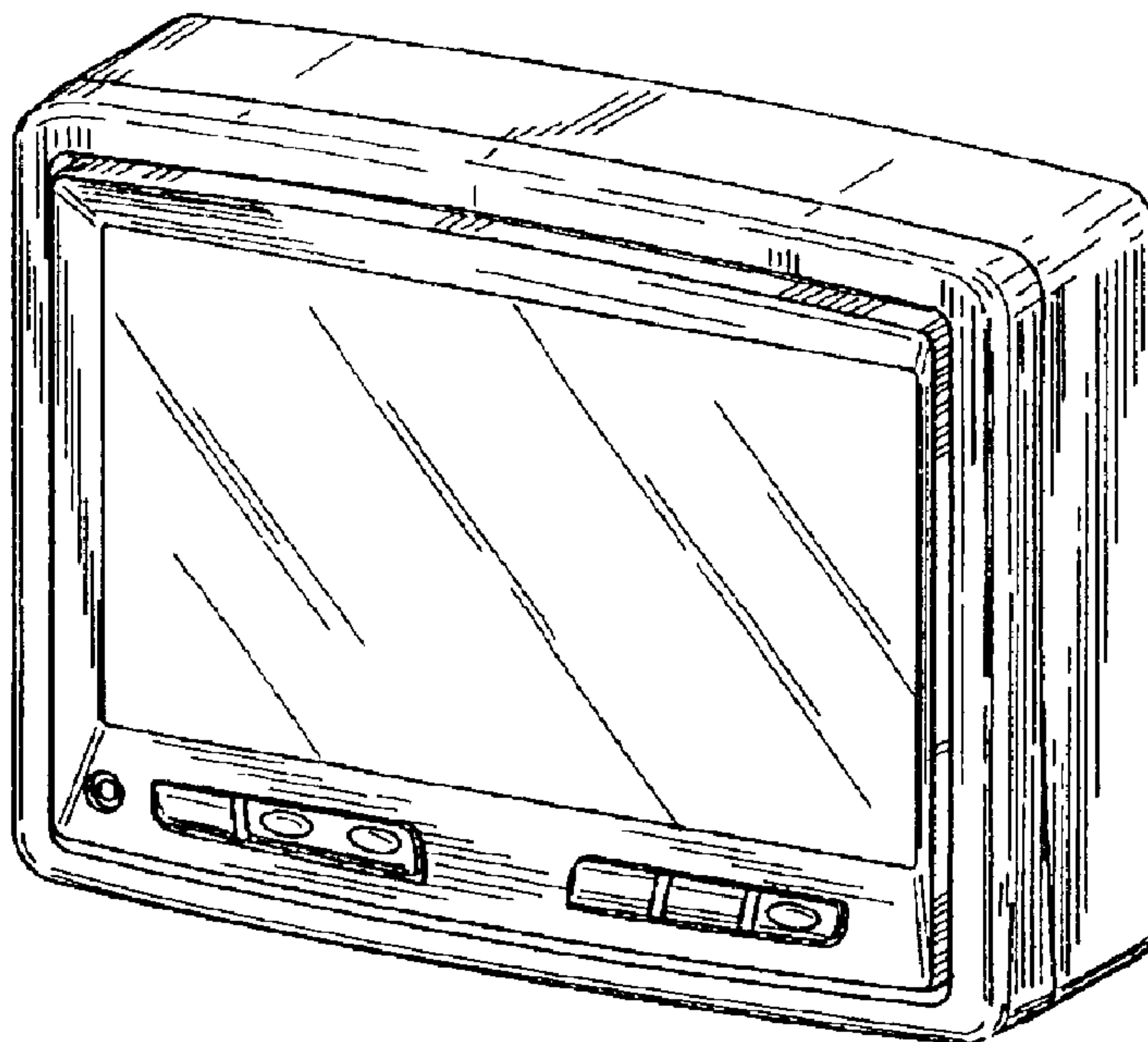

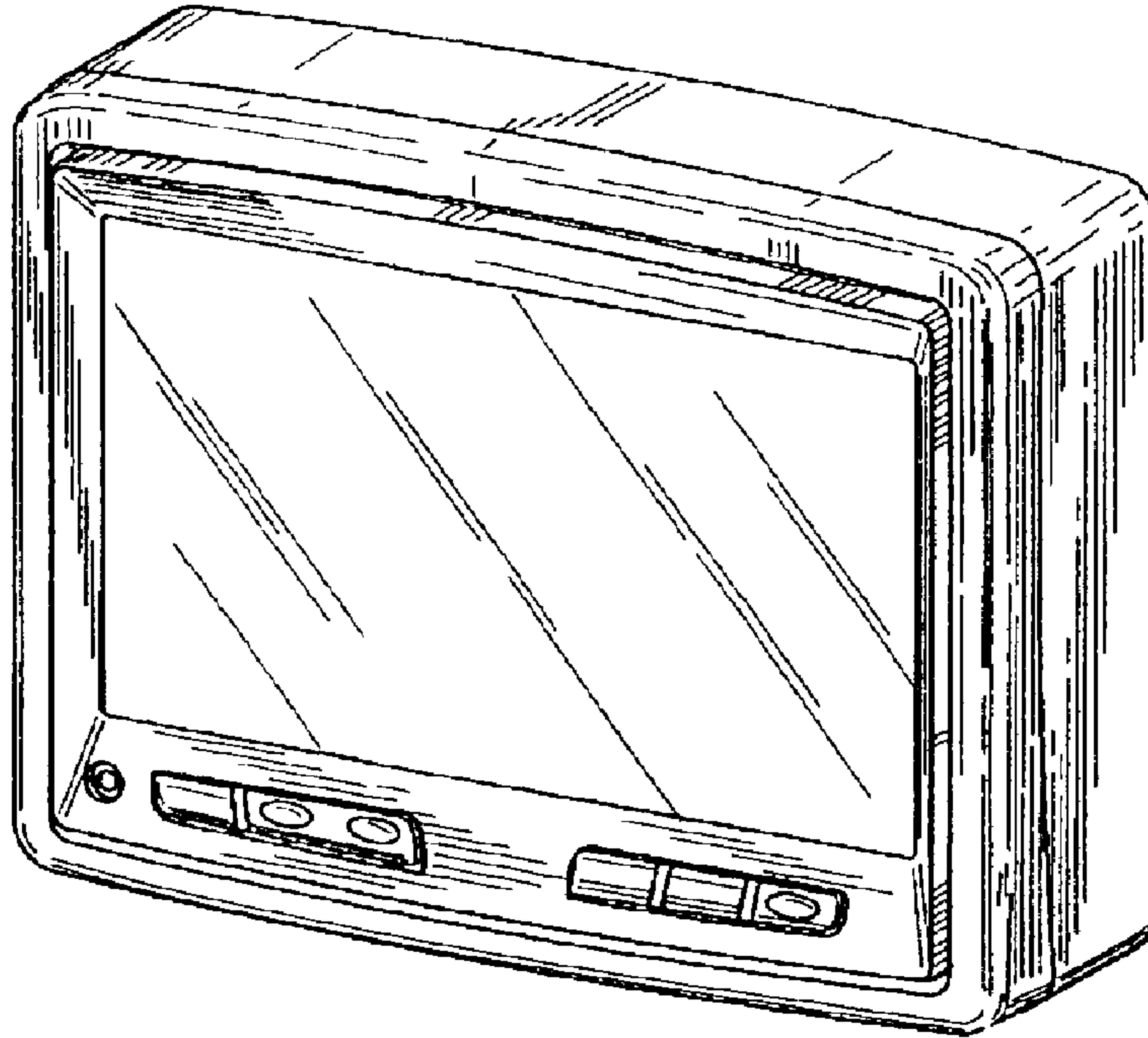

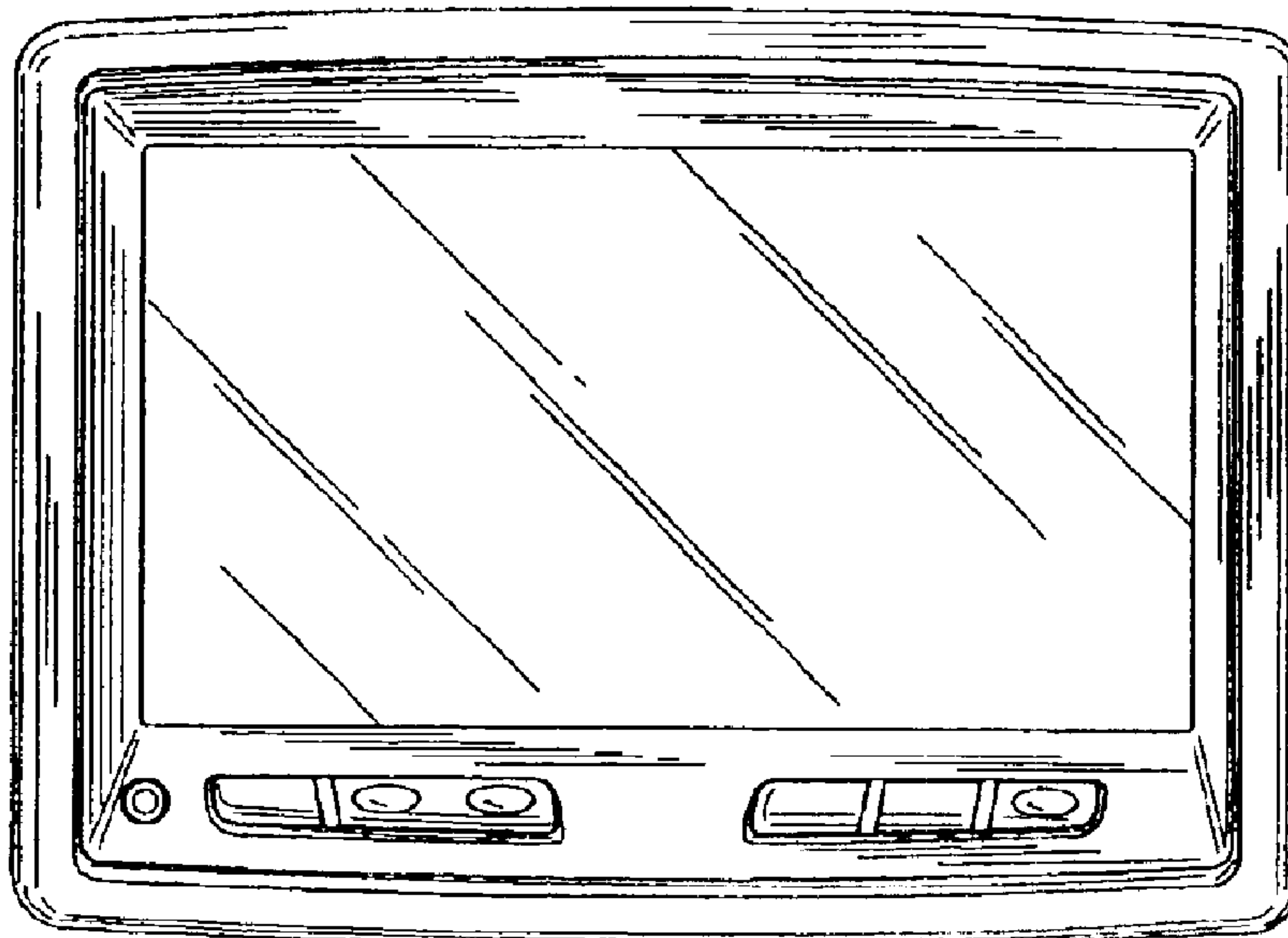

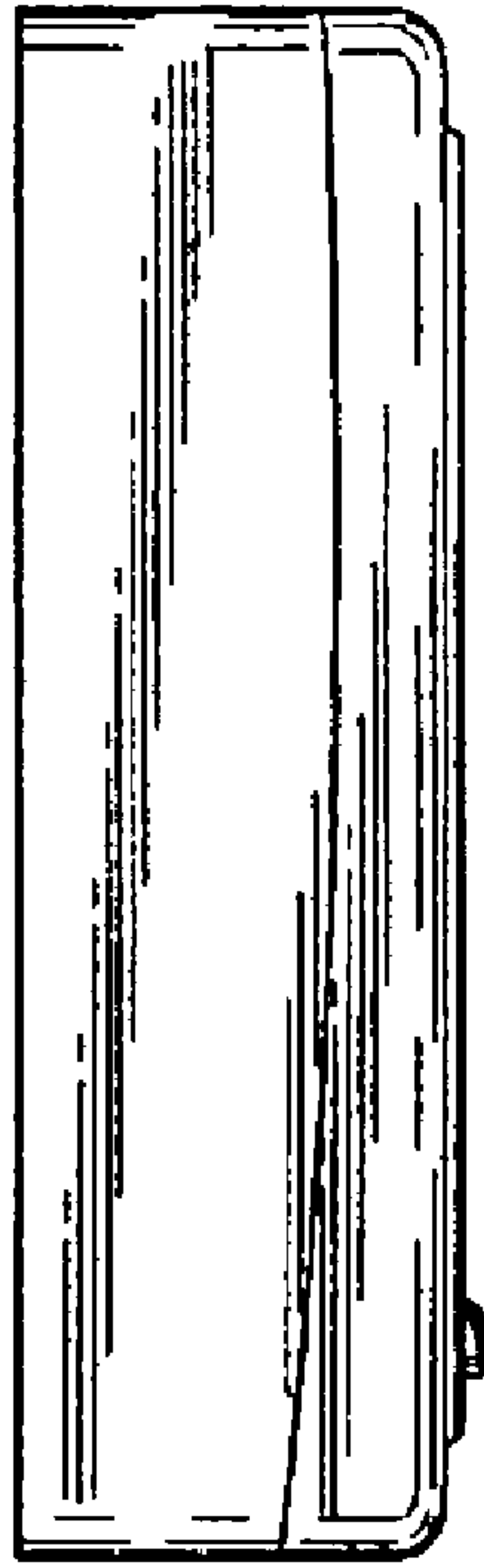

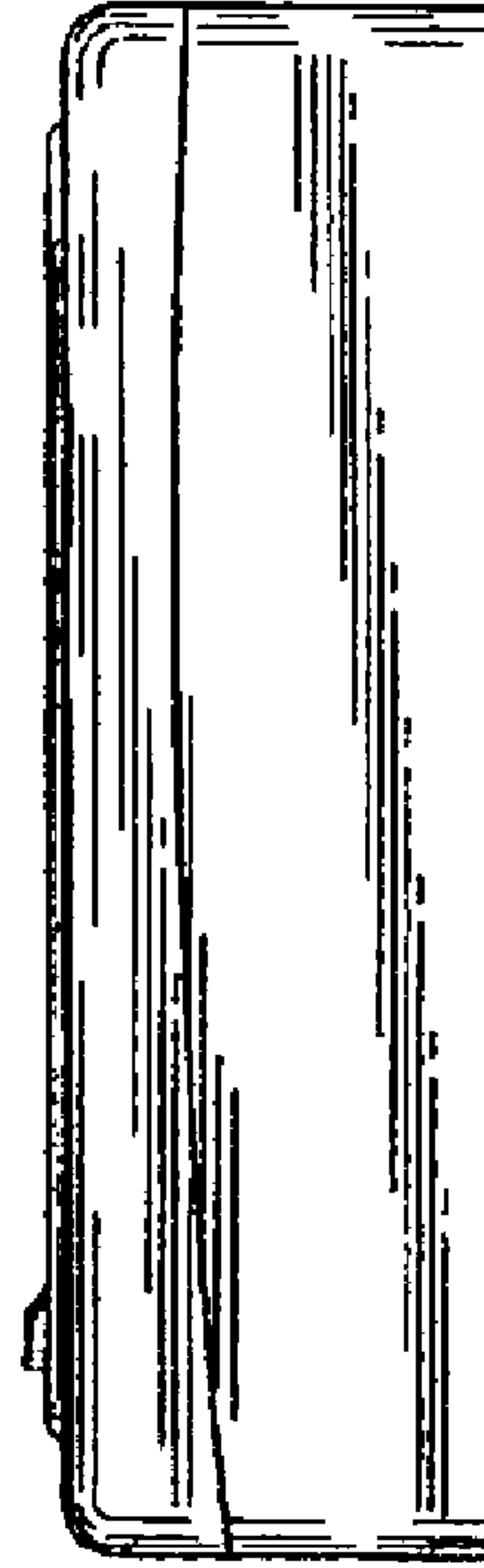

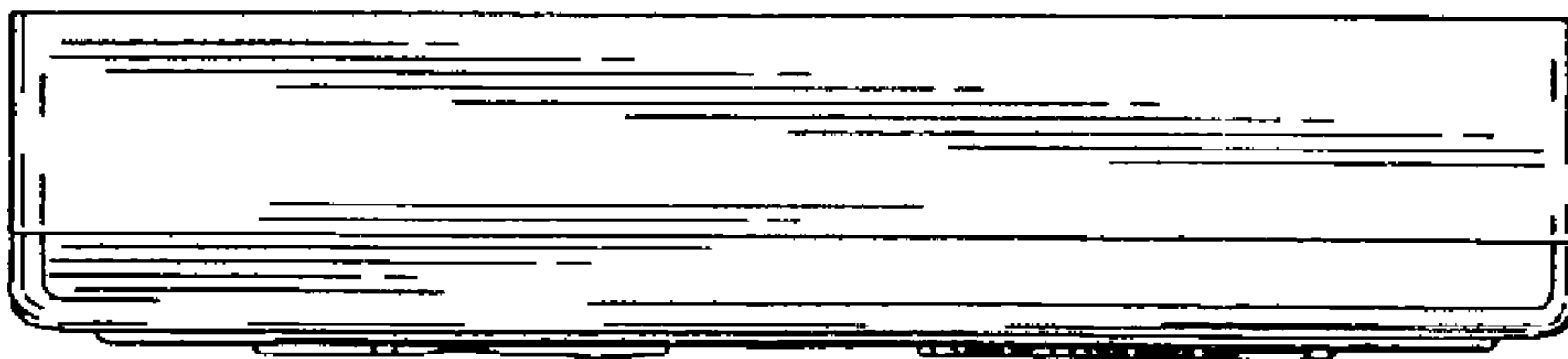

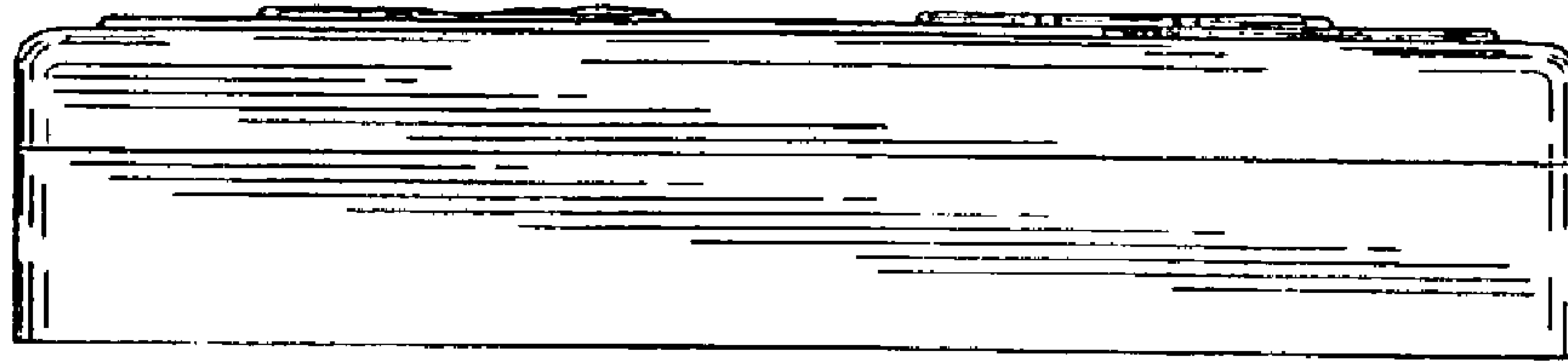
