(57) **CLAIM**

The ornamental design for an American football placekicking tee for kickoffs and onside kicks, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of my claimed design; FIG. 2 shows a top view of my claimed design; FIG. 3 shows a view from the right side of my claimed design. The view from the left side is a mirror image; FIG. 4 shows a rear view of my claimed design; FIG. 5 shows a front view of my claimed design; FIG. 6 shows a bottom view of my claimed design; FIG. 7 shows a further perspective view of my claimed design, with an American football supported for an onside kick shown in phantom. The broken lines showing the American football are for illustrative purposes only; and form no part of the claimed design; and, FIG. 8 shows a further perspective view of my claimed design, with an American football supported for a conventional kickoff shown in phantom. The broken lines showing the American football are for illustrative purposes only; and form no part of the claimed design.

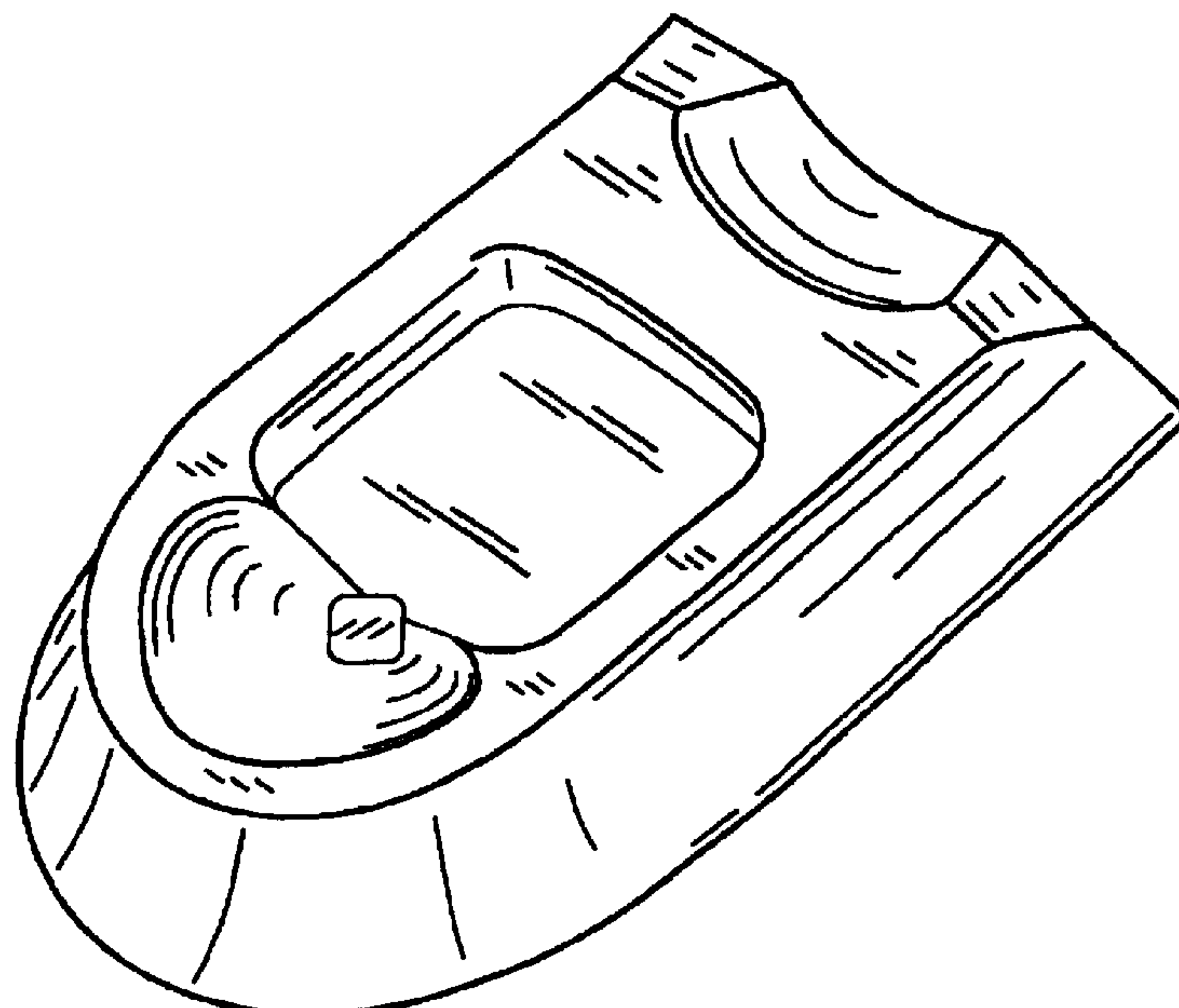

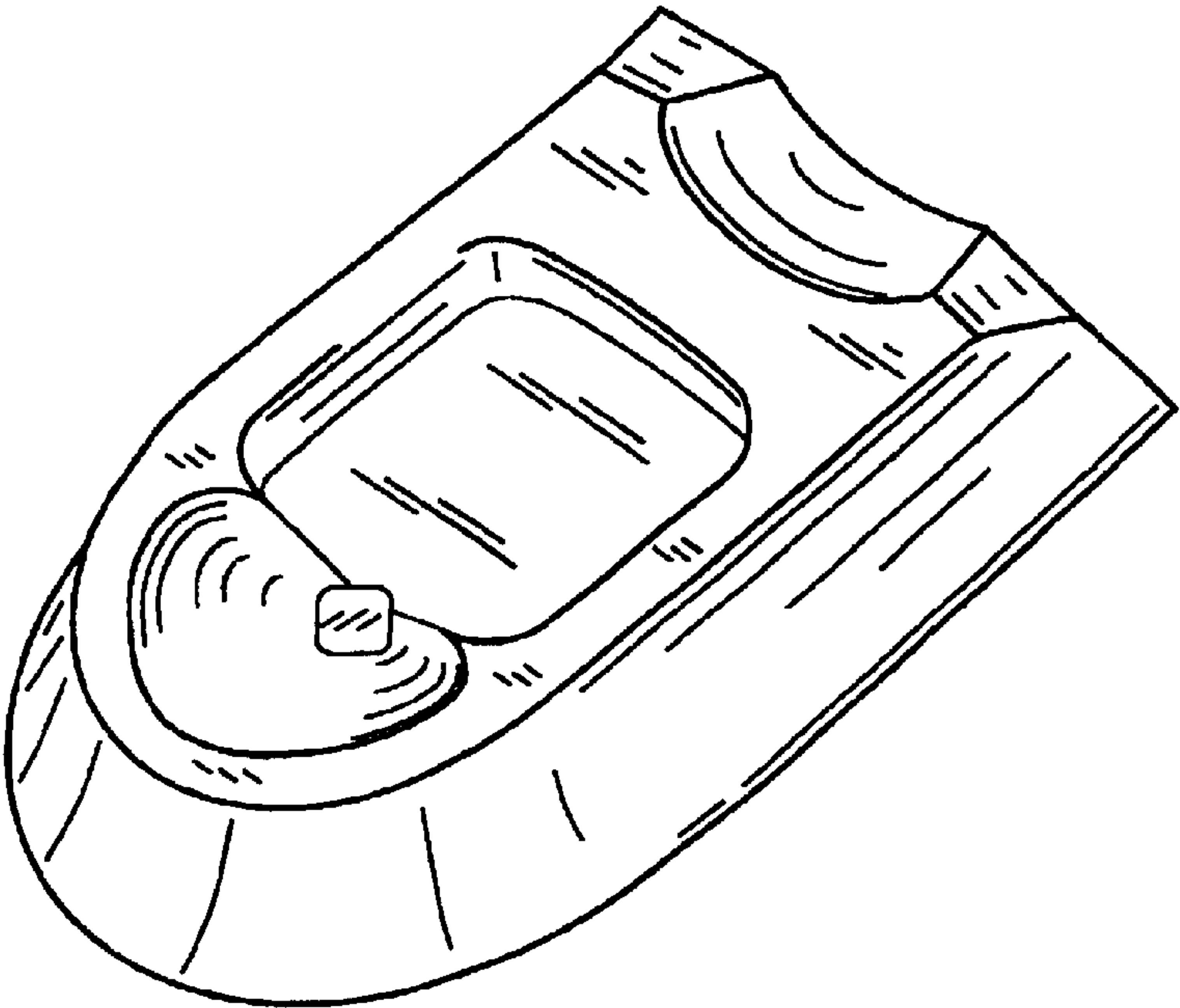

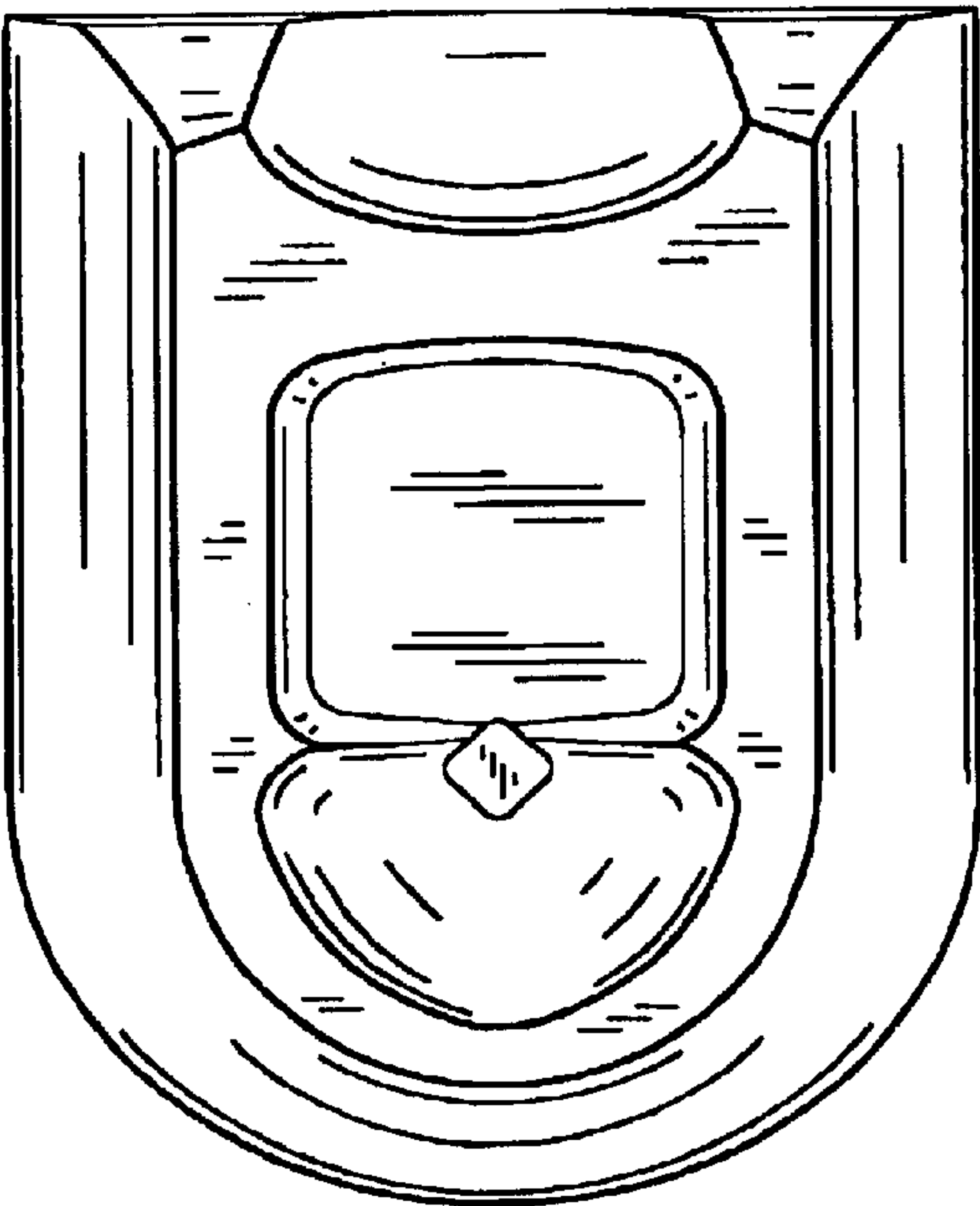

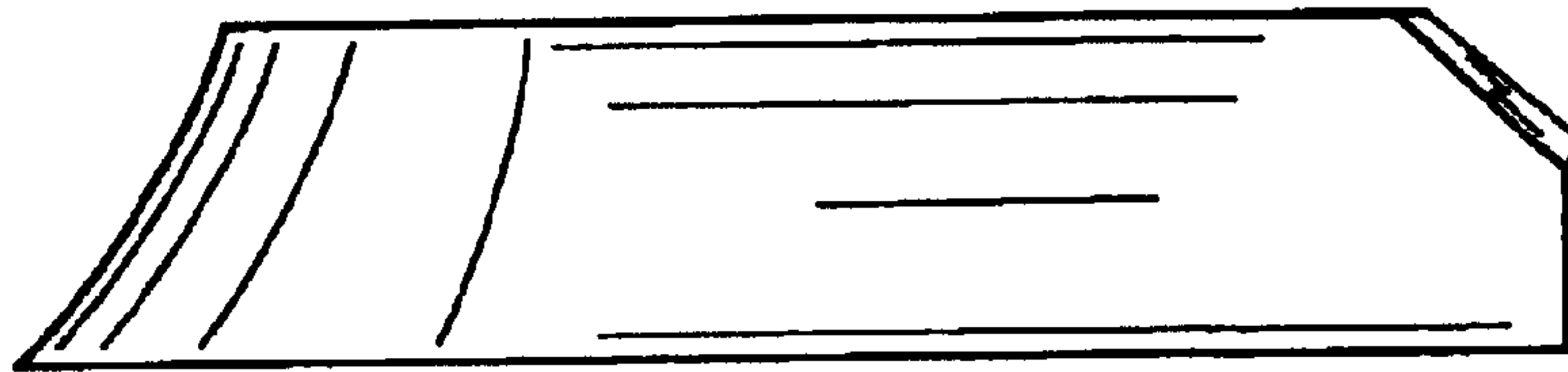

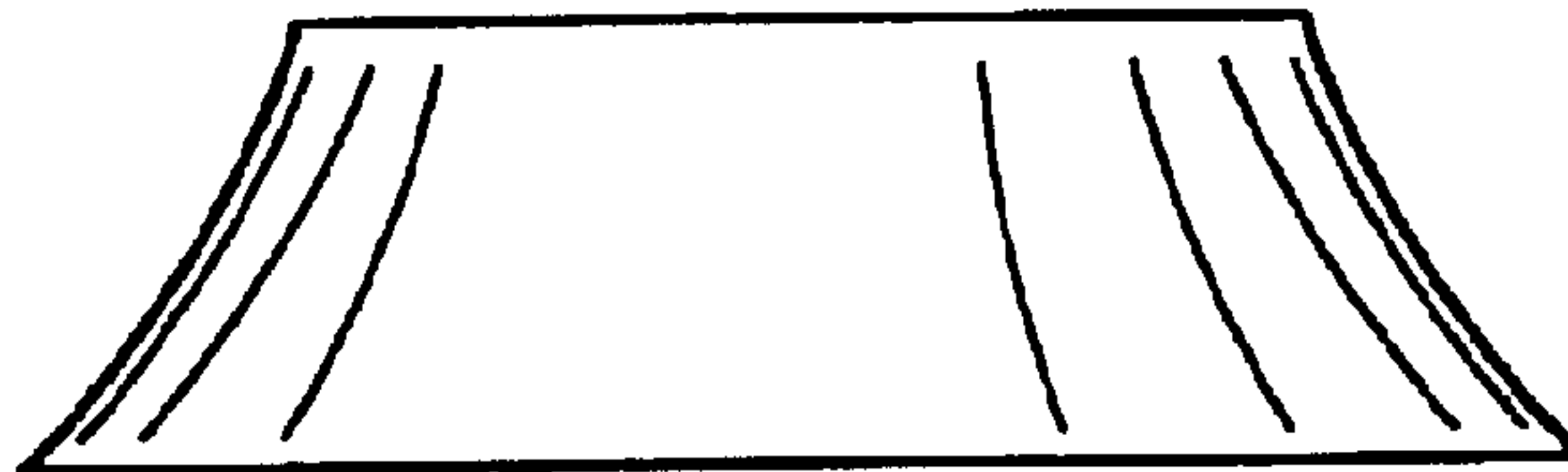

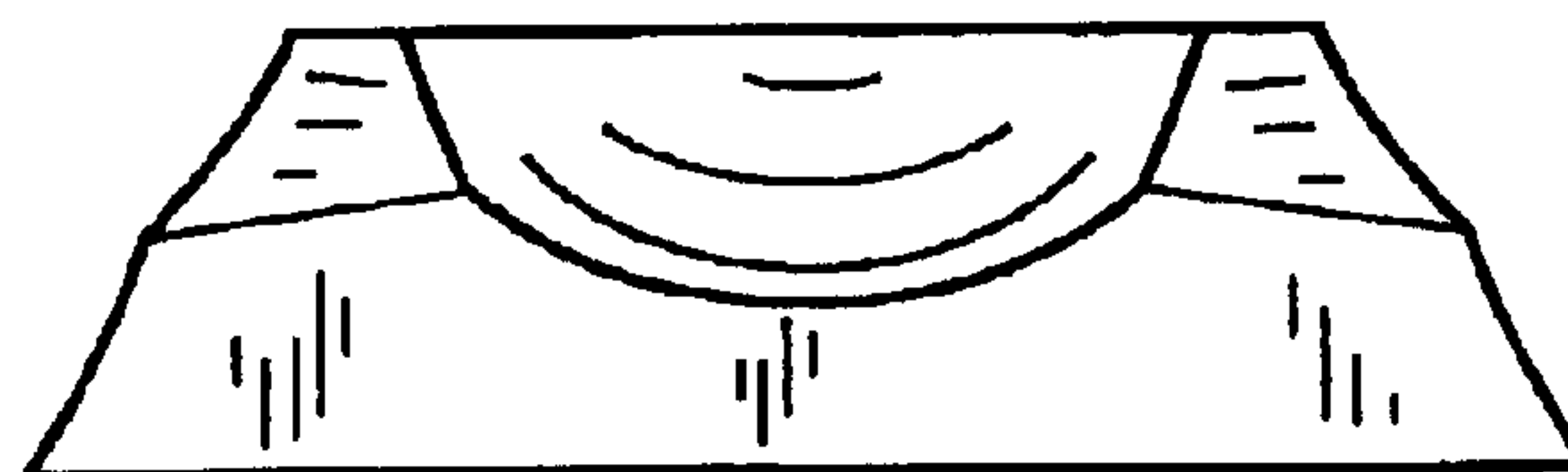

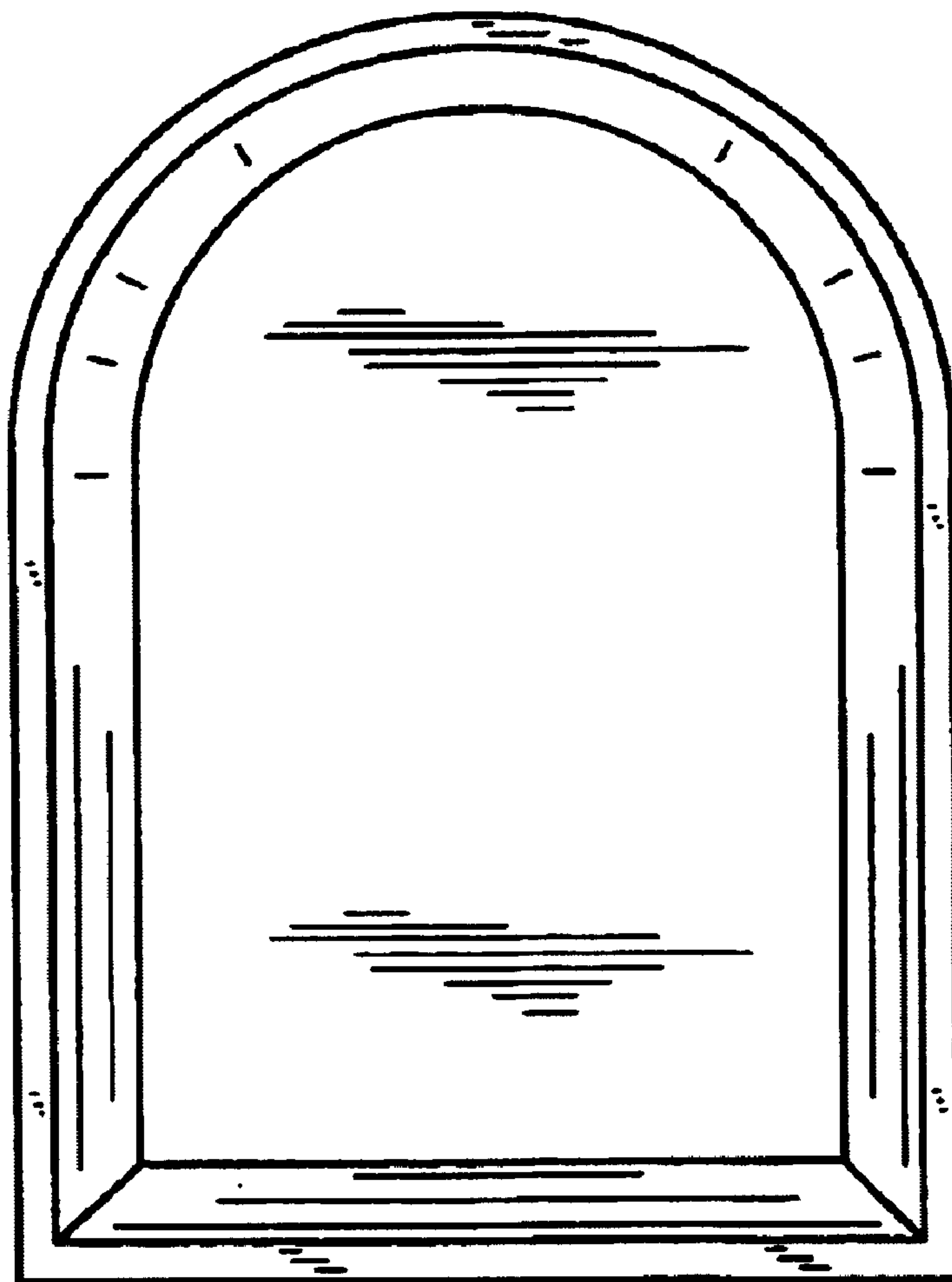

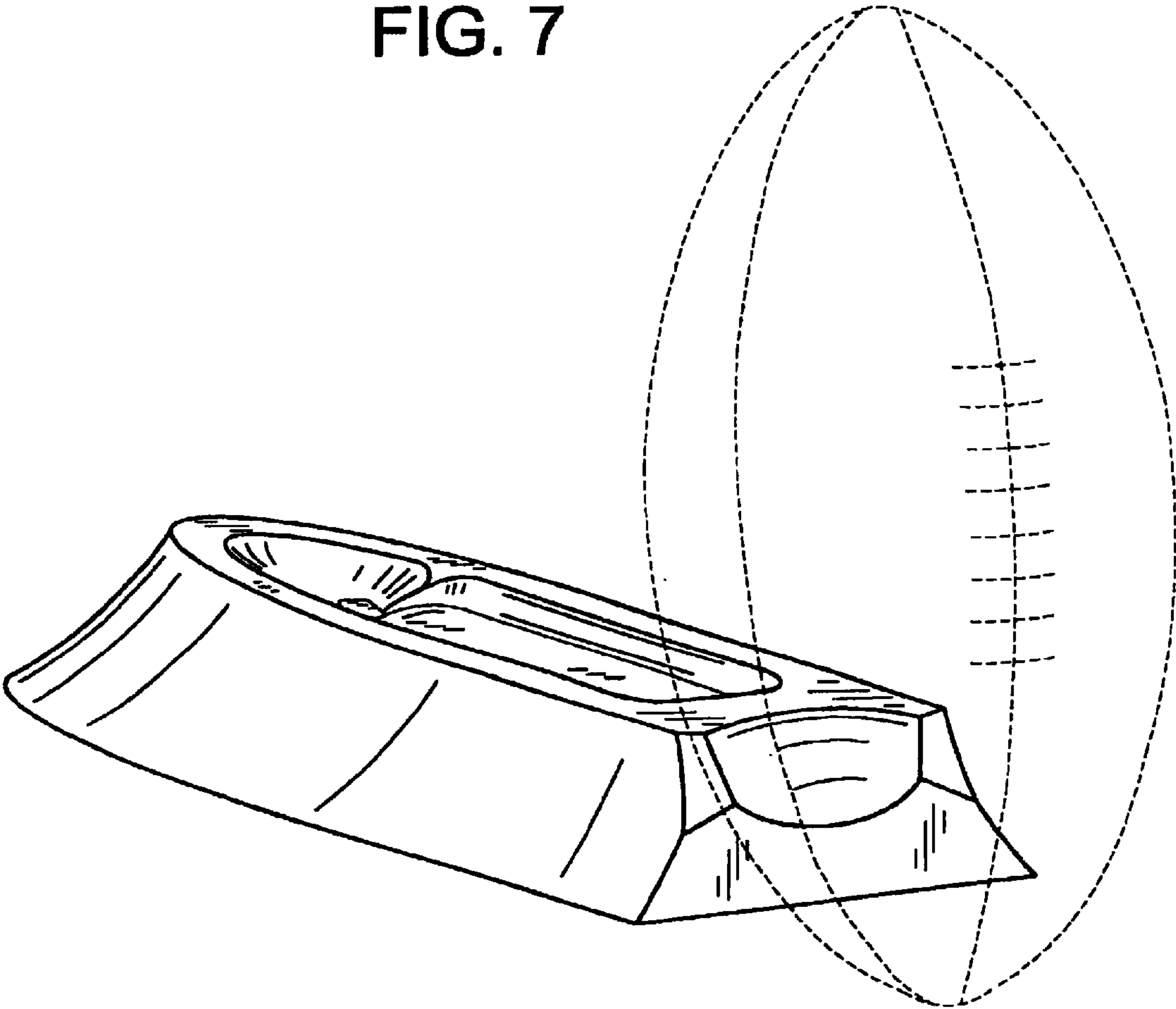
