(57) **CLAIM**

The ornamental design for a user interface for a medical device, as shown and described.

DESCRIPTION

FIG. 1 illustrates a front perspective view of a medical device showing a first embodiment of a new, original and ornamental user interface.

FIG. 2 illustrates a front view of the medical device showing the user interface of FIG. 1.

FIG. 3 illustrates a top view of the medical device showing the user interface of FIG. 1.

FIG. 4 illustrates a bottom view of the medical device of FIG. 1.

FIG. 5 illustrates a rear view of the medical device of FIG. 1.

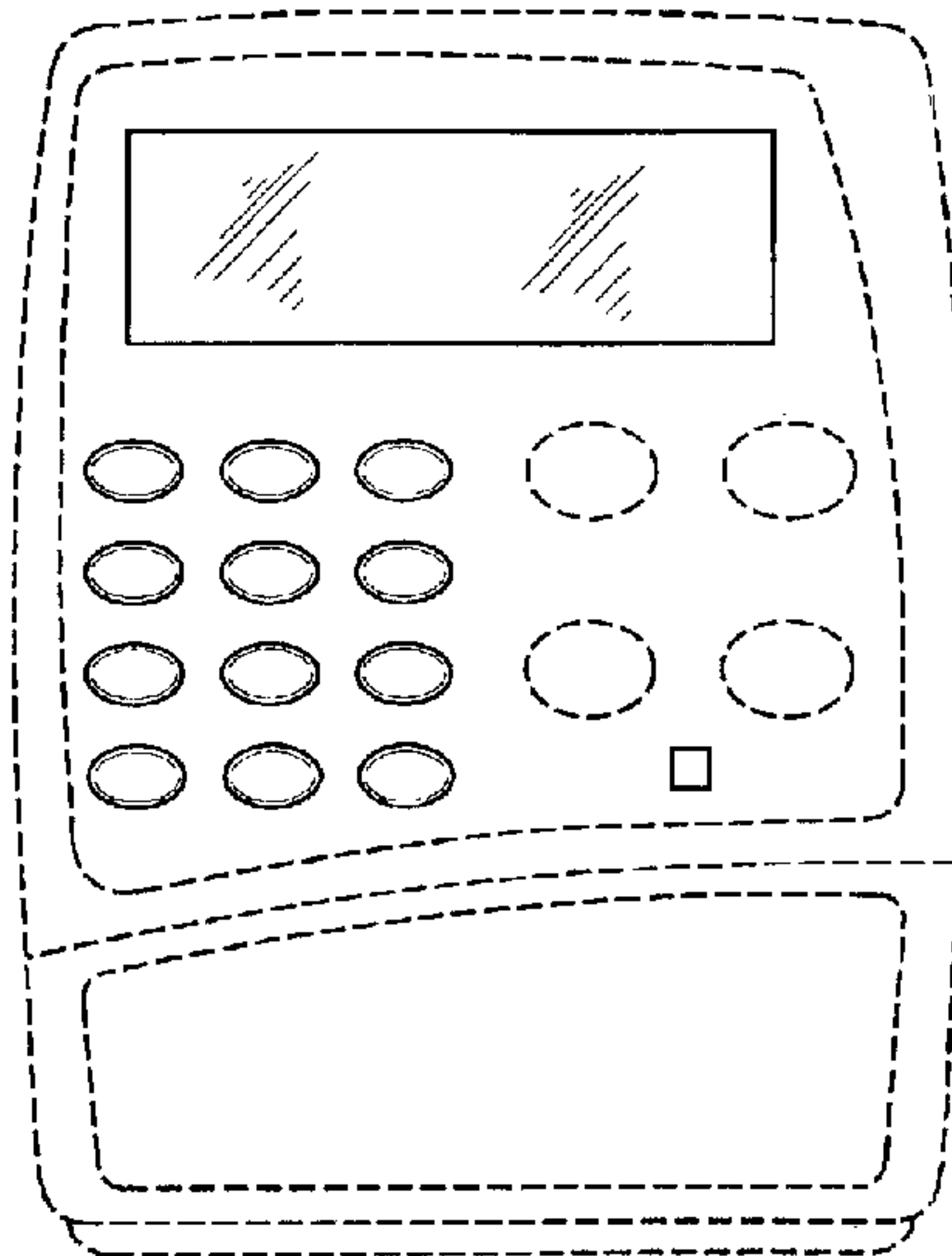
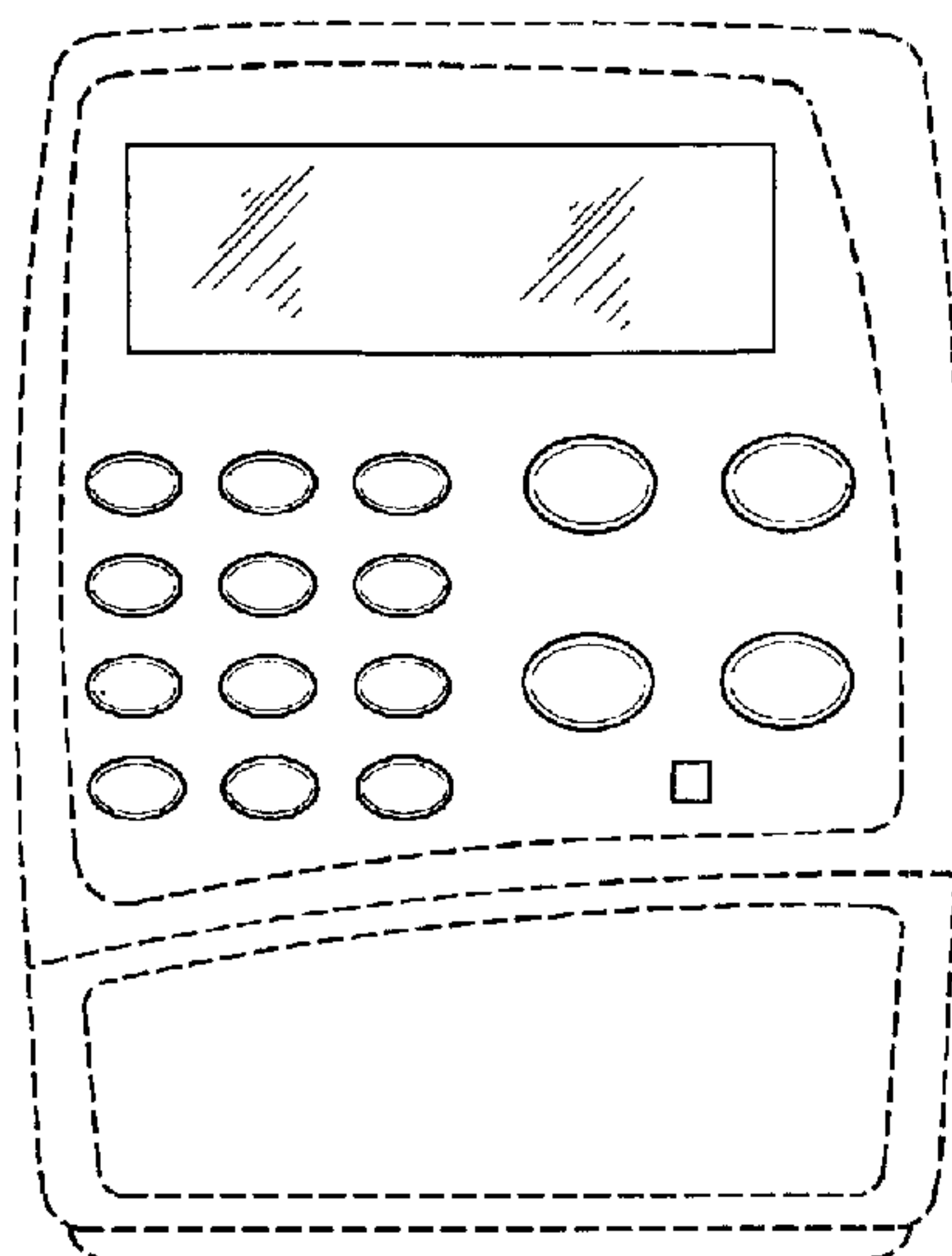
FIG. 6 illustrates a left side view of the medical device of FIG. 1.

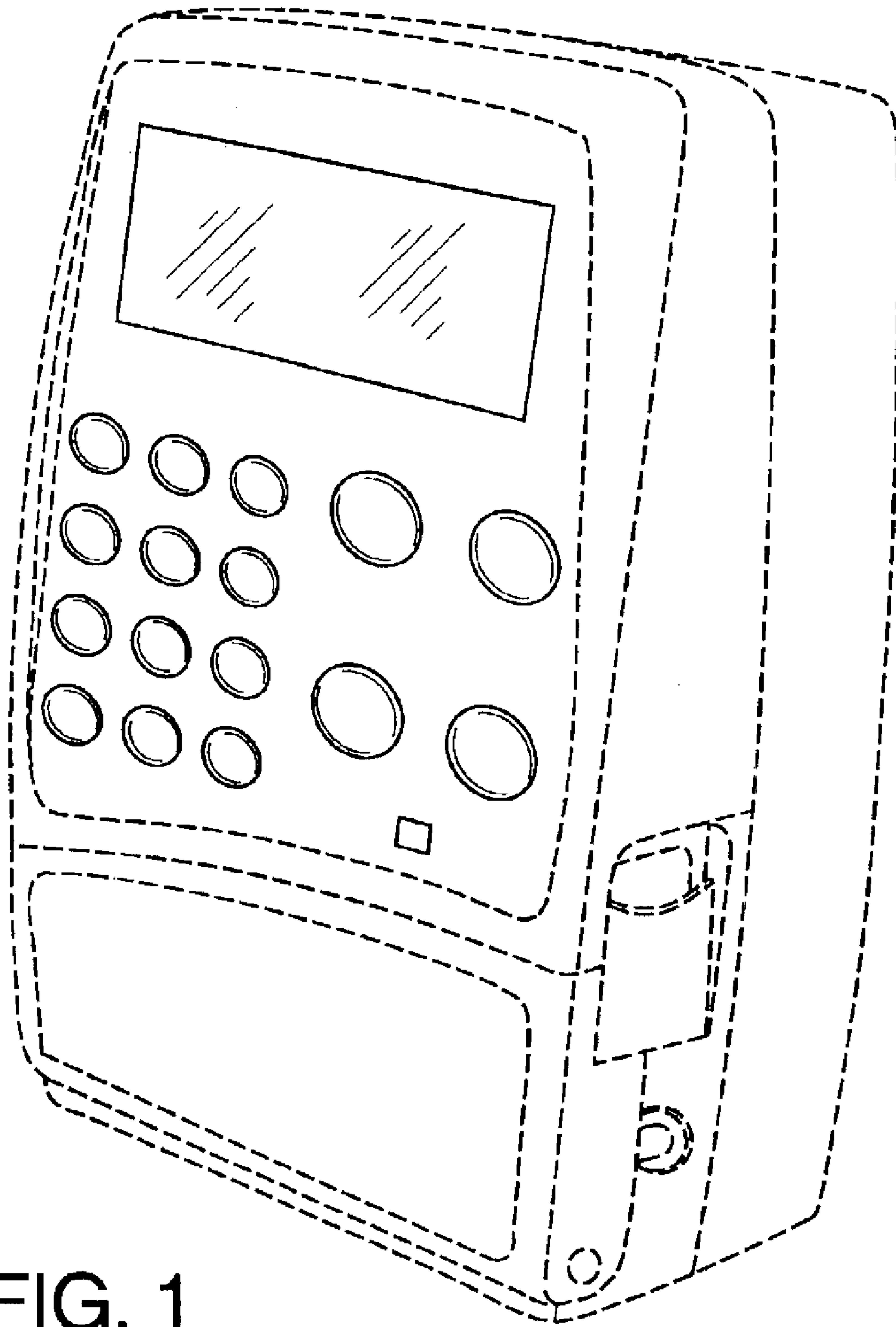

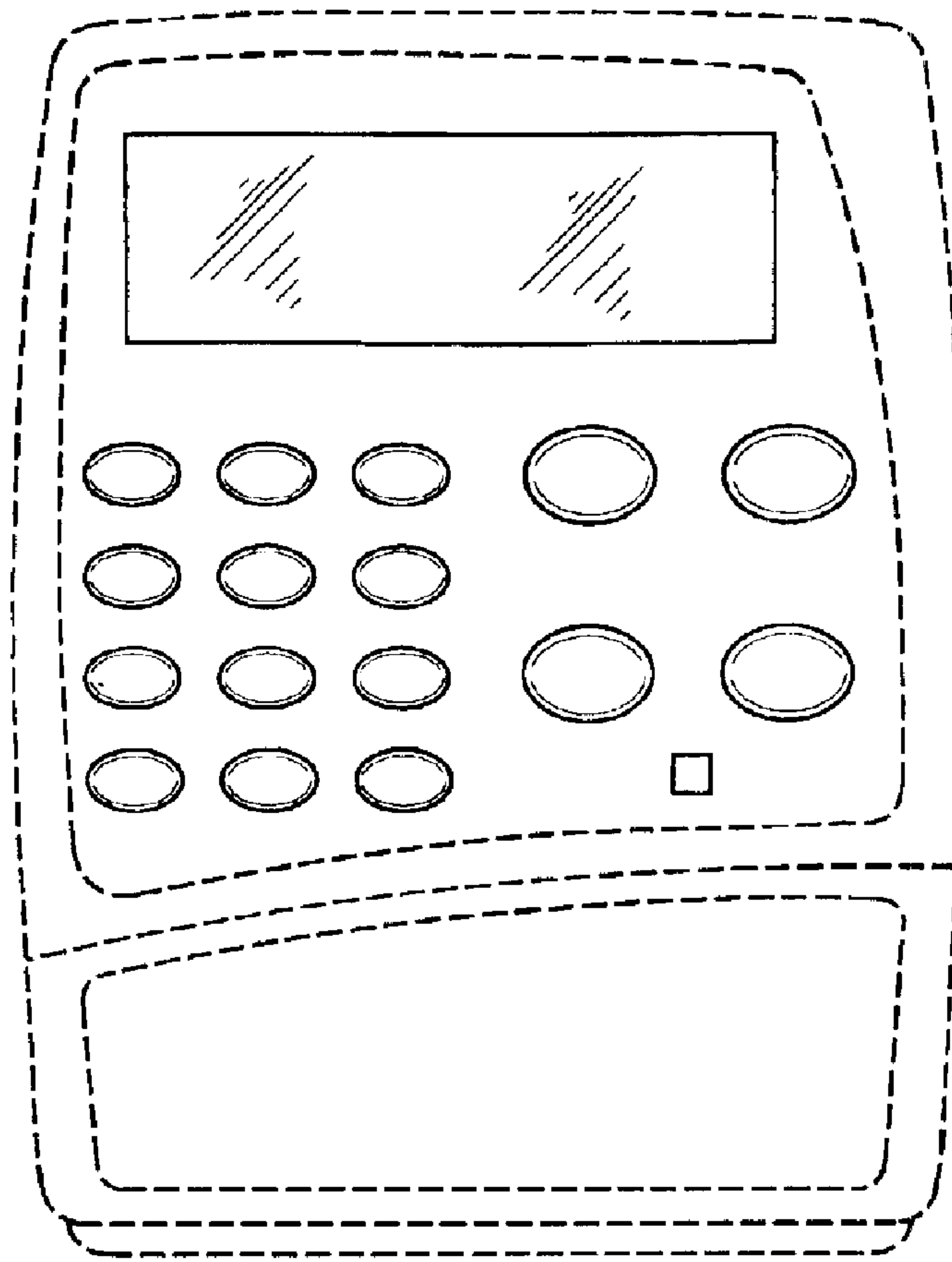

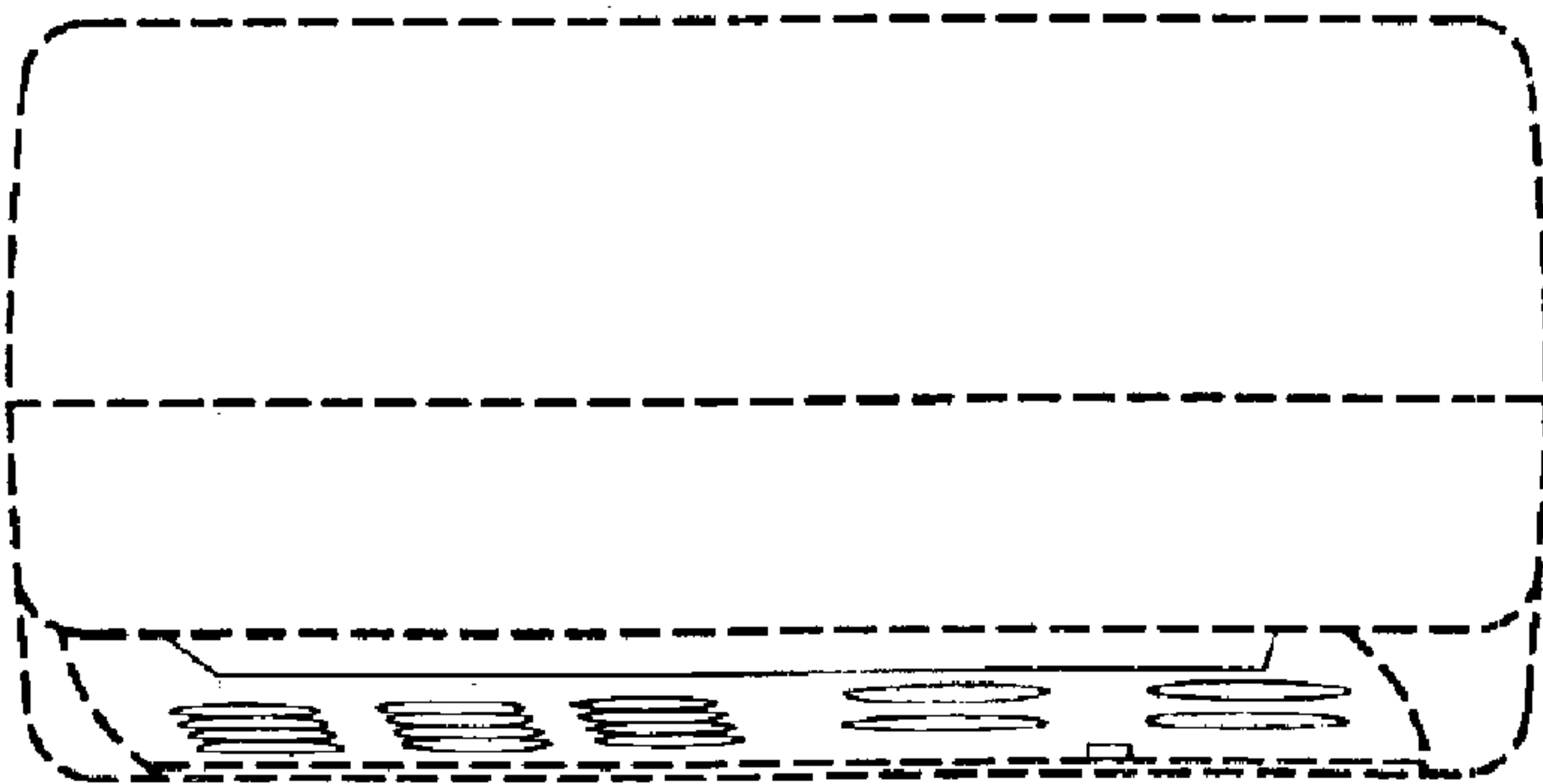

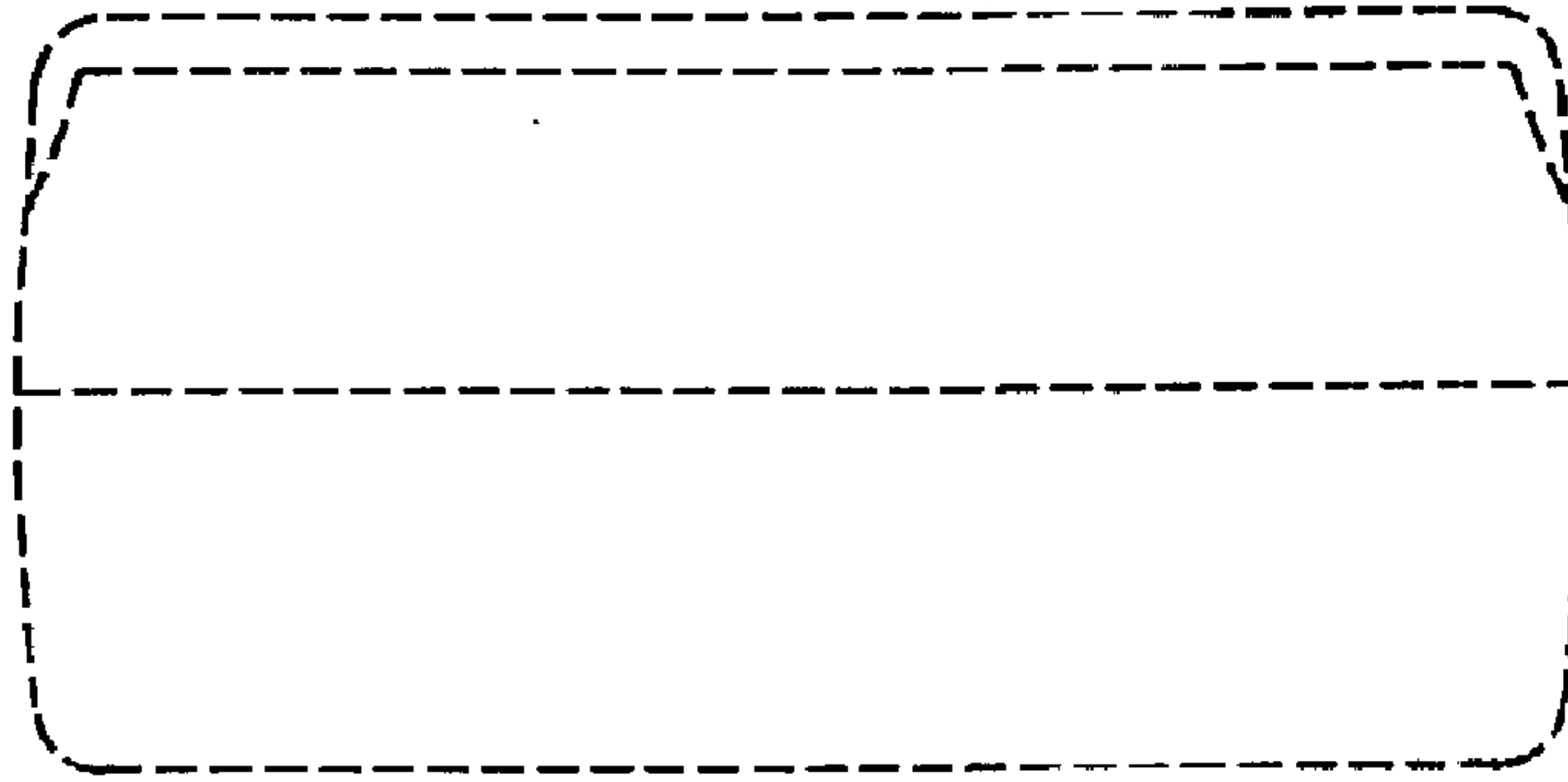

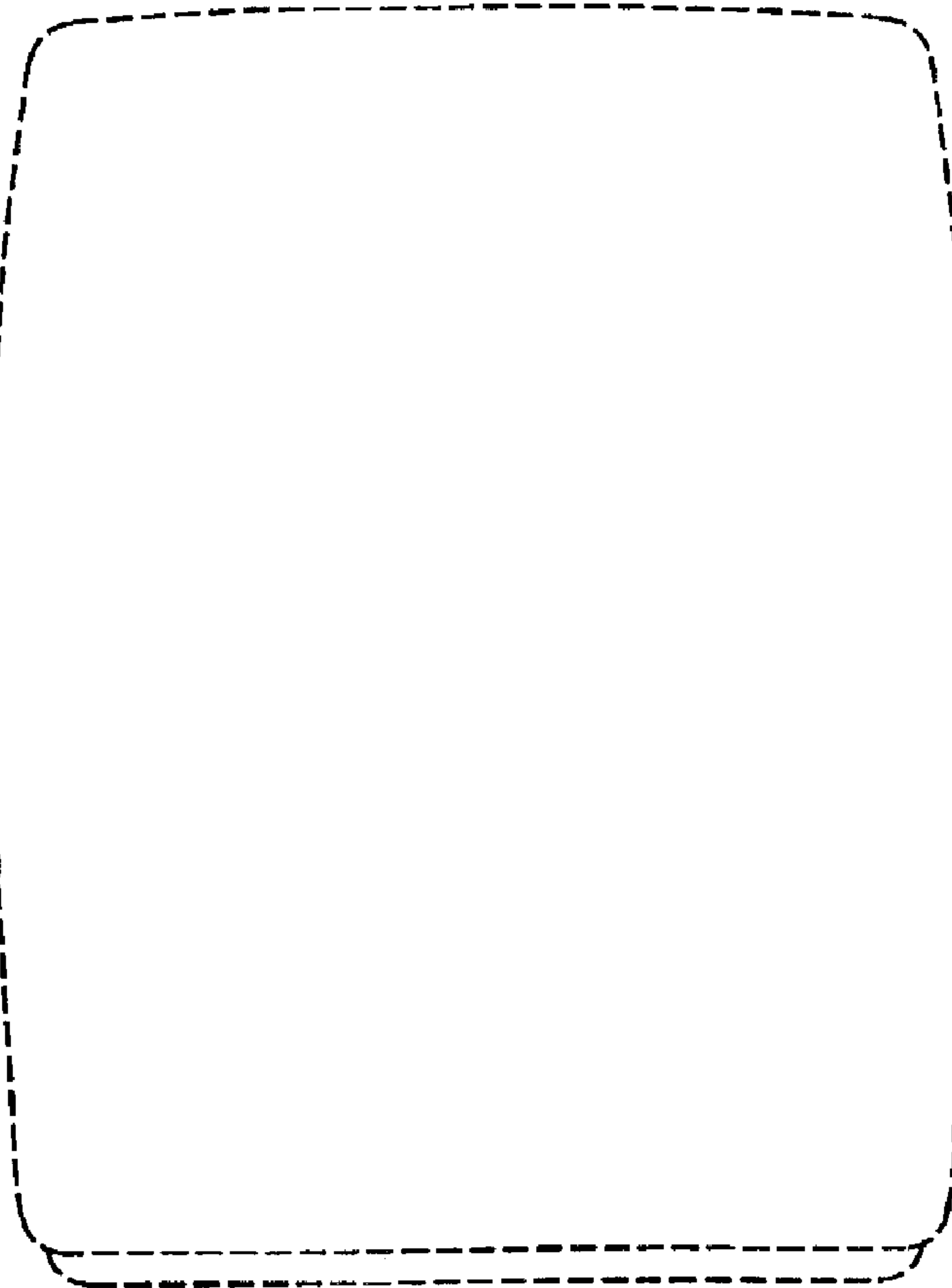

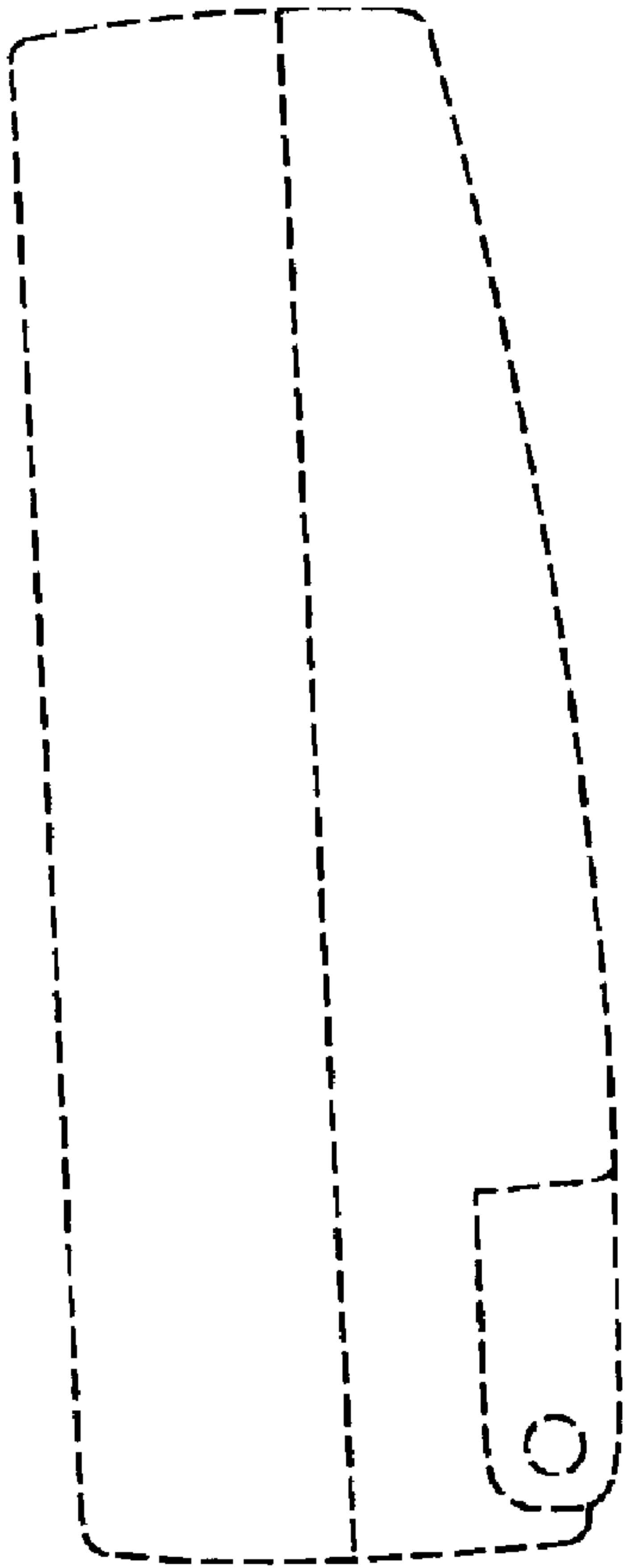

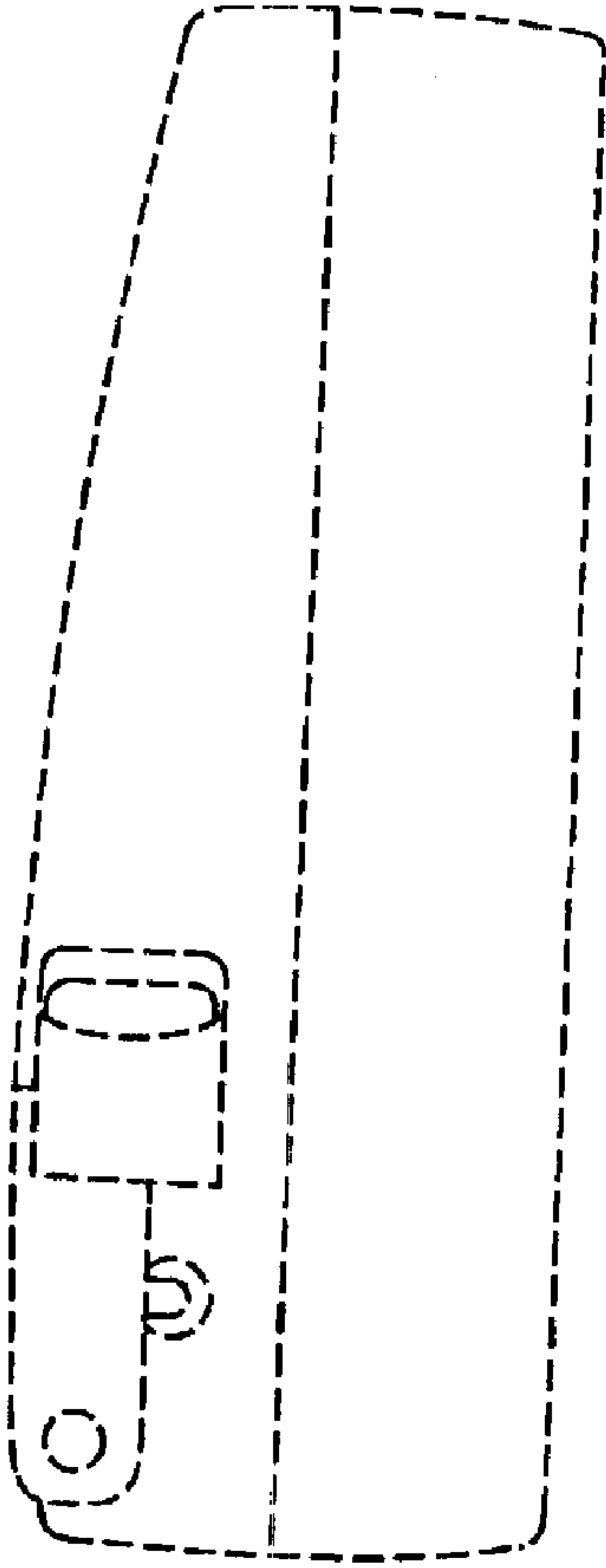

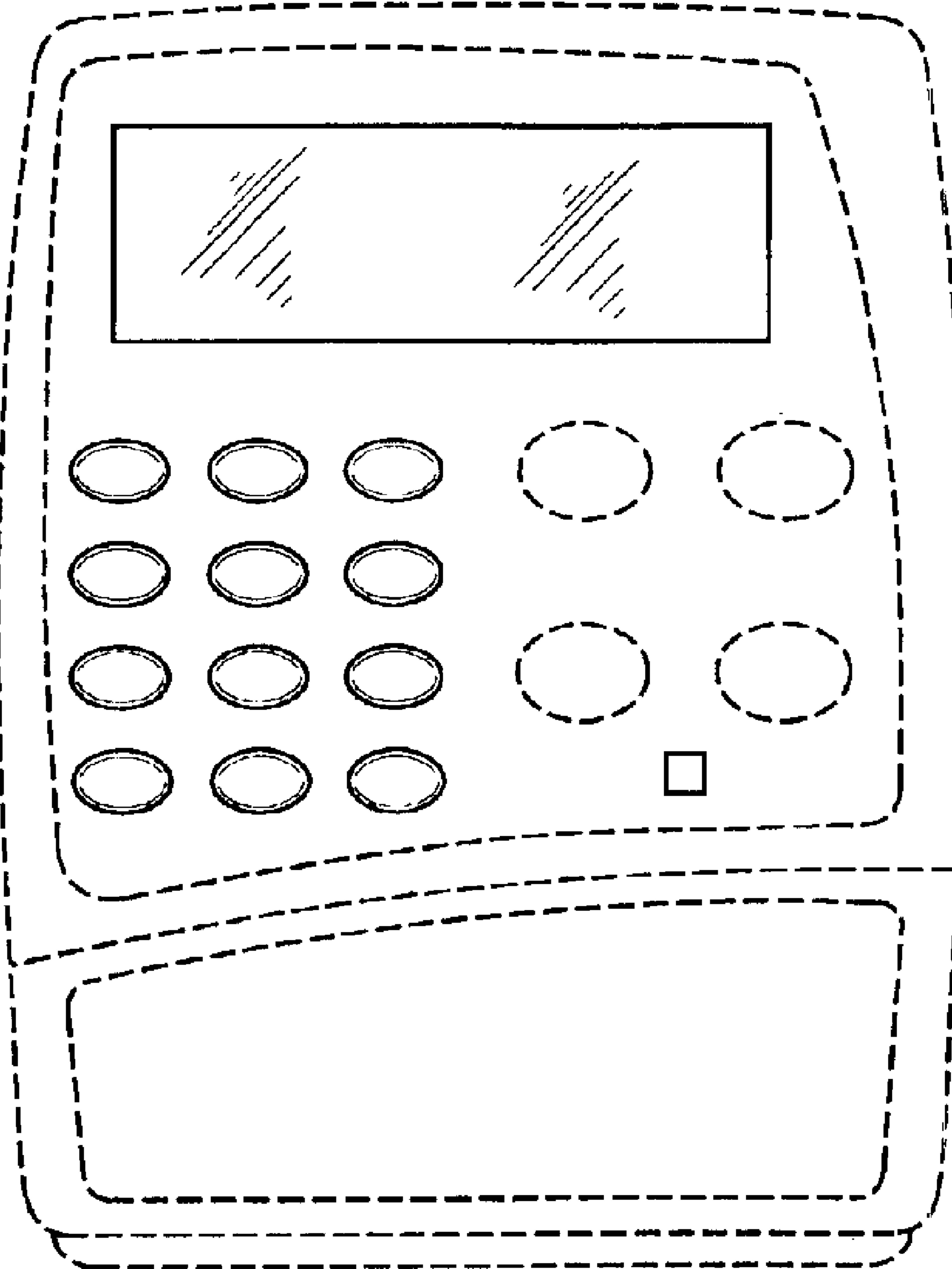
