(57) **CLAIM**

The ornamental design for a needle stick shield, as shown and described herein.

DESCRIPTION

FIG. 1 is a top perspective view of a needle stick shield showing the ornamental design.

FIG. 2 is a bottom perspective view thereof.

FIG. 3 is a bottom plan view thereof.

FIG. 4 is a top plan view thereof.

FIG. 5 is a side view taken along the line 5—5 in FIG. 3.

FIG. 6 is a perspective view thereof.

FIG. 7 is a perspective view thereof; and,

FIG. 8 is a side view taken along the line 8—8 in FIG. 3.

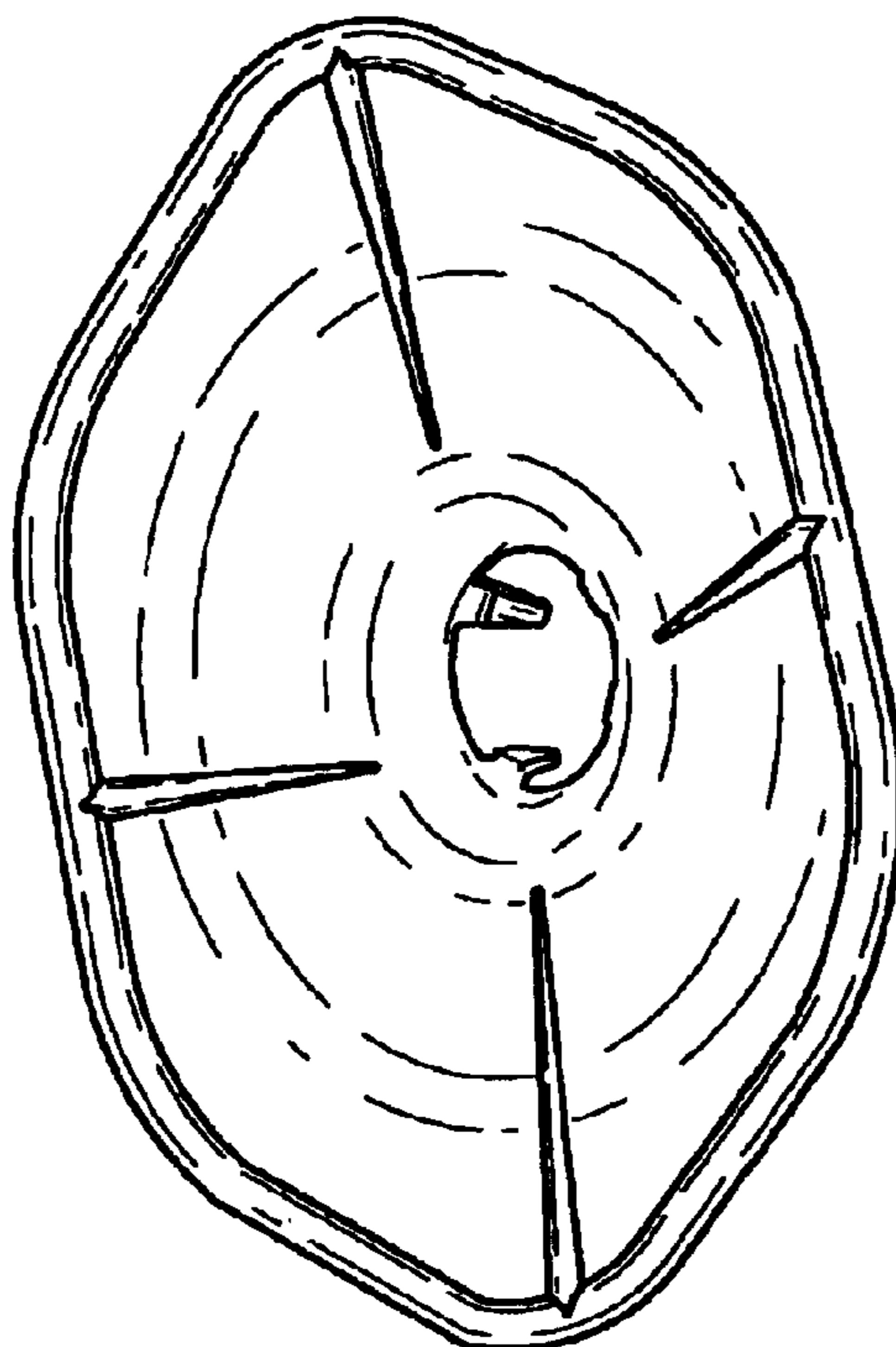

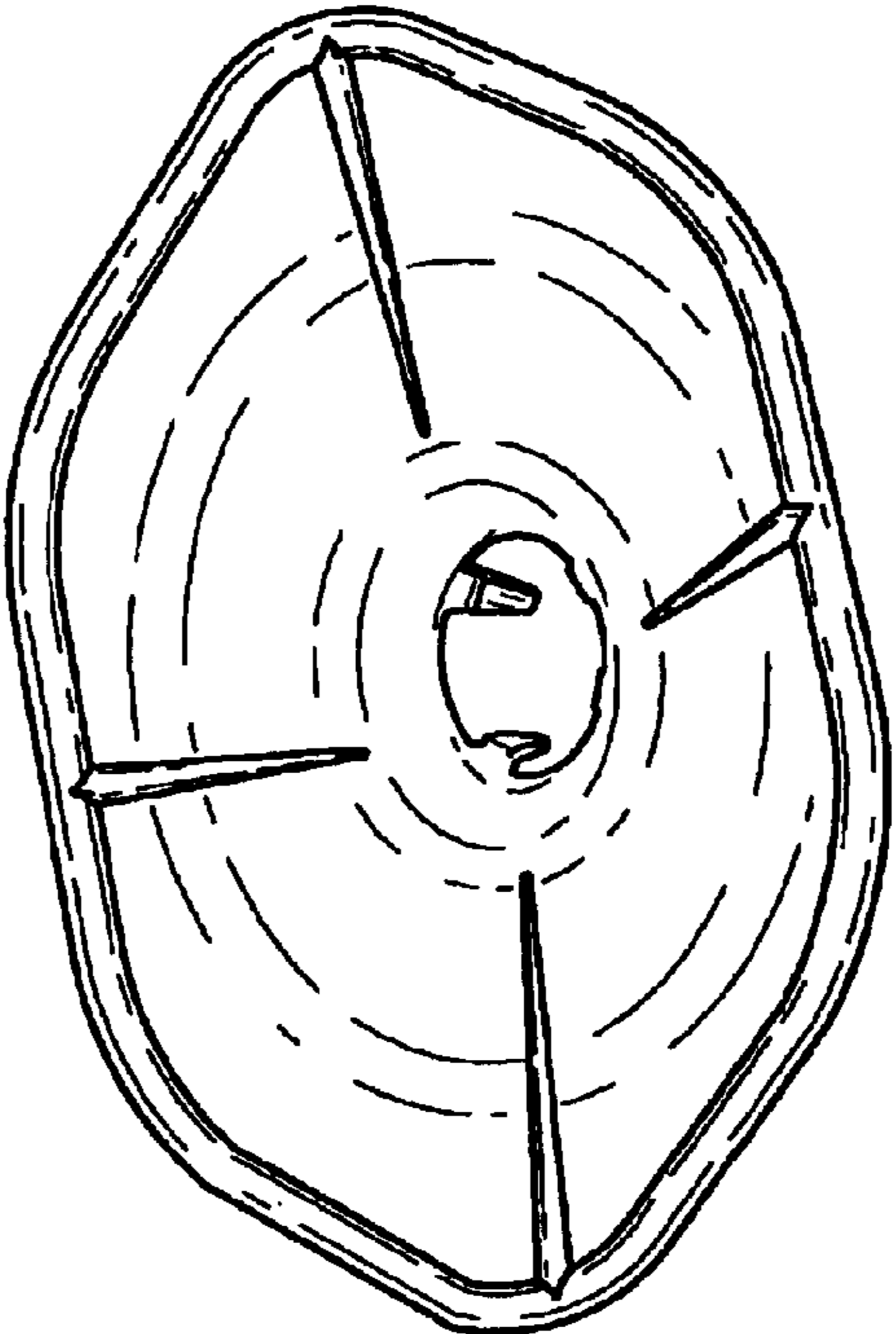

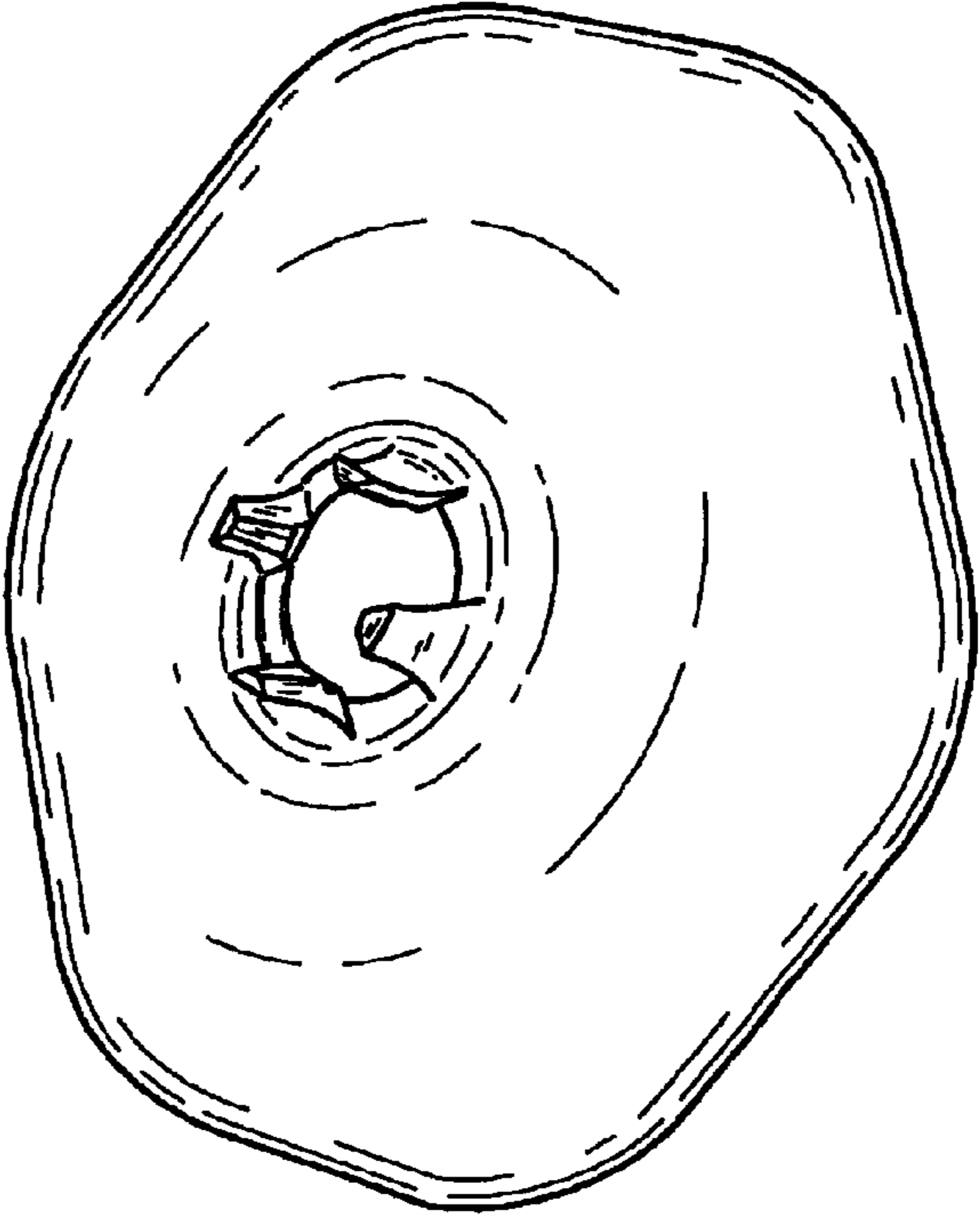

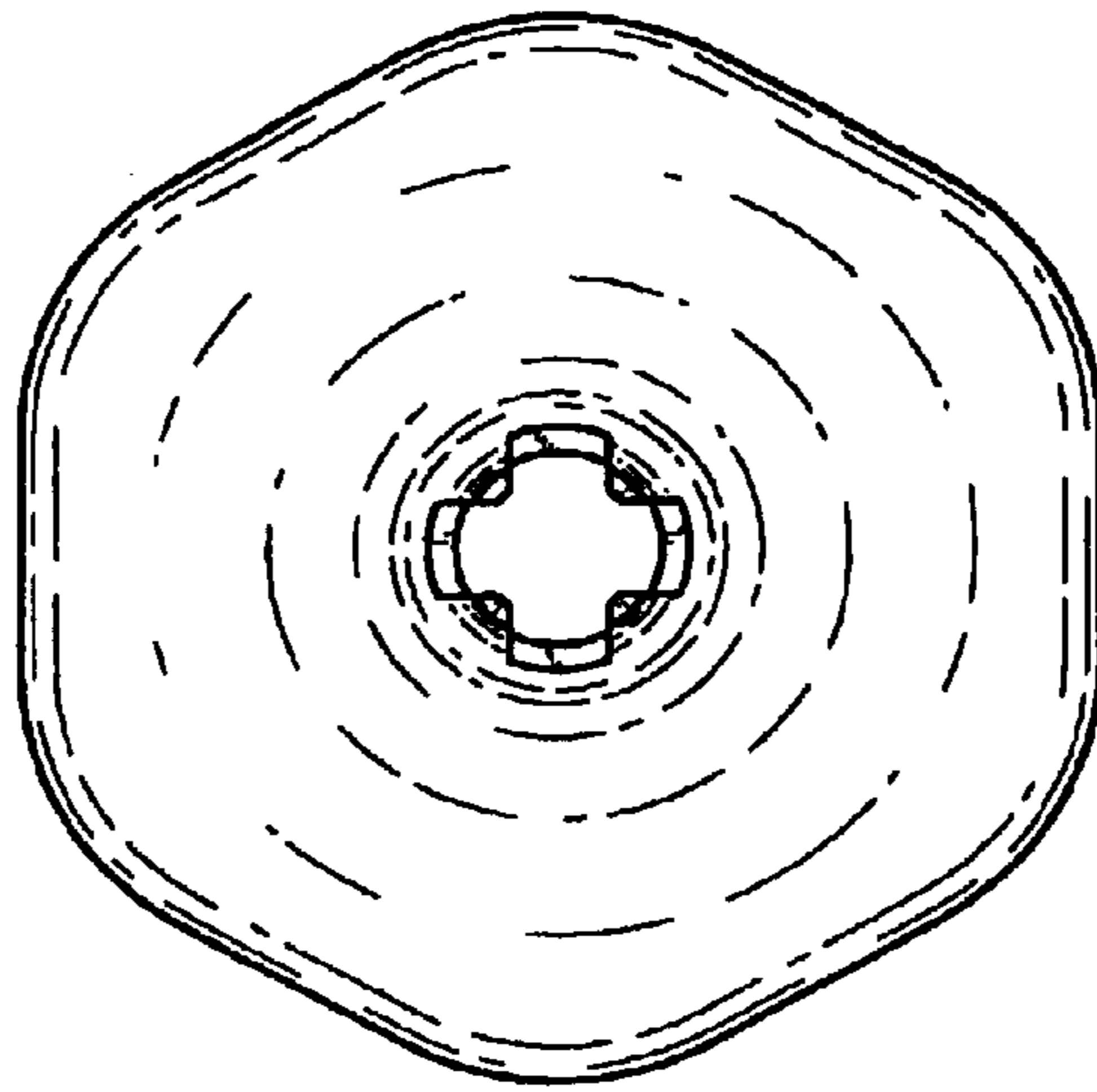

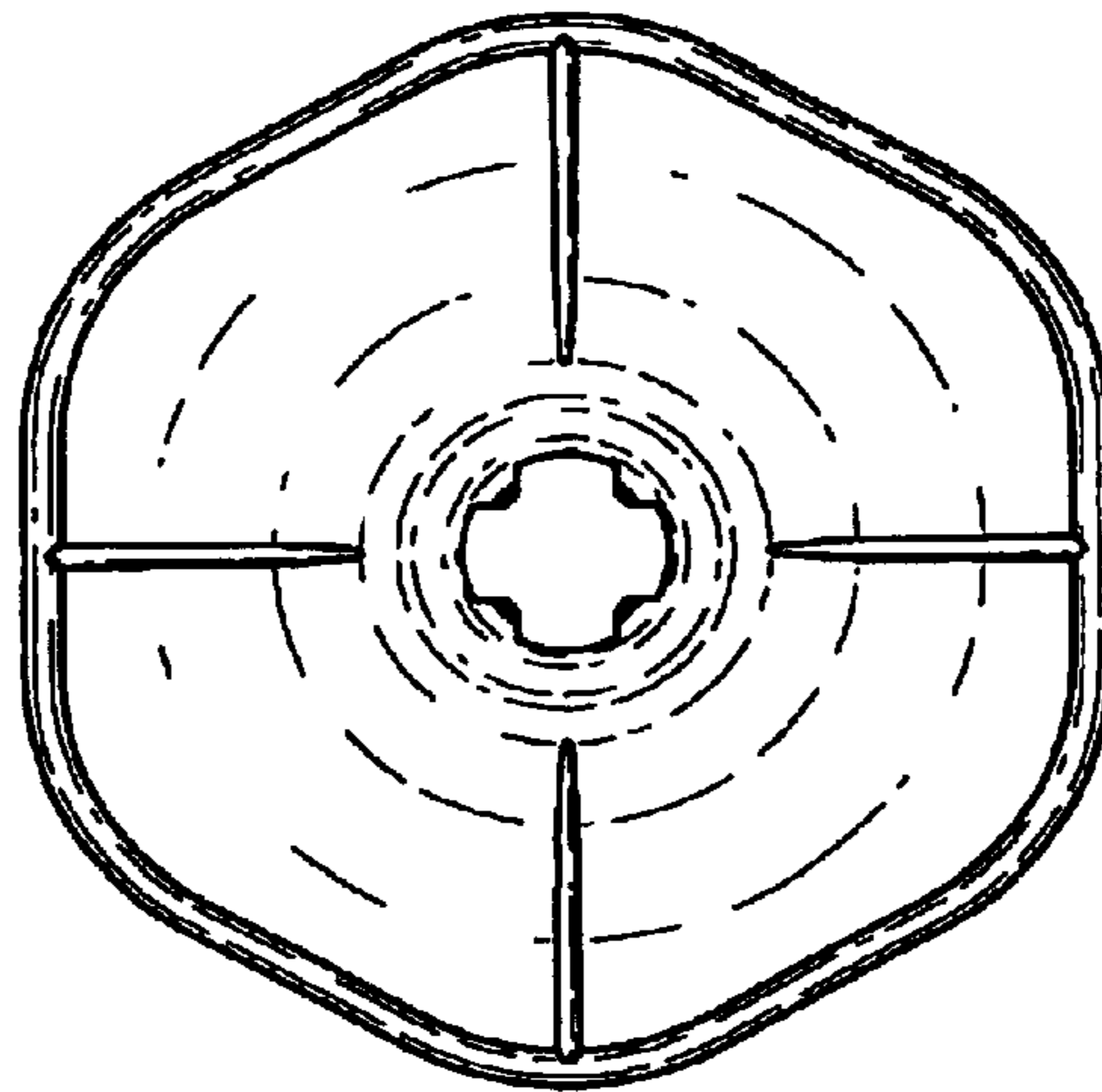

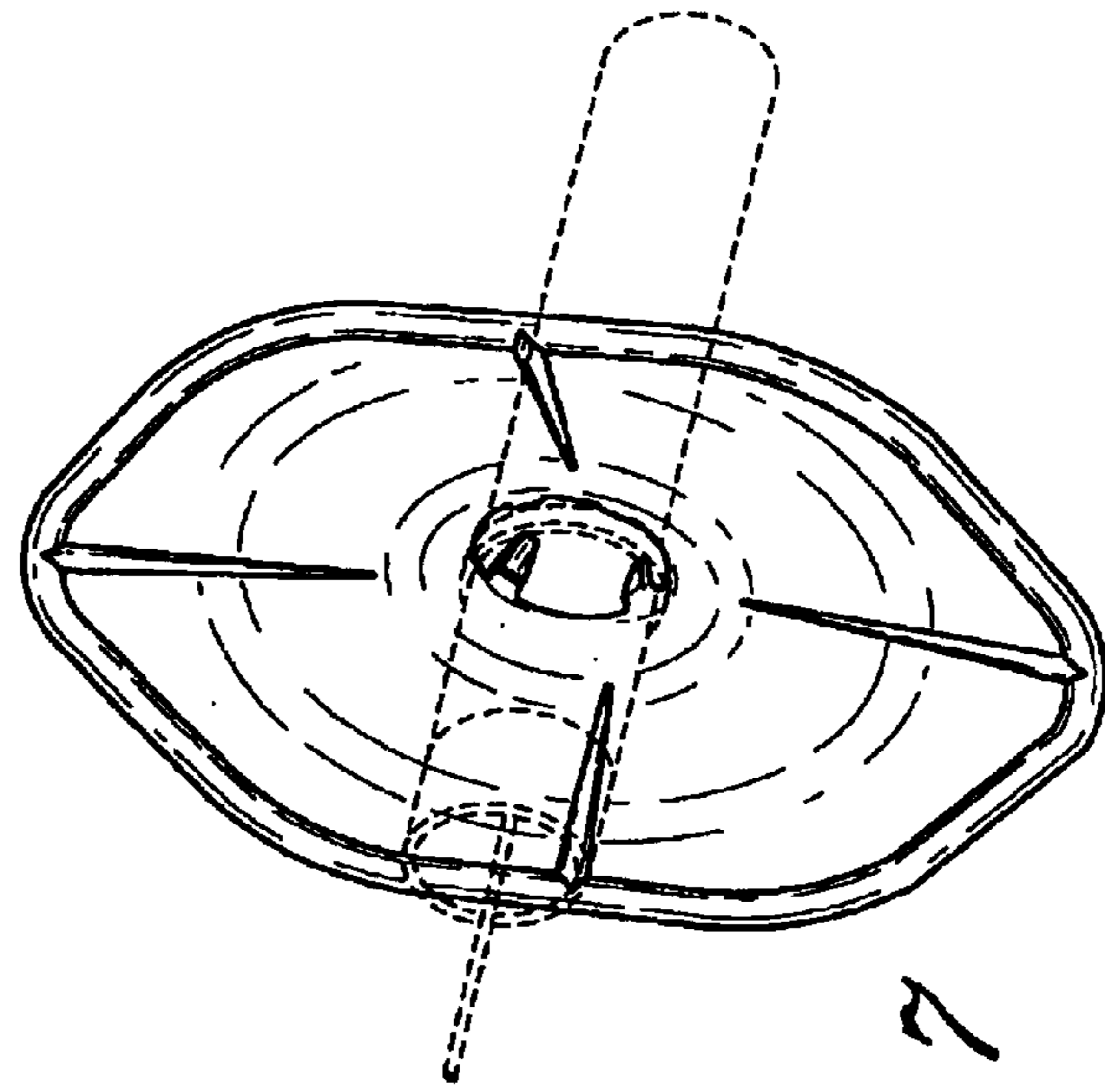
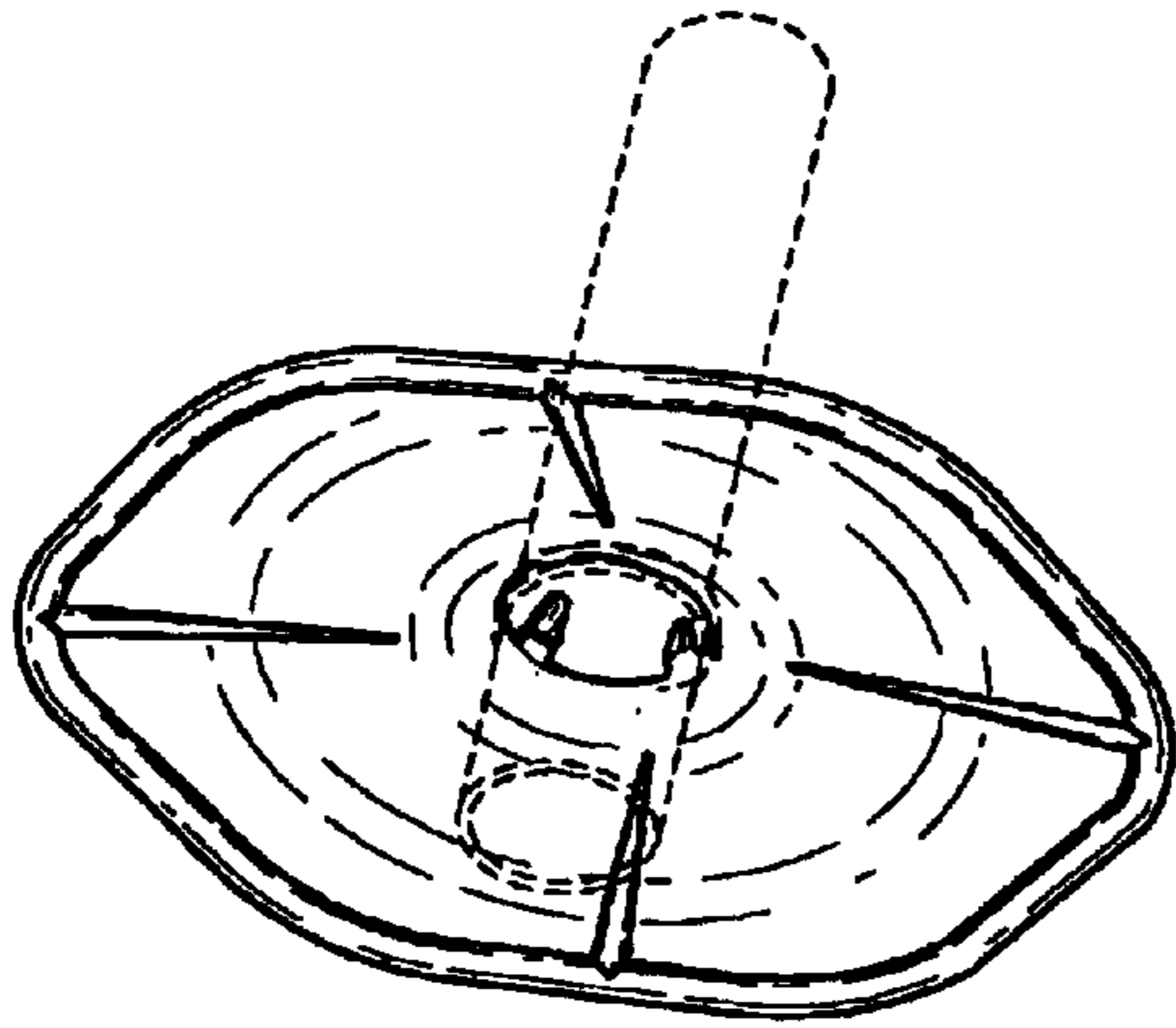

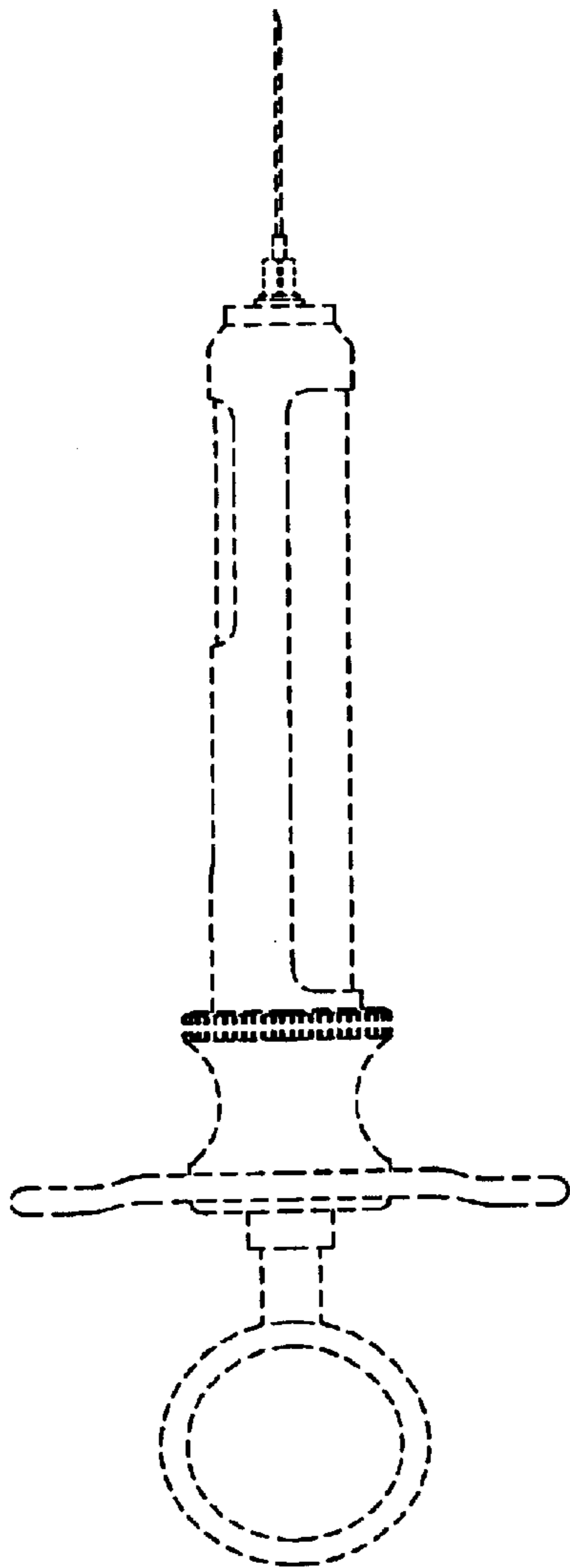
