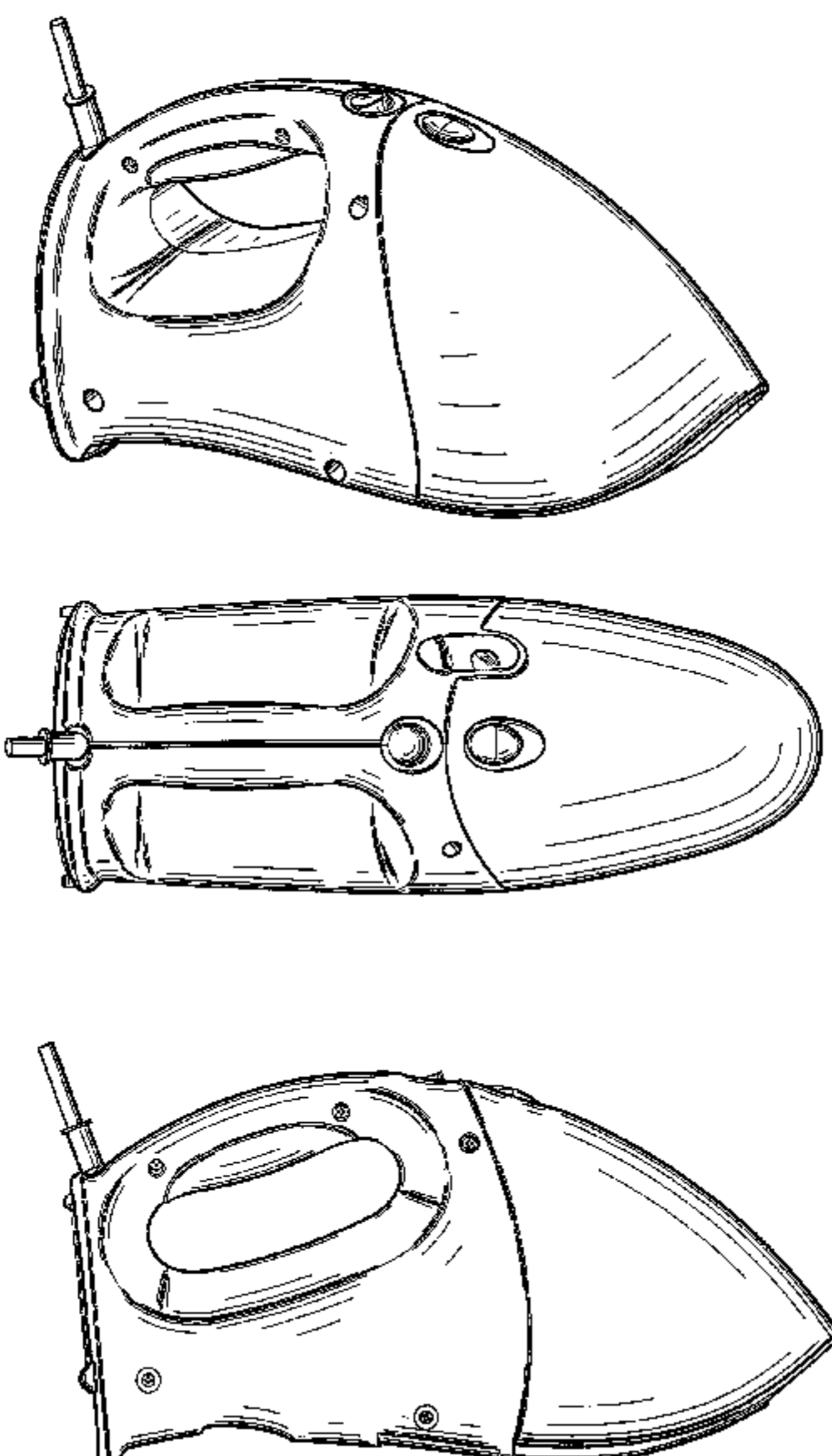

The ornamental design for a corded hand vacuum, as shown and described.

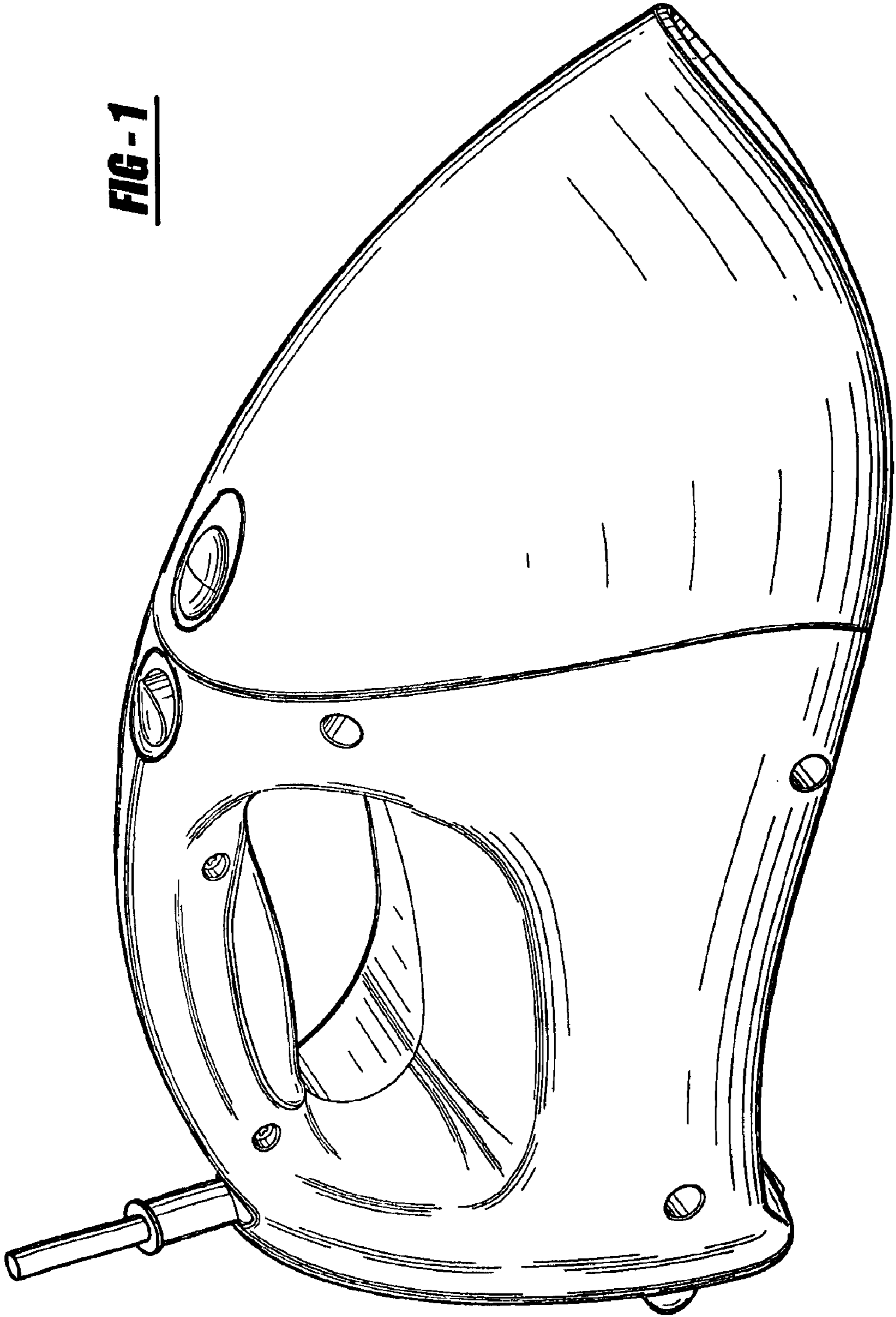
**DESCRIPTION**

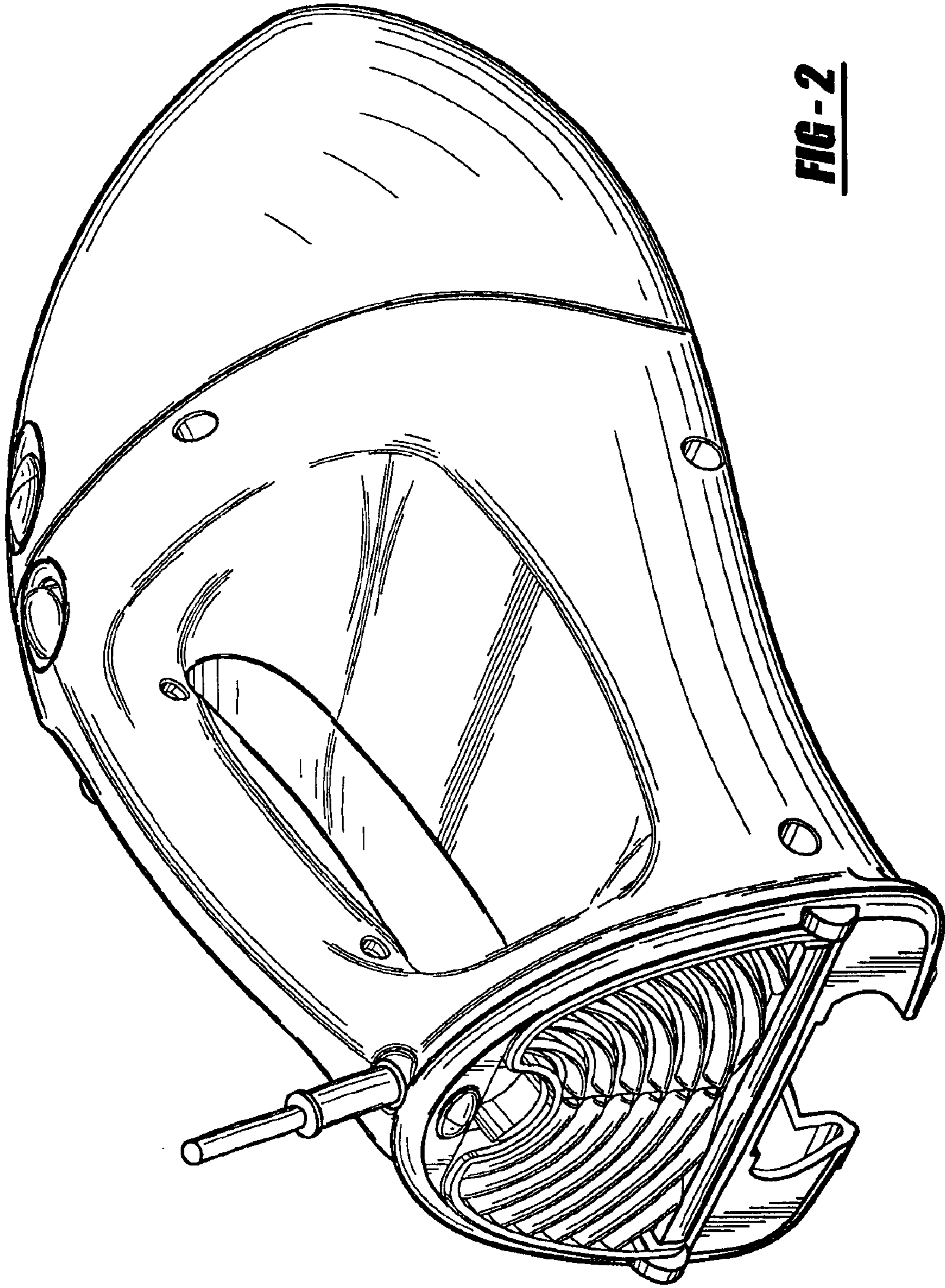
FIG. 1 is a perspective view of the right and front side of a corded hand vacuum, showing our new design;

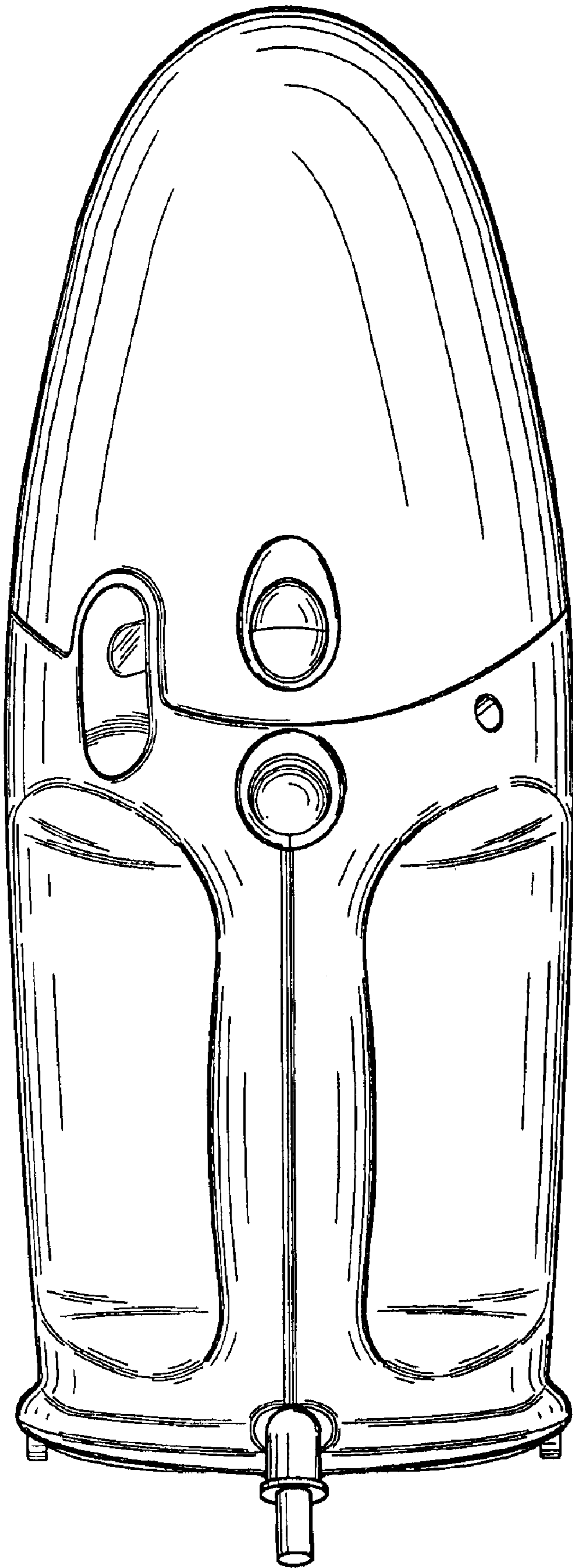

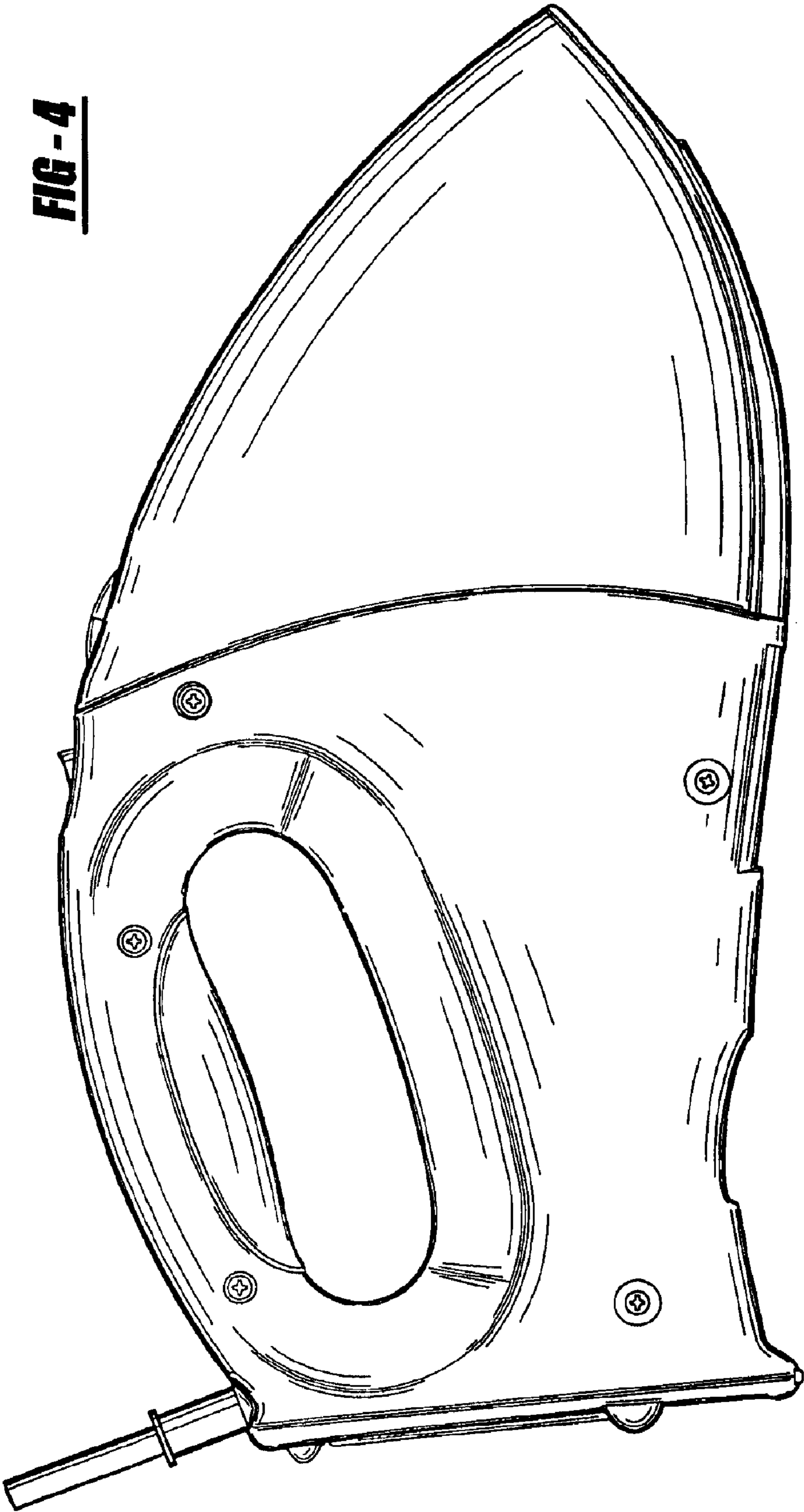


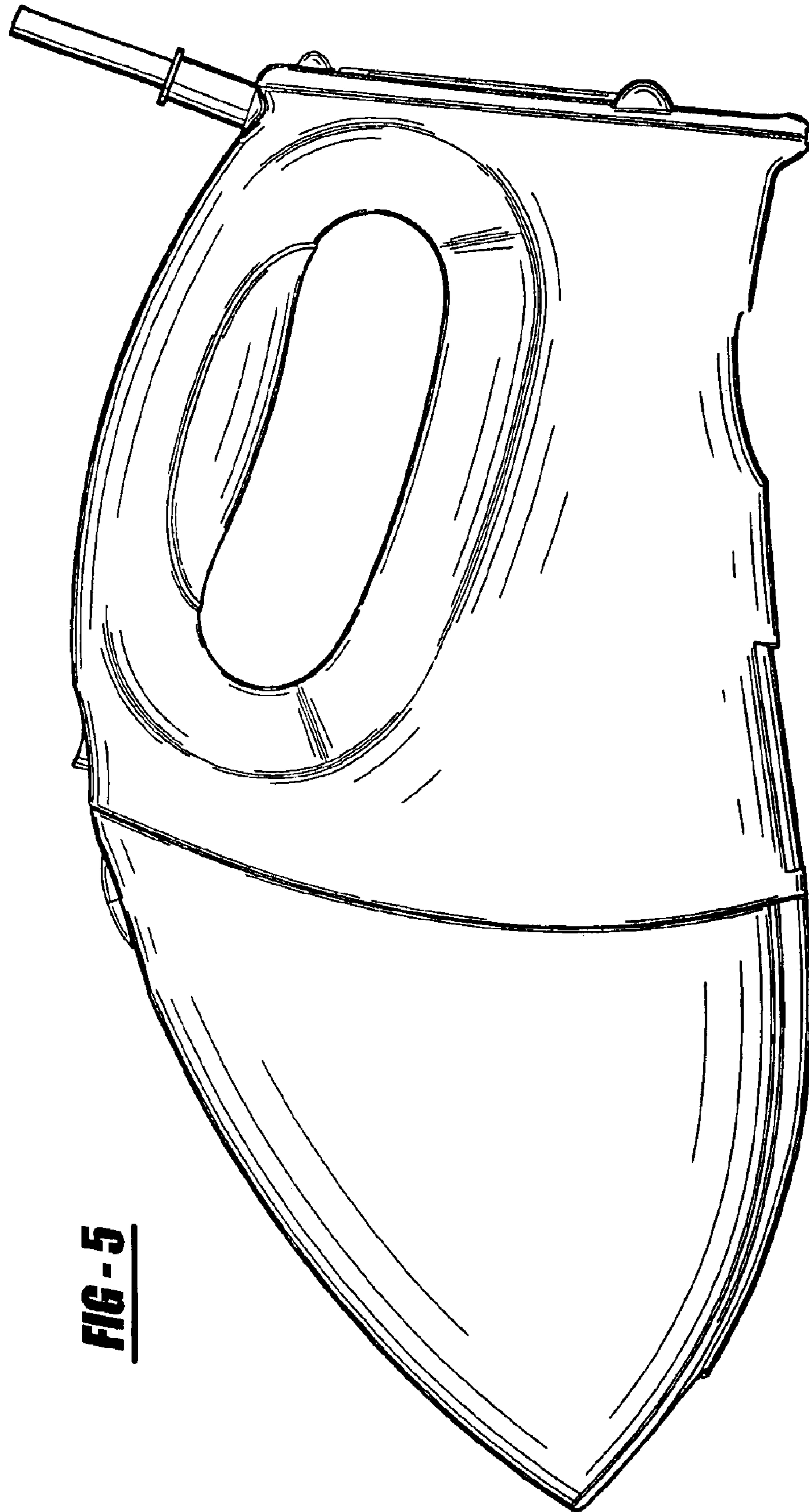

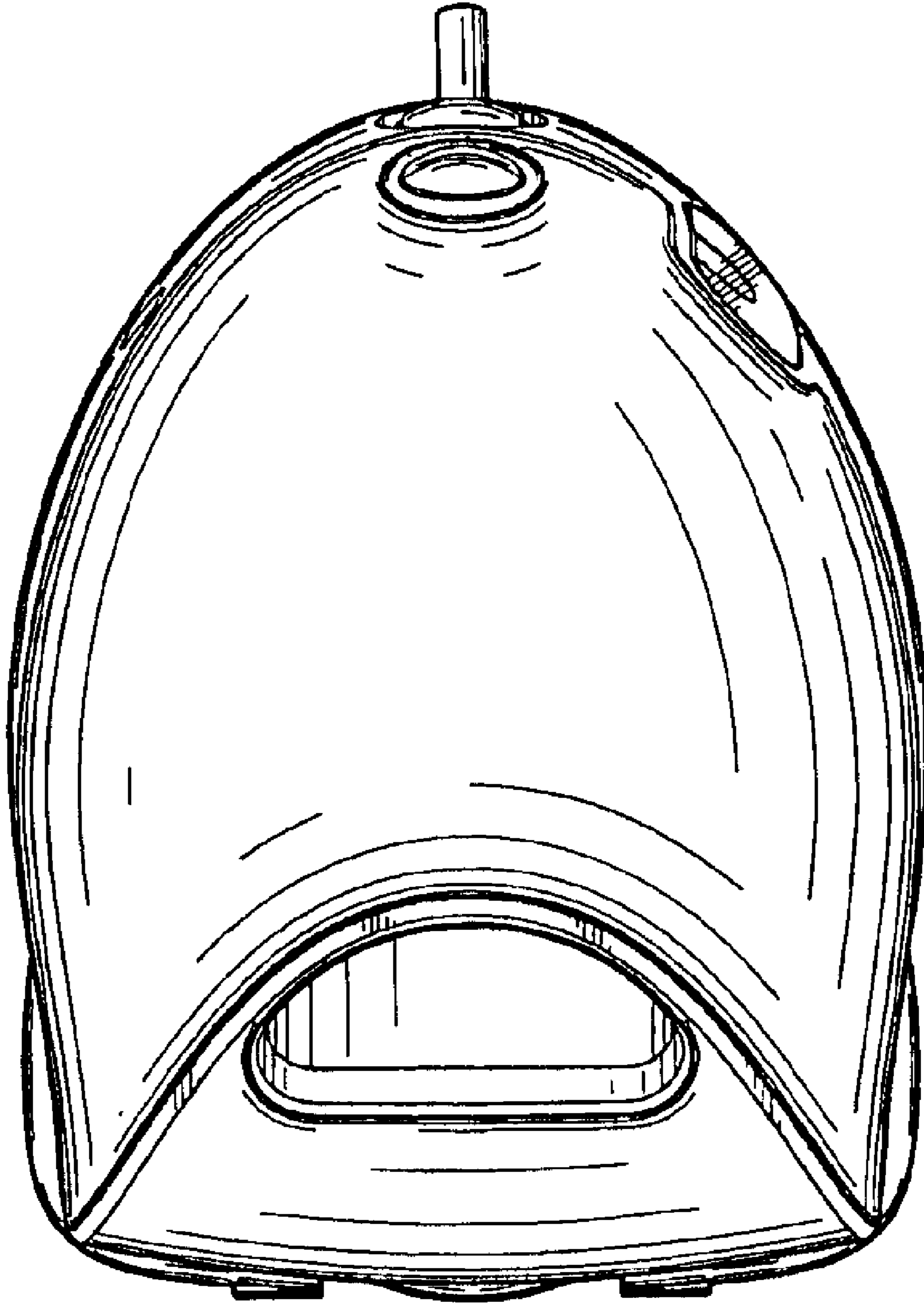

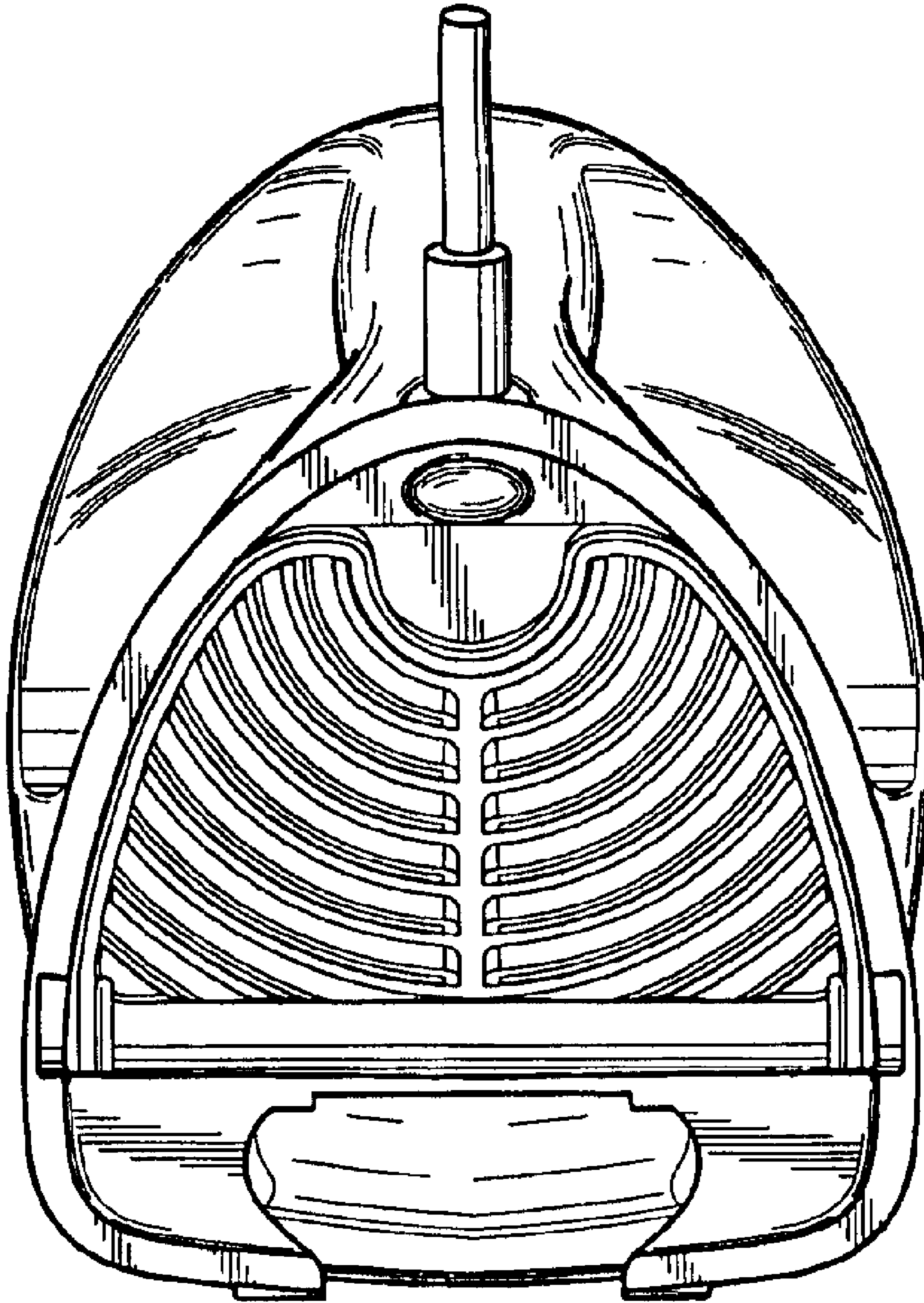

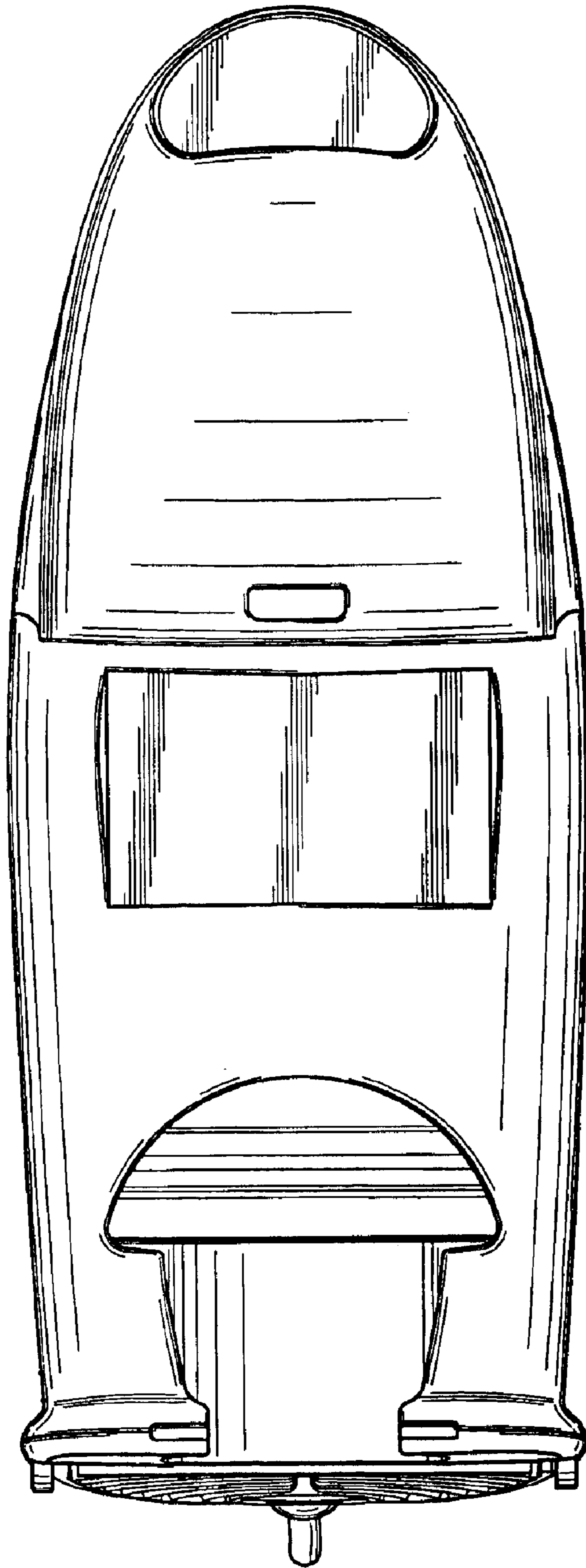
