(57) **CLAIM**

The ornamental design for a double articulating connector, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a double articulating connector showing my new design.

FIG. 2 is a front plan view thereof.

FIG. 3 is a right side view thereof.

FIG. 4 is a left side view thereof.

FIG. 5 is a top plan view thereof.

FIG. 6 is a bottom plan view thereof.

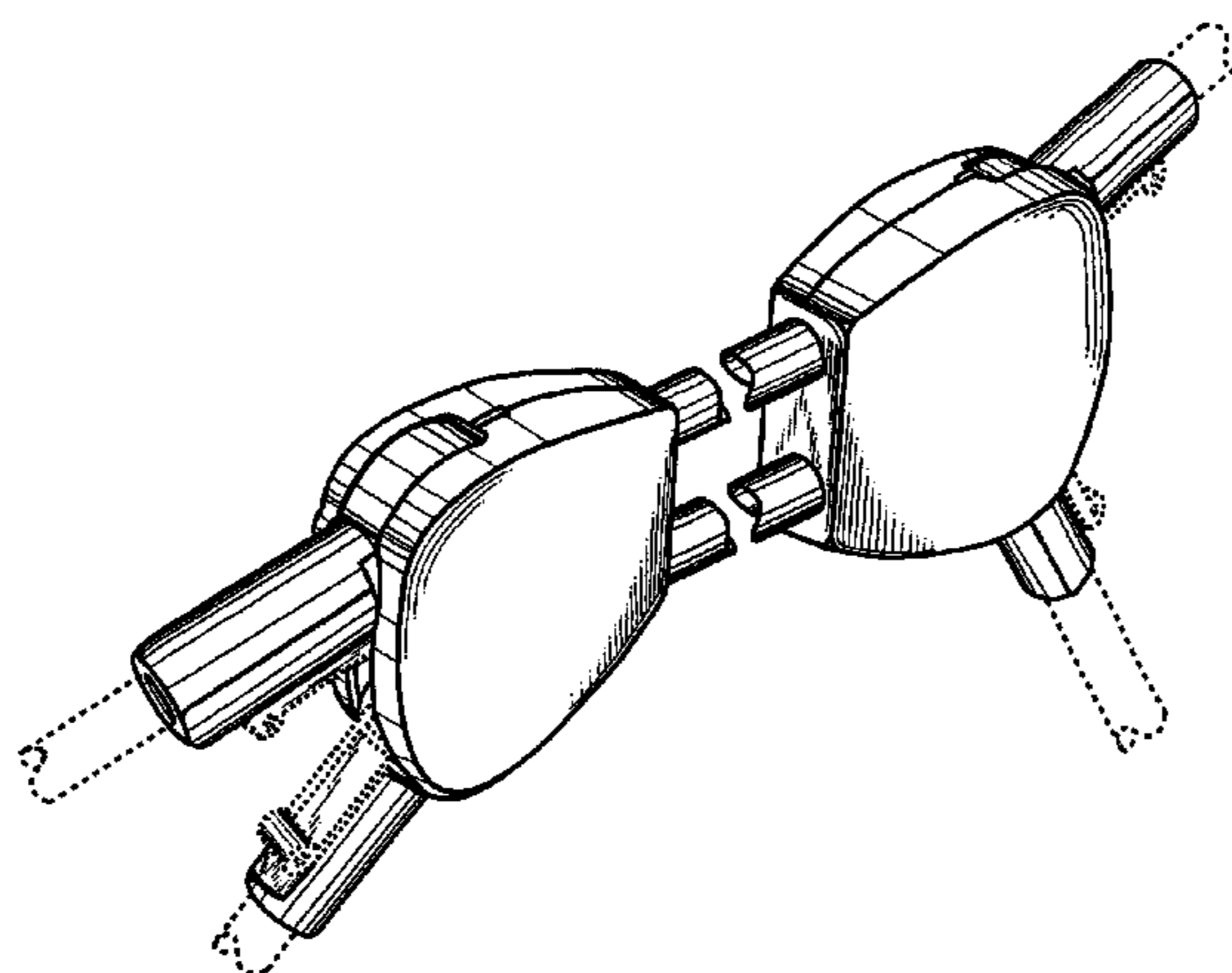
FIG. 7 is a rear plan view thereof; and,

FIG. 8 is an isometric view of a double articulating connector in the environment of an adjustable joining mechanism in a furniture item.

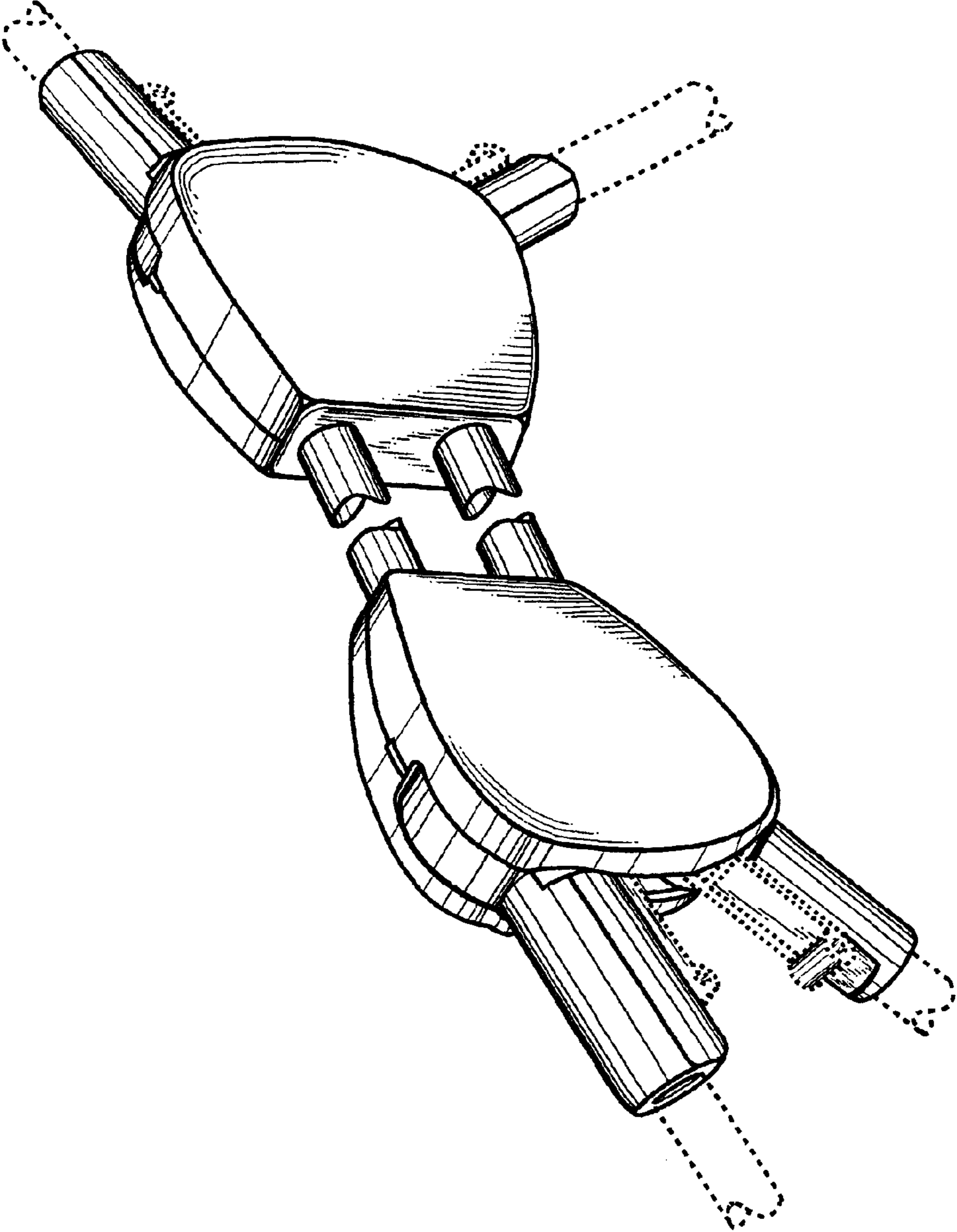

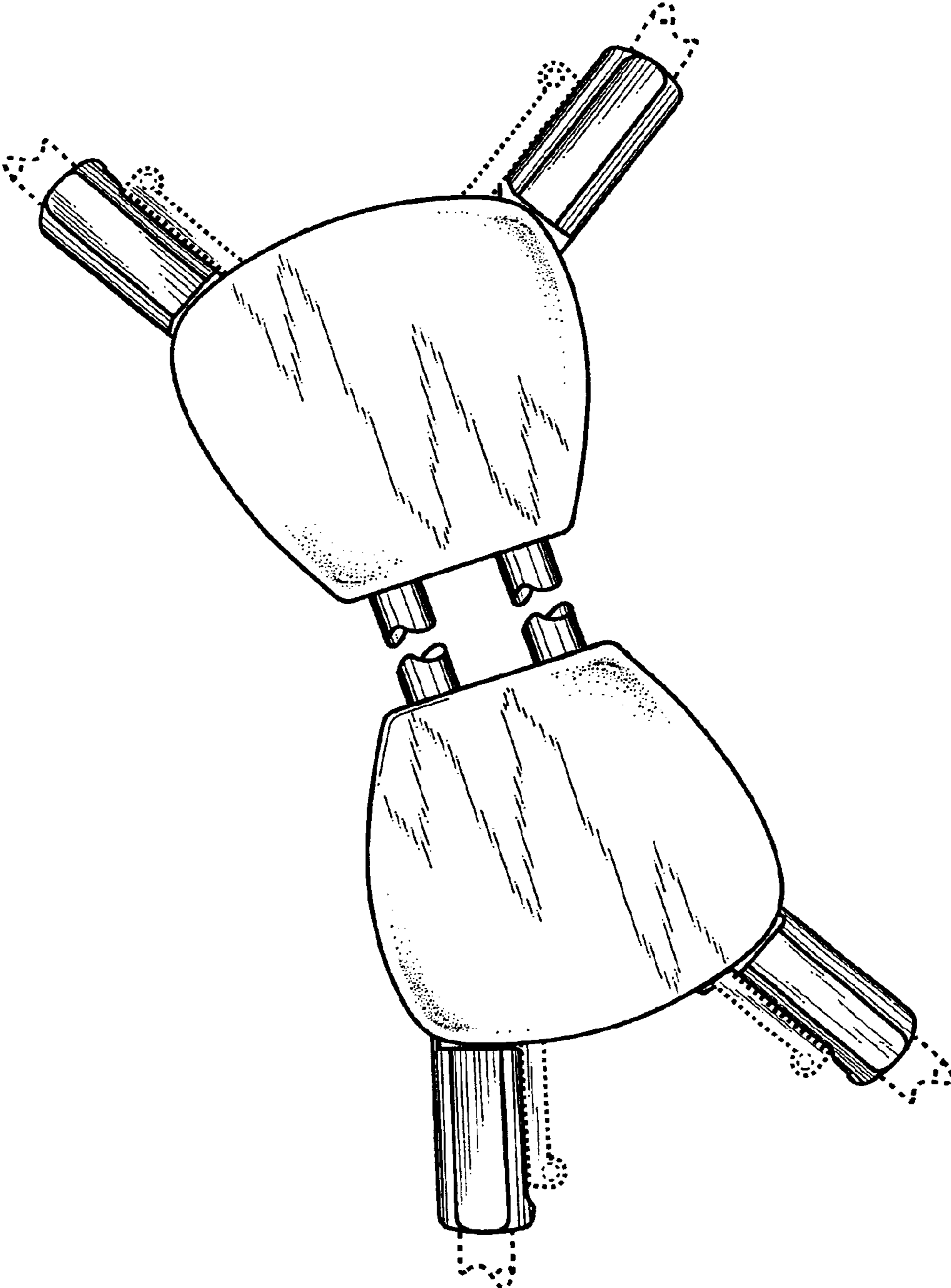

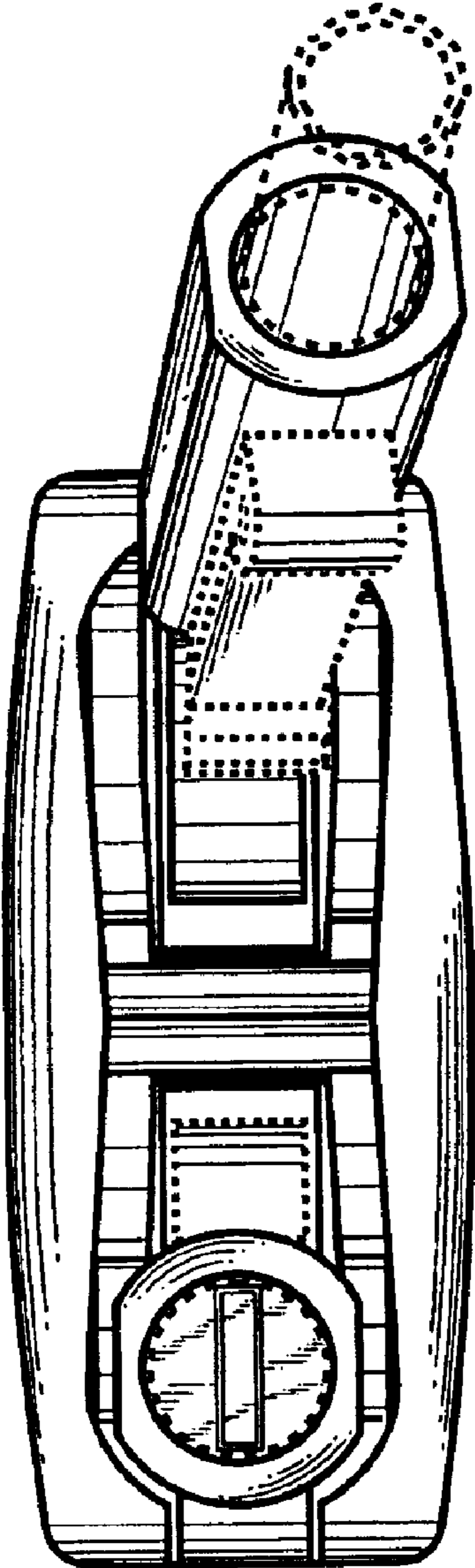

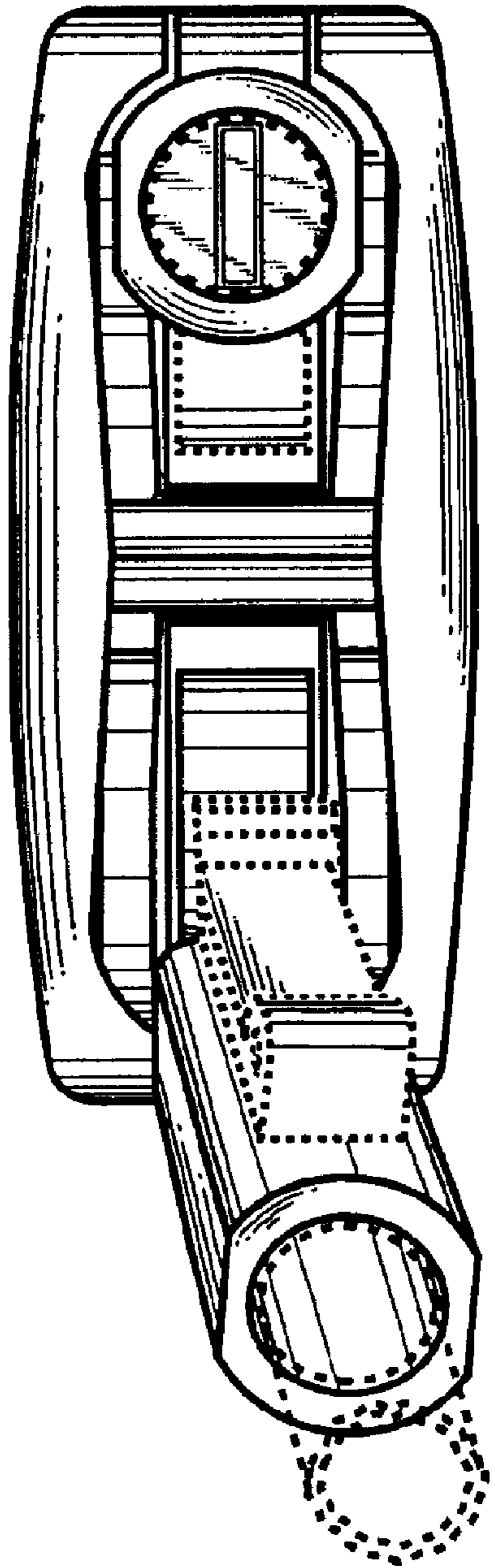

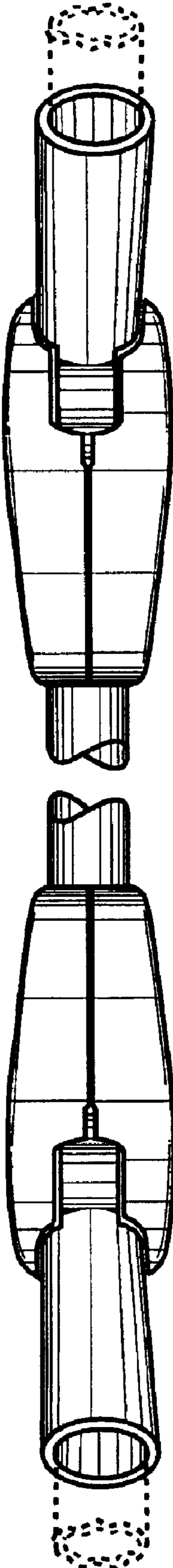

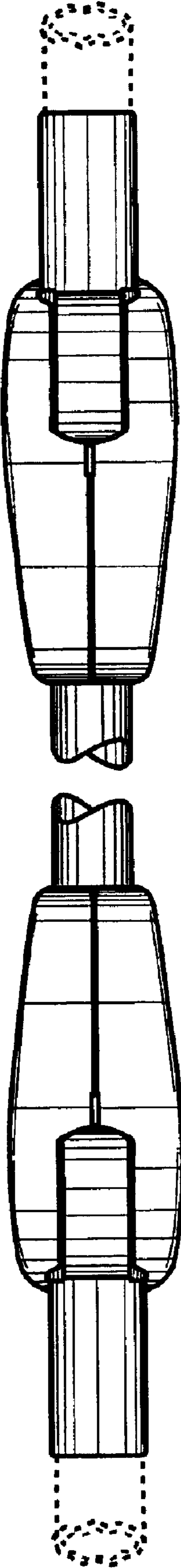

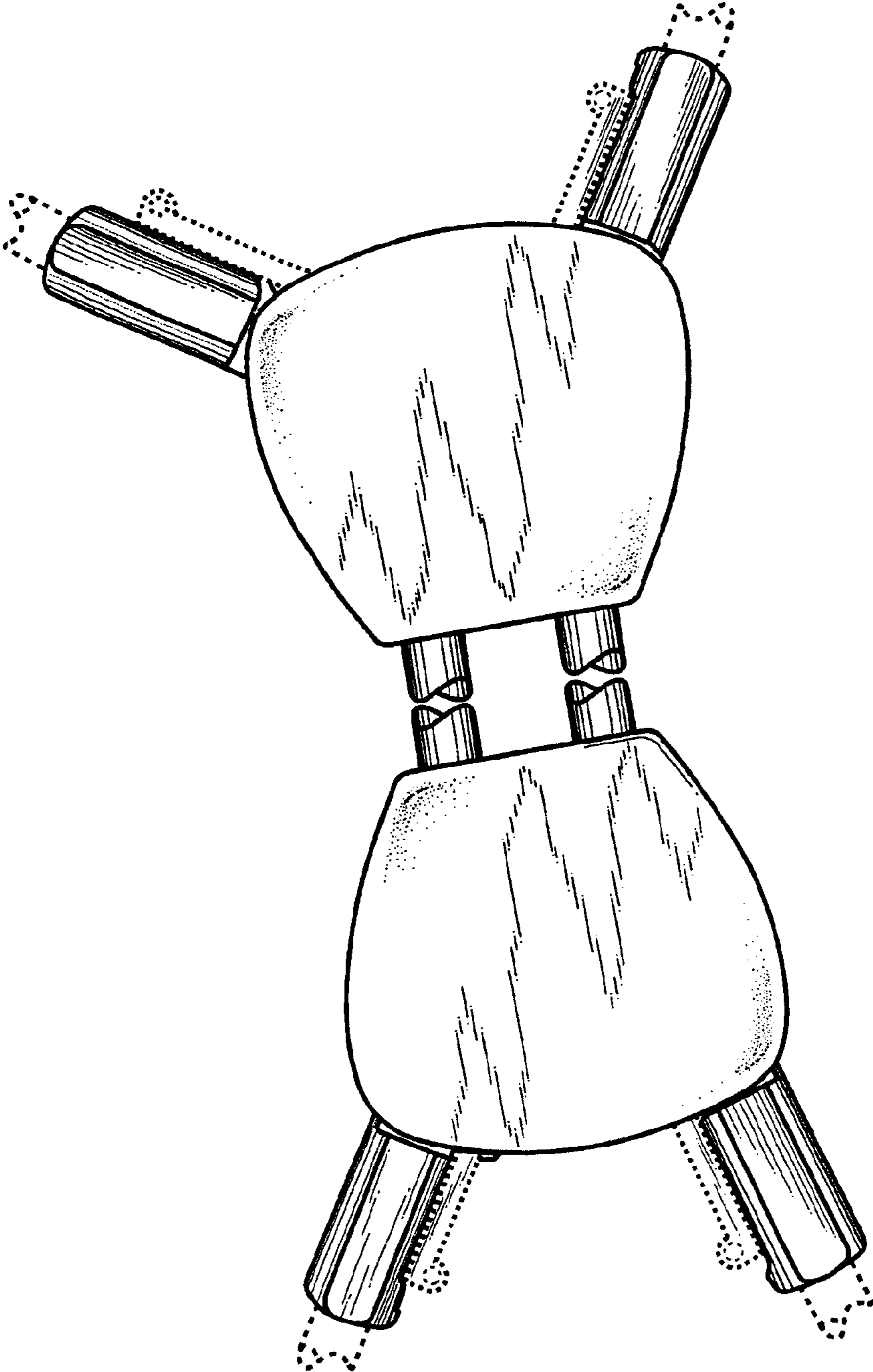
