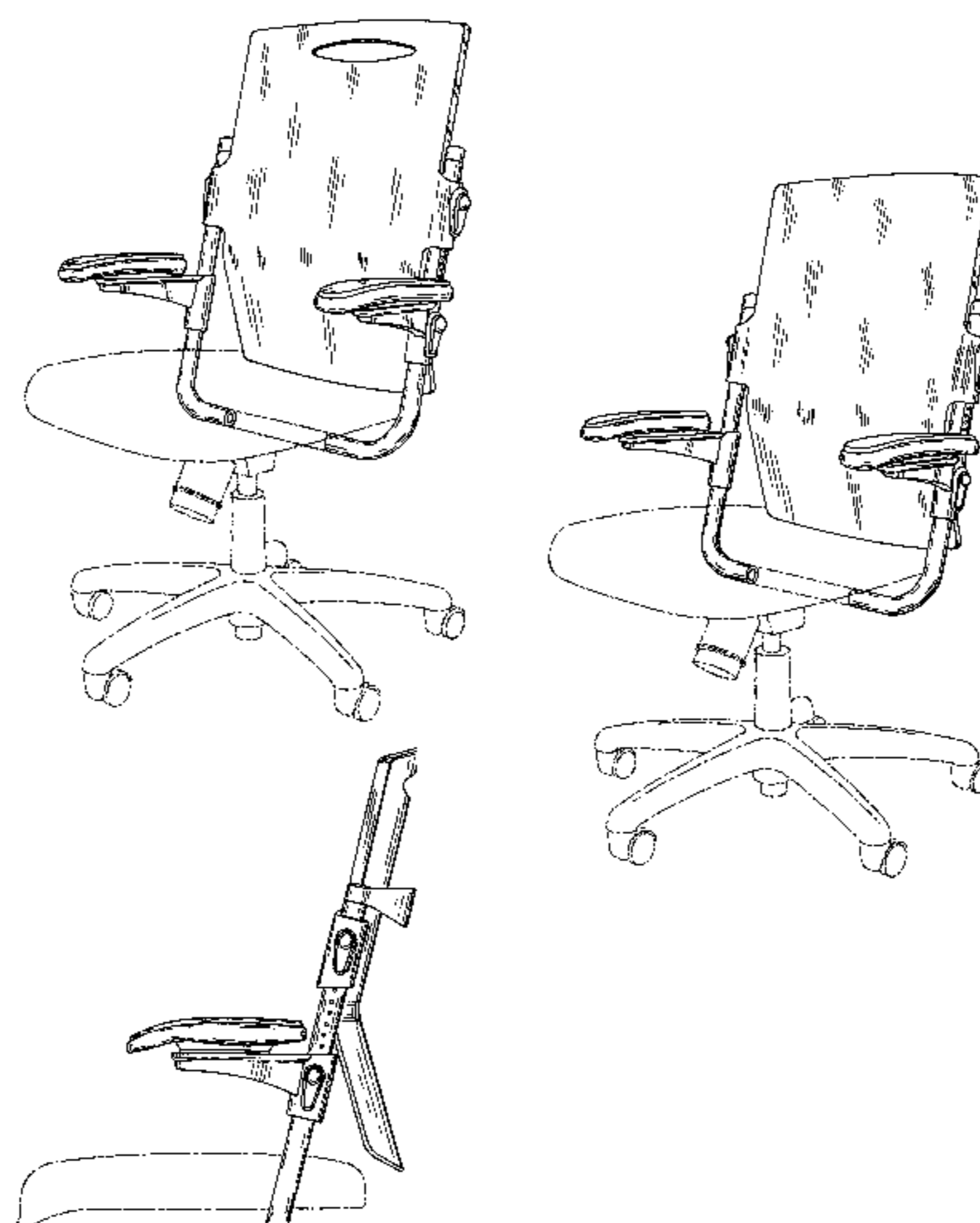

FIG. 11 is a left side view thereof;  
FIG. 12 is a right side view thereof; and,  
FIG. 13 is a top view of thereof.

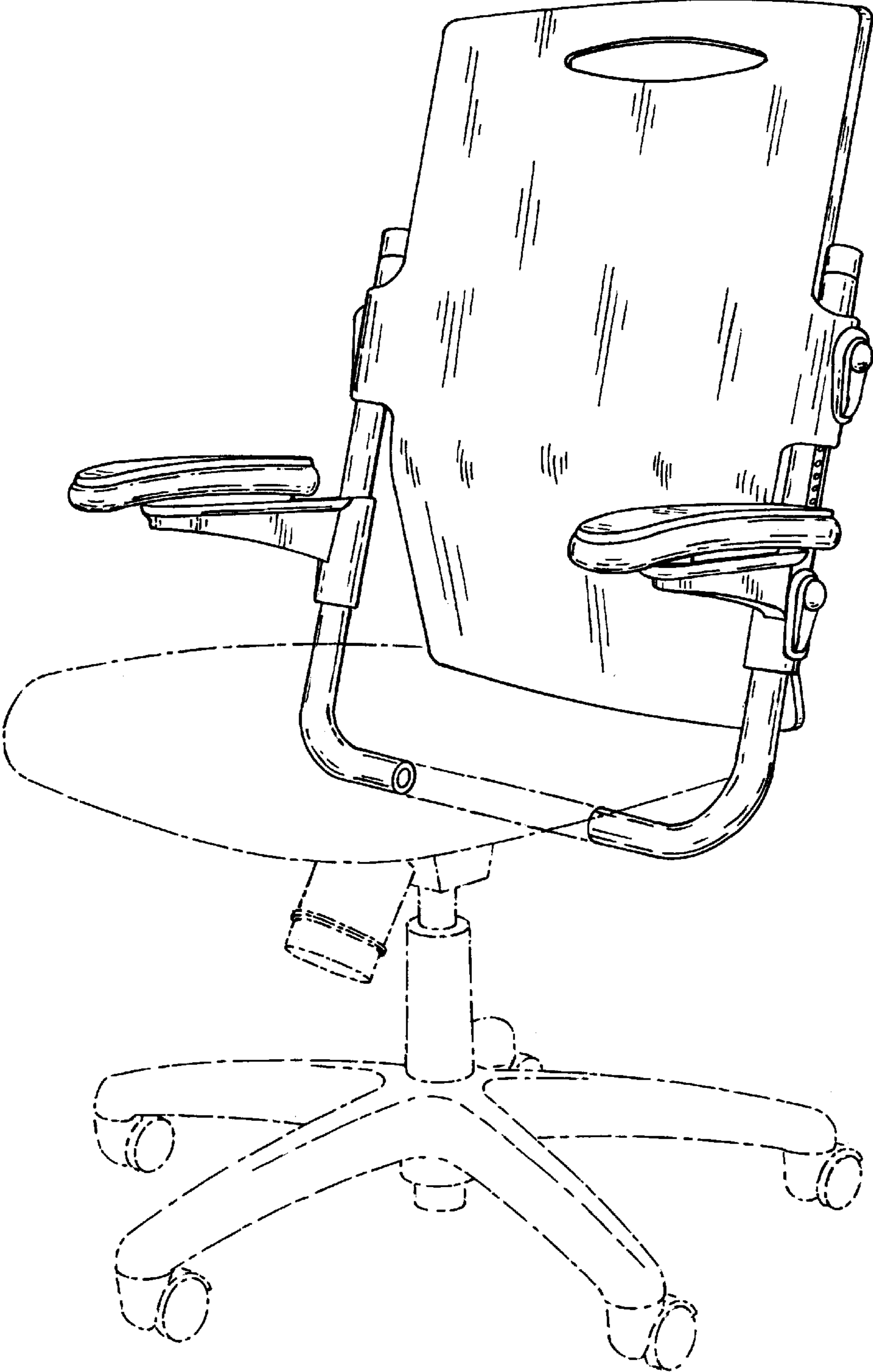

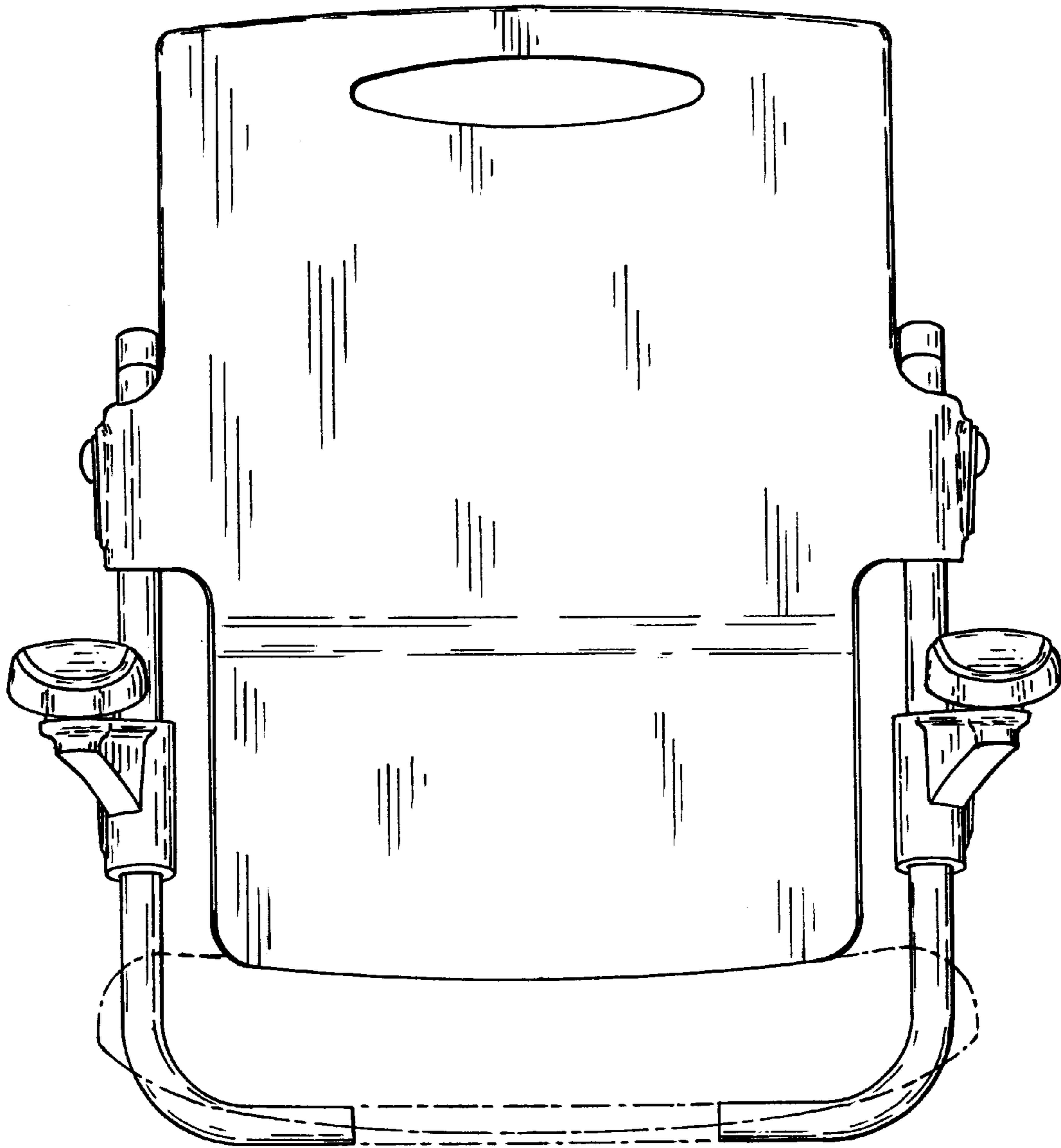

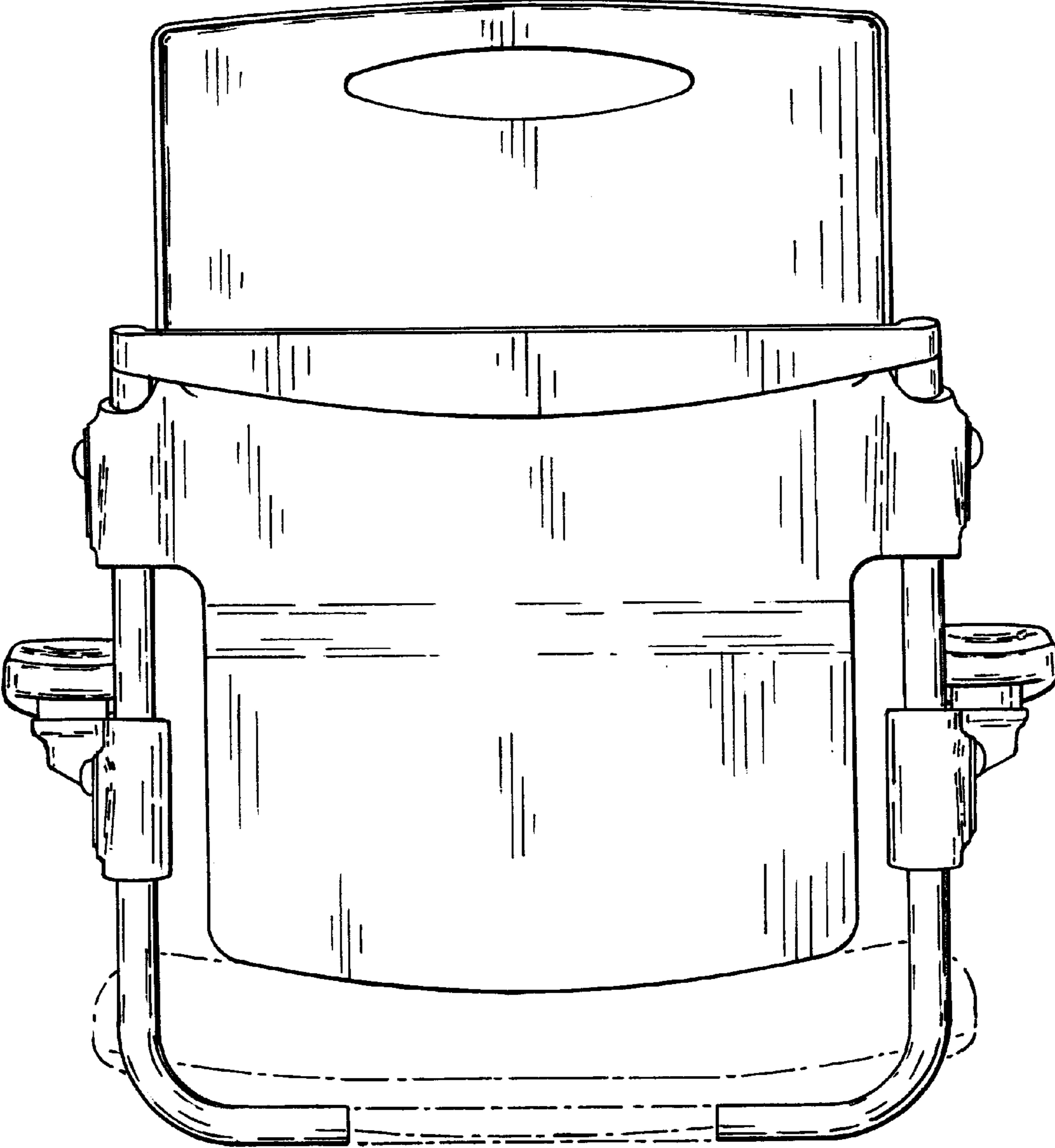

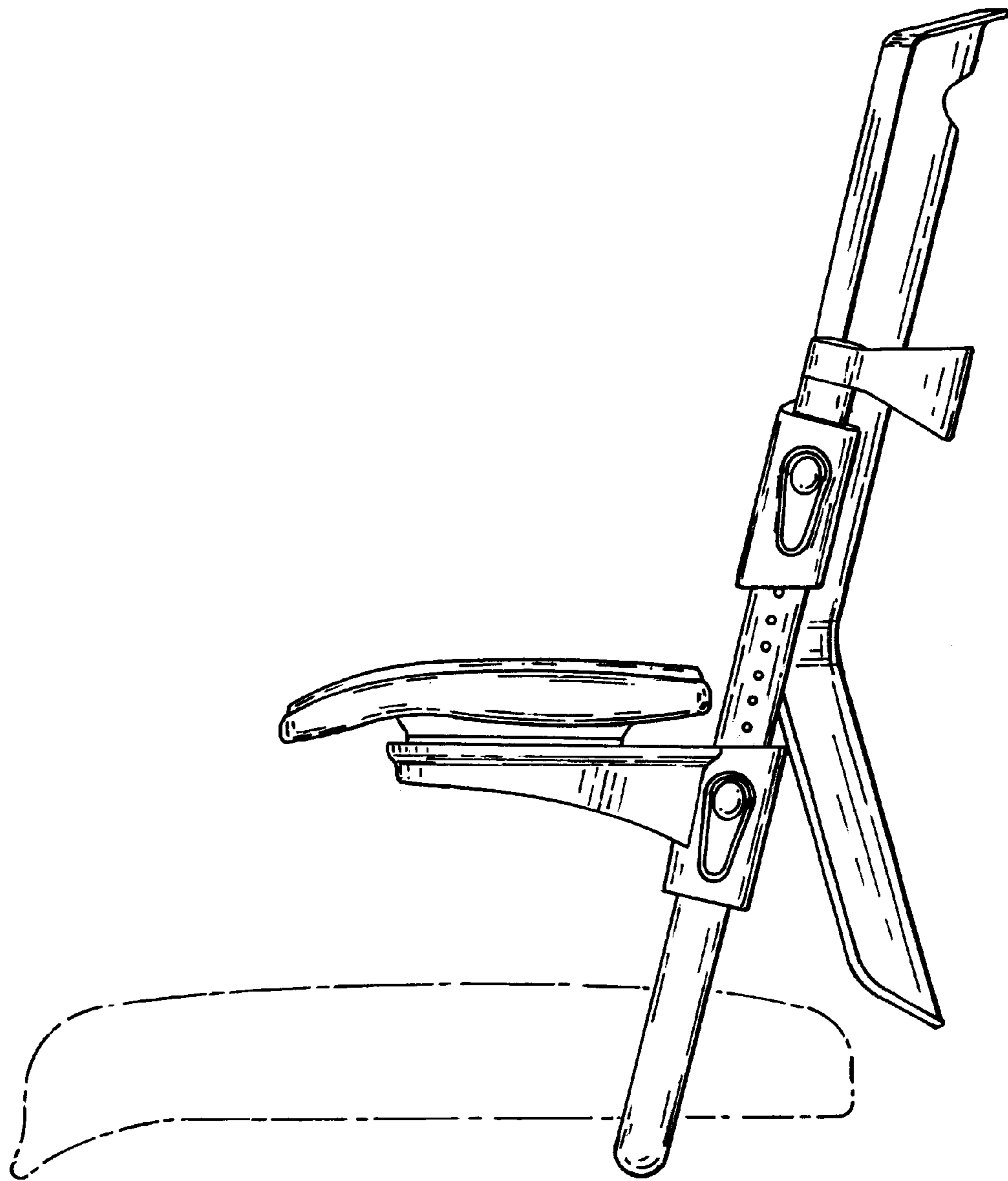

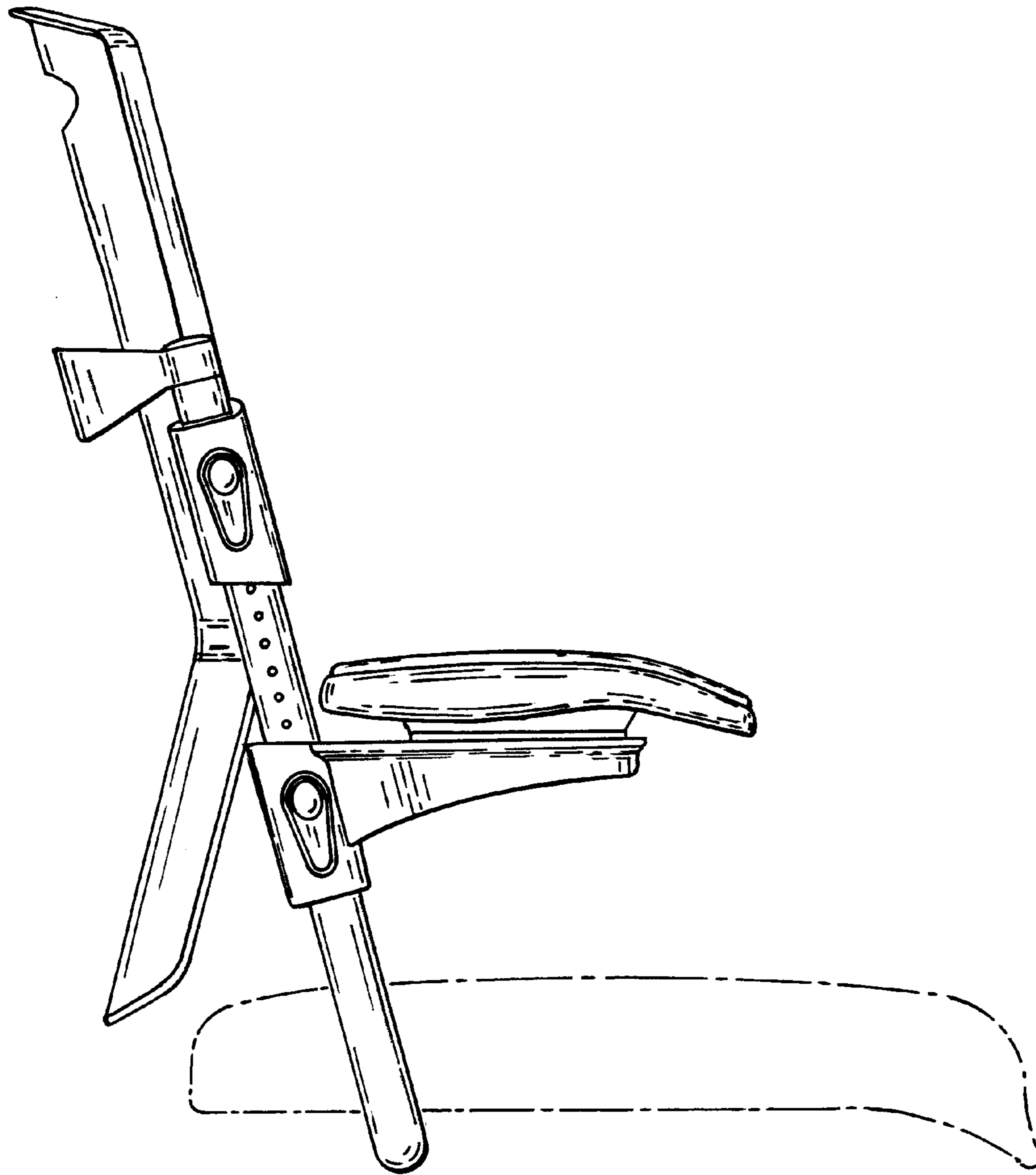

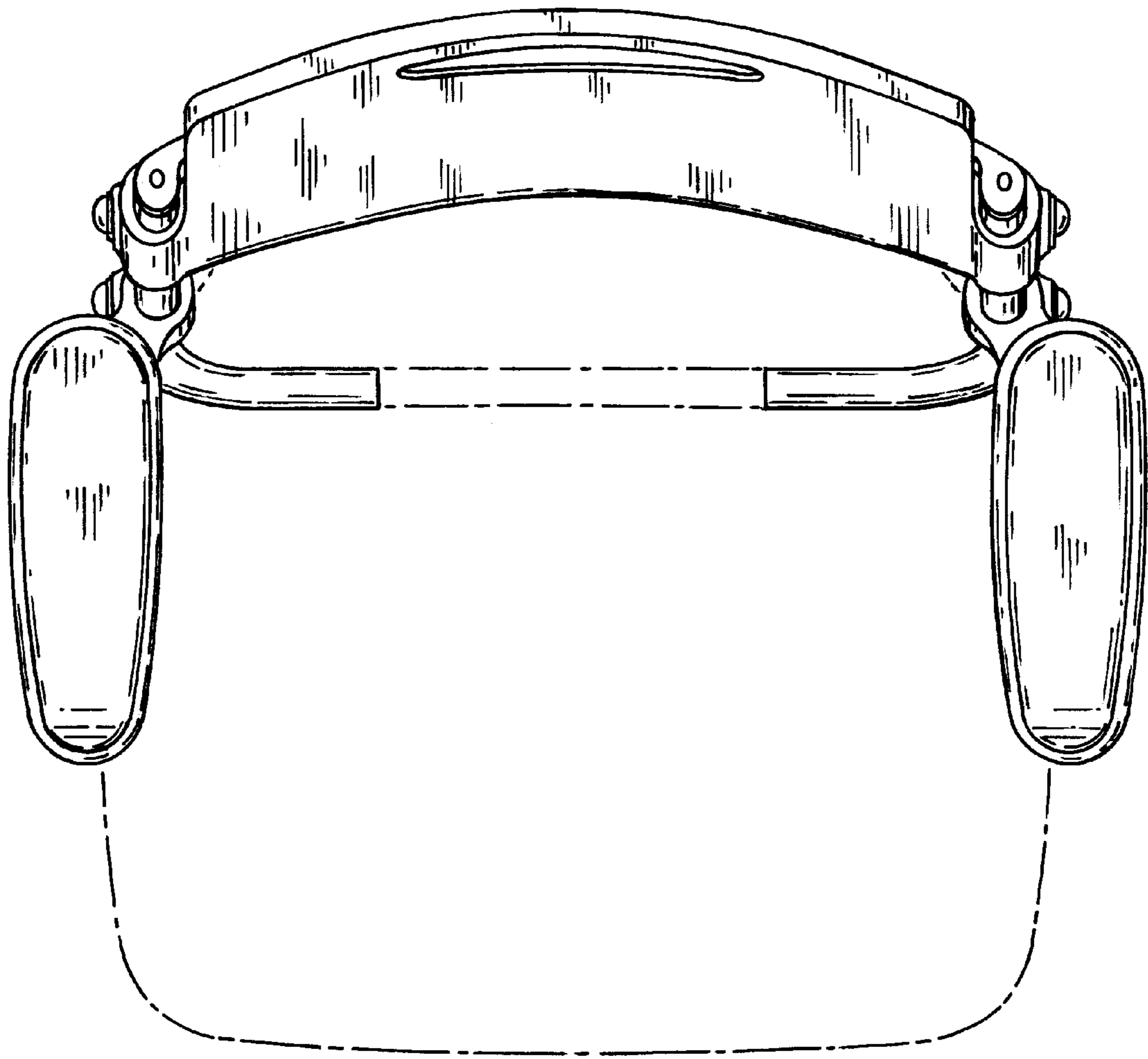

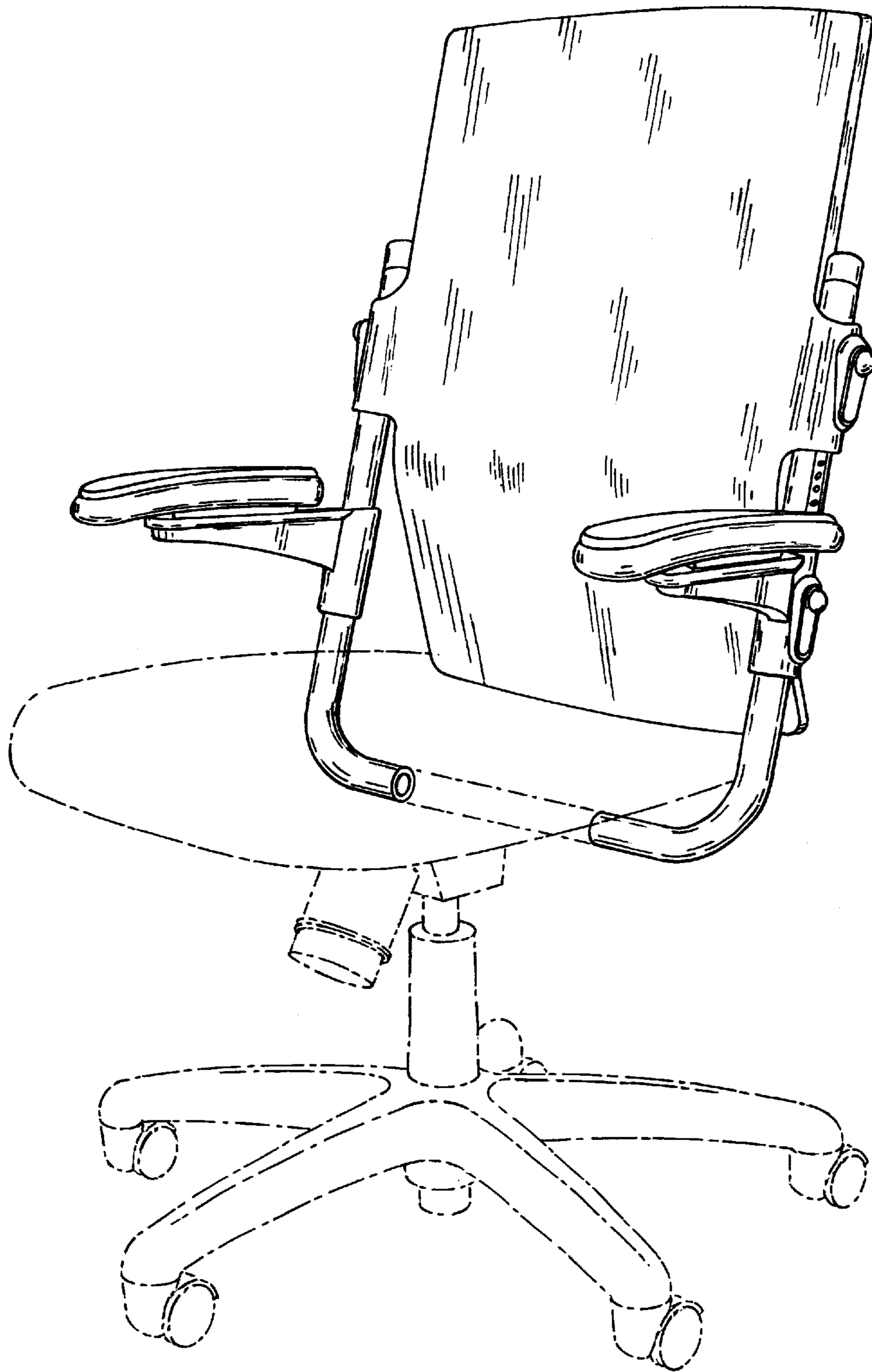

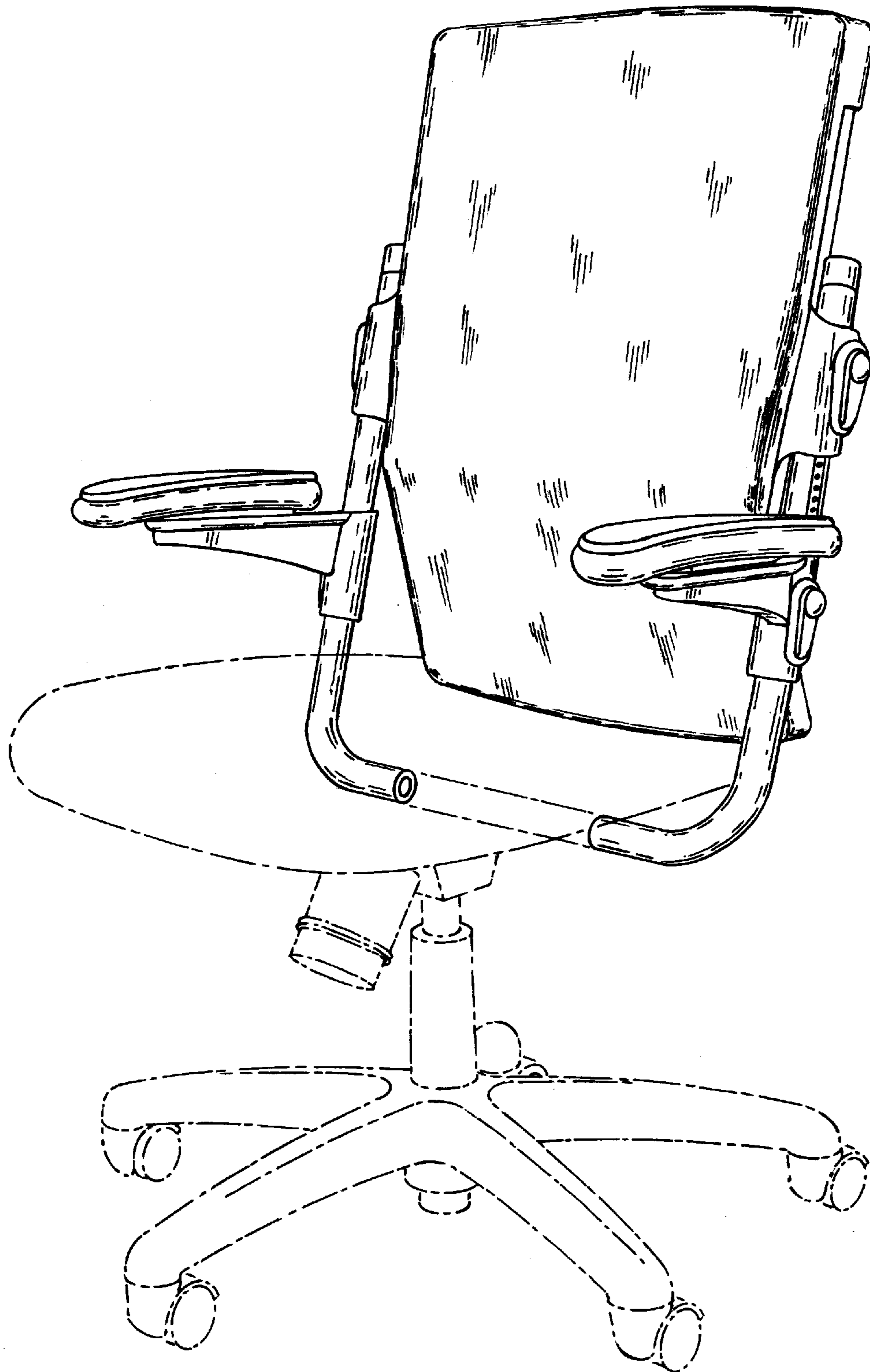

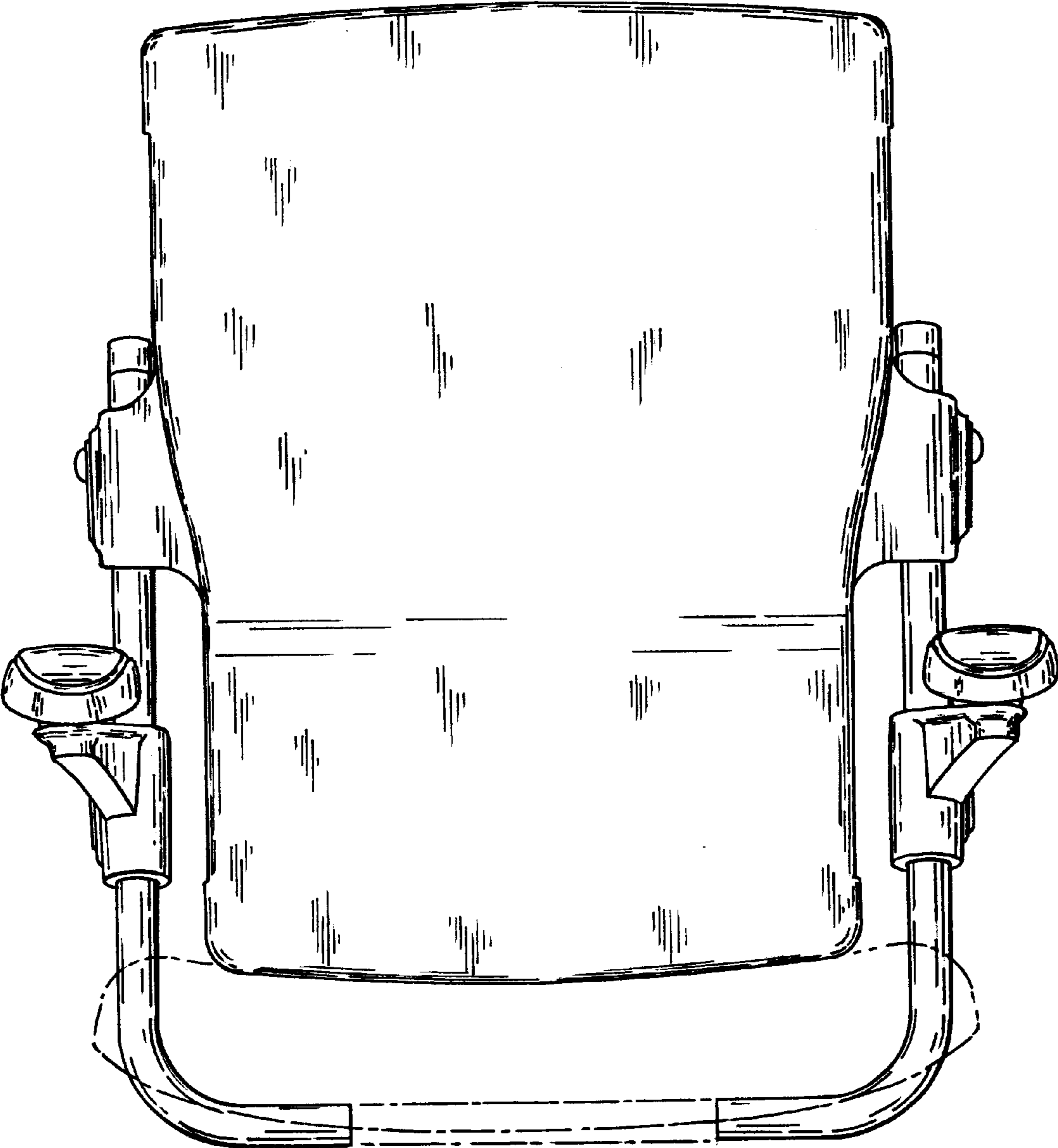

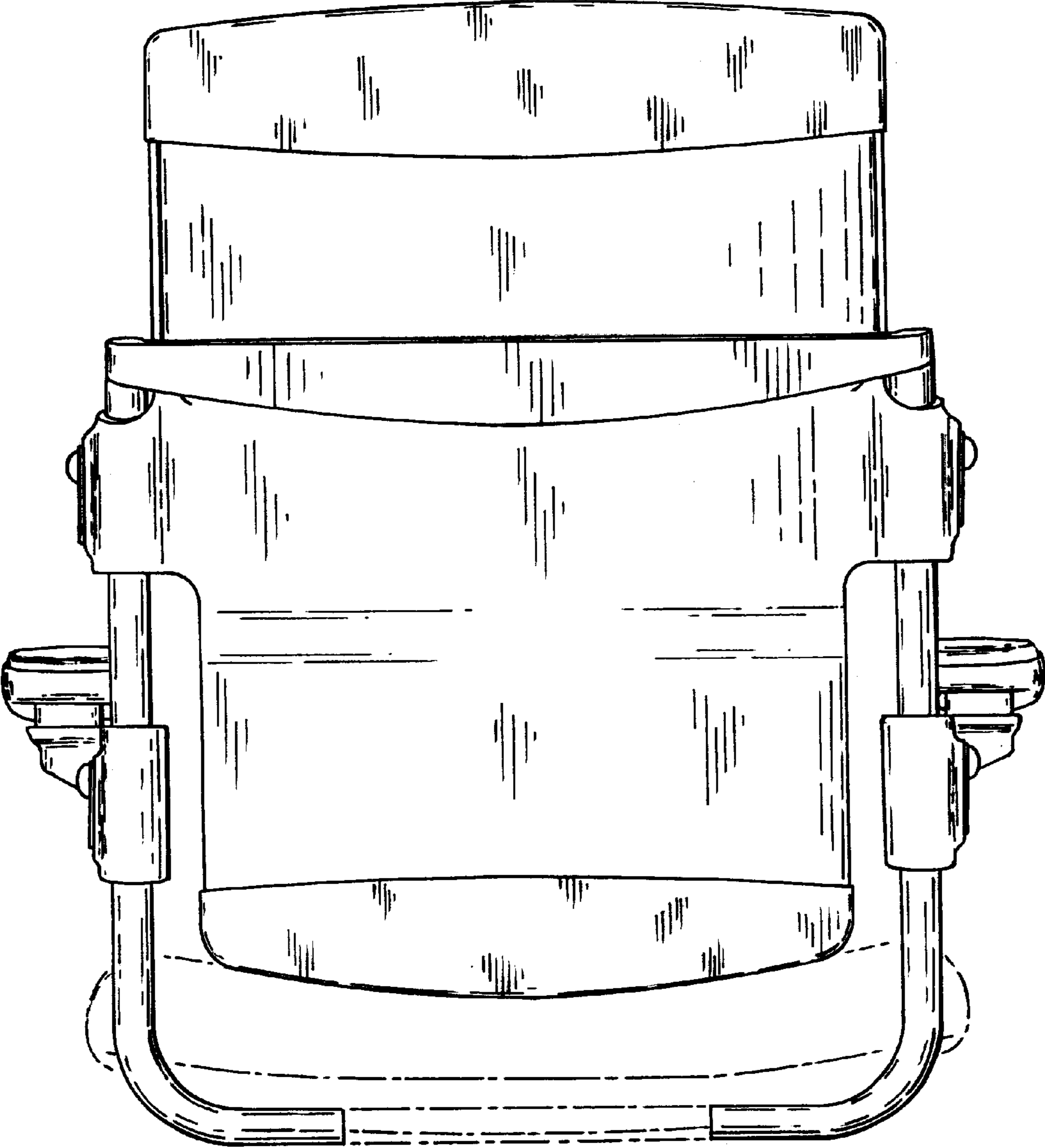

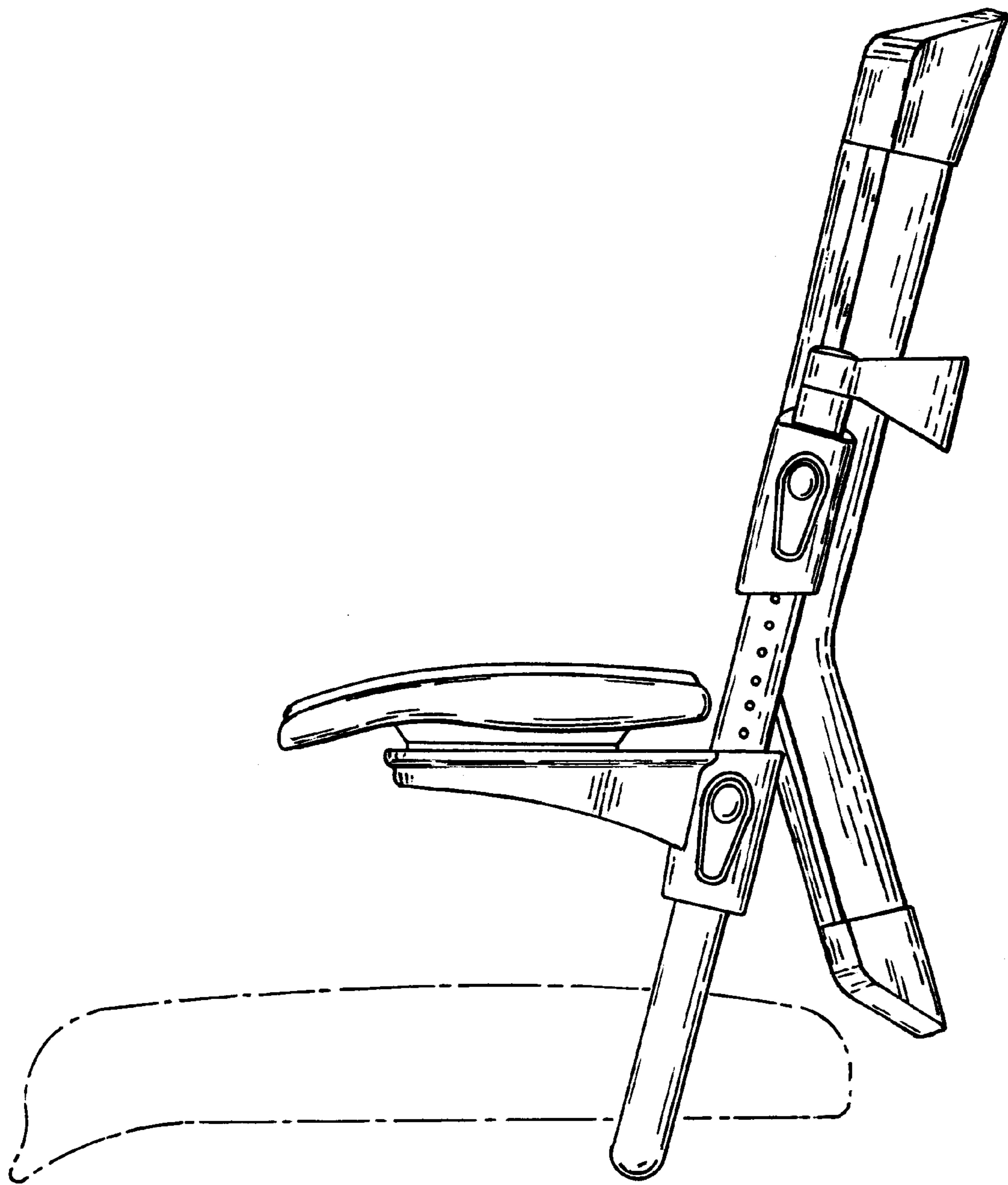

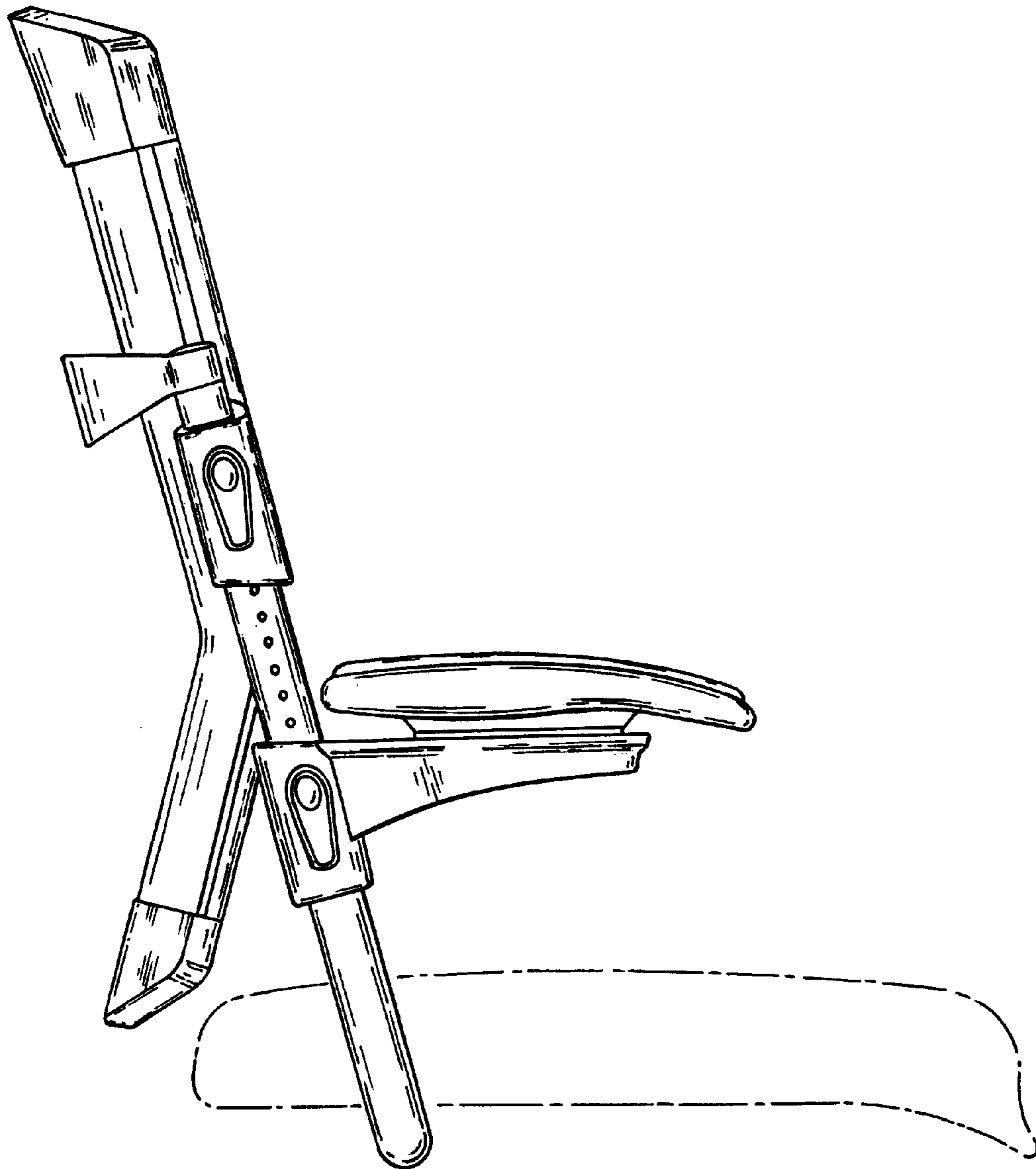

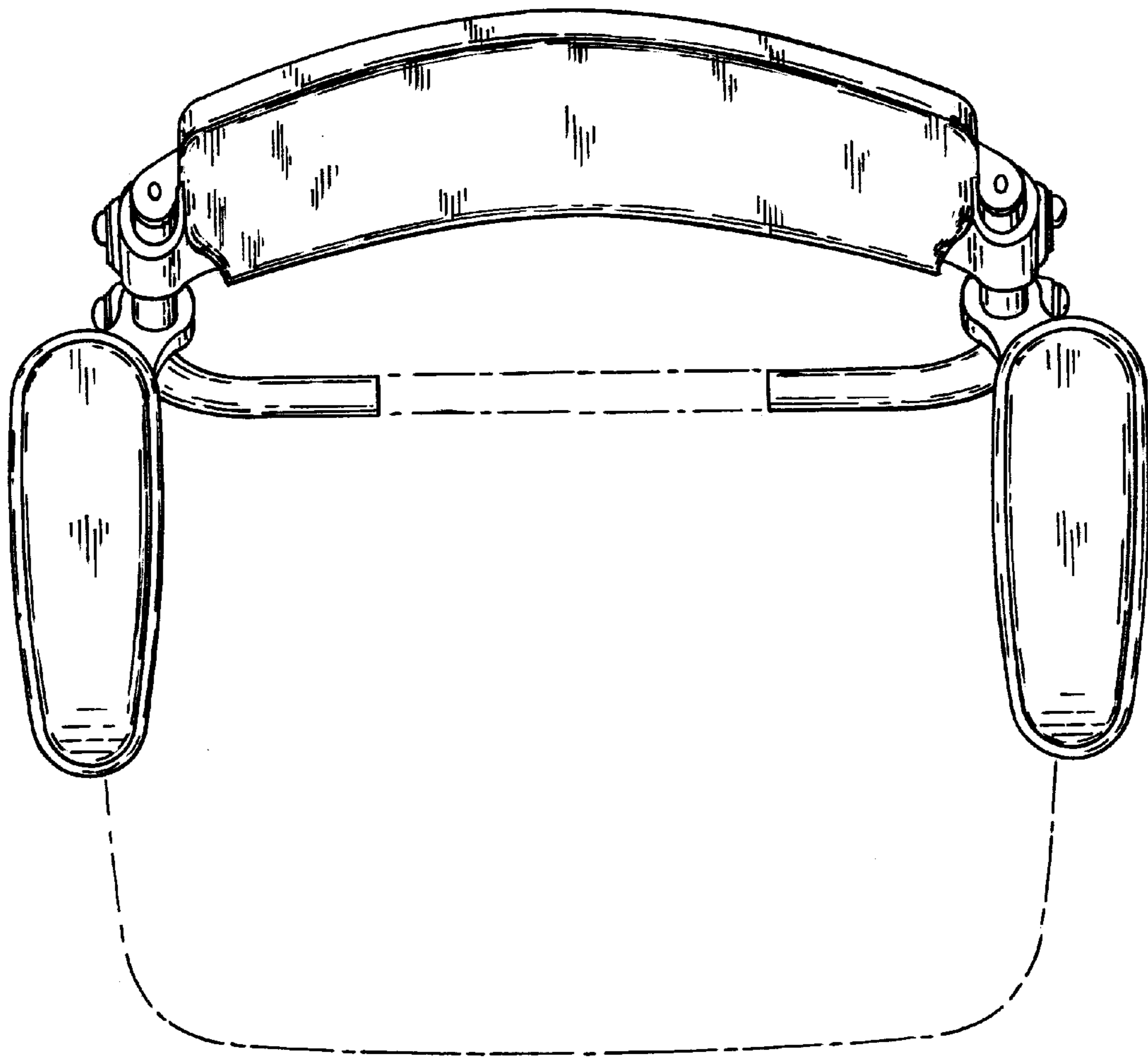
