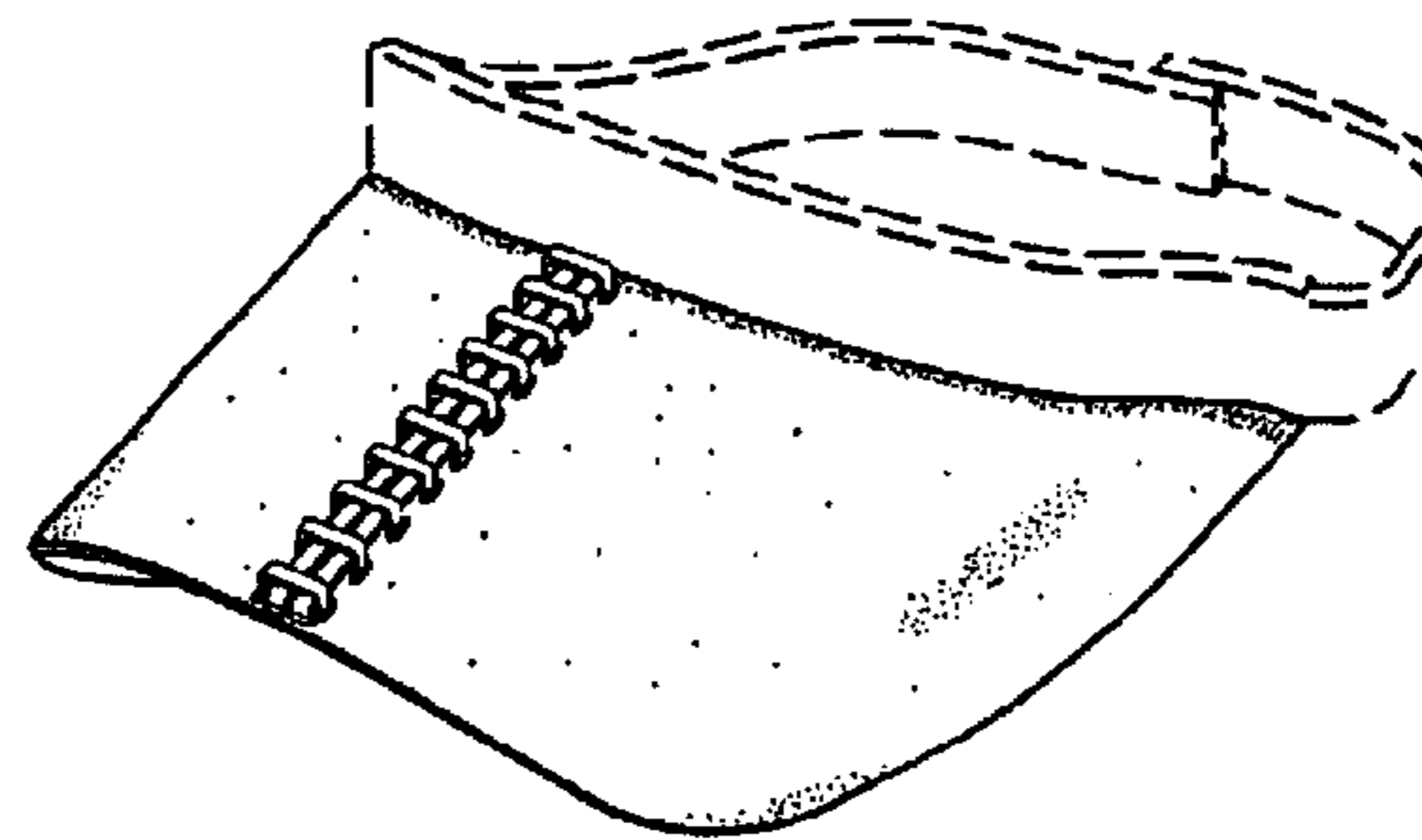
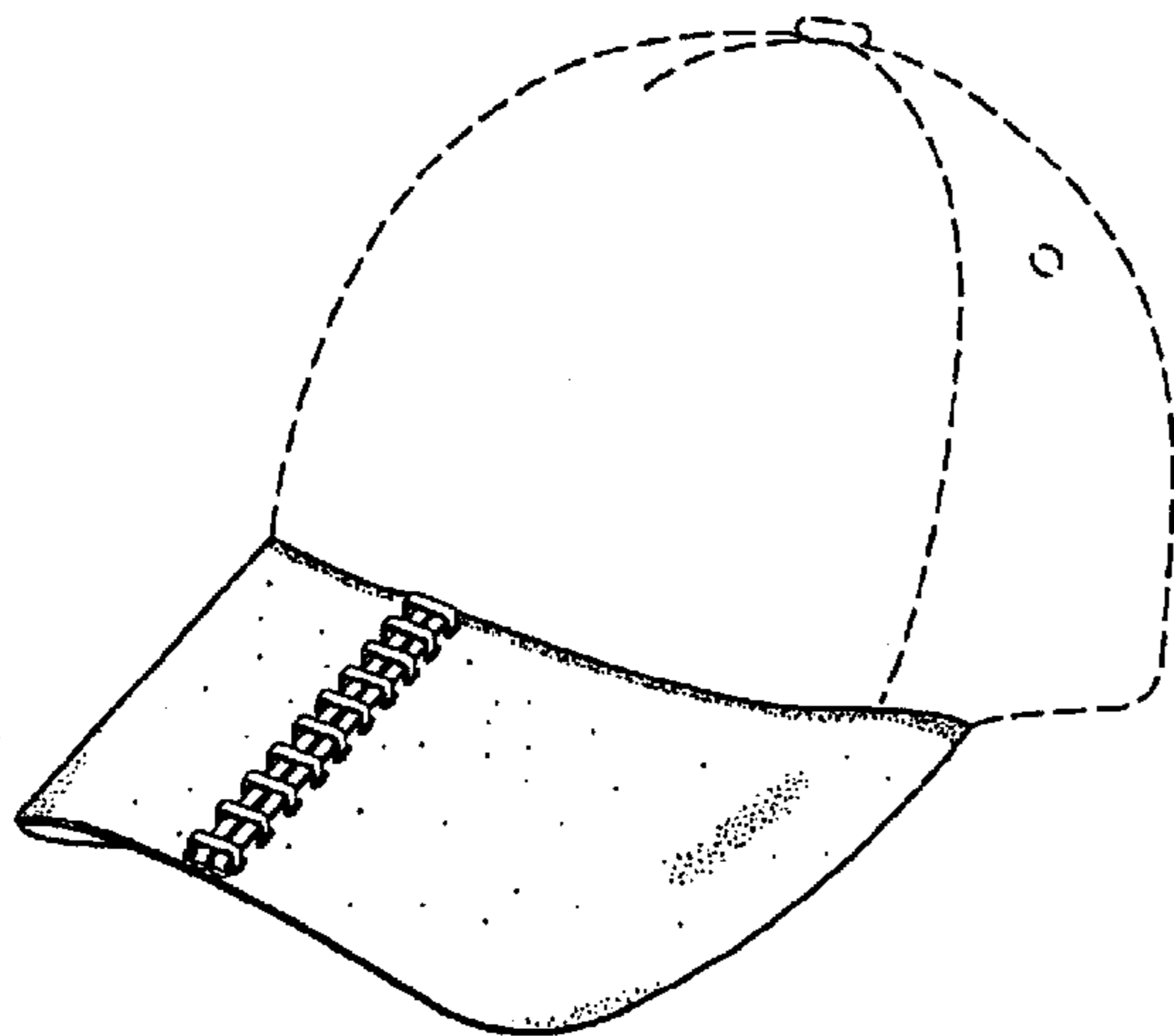
FIG. 3 is a slightly reduced top view of the decorative bill for sports cap of FIG. 1;

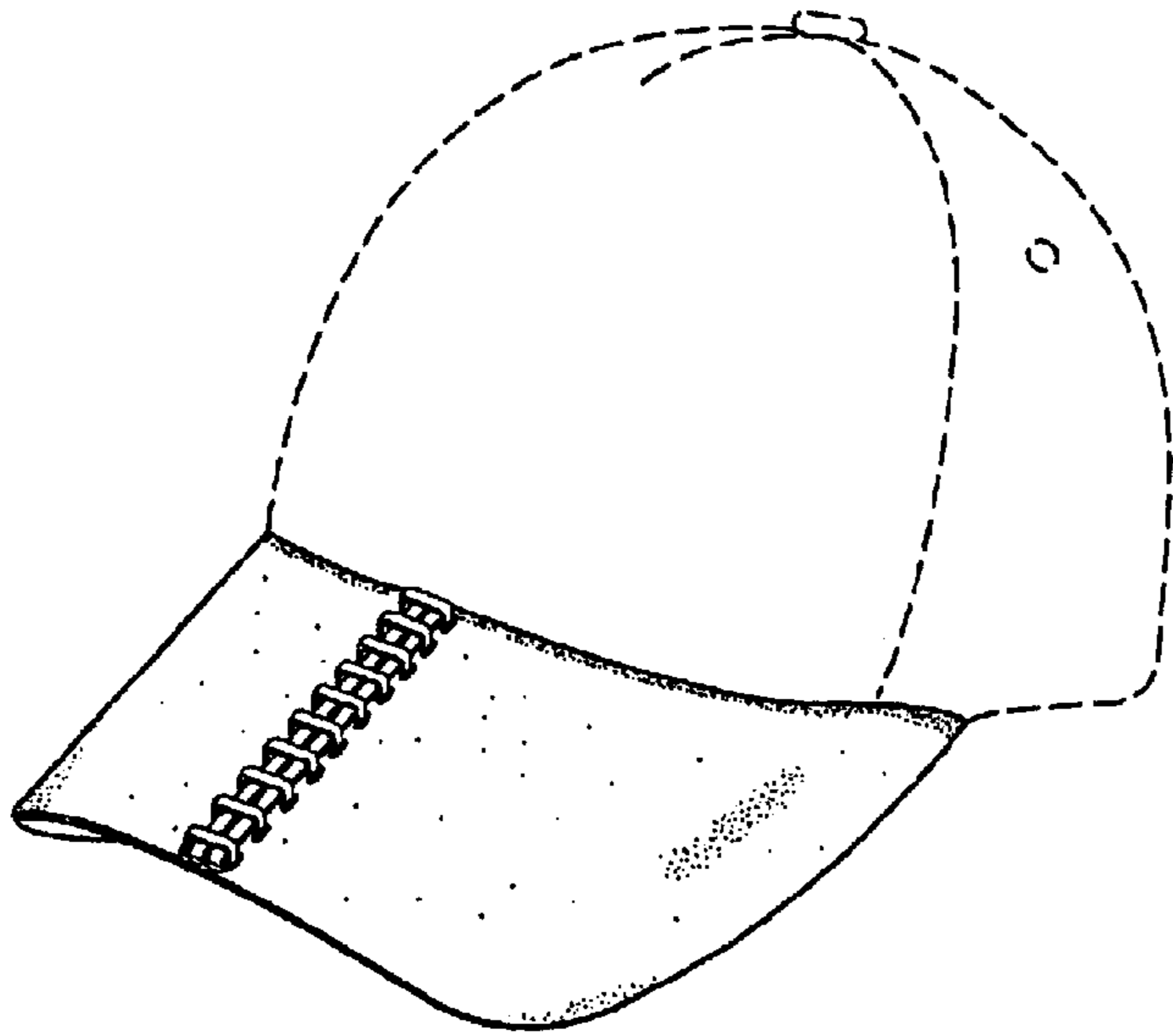
FIG. 4 is a slightly reduced right side view of the decorative bill for sports cap of FIG. 1;

FIG. 5 is a slightly reduced bottom view of the decorative bill for sports cap of FIG. 1; and,

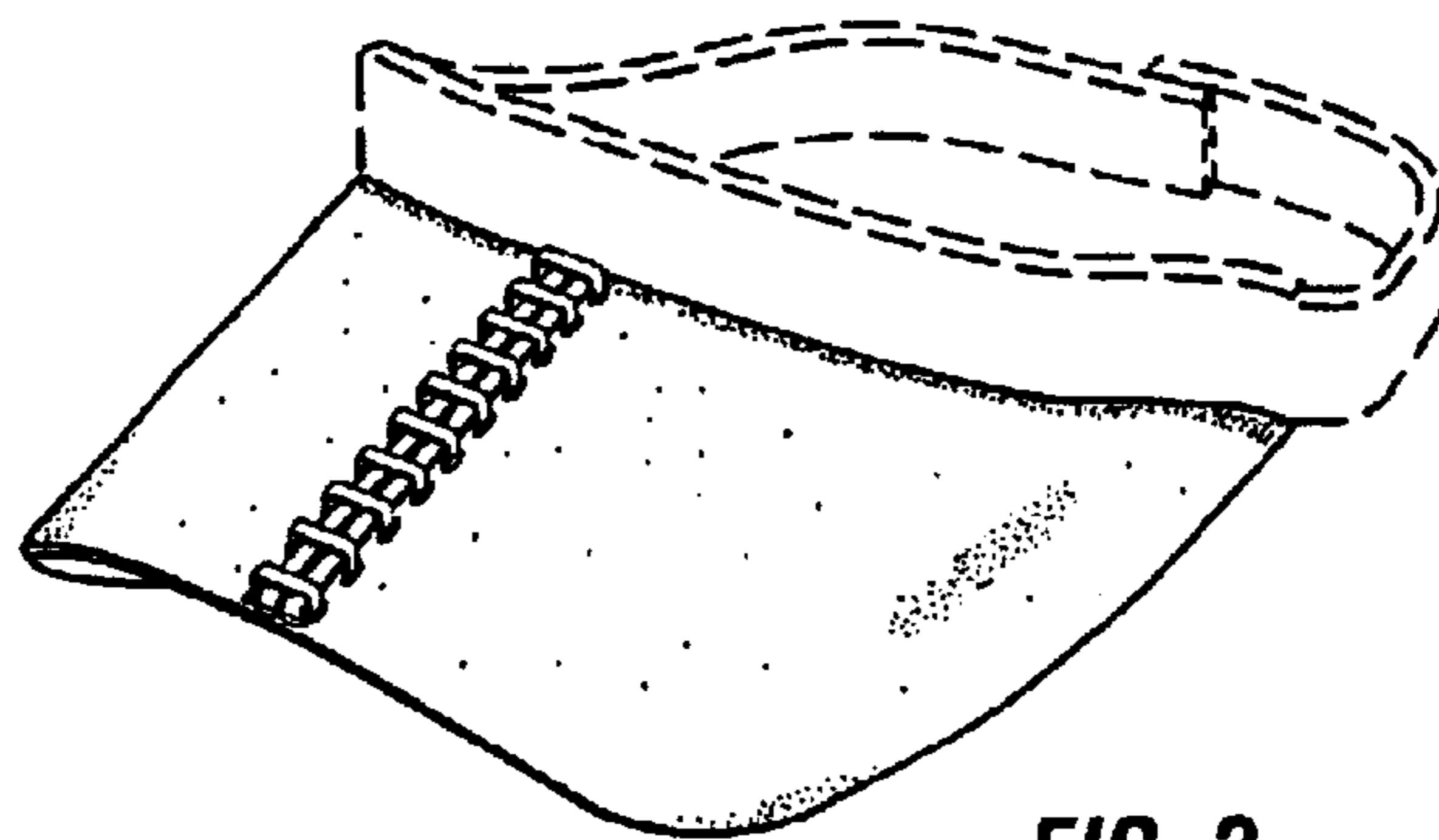
FIG. 6 is a slightly reduced front view of the decorative bill for sports cap of FIG. 1.

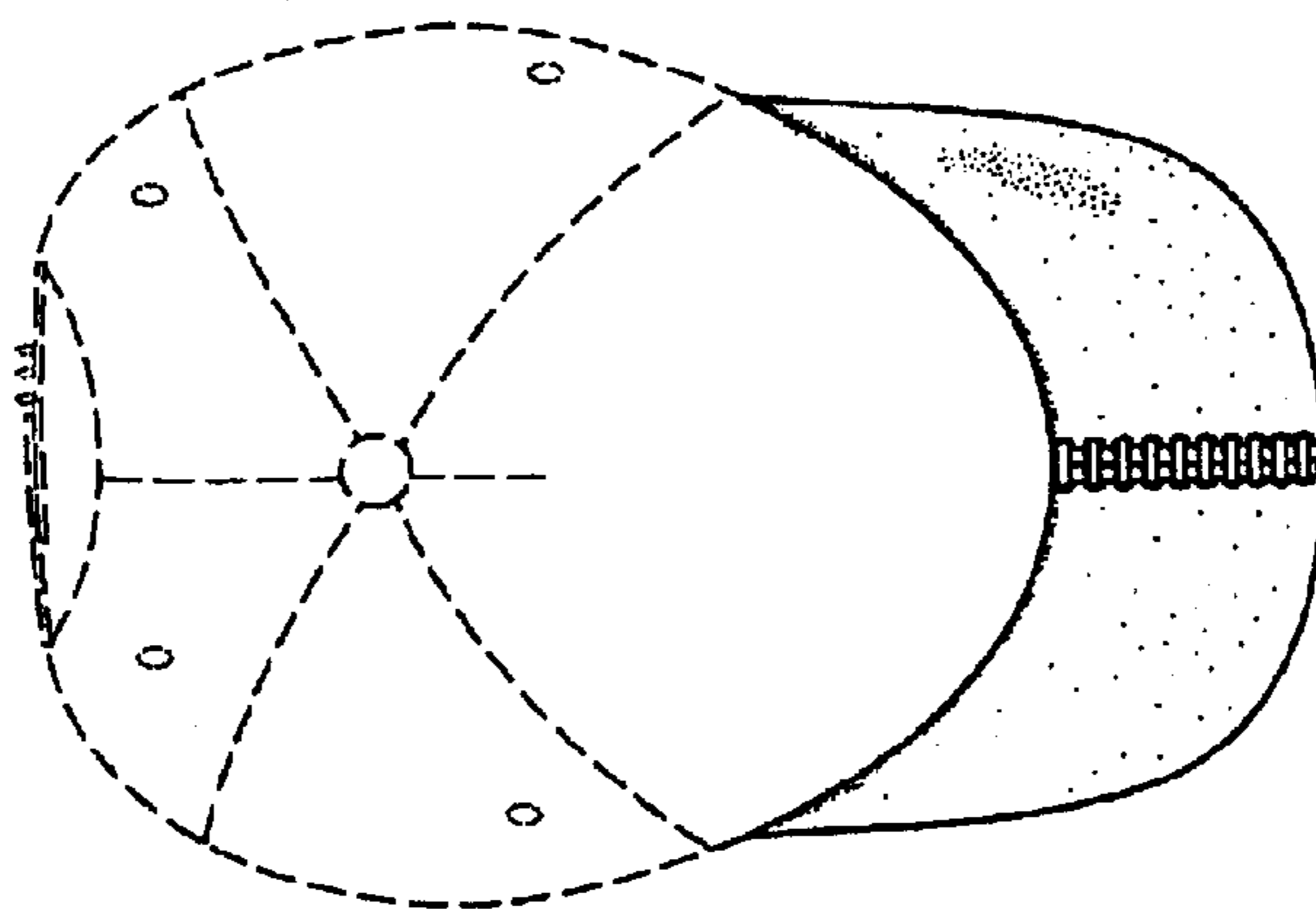




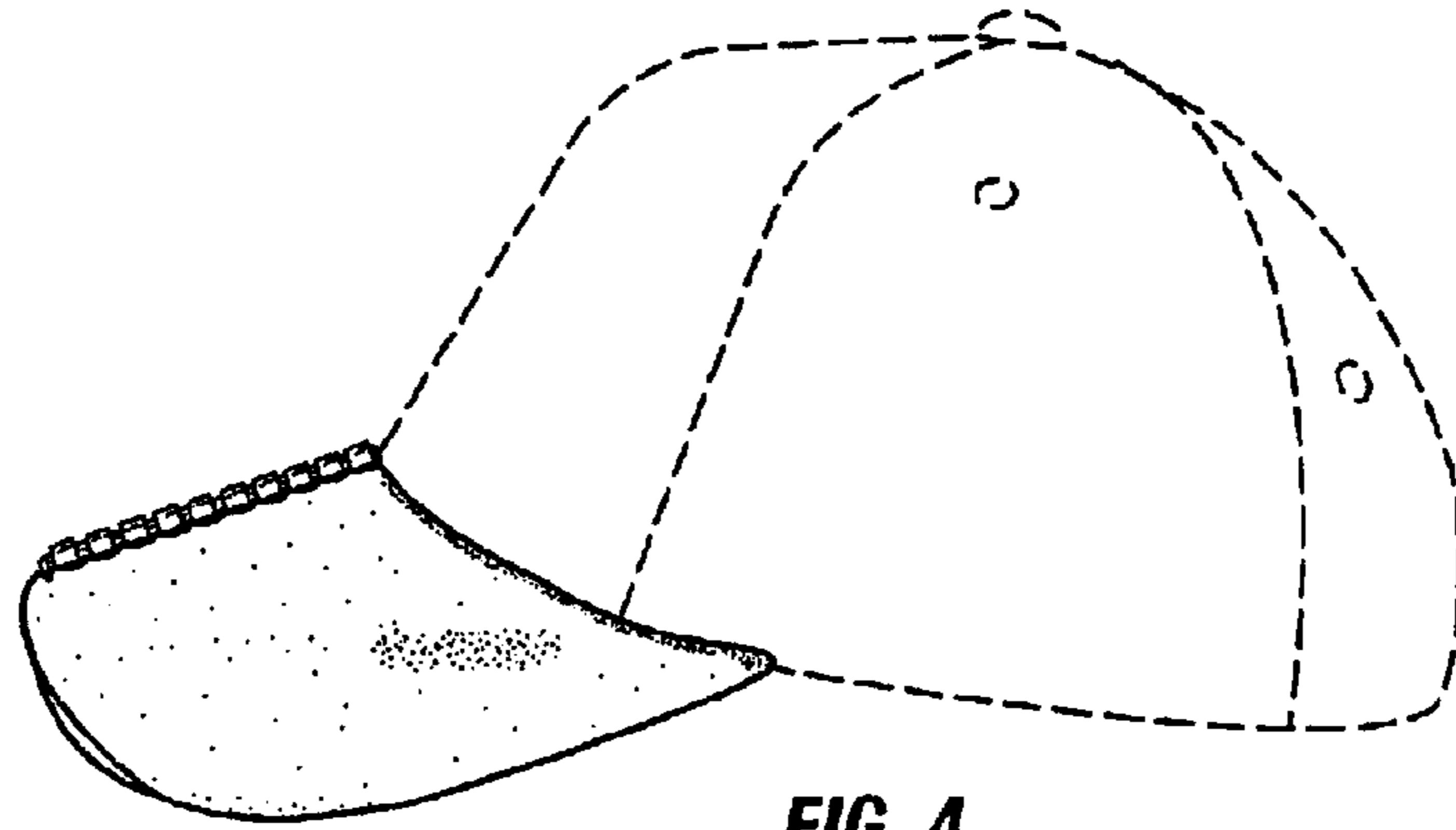

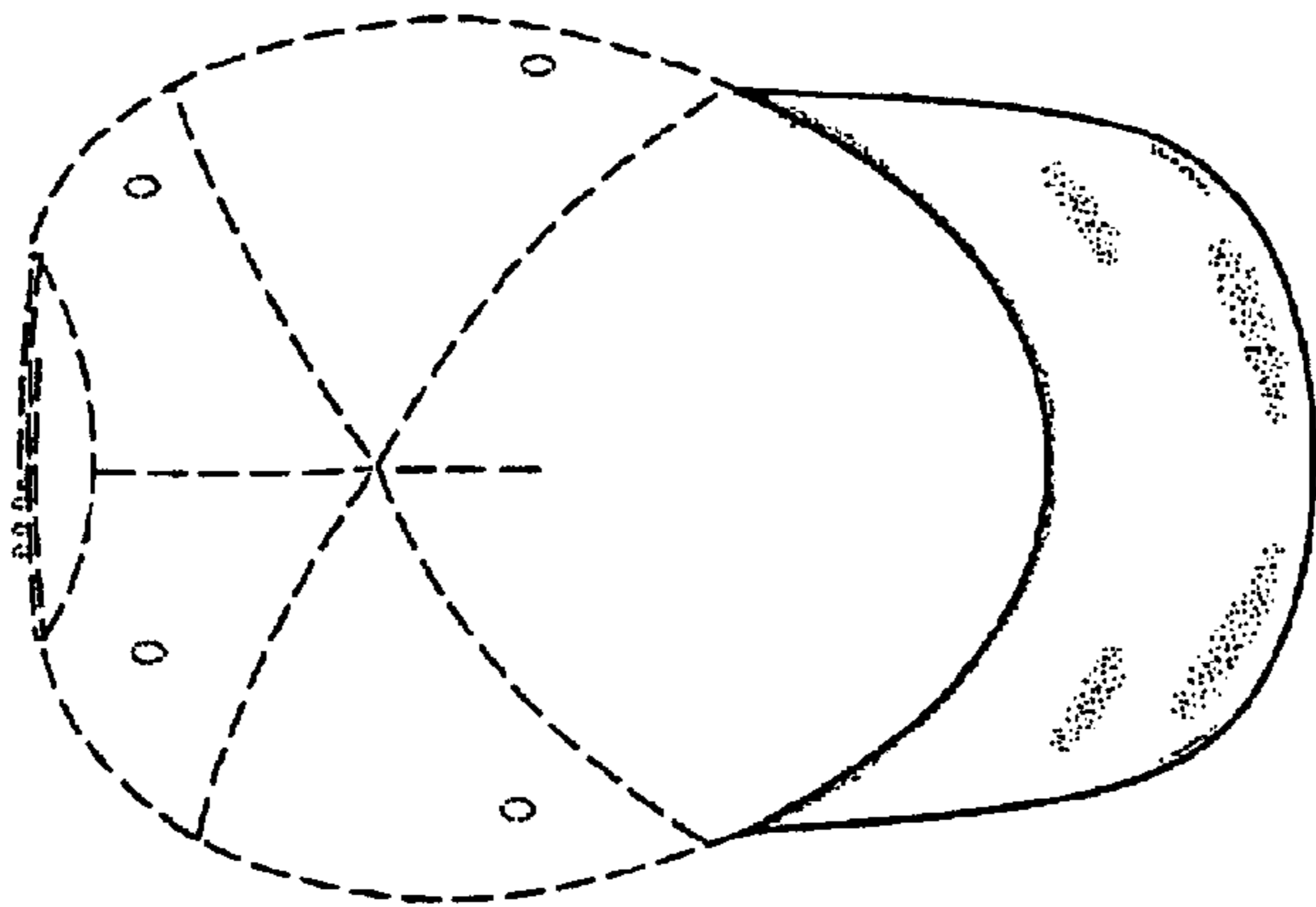

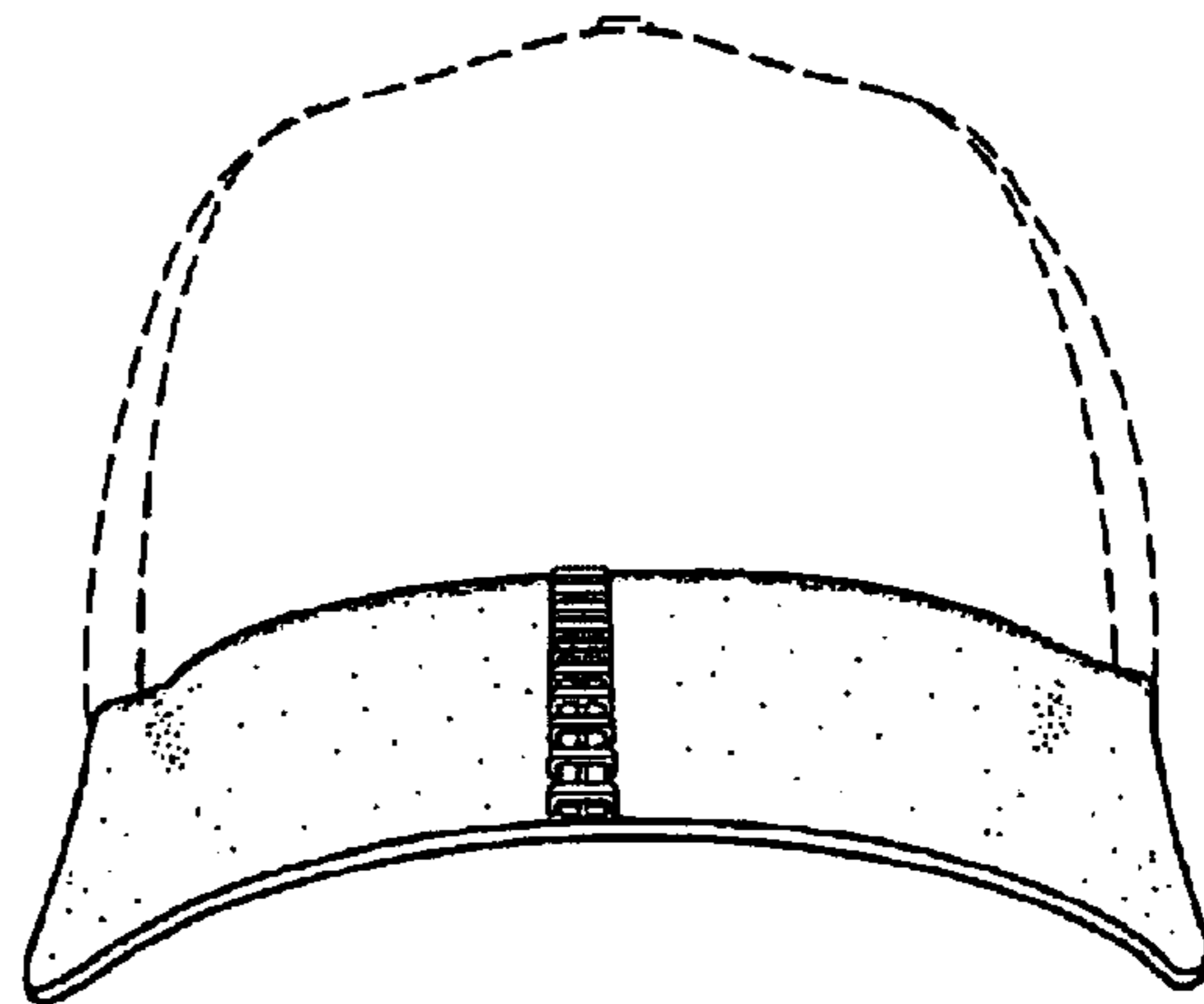
