(57) **CLAIM**

The ornamental design for a front combination lamp for automobile, as shown and described.

**DESCRIPTION**

FIG. 6 is a left-side view of my new design;

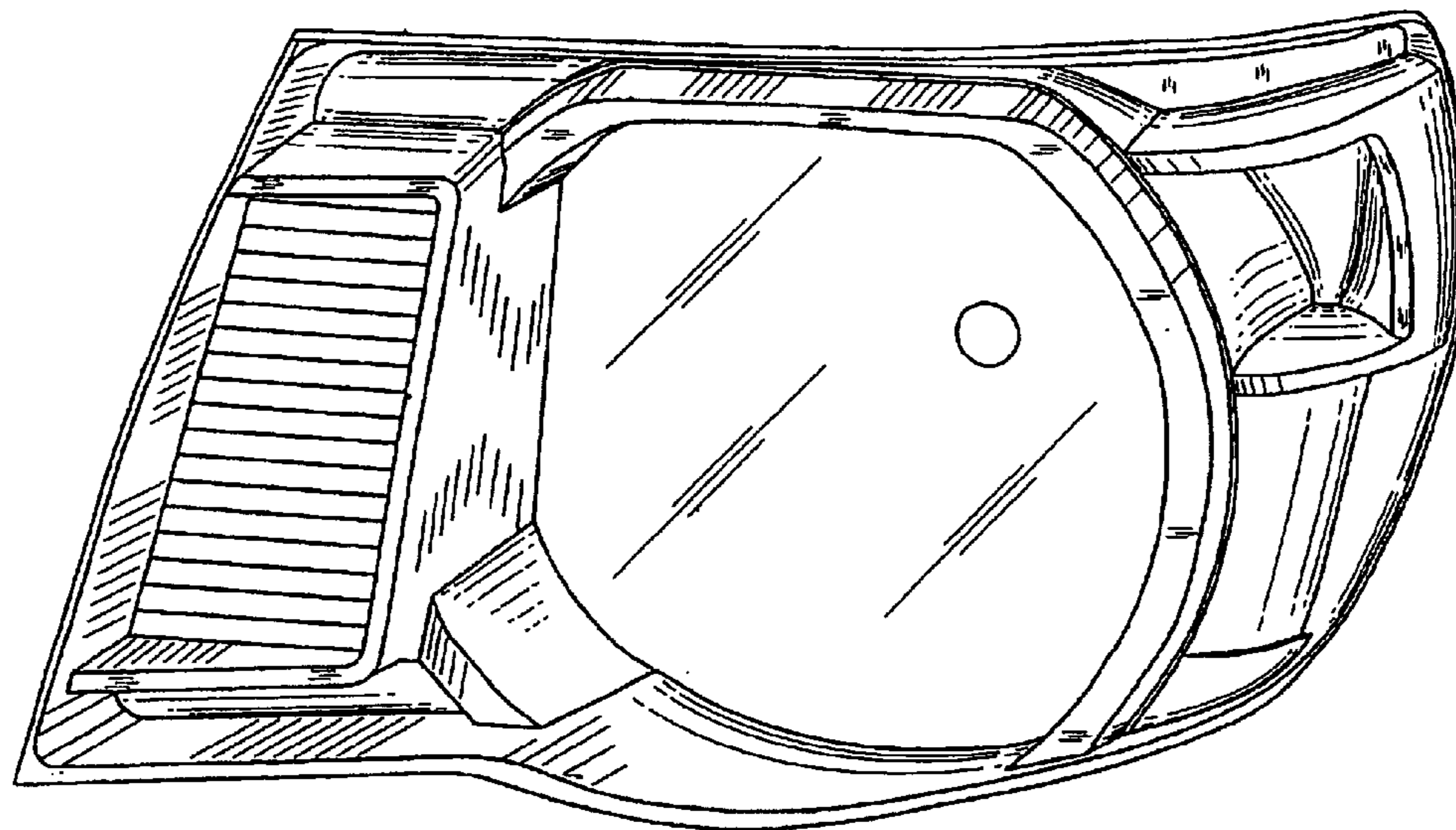
FIG. 7 is a right-side view of my new design;

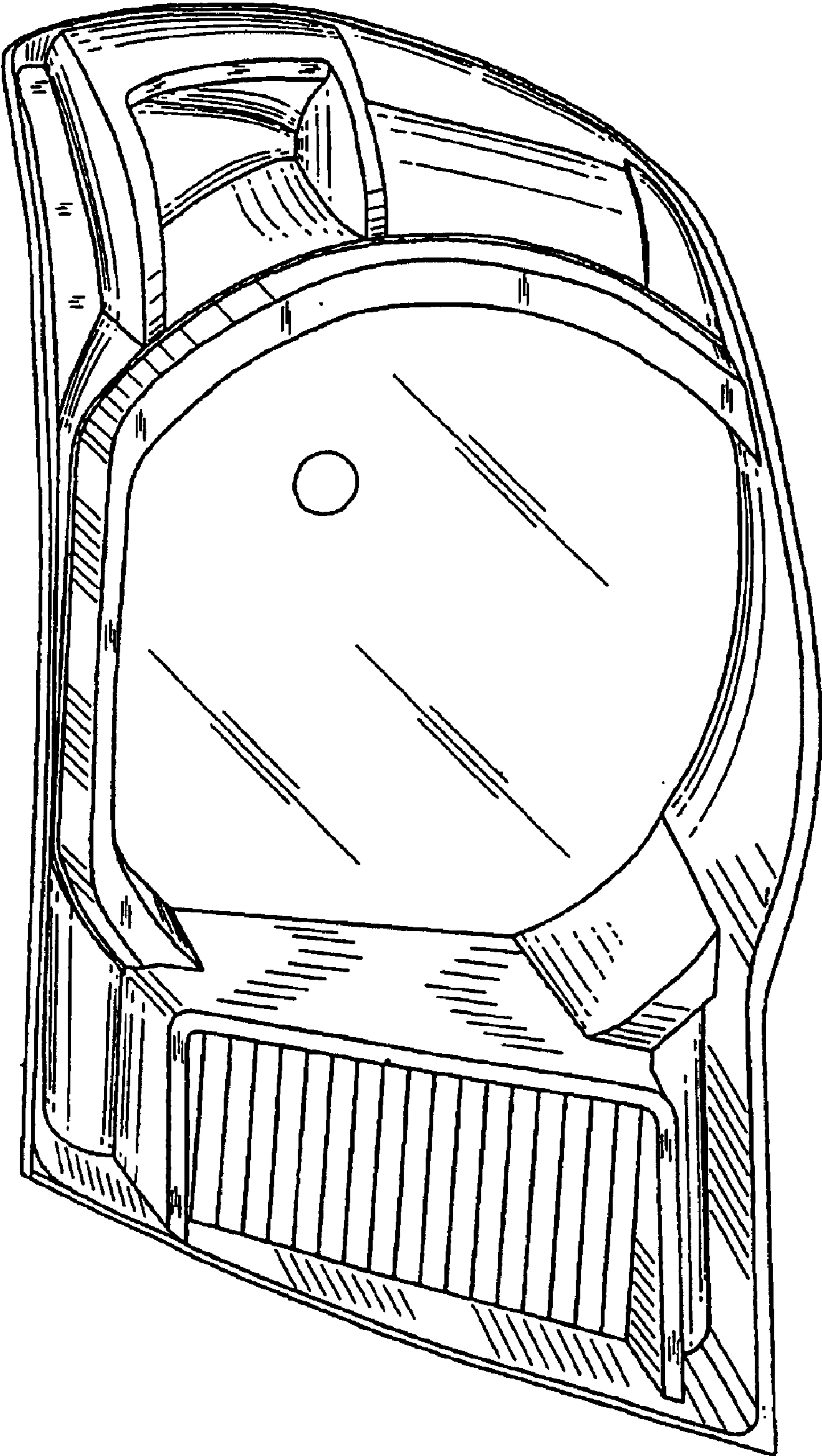
FIG. 8 is a cross-sectional view of my new design taken along the line 8—8 in FIG. 2, showing the profile of that portion of the design; and,

FIG. 9 is a cross-sectional view of my new design taken along the line 9—9 in FIG. 2, showing the profile of that portion of the design.

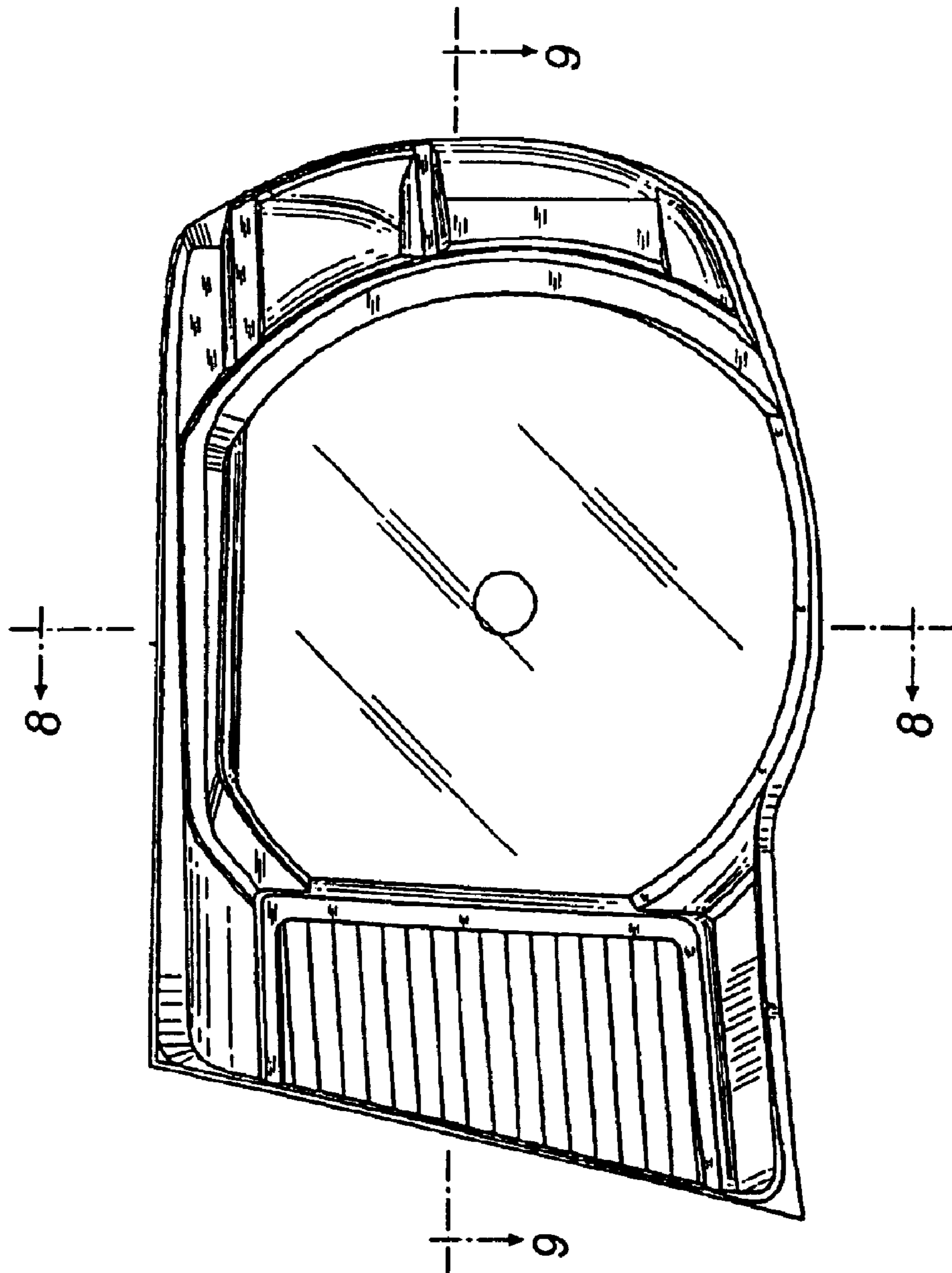
My design includes the mirror image of the embodiment depicted.

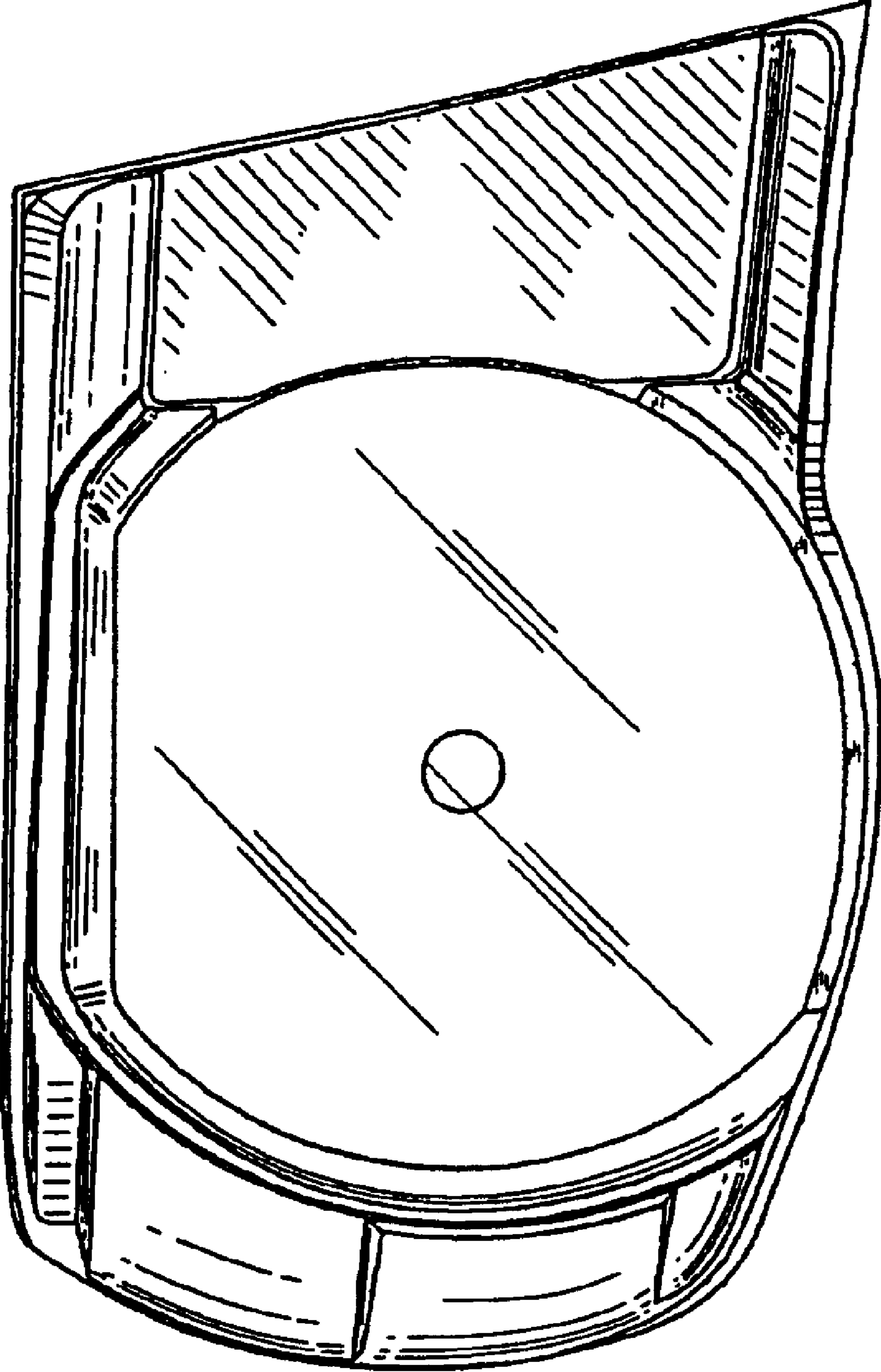

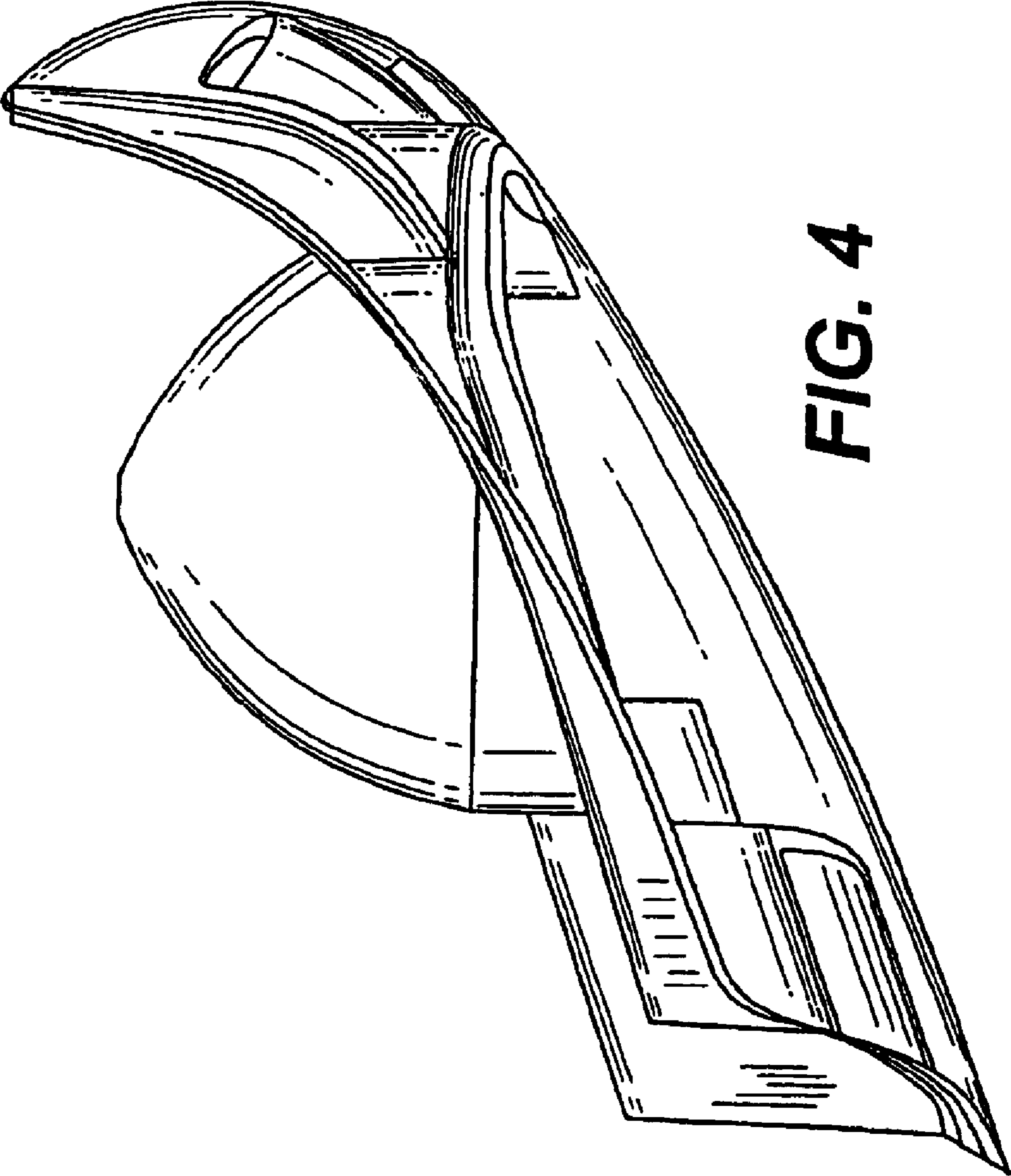

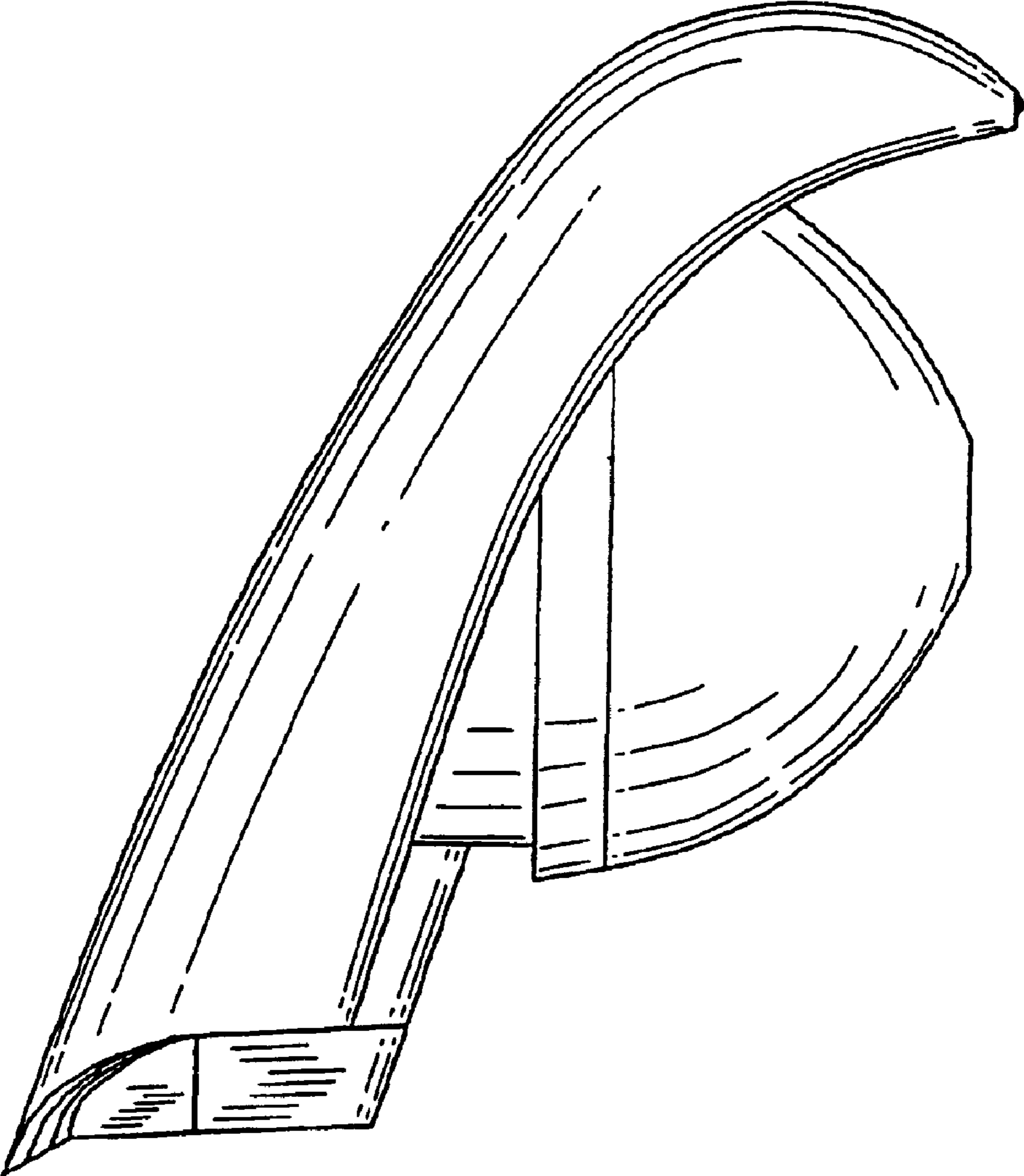

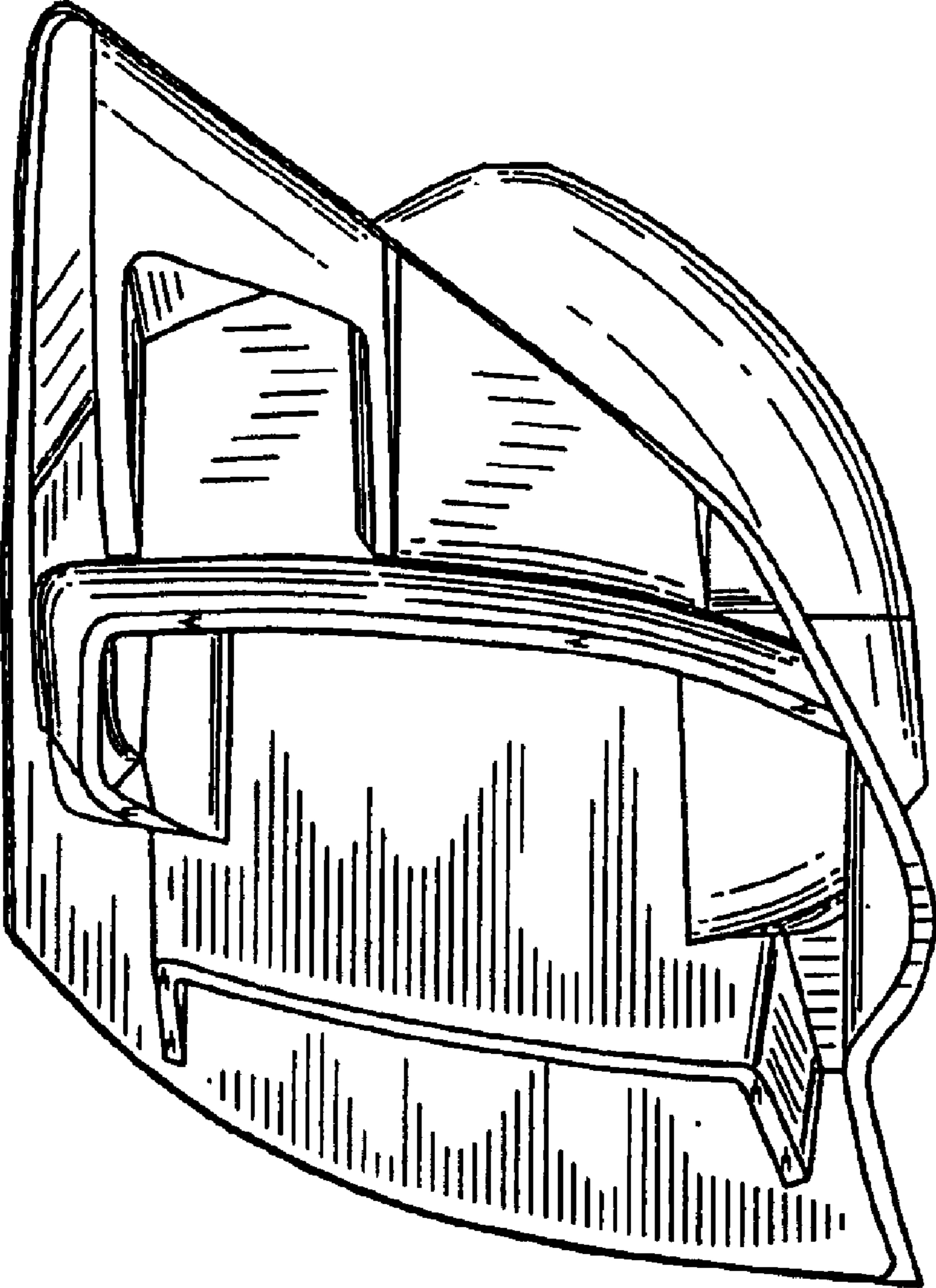




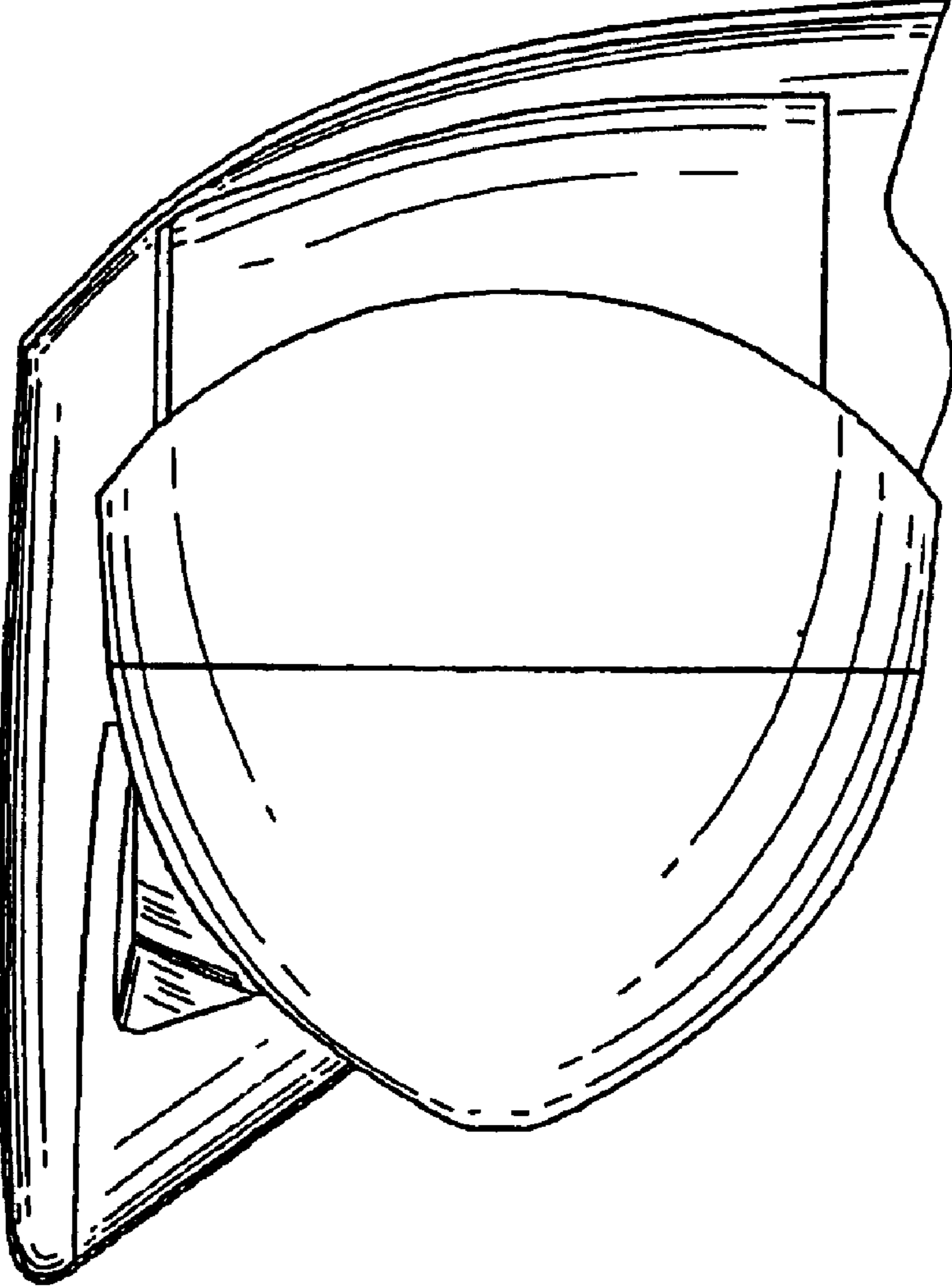

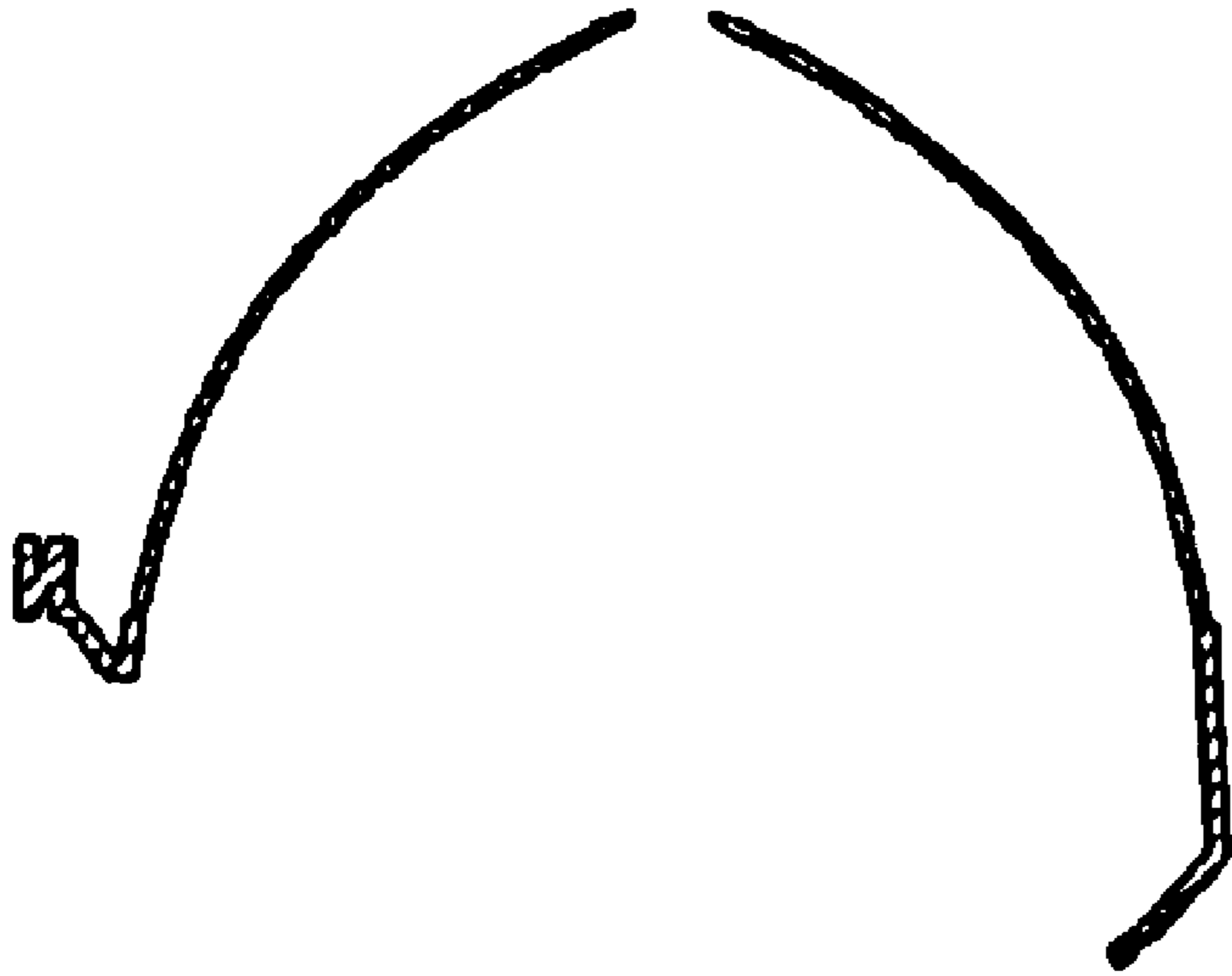

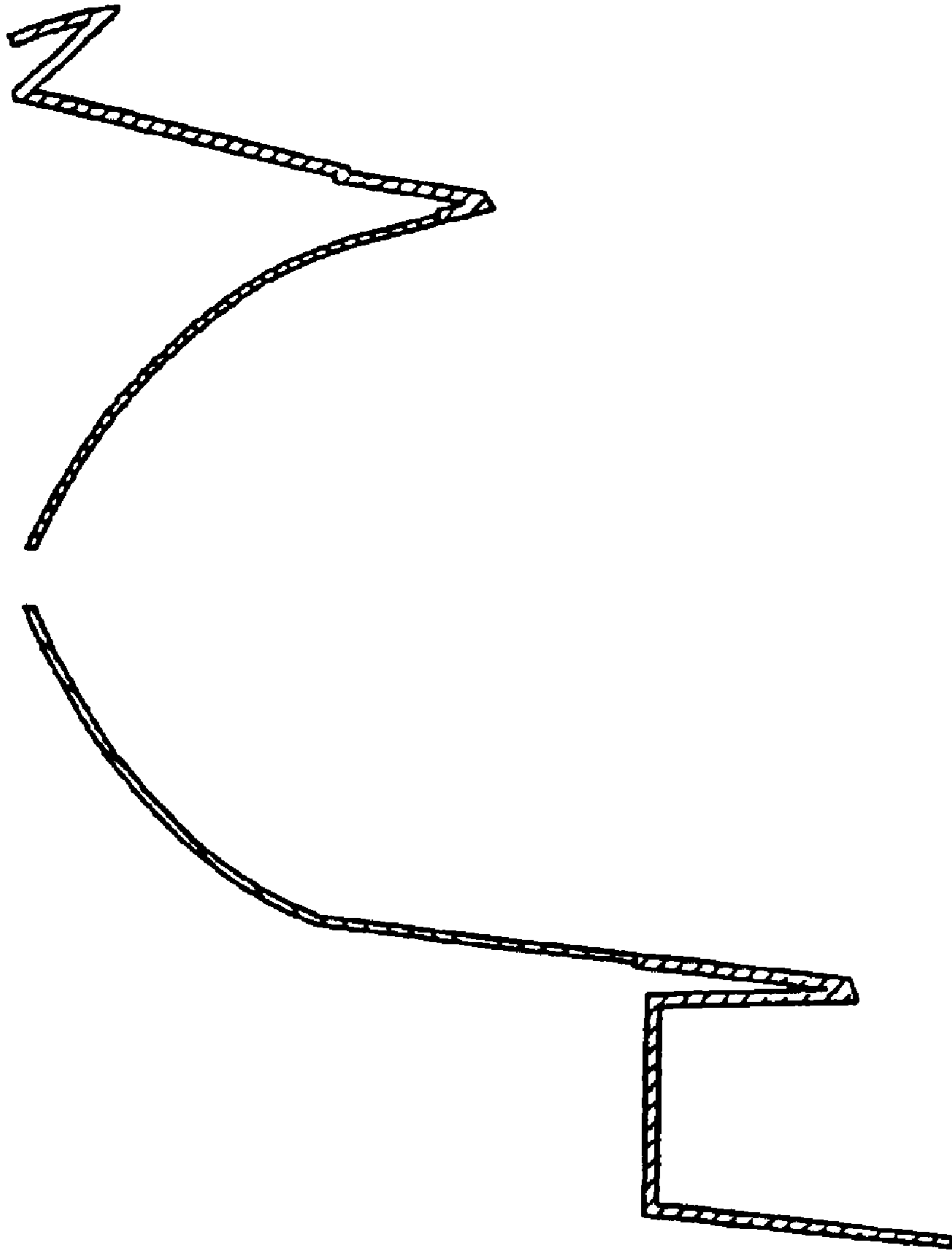
