The ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 2 is a front elevation view thereof;

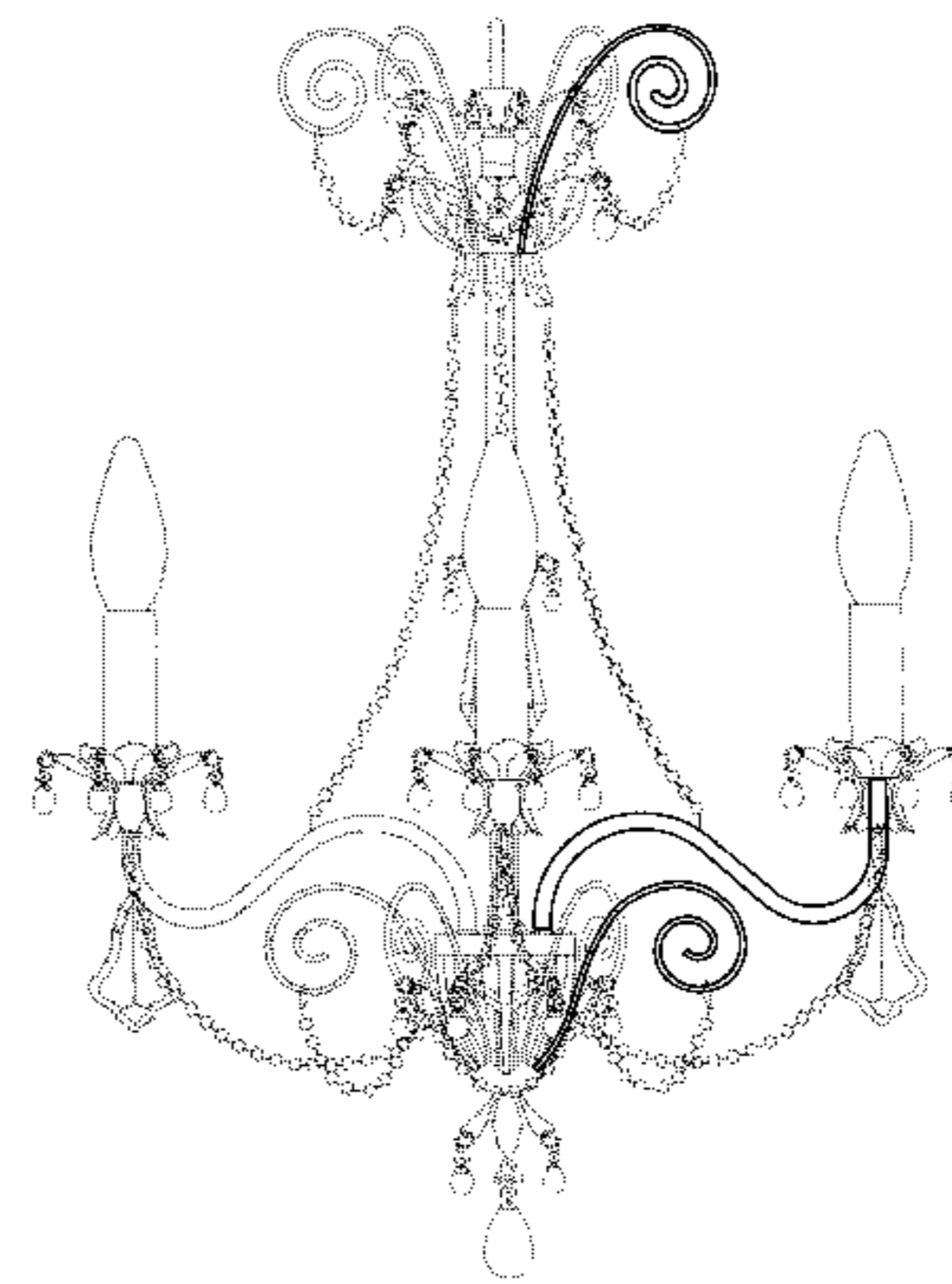
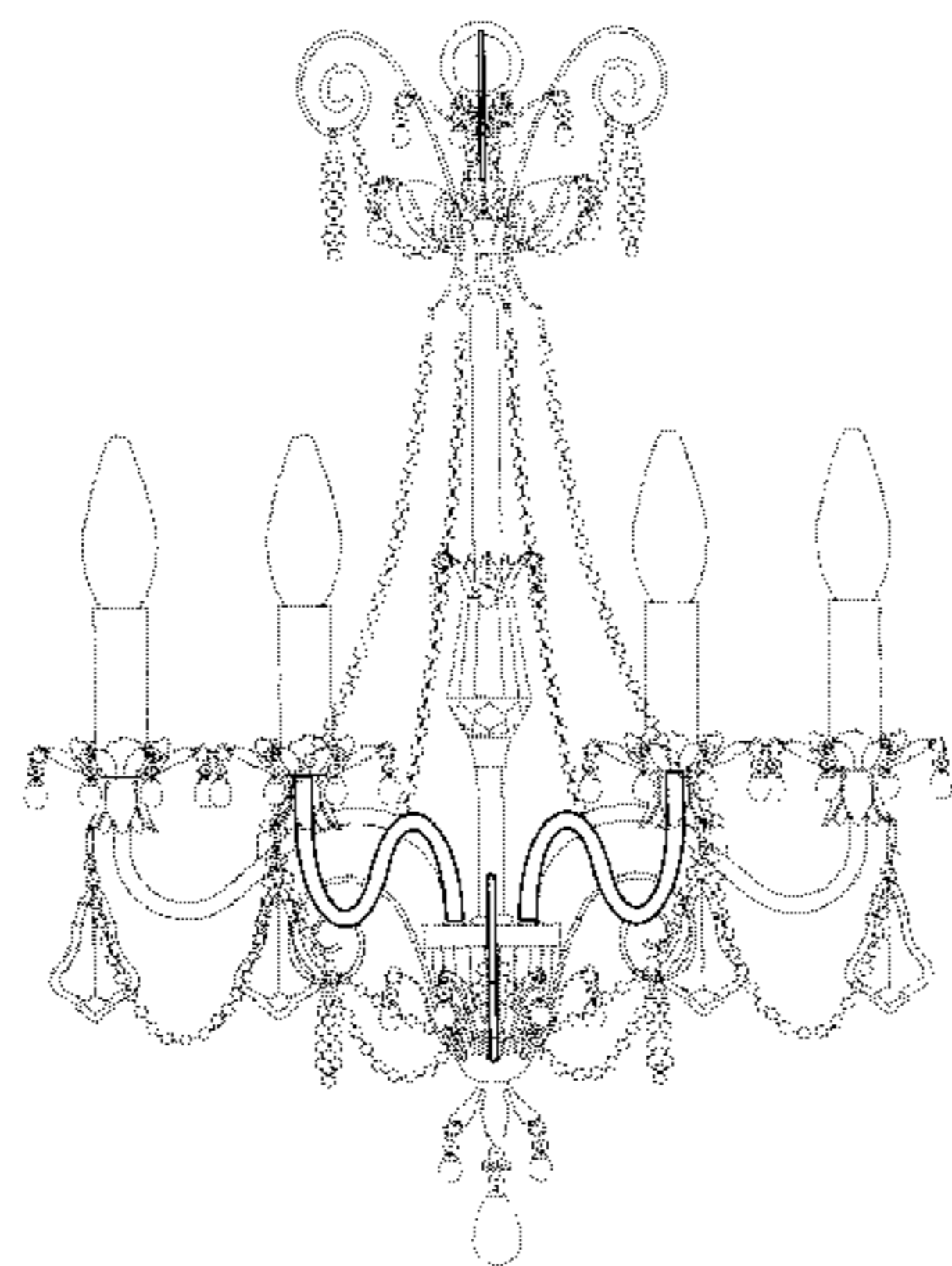
FIG. 3 is a side elevation view thereof; the other side being a mirror image thereof;

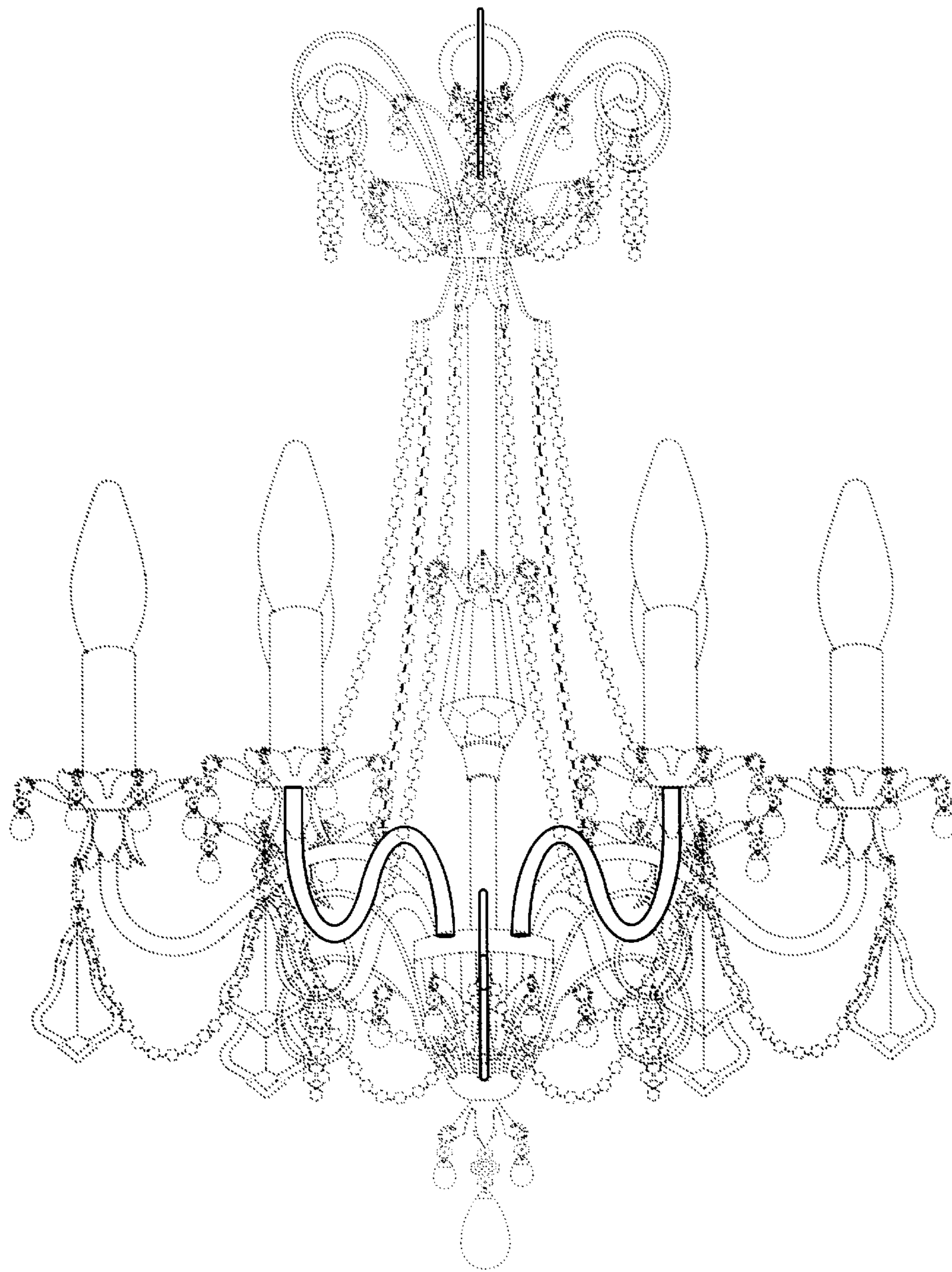

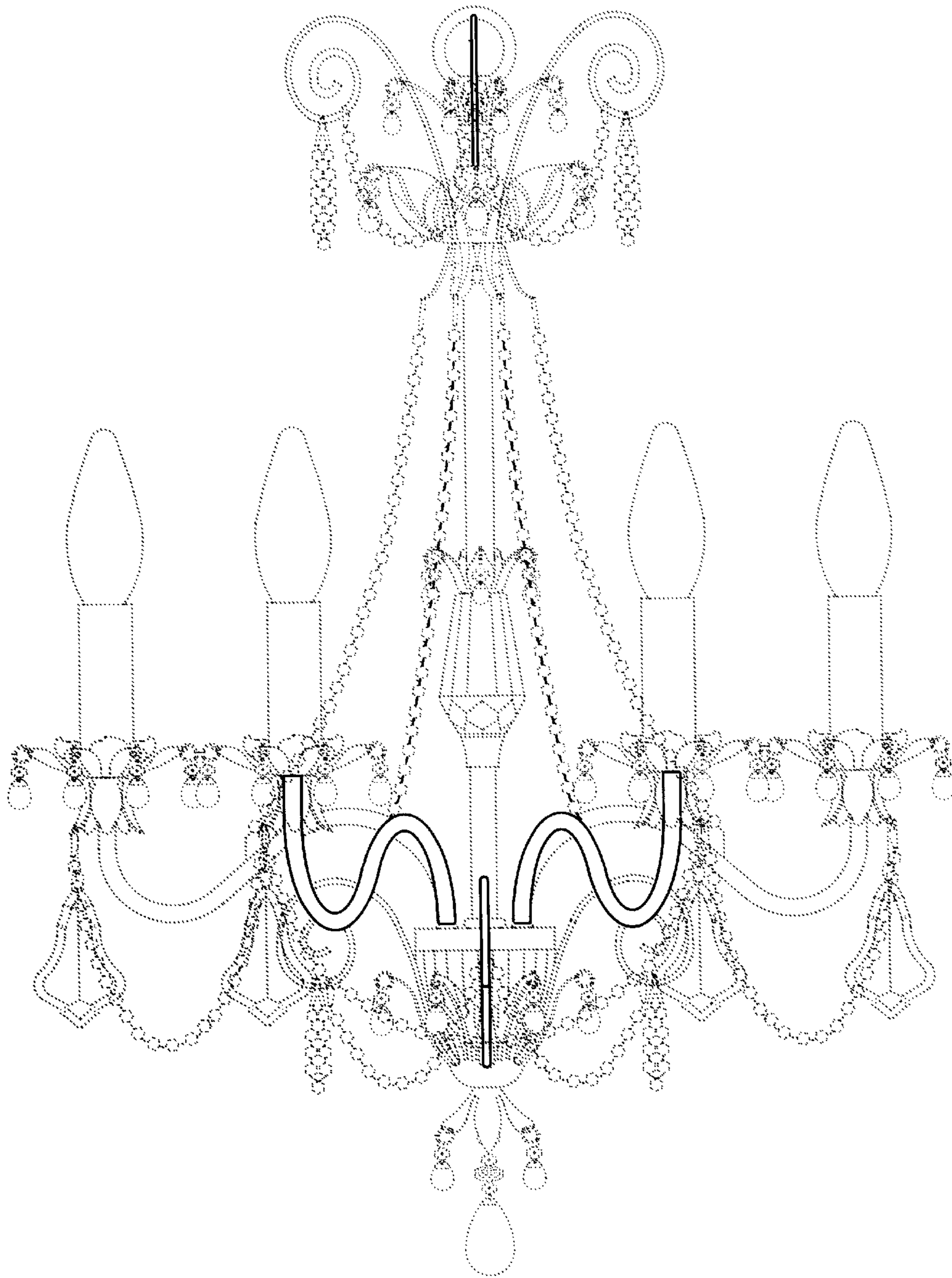

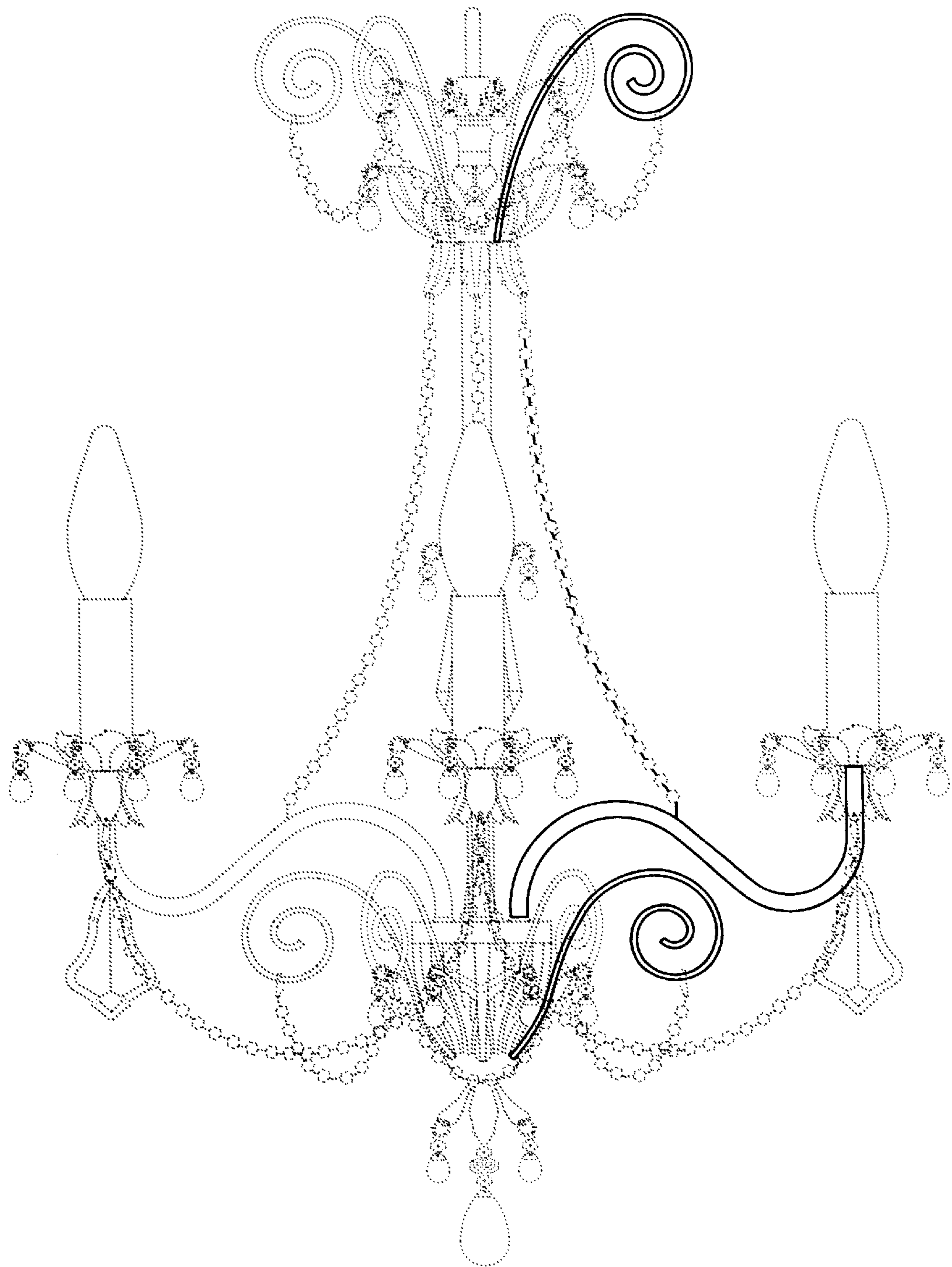

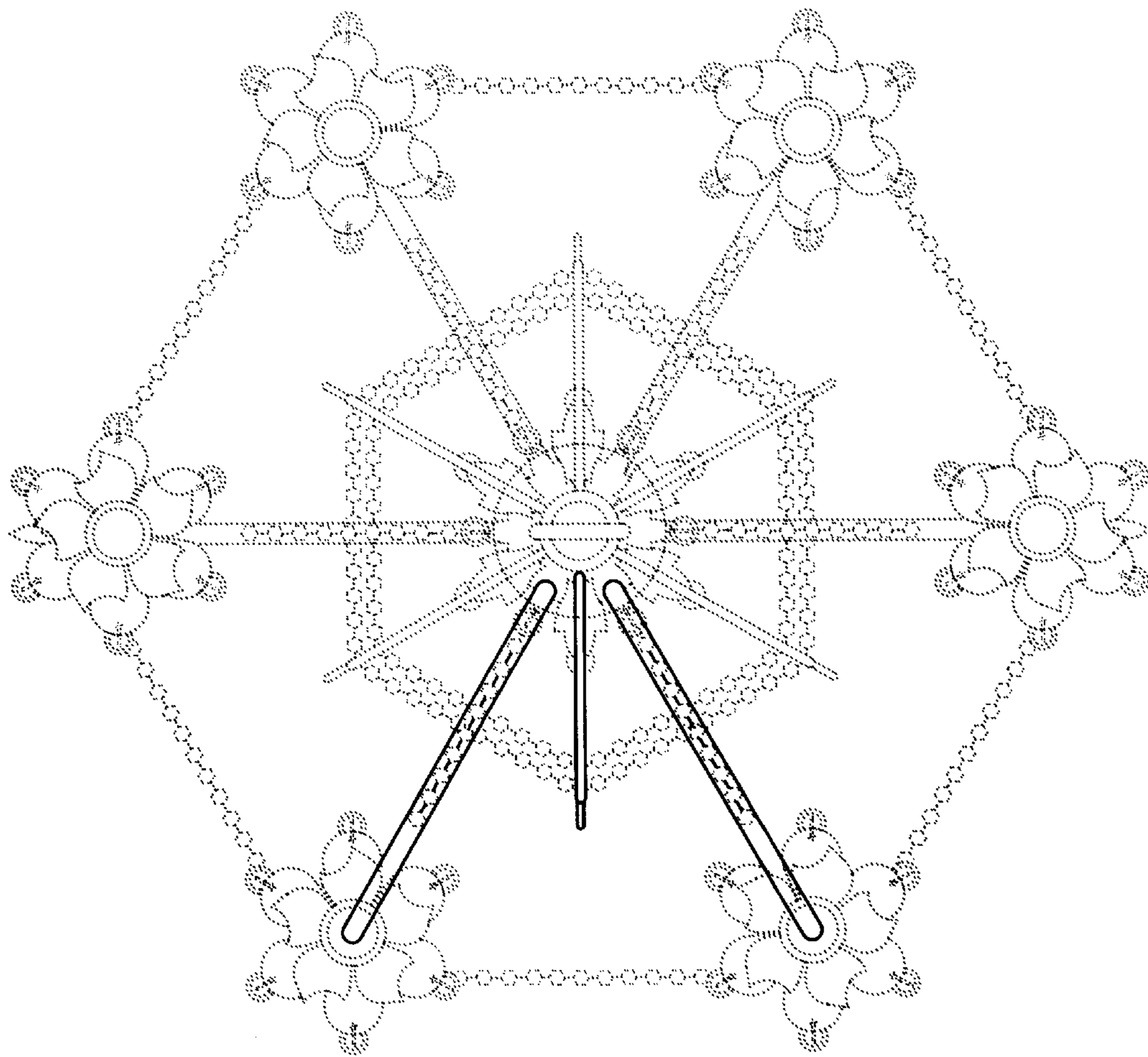

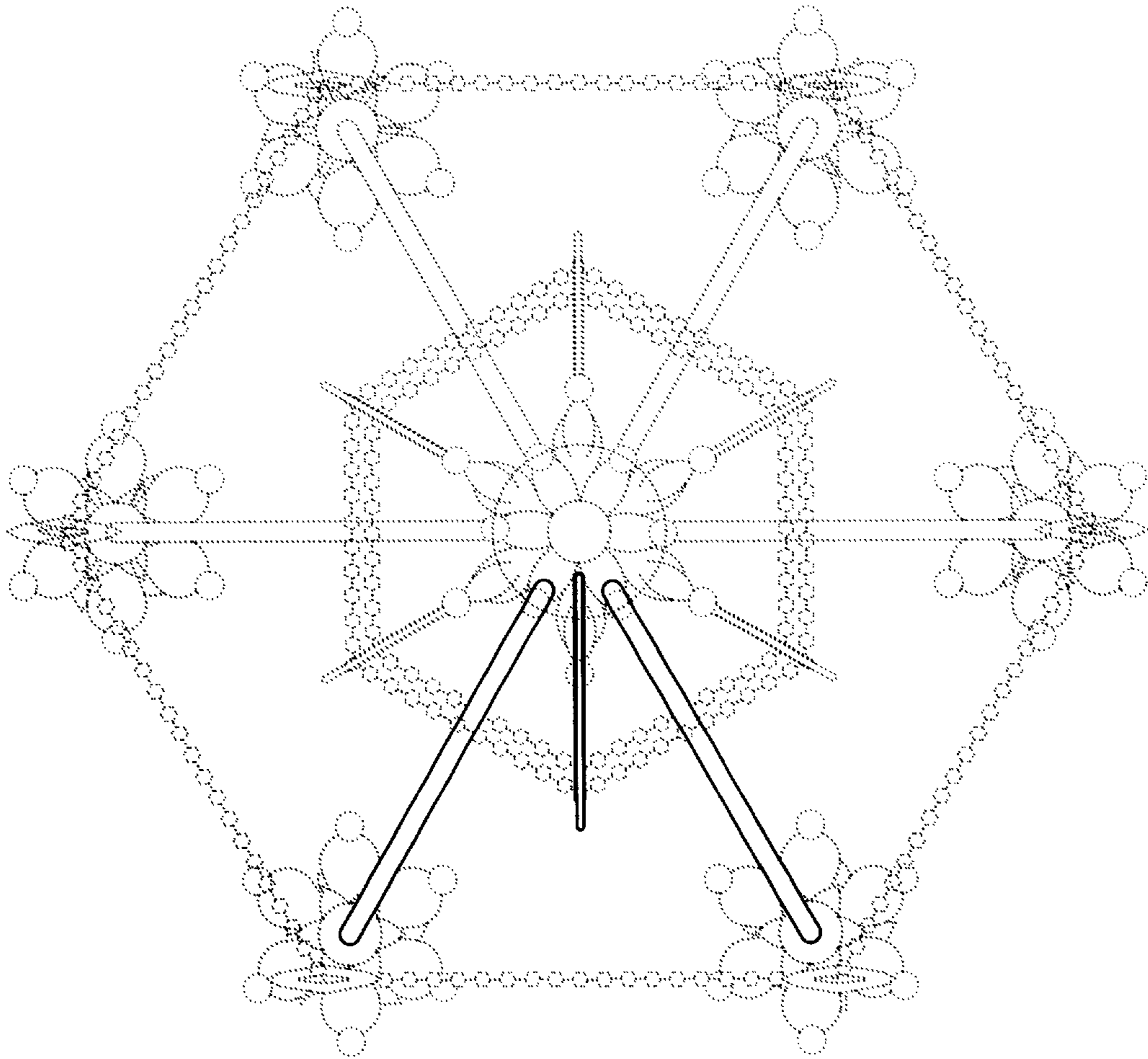
