The ornamental design for shoes, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the present invention for a right shoe;

FIG. 2 is a rear elevational view of the design of the shoe of FIG. 1;

FIG. 3 is a perspective view of the front and rear elevational views and the right side of FIG. 1;

FIG. 4 is an elevational view of the right side of the shoe of FIG. 1;

FIG. 5 is an elevational view of the left side of the shoe of FIG. 1;

FIG. 6 is a plan overhead view of the shoe of FIG. 1;

FIG. 7 is a plan underneath view of the shoe of FIG. 1;

FIG. 8 is a front elevational view of the shoe of FIG. 1;

FIG. 9 is a rear elevational view of the shoe of FIG. 1

FIG. 10 is a perspective view of the front and rear elevational views of the left shoe;

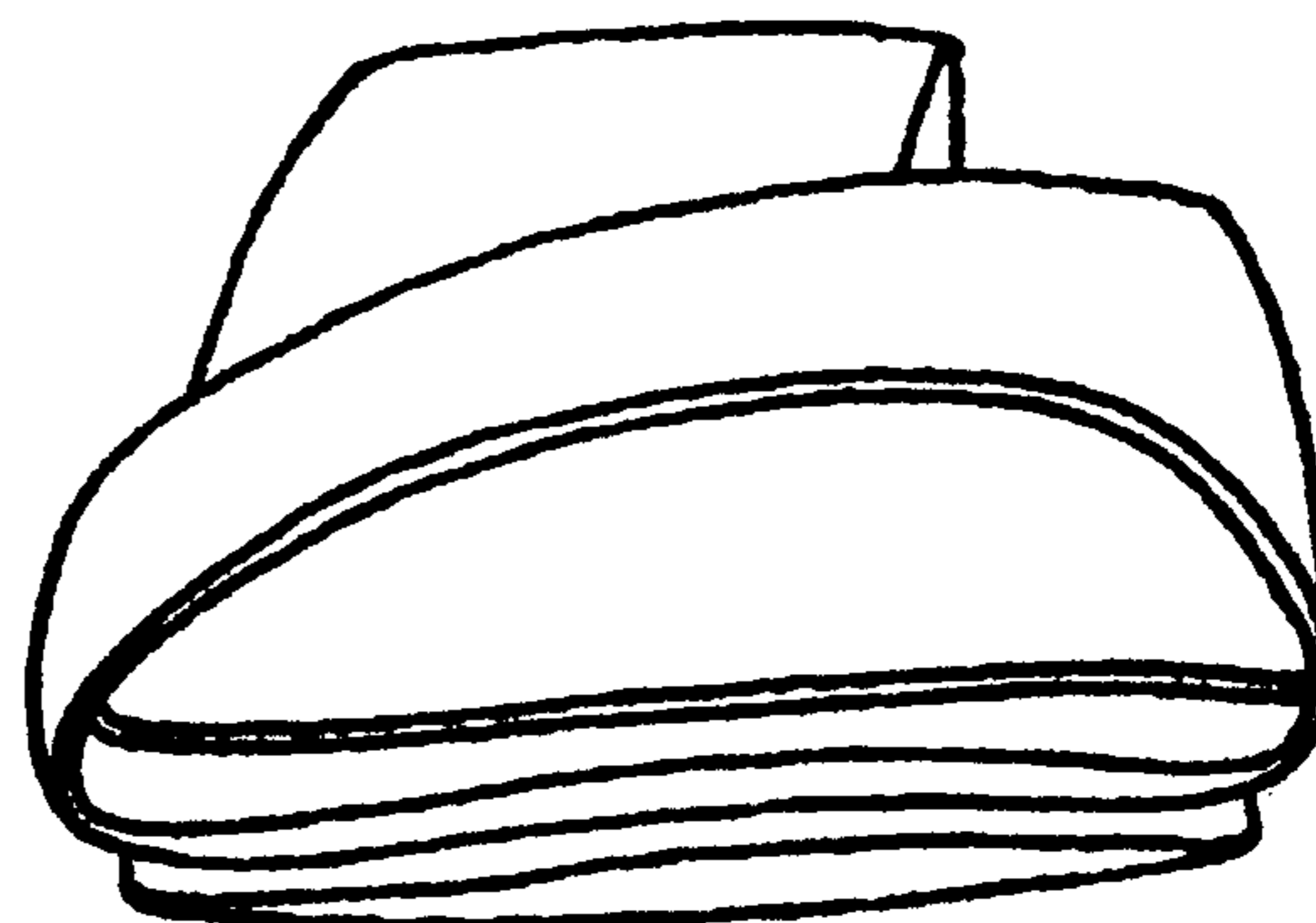
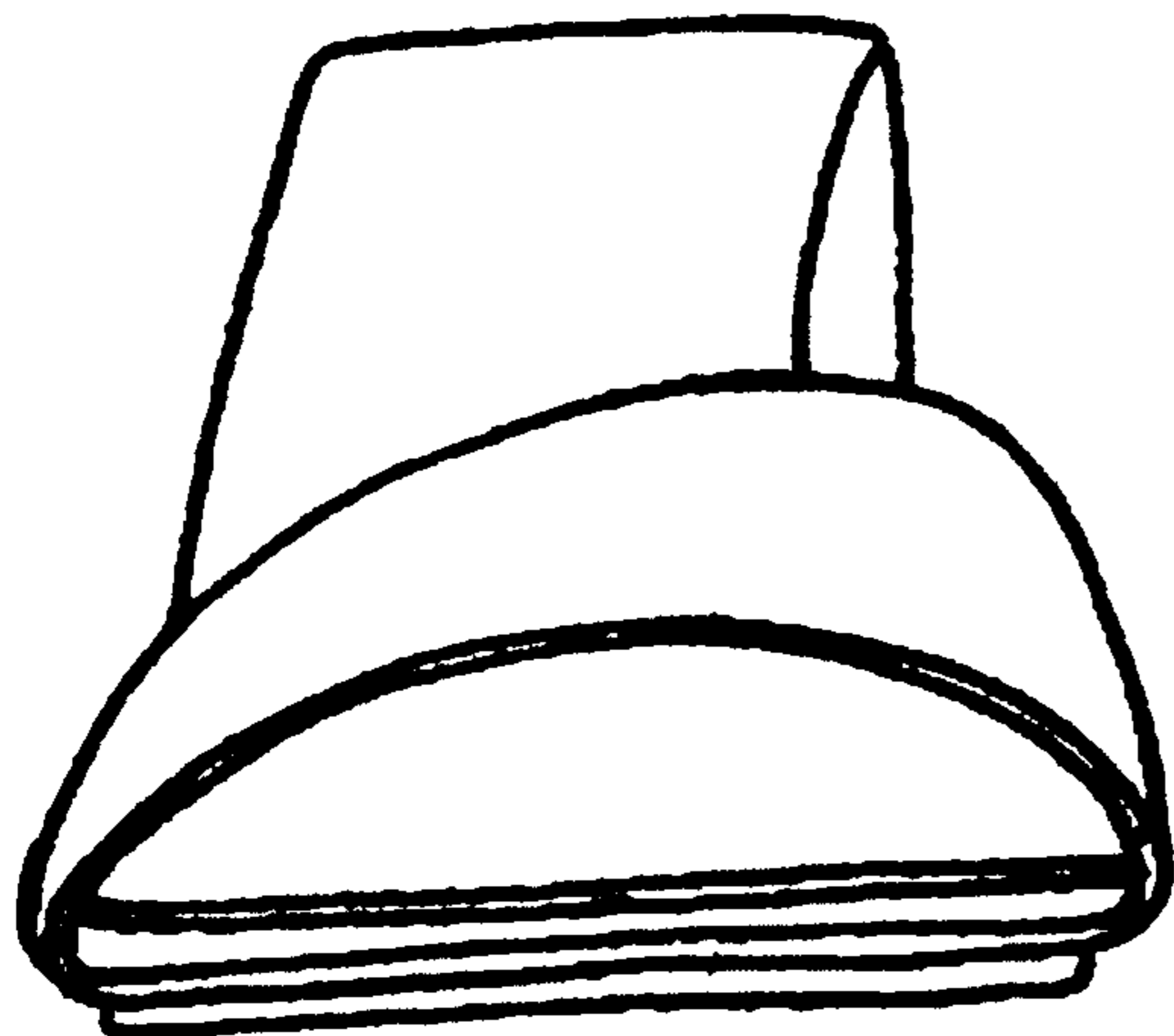
FIG. 11 is an elevational view of the right side of the shoe of FIG. 10;

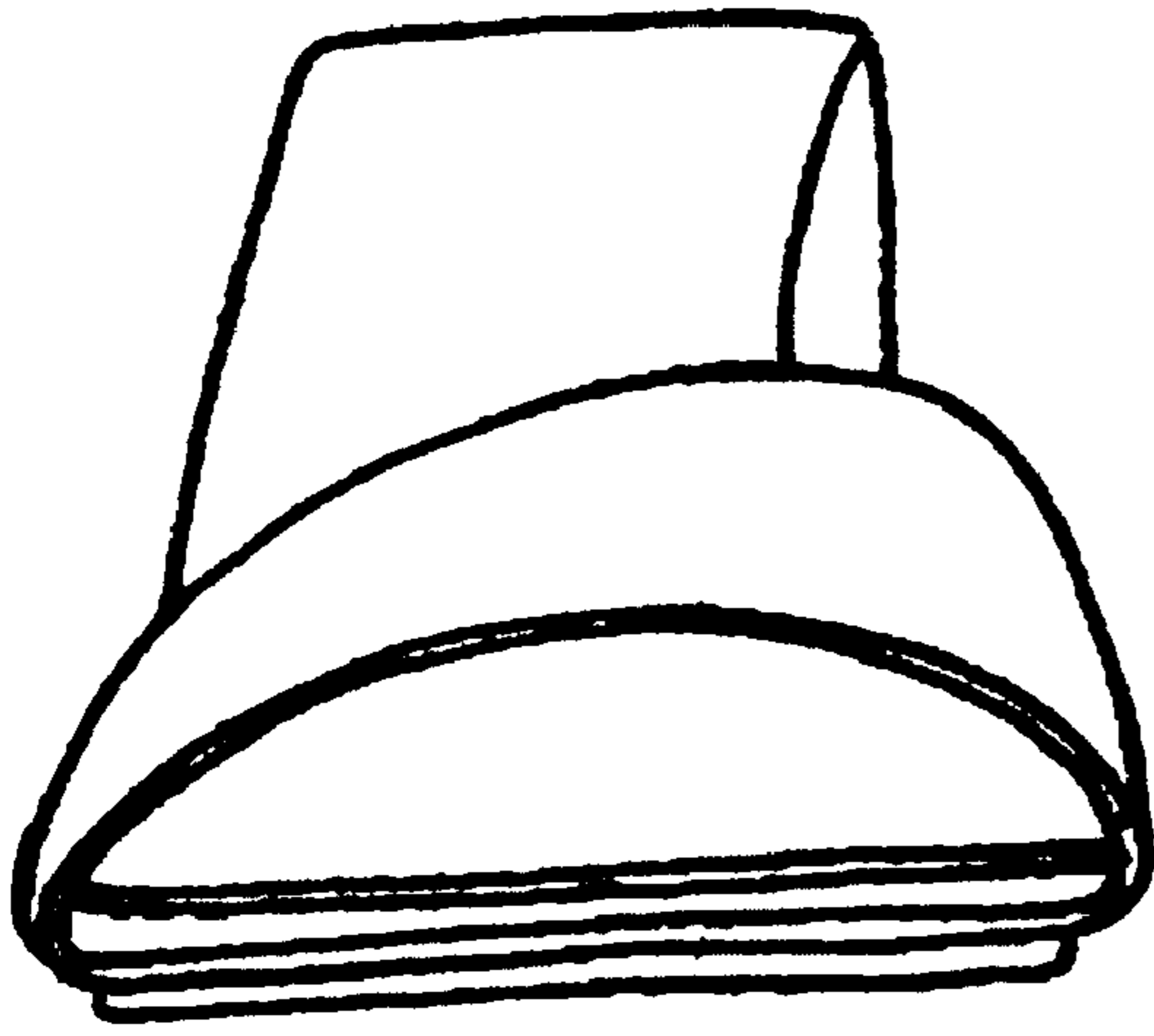

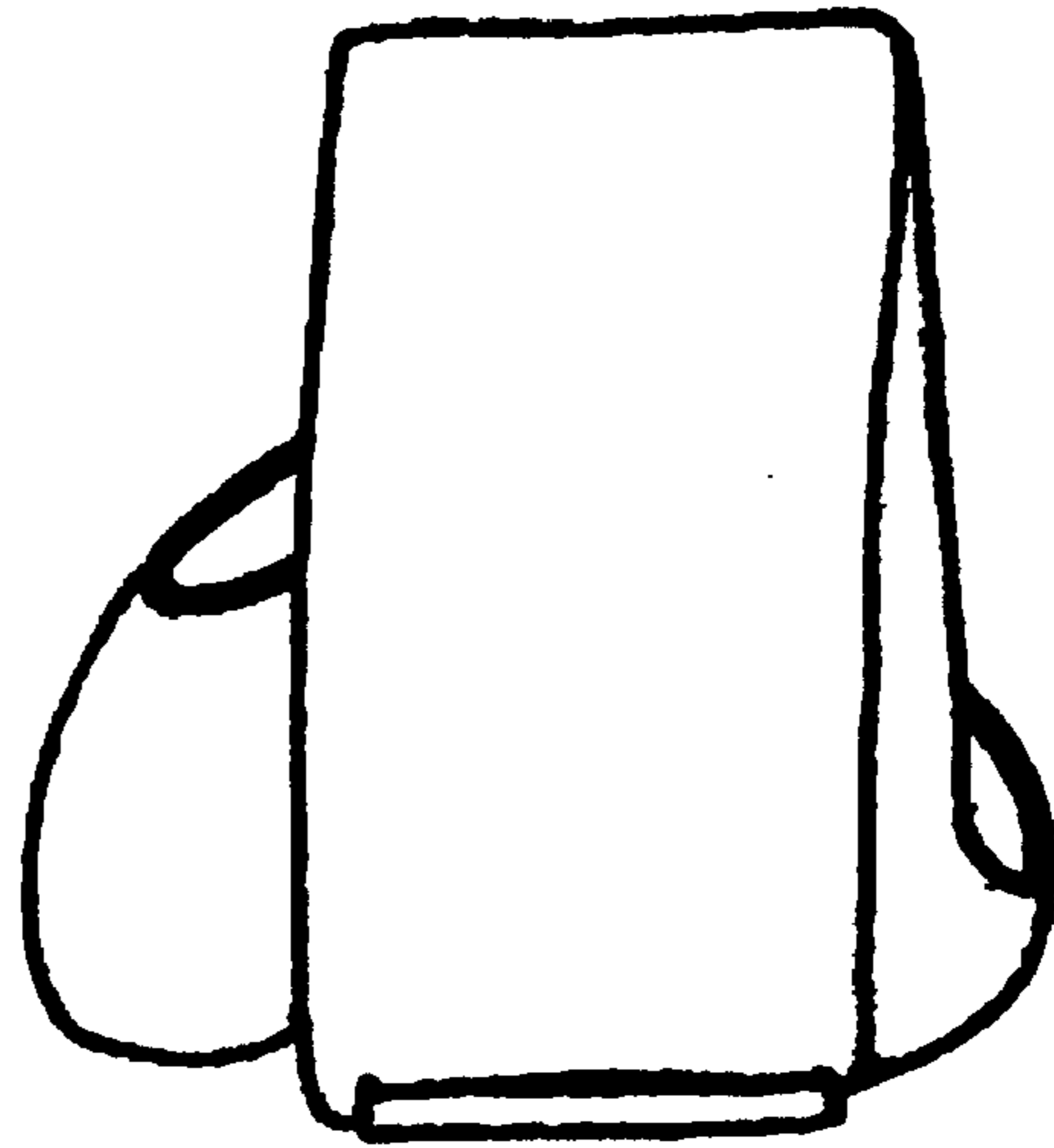

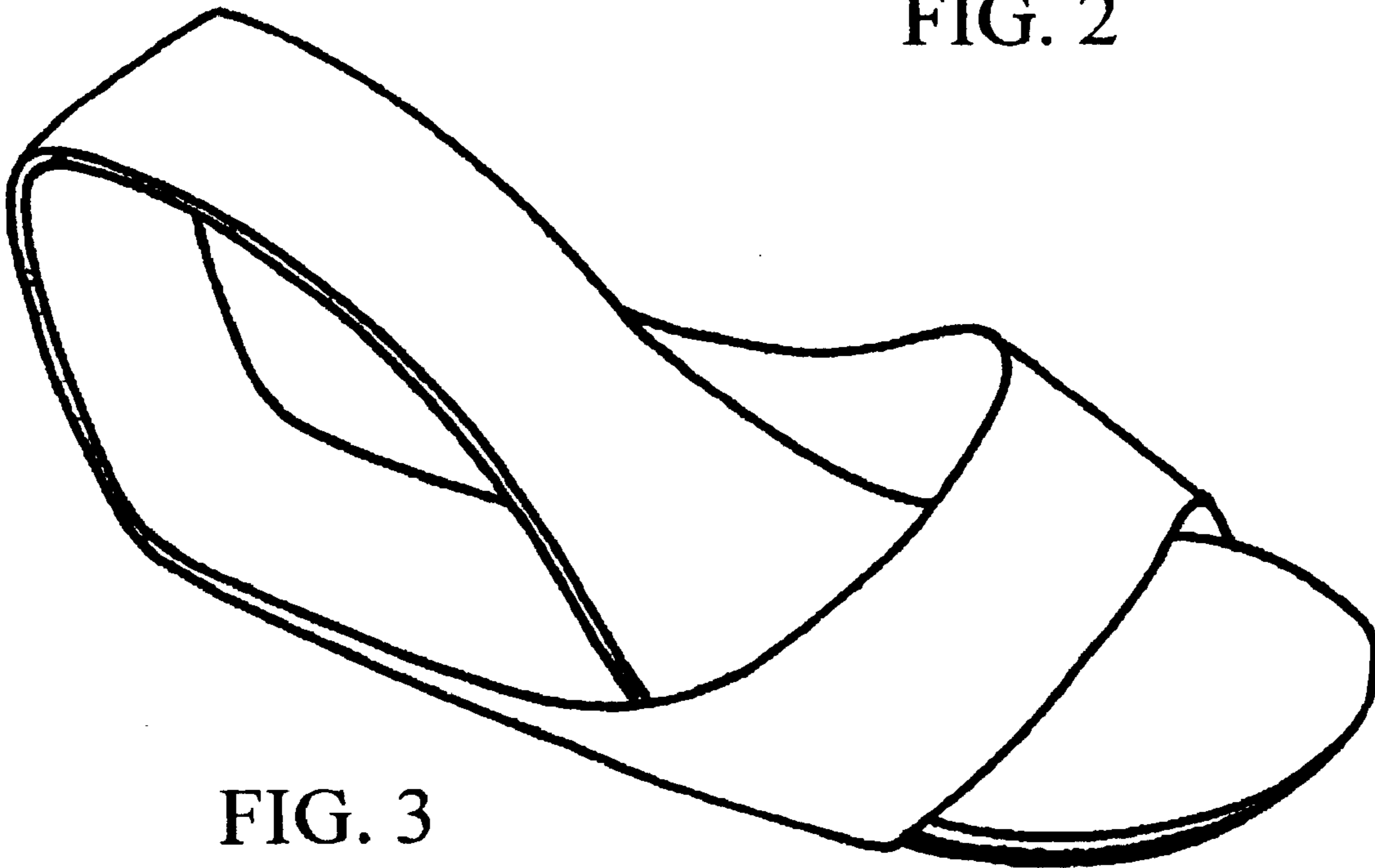

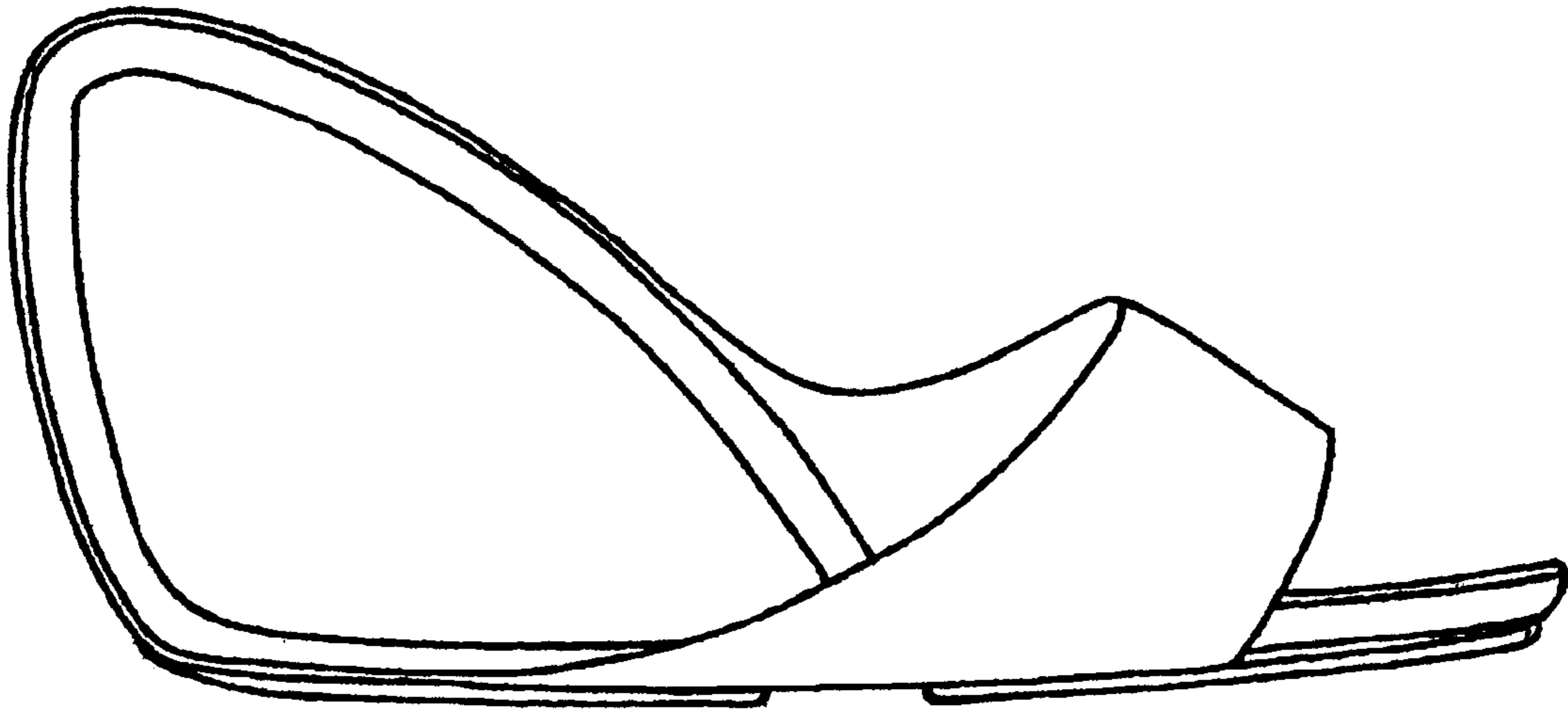

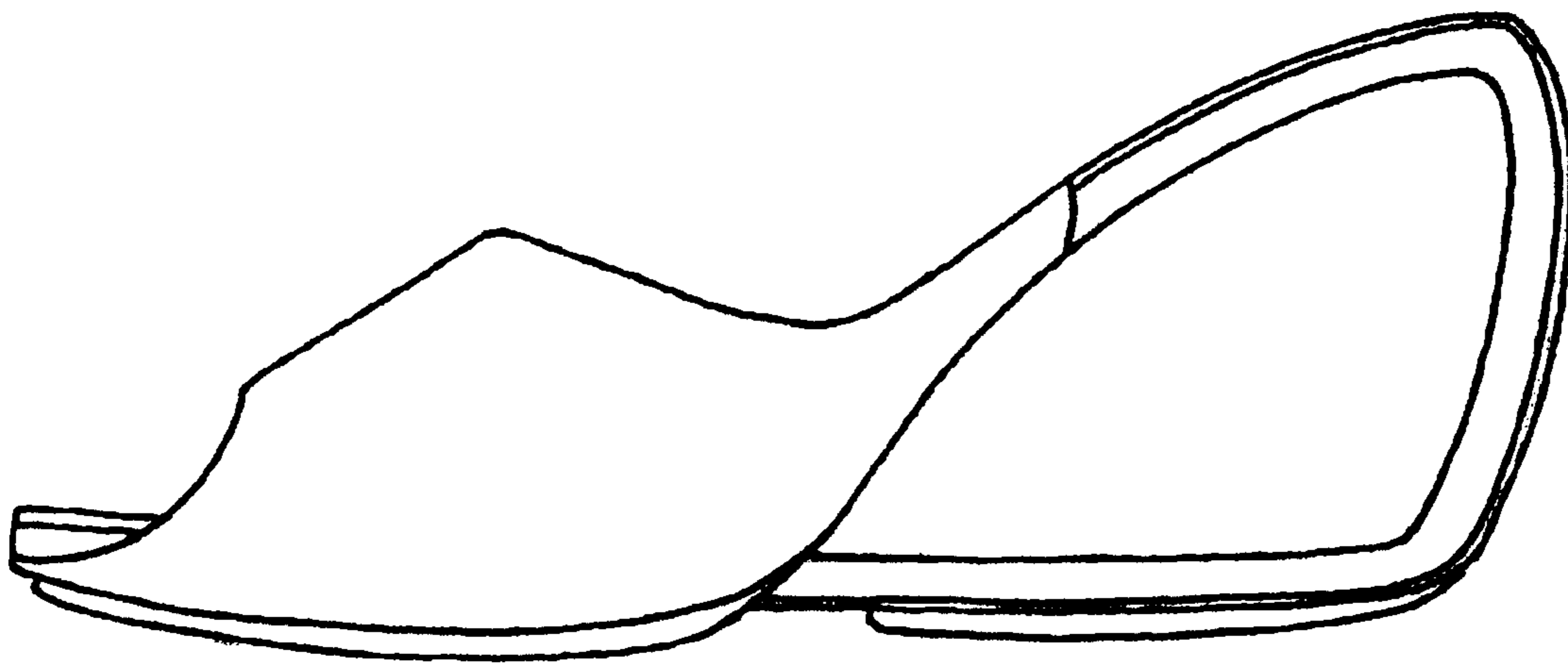

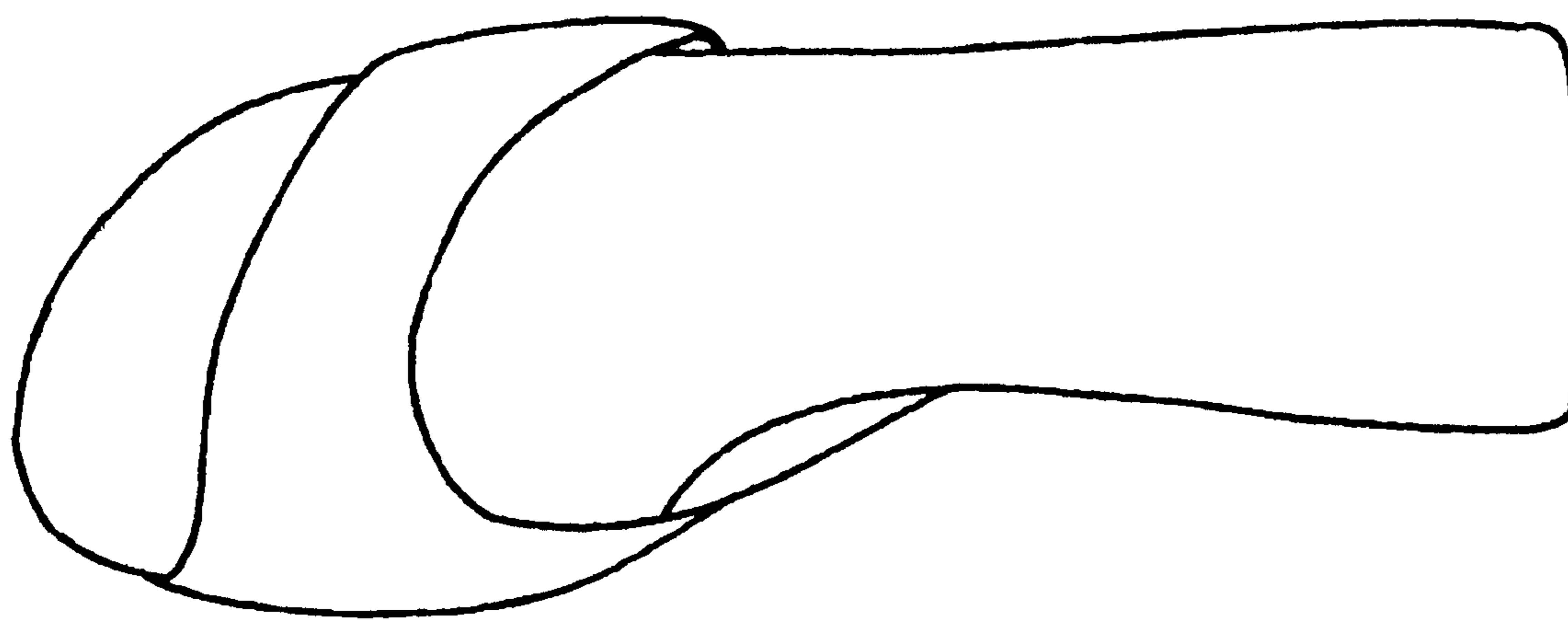

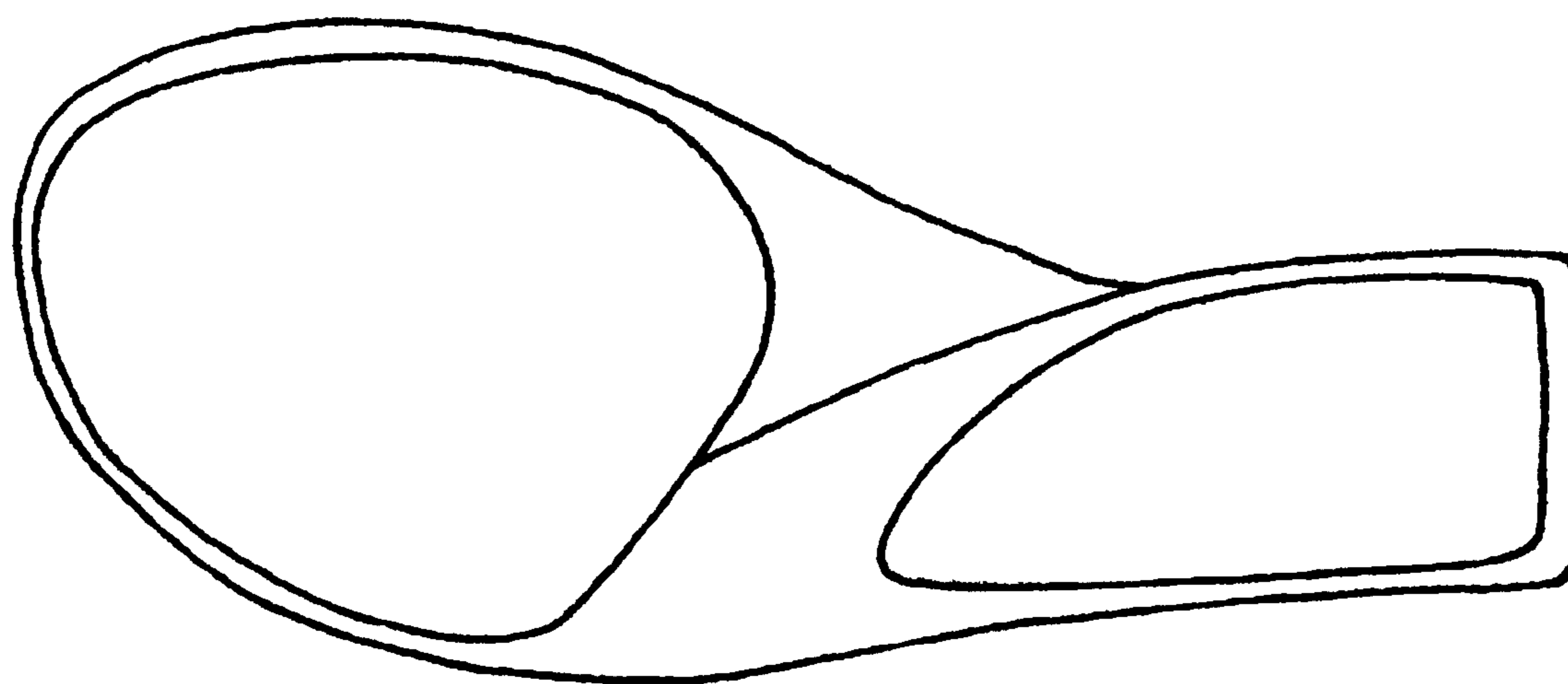

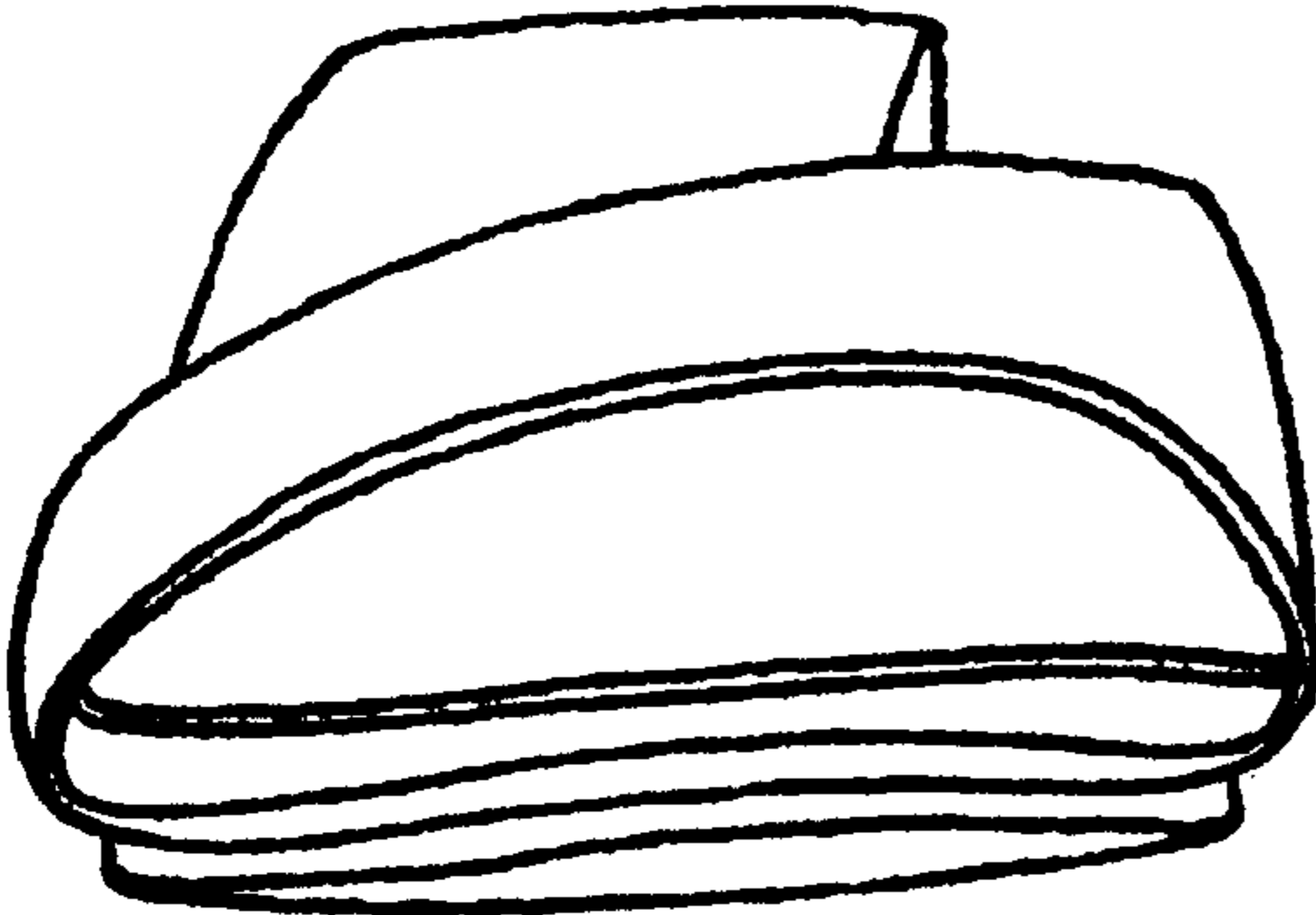

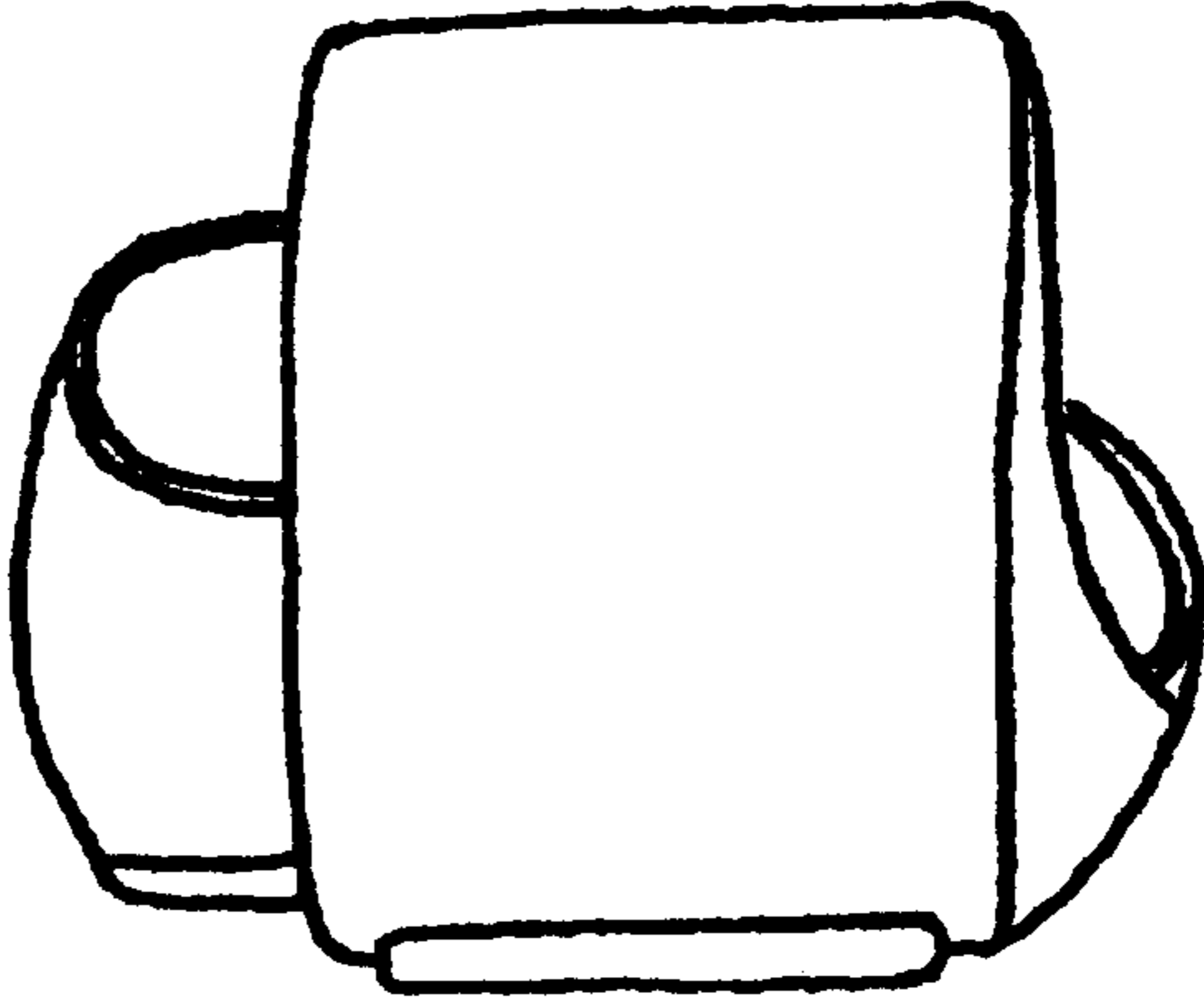

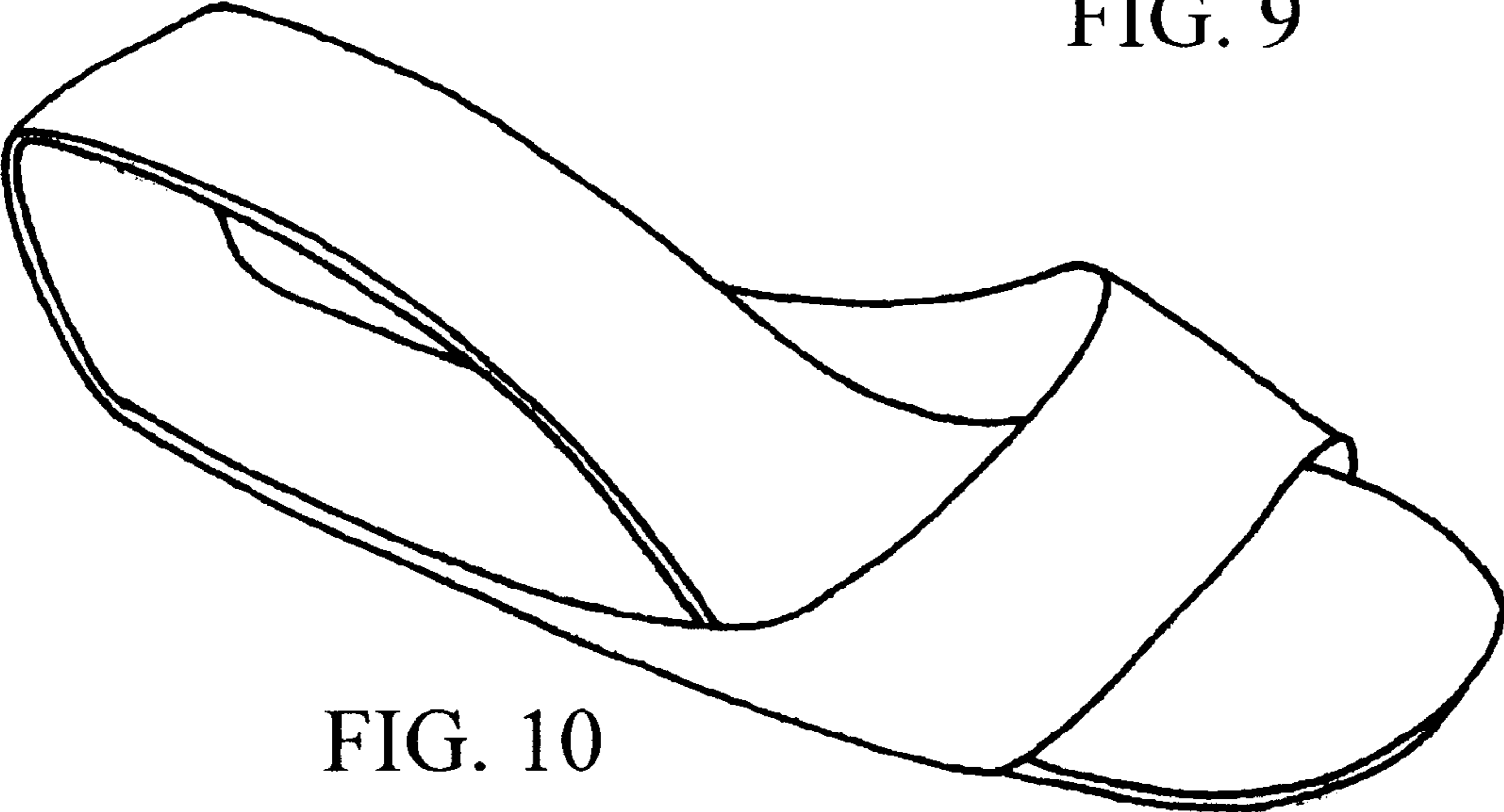

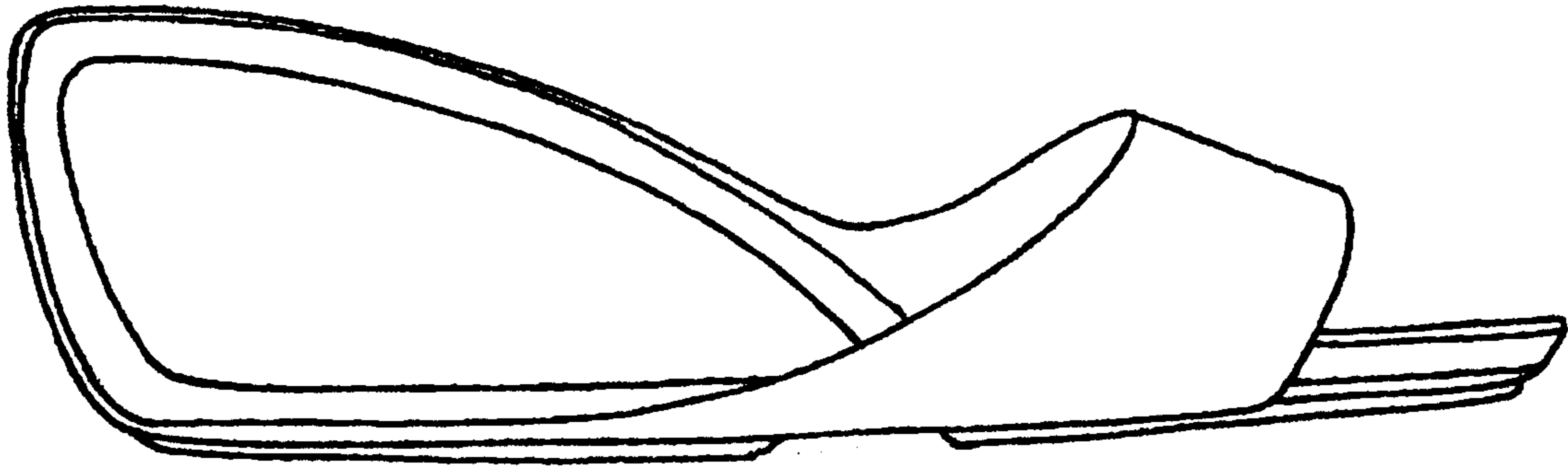

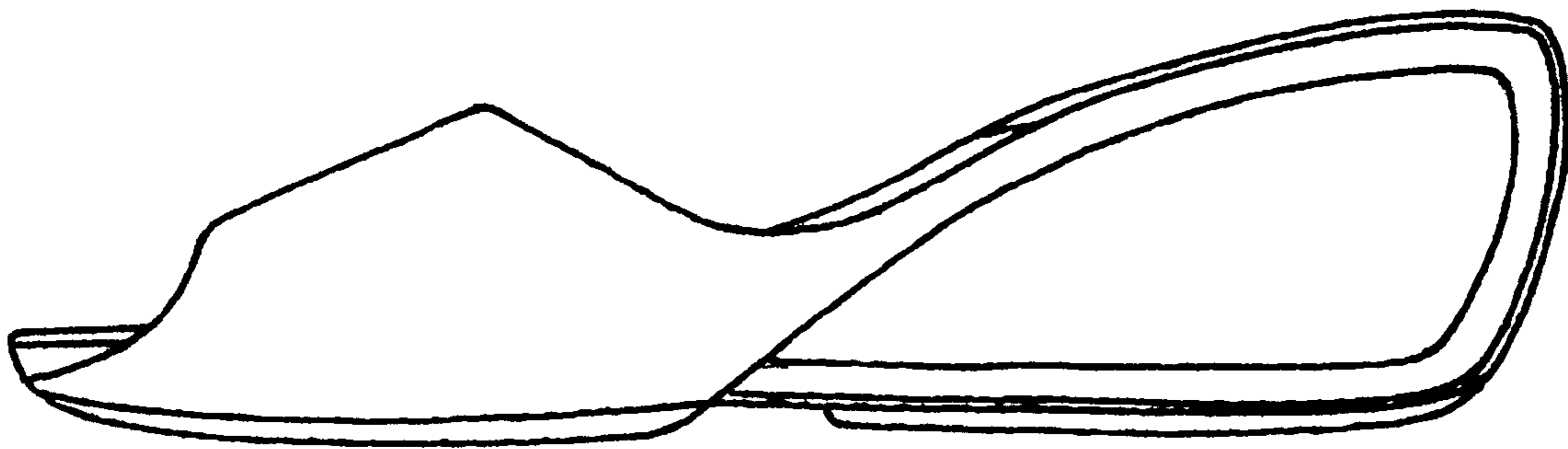

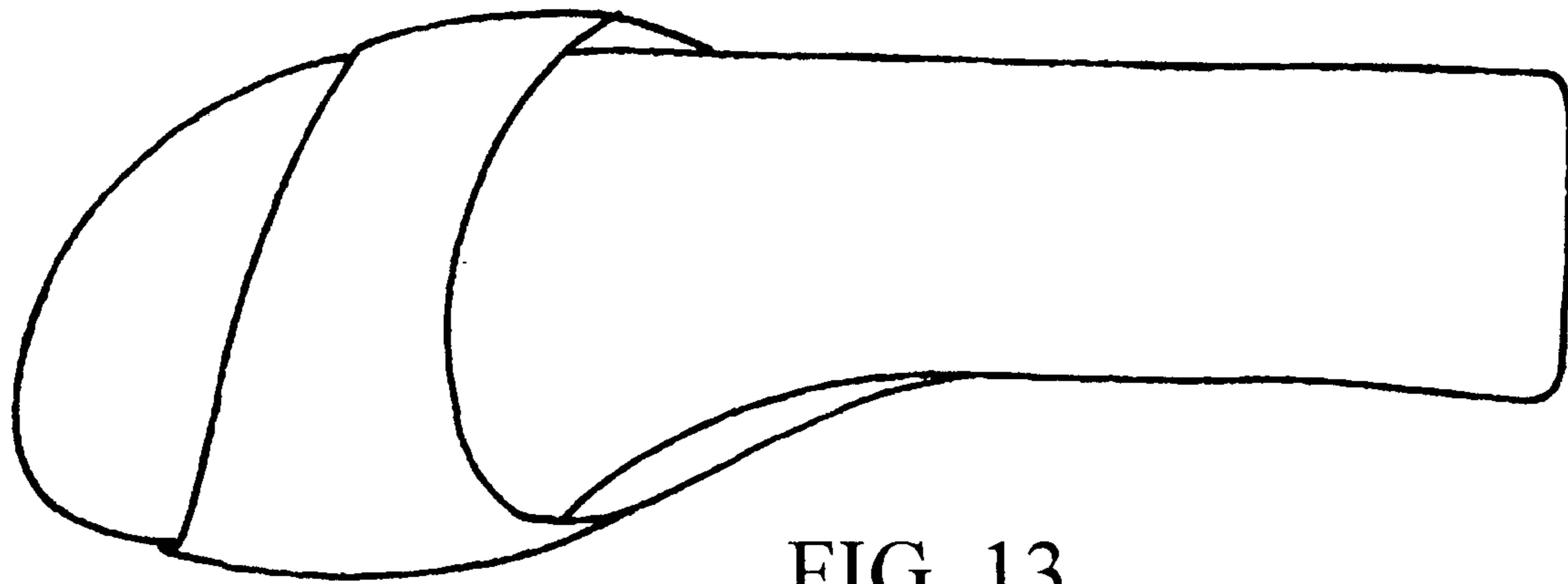

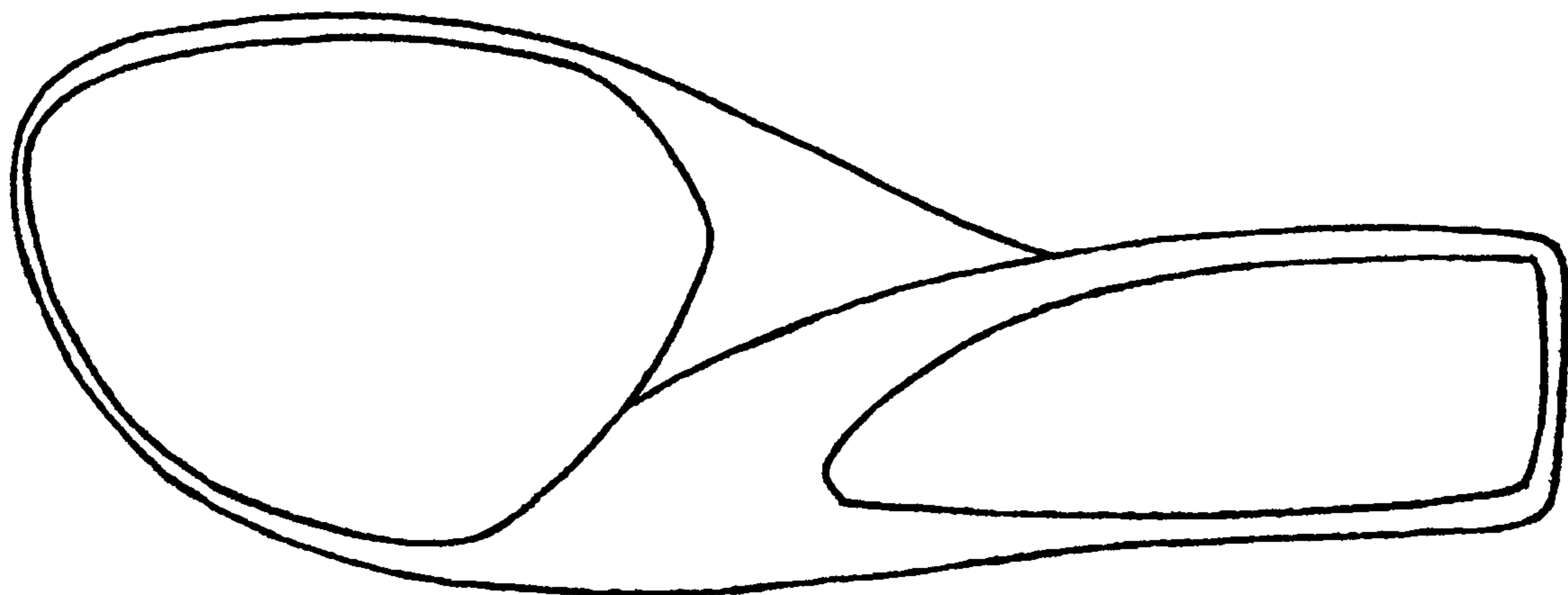
