We claim, the ornamental design for a cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of a cellular phone, showing our new design;

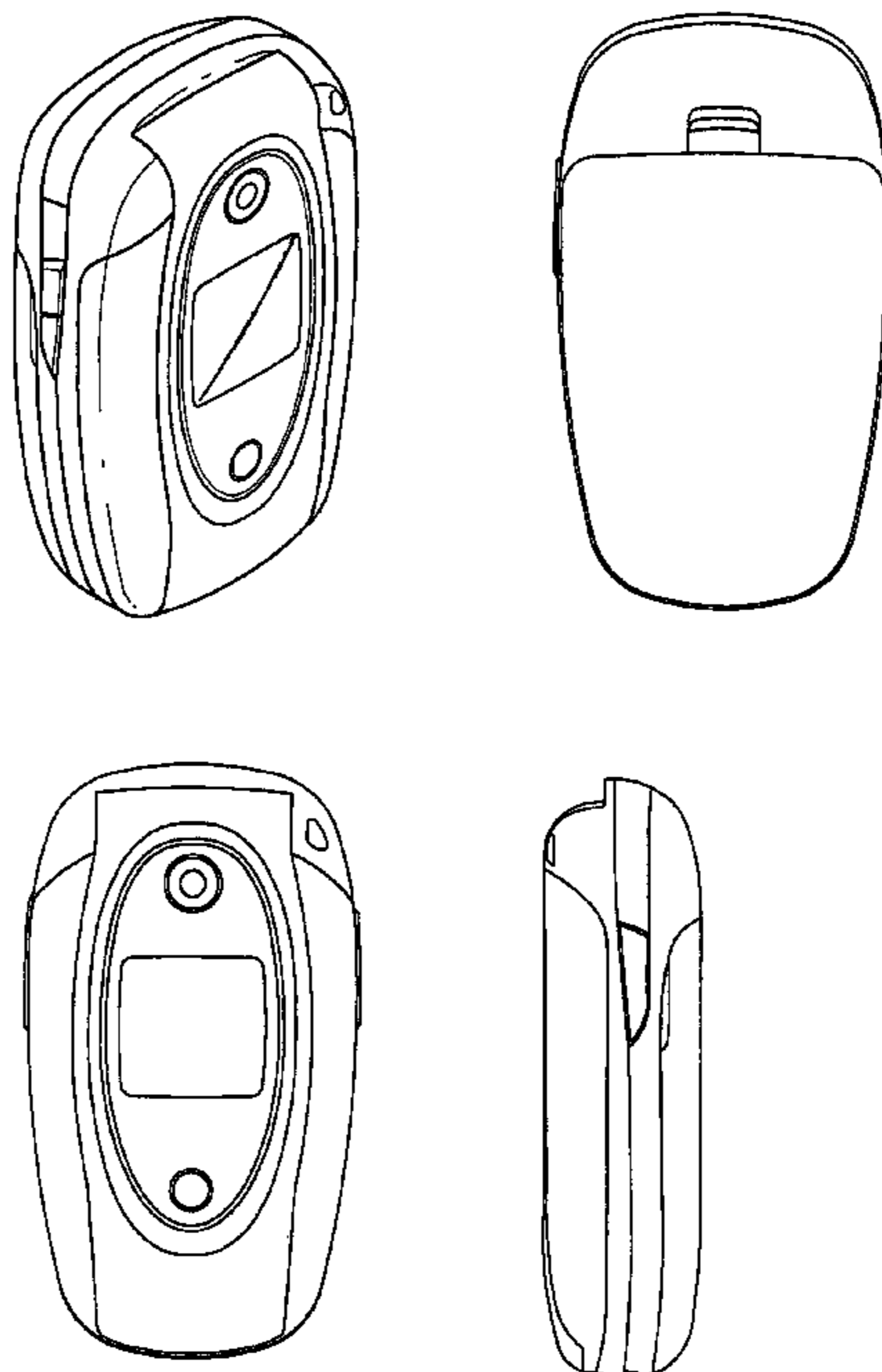

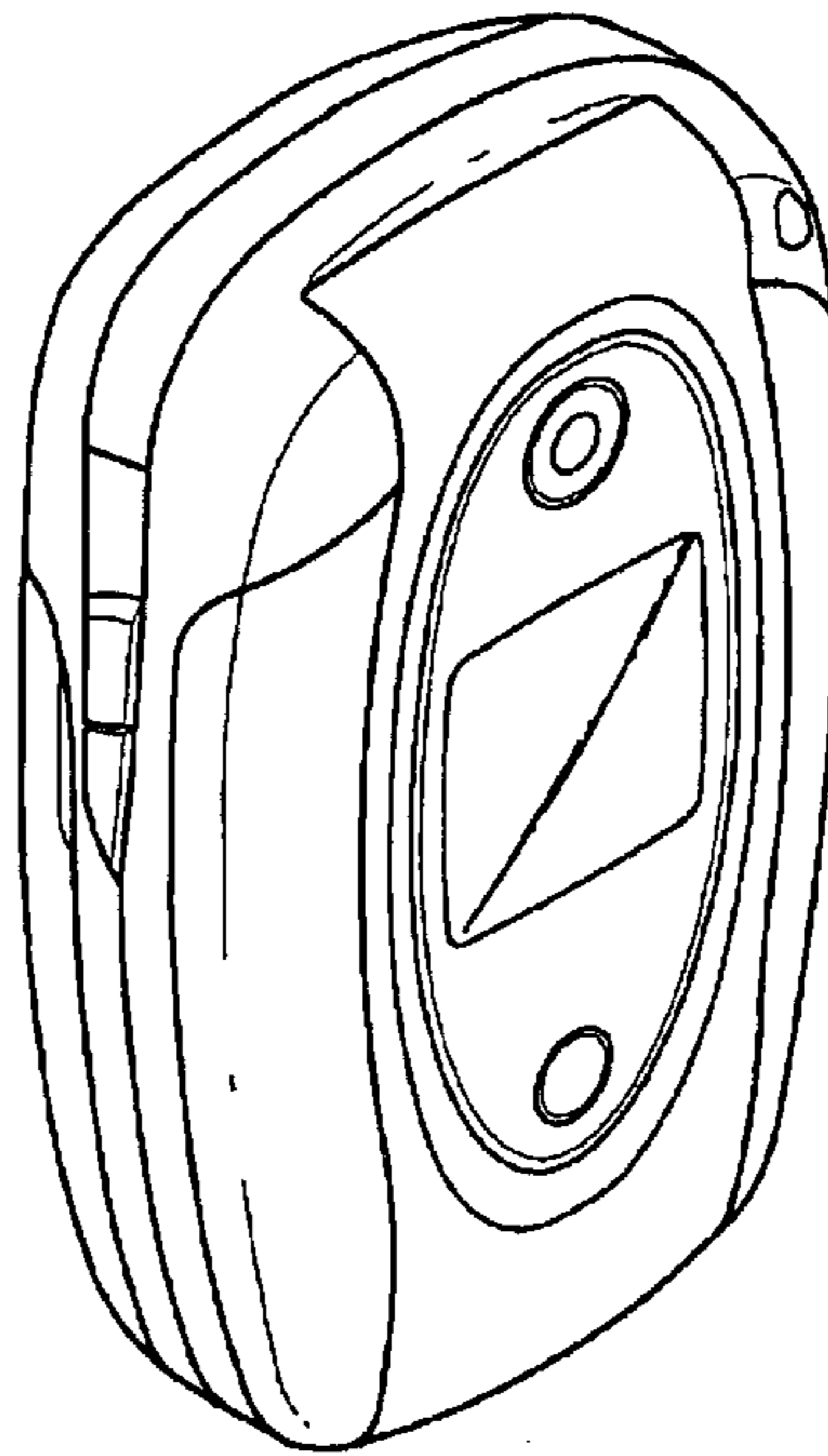

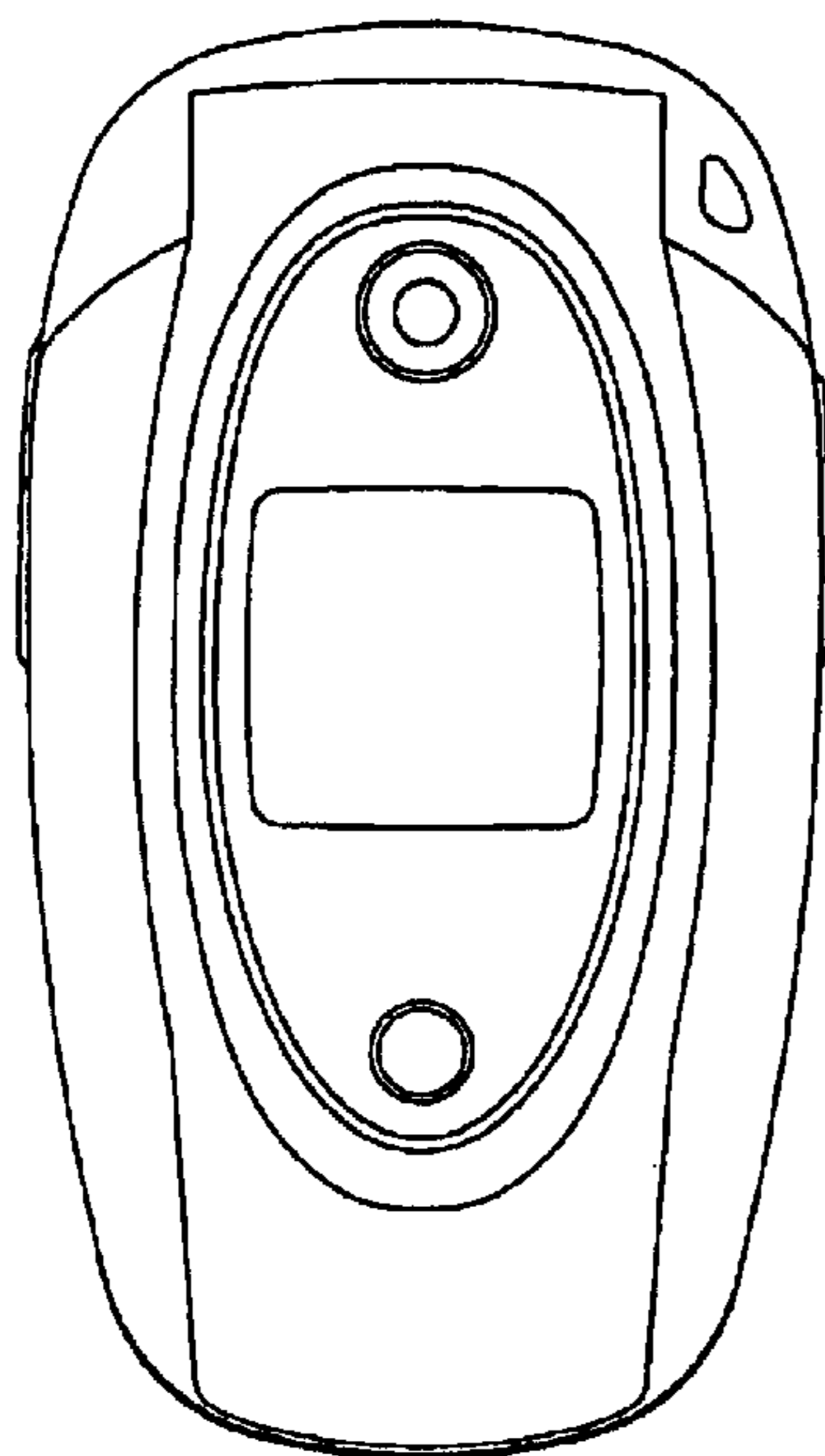

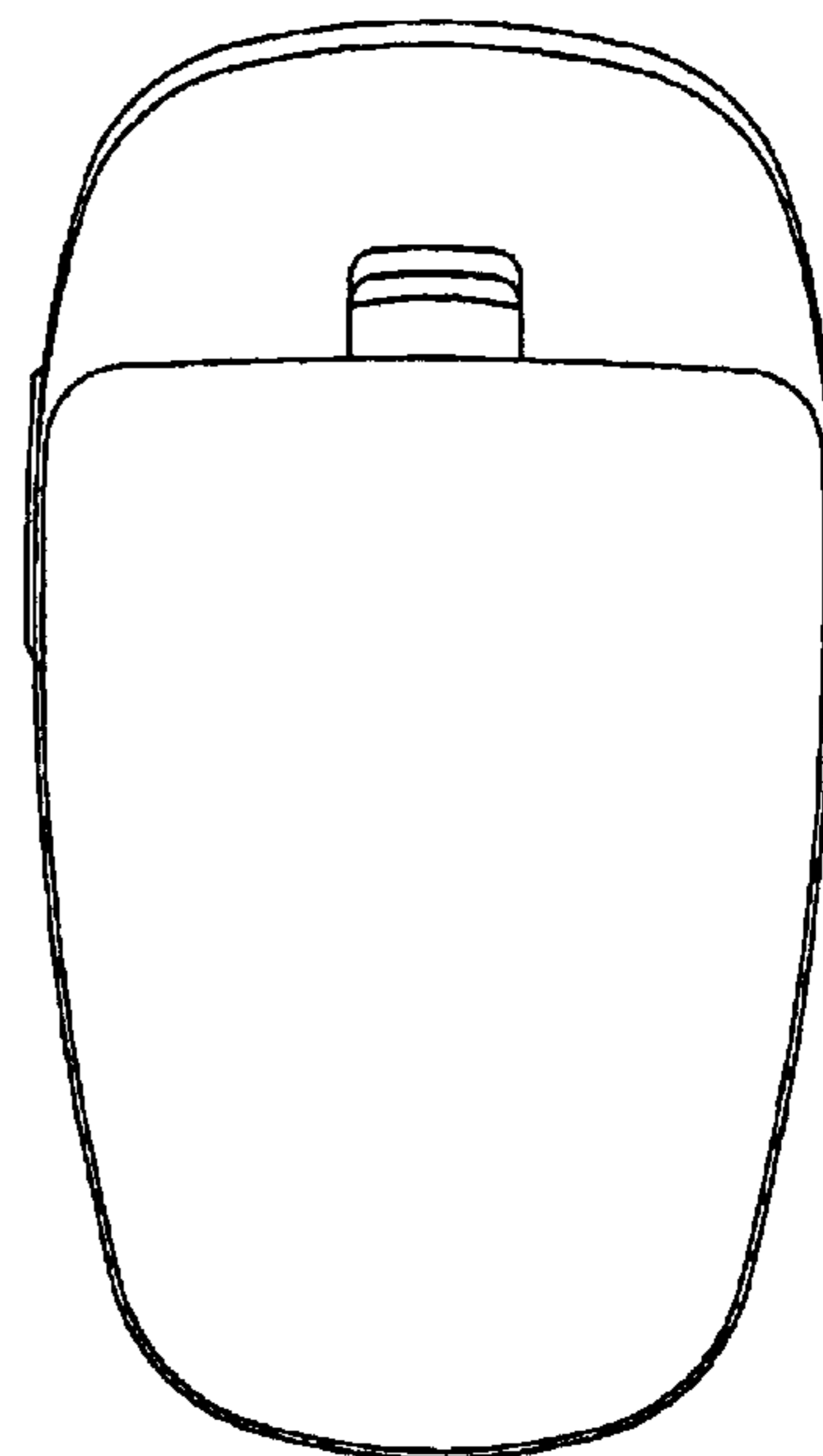

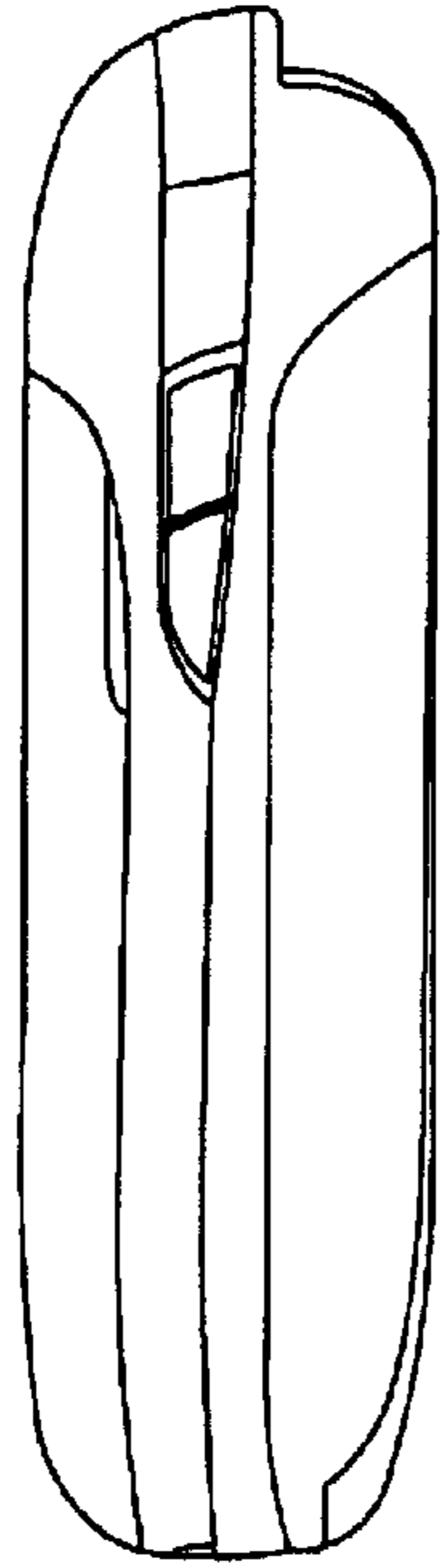

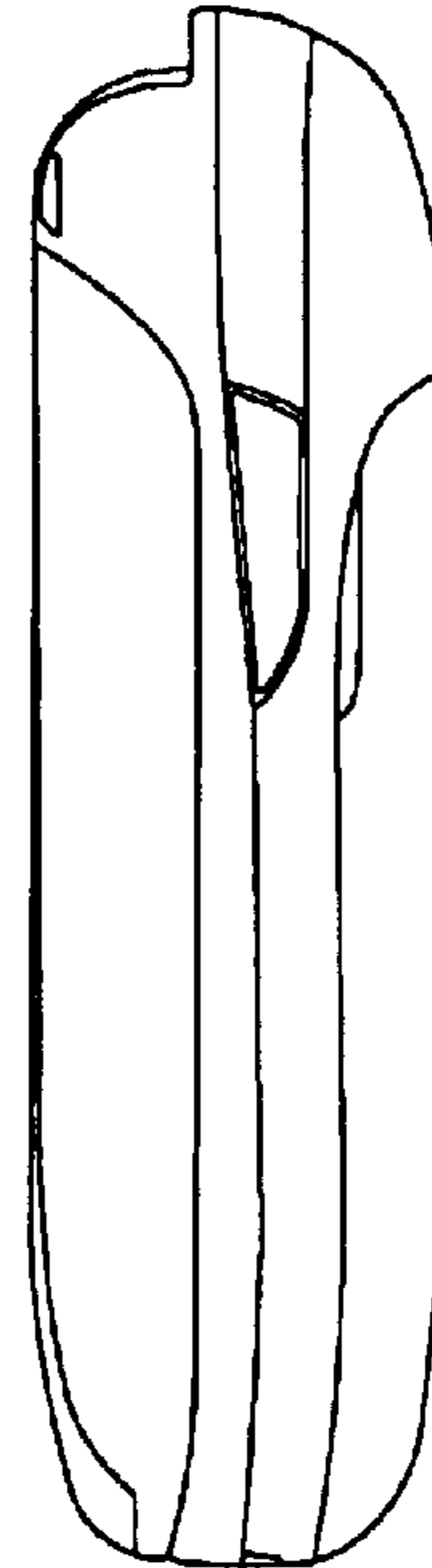

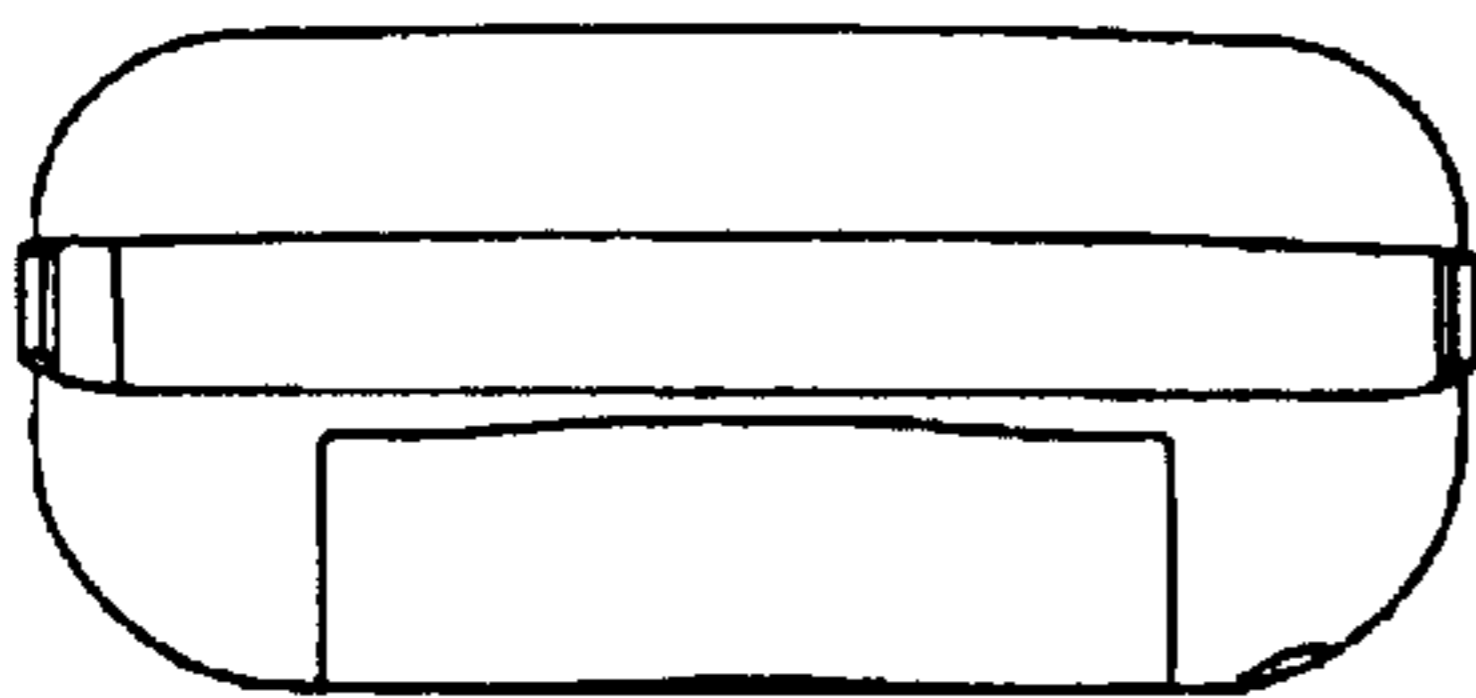
