FIG. 10 is a top plan view of FIG. 8;

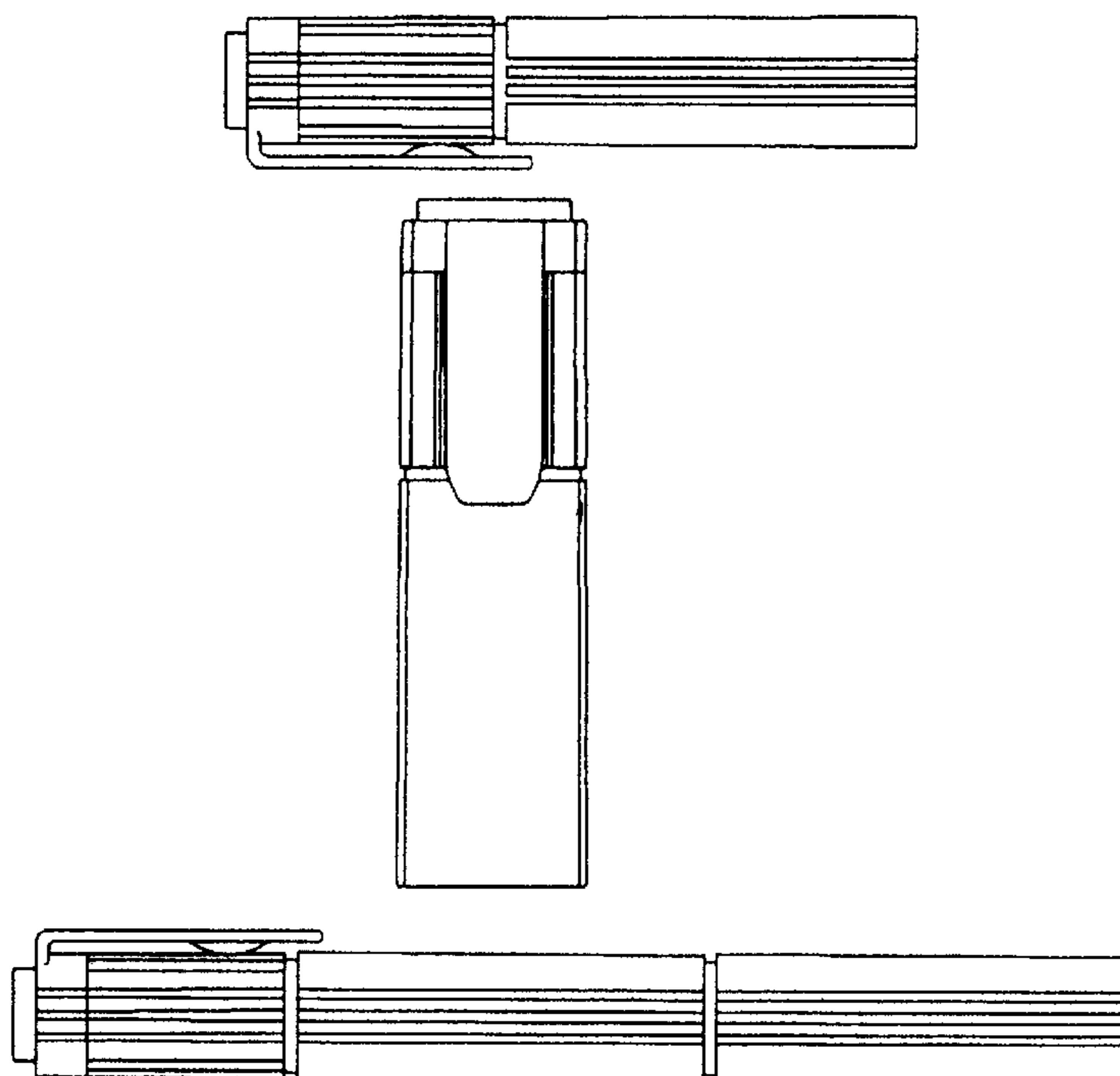
FIG. 11 is a front elevational view of a fourth embodiment of my design of FIG. 1;

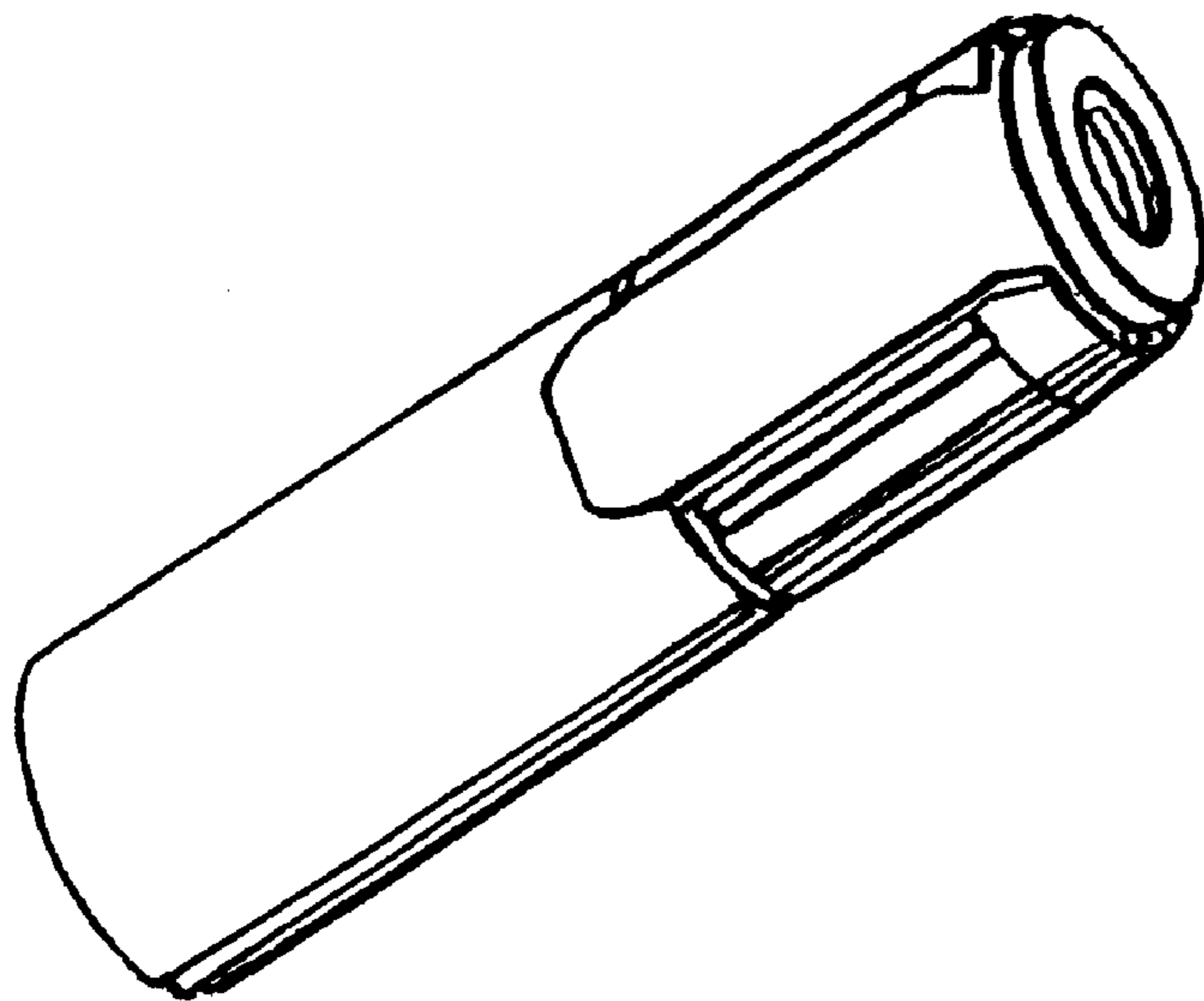

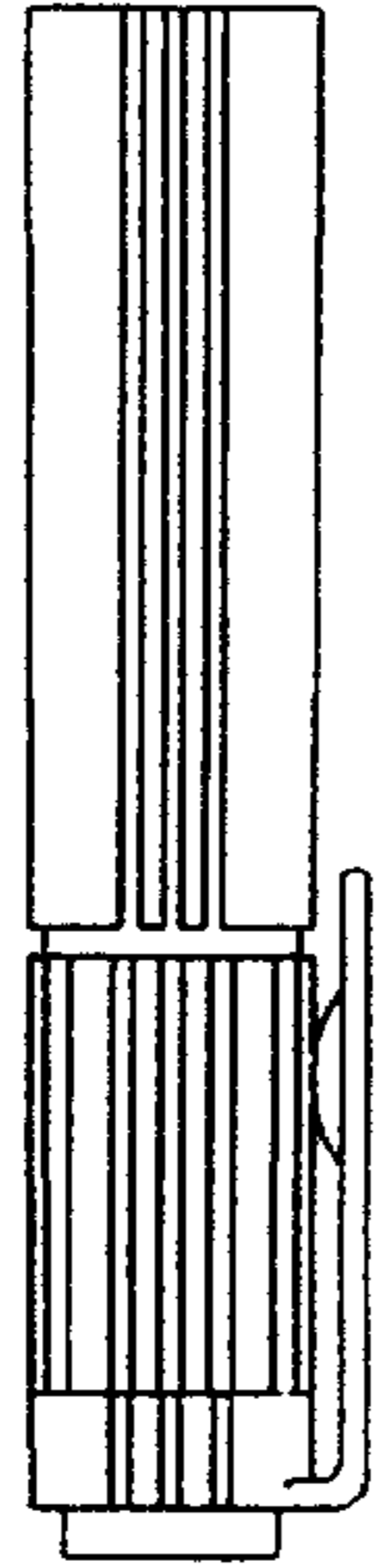

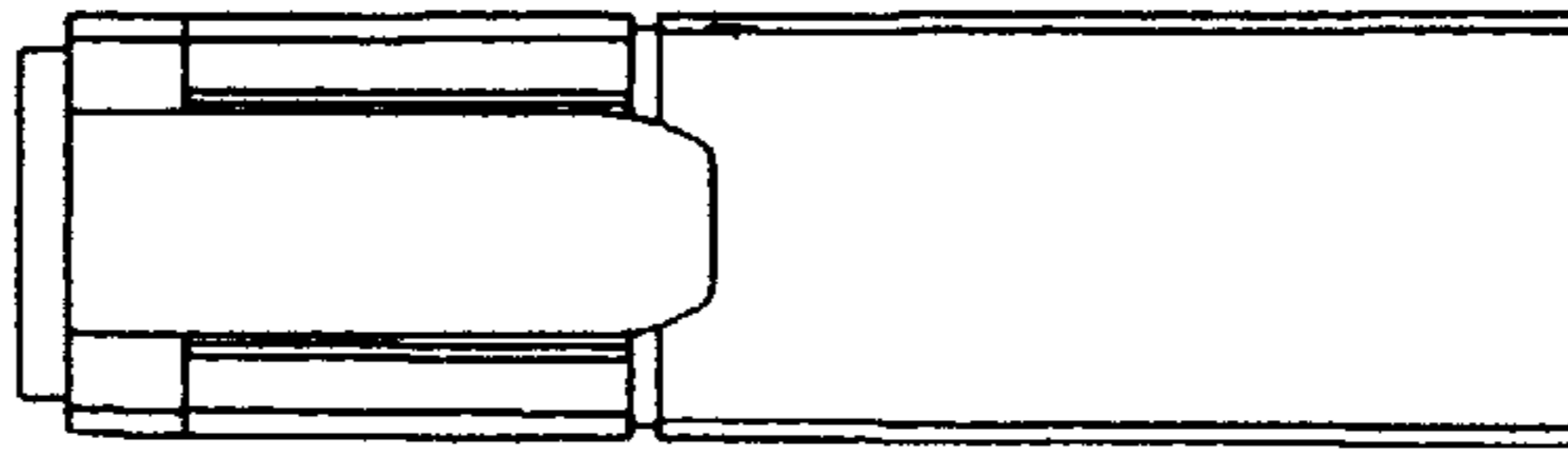

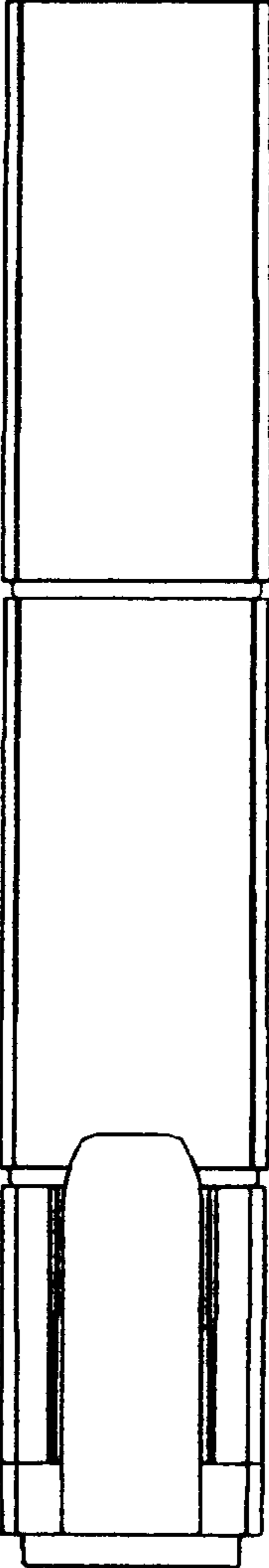

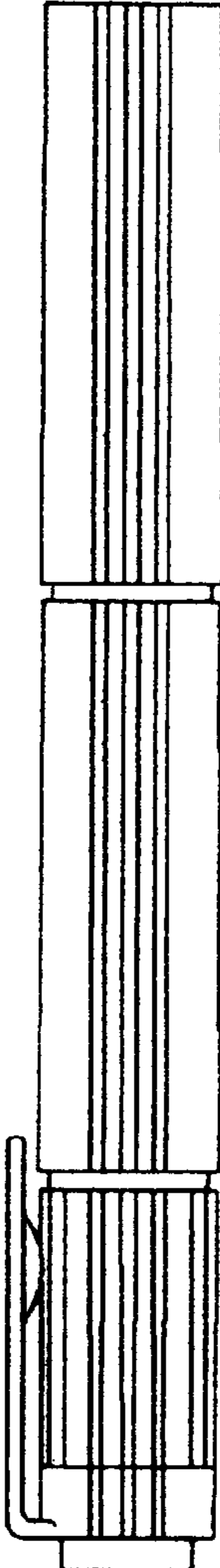
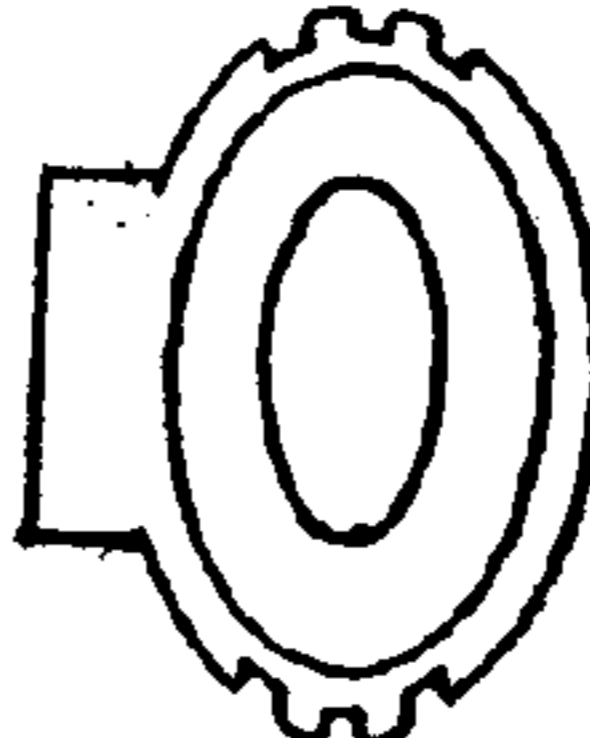

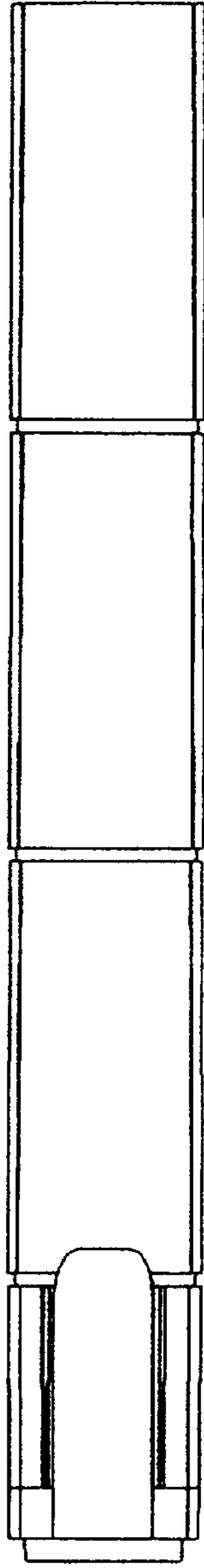

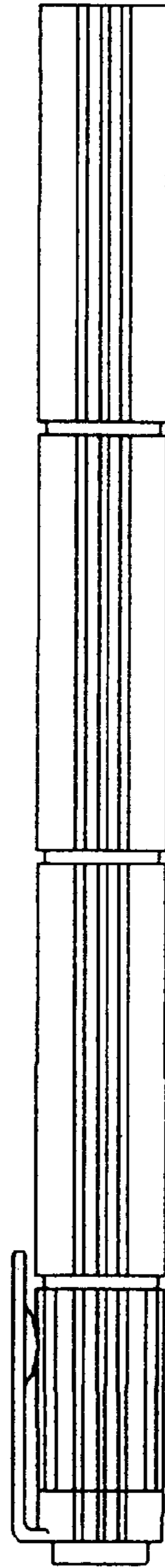

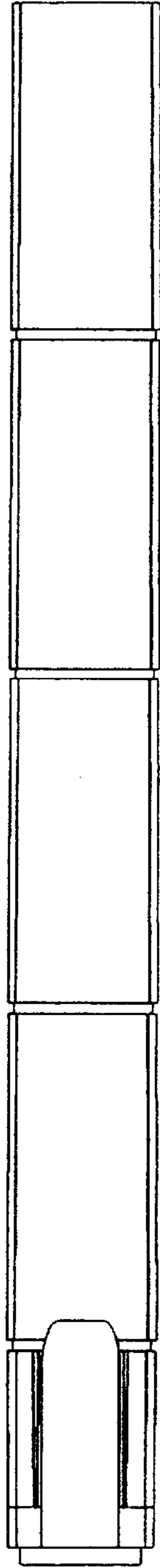

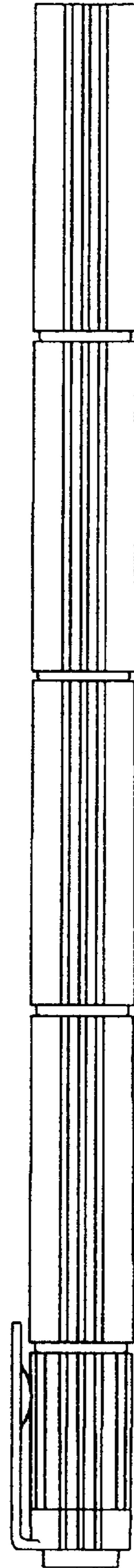

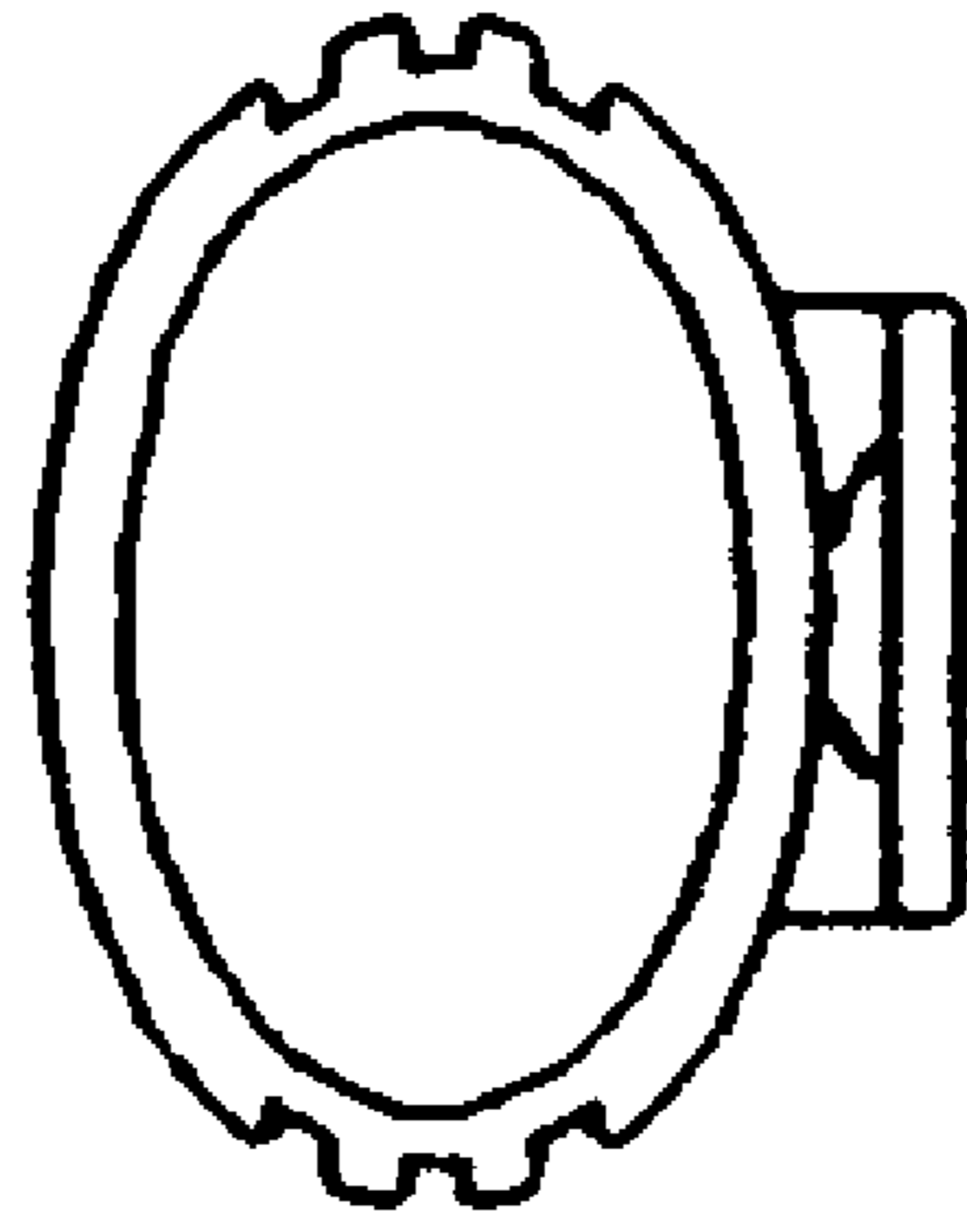
