FIG. 3 is a left side view of the surface configuration of a vehicle, toy, and/or other replicas according to my novel design;

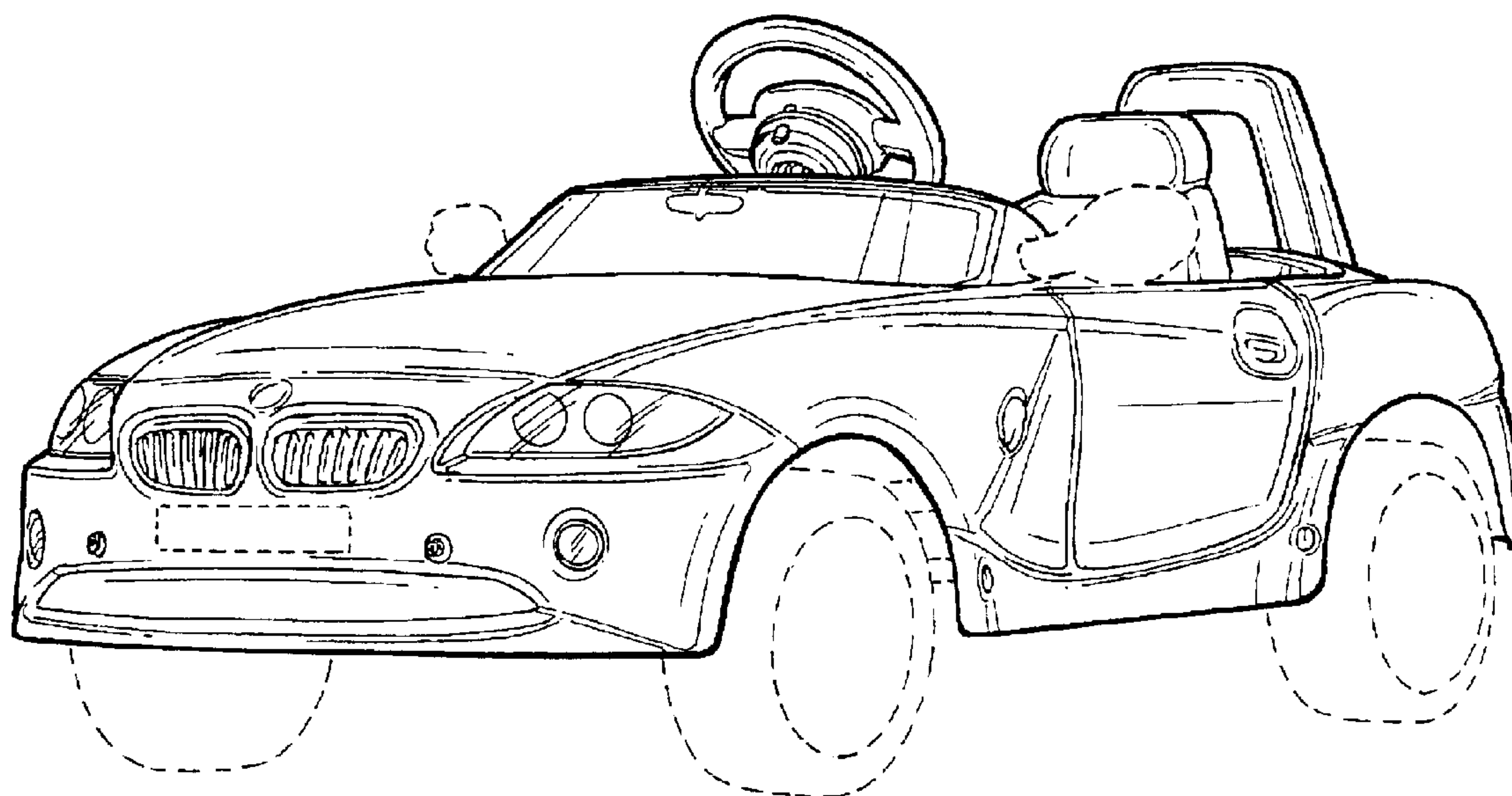
FIG. 4 is a front view of the surface configuration of a vehicle, toy, and/or other replicas according to my novel design;

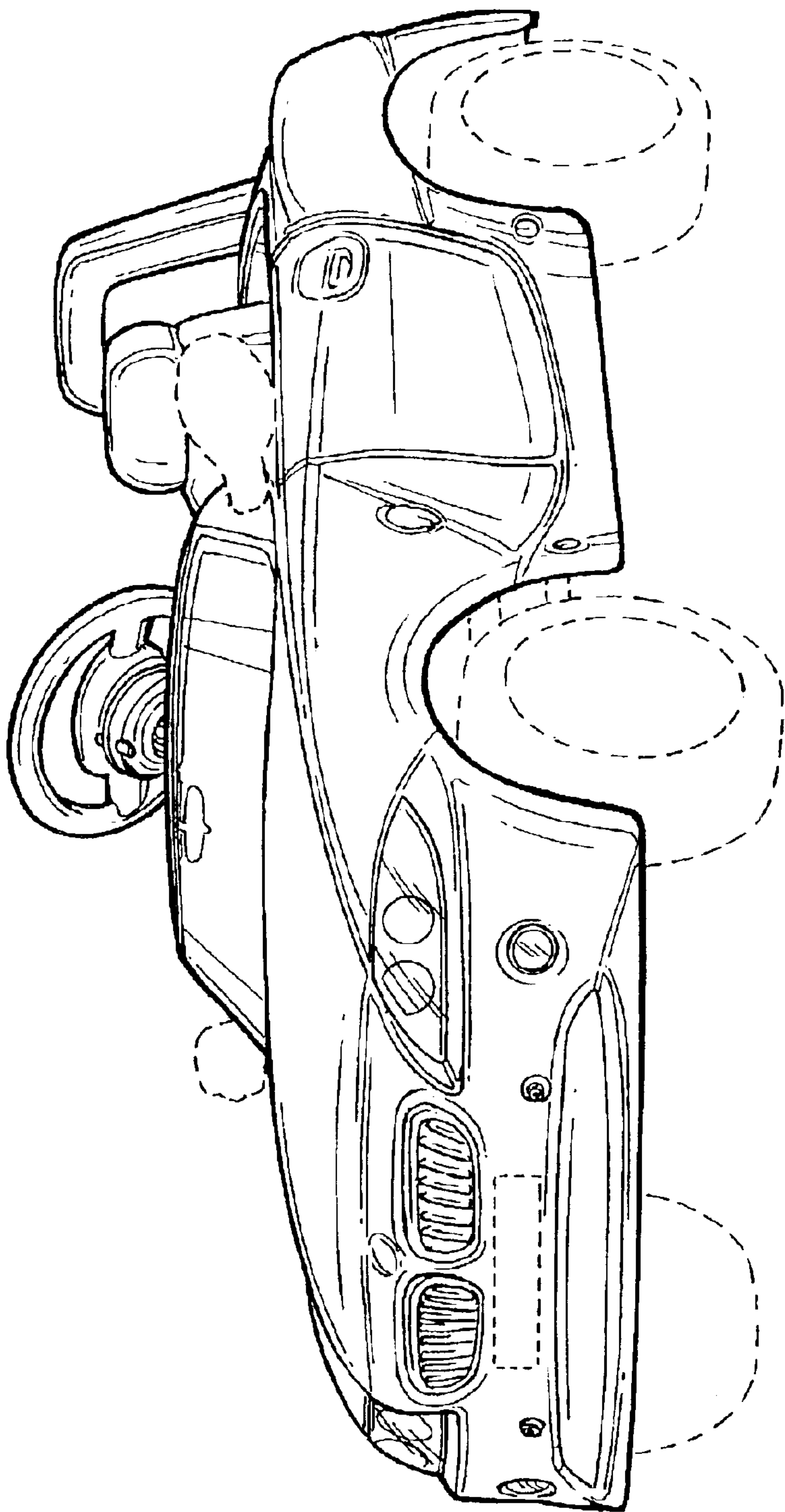

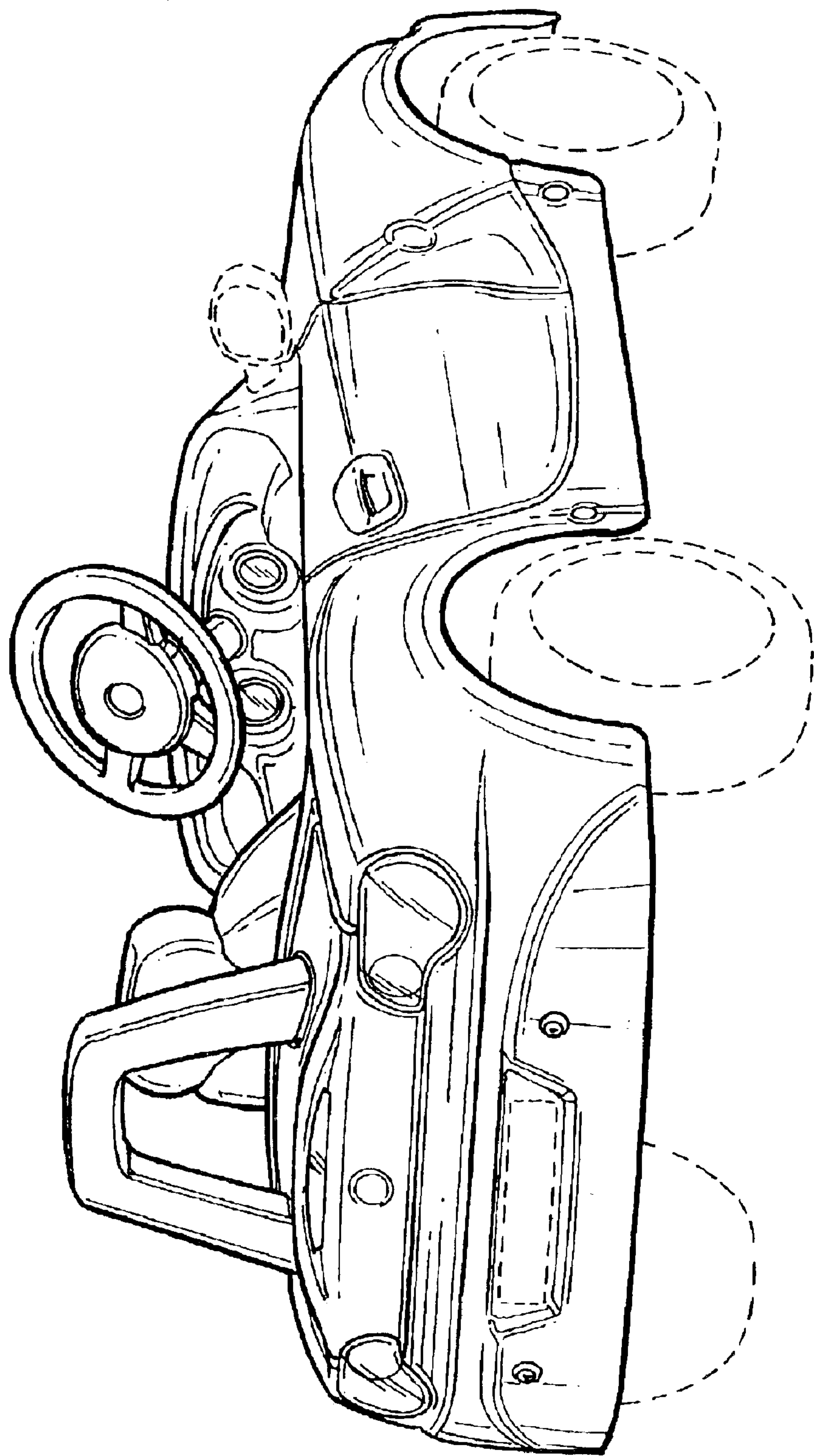

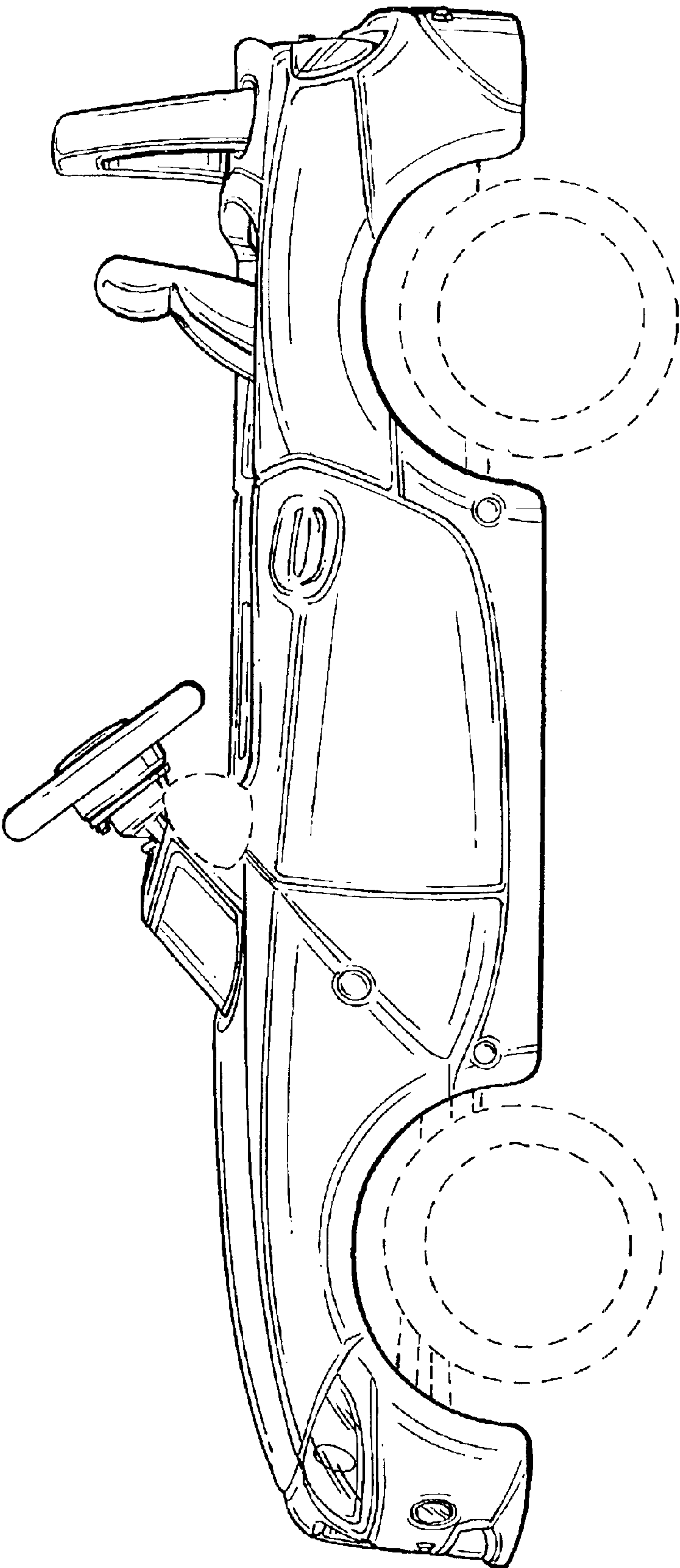

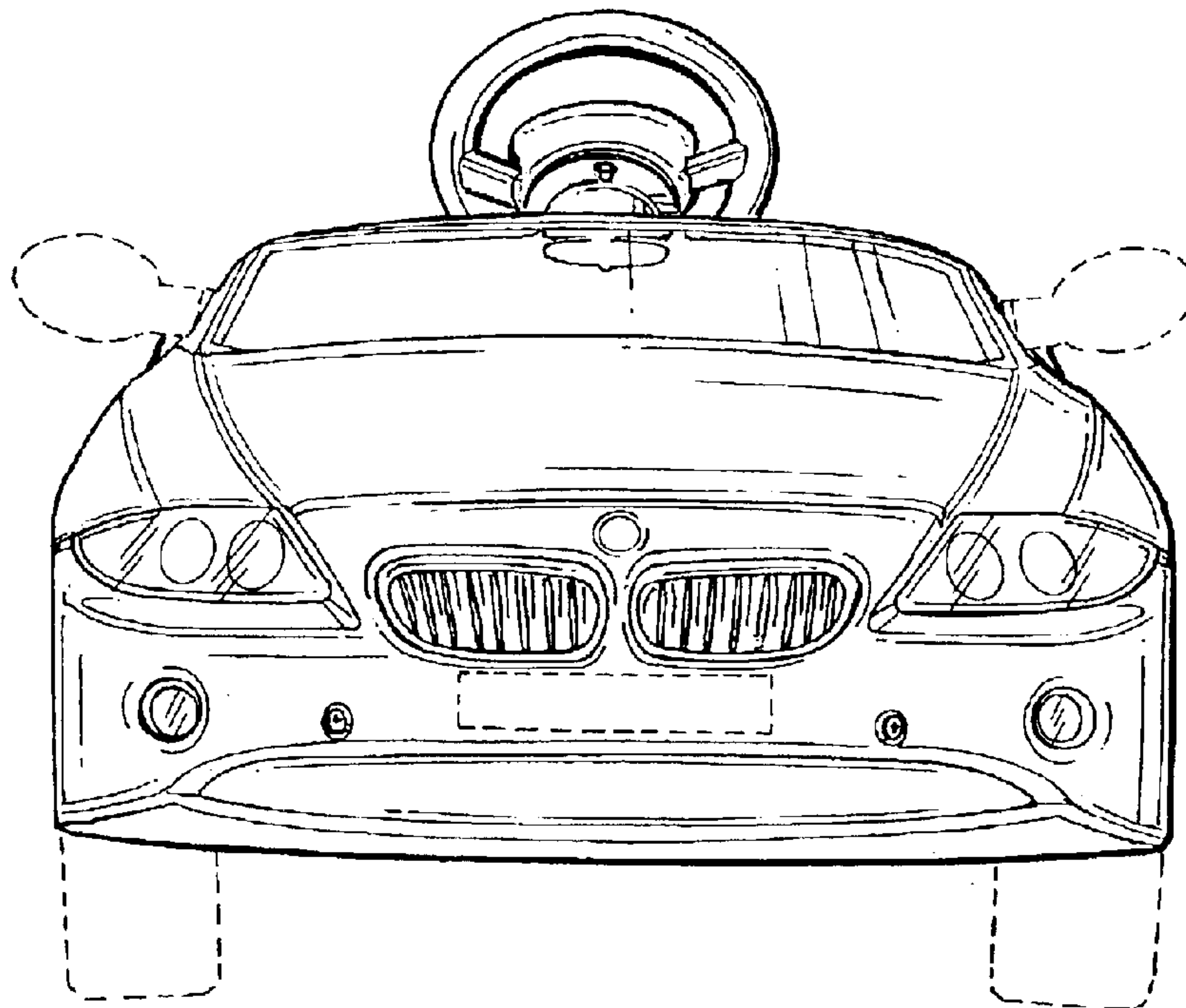

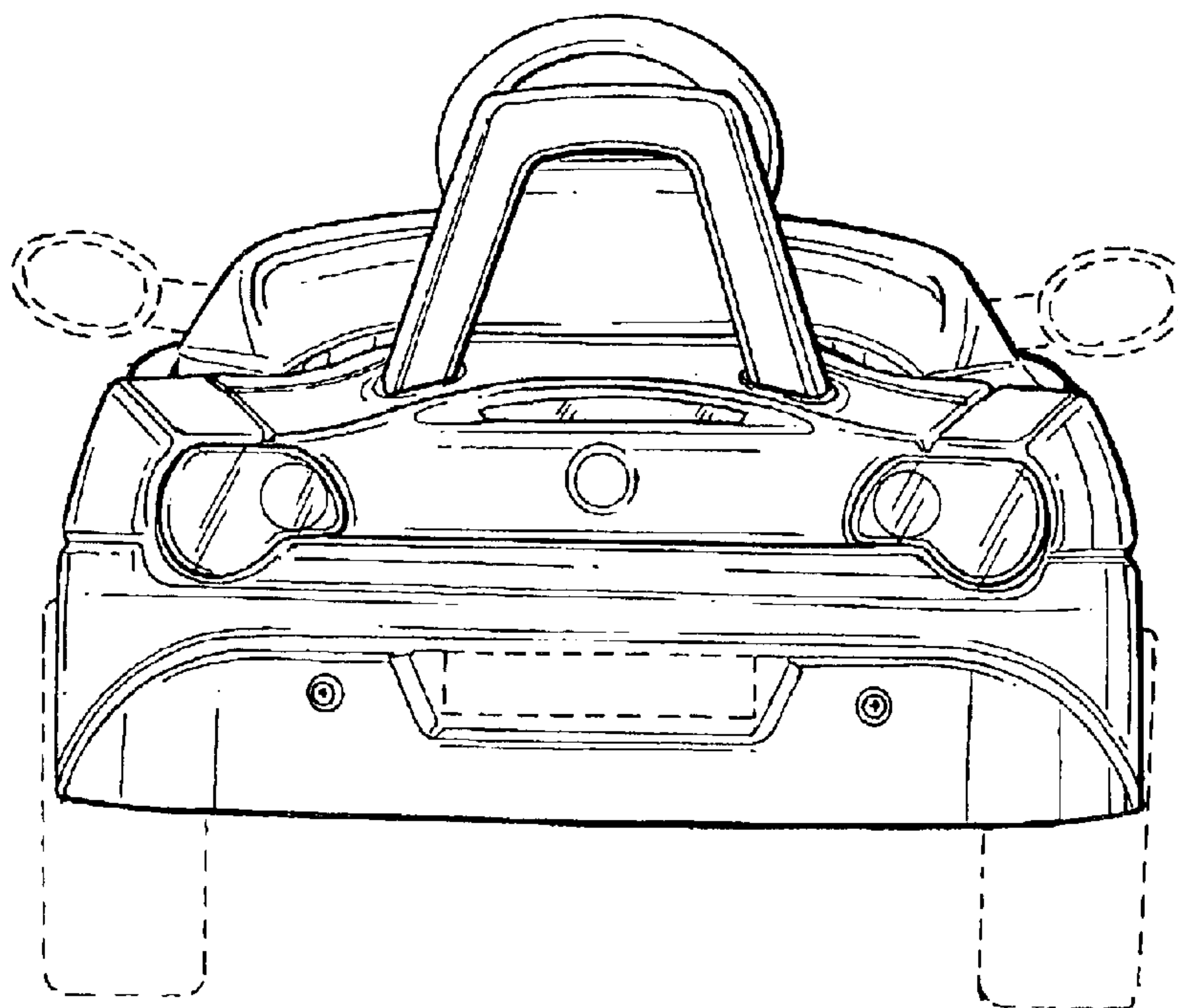

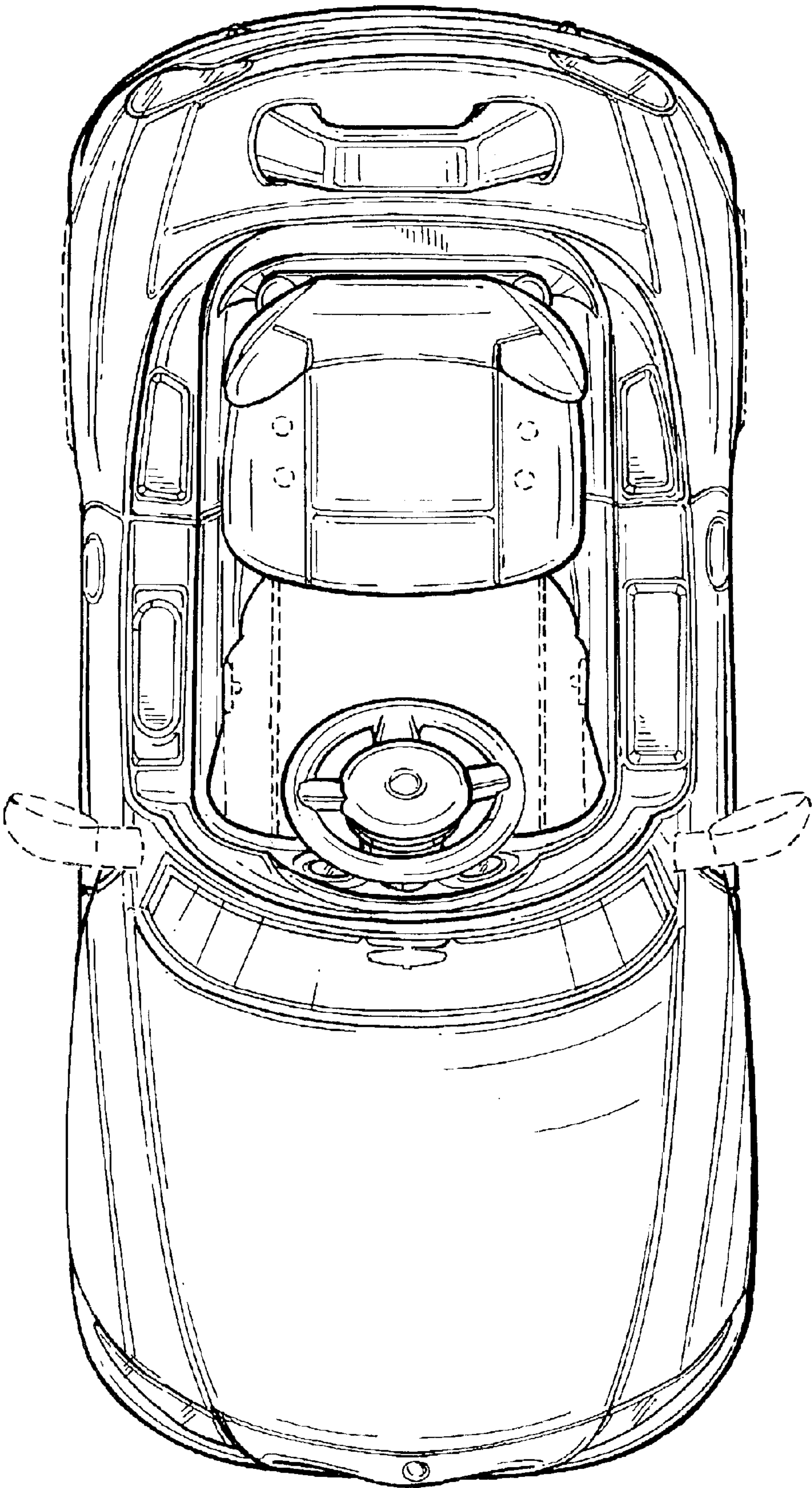
