(57) **CLAIM**

The ornamental design for a covering for a water closet, as shown and described.

**DESCRIPTION**

In a preferred embodiment, the nature of this product is as a cover pivotably attachable to a toilet so as to cover a toilet seat when the toilet is not in use.

FIG. 1 is a left, front, top perspective view of a covering for a water closet embodying my new design;

 FIG. 15 is a rear elevational view thereof;  
 FIG. 16 is a top plan view thereof;  
 FIG. 17 is a left side elevational view thereof, the right side elevational view being the mirror image of the left side shown;  
 FIG. 18 is a bottom plan view thereof;  
 FIG. 19 is a left, front, top perspective view of a fourth embodiment of my new design;  
 FIG. 20 is a front elevational view thereof;  
 FIG. 21 is a rear elevational view thereof;  
 FIG. 22 is a top plan view thereof;  
 FIG. 23 is a left side elevational view thereof, the right side elevational view being the mirror image of the left side shown; and,  
 FIG. 24 is a bottom plan view thereof.

The broken line representations of four risers in FIGS. 2, 3, 5, 6, 8, 9, 11, 12, 14, 15, 17, 18, 20, 21, 23 and 24 are for the purpose of illustration only, and form no part of the claimed design.

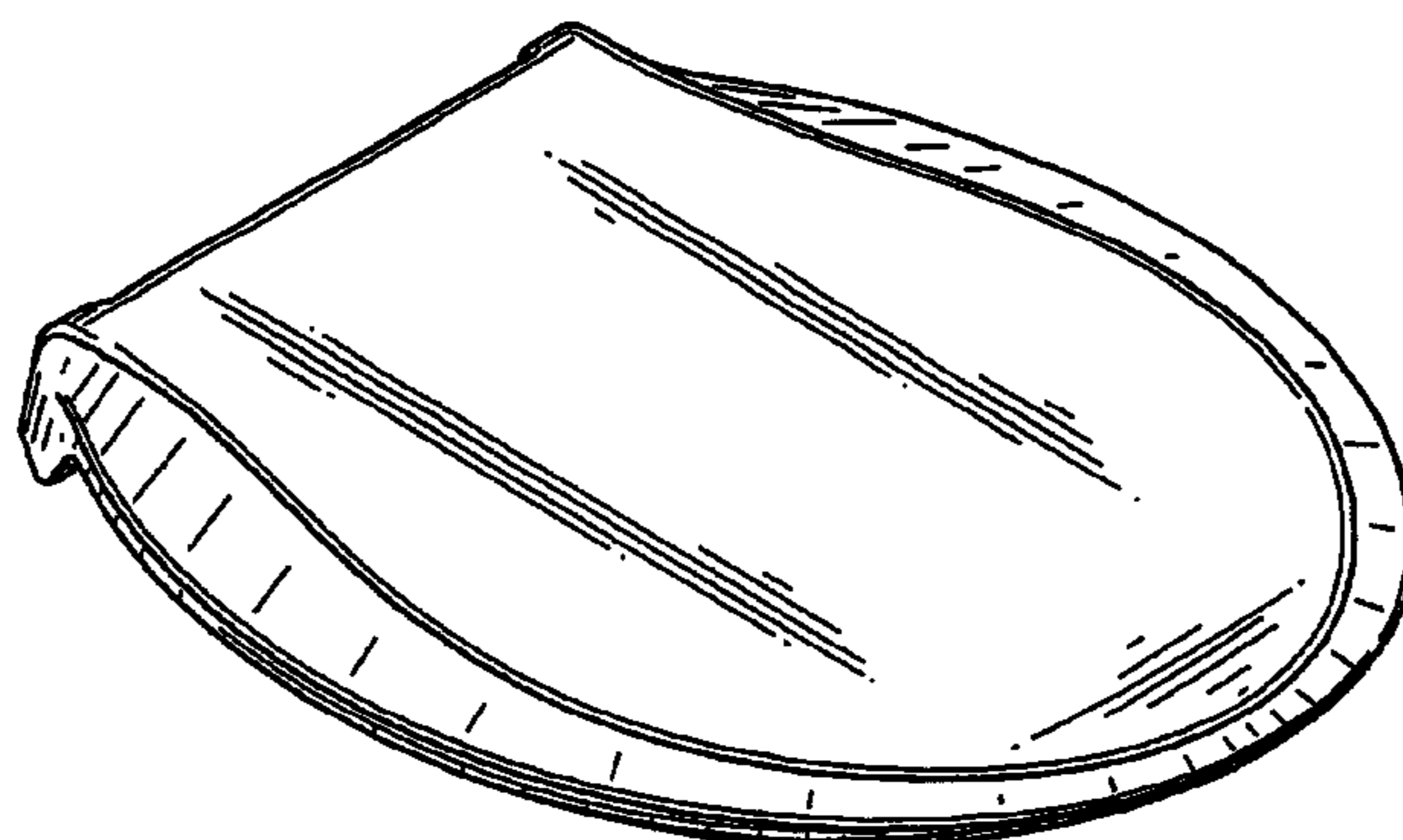

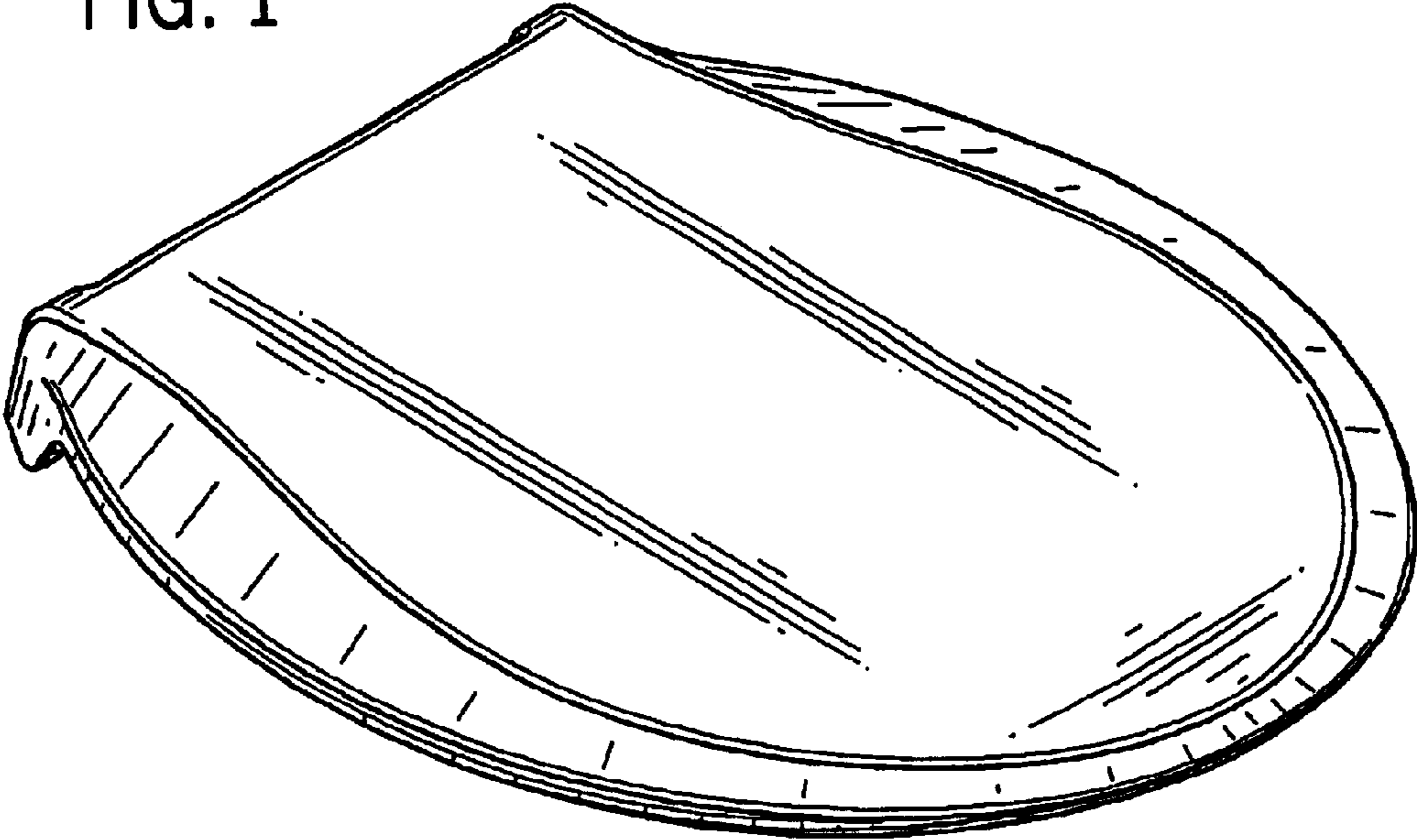

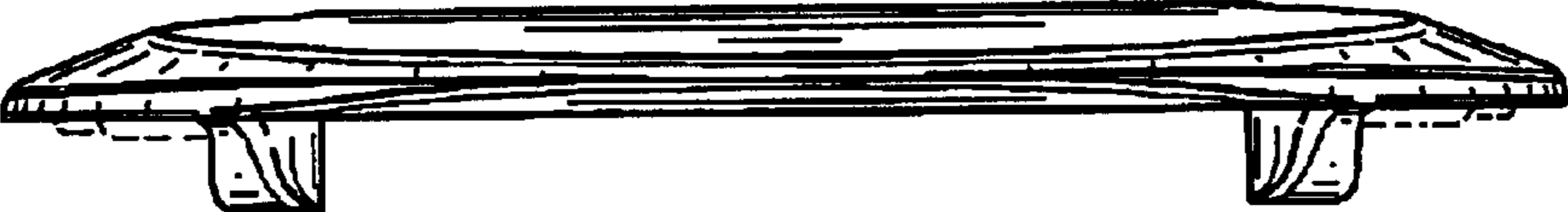

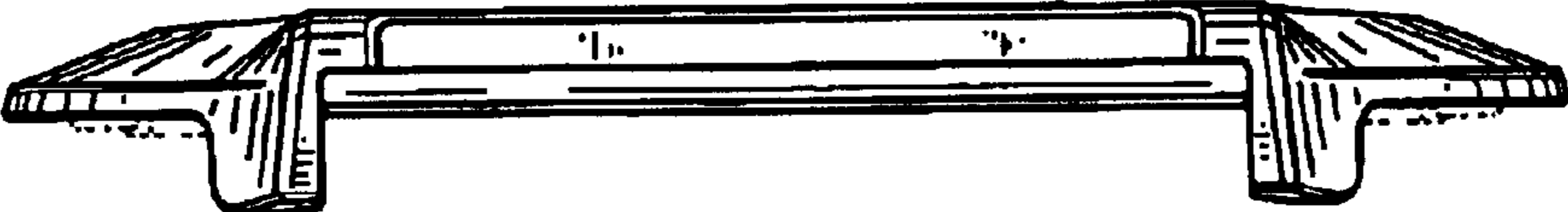

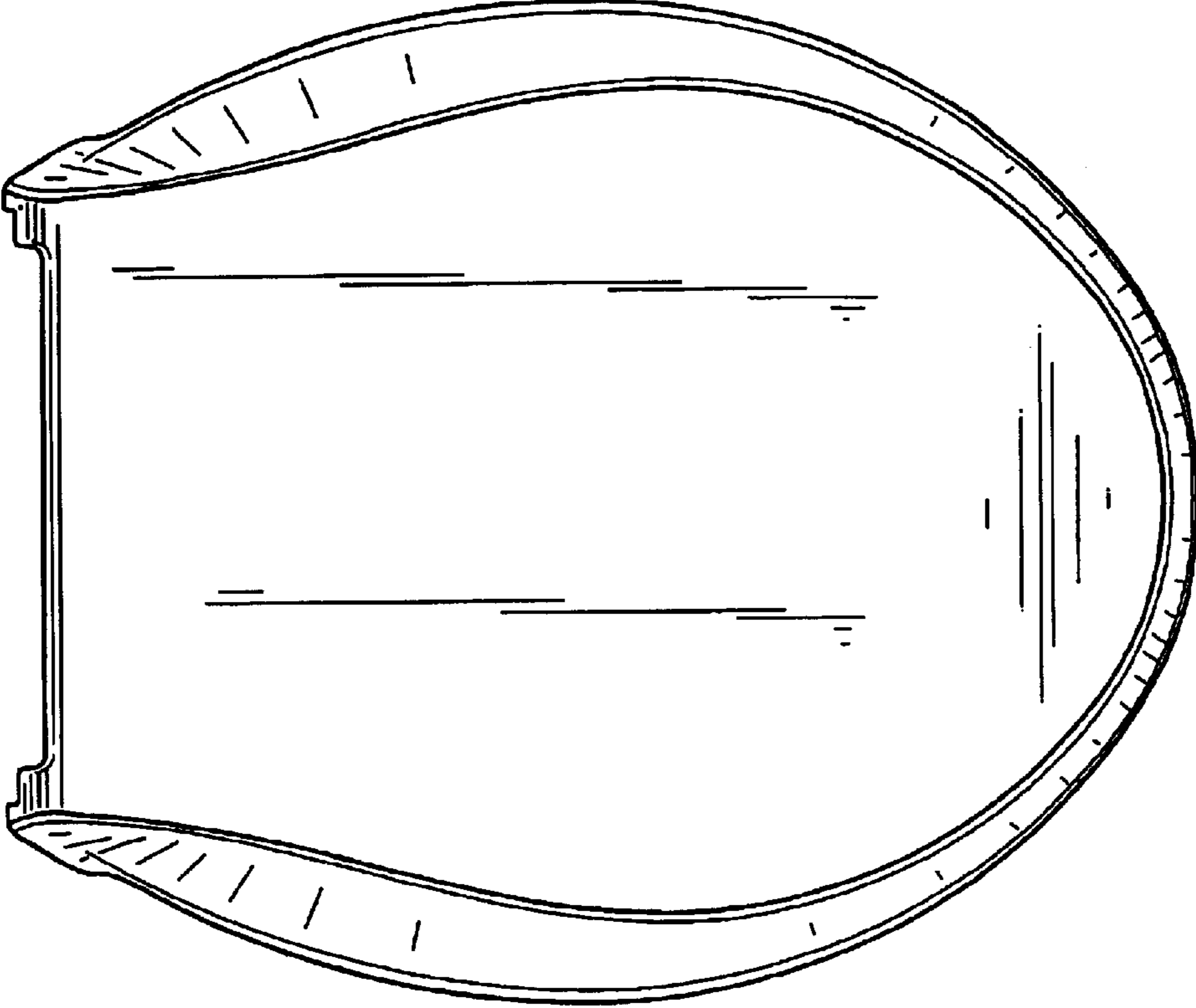

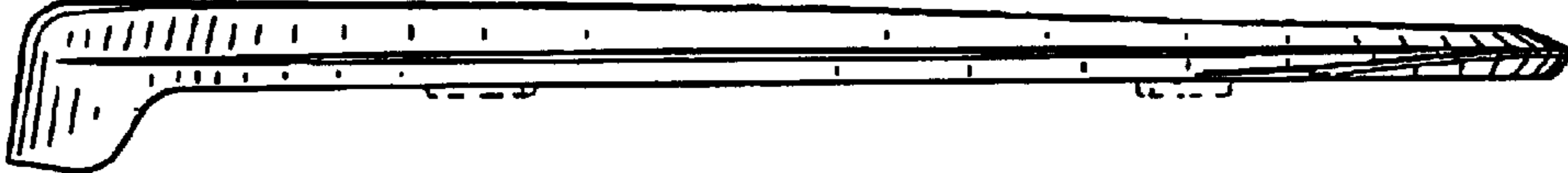

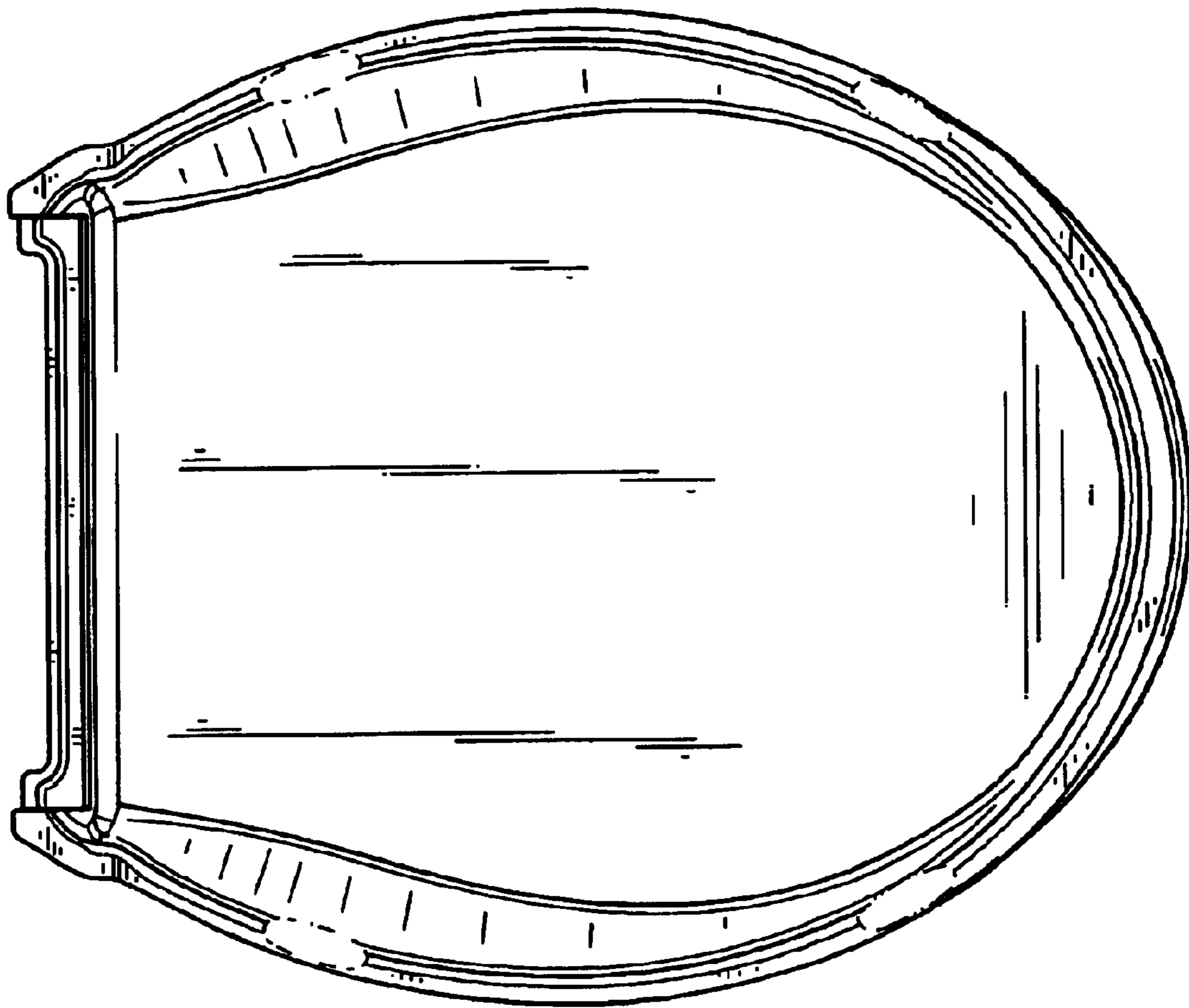

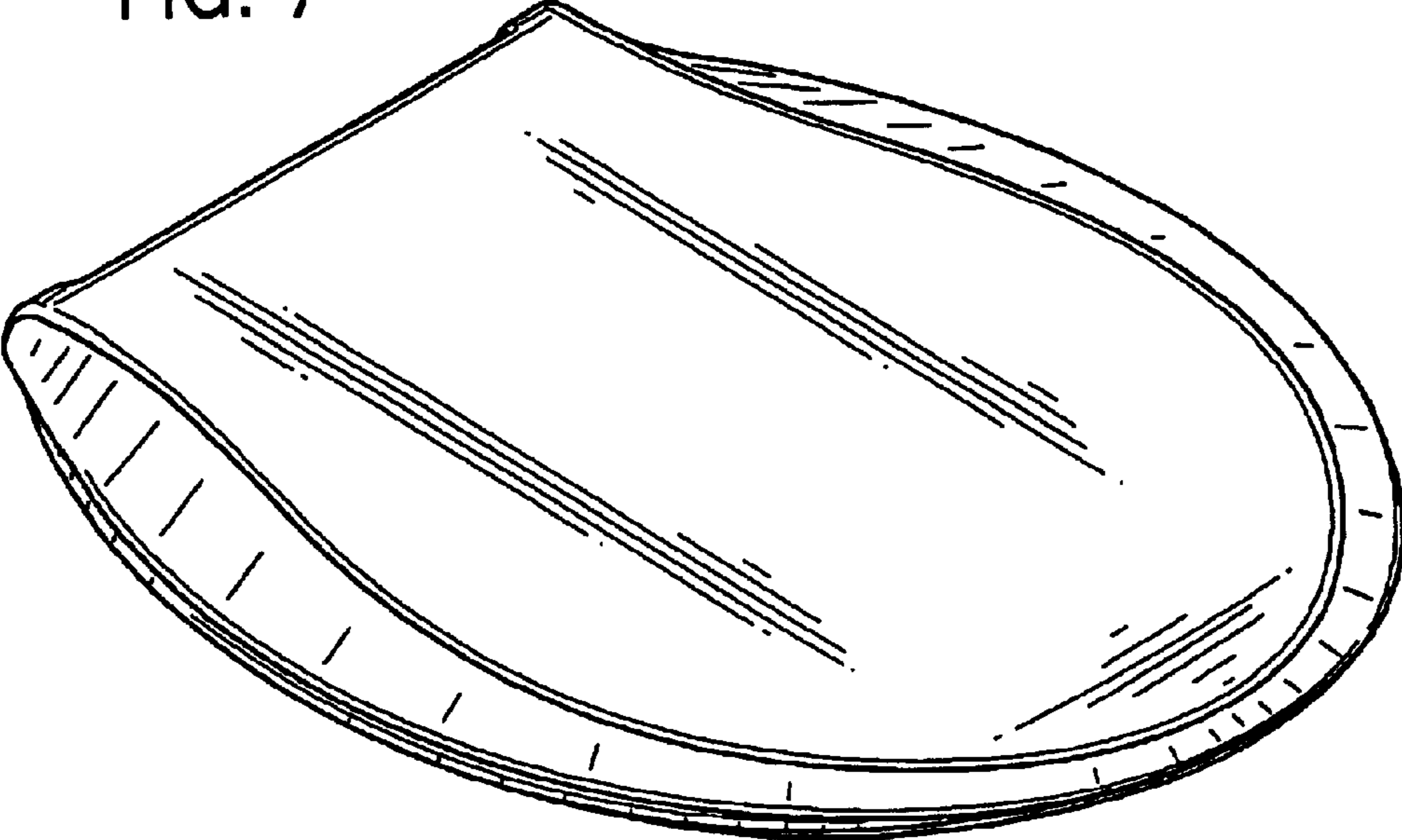

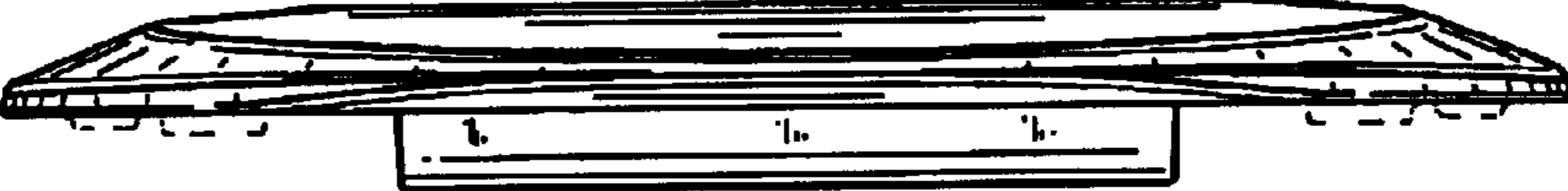

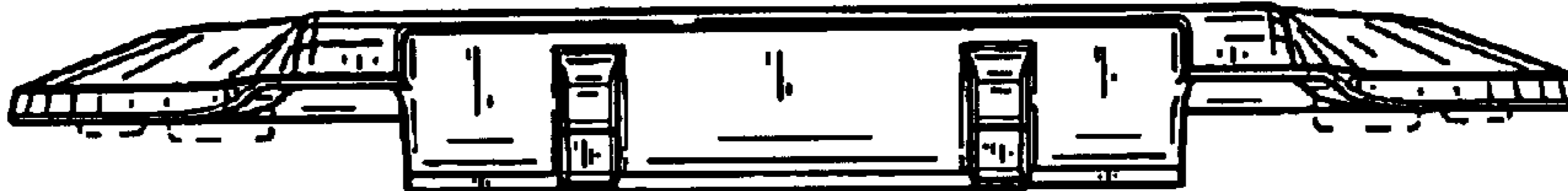

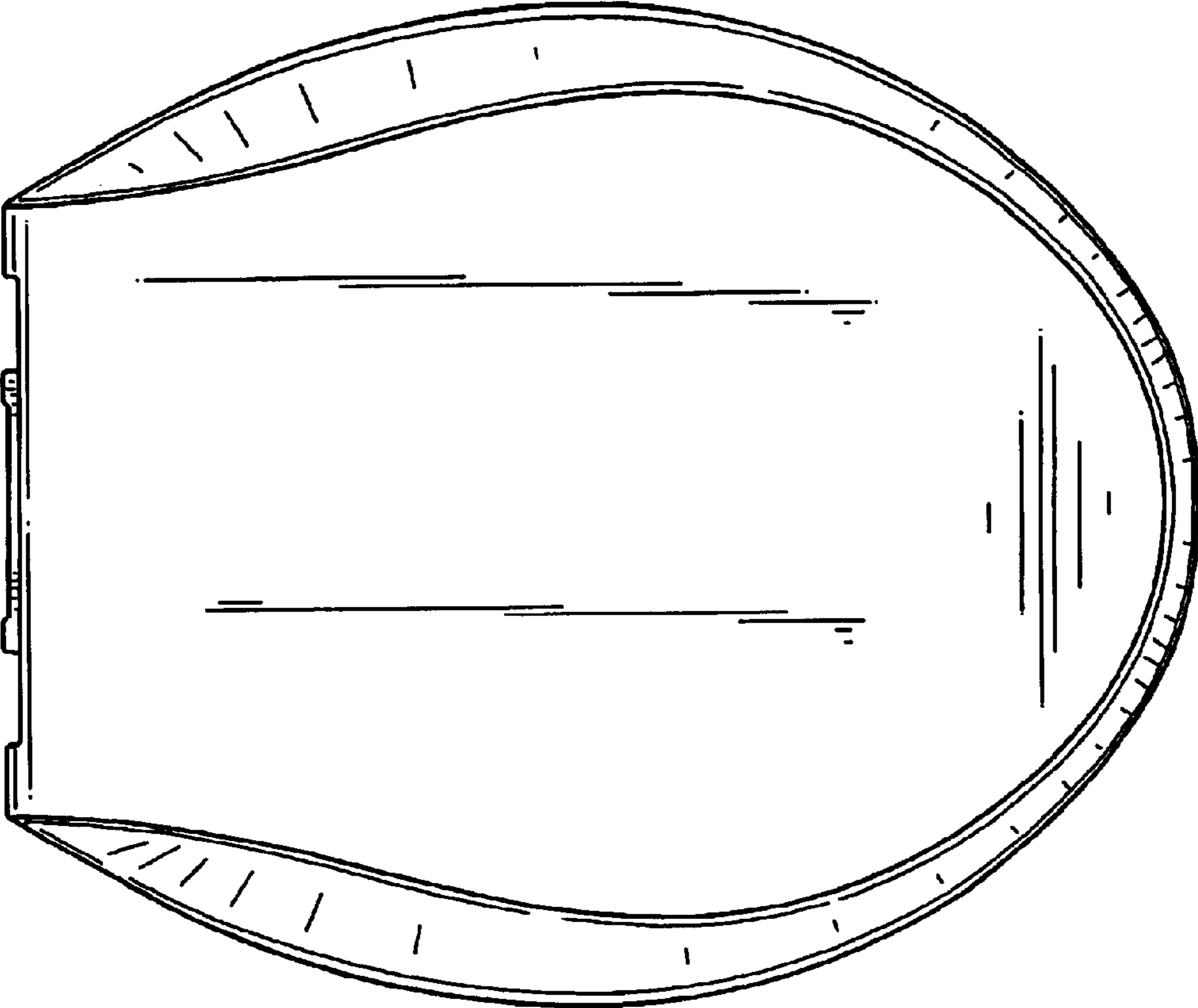

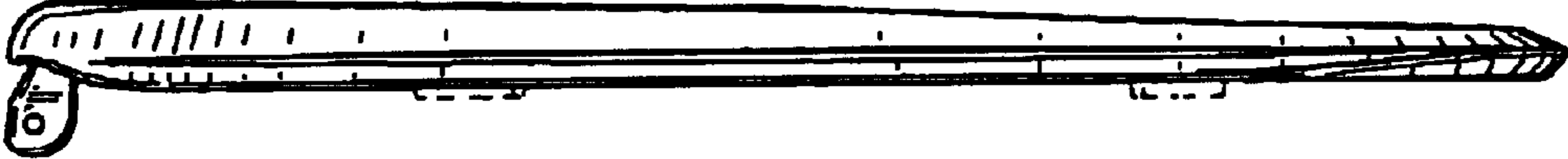

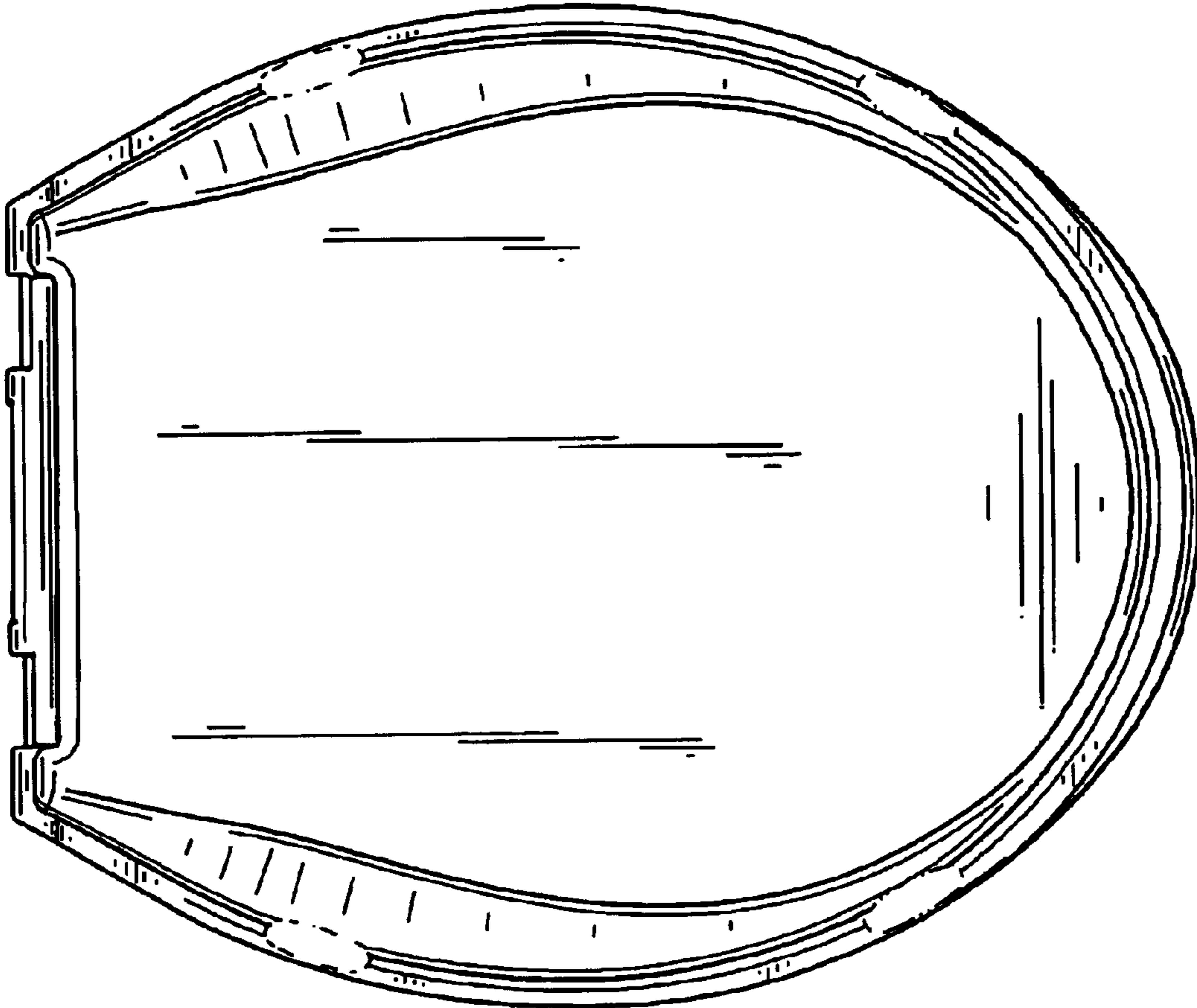

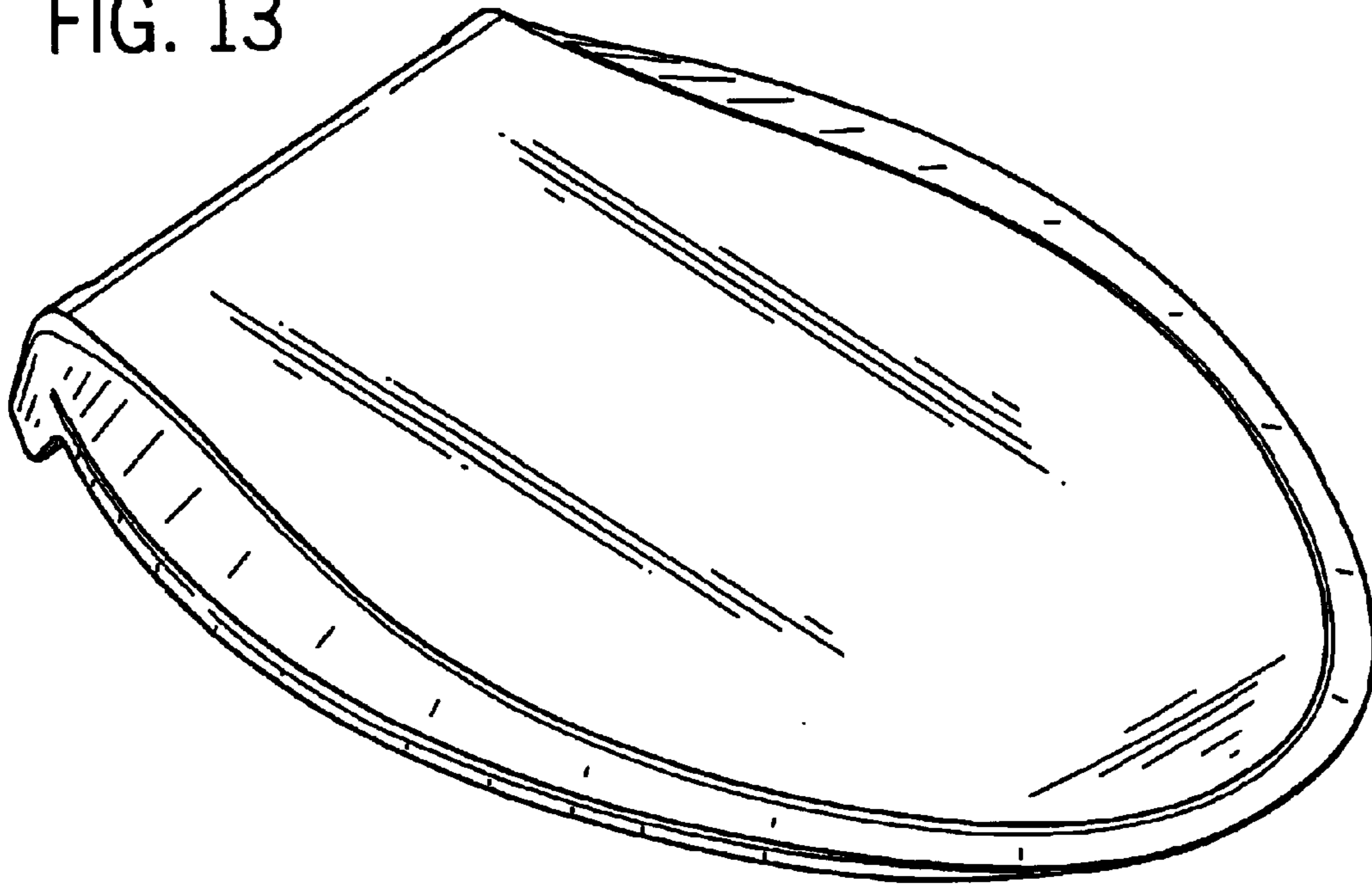

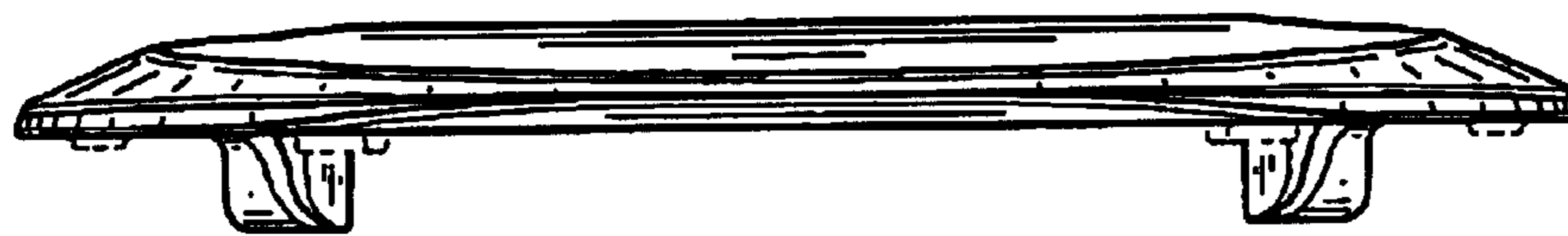

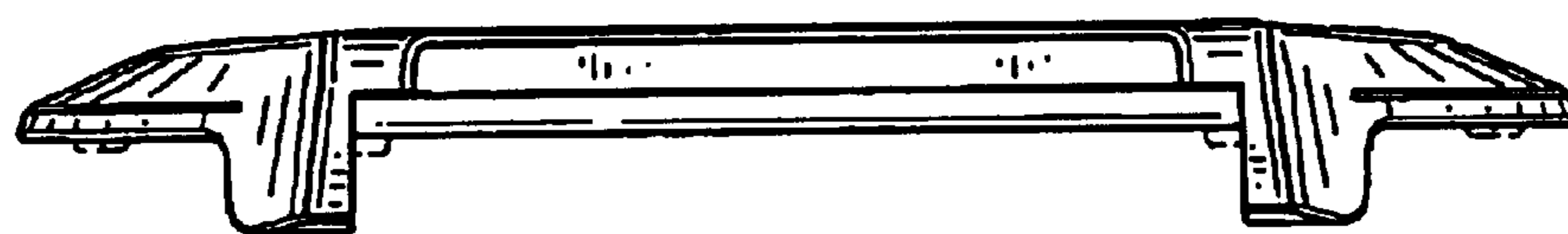

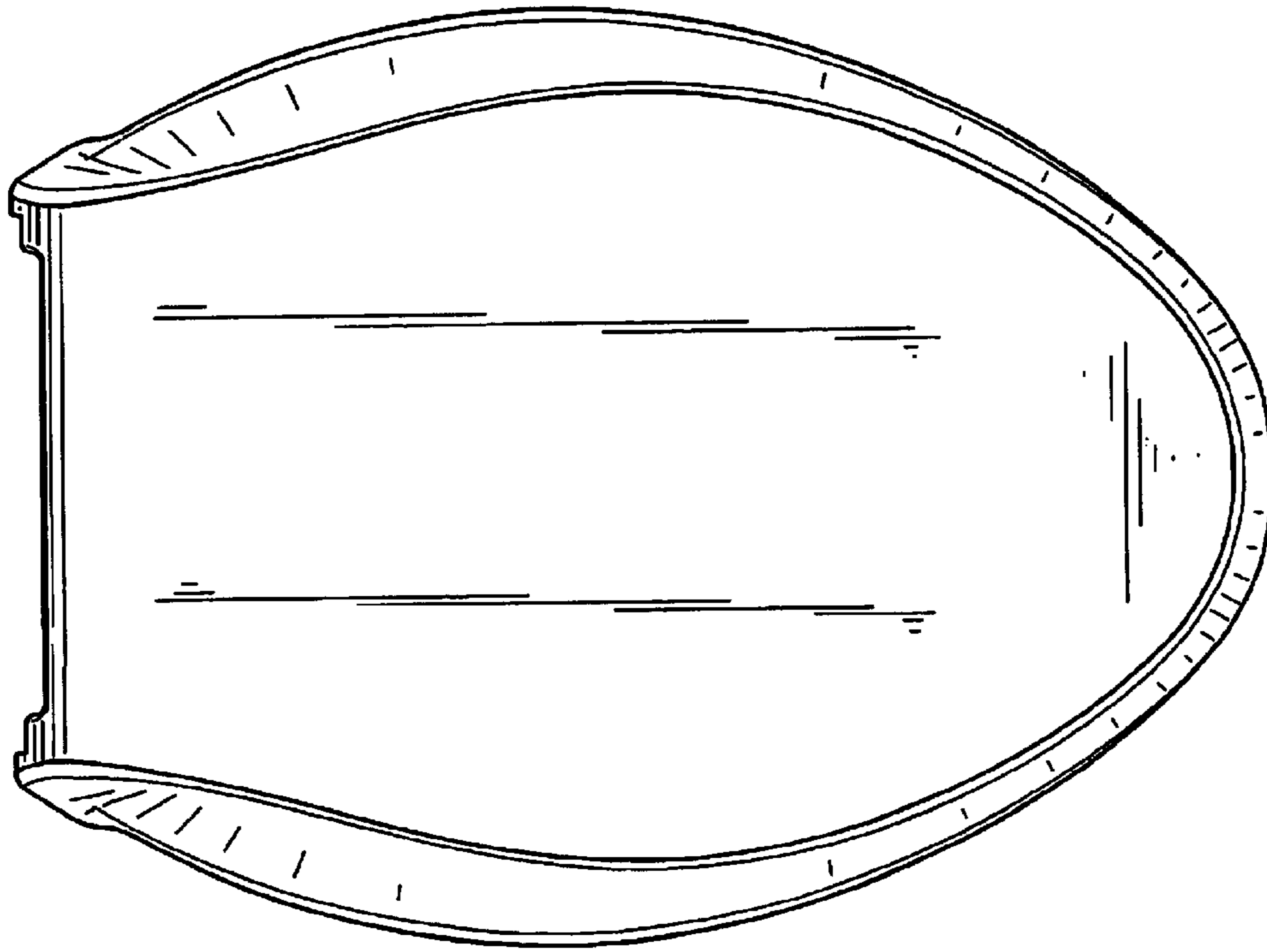

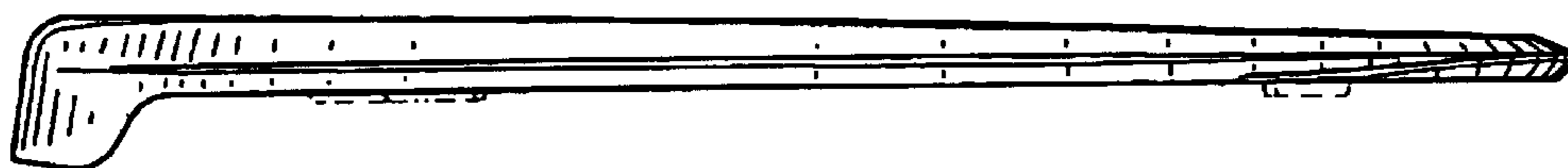

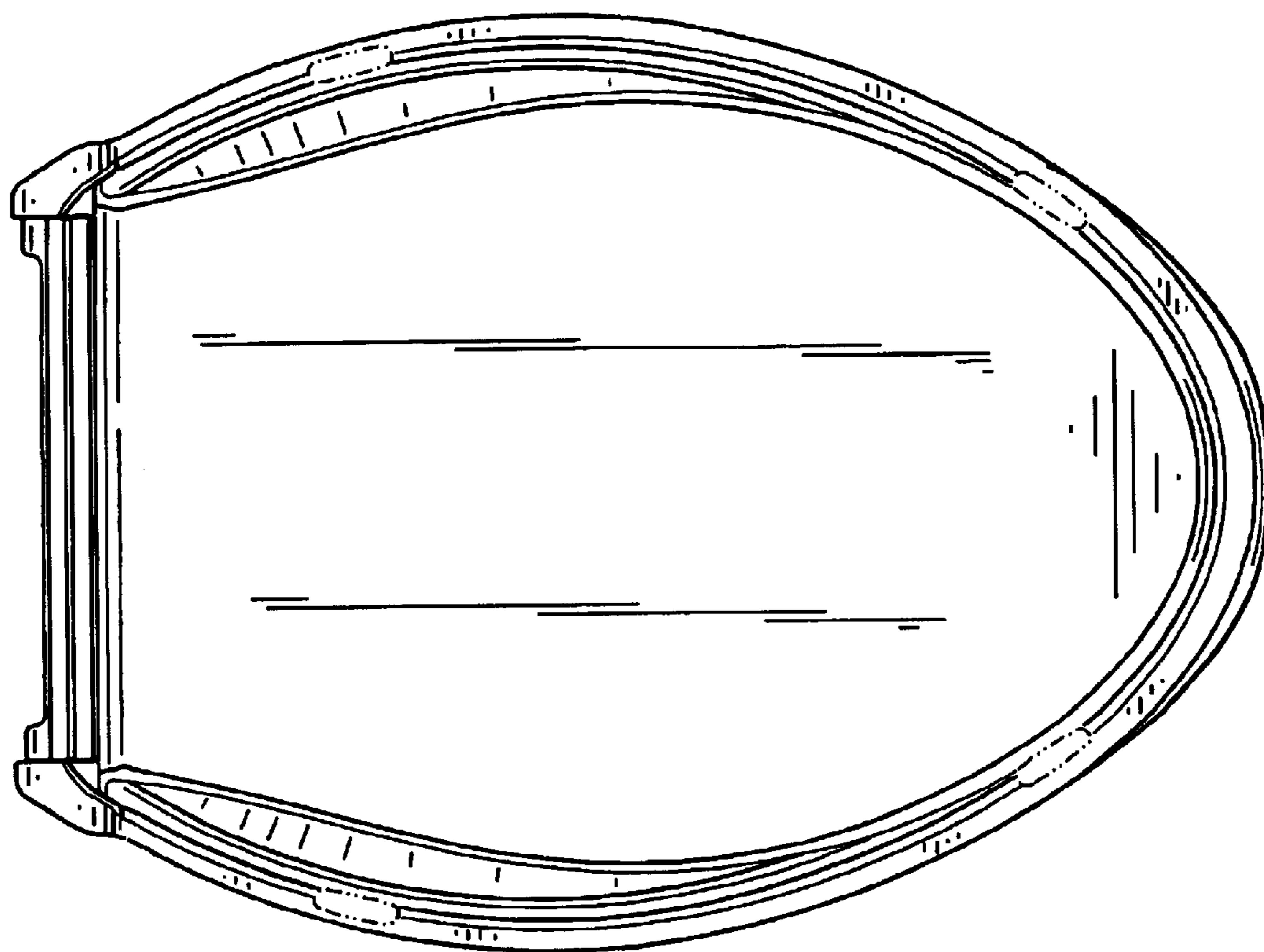

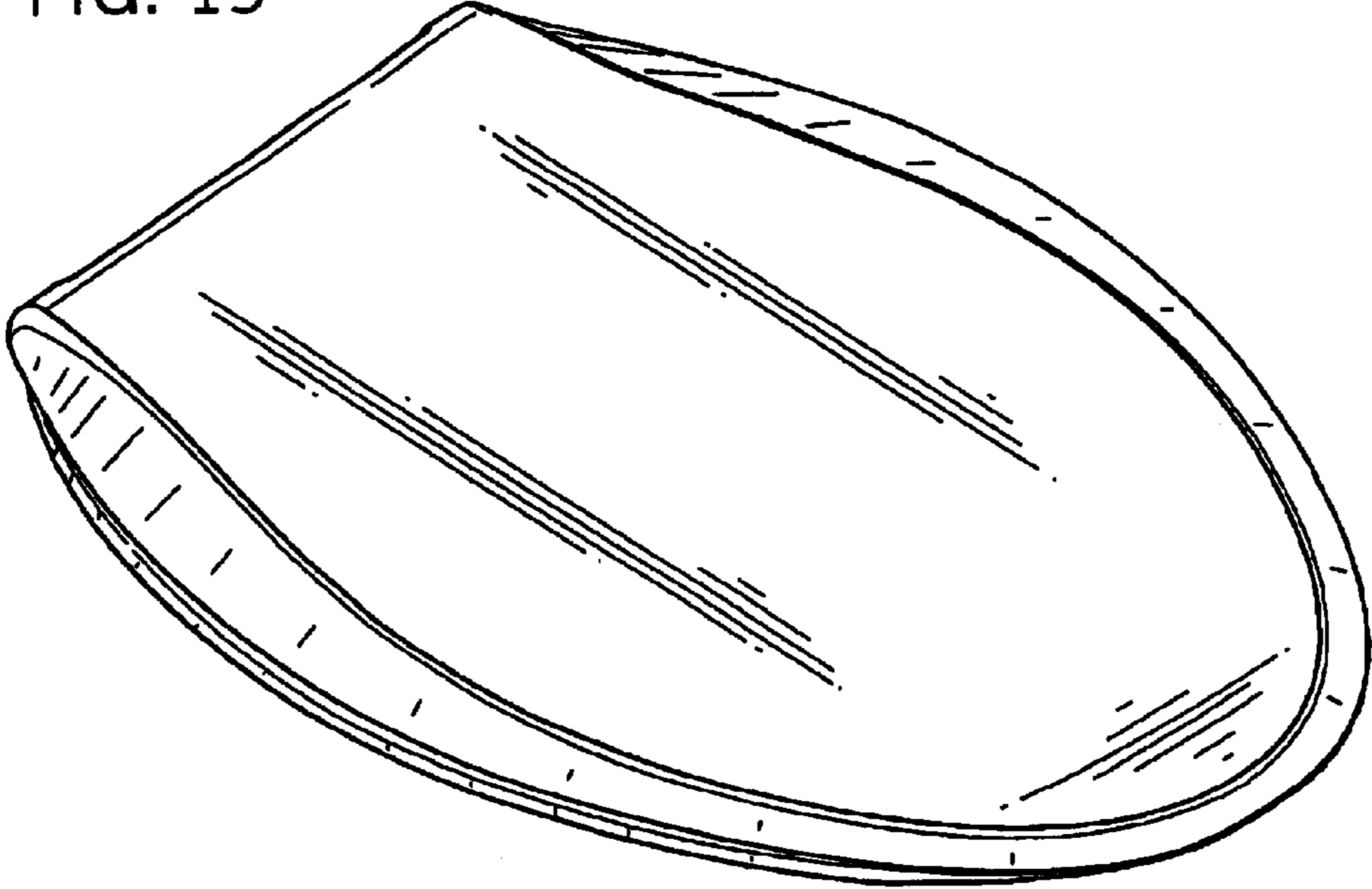

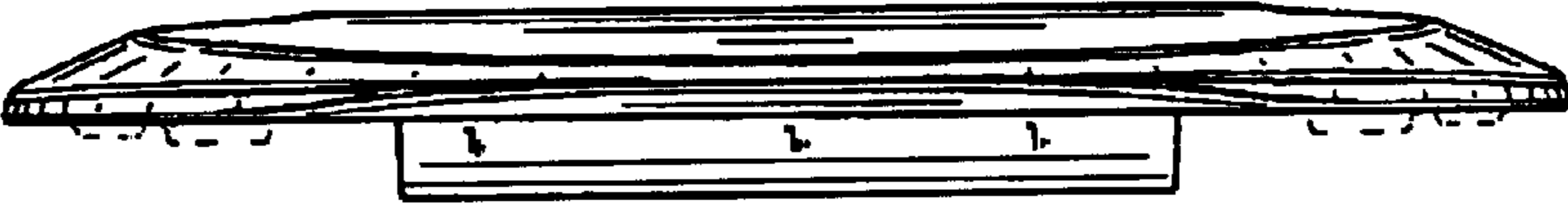

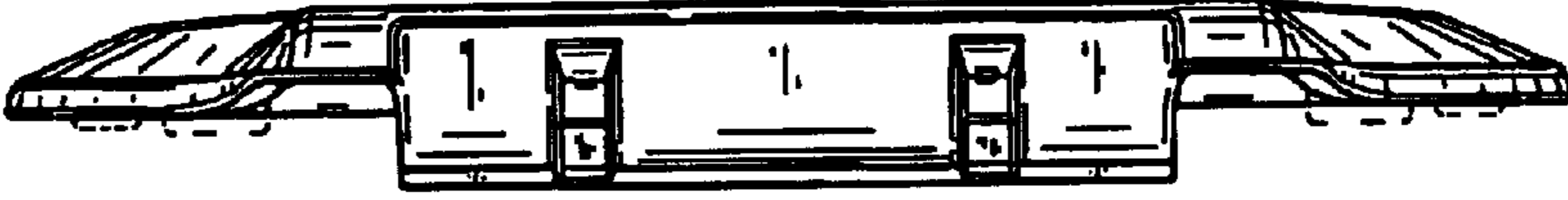

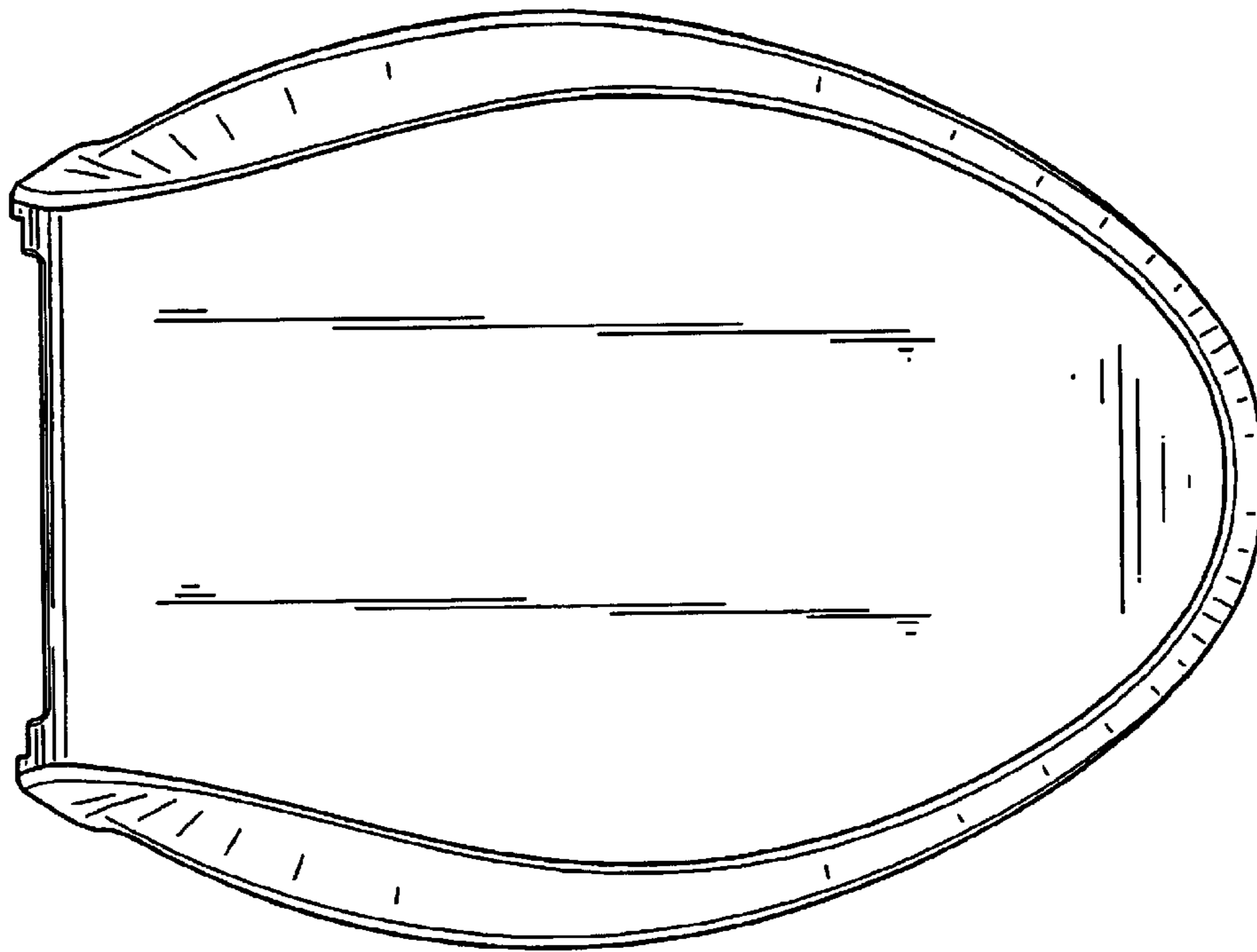

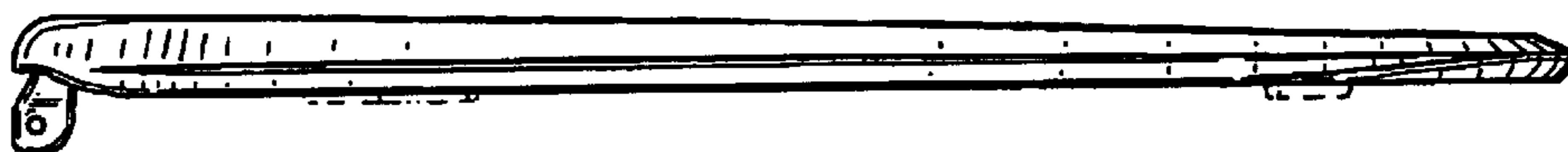
