**DESCRIPTION**

FIG. 3 is a back view of the ornamental vaporizer of FIG. 1;

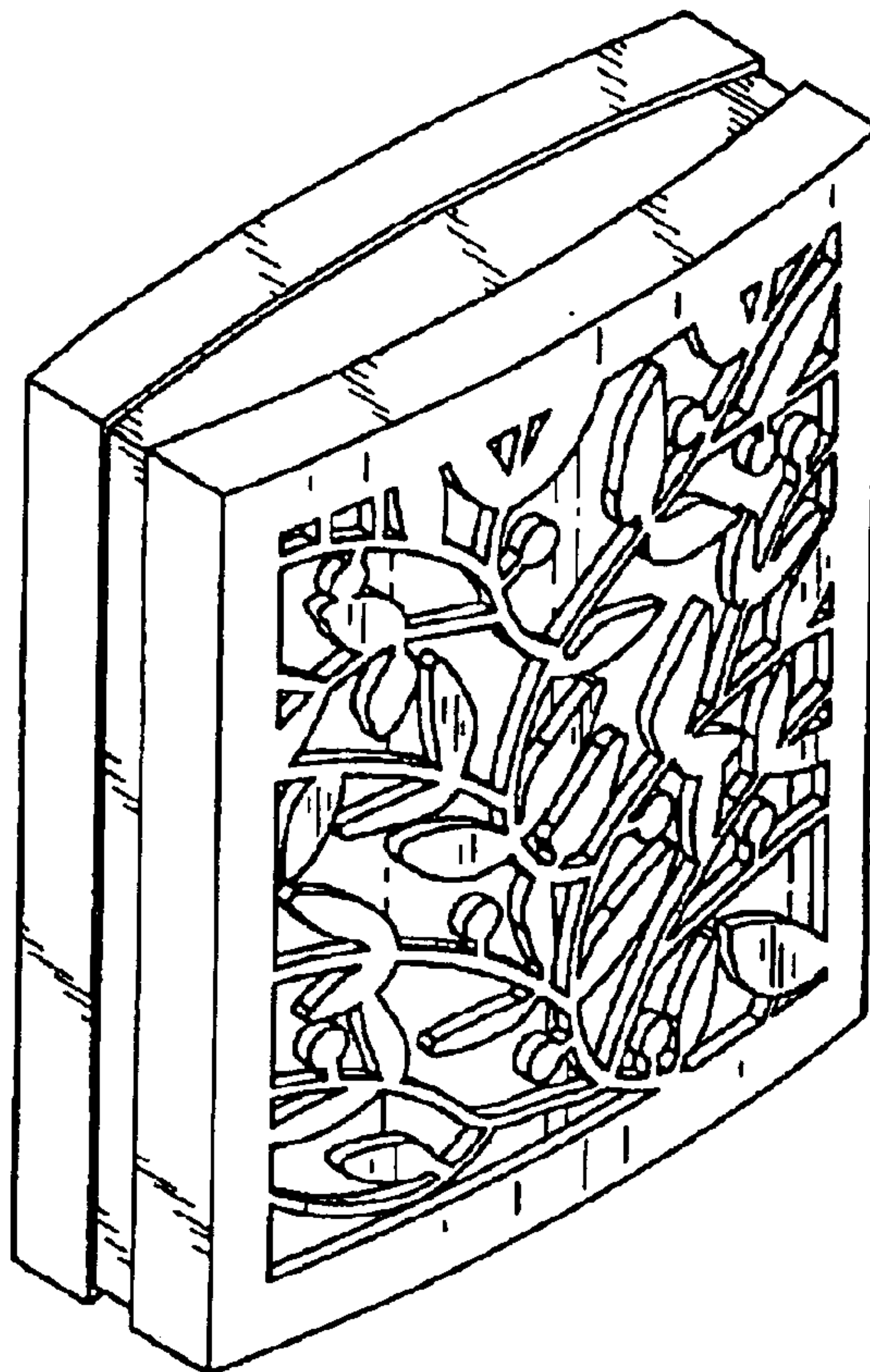
FIG. 4 is a right side view of the ornamental vaporizer of FIG. 1;

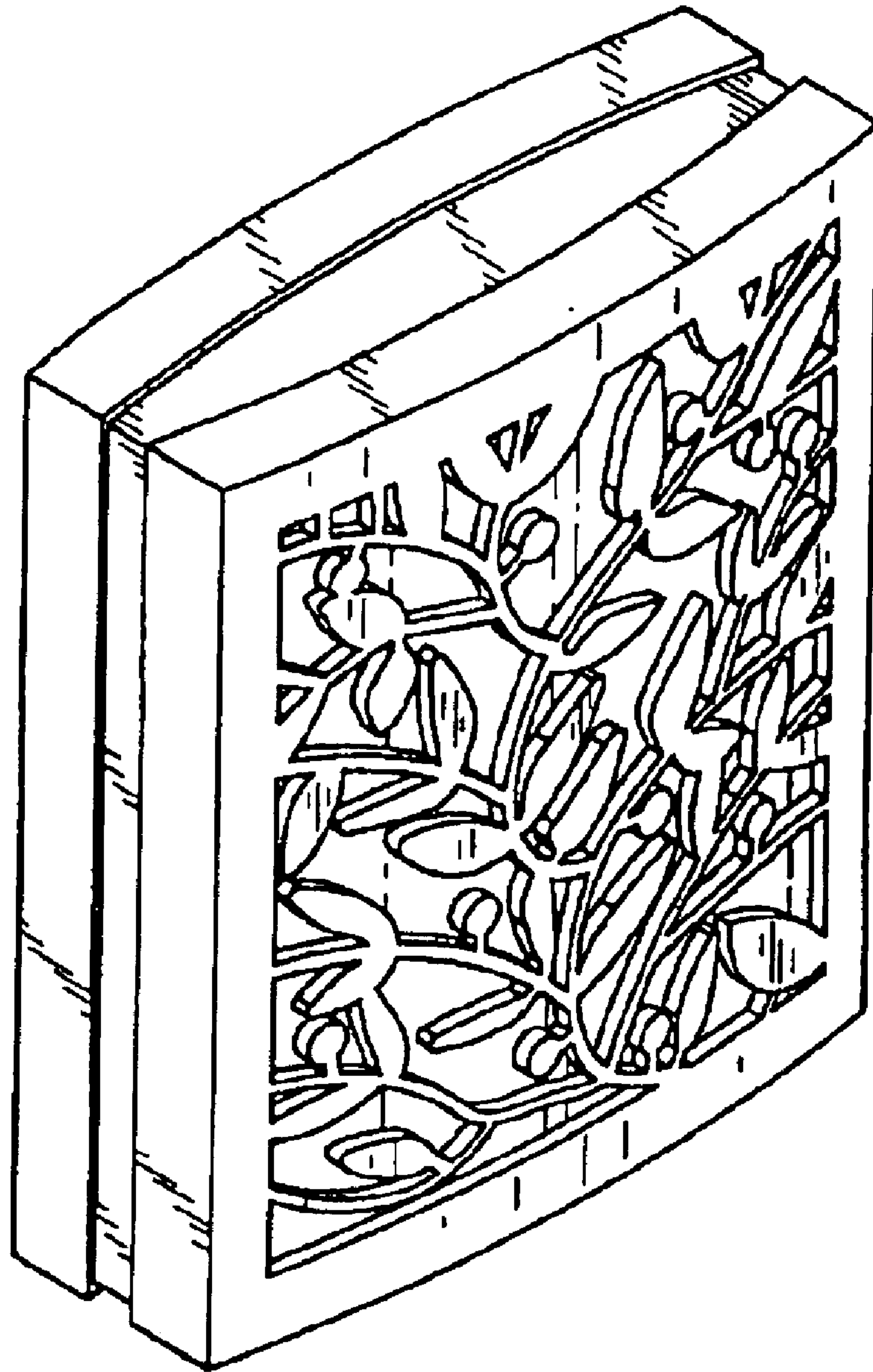

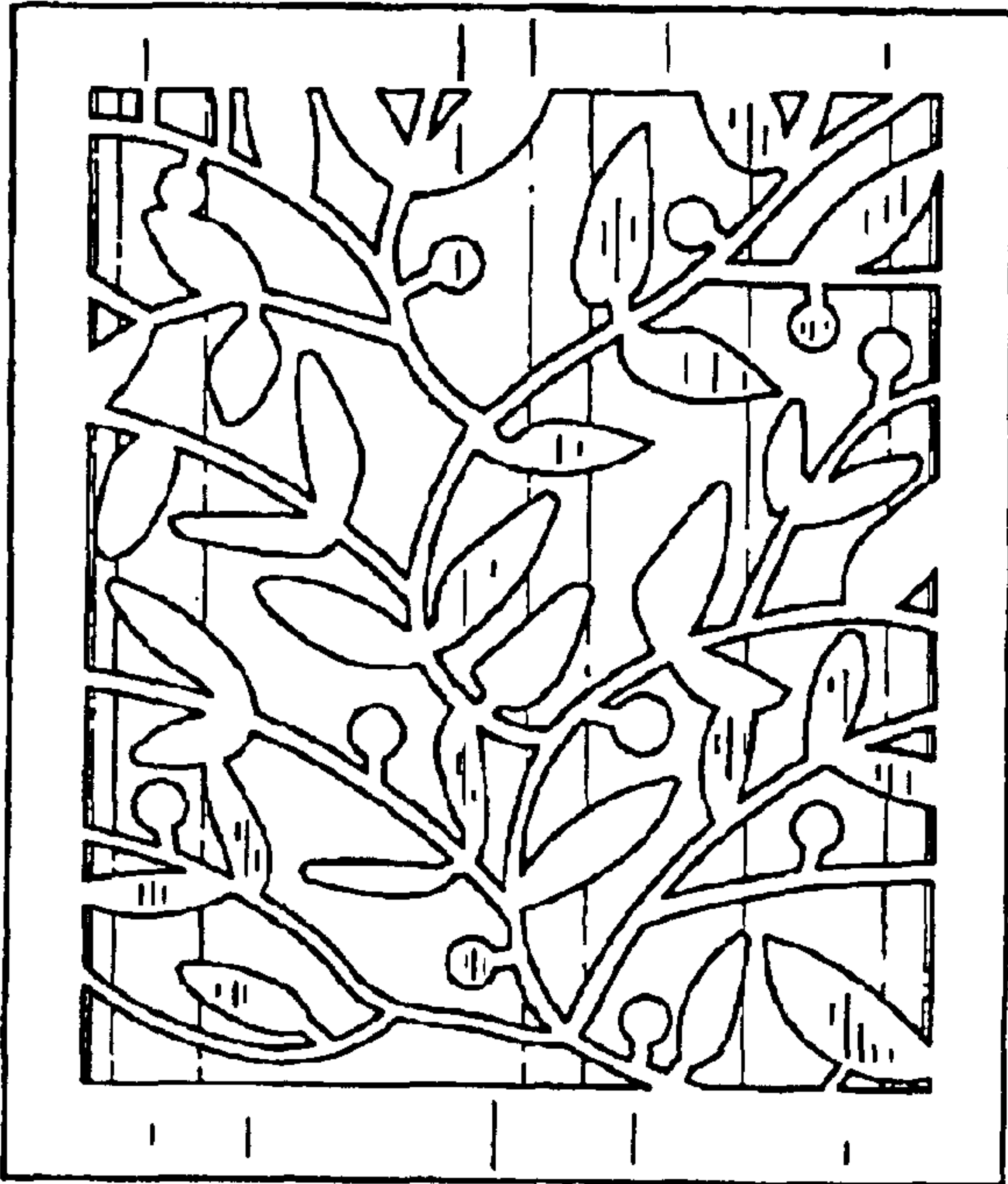

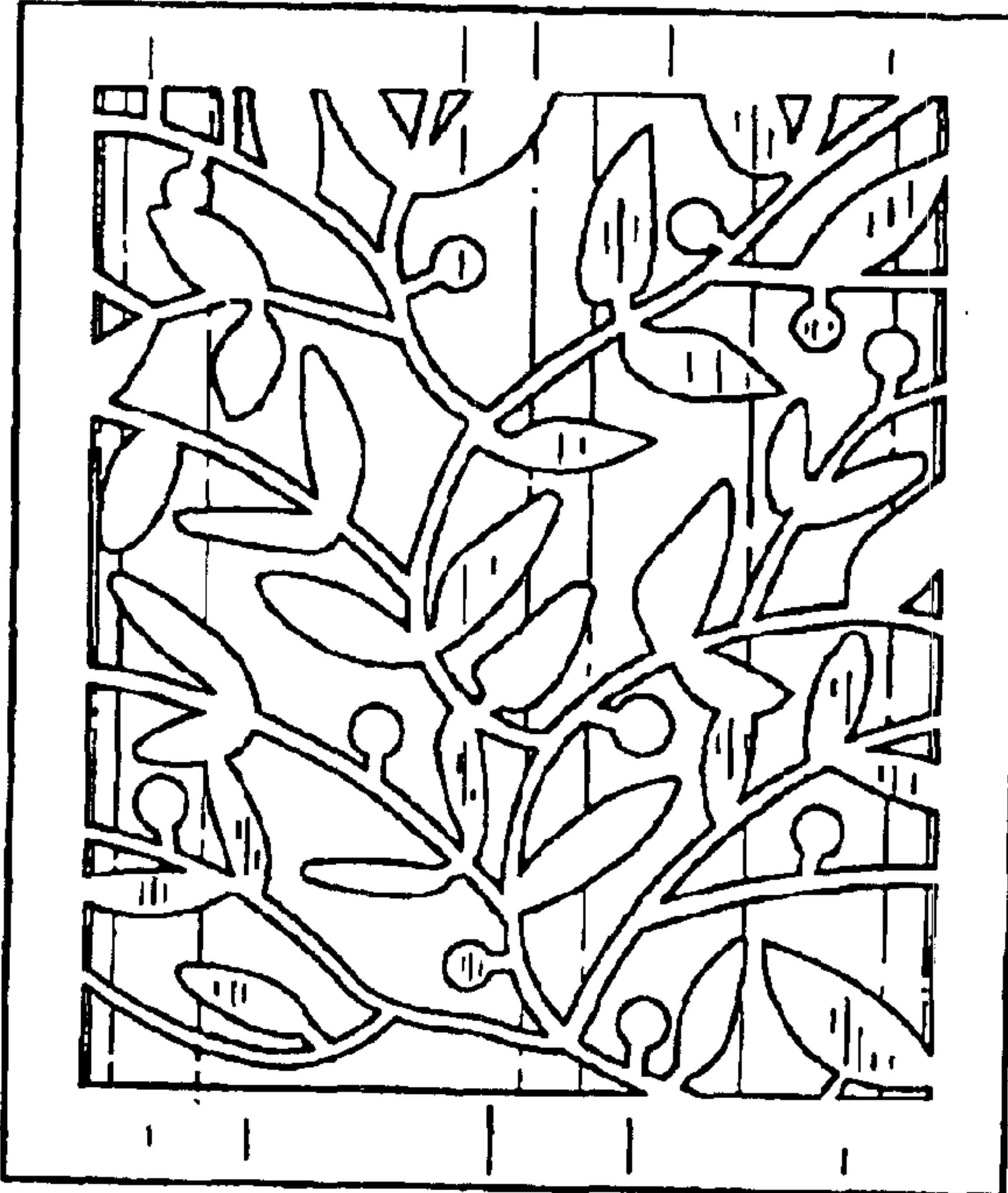

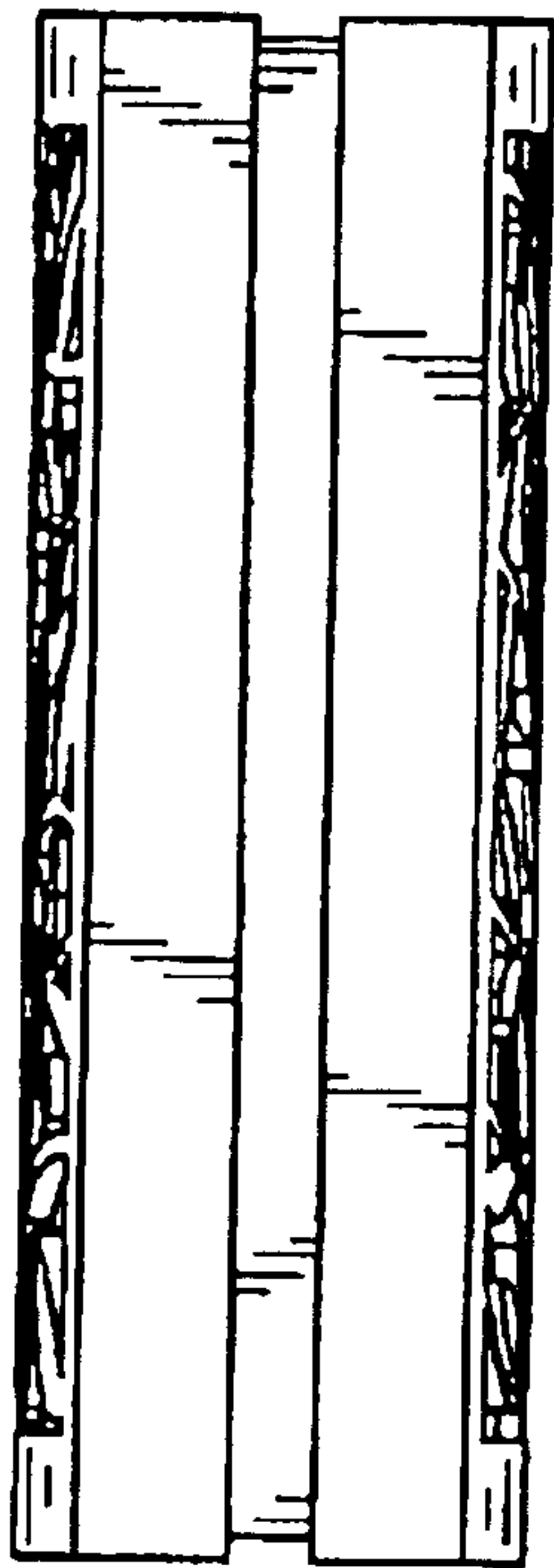

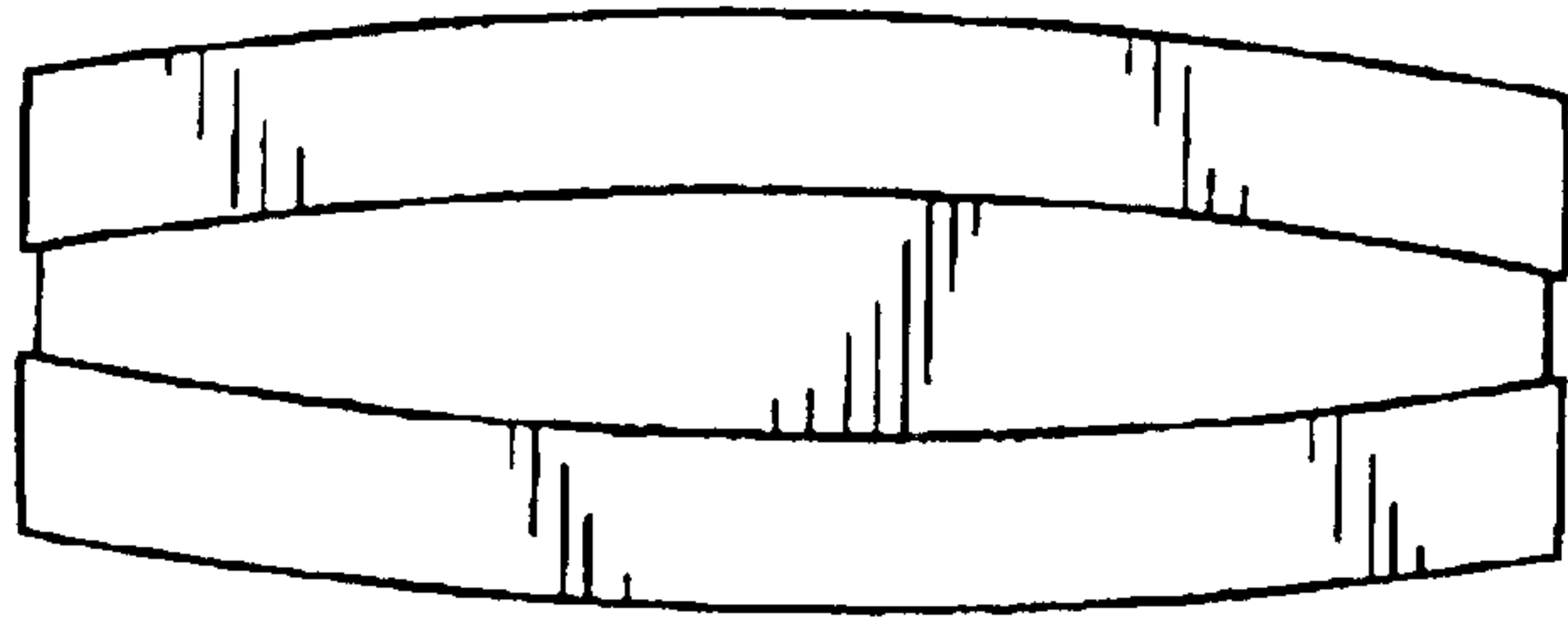

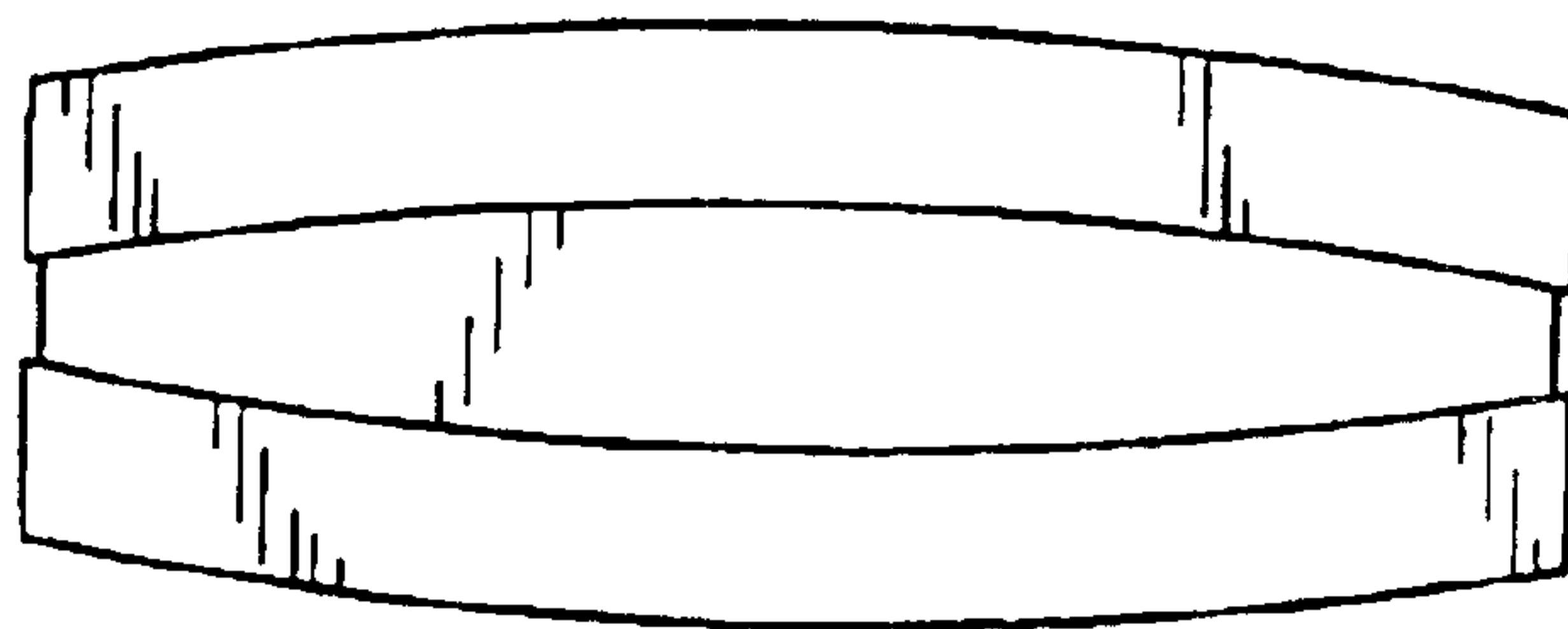
