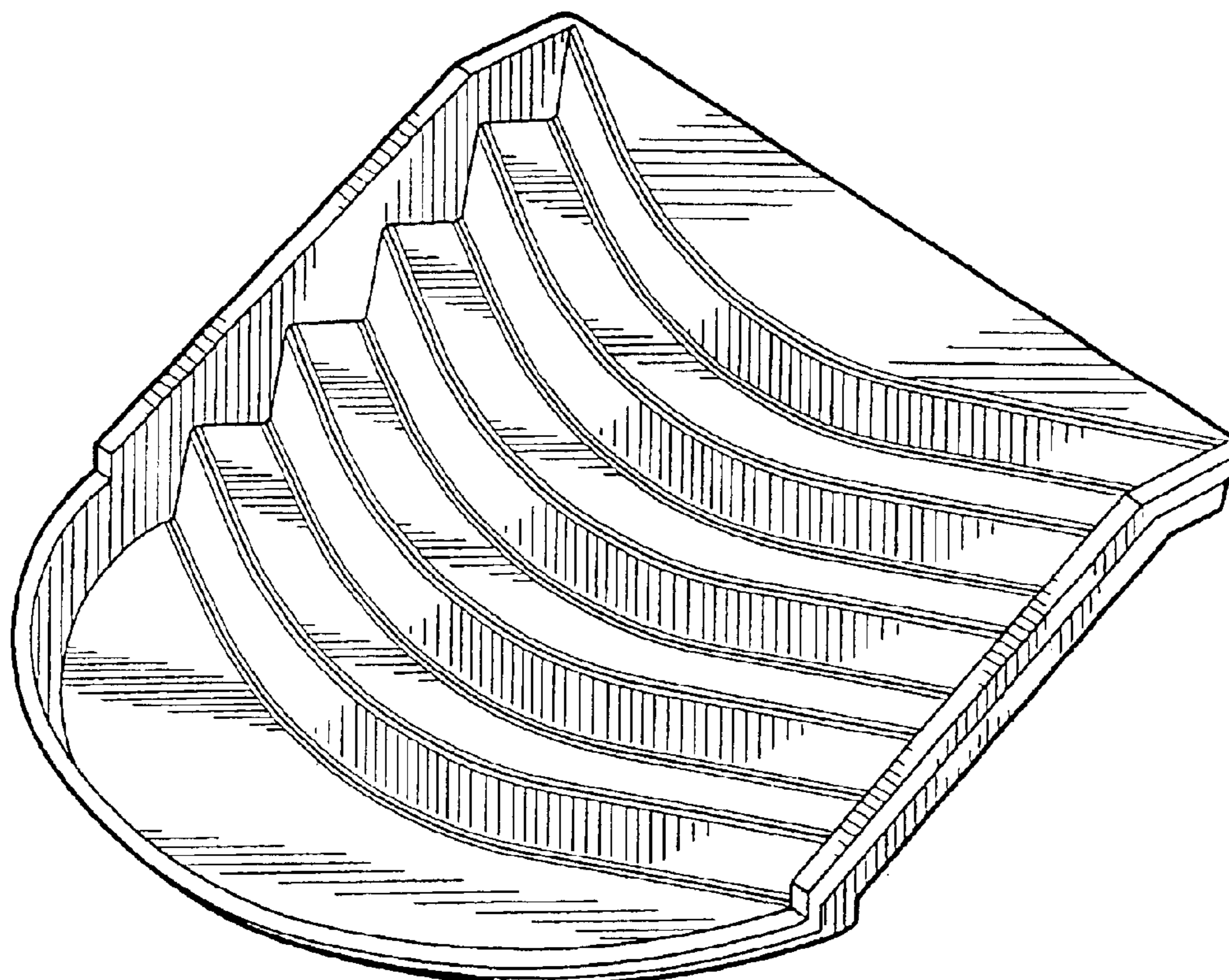

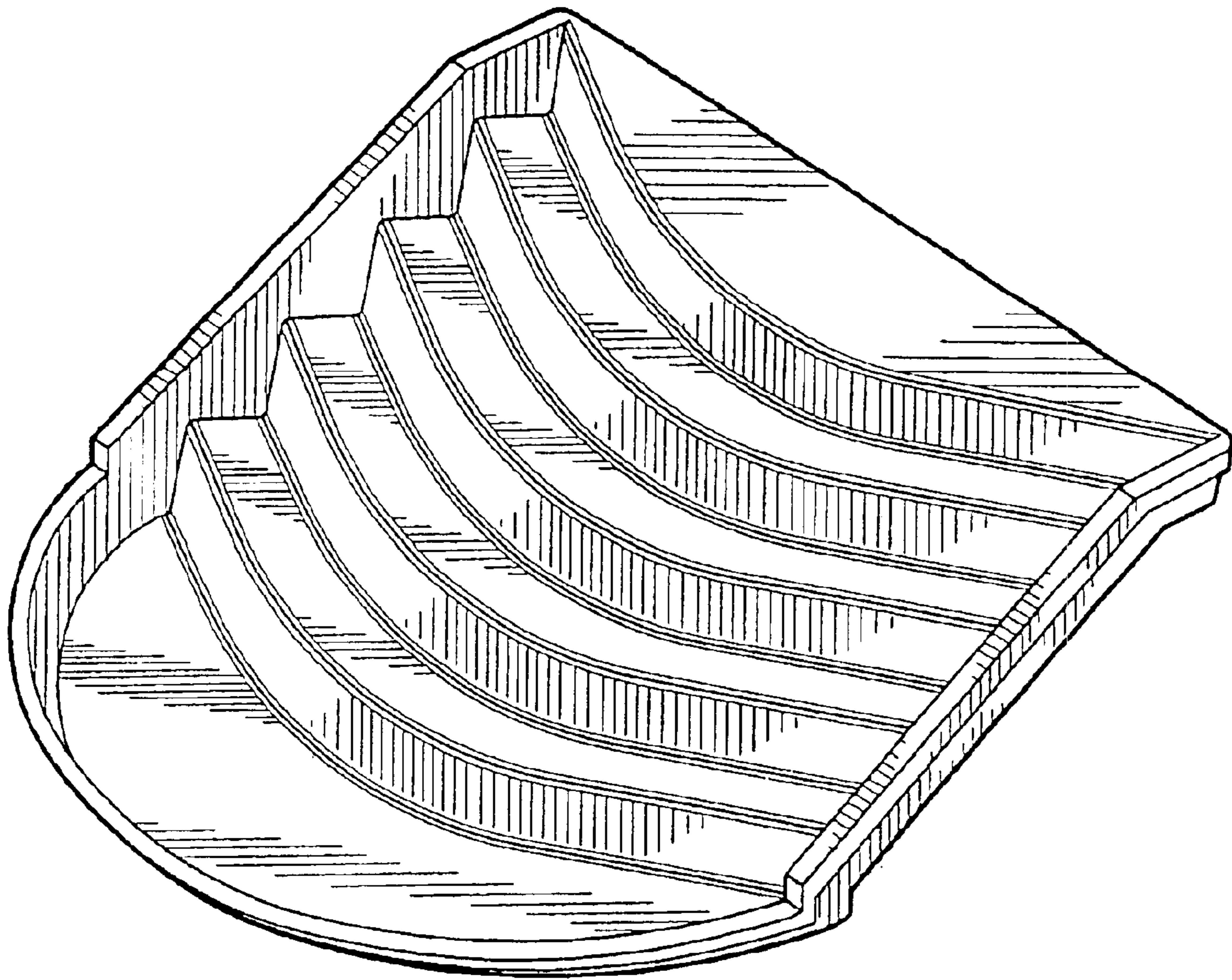
The ornamental design for a goods display stand, as shown

**DESCRIPTION**

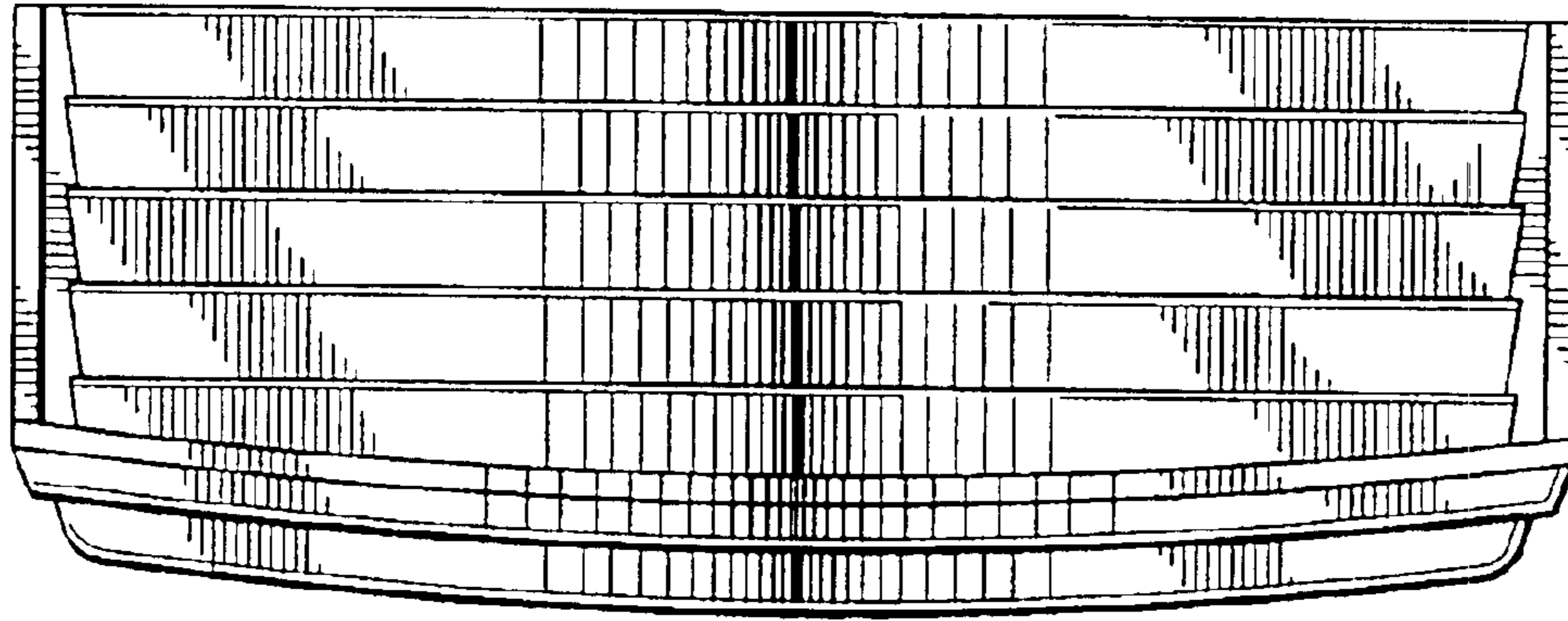
FIG. 1 is a top and right front perspective view of a goods display stand, showing my design;

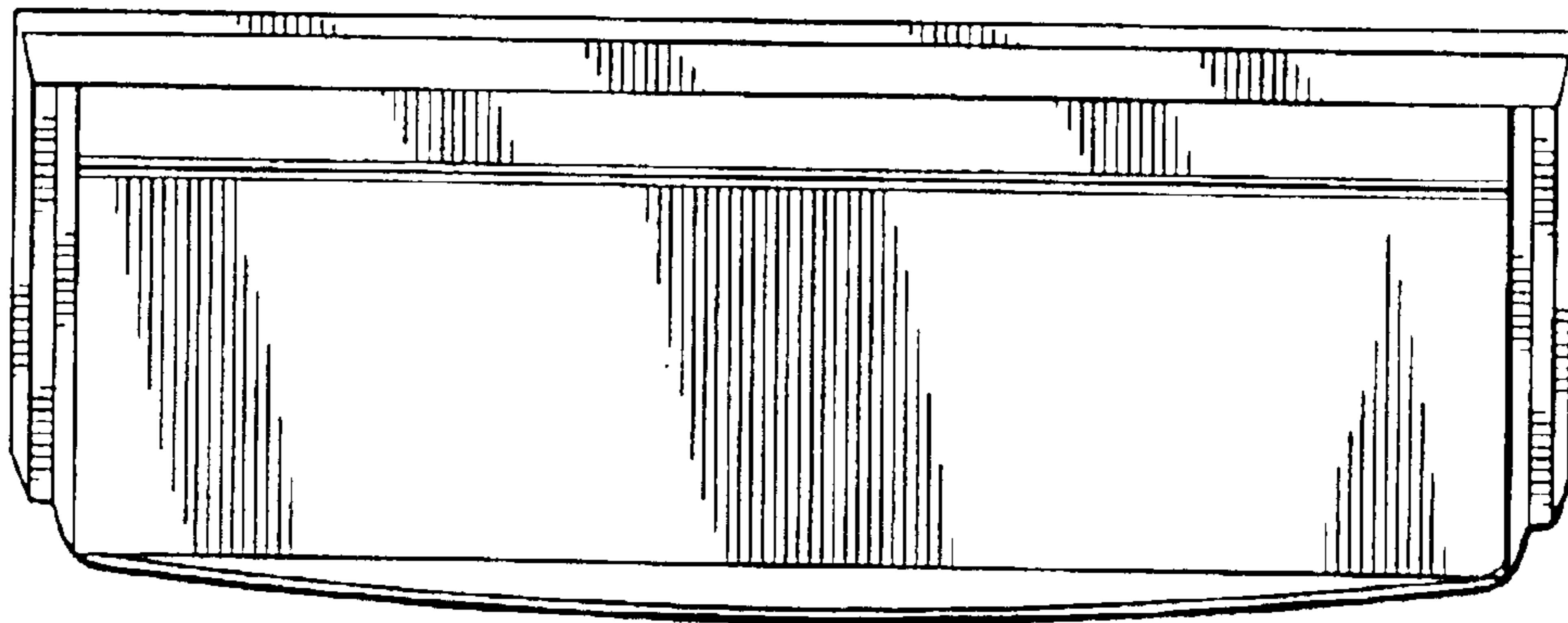




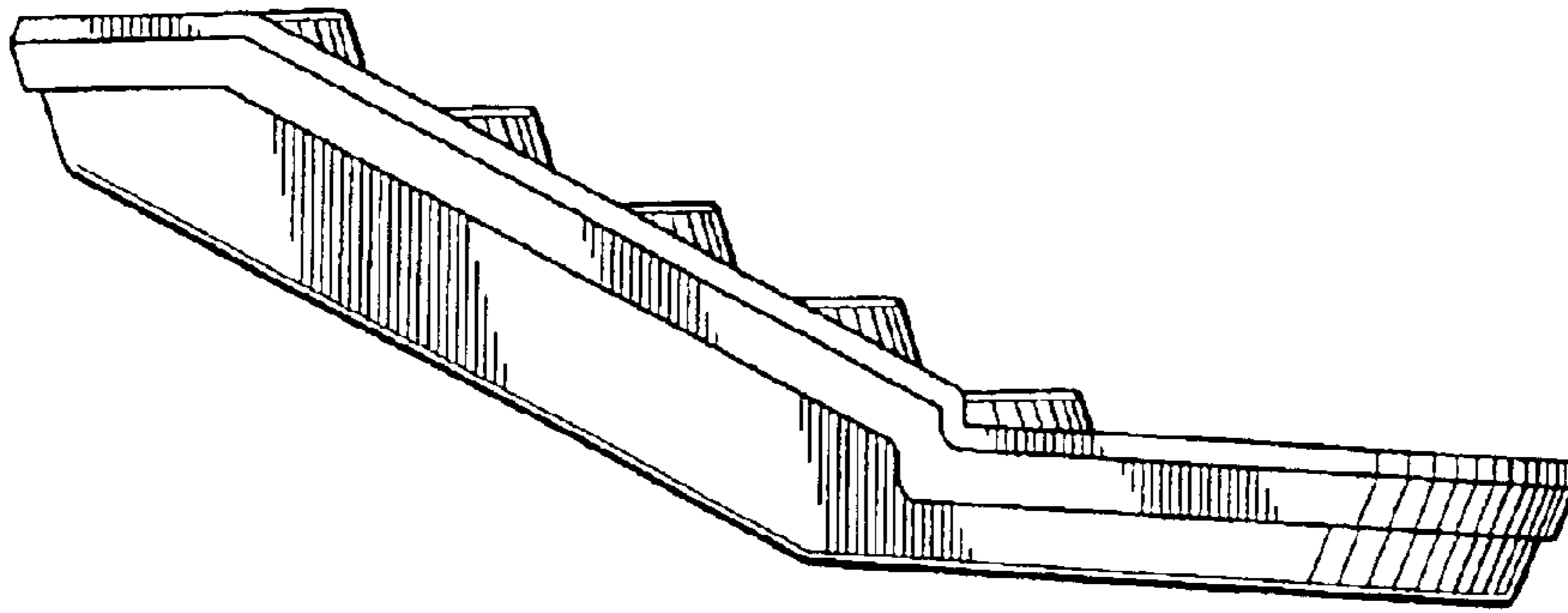

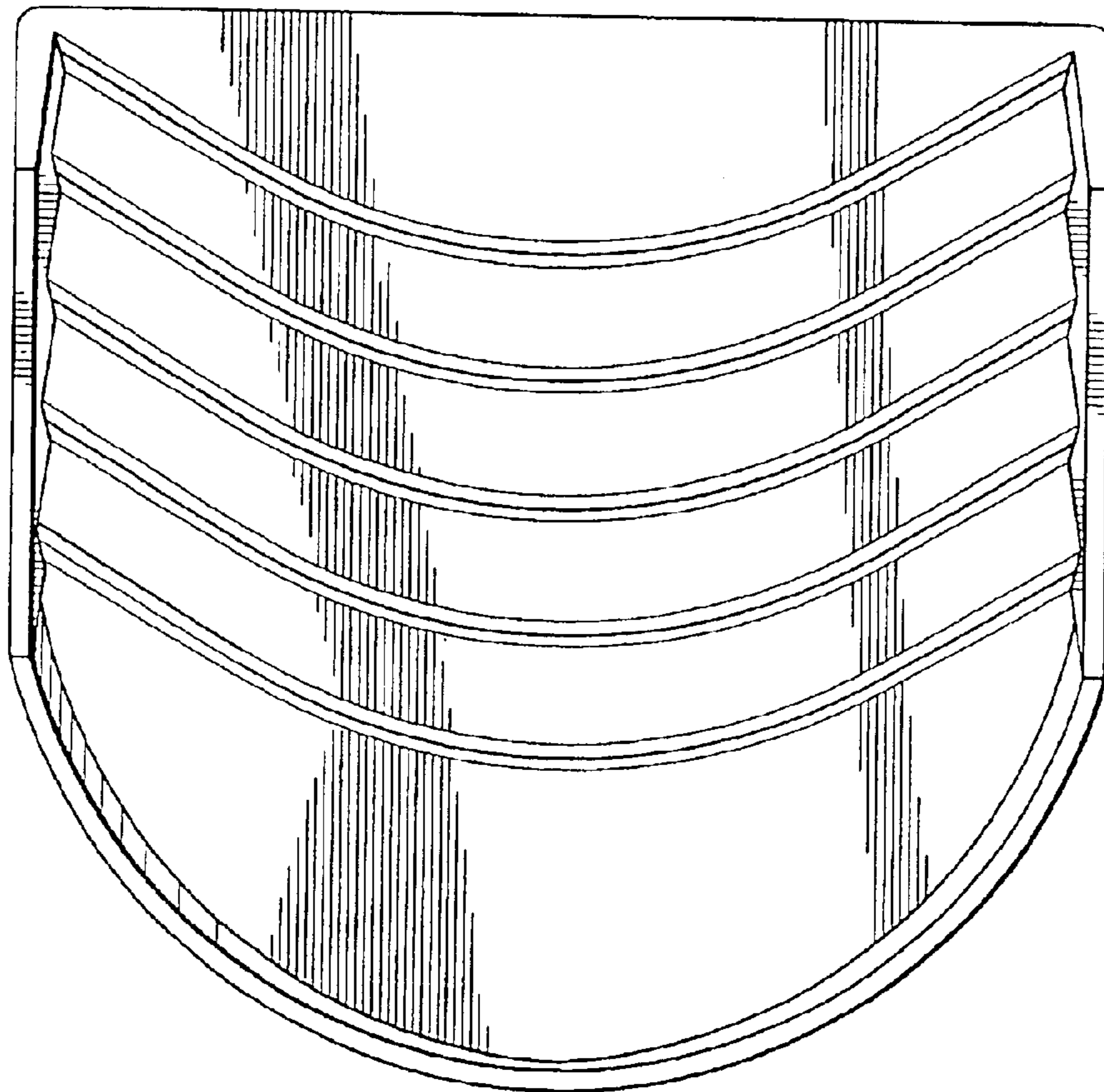

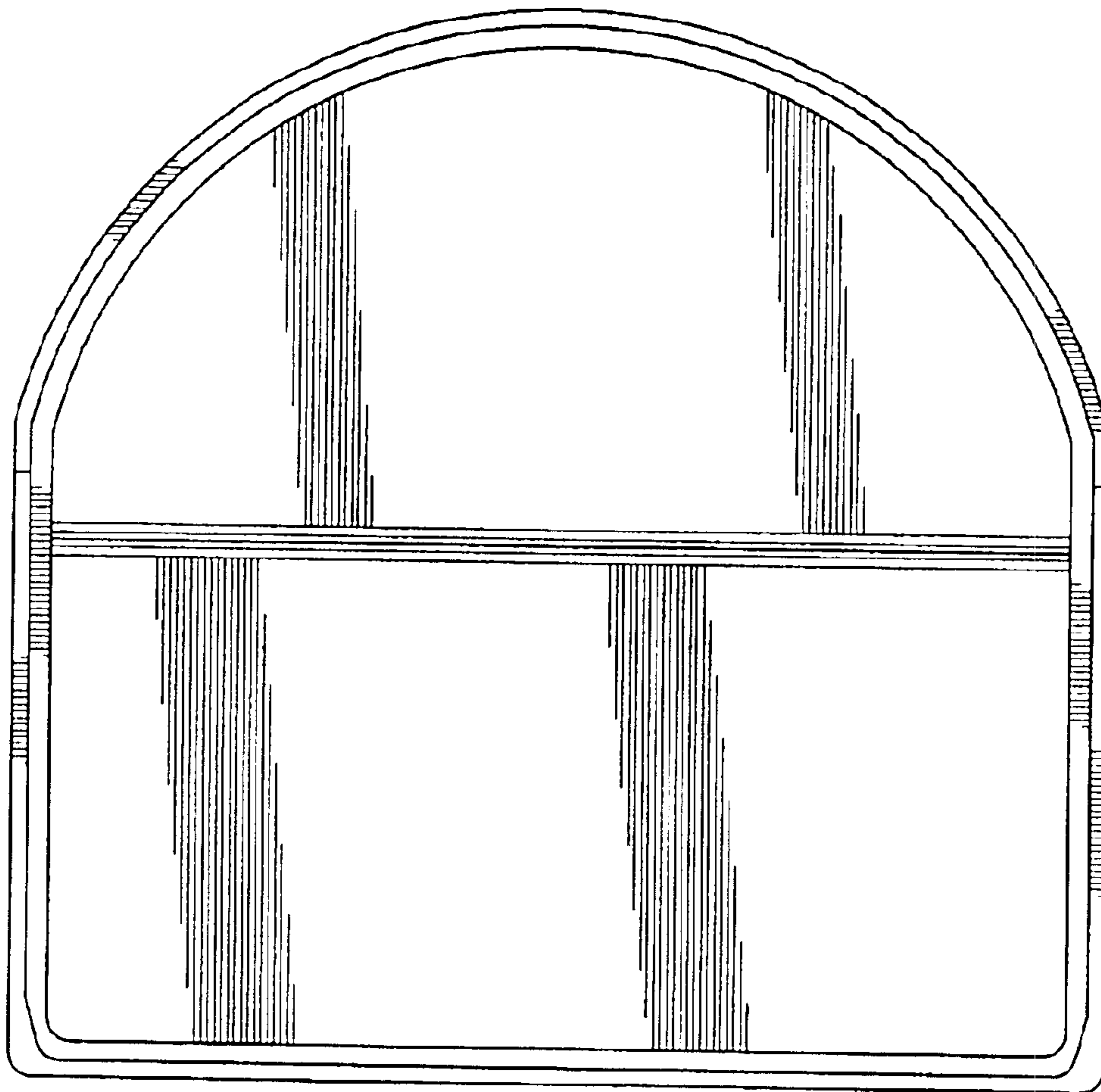
