(57) **CLAIM**

The ornamental design for an accessory post, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an accessory post of the new design;

FIG. 2 is a top plan view of the accessory post of FIG. 1;

FIG. 3 is a rear elevational view of the accessory post of FIG. 1;

FIG. 4 is a right elevational view of the accessory post of FIG. 1, the left side being a mirror image;

FIG. 5 is a front elevational view of the accessory post of FIG. 1; and,

FIG. 6 is a bottom plan view of the accessory post of FIG. 1.

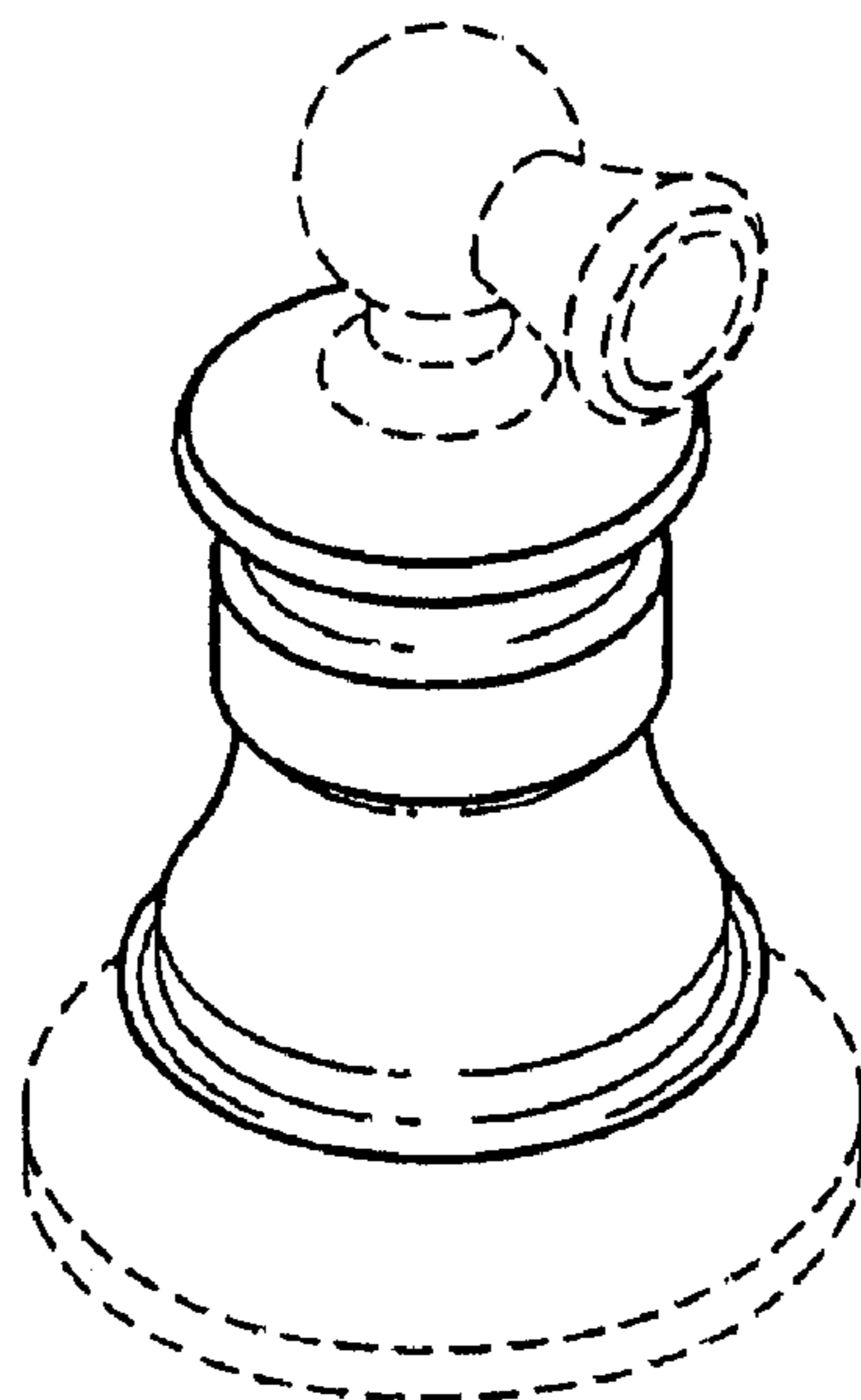

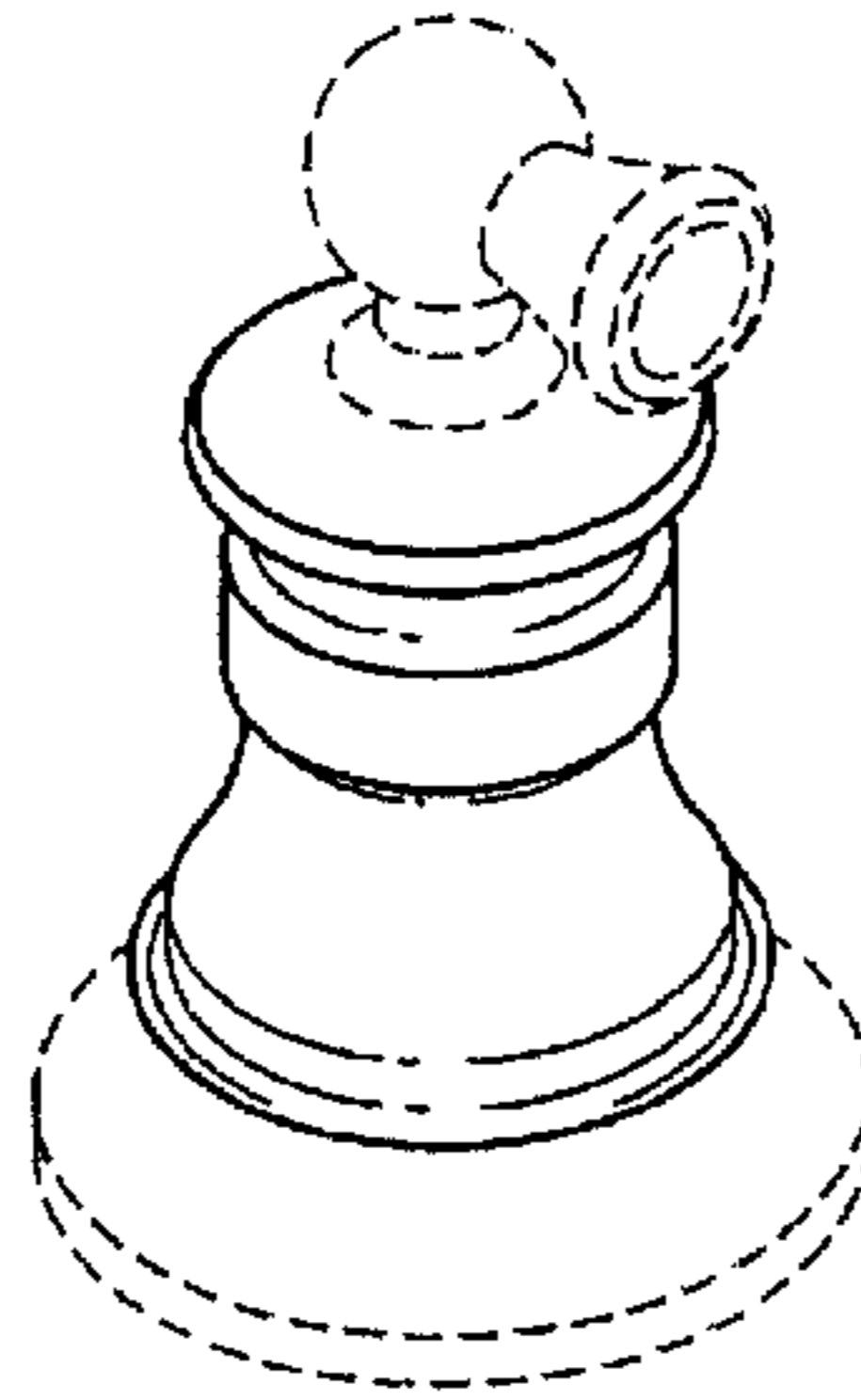

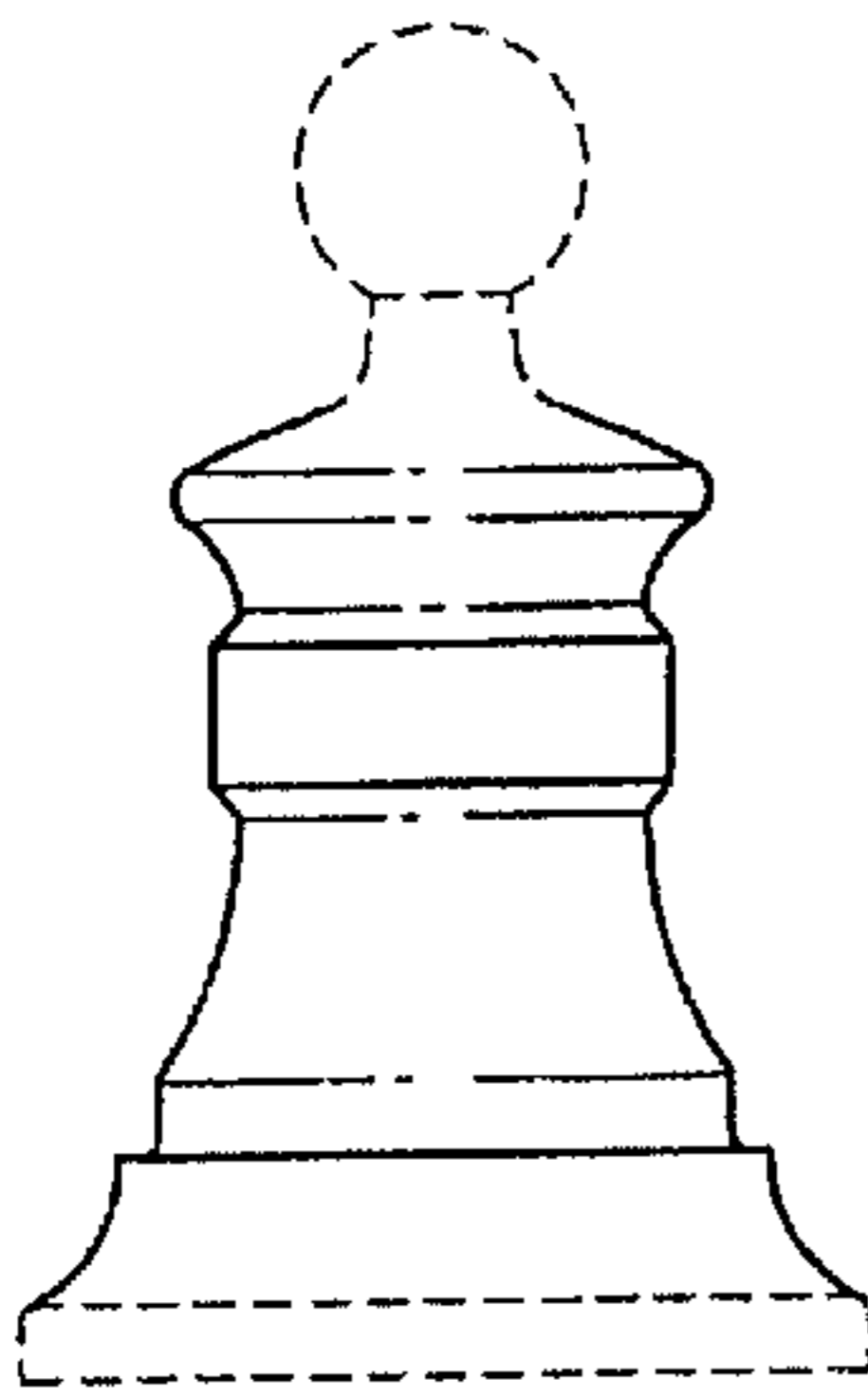
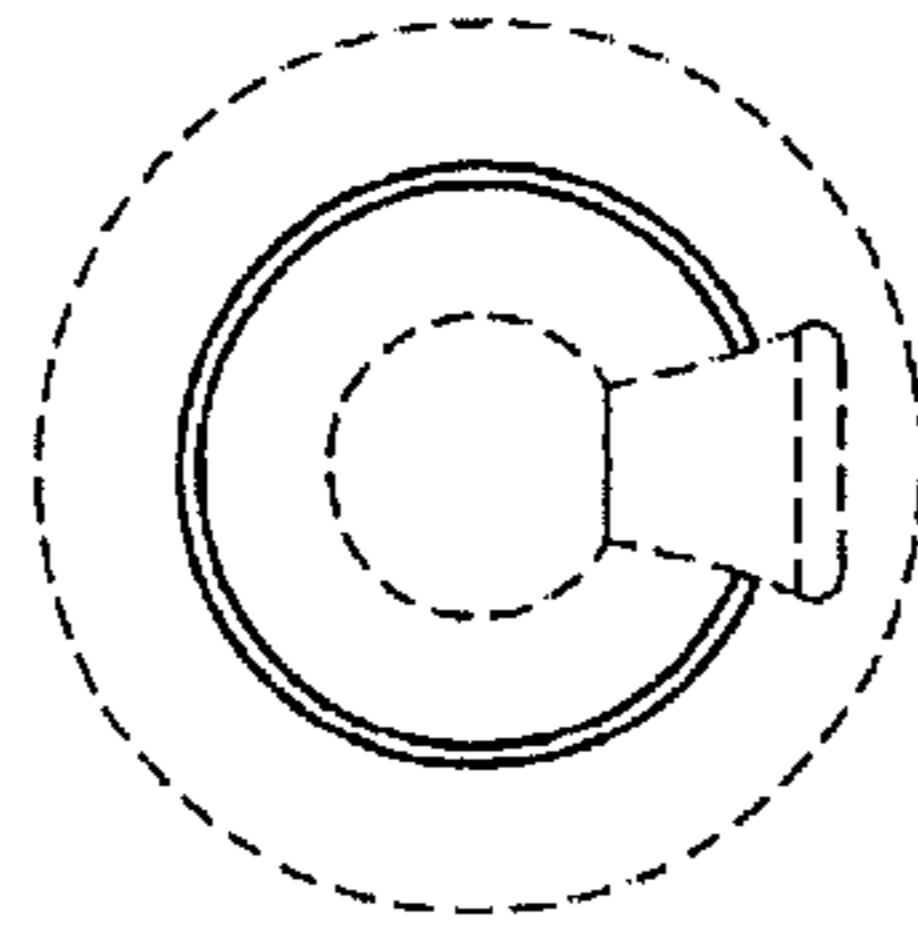

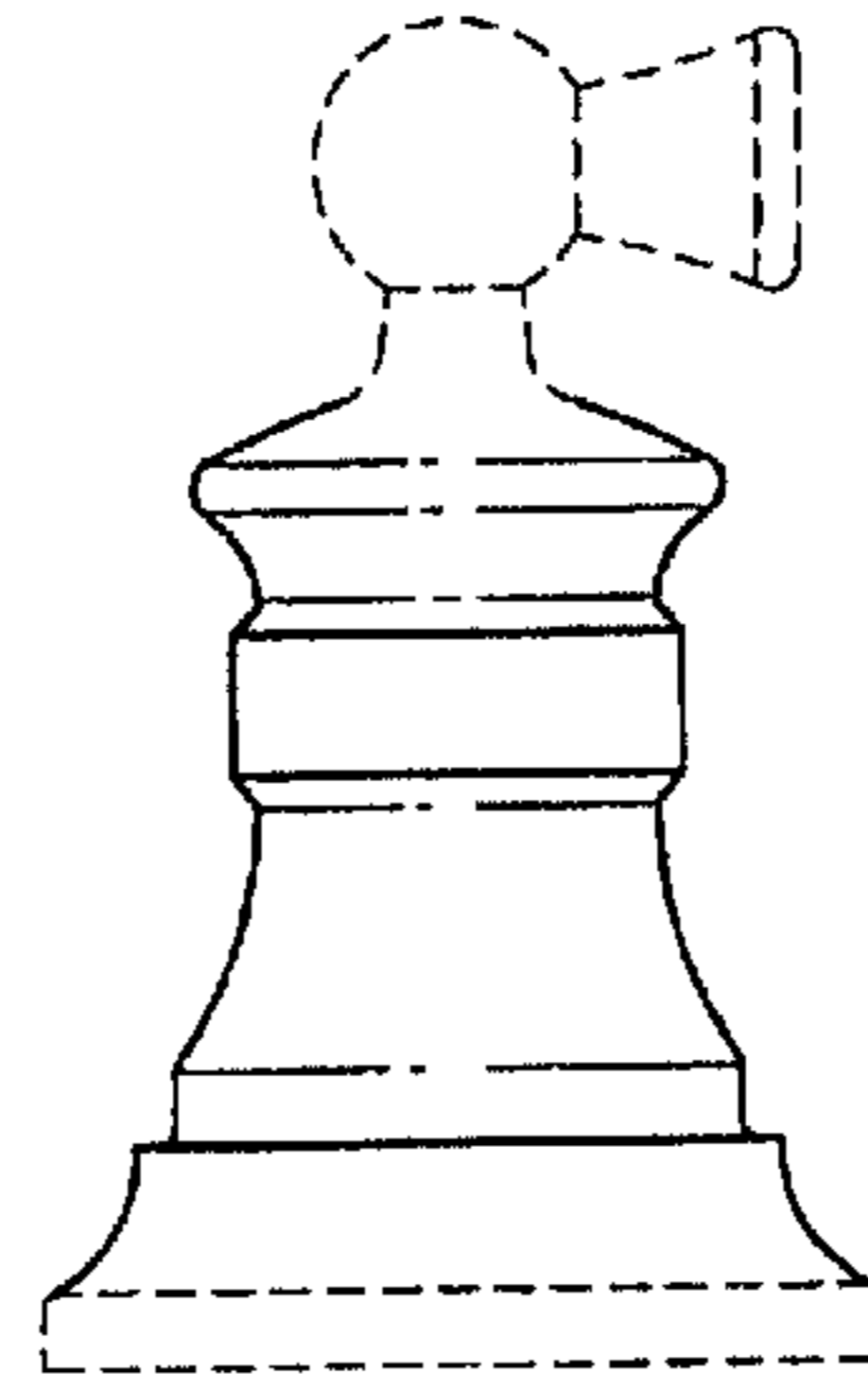

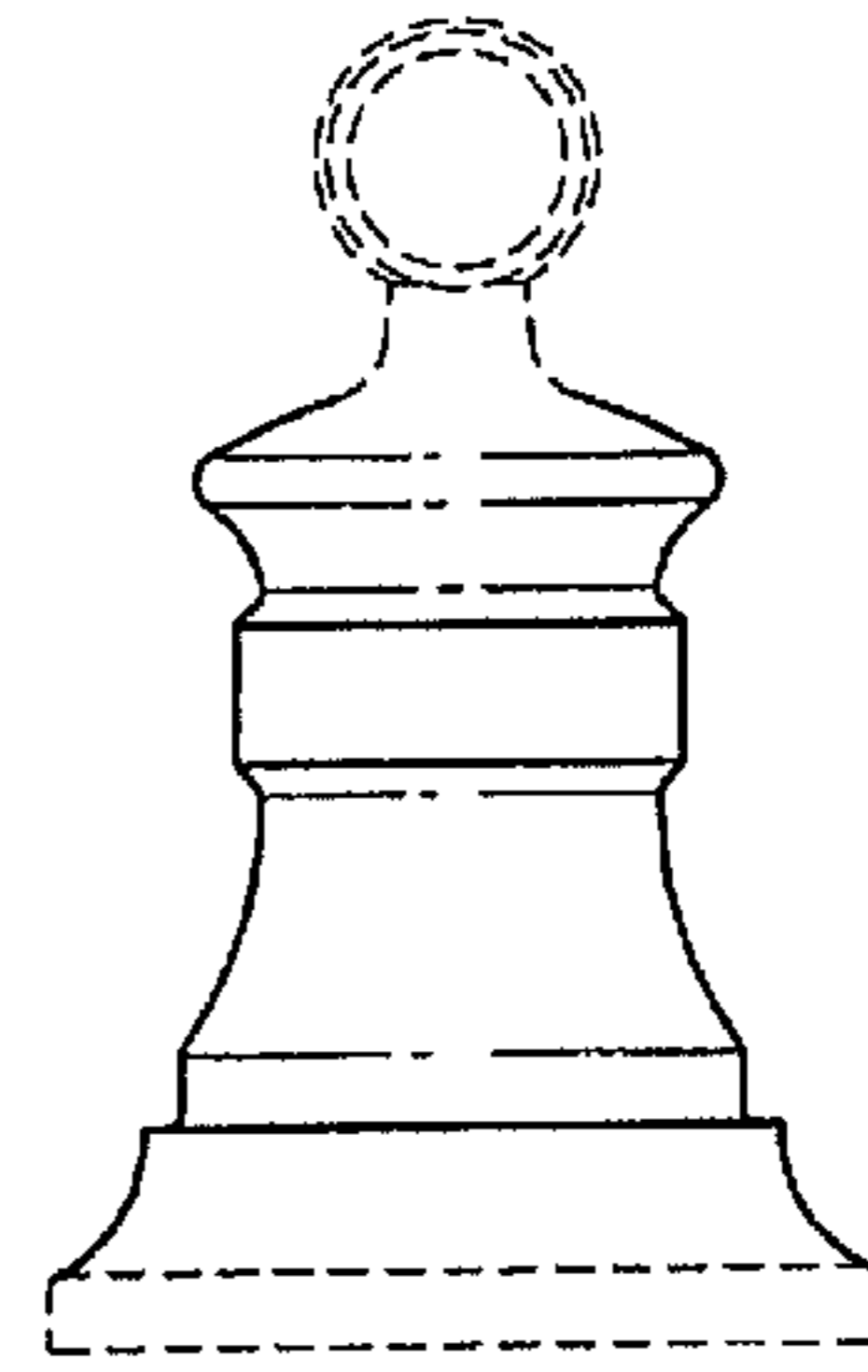
