The ornamental design for an escutcheon, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an escutcheon of the subject design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

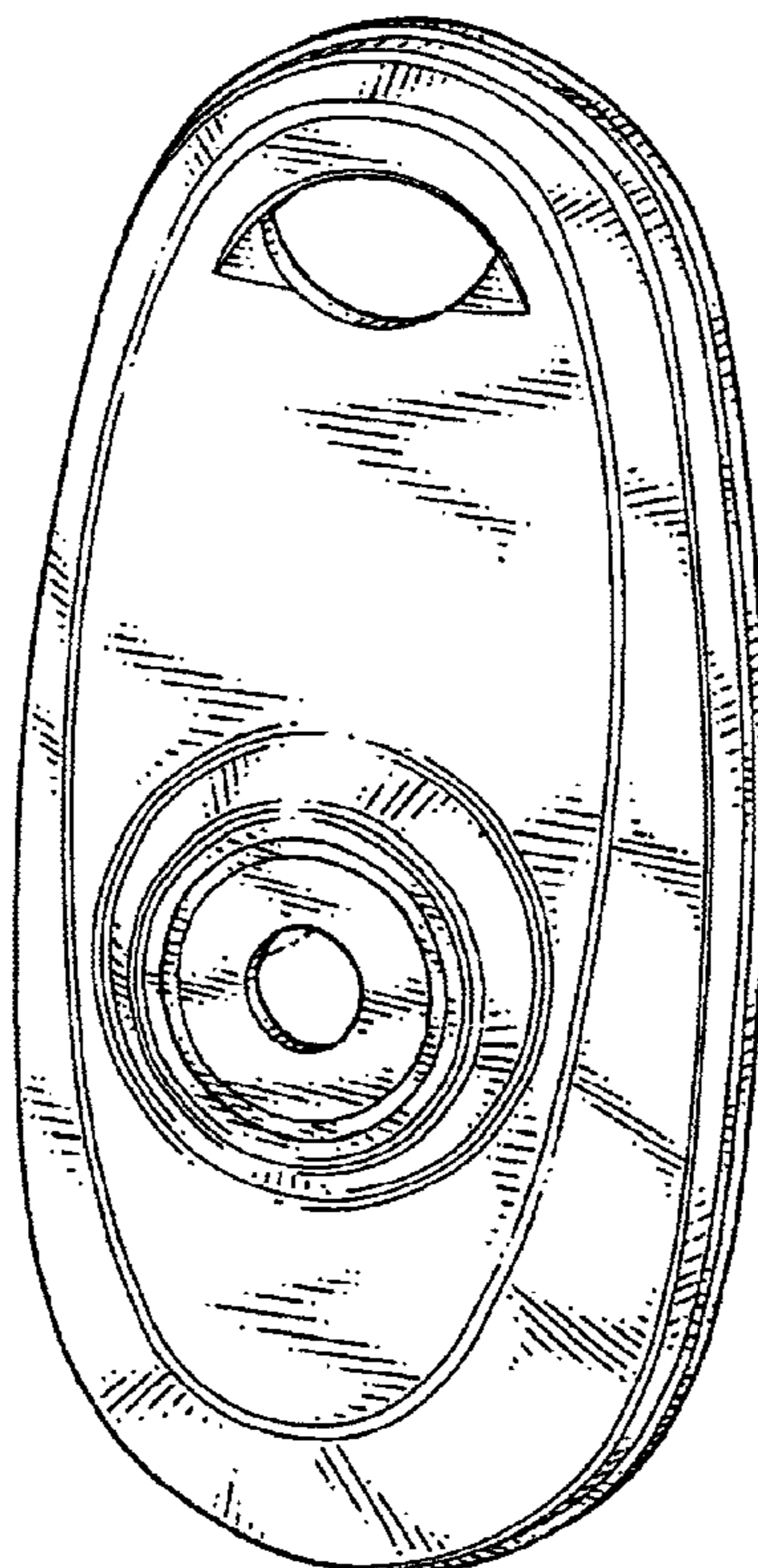
FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side elevational view thereof, the left side elevational view being symmetric to the right side elevational view; and,

FIG. 7 is a reference view showing an escutcheon with a key hole.

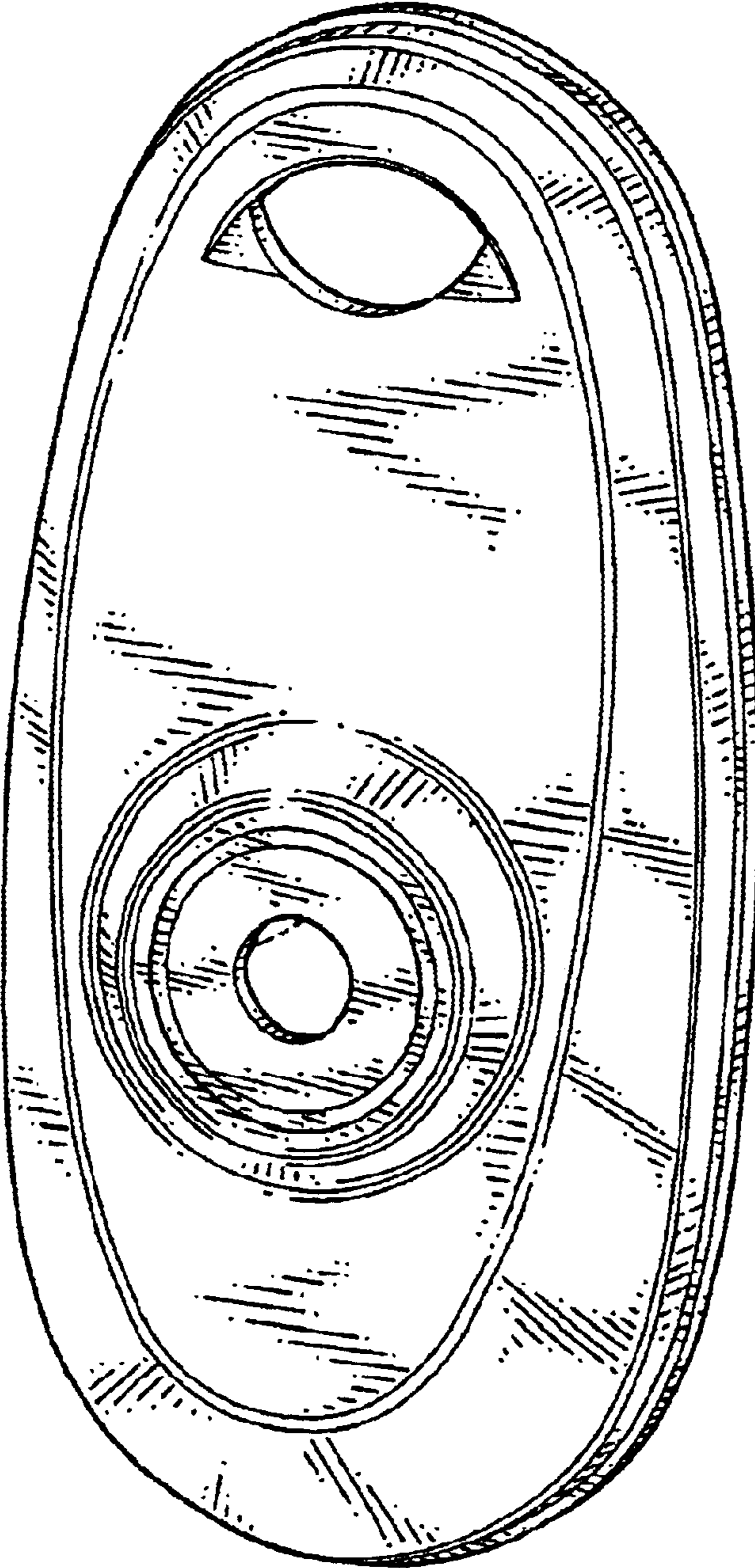

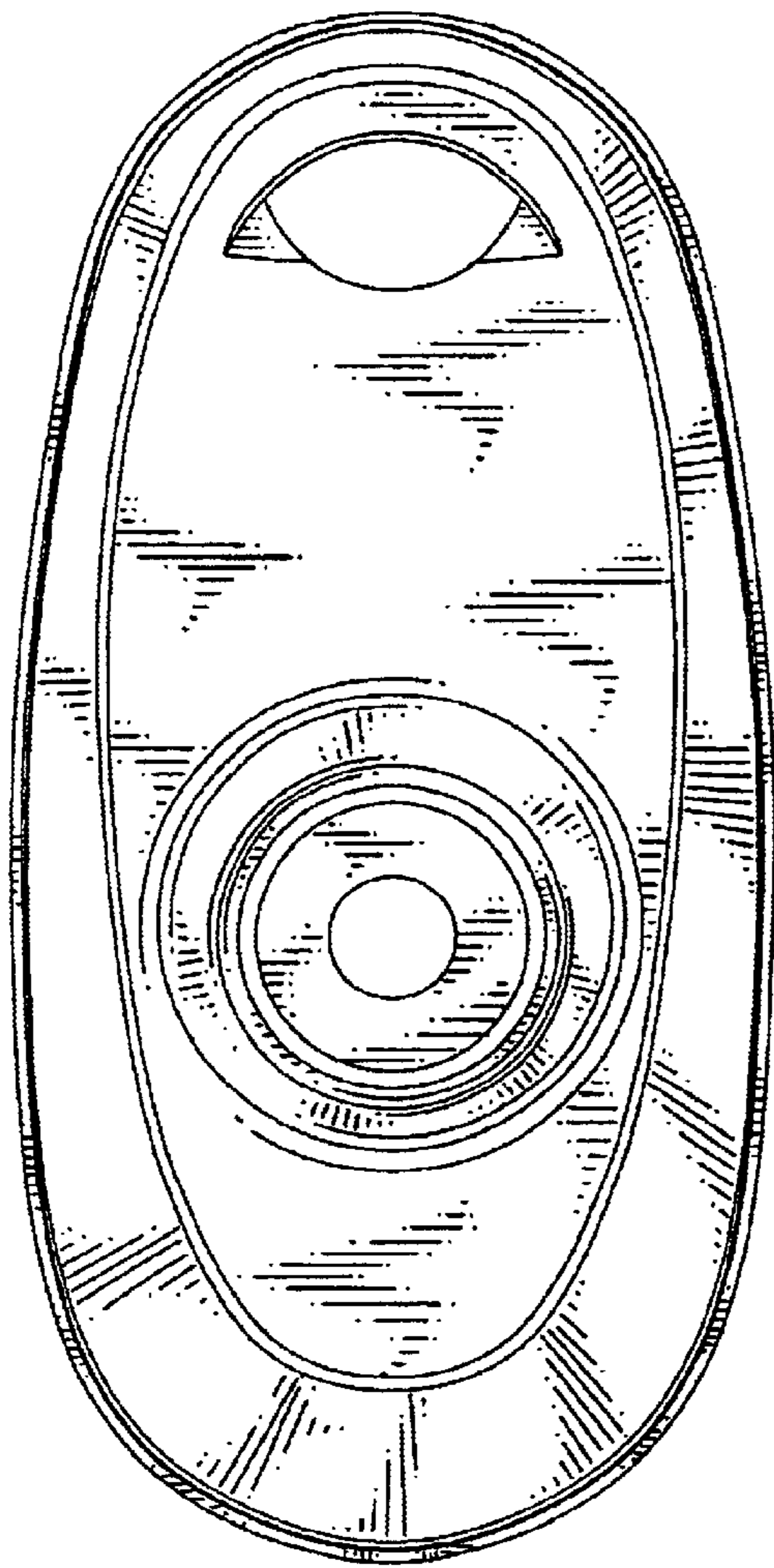

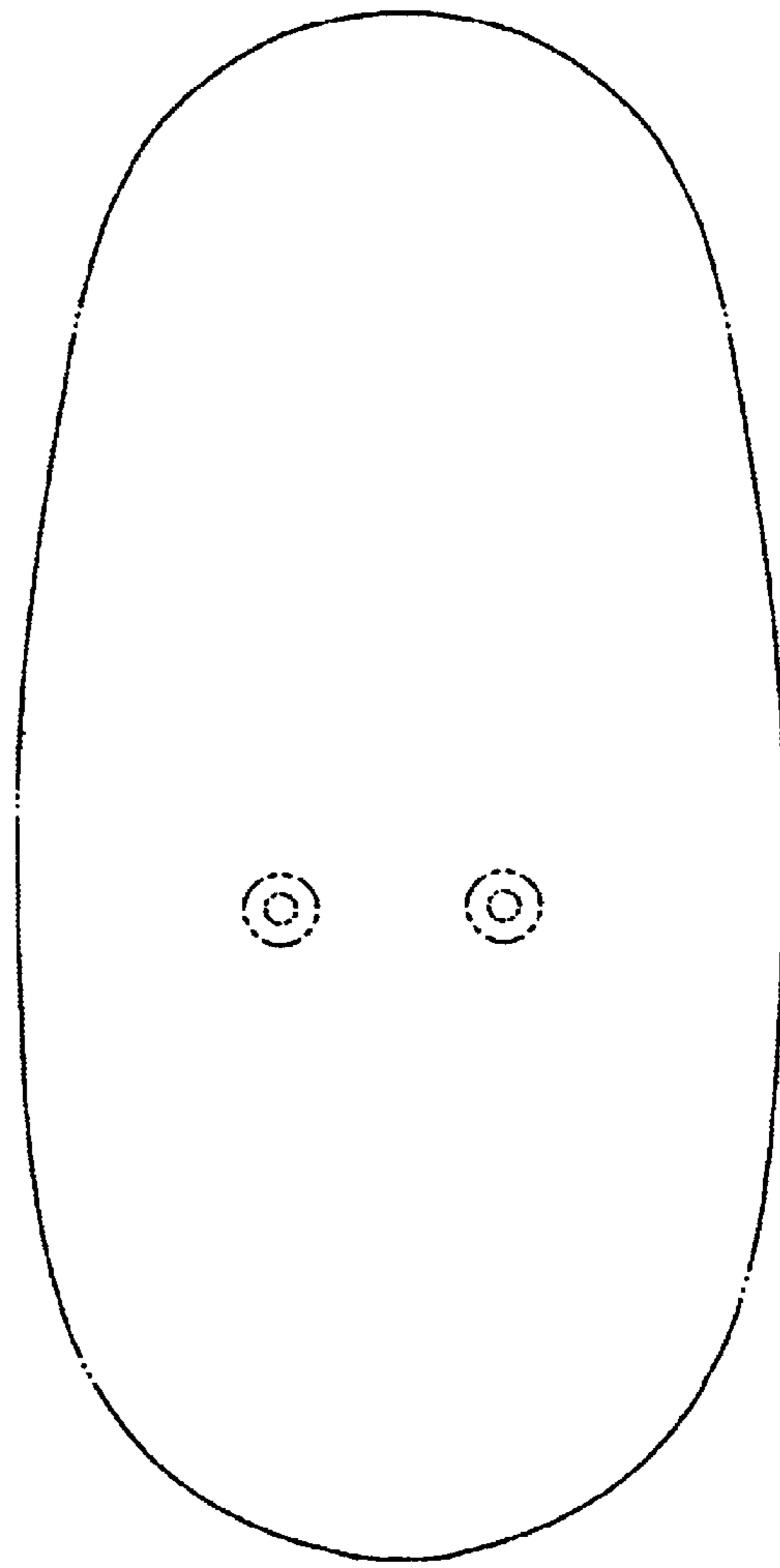

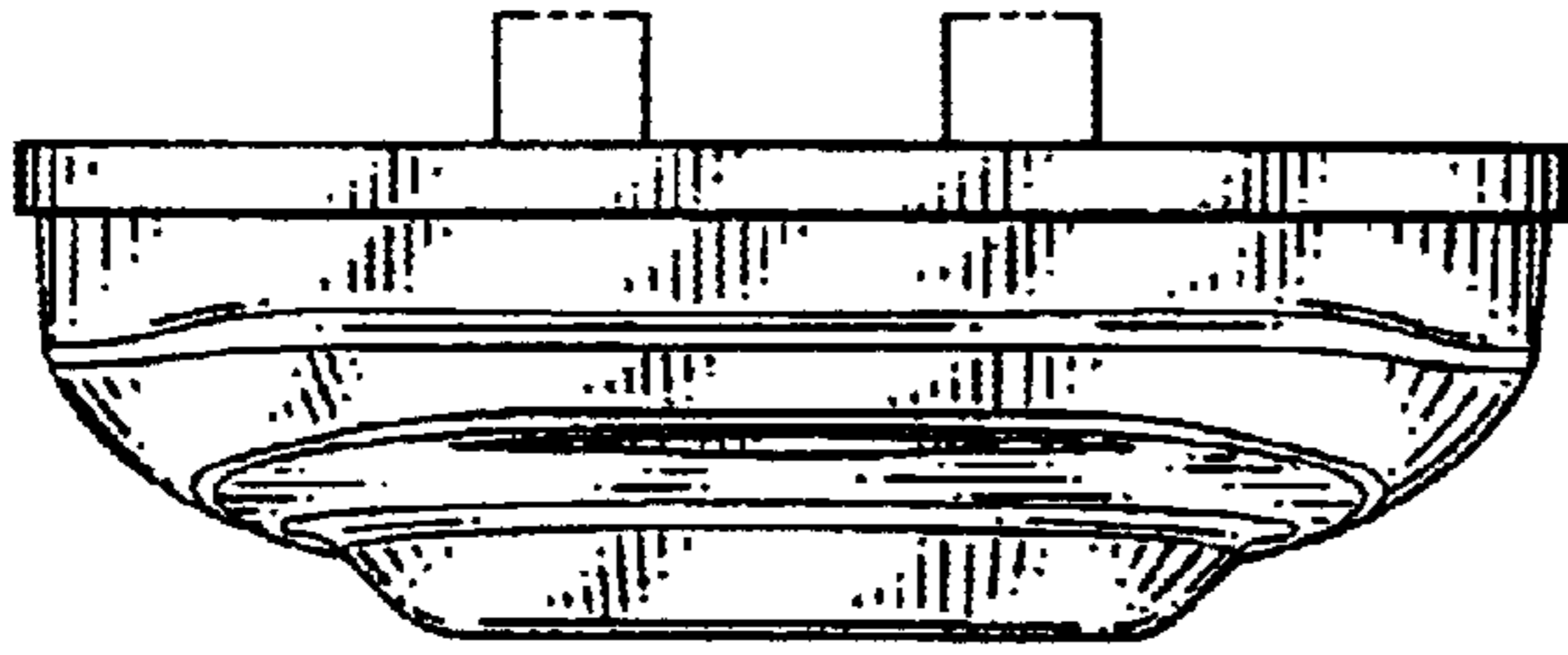

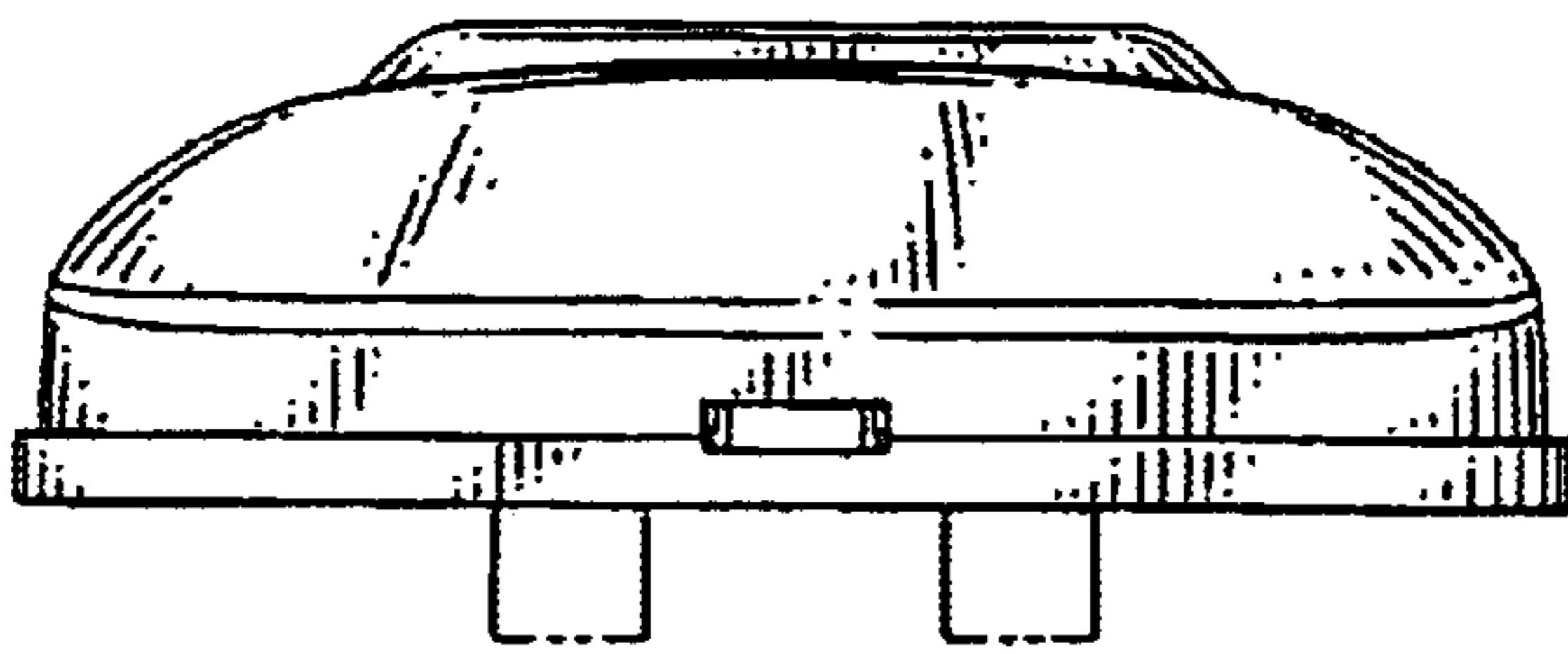

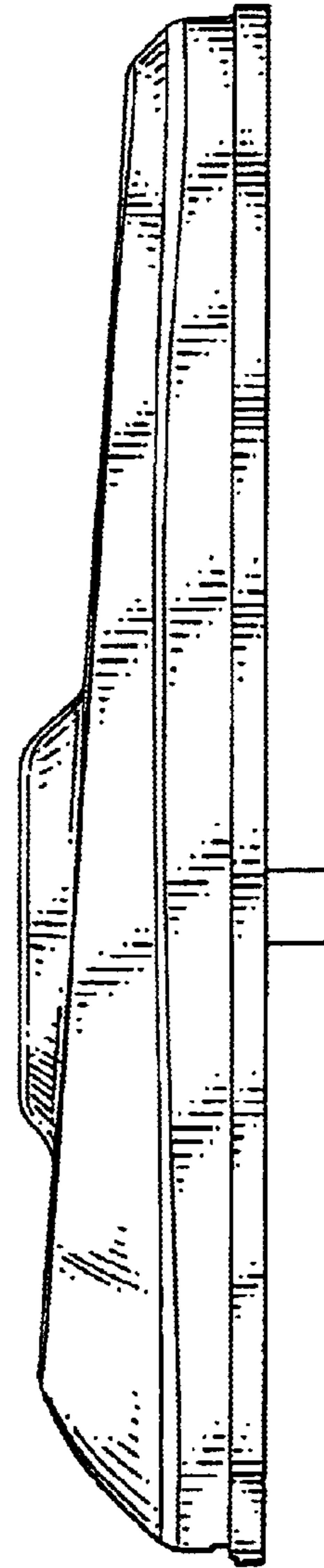

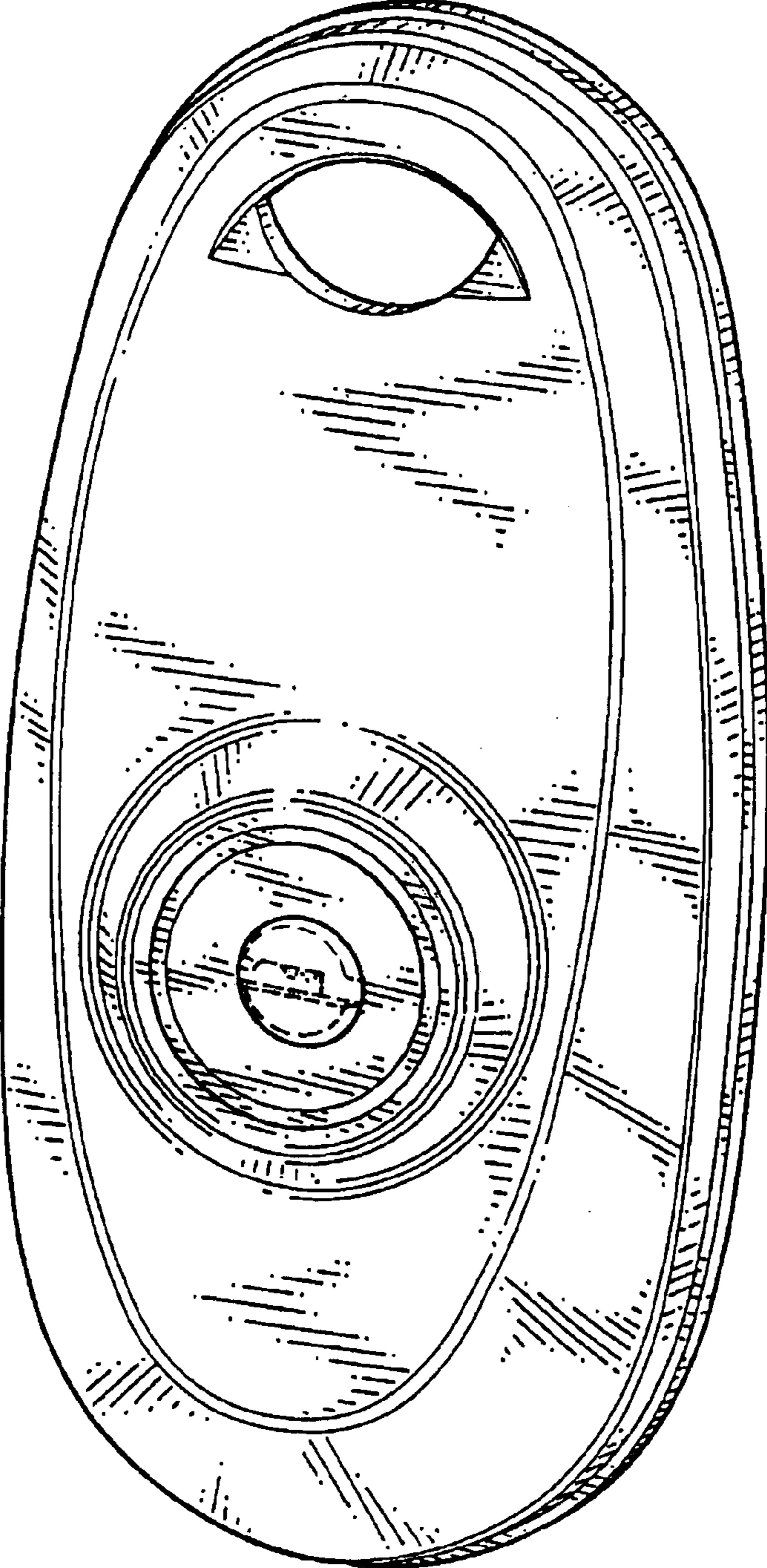
