(57) **CLAIM**

What is claimed is the ornamental design for a desktop audio recording and playback system, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing the desktop audio recording and playback system of Applicants' invention.

FIG. 2 is a front elevation of the desktop audio recording and playback system of Applicants' invention.

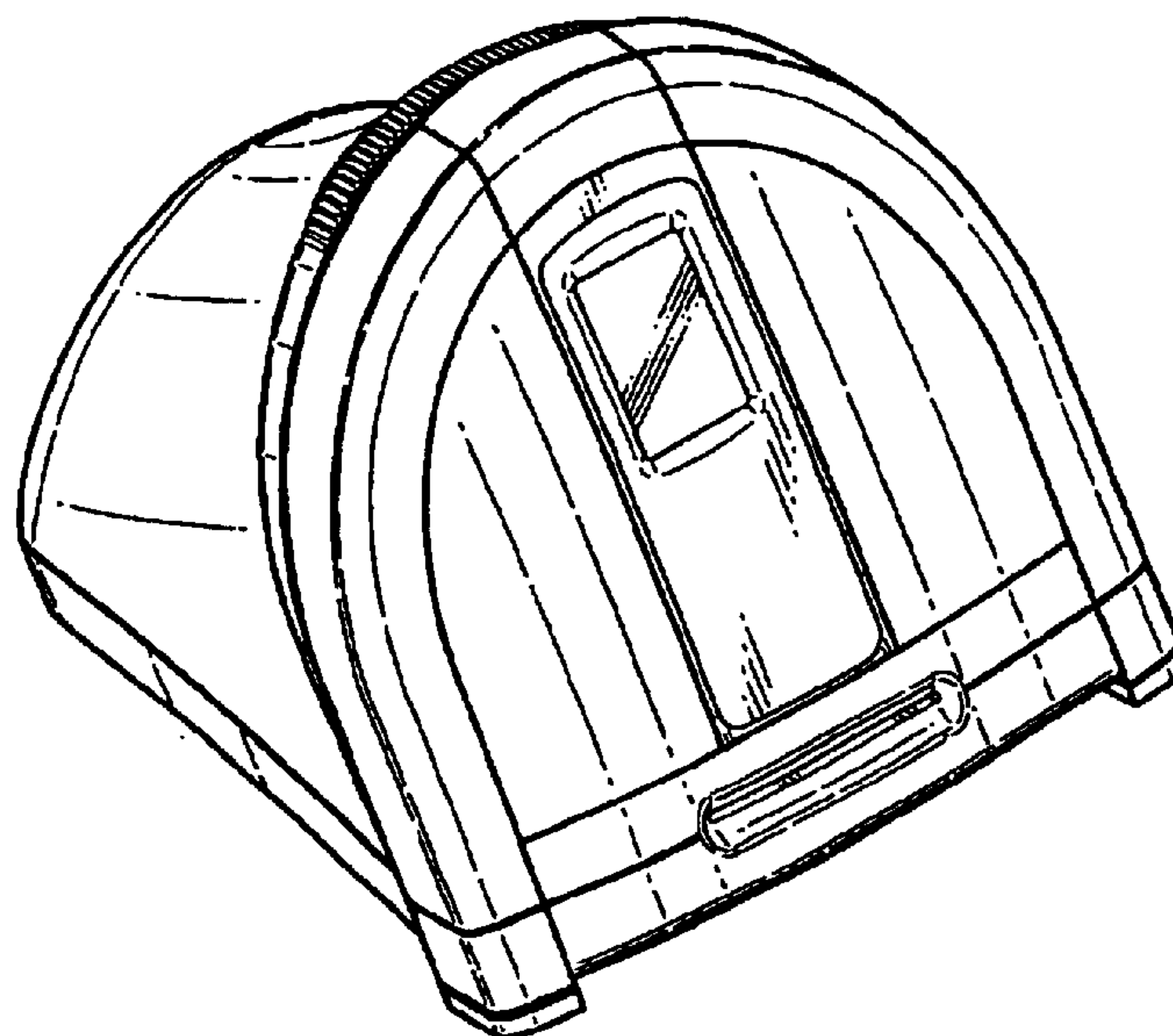
FIG. 3 is a right side elevation of the desktop audio recording and playback system of Applicants' invention, both sides being identical.

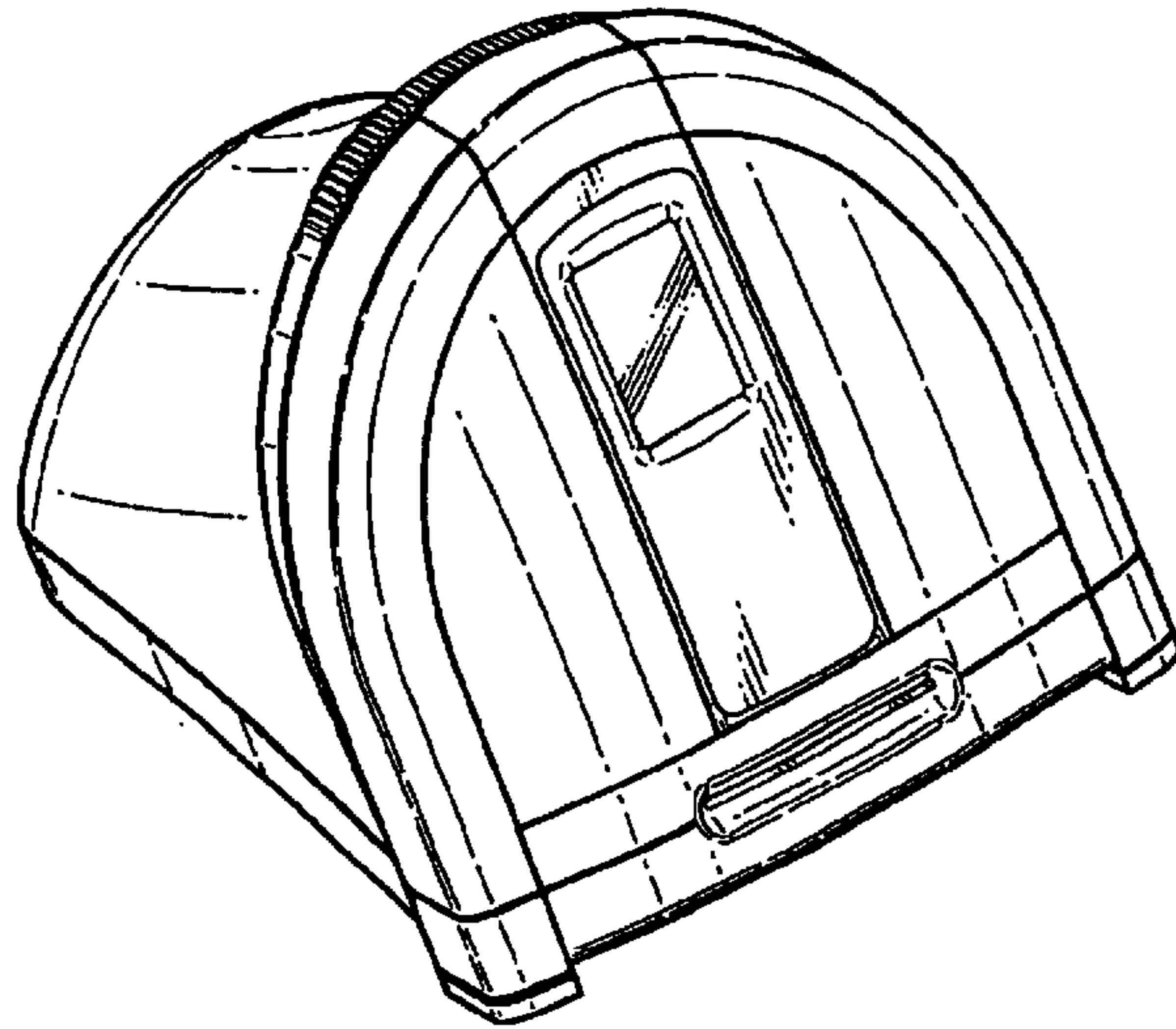

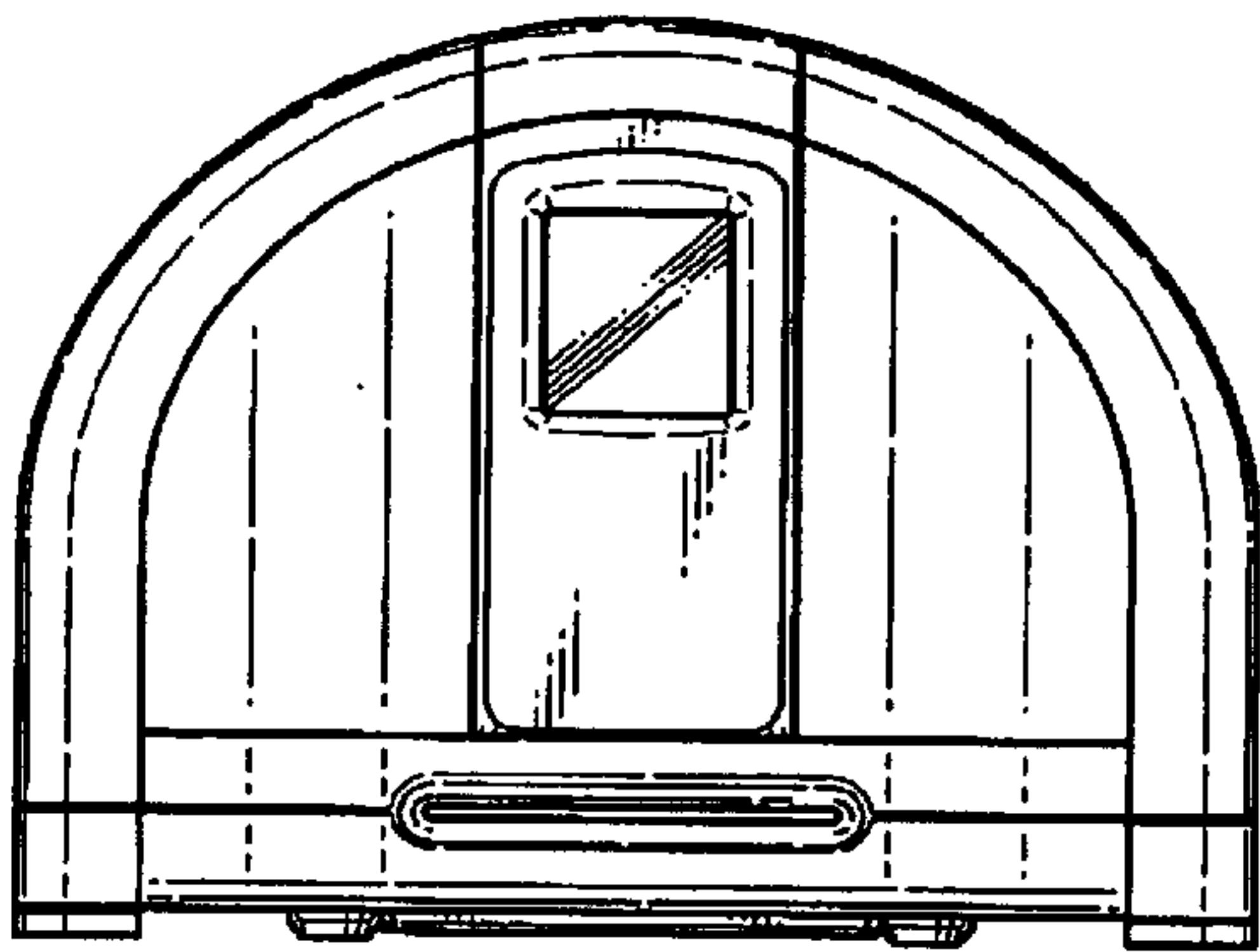

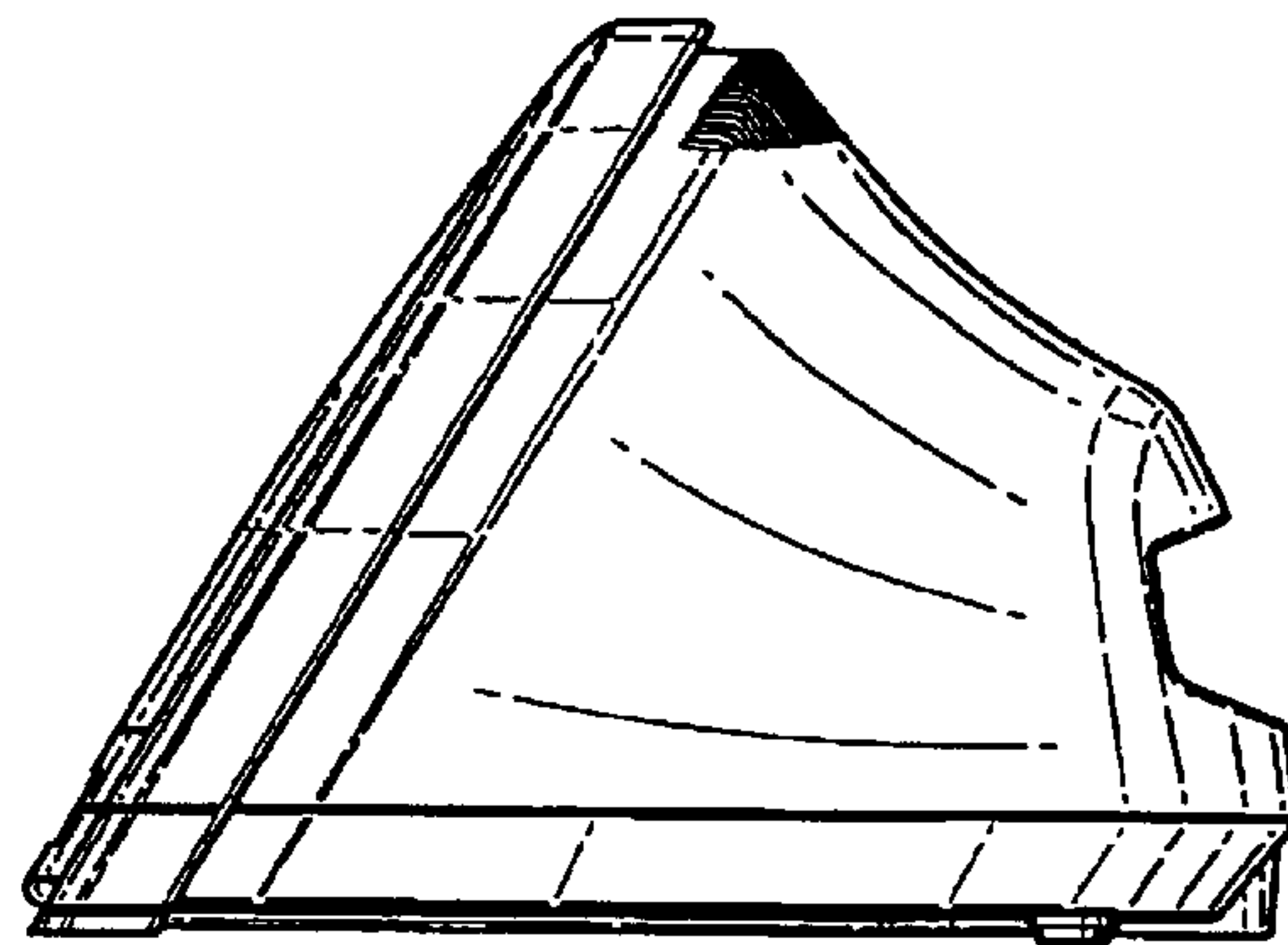

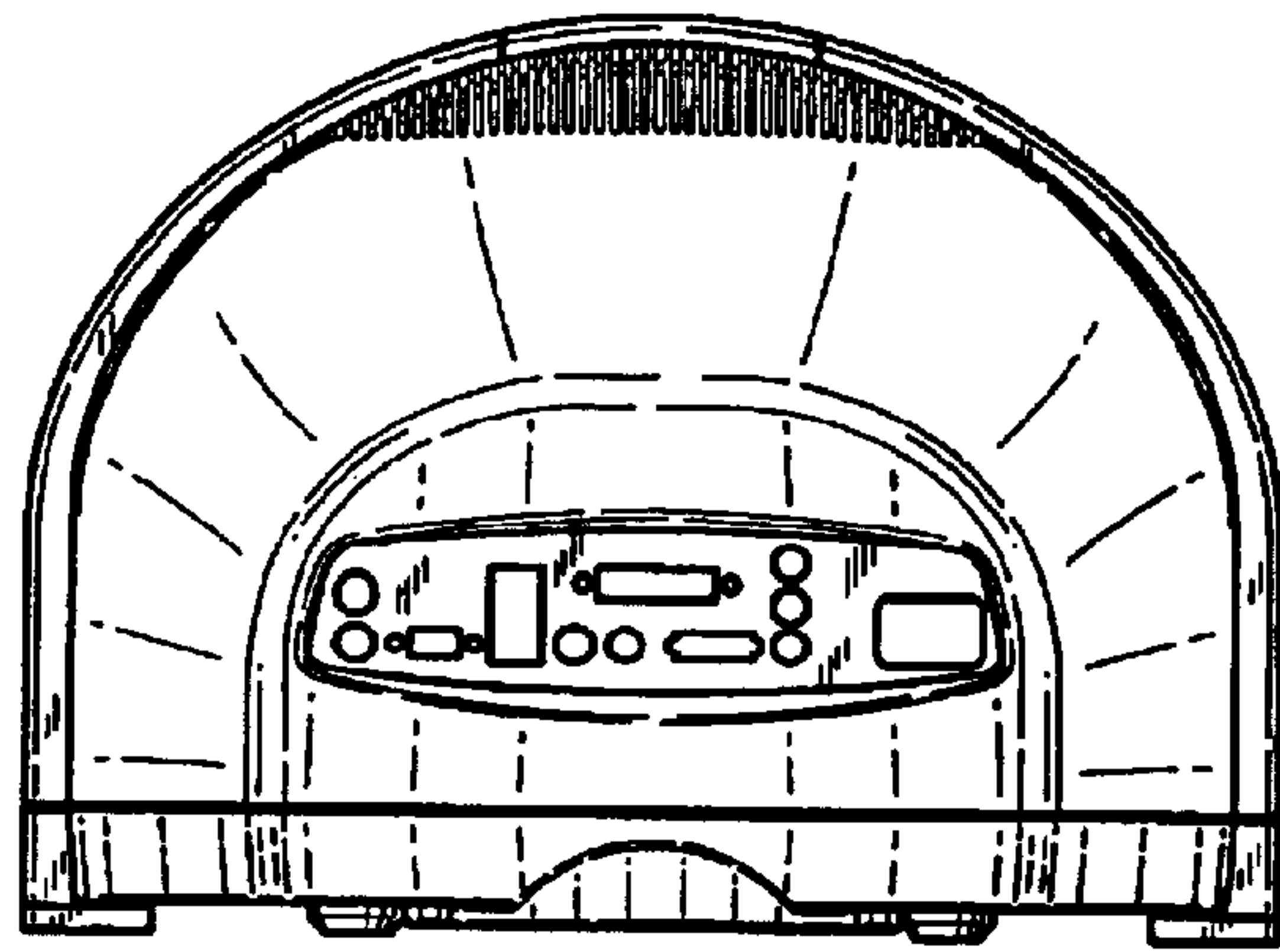

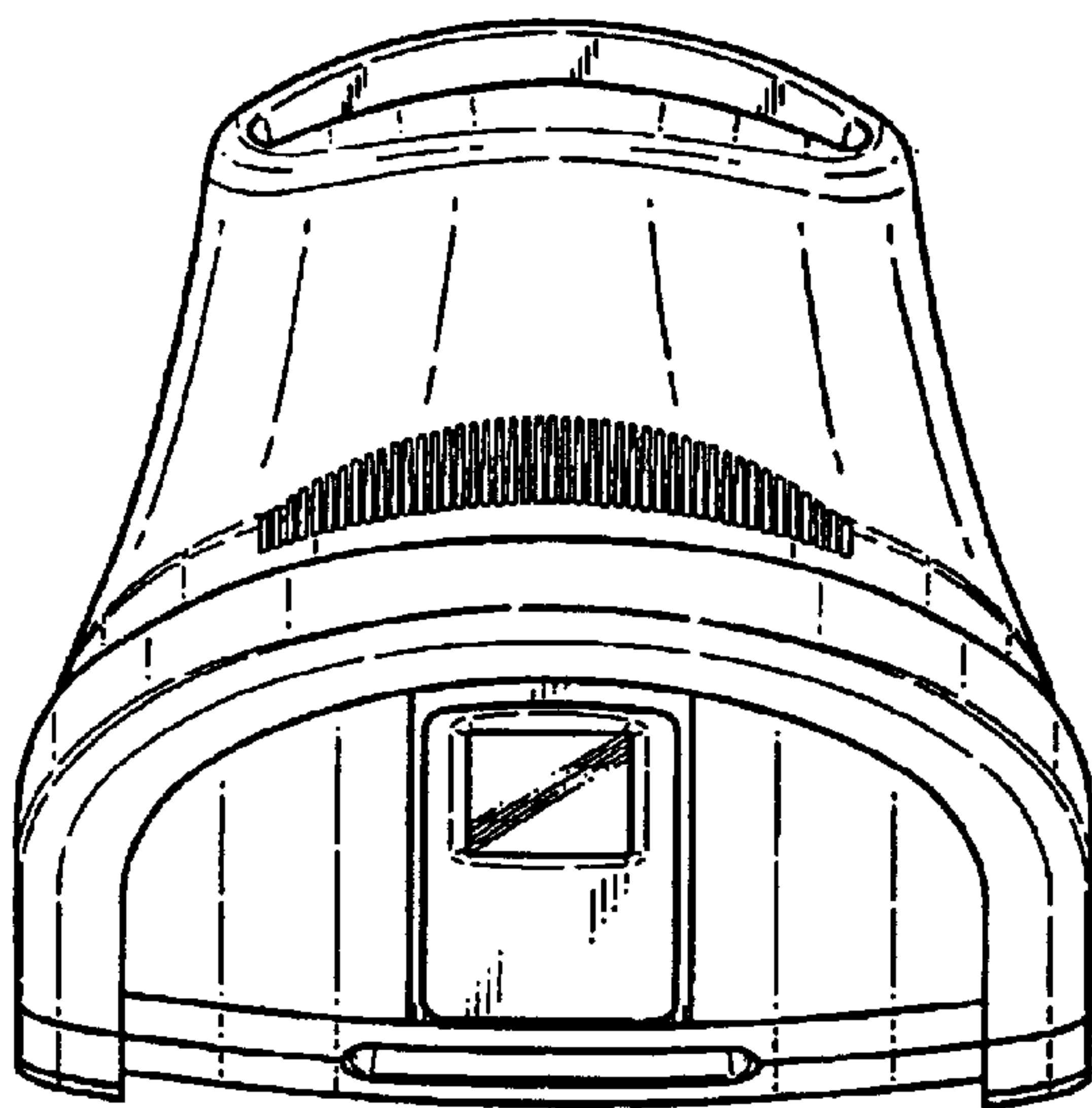

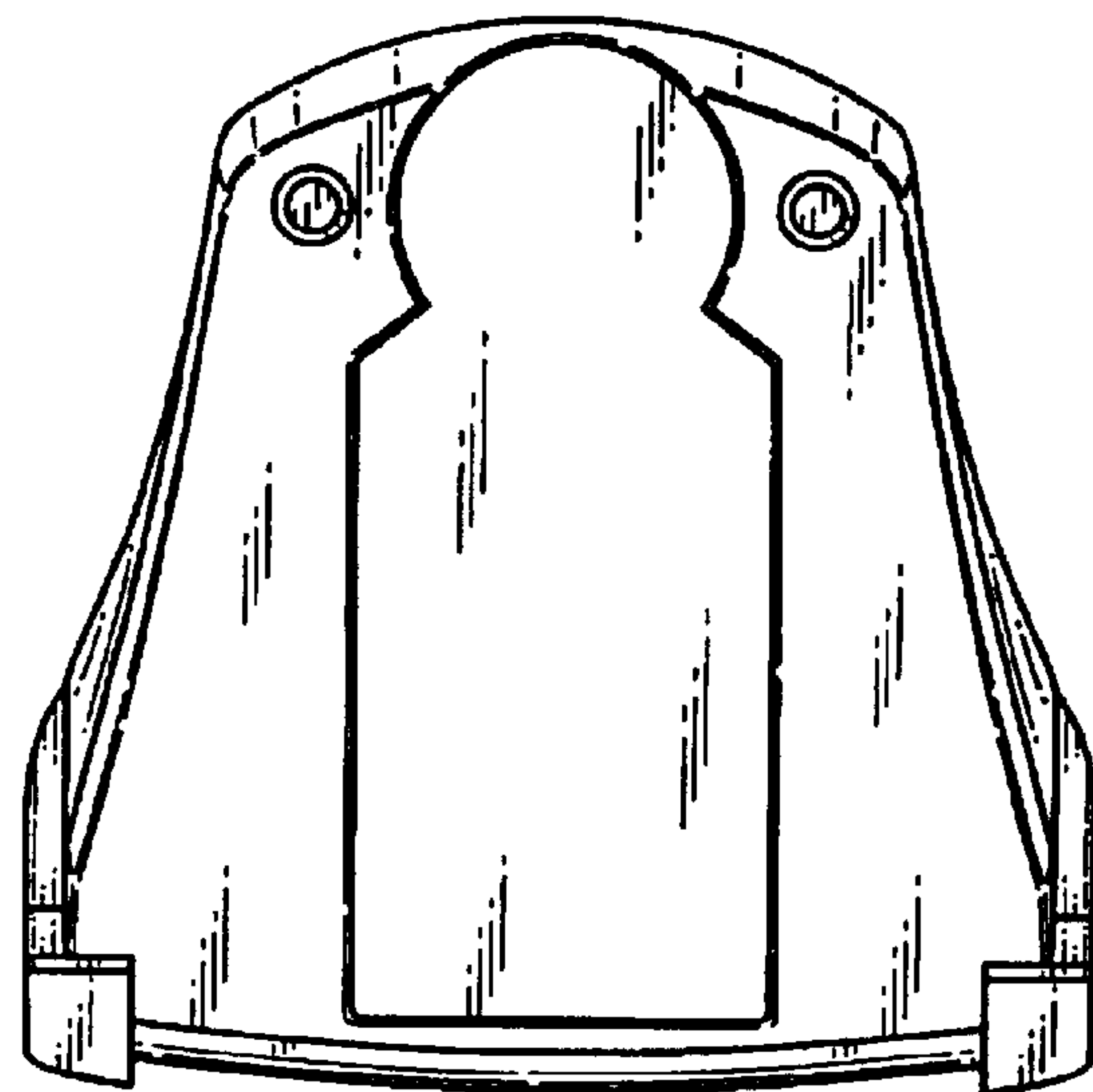
