(57) **CLAIM**

The ornamental design for a glitter pencil having three color  
glitters forming transversal stripes, substantially as shown  
and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a glitter pencil having  
three color glitters forming transversal stripes showing my  
new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is an enlarged fragmentary view of the junction of the  
two lower sections.

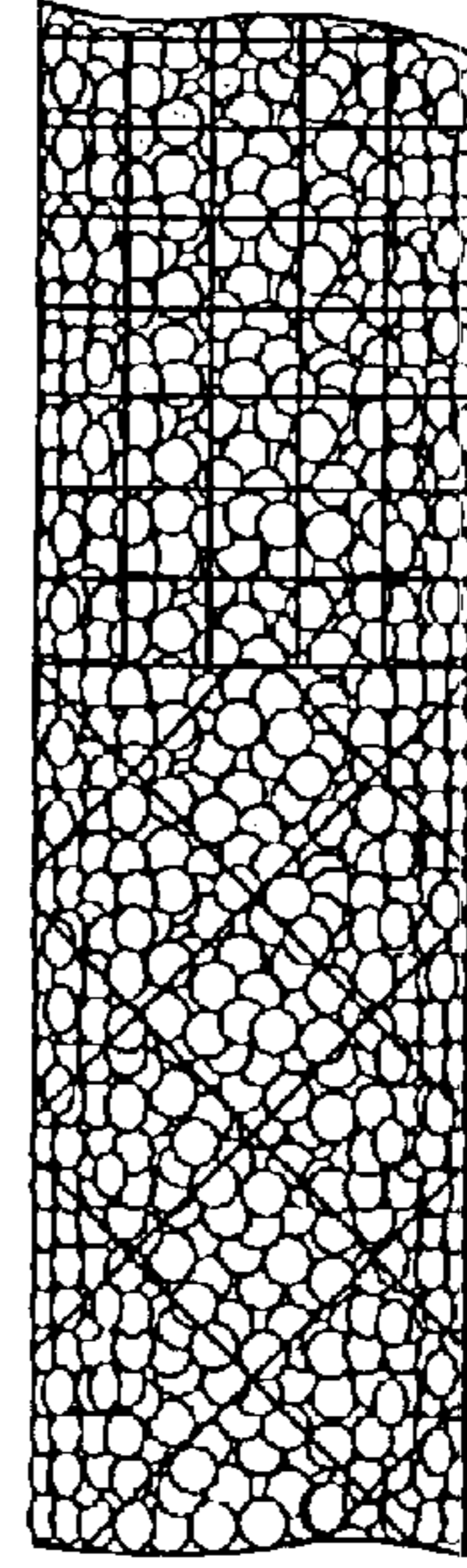
