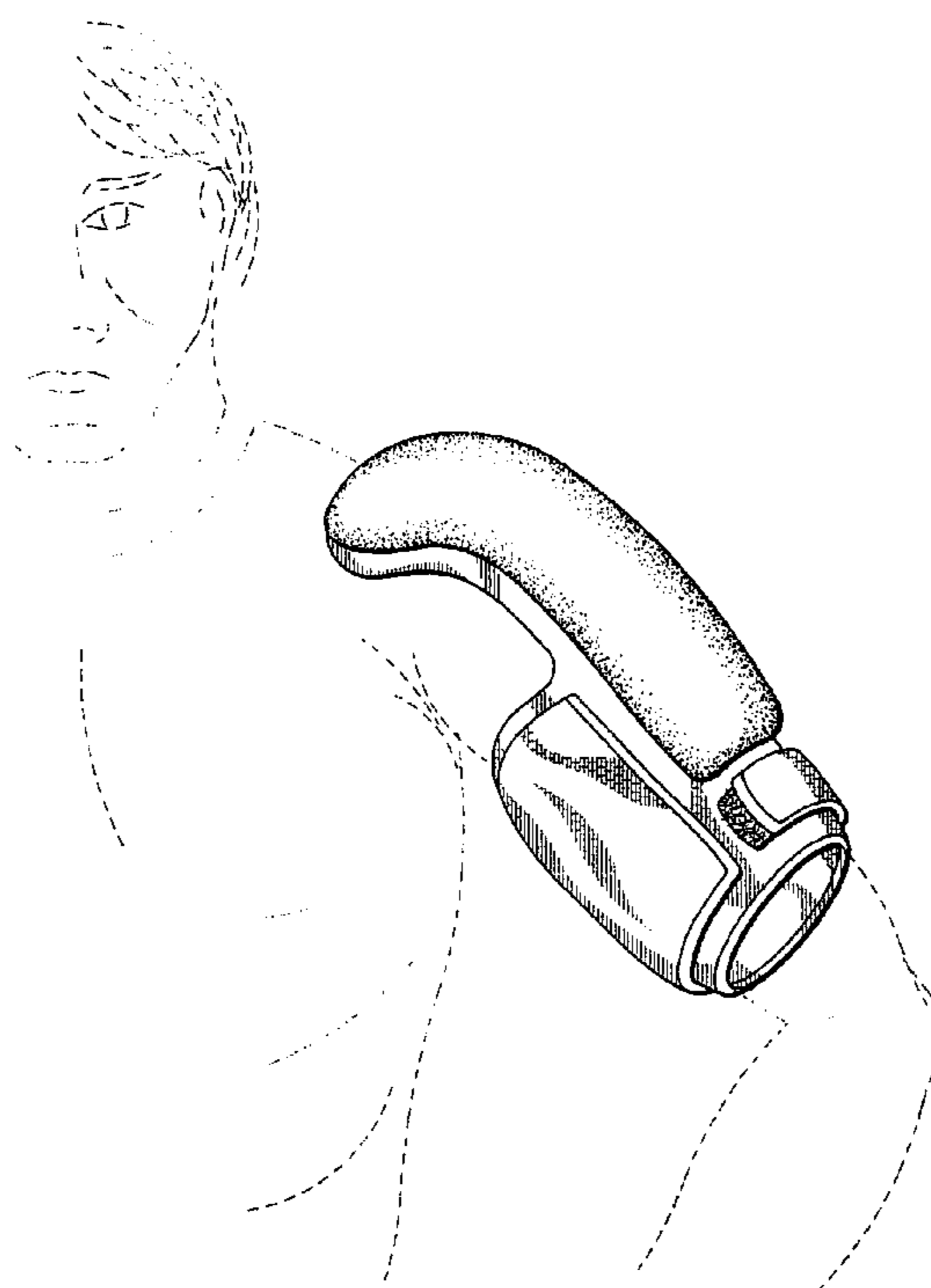
(57) **CLAIM**

I claim the ornamental design for a sports sweat pad with hook and loop fastener, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sports sweat pad with hook and loop fastener showing my new design;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is an elevational view of the opposing side thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a rear elevational view thereof; and,
FIG. 8 is a reduced perspective view showing the sports sweat pad with hook and loop fastener in use; the broken lines depict environmental structure for illustrative purposes only and form no part of the claimed design.

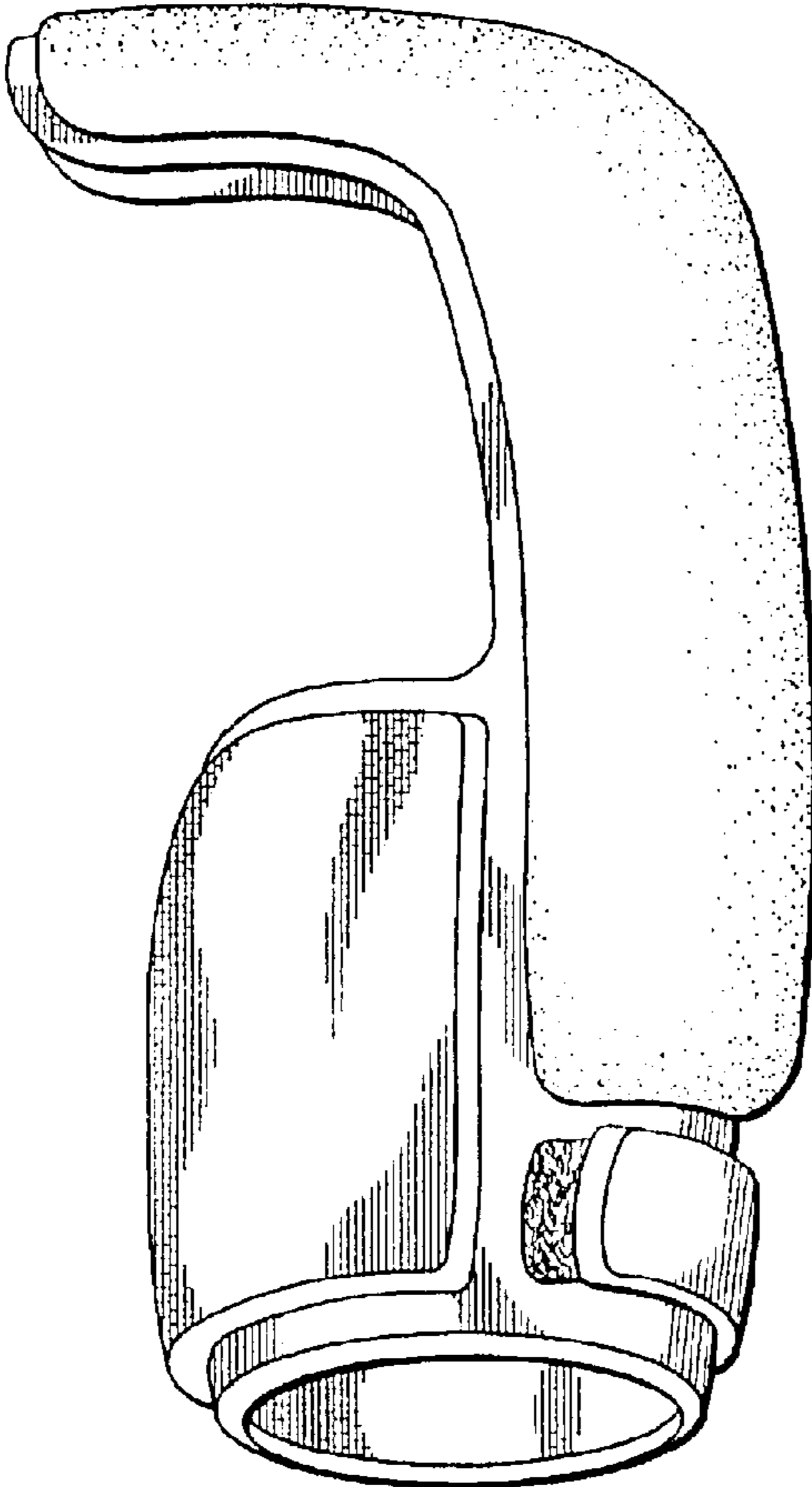

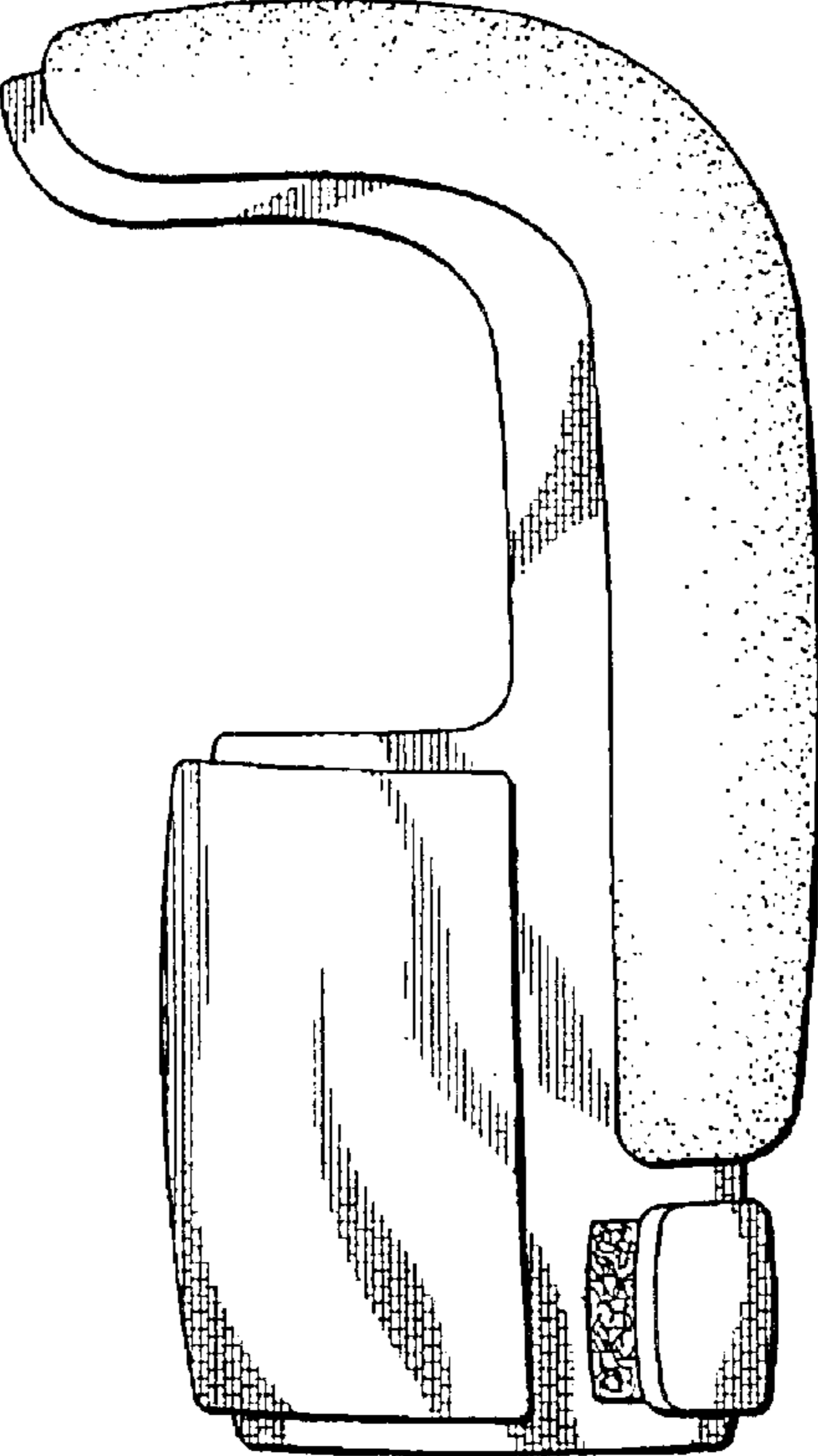

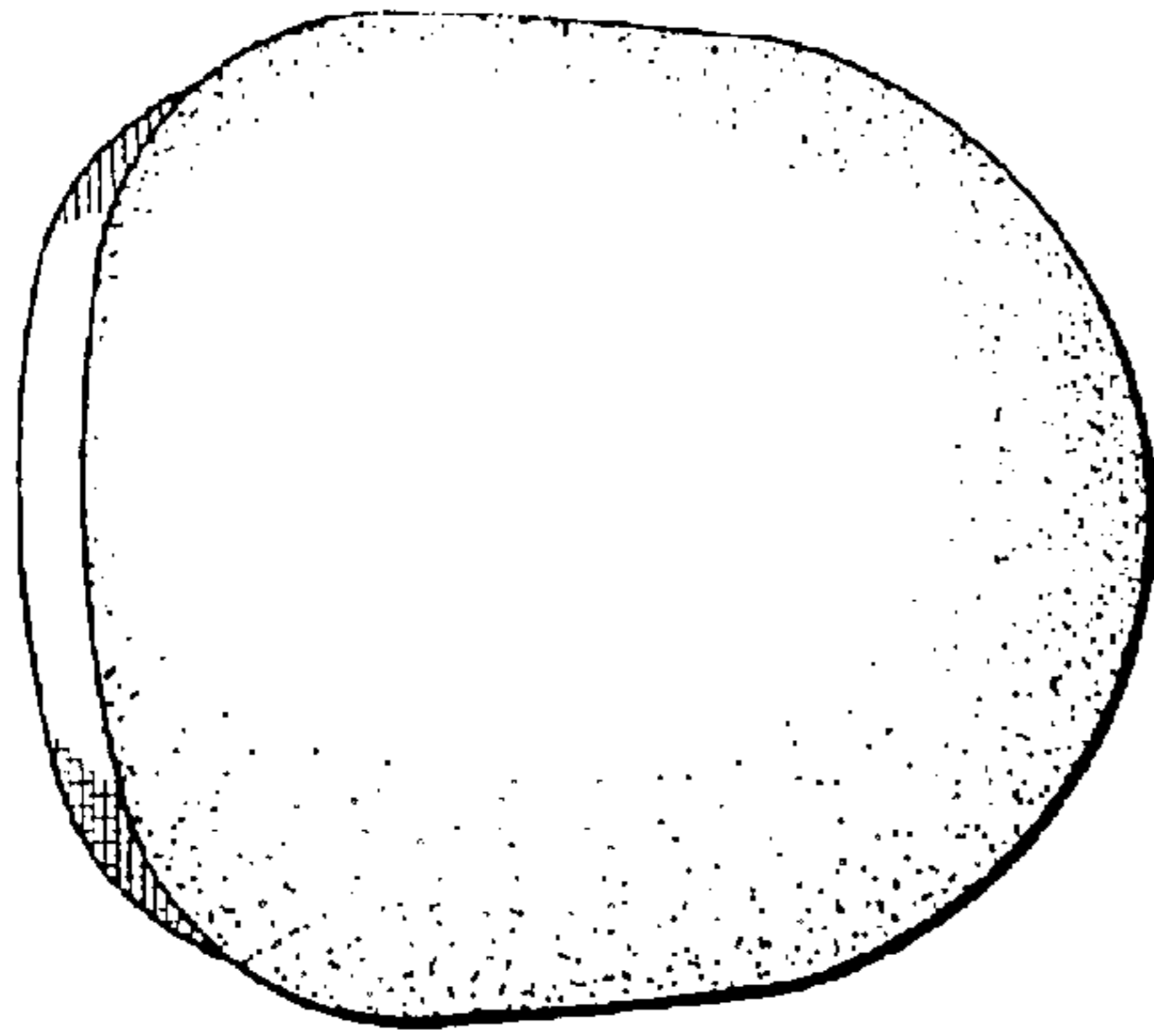

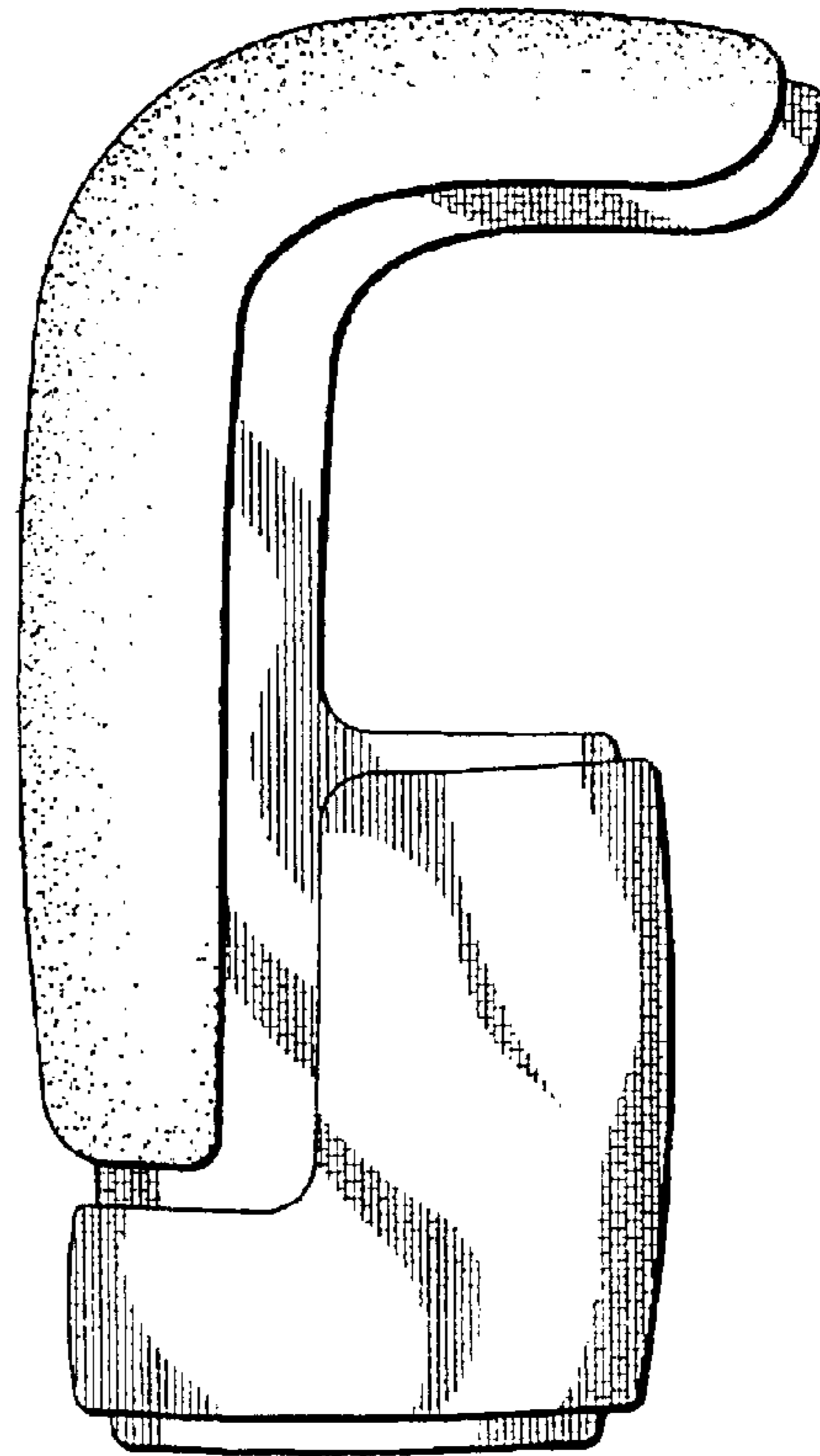

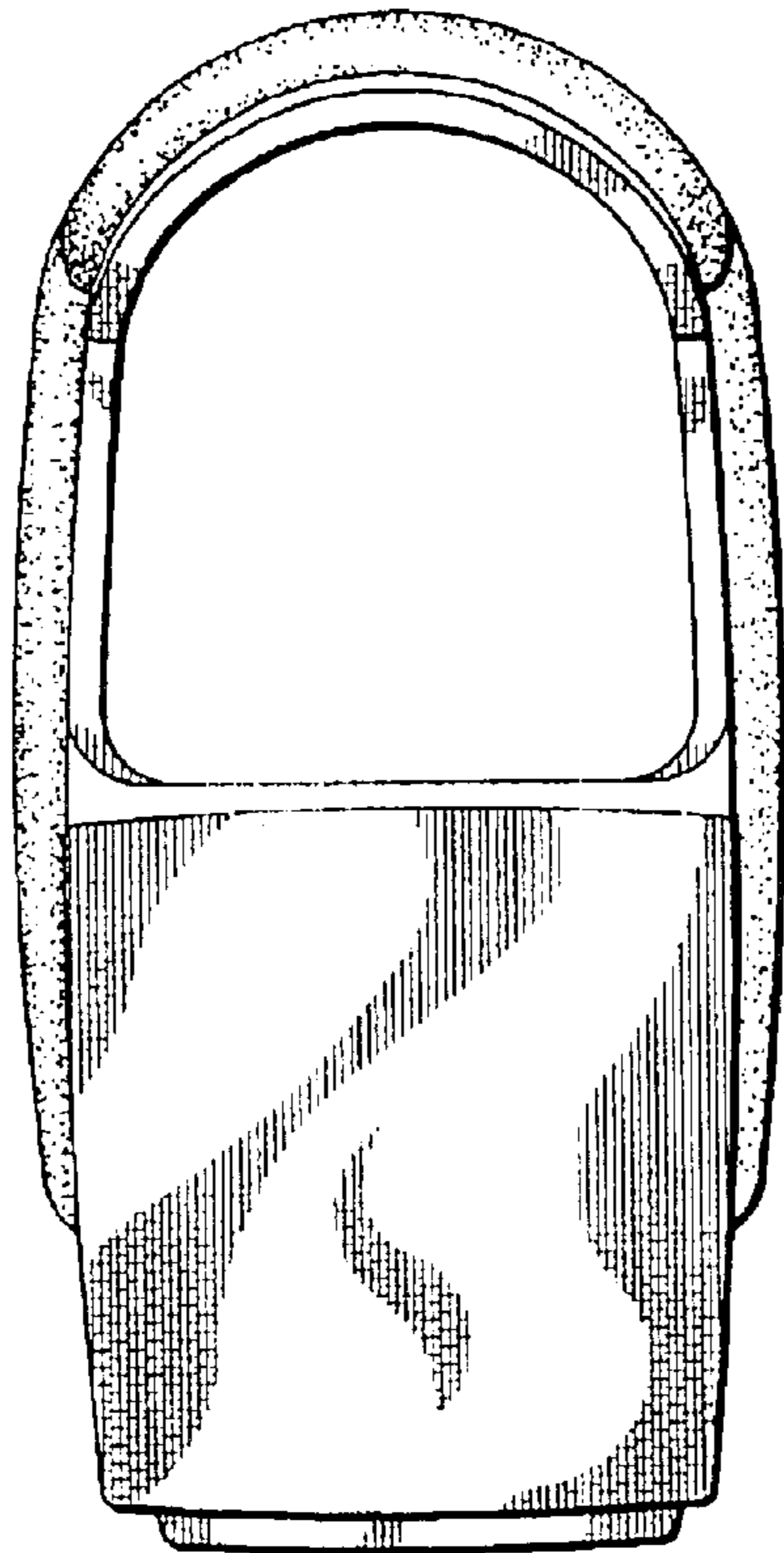

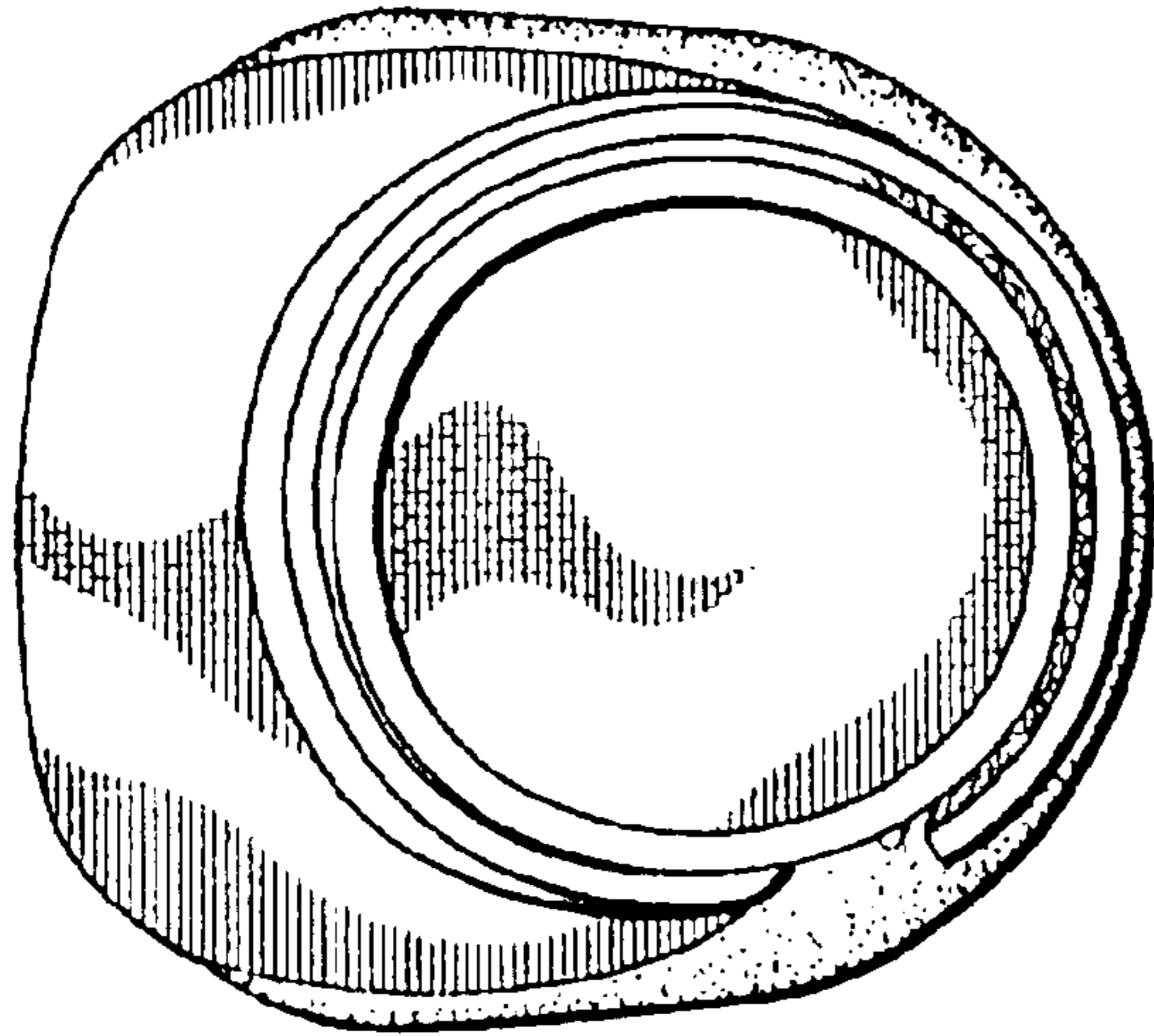

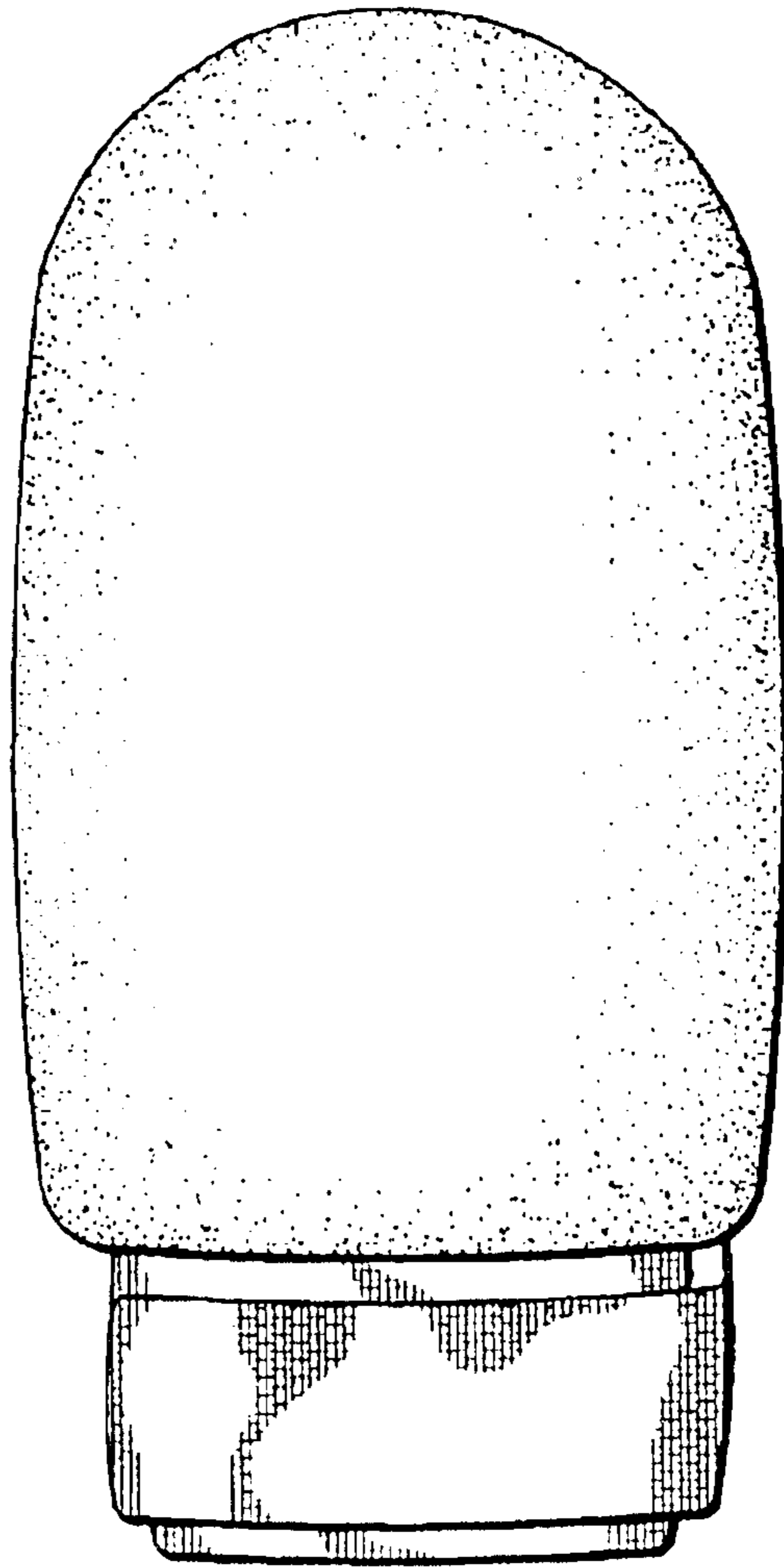

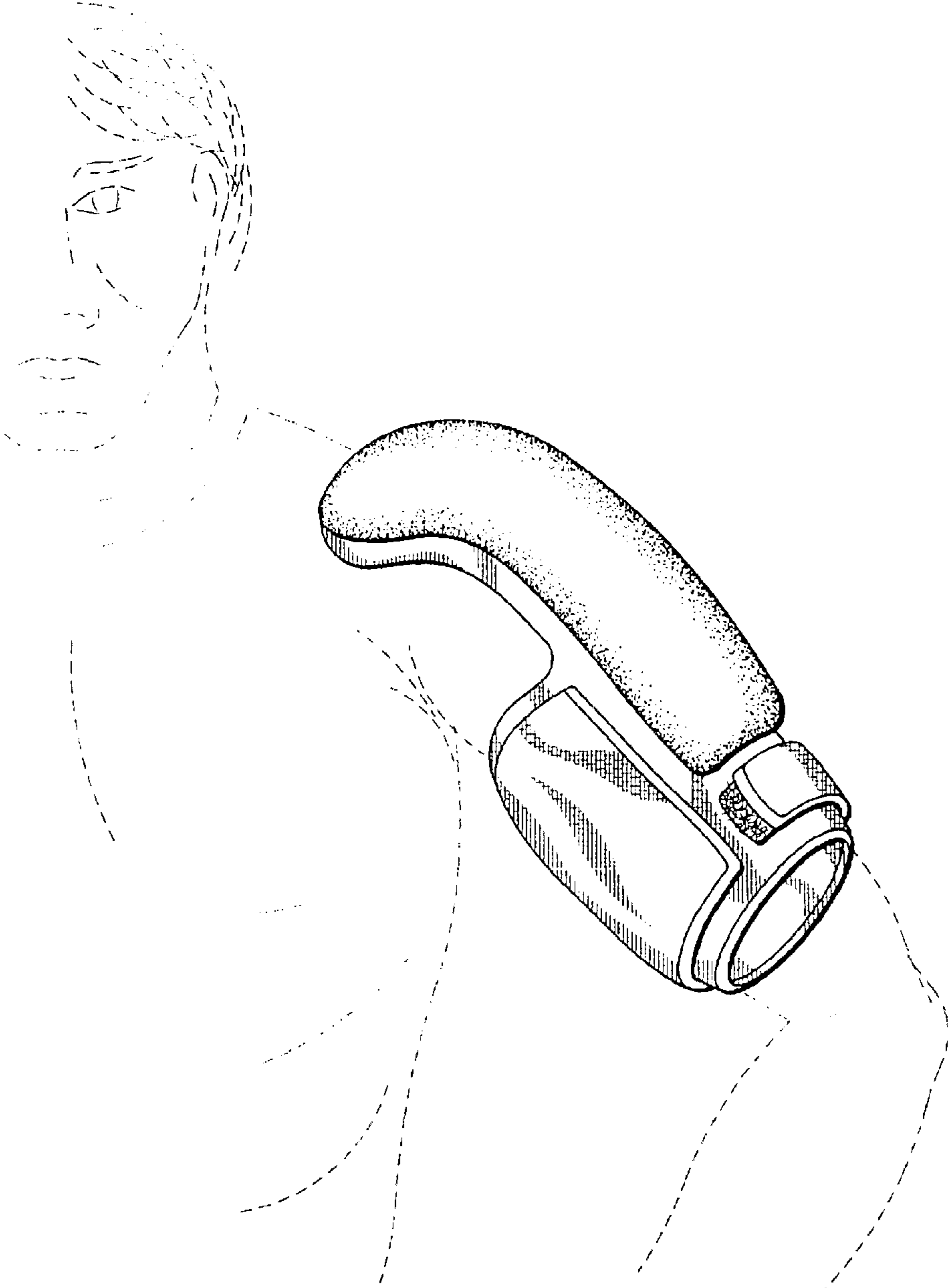
