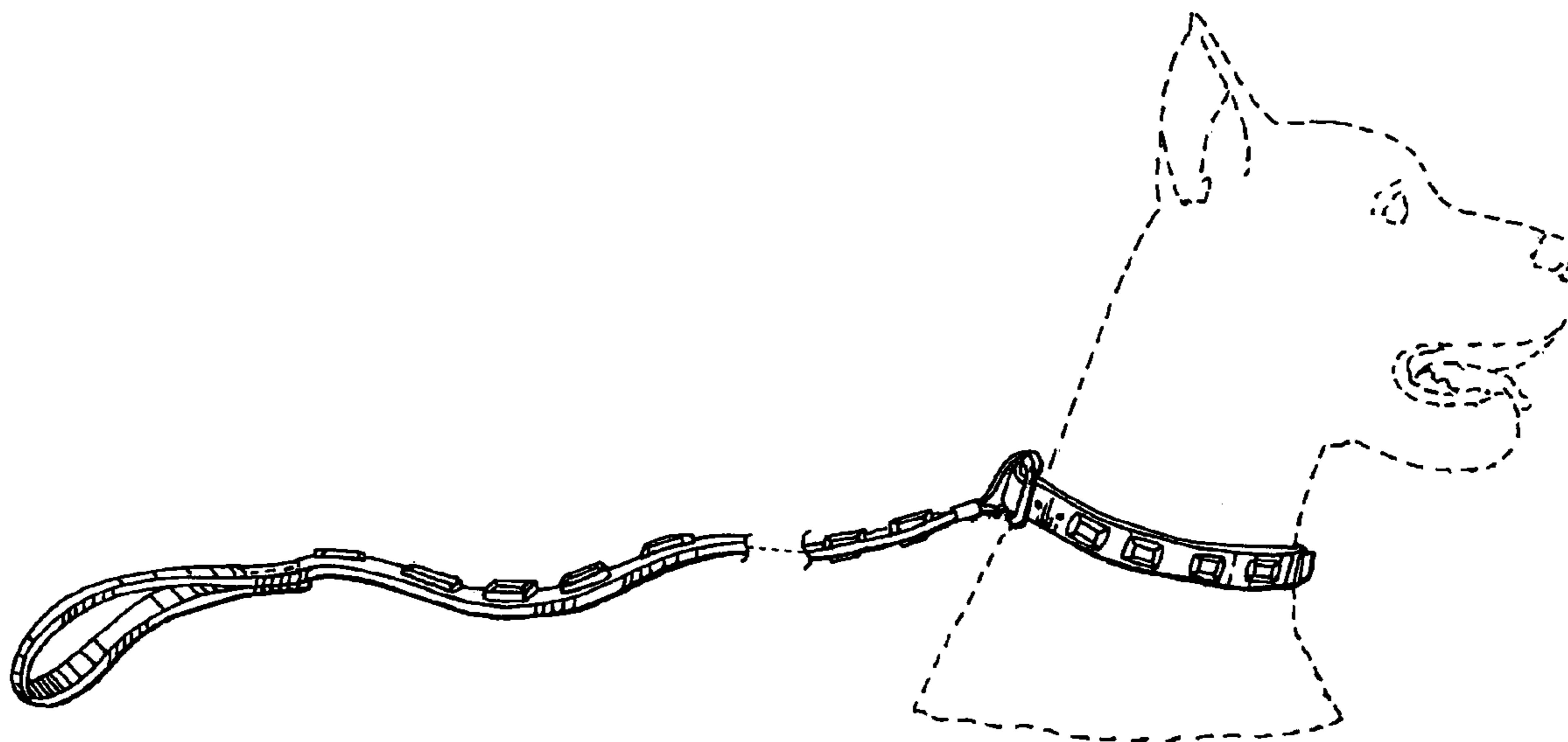
(57) **CLAIM**

The ornamental design for a combined pet leash and collar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined pet leash and collar, showing our new design; FIG. 2 is a right side view thereof; and, FIG. 3 is a plan view thereof. The broken line showing in the views is for illustrative purposes only and forms no part of the claimed design. The figures have been shown broken away for ease of illustration.

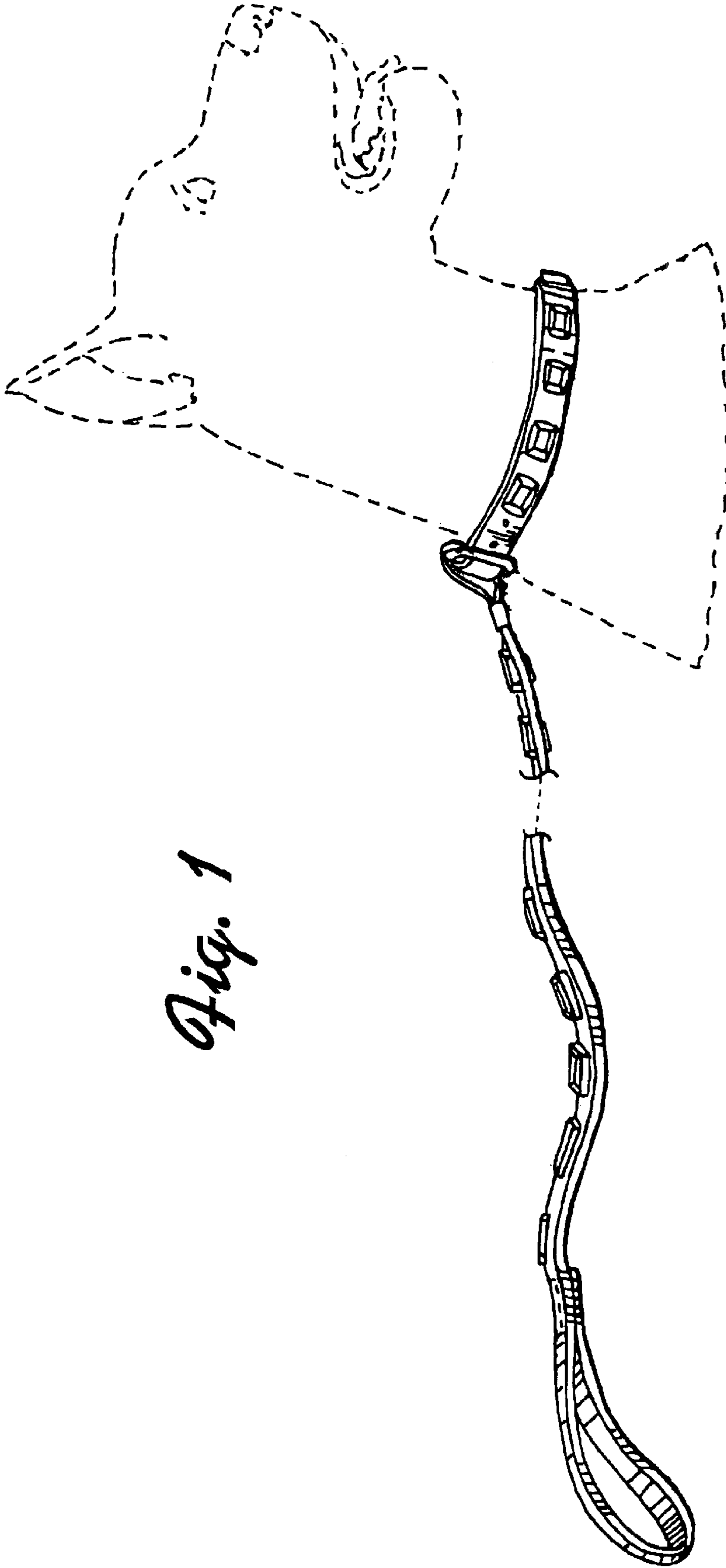

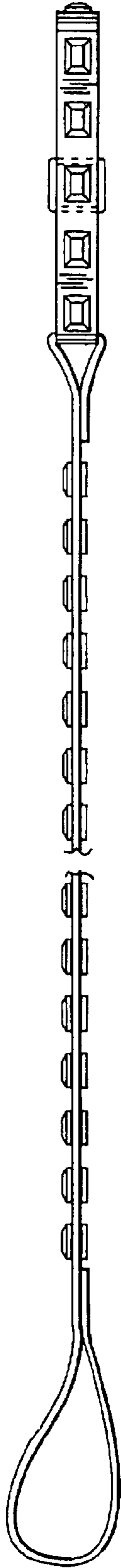

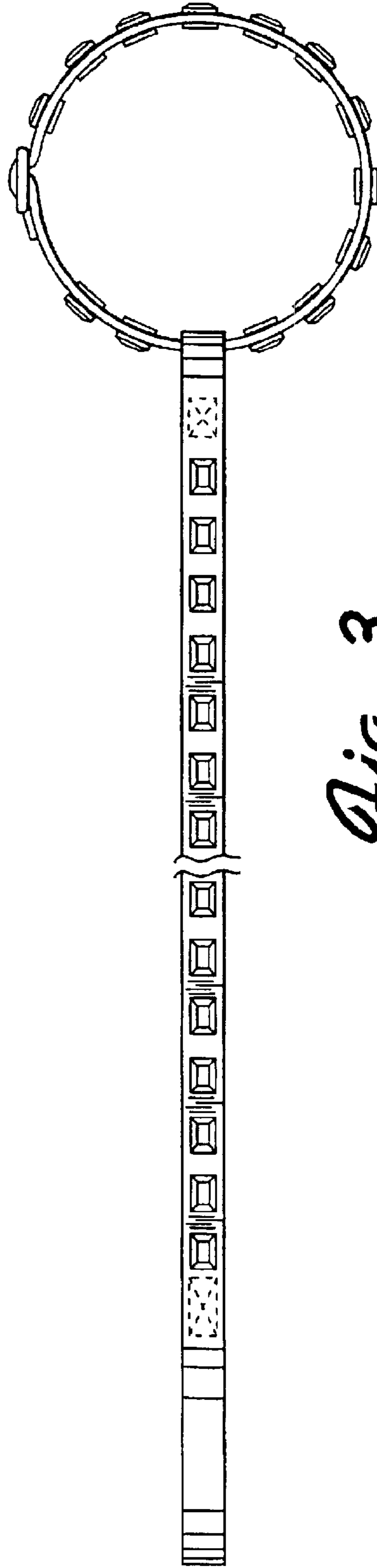
