DESCRIPTION

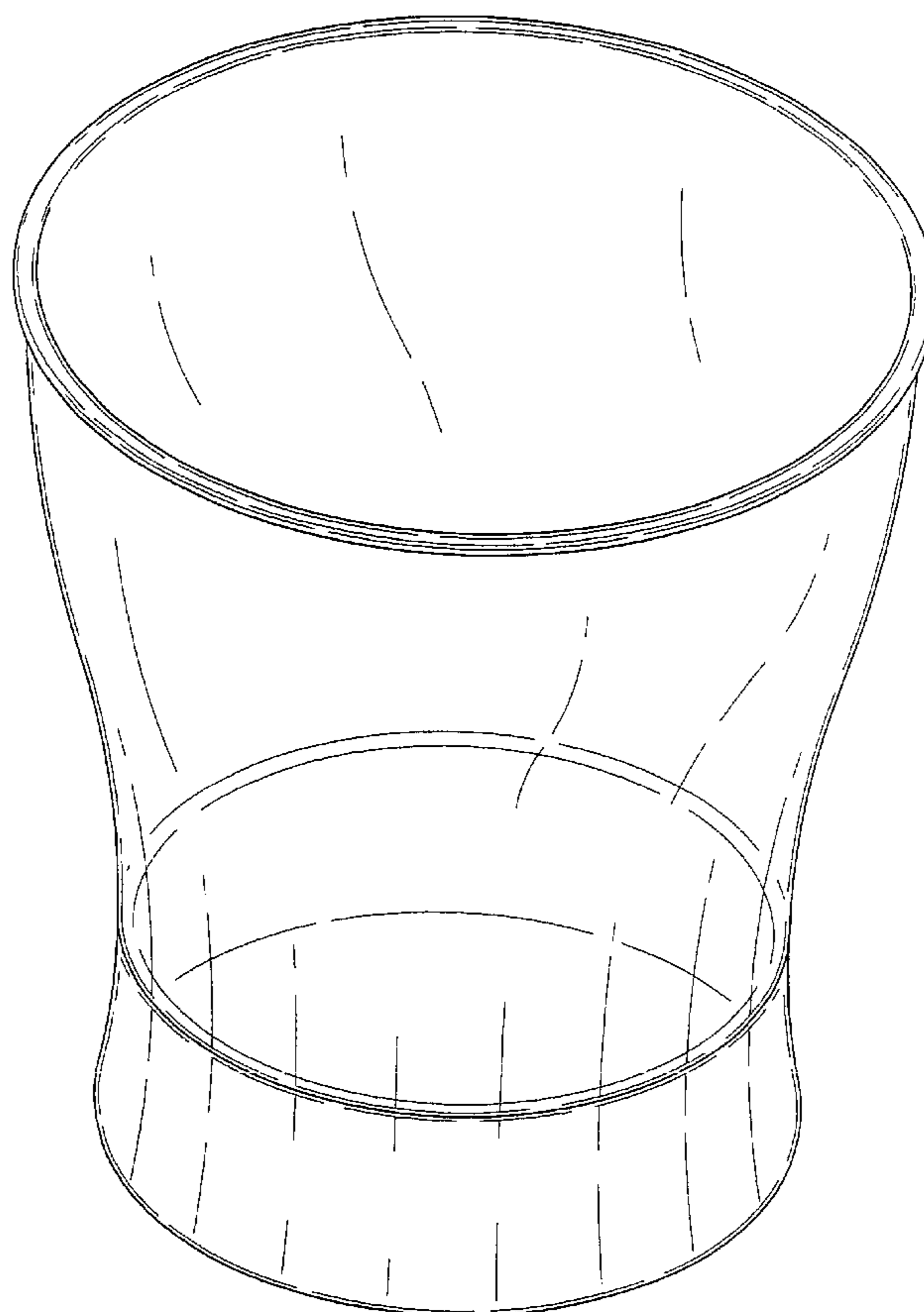
FIG. 1 is a perspective view of a waste can embodying this invention;

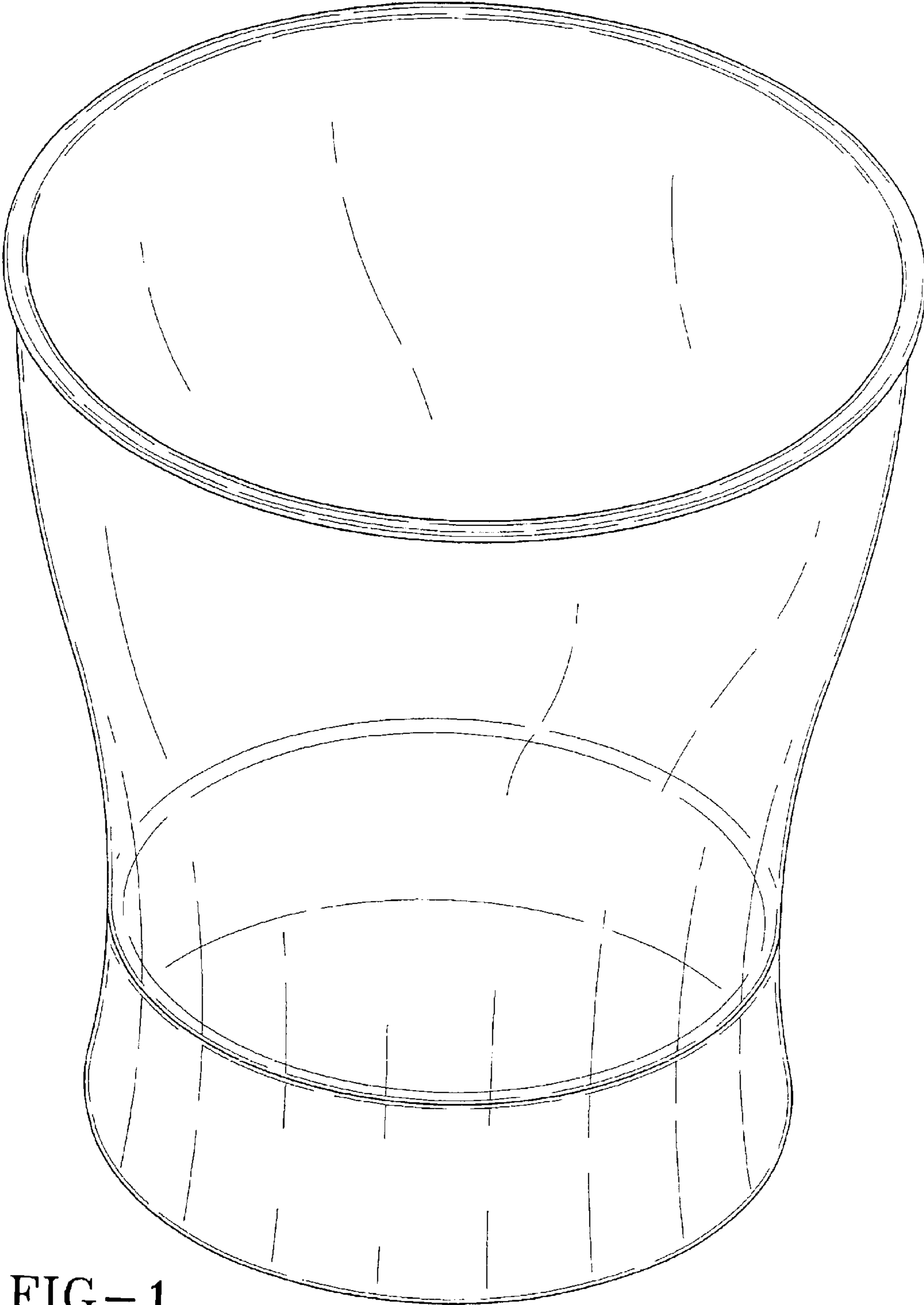

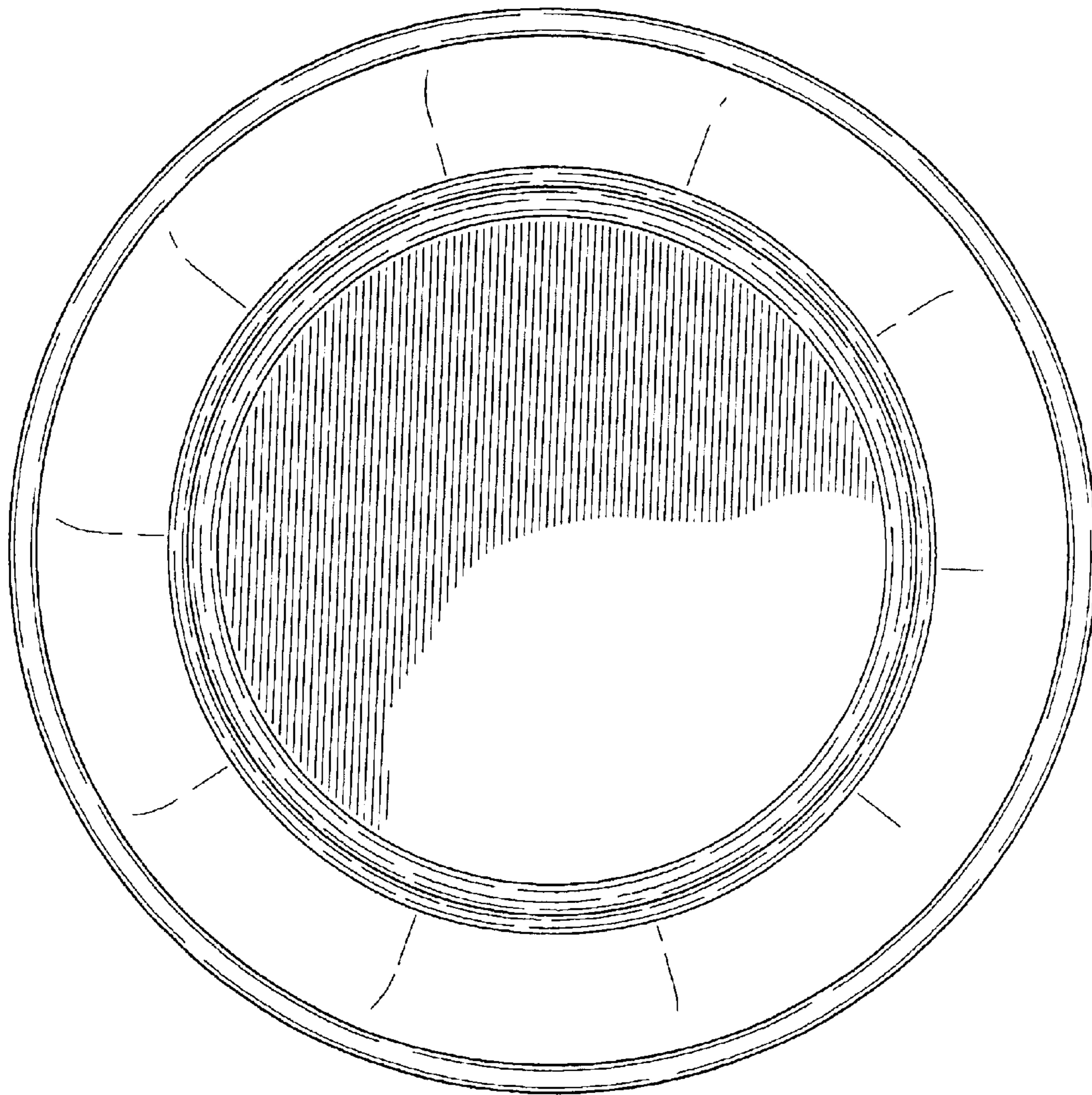

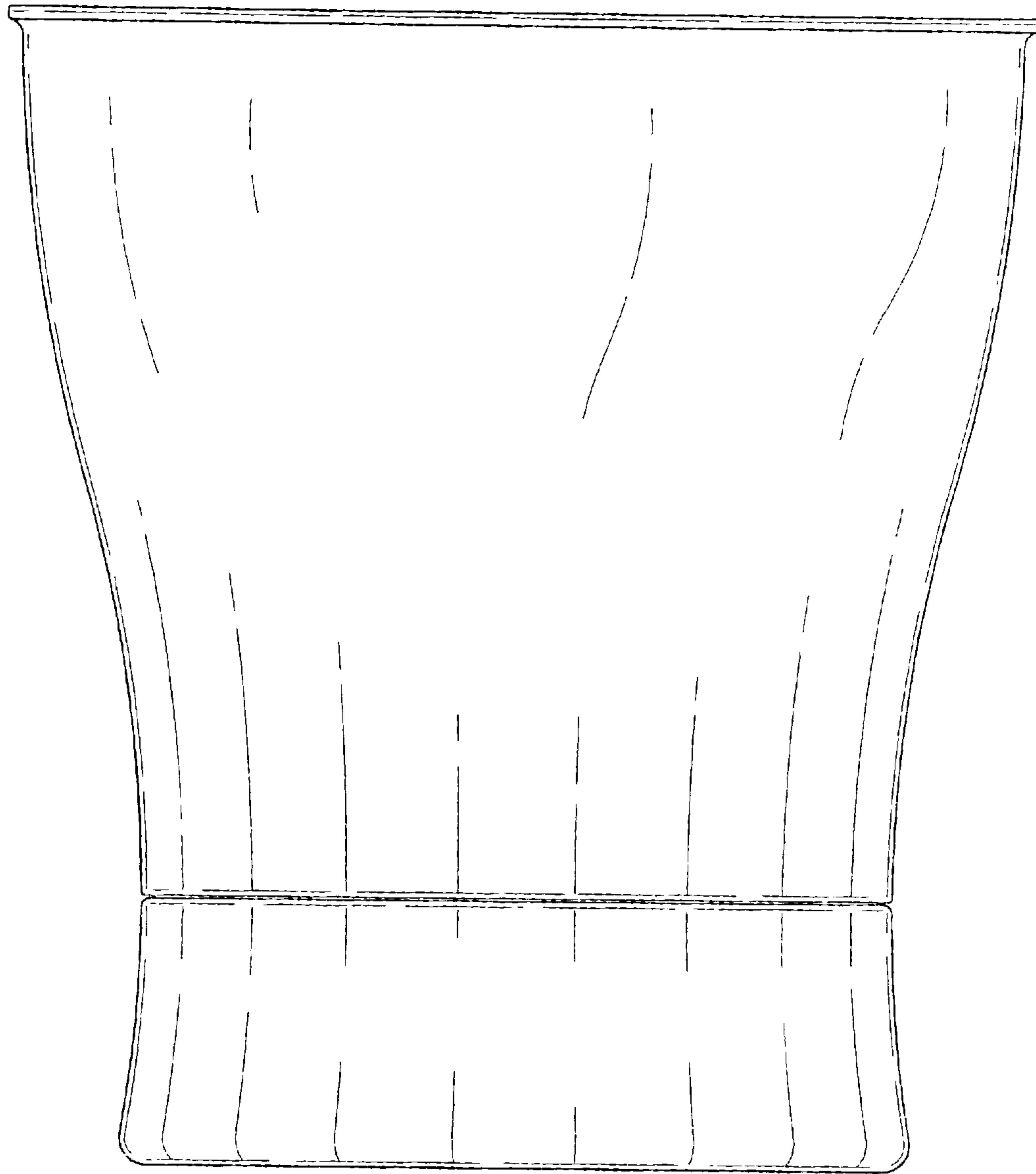

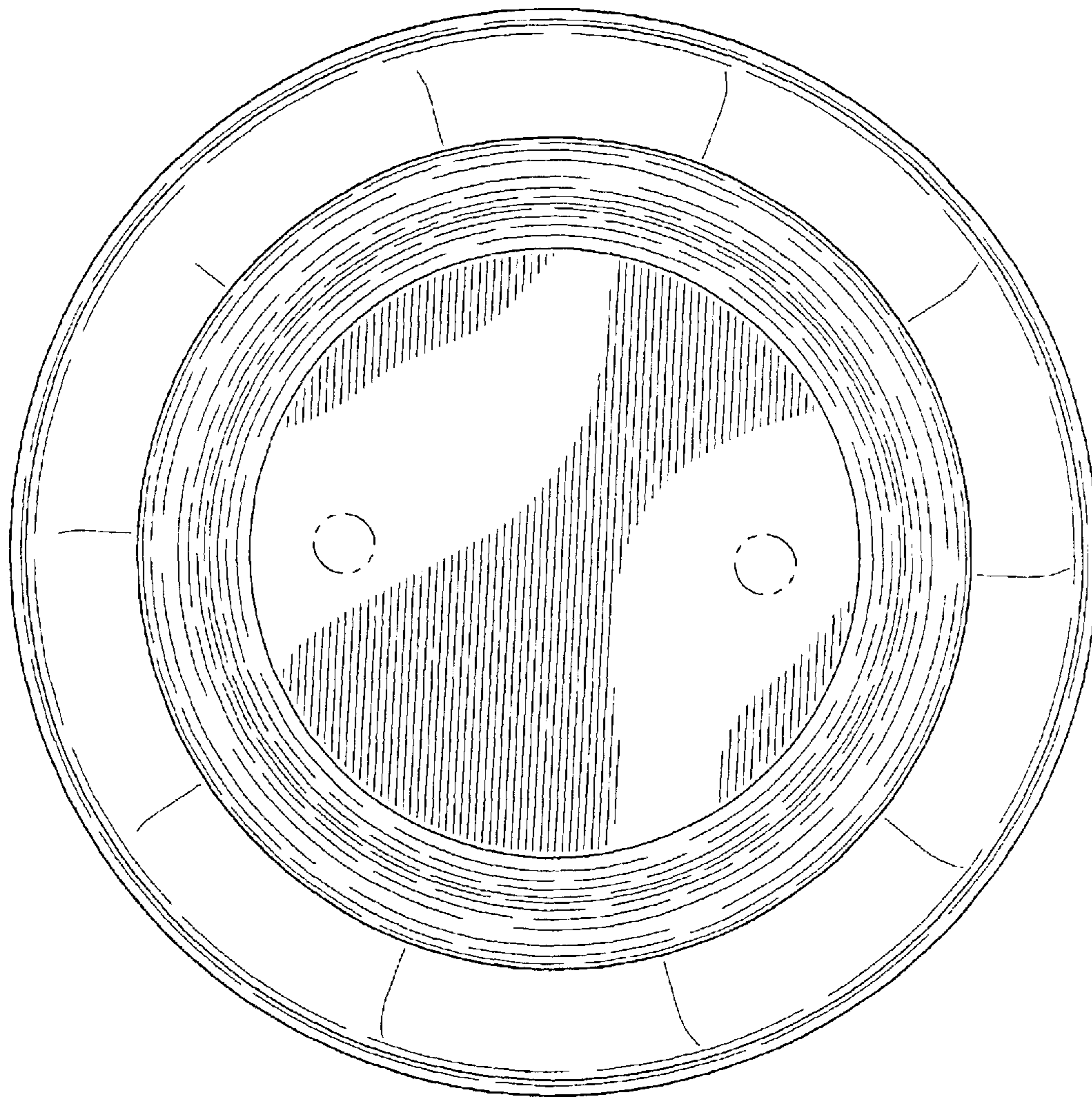
