**DESCRIPTION**

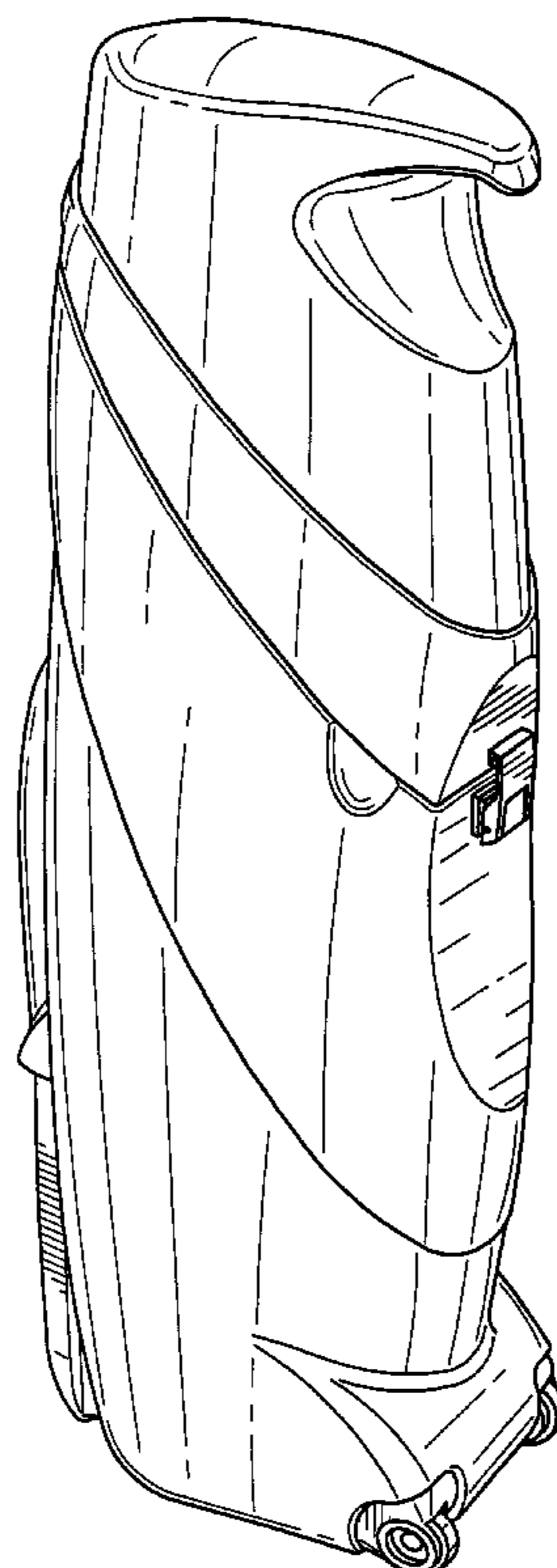
FIG. 1 is a top front perspective view of a wheeled carrier which can be removably secured to a vehicle showing my new design;

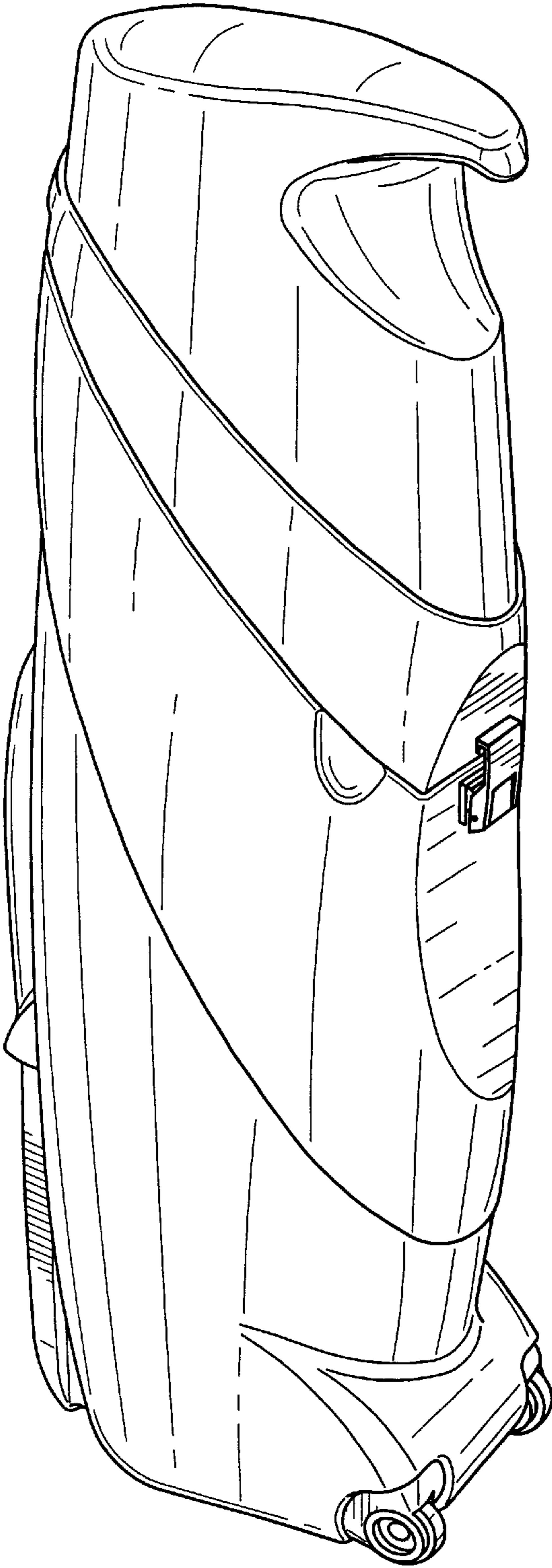

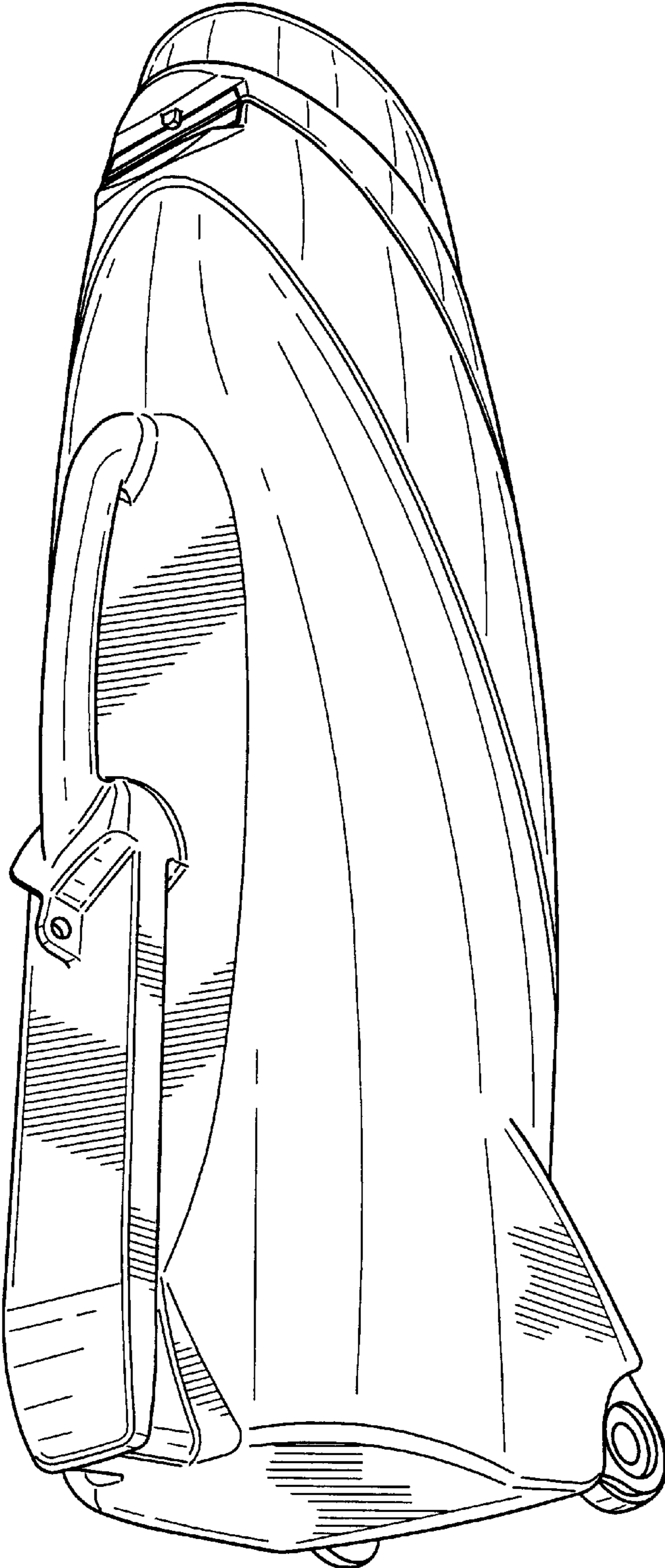

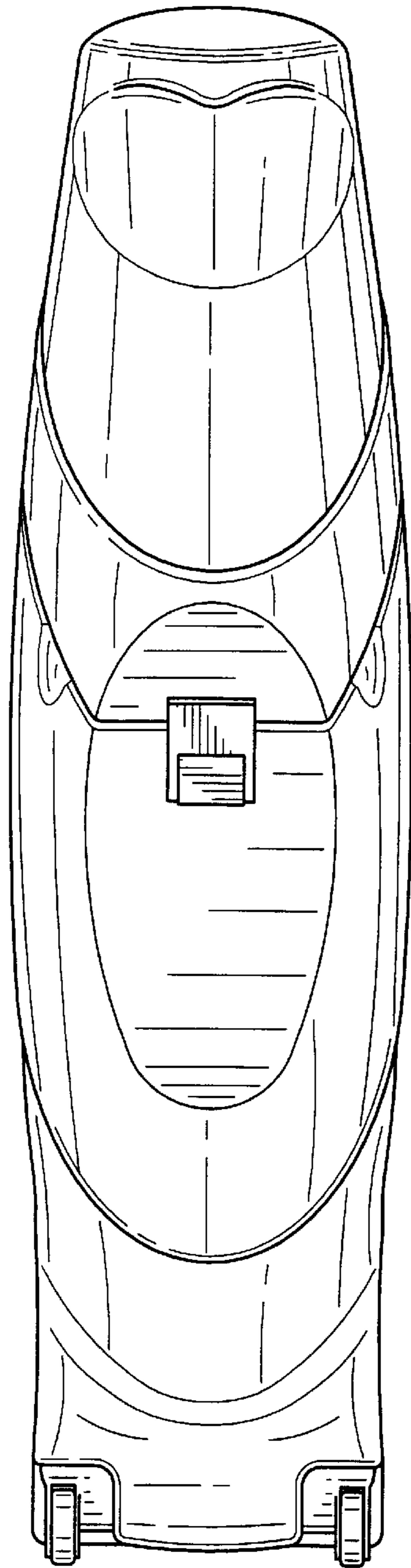

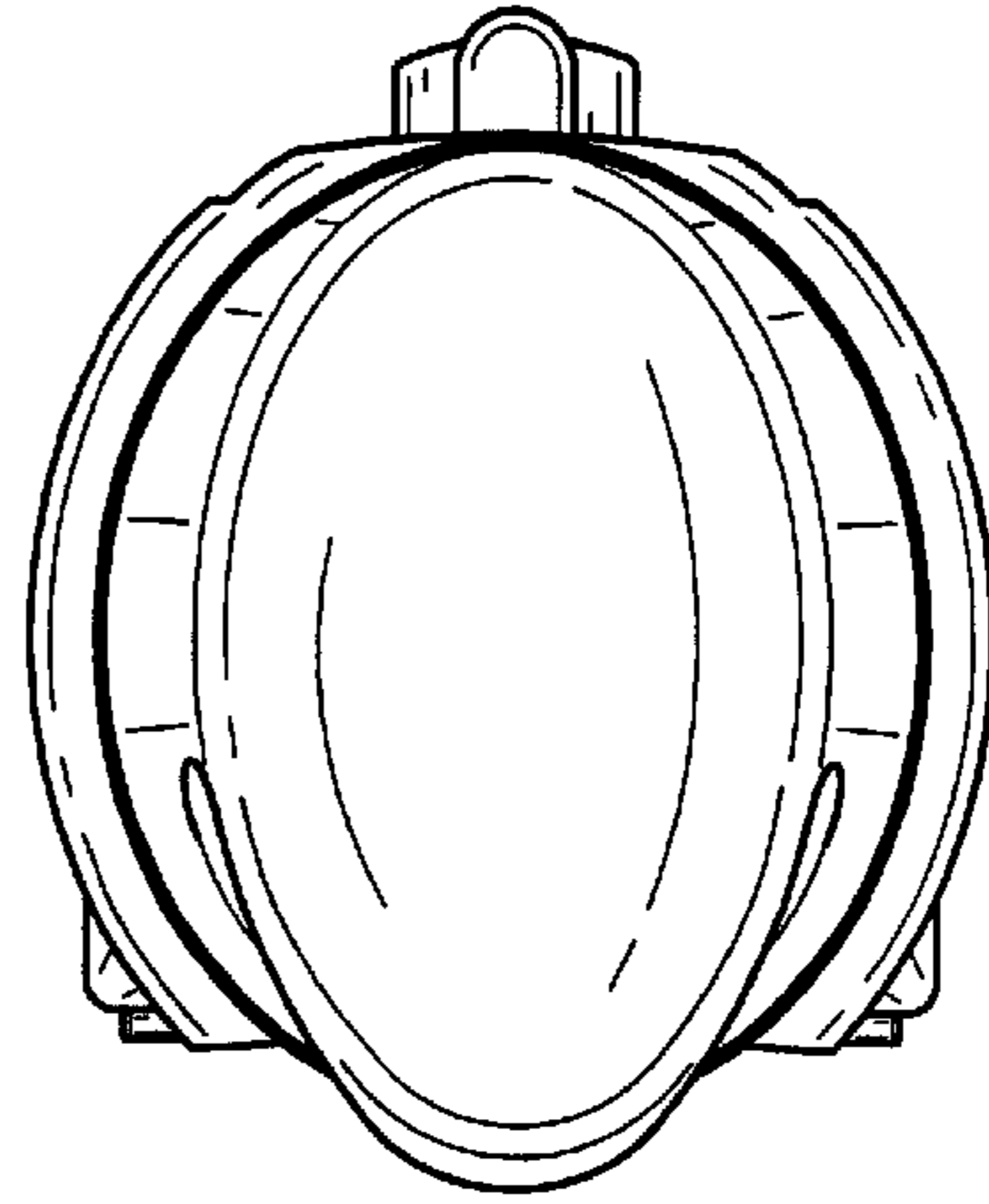
