FIG. 5 is a perspective view thereof showing the tool in an unfolded position.

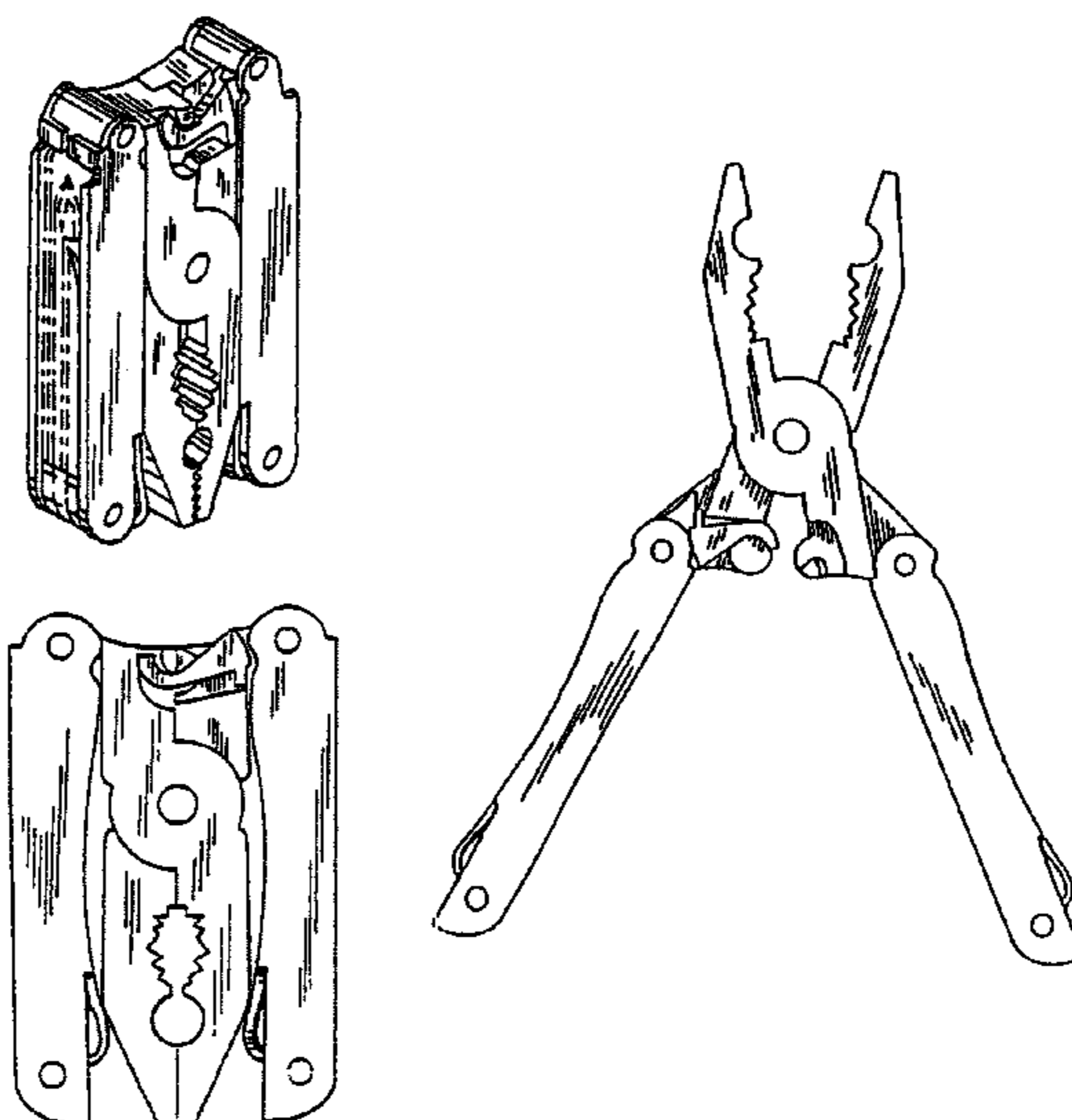
FIG. 6 is a plan view of one side thereof.

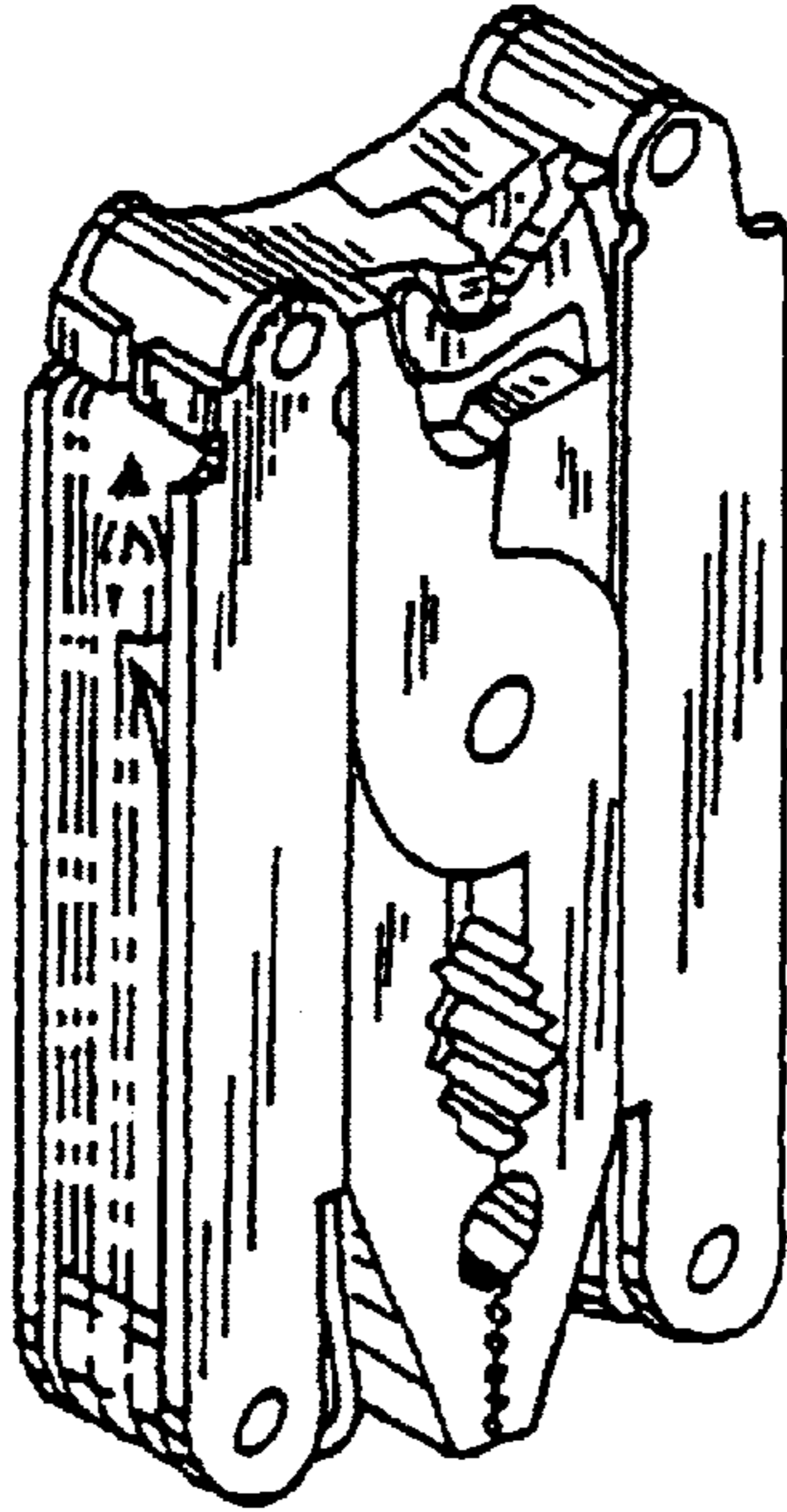

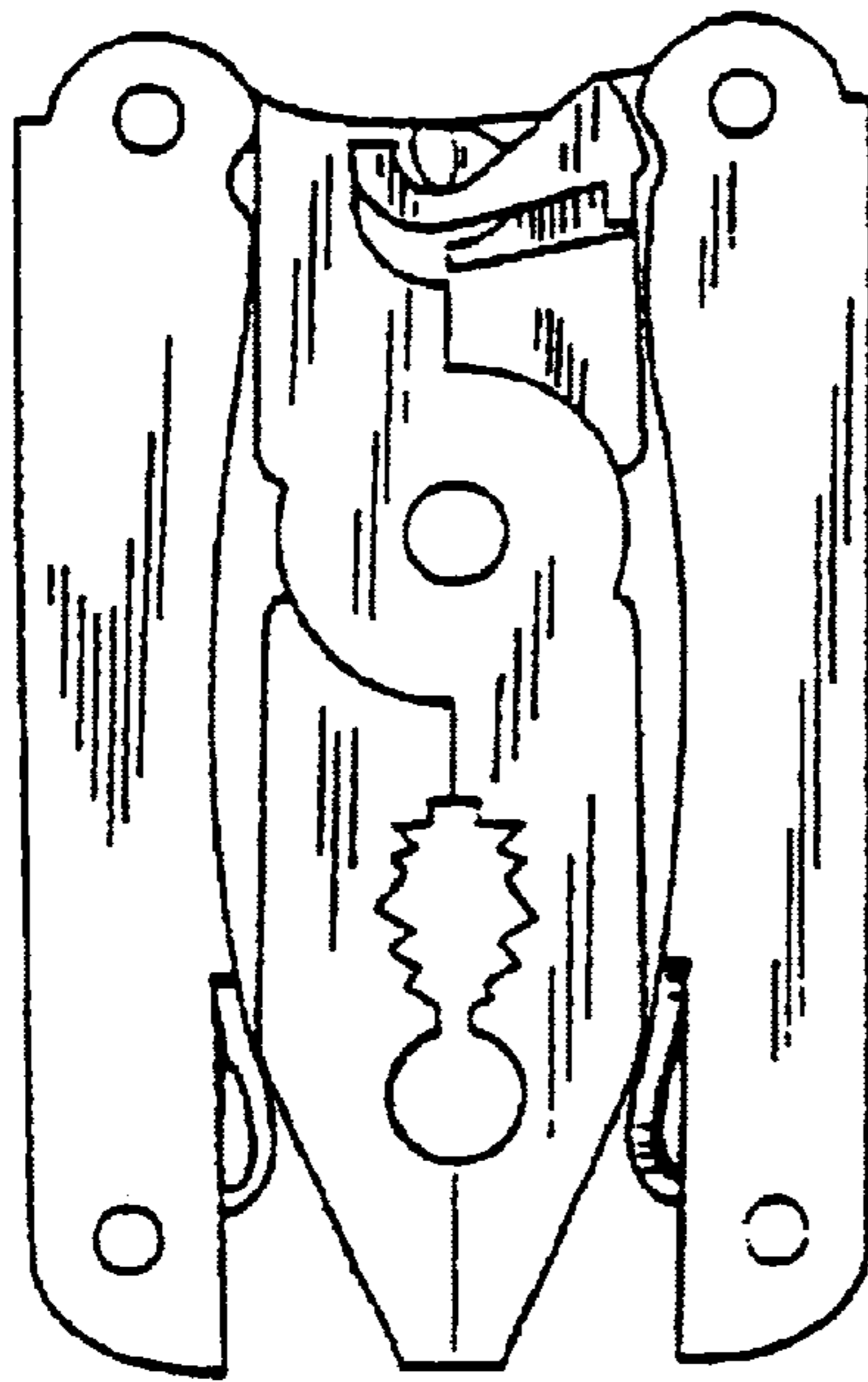

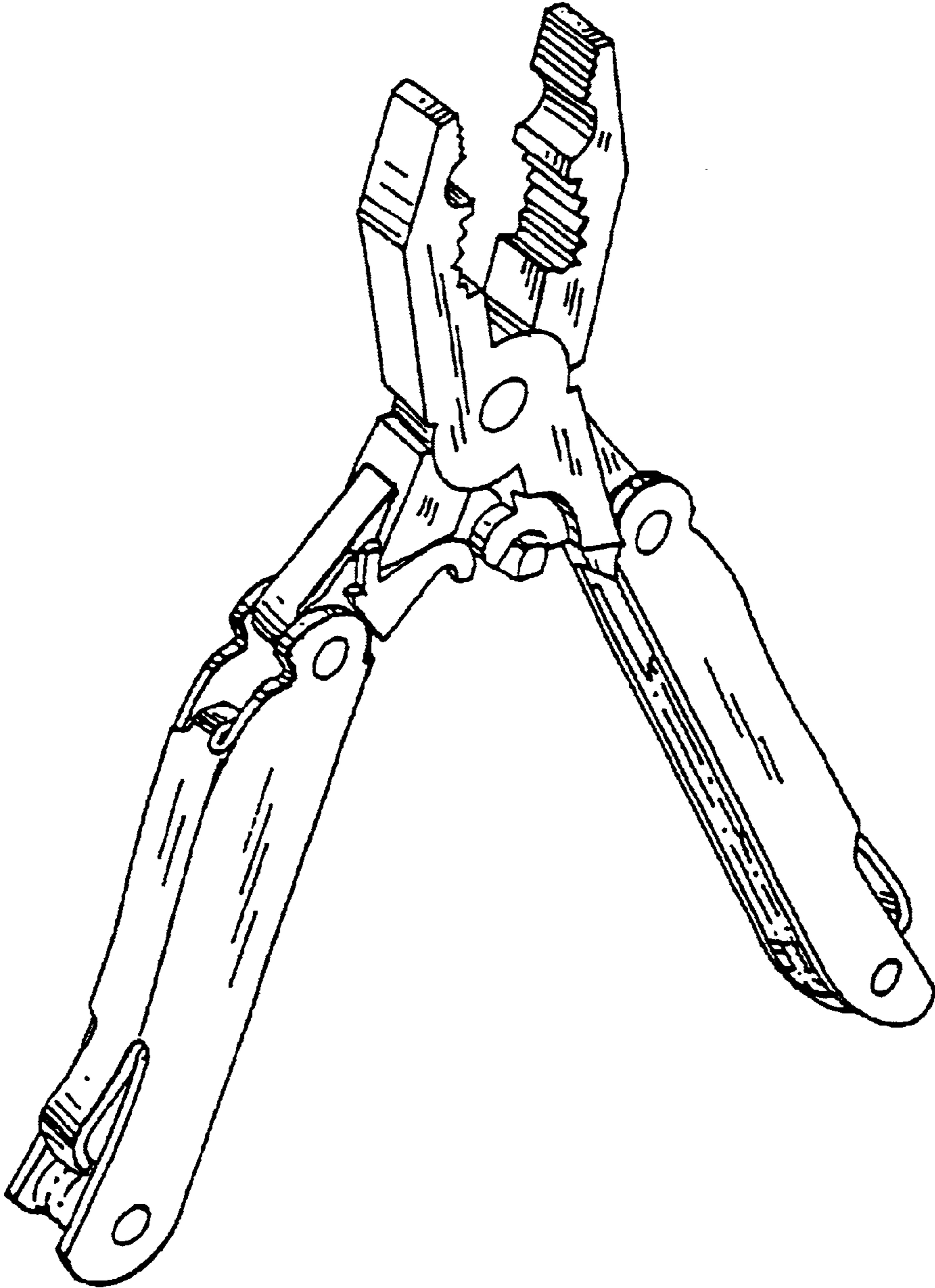

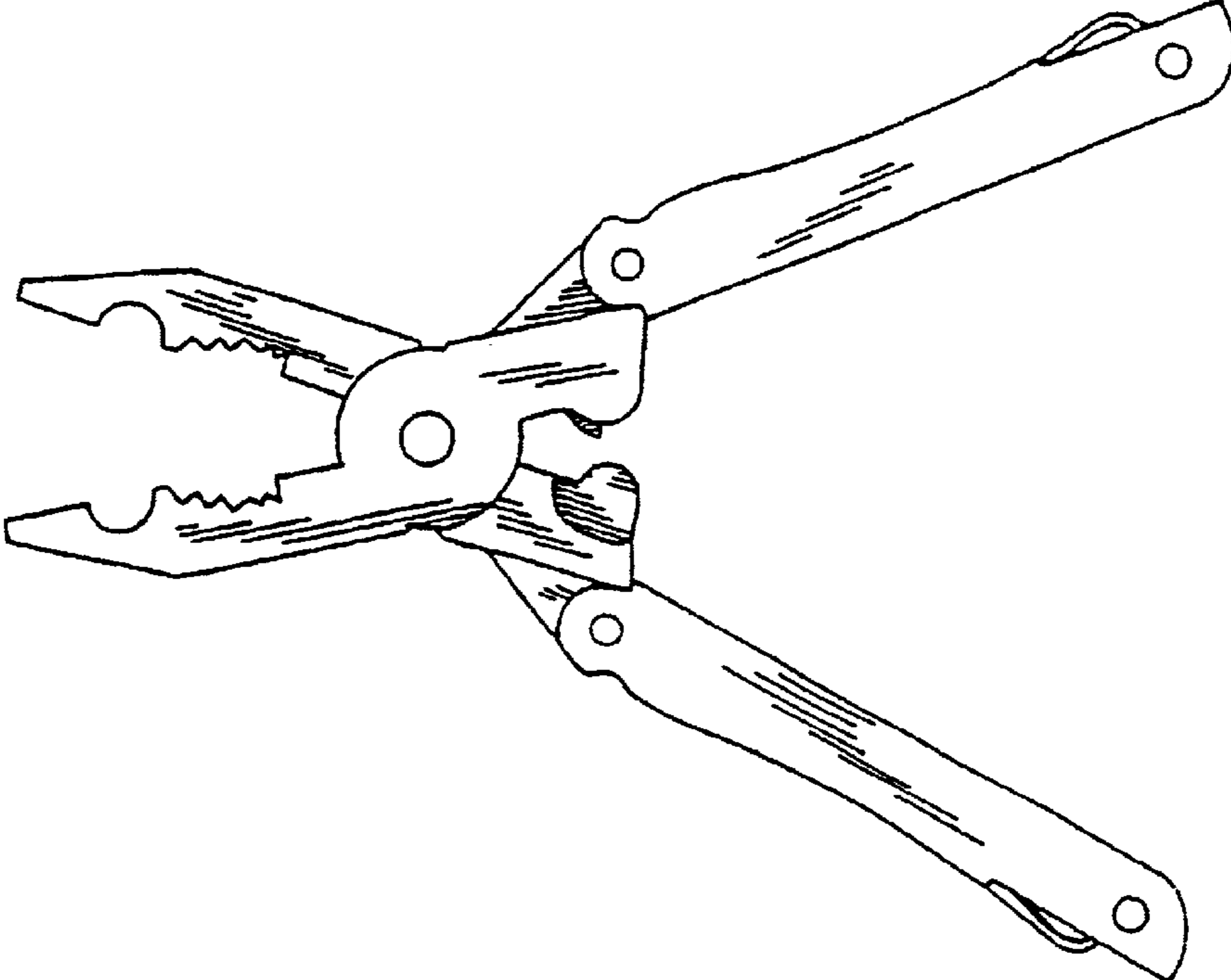
