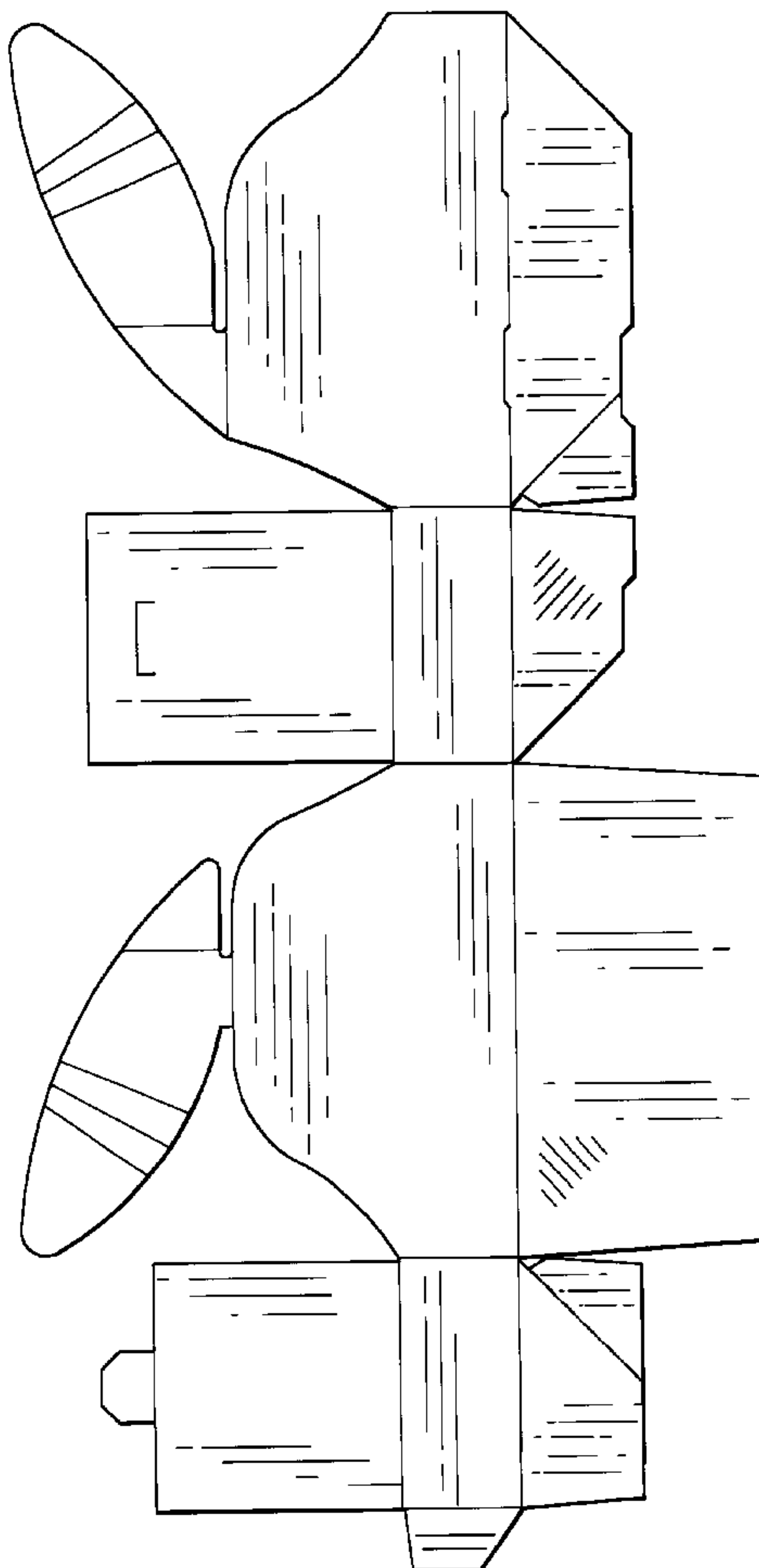
(57) **CLAIM**

The ornamental design for a decorative box, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the decorative box;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side bottom view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a front view thereof,
FIG. 6 is a rear view thereof; and,
FIG. 7 is the view of the decorative box prior to being folded to form the entire box.

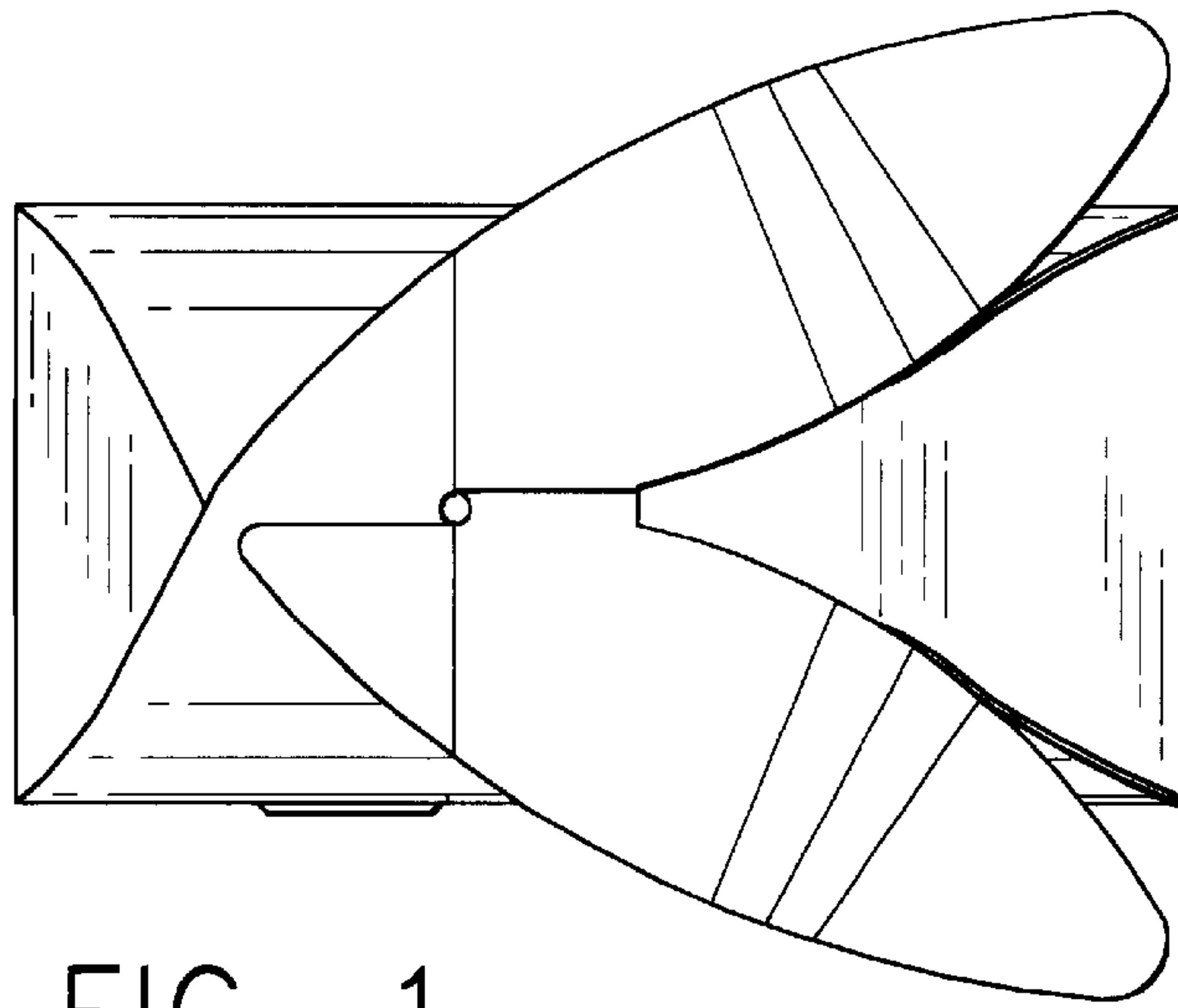

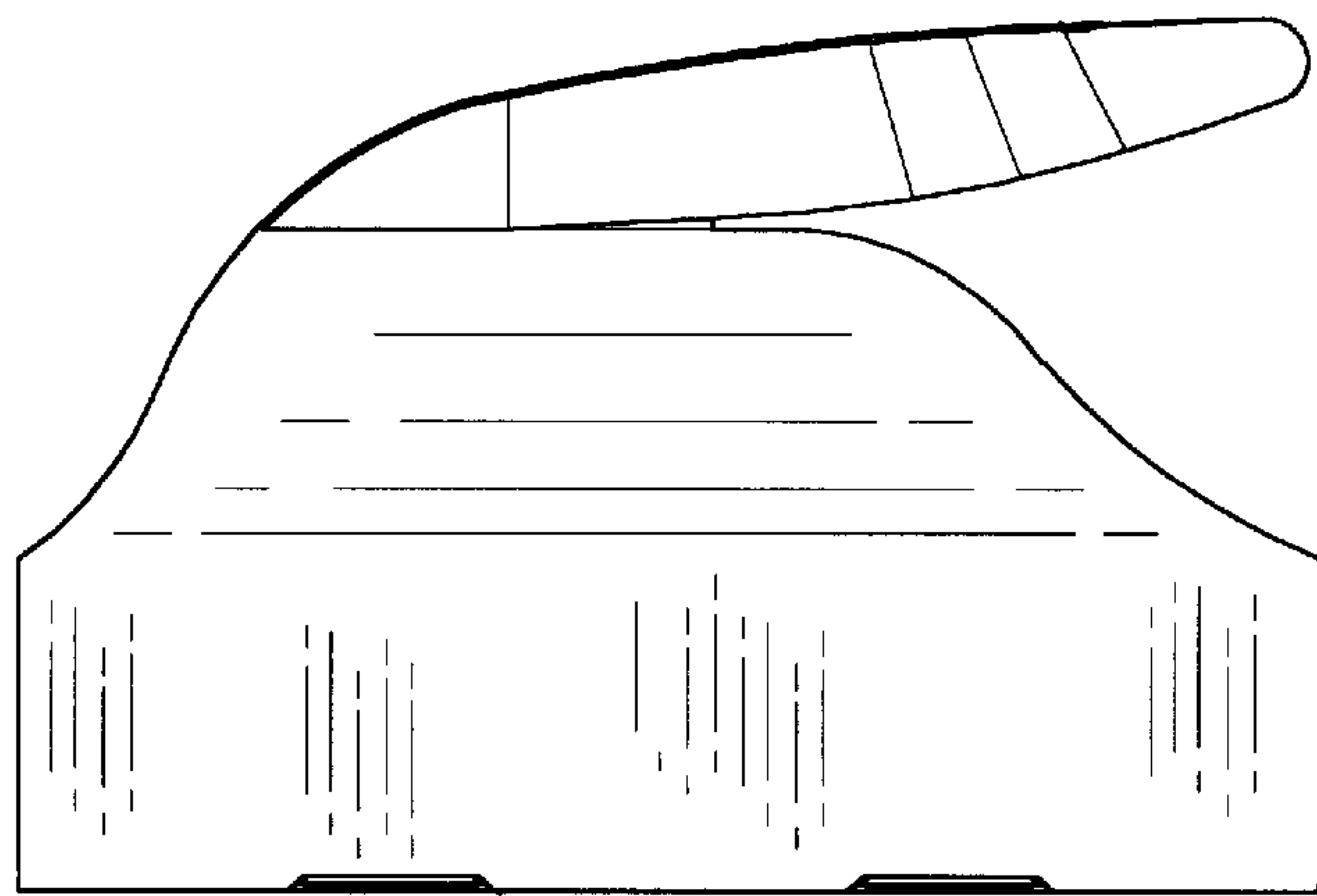

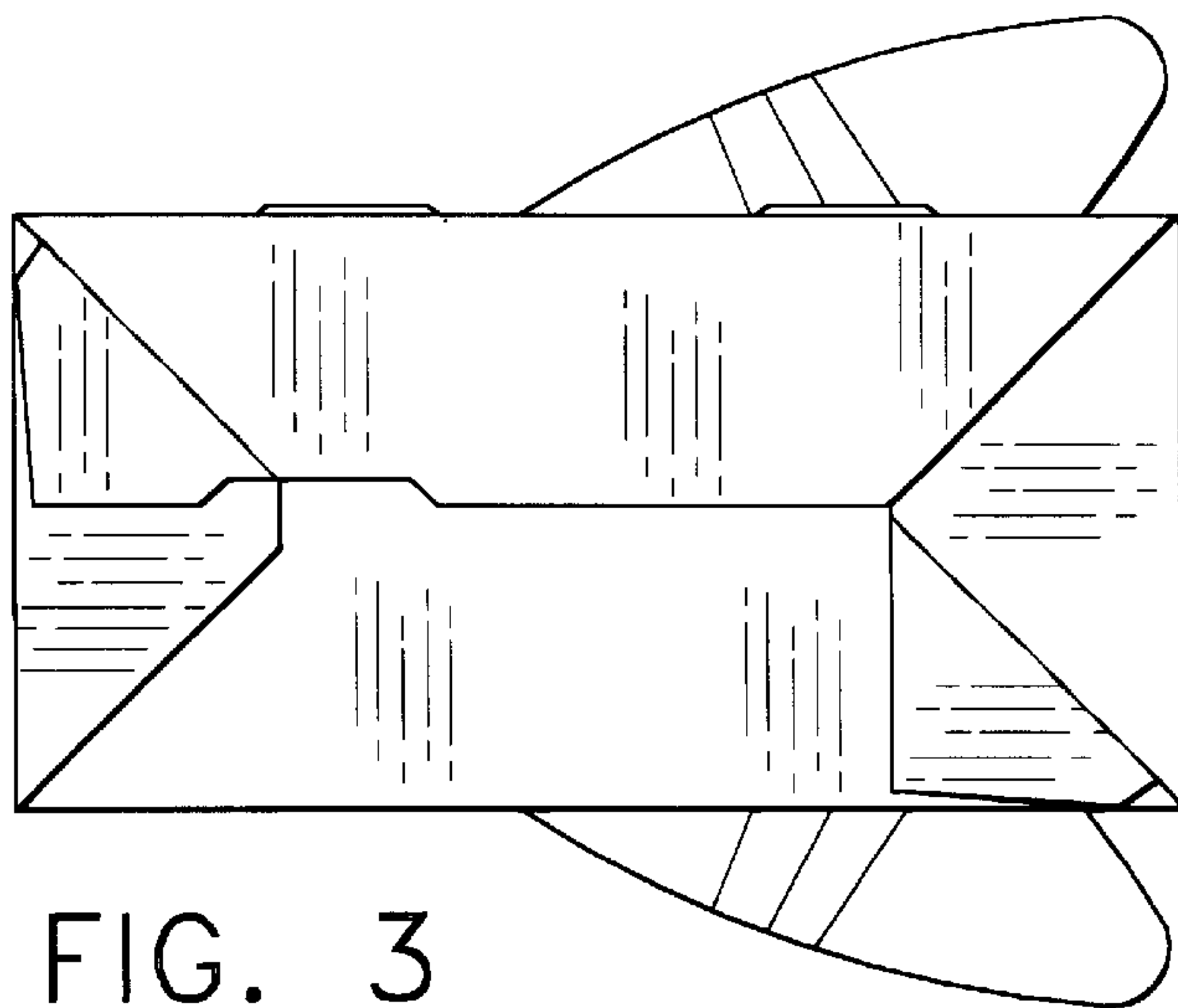

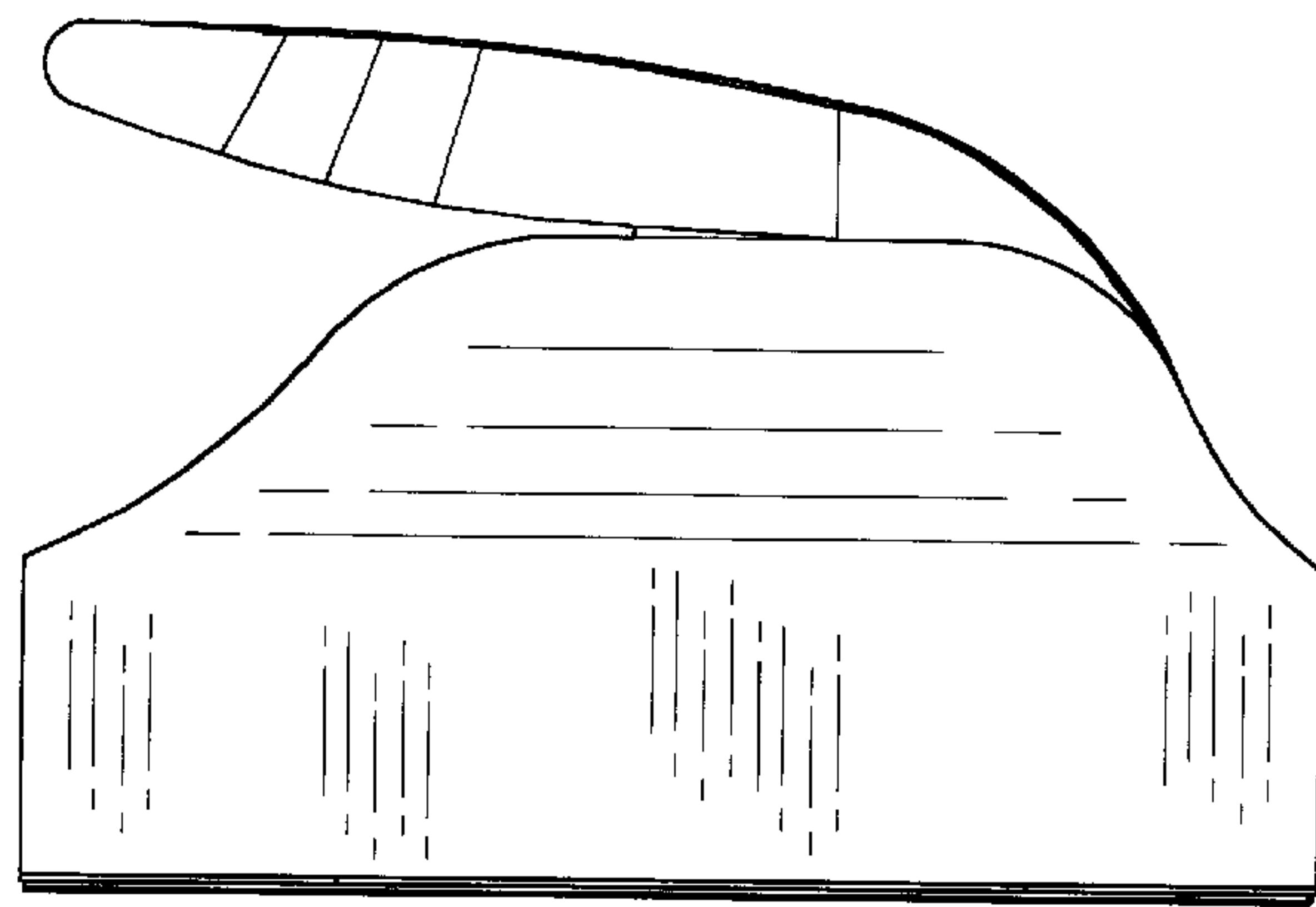

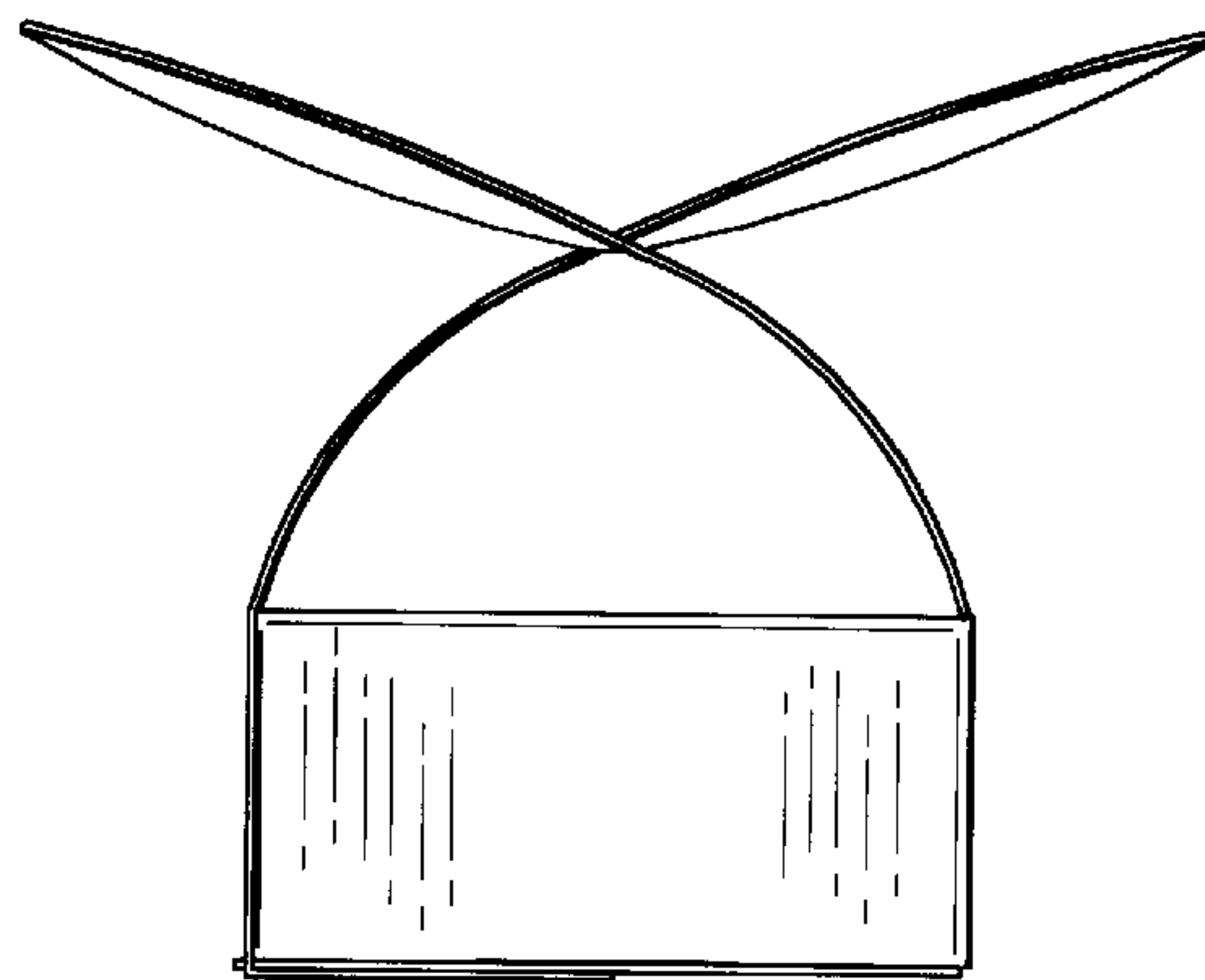

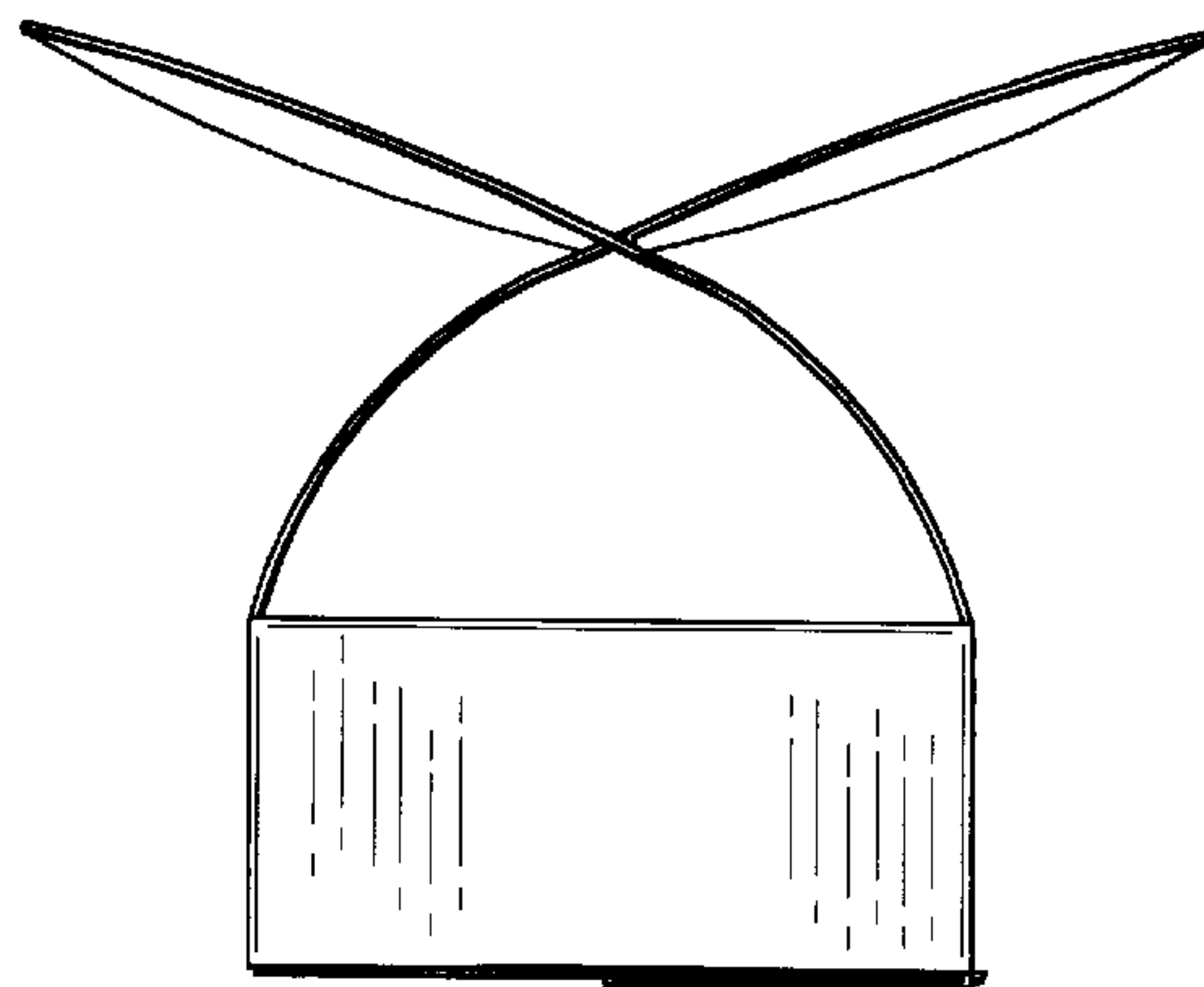

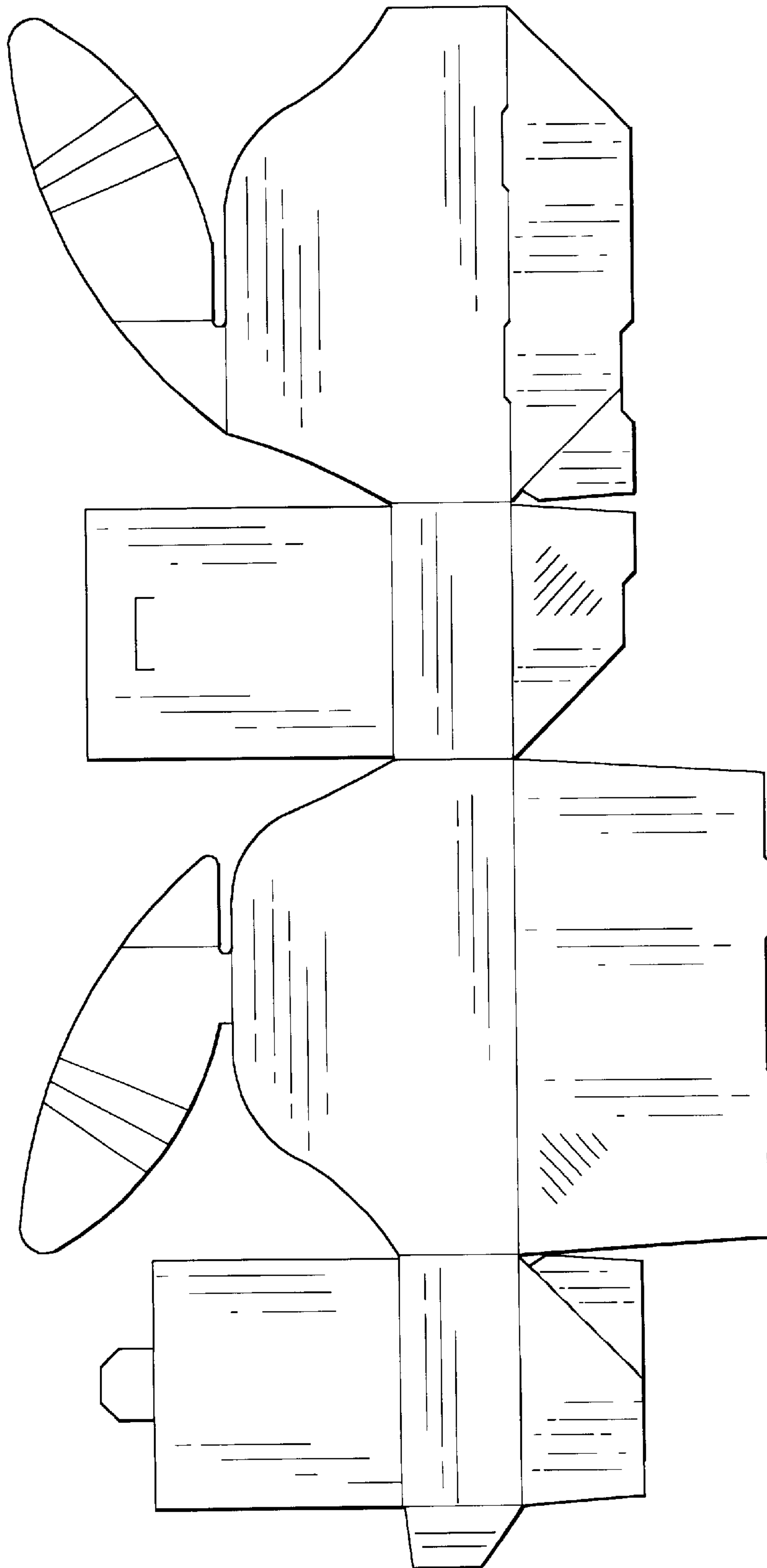
